(57) **CLAIM**
I claim the ornamental design for a medallion, as shown and described.

DESCRIPTION

FIG. 1 is a front view of medallion showing my new design; FIG. 2 is a front perspective view thereof; FIG. 3 is a top side view thereof; FIG. 4 is a bottom side view thereof; FIG. 5 is a left side view thereof; and, FIG. 6 is a right side view thereof. The undisclosed back of the medallion shown in FIGS. 1-6 forms no part of the claimed design.

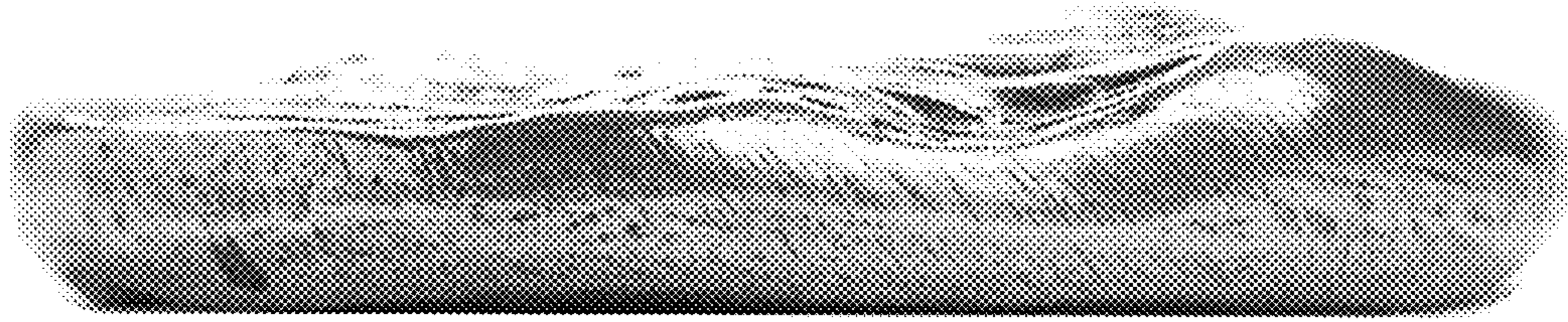

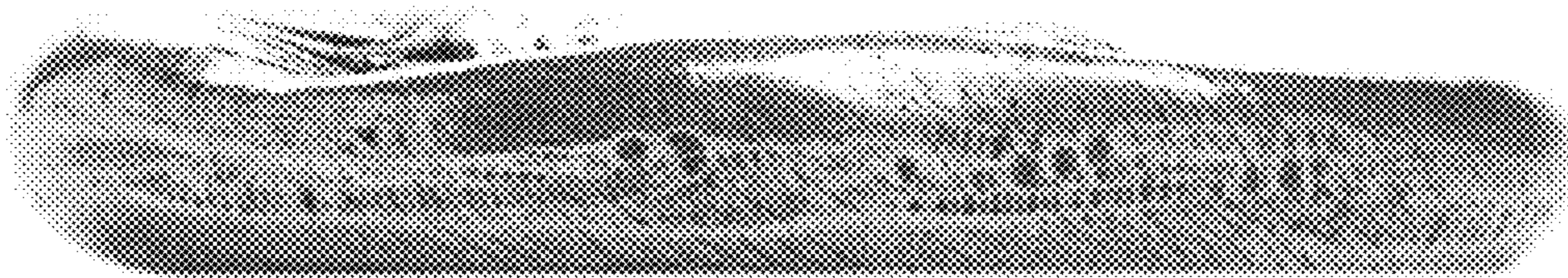

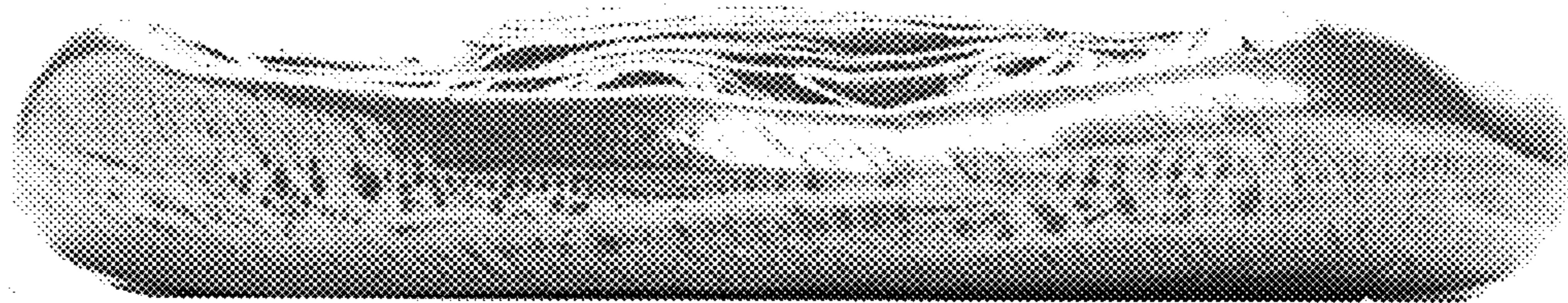

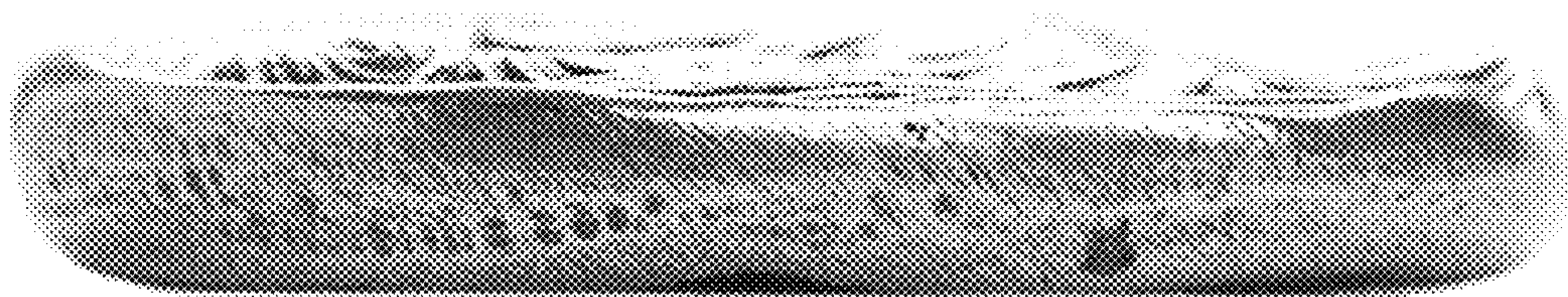
