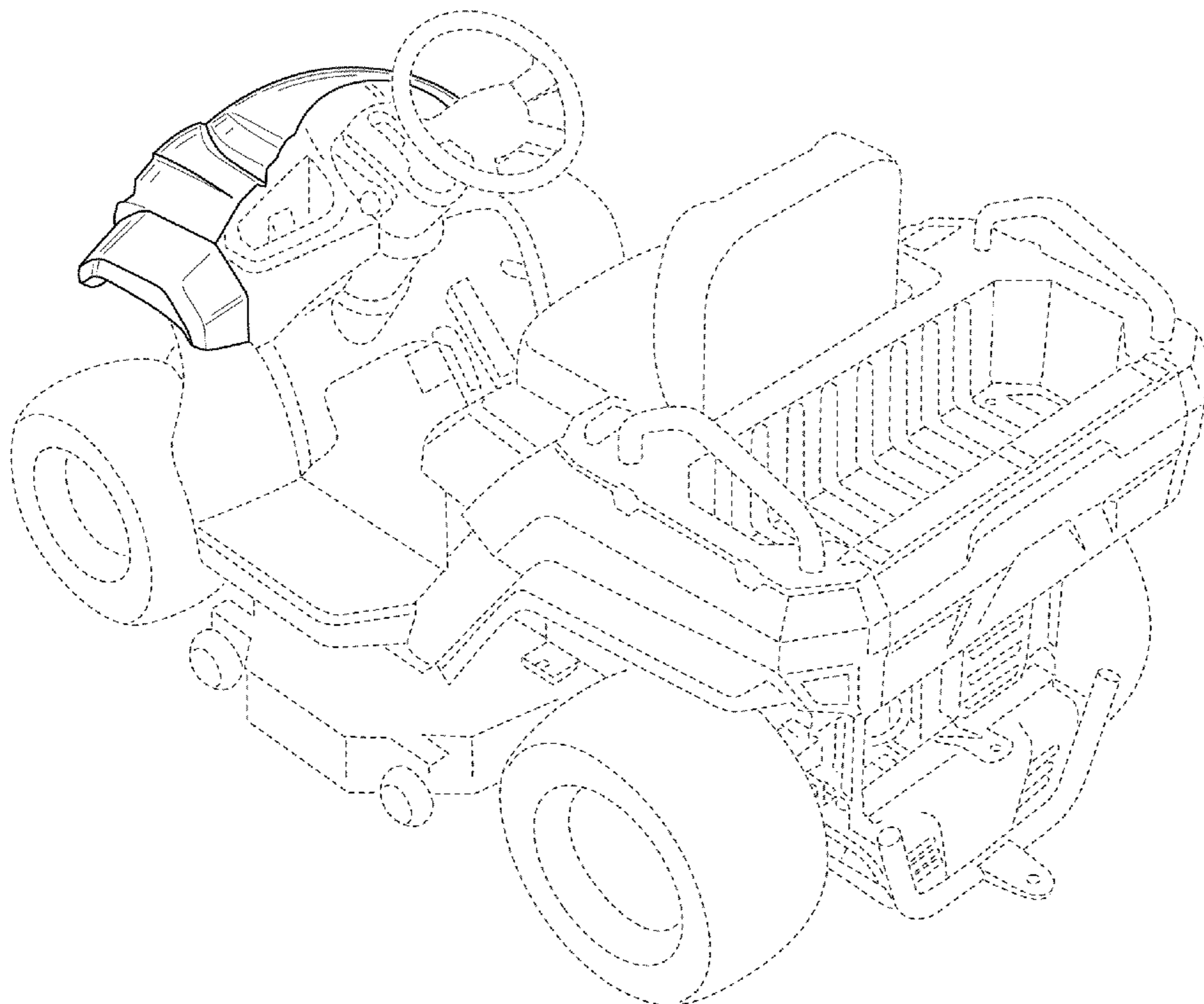
(57) **CLAIM**

The ornamental design for a front cowling of a multi-purpose vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a front cowling of a multi-purpose vehicle showing the new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is bottom plan view thereof. The broken lines shown in the drawings are for the purpose of illustrating environmental structure that forms no part of the claimed design.

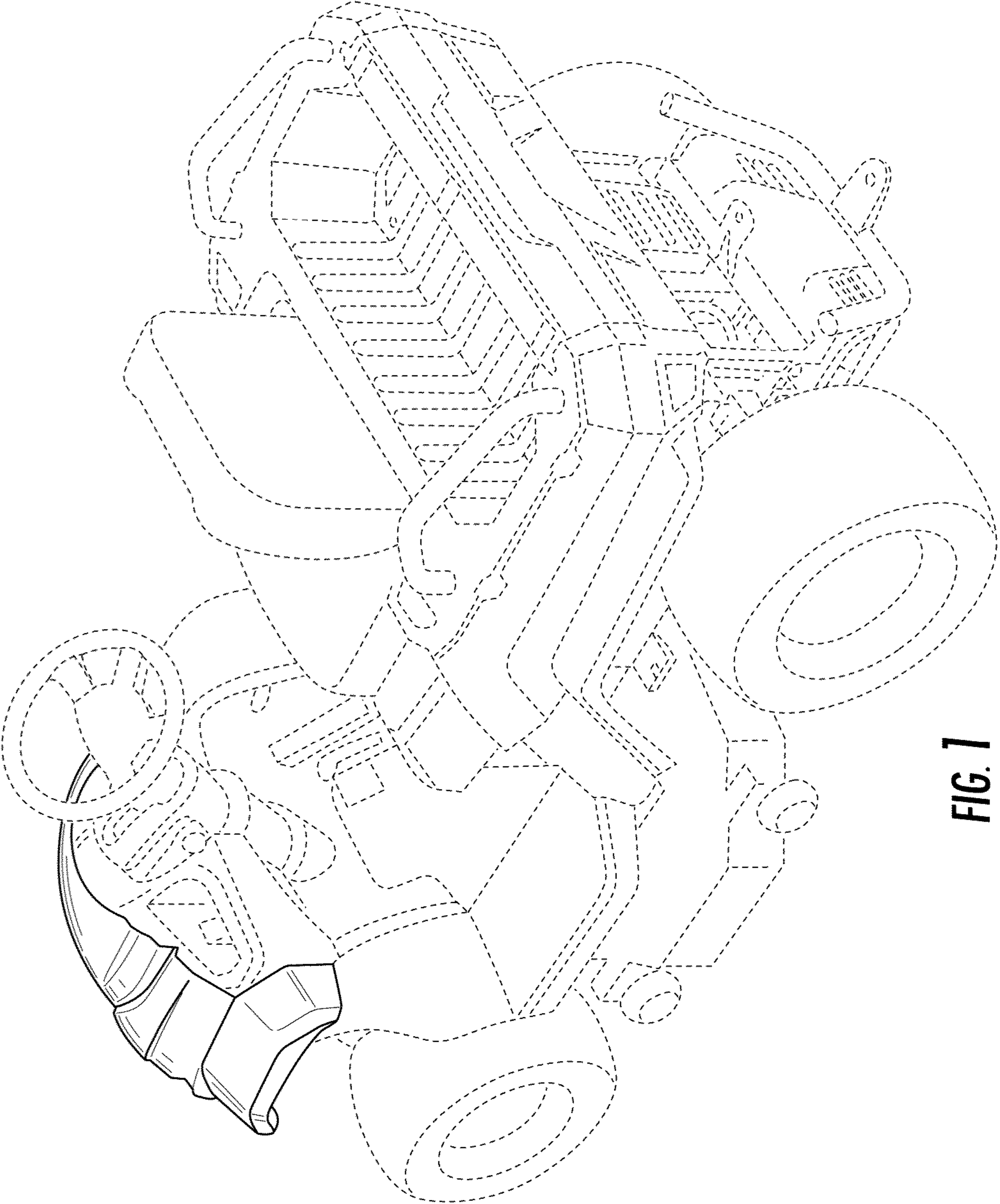
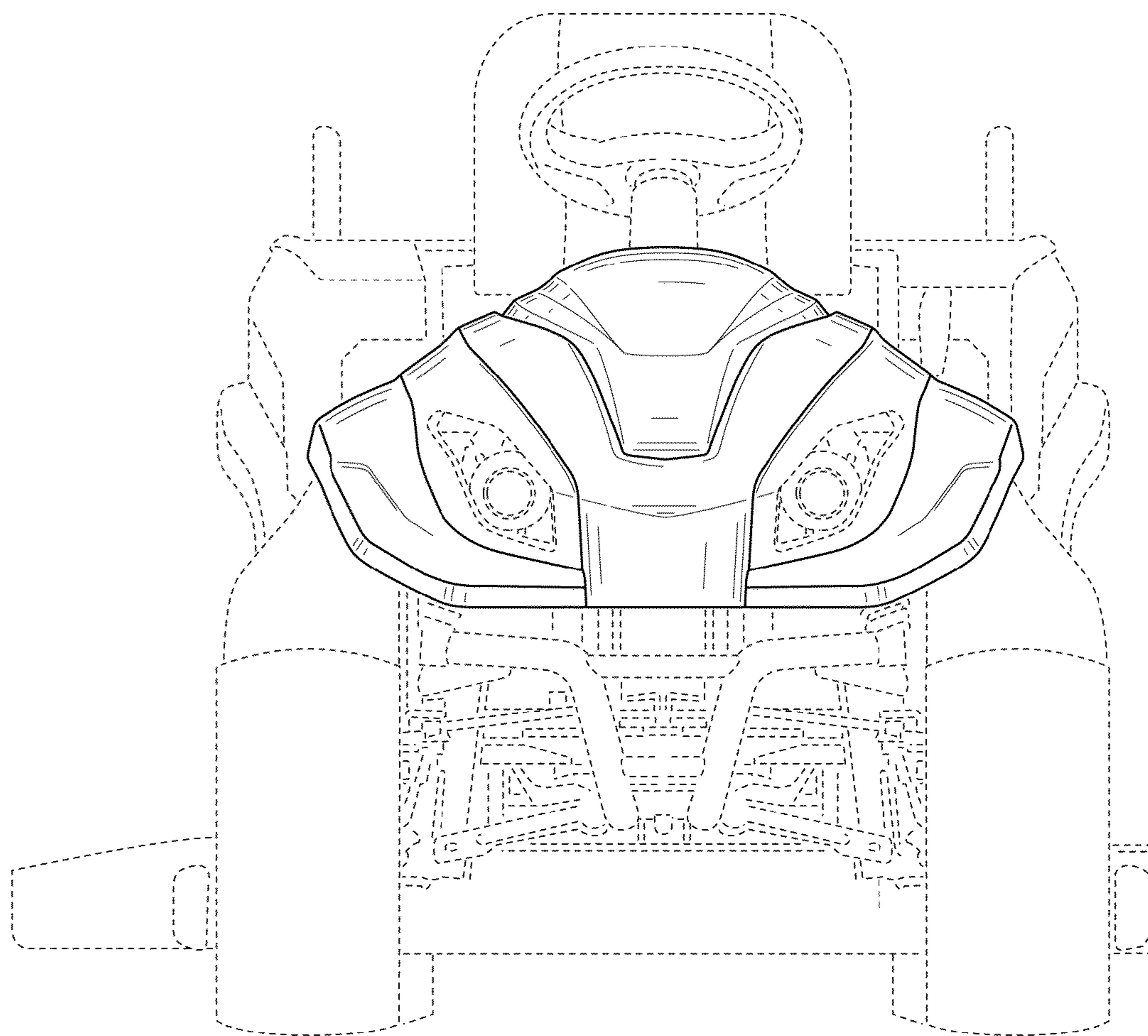
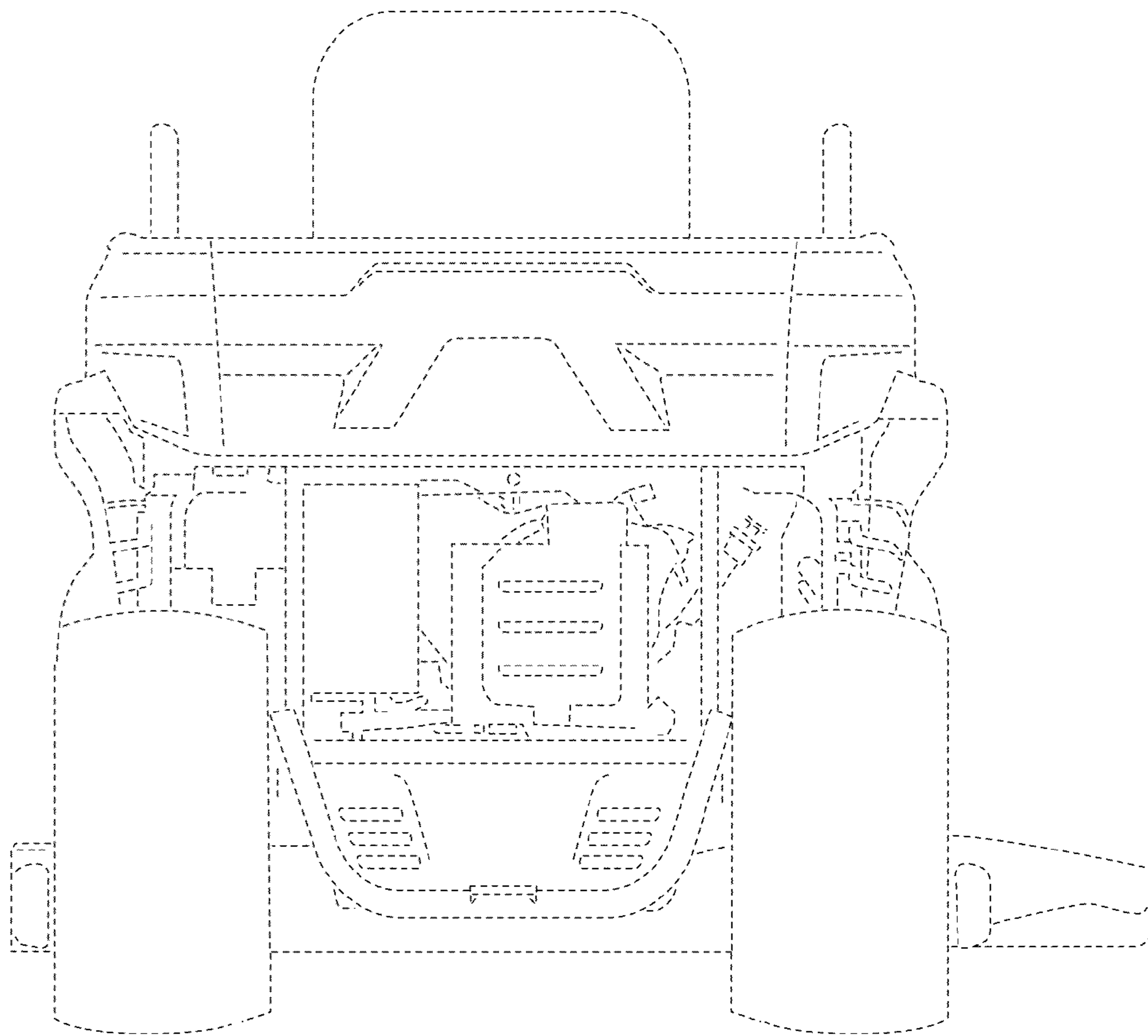

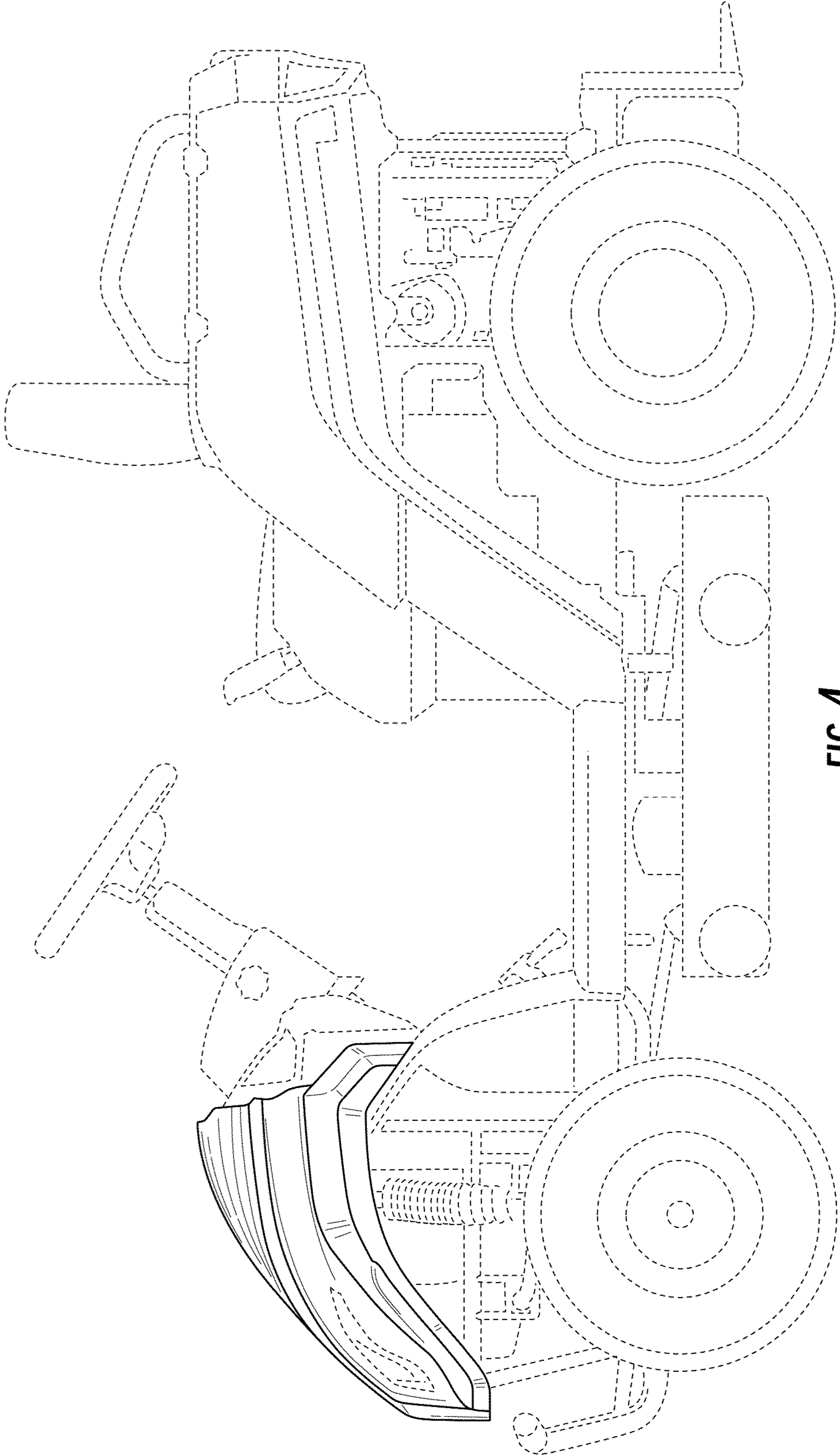

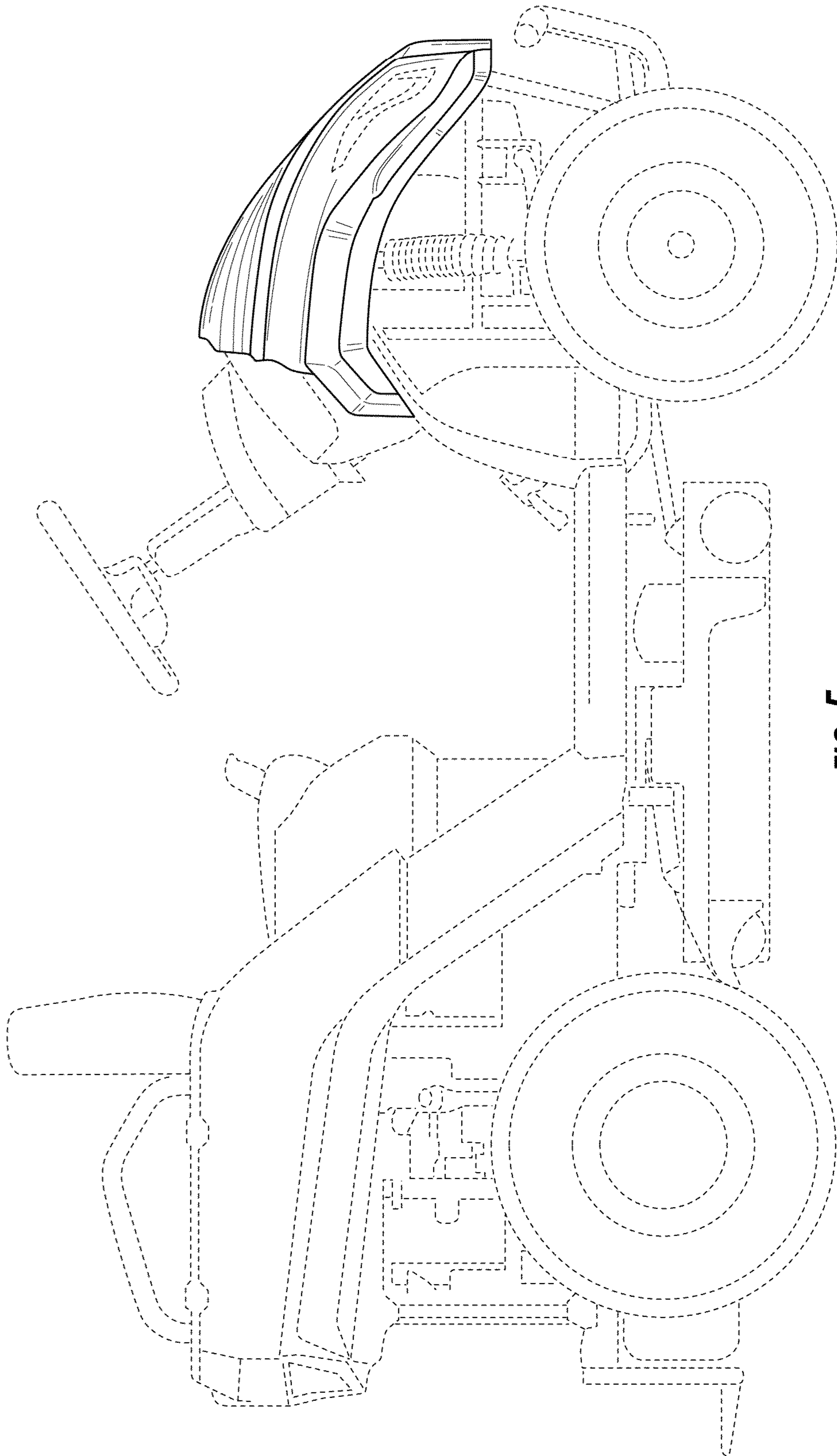

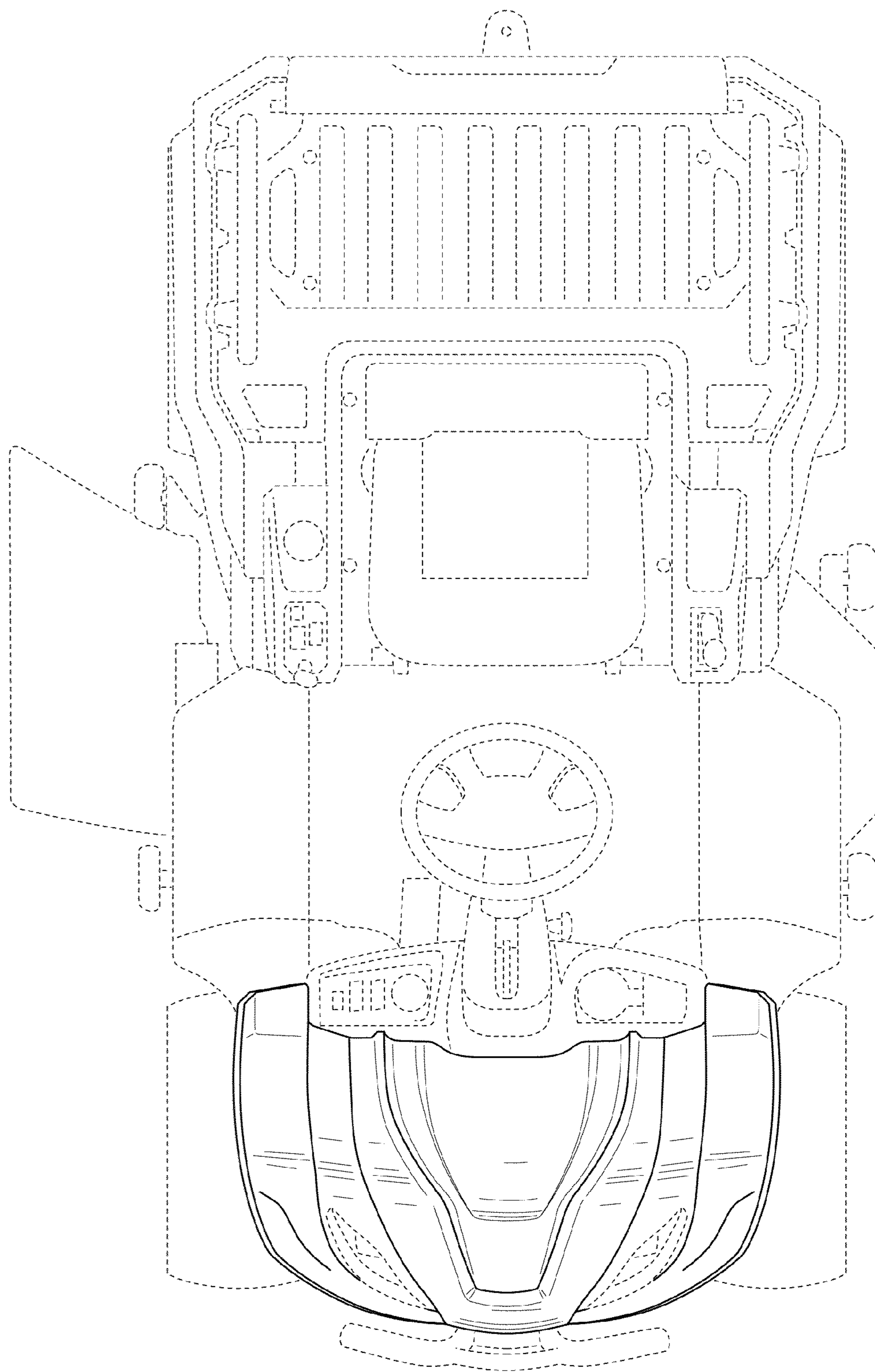

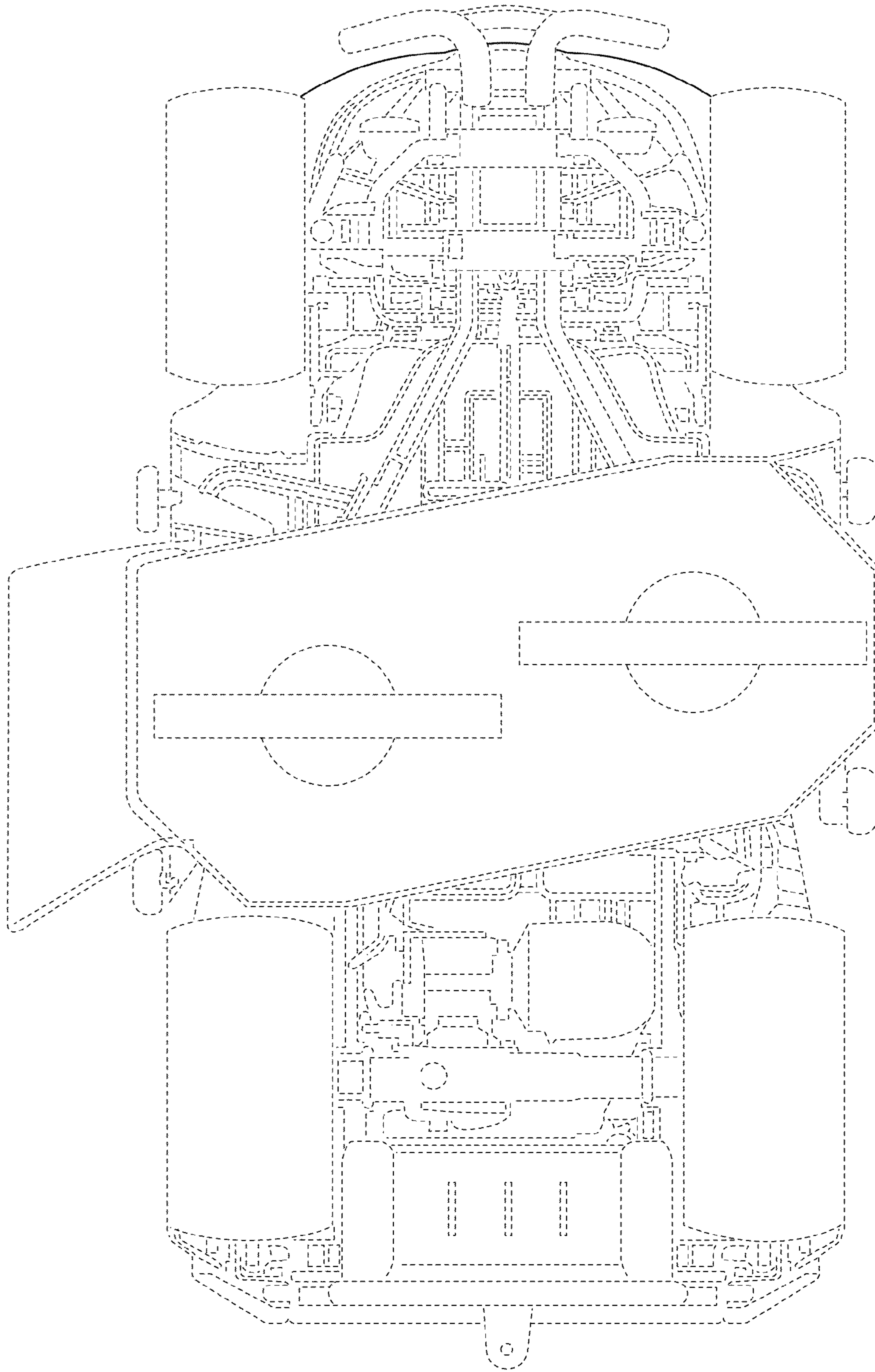
