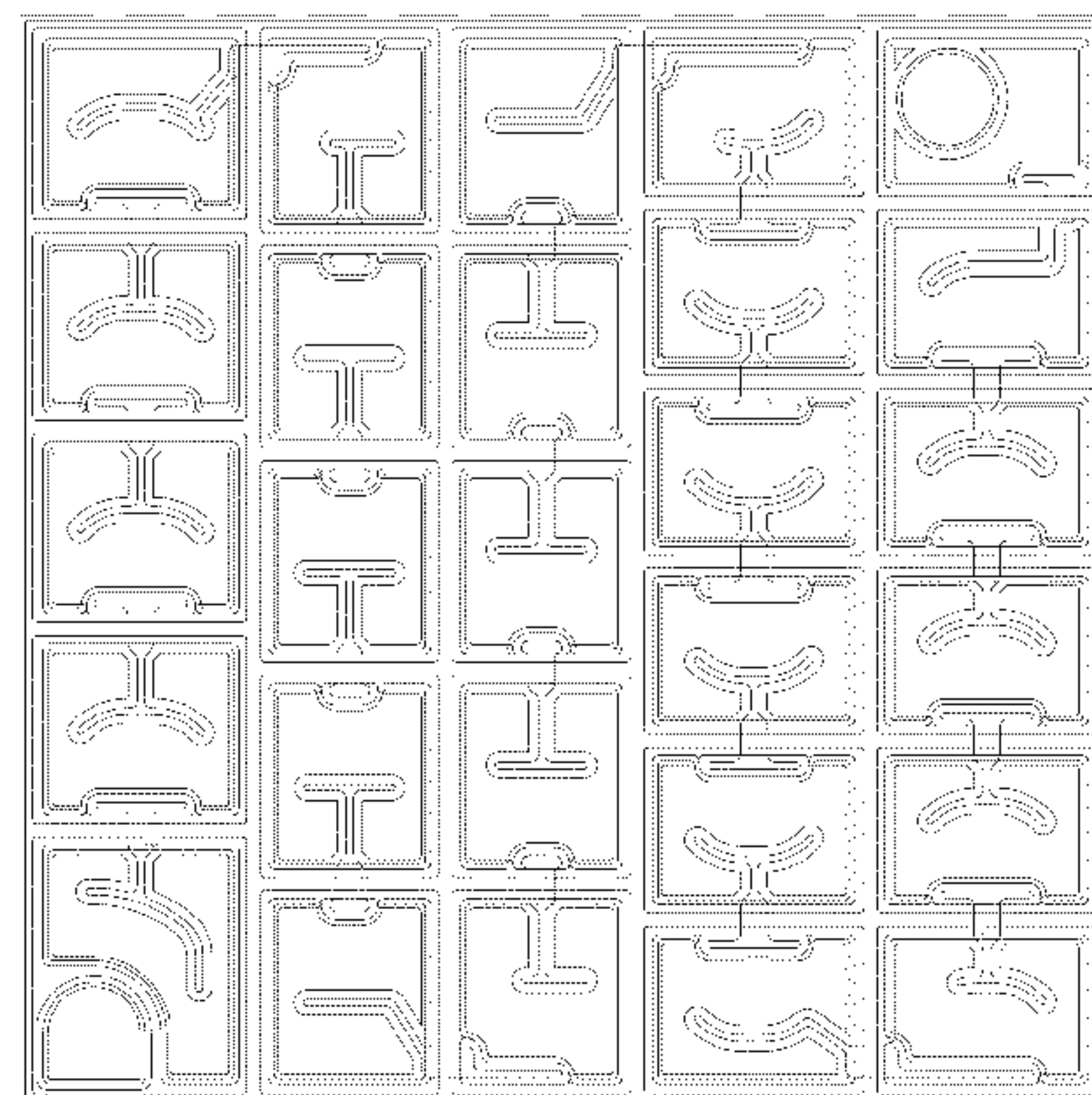
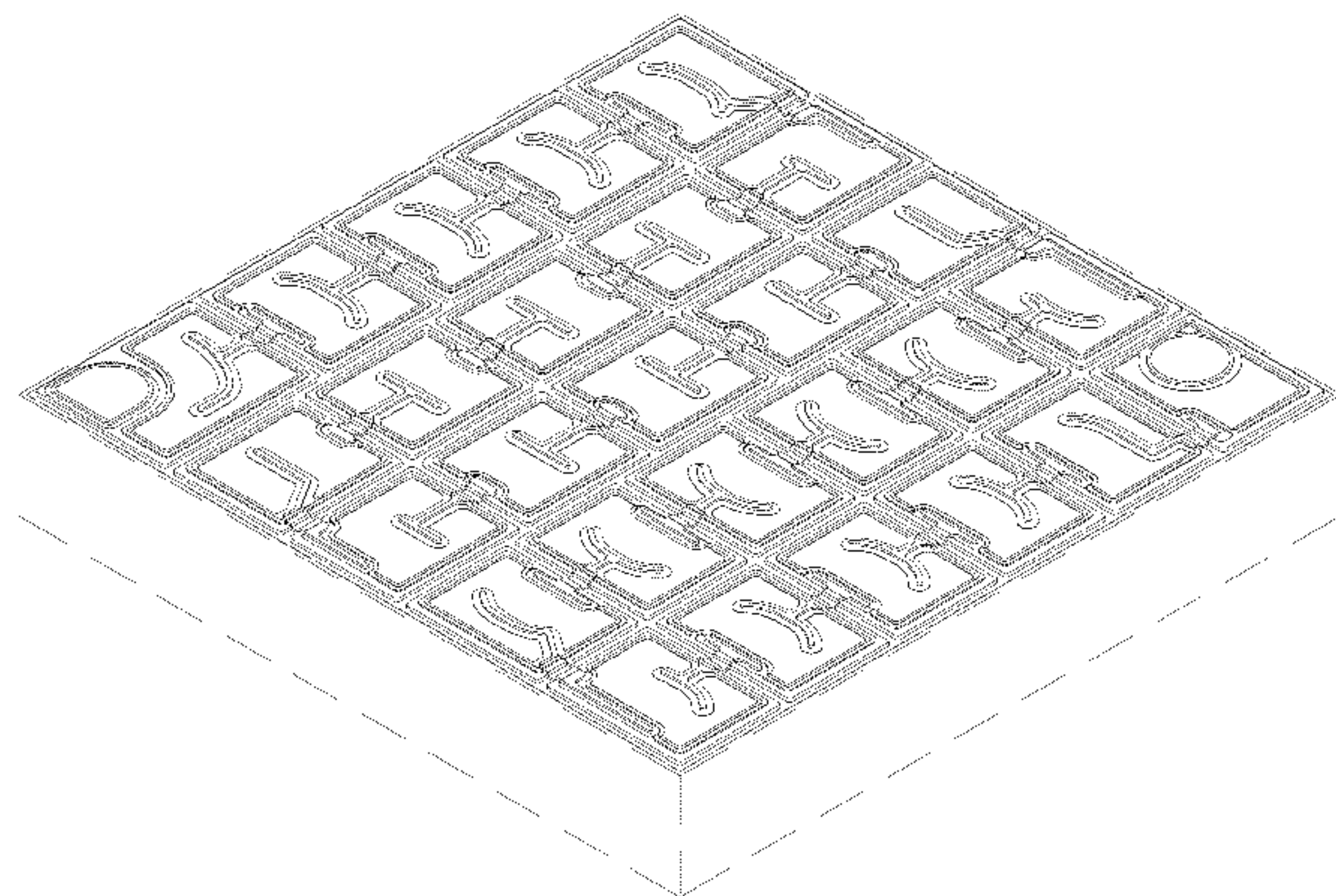
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, bottom, right perspective view of a light-emitting diode array, showing our design;
FIG. 2 is a front, top, left perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevational view thereof;

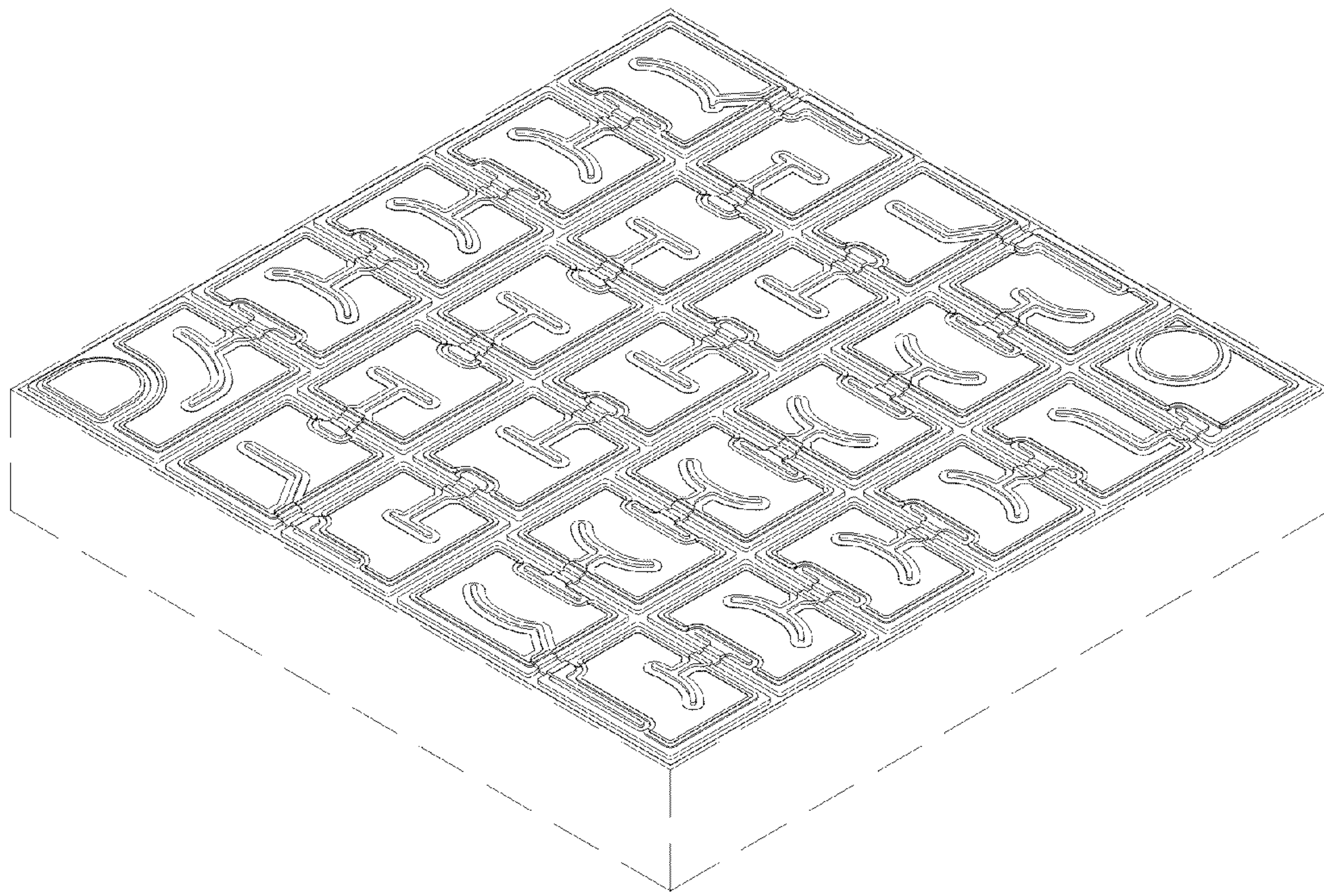

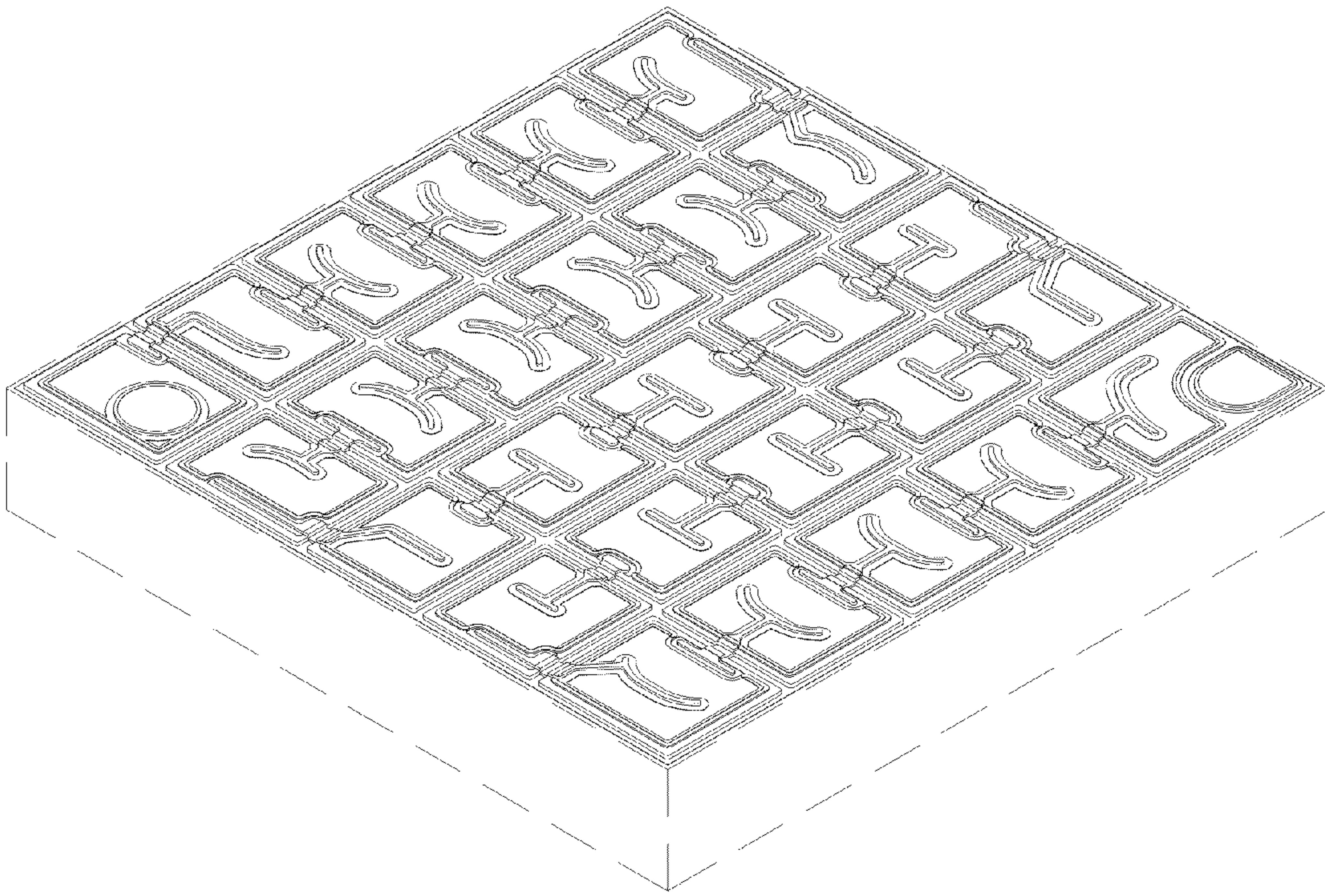

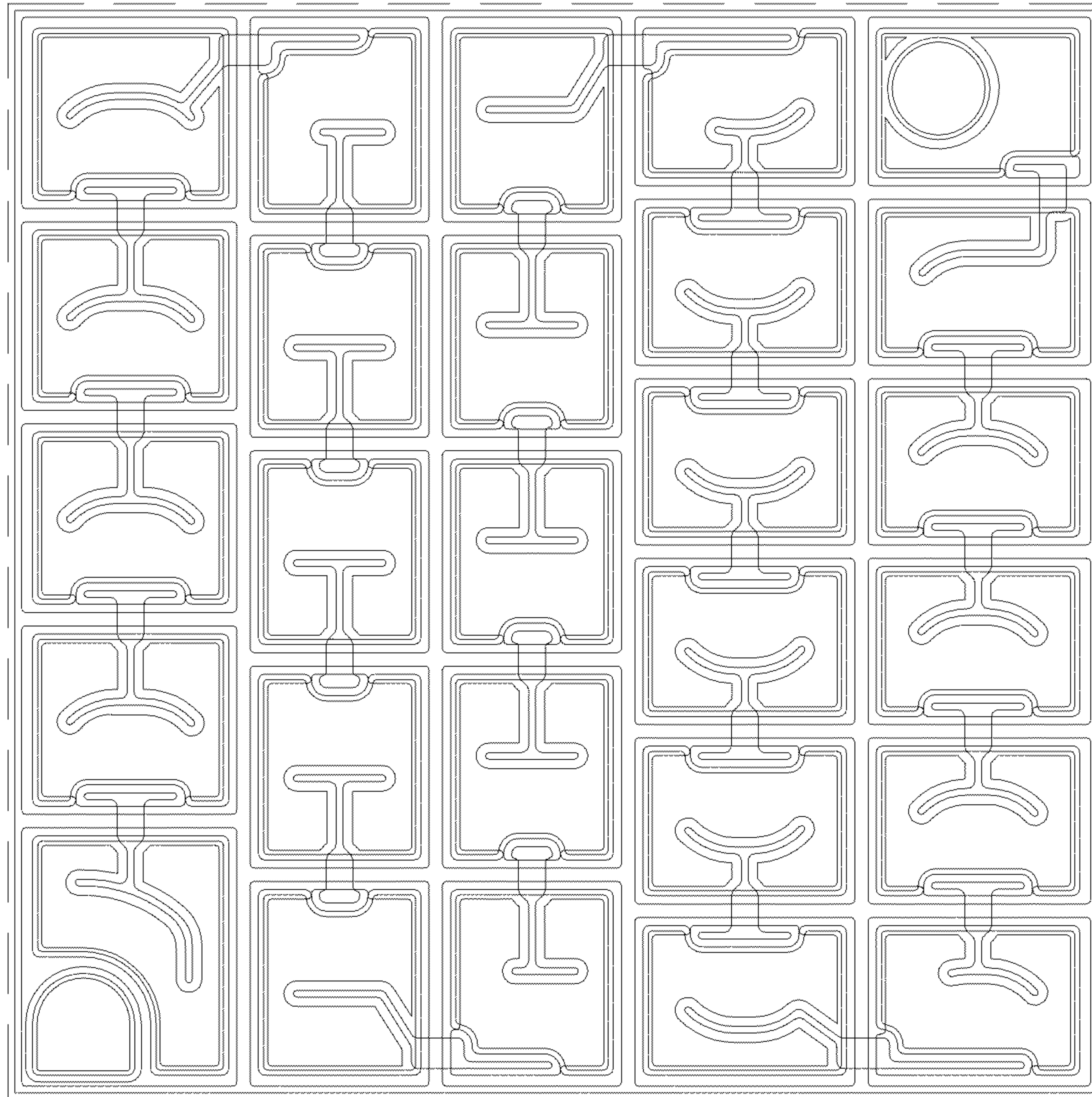

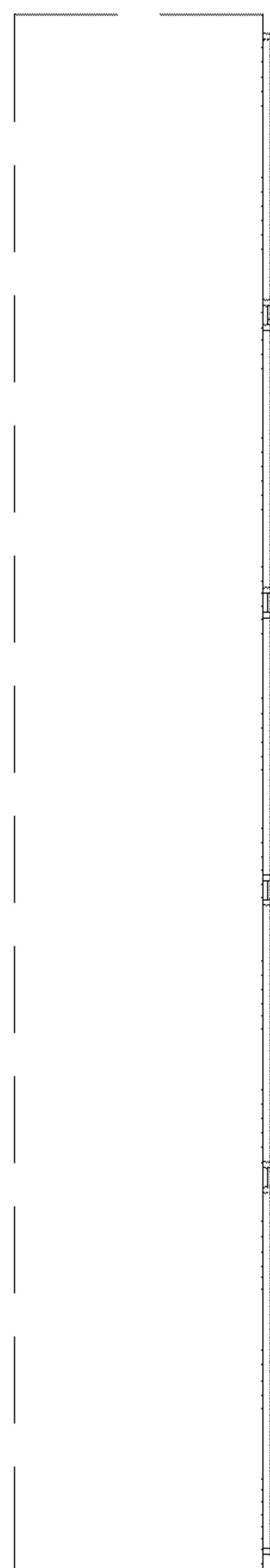

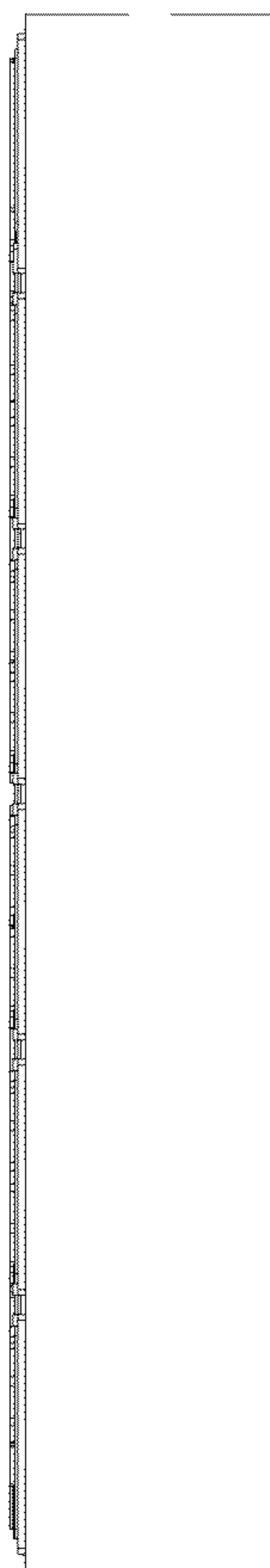

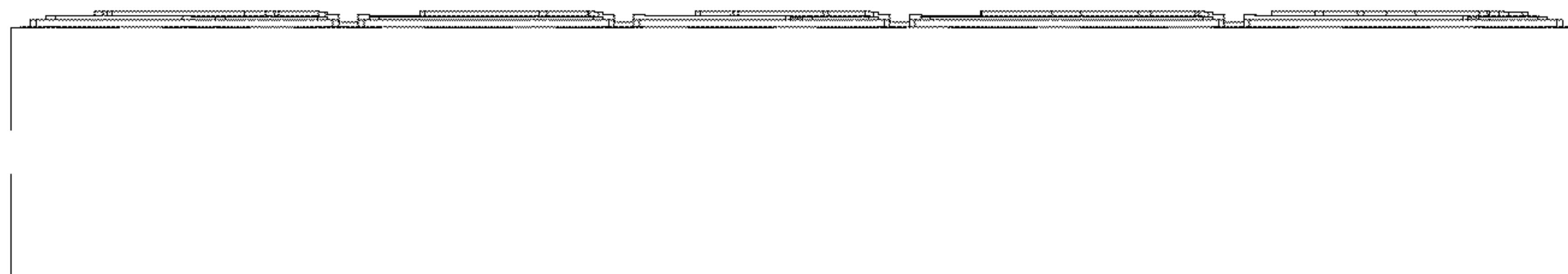
