(57) **CLAIM**

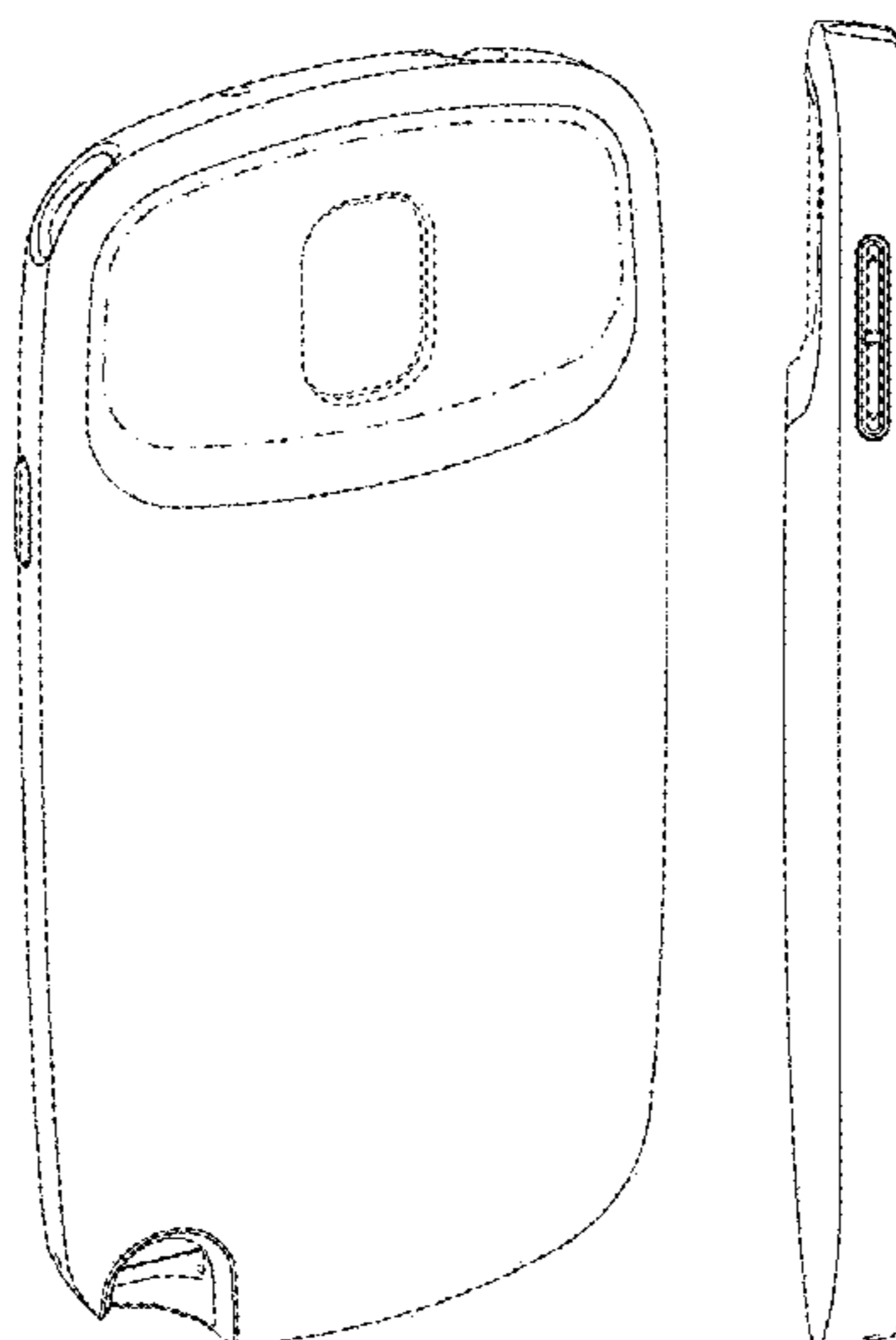
We claim the ornamental design for a smartphone case, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a smartphone case in accordance with the present design;

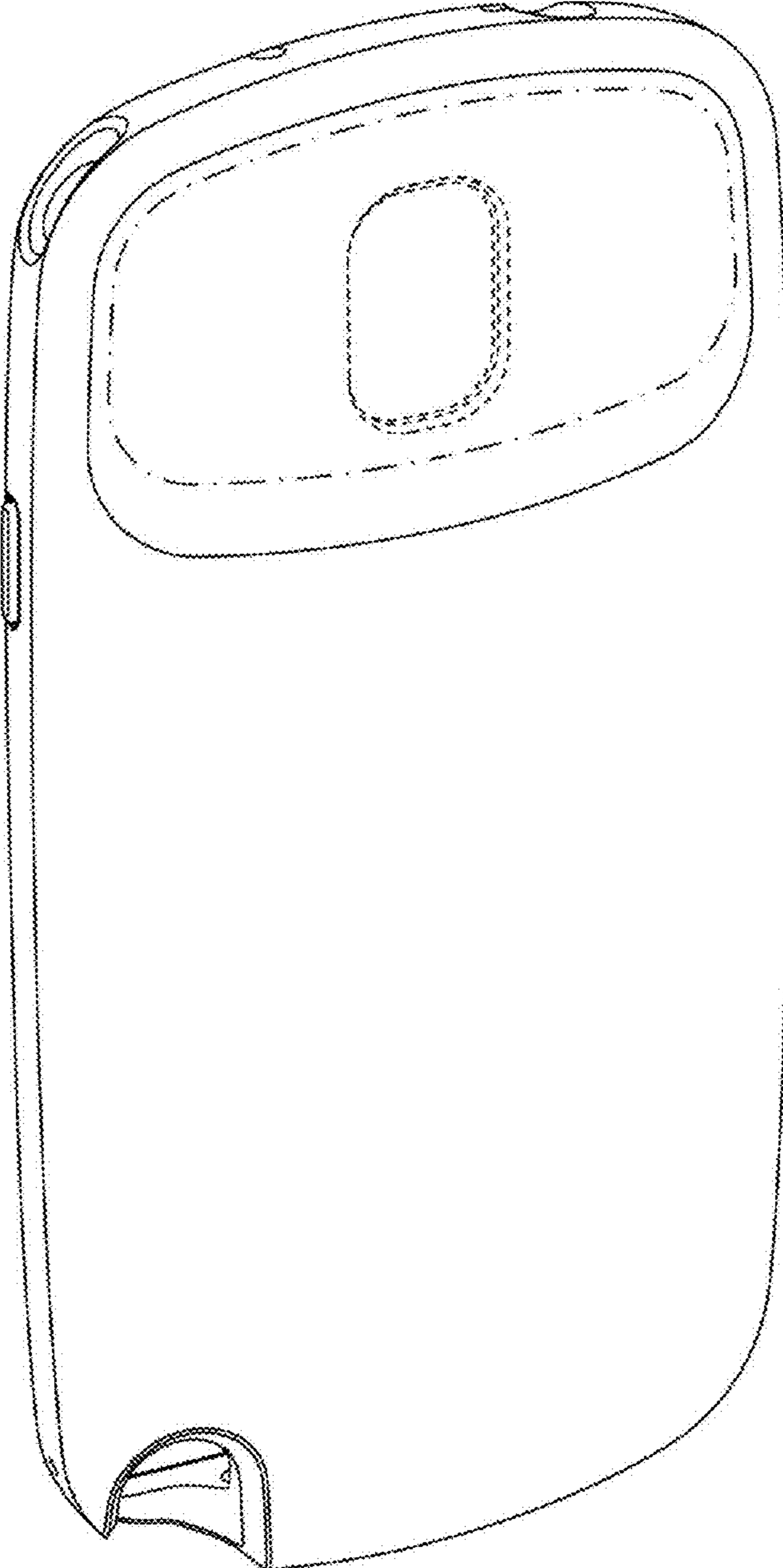

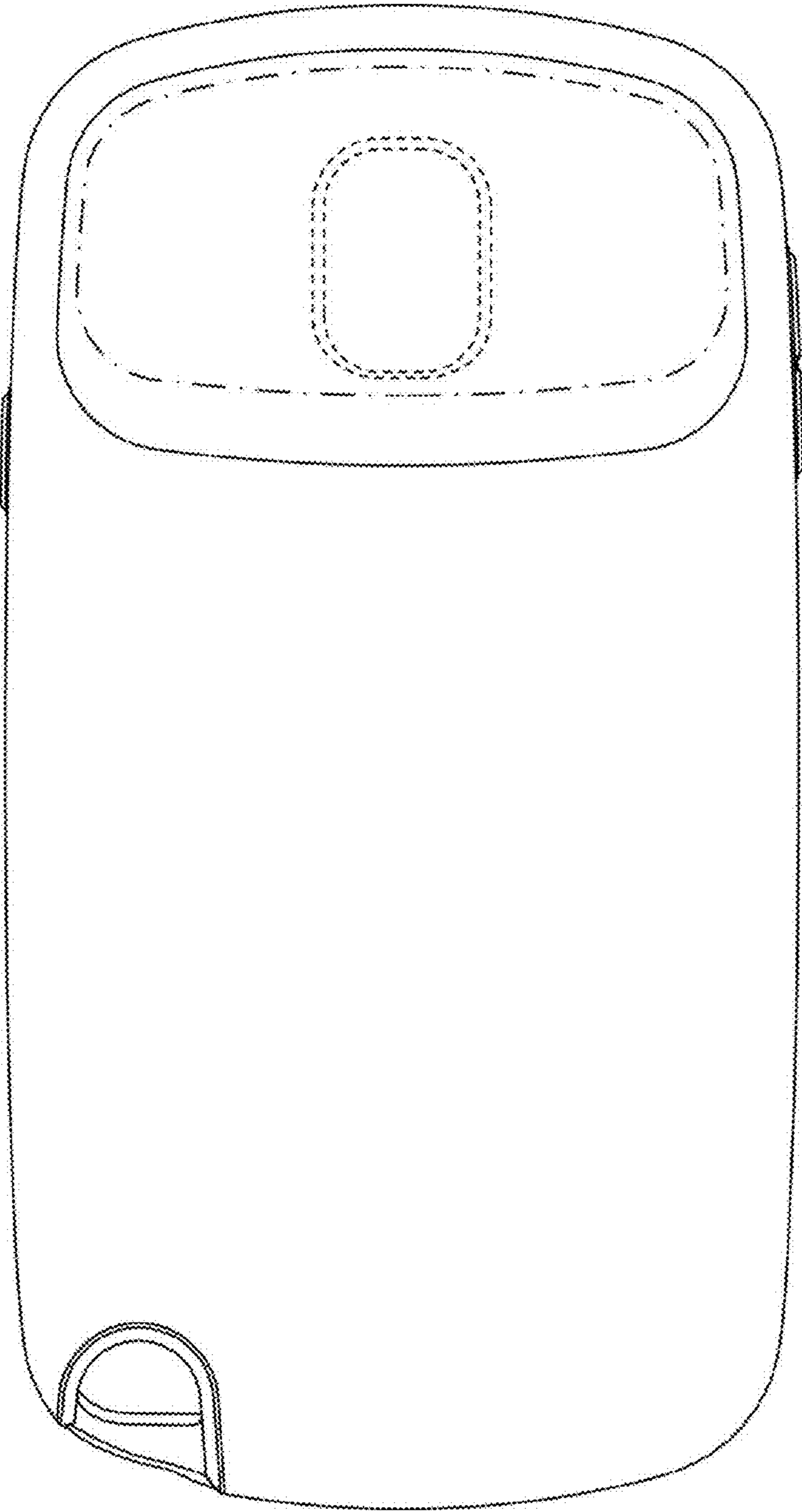

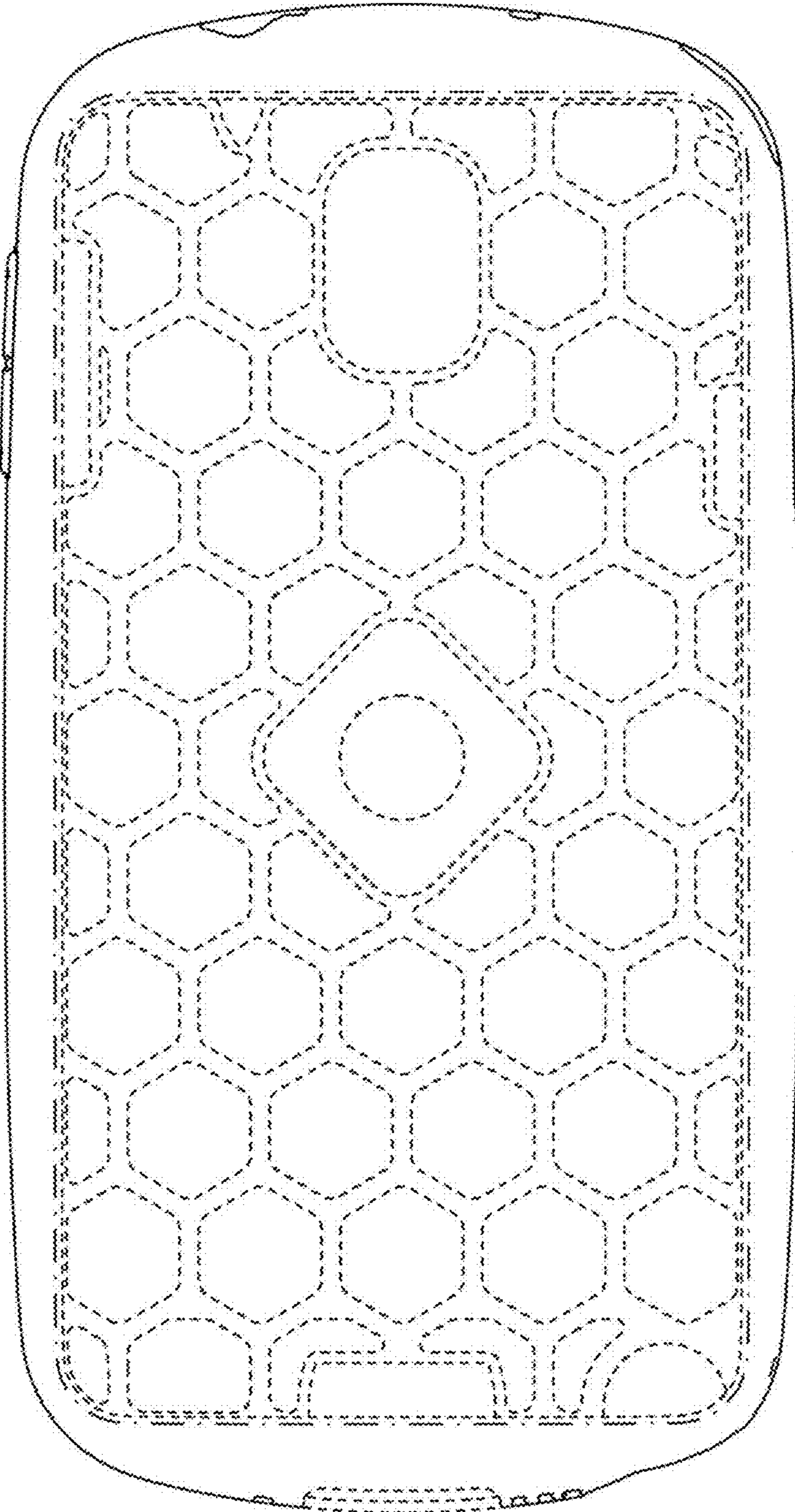

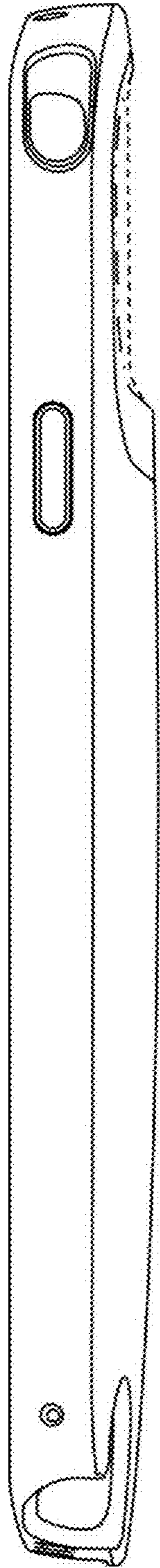

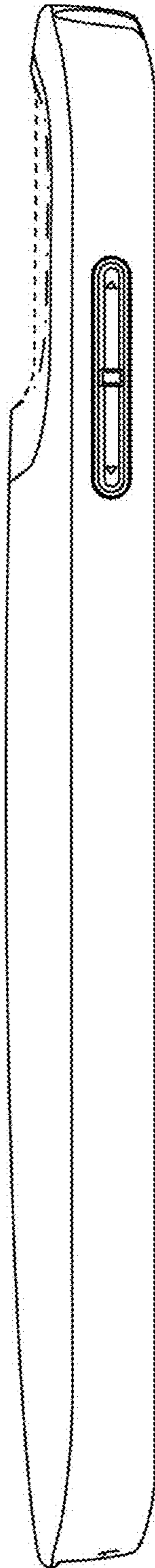

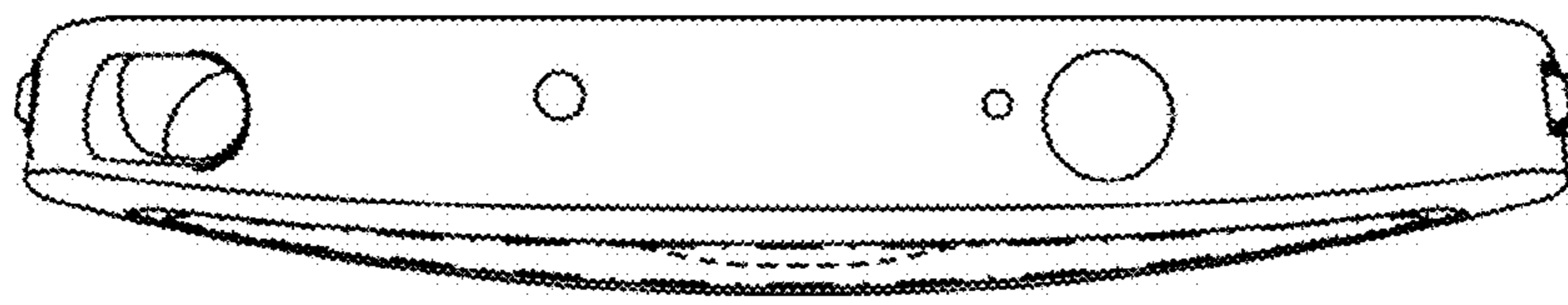

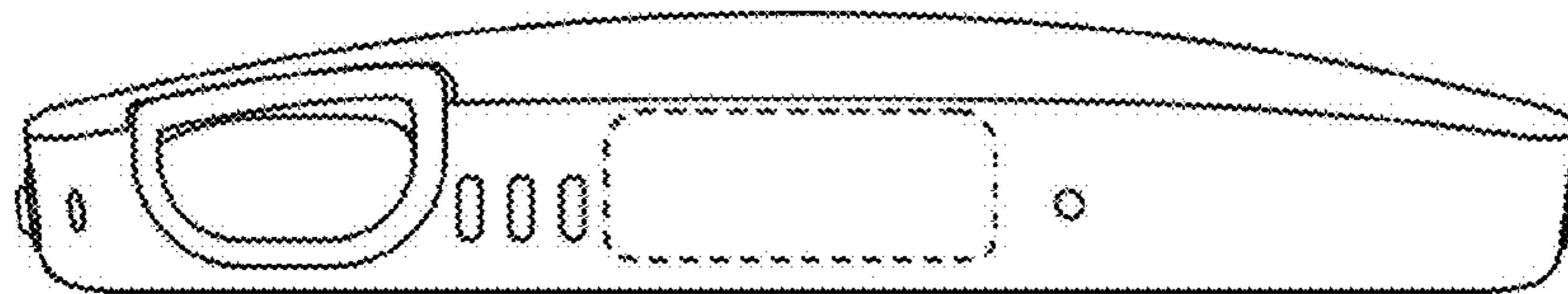
