DESCRIPTION

FIG. 1 is a perspective view of a head mounted display showing our new design;

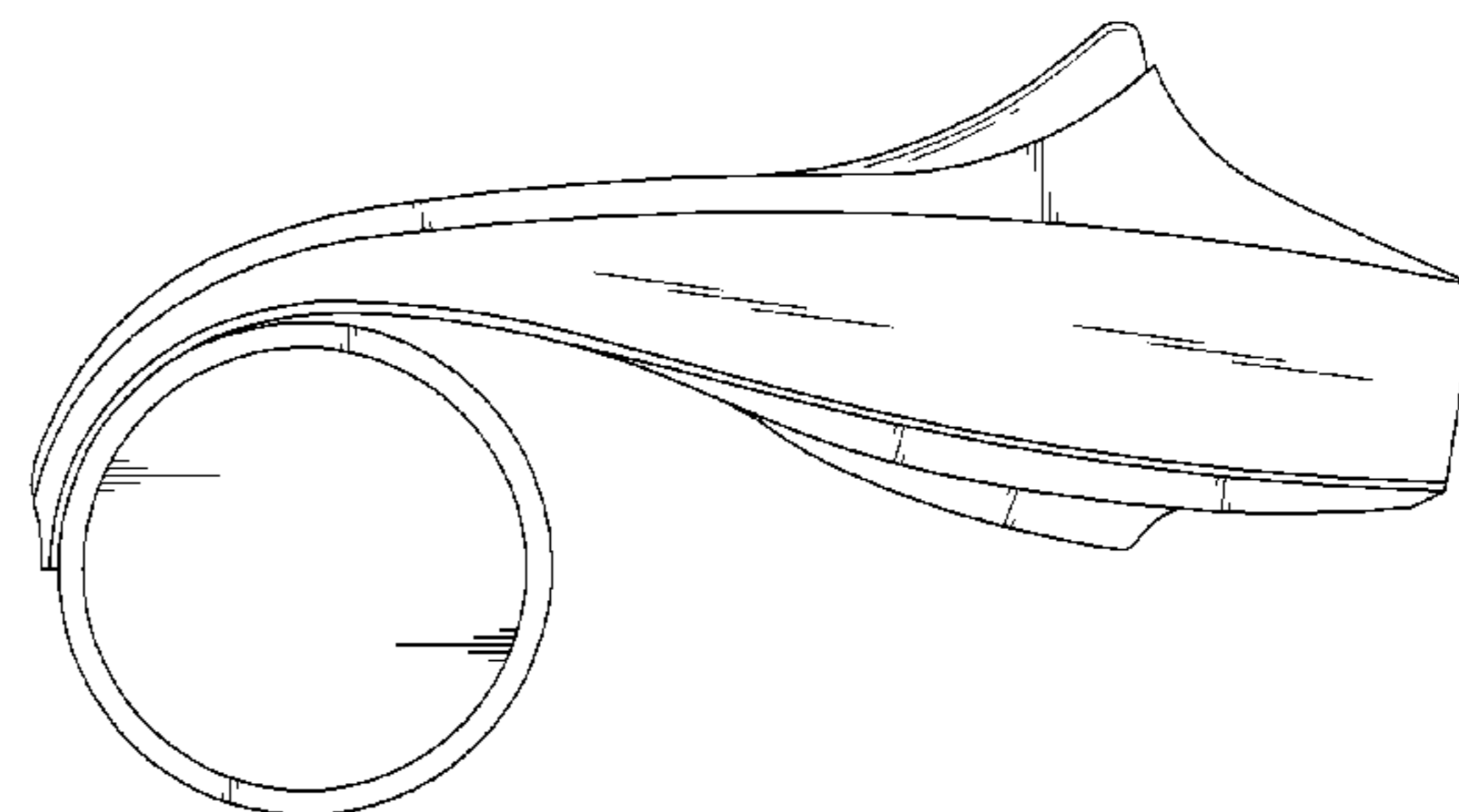
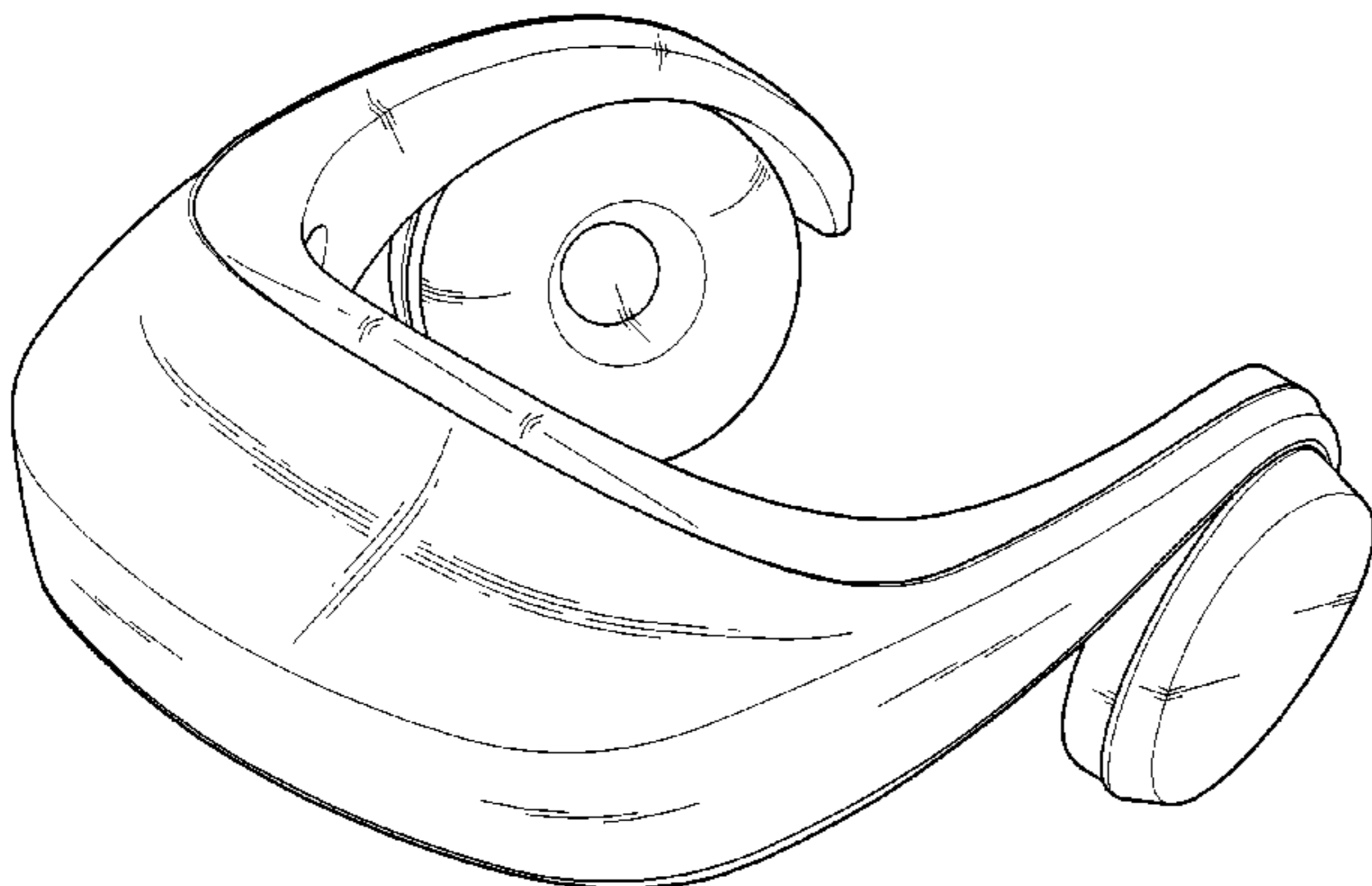

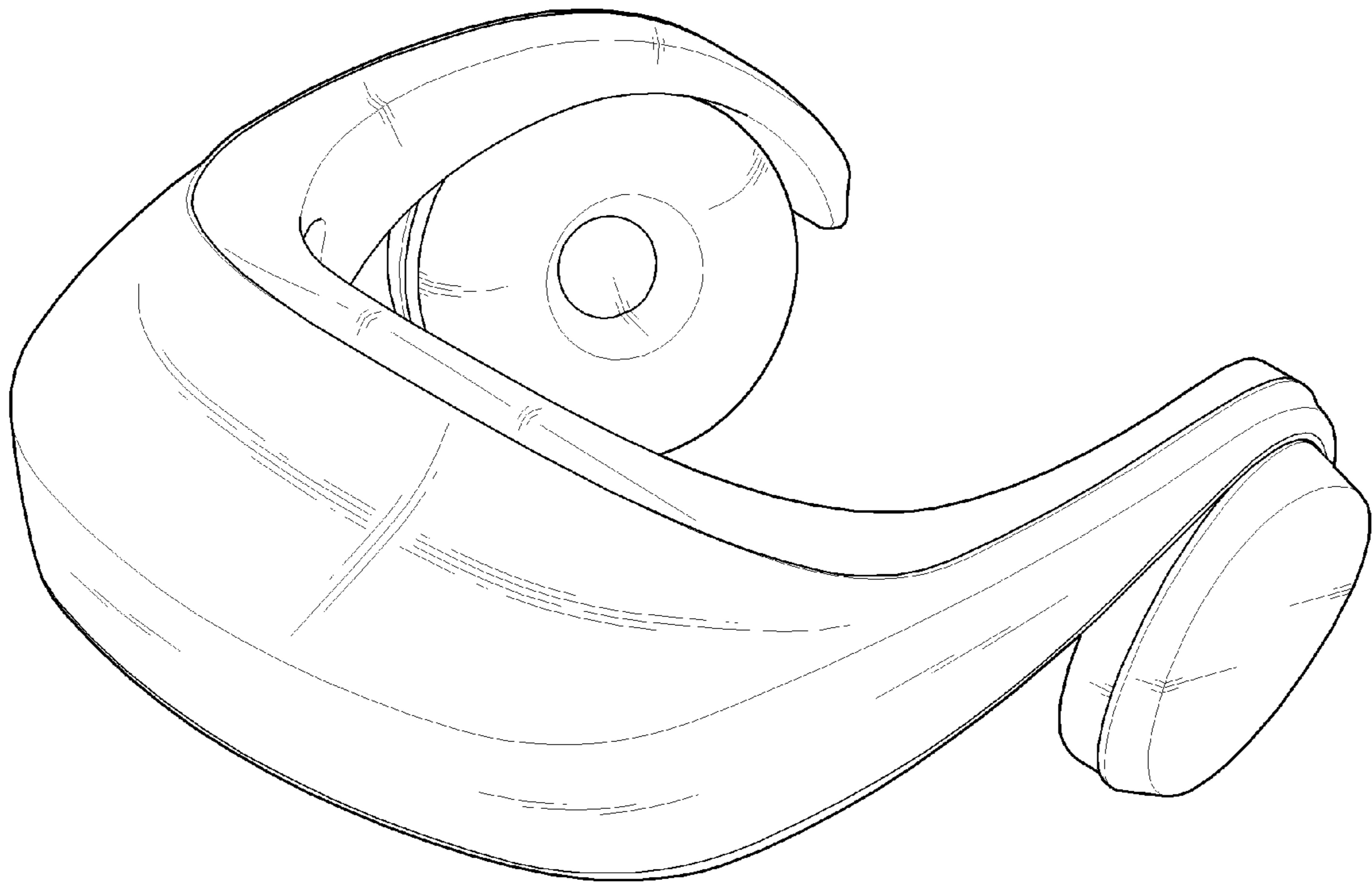

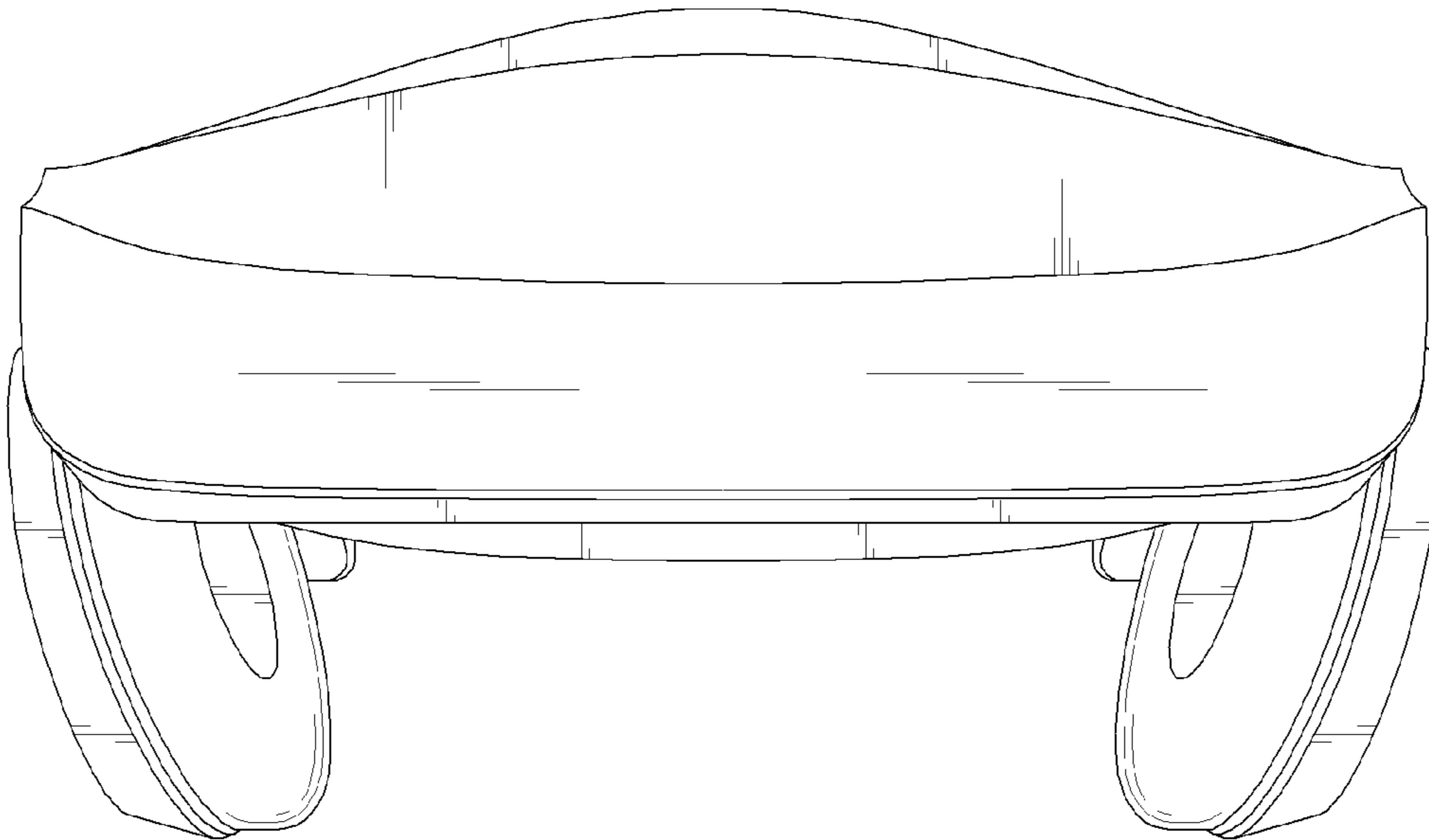

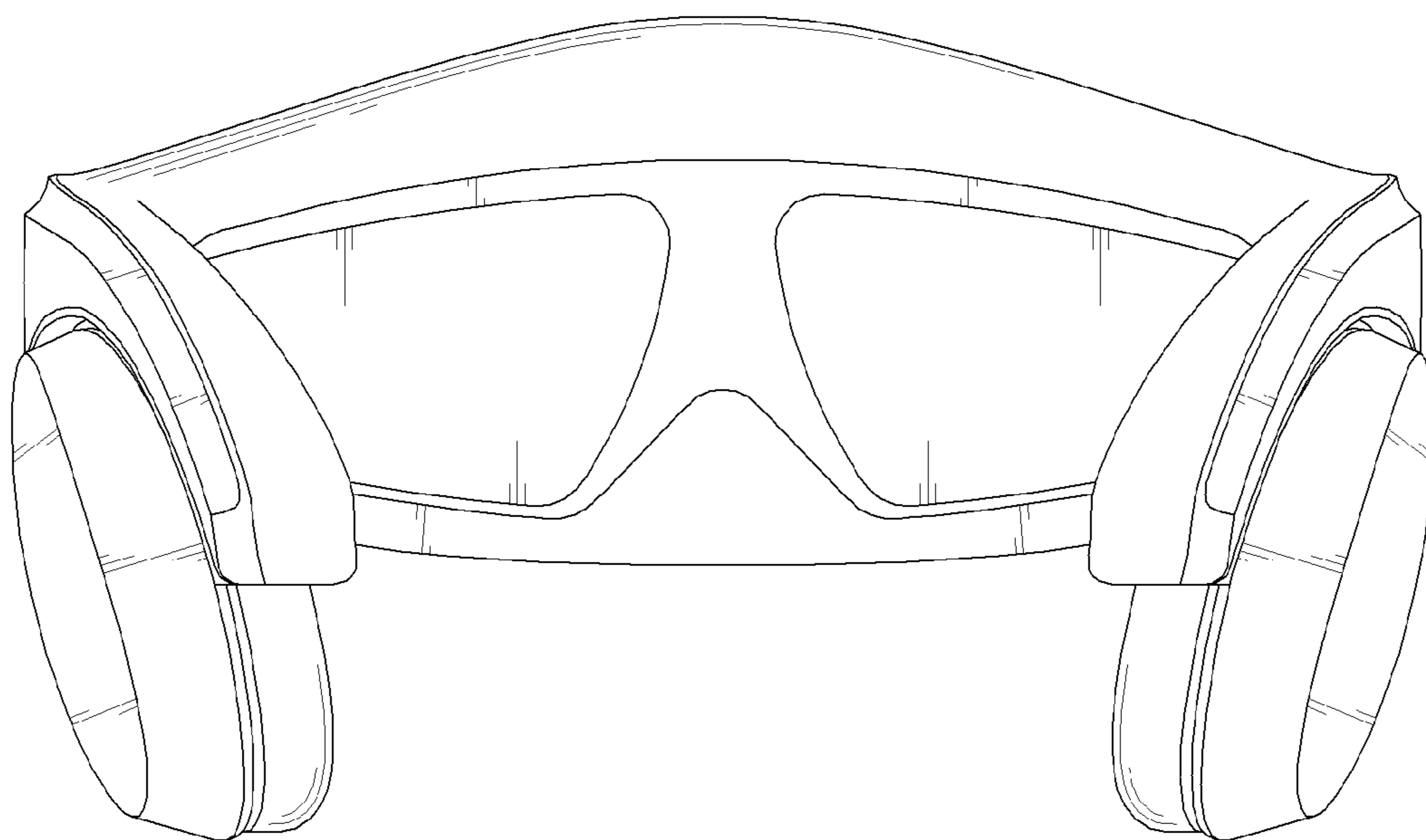

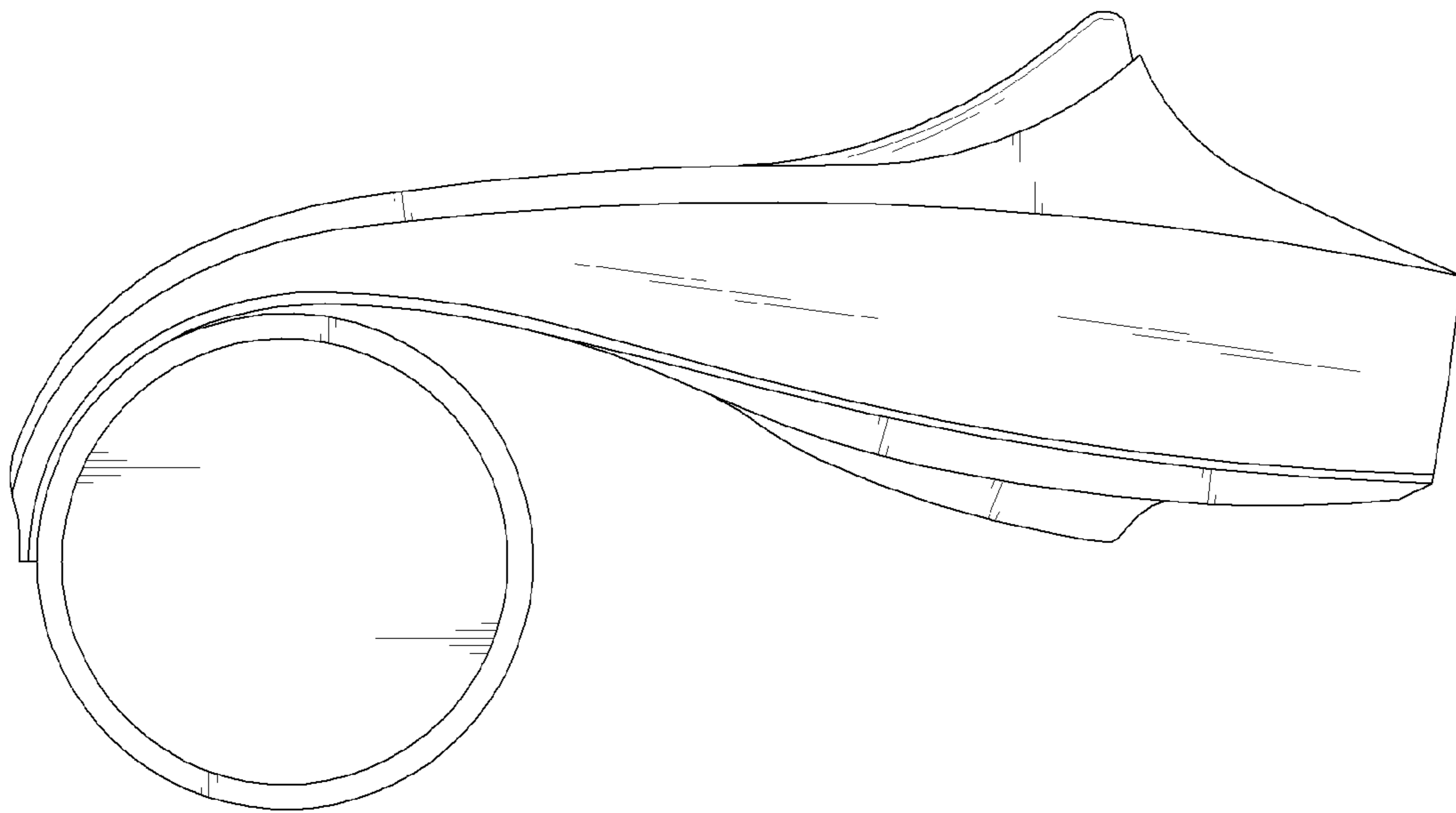

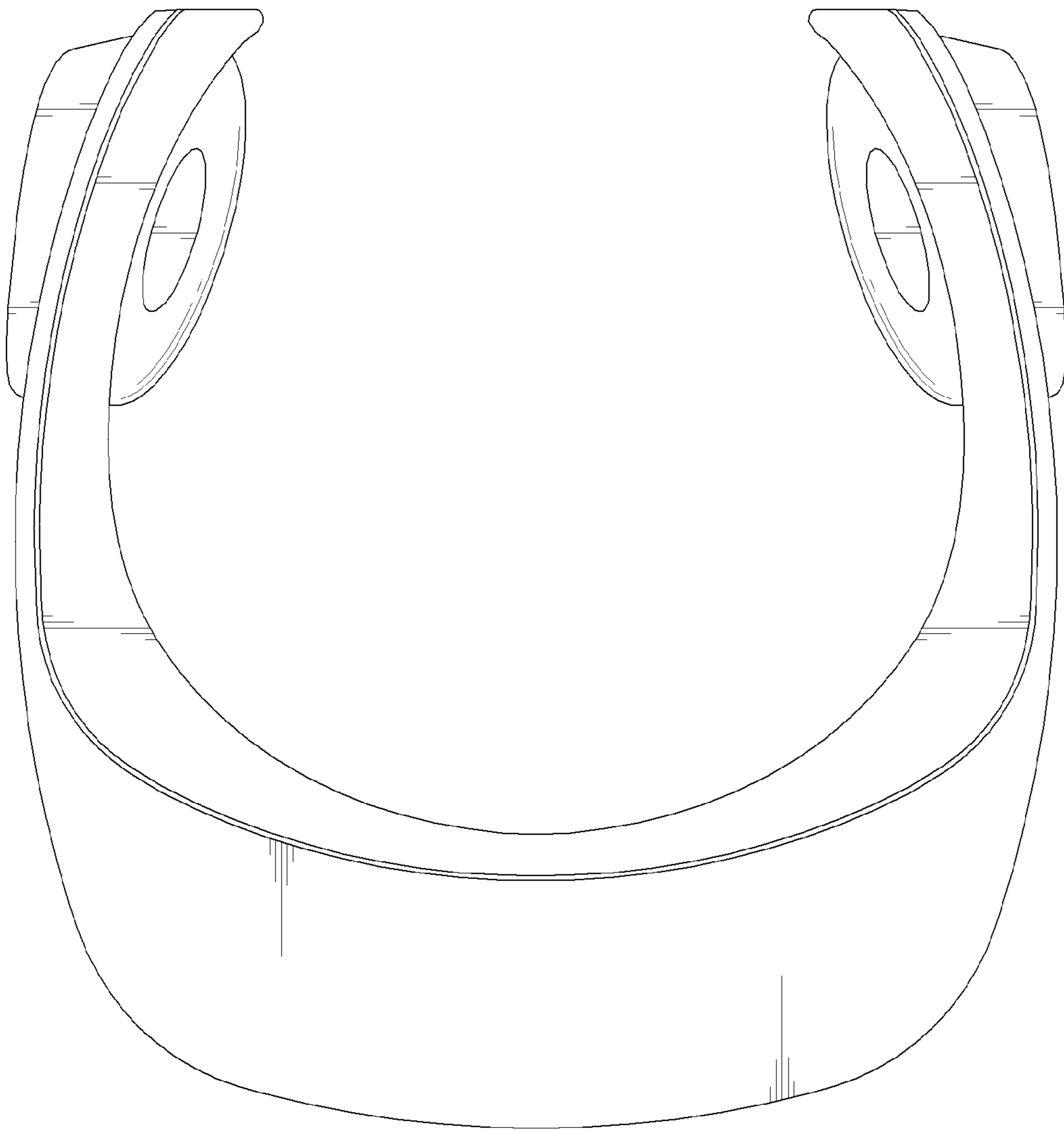

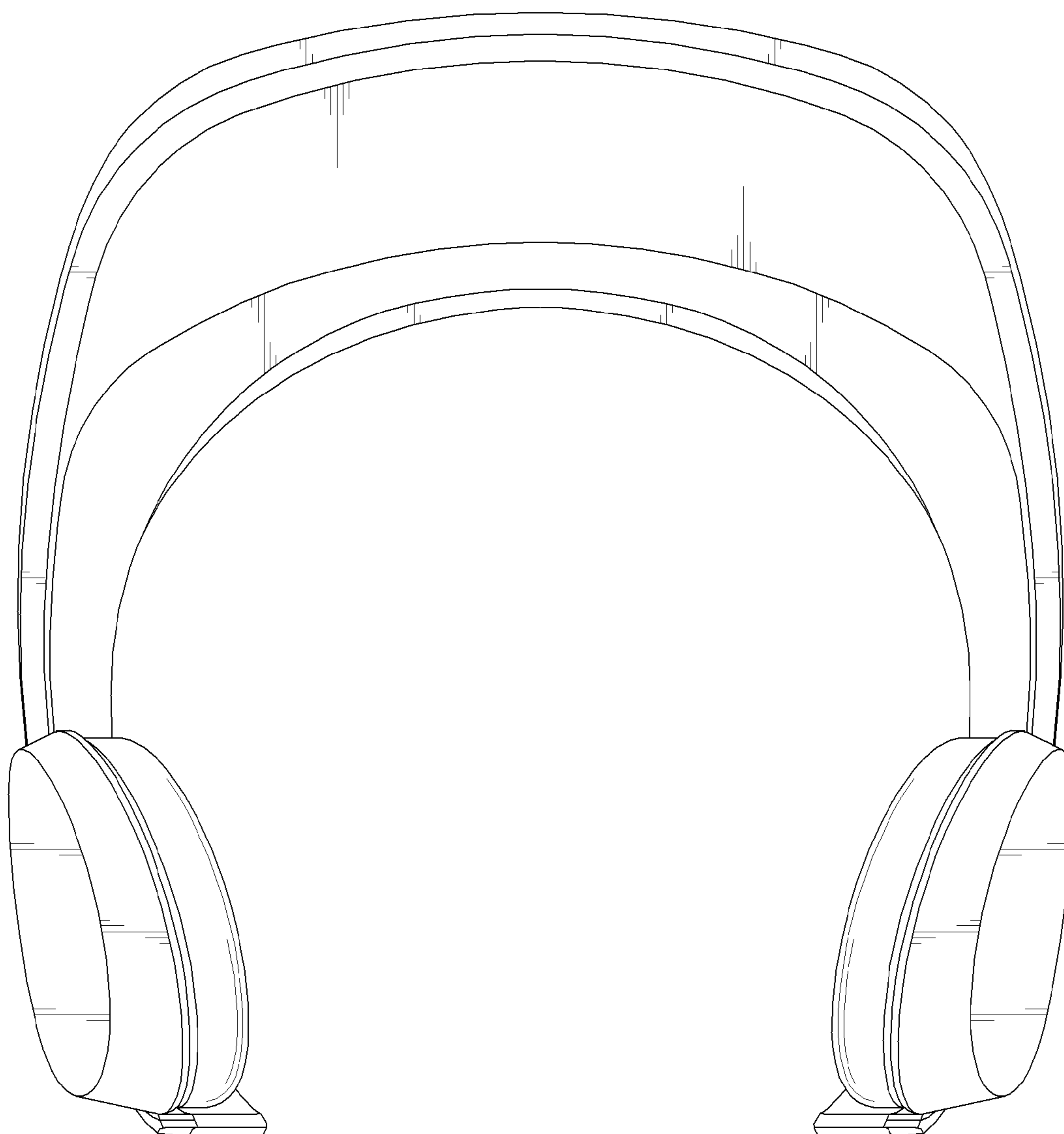
