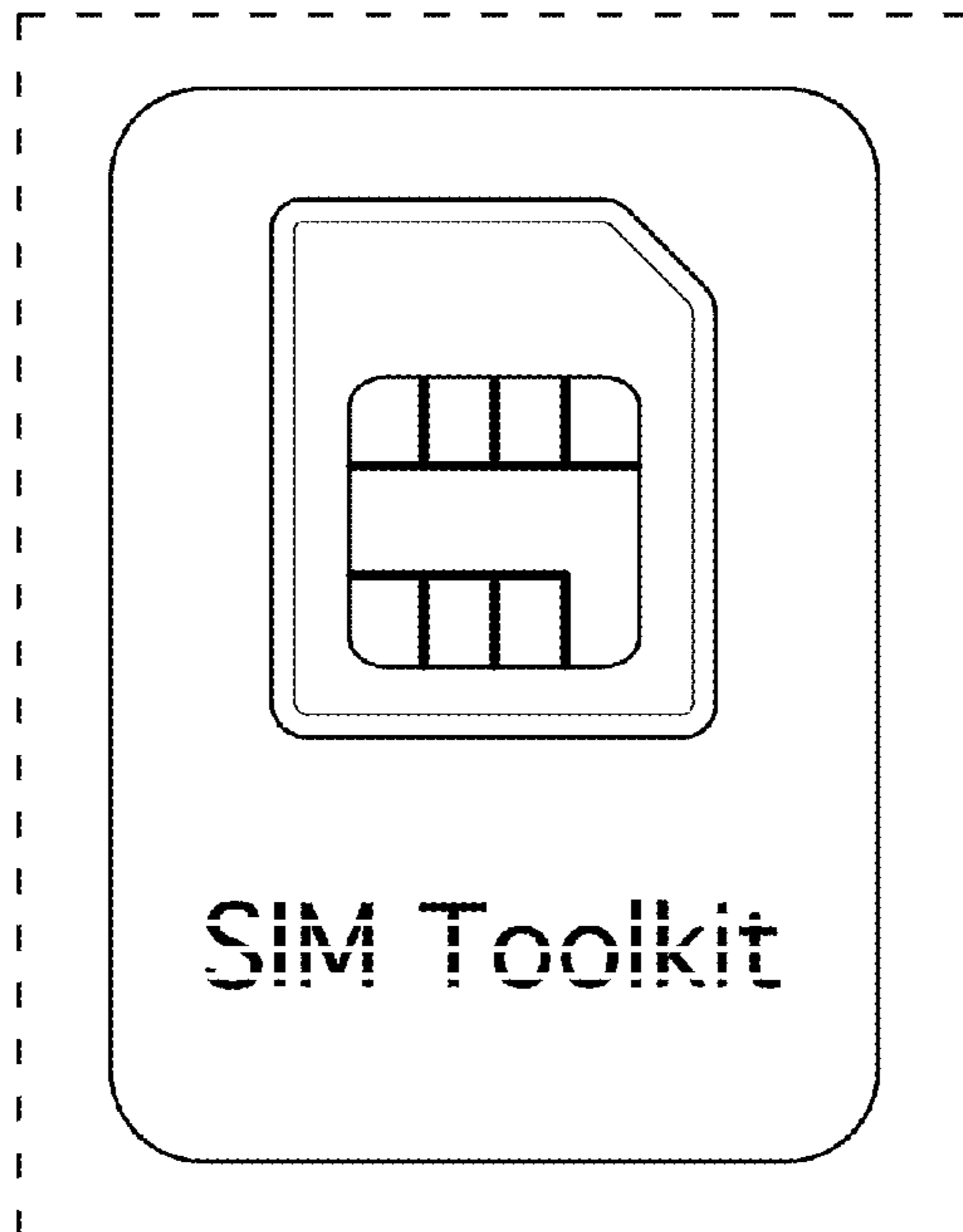
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with icon, as shown and described.

DESCRIPTION

The broken lines surrounding the icon depict a display screen or portion thereof on which the icon is presented and forms no part of the claimed design. 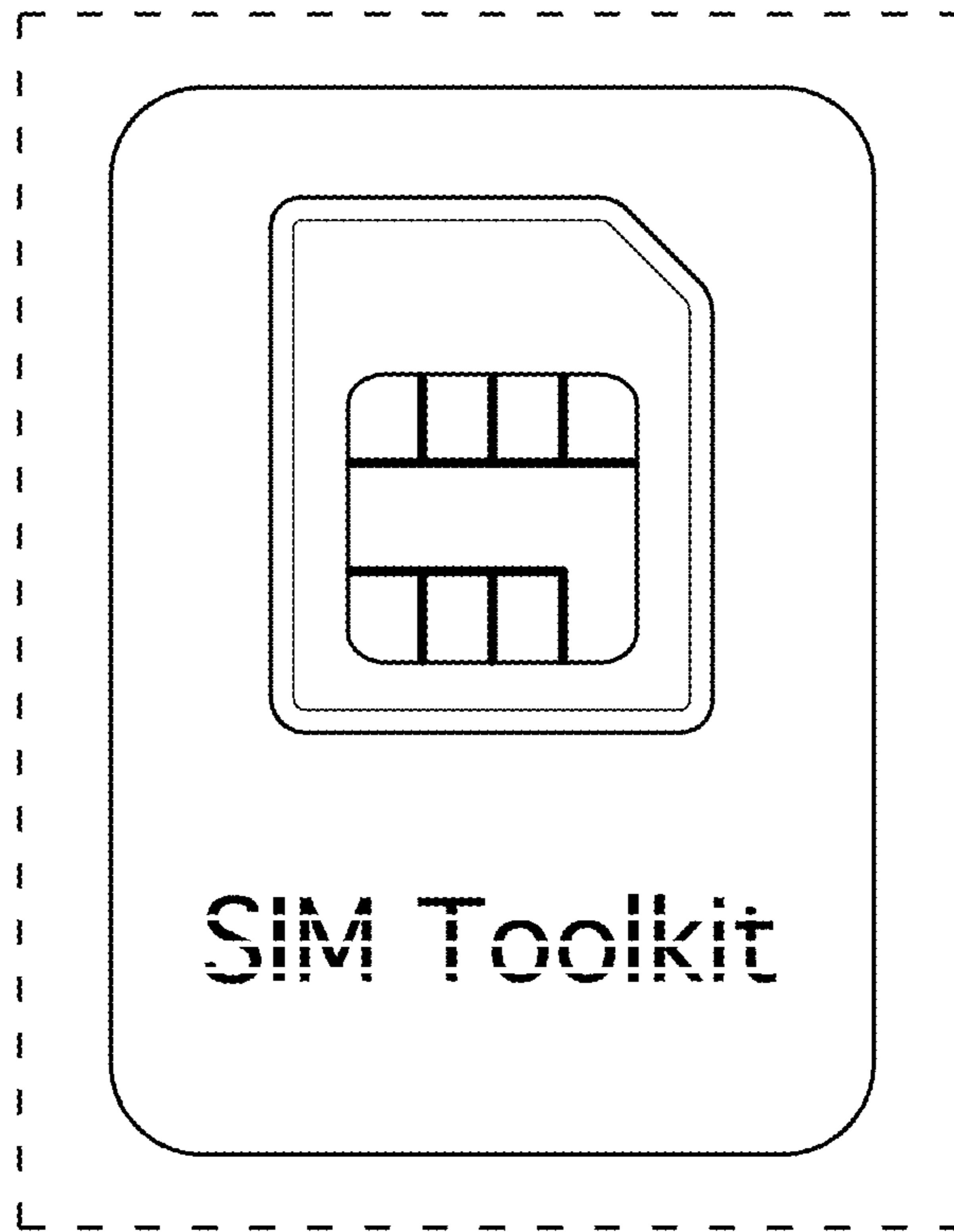

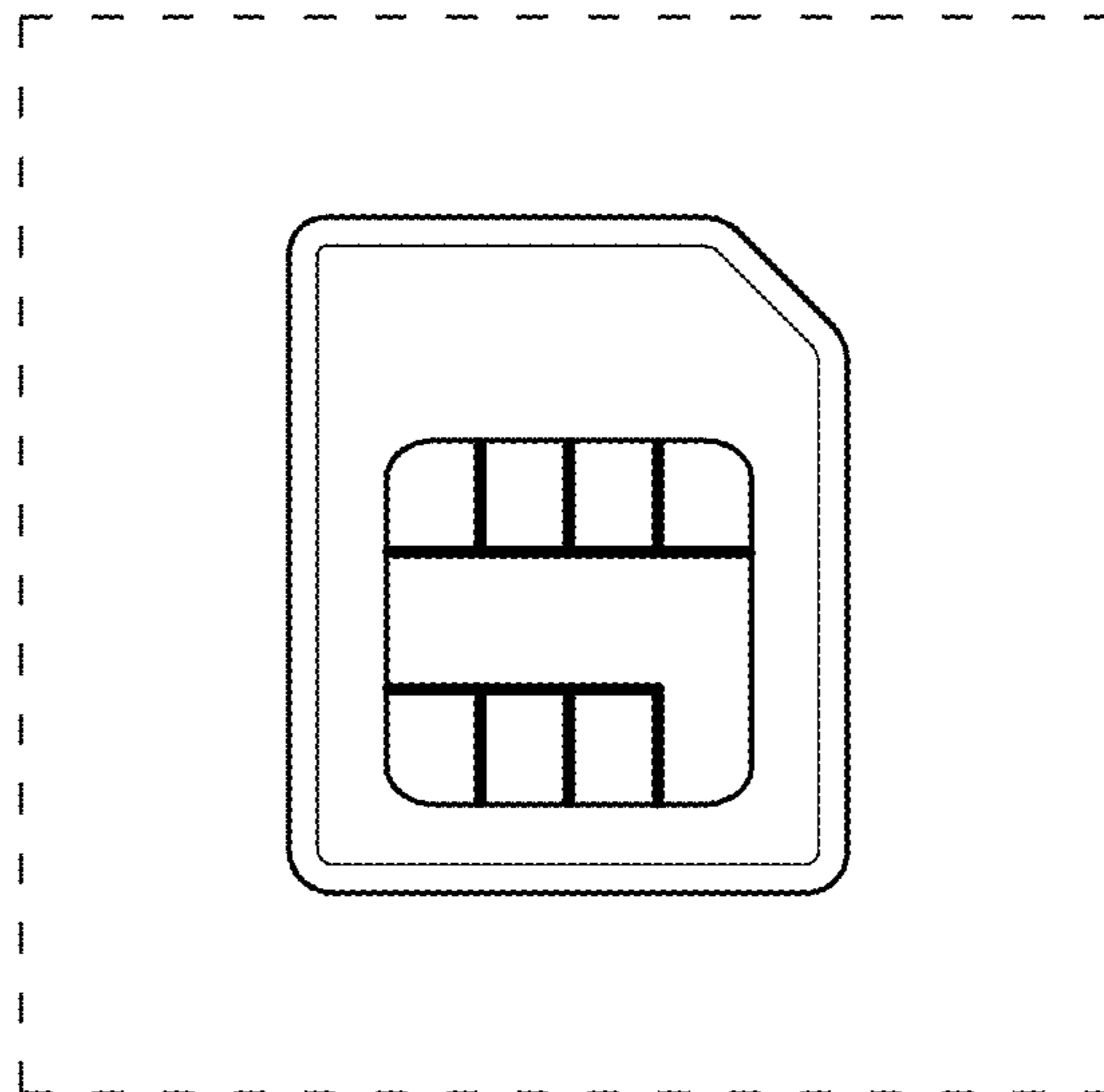
