(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design; and, FIG. 2 is a front view of the display screen or portion thereof with graphical user interface of FIG. 1, in which a mobile terminal in broken lines is provided to illustrate an example environment.

The row of symbols shown in broken lines at the top of the graphical user interface in FIG. 2 are unclaimed features. The edge of the display screen shown in broken lines in FIG. 1 and the mobile terminal shown in broken lines in FIG. 2 constitute environmental subject matter that forms no part of the claimed design.

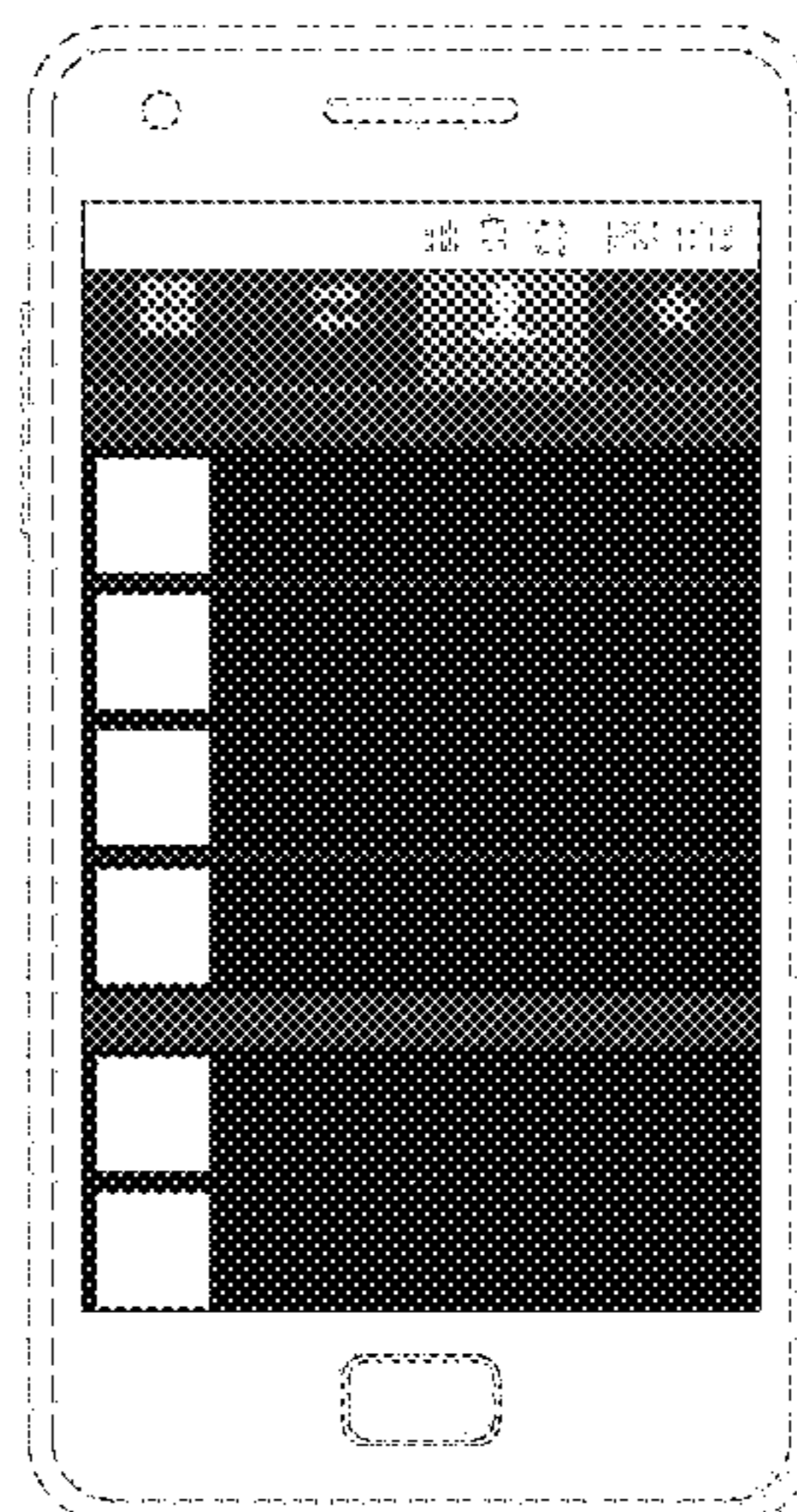
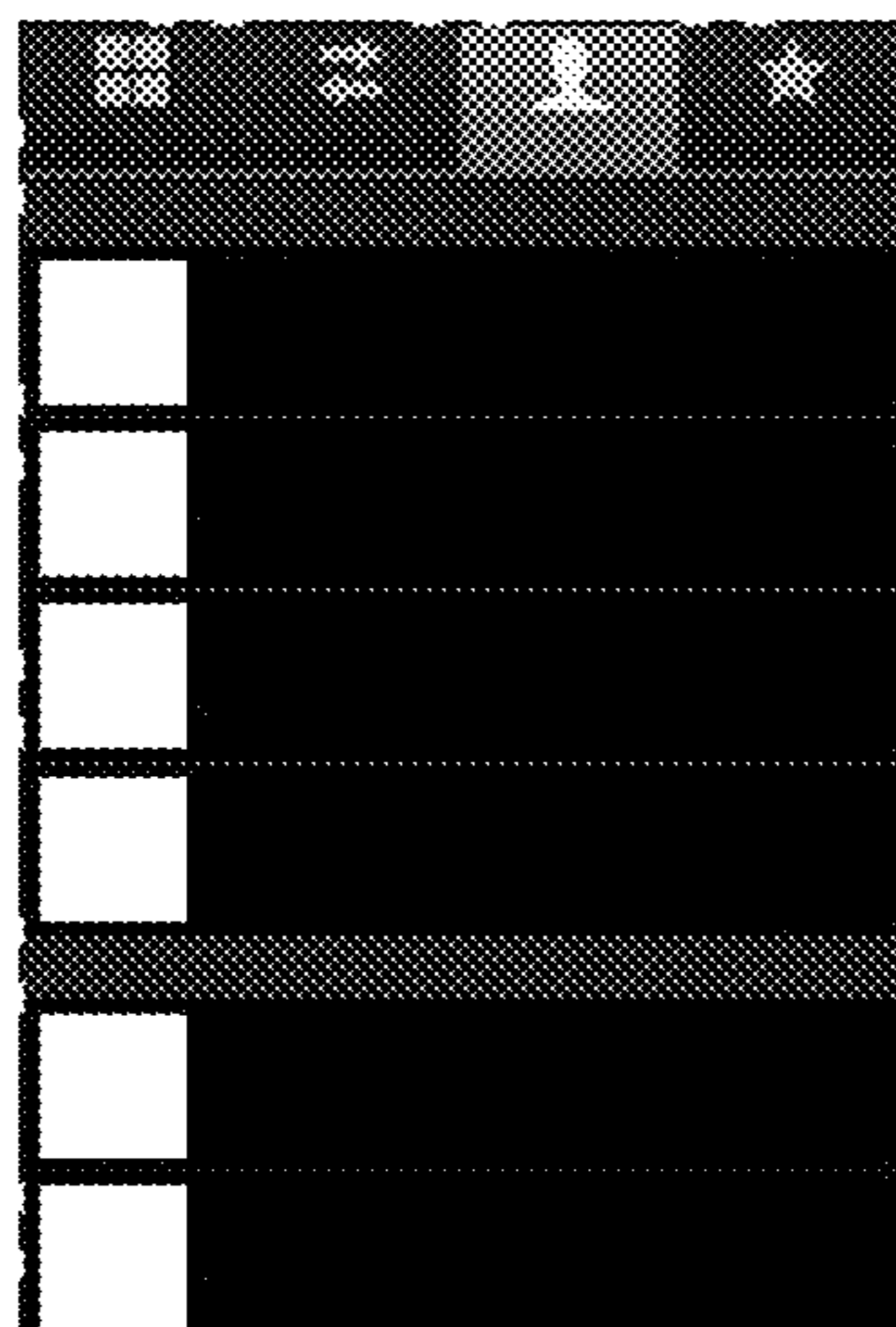
