The single FIGURE is a front view of a display screen or portions thereof with graphical user interface showing our new design.

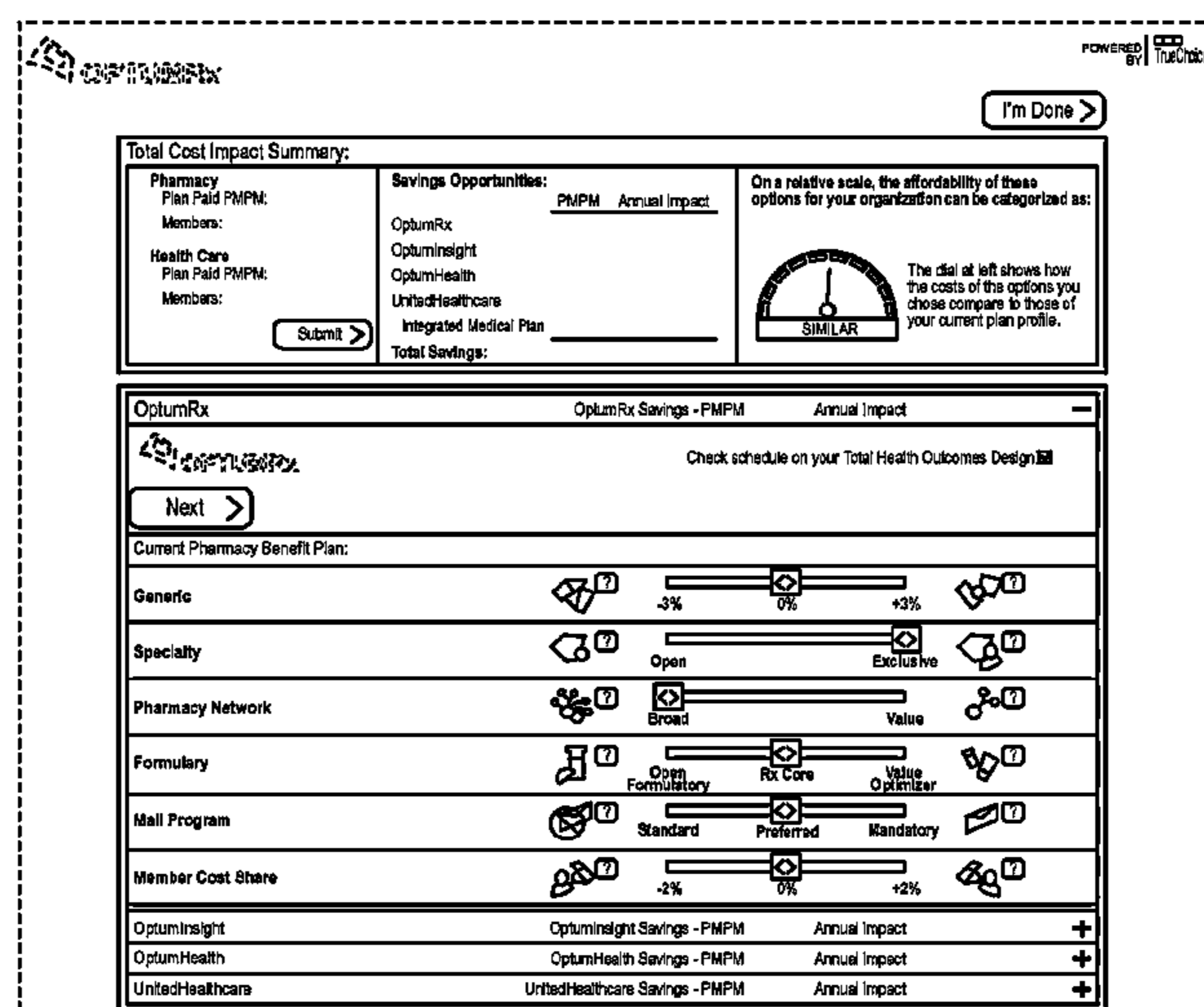
The portion of the graphical user interface shown in broken line is intended for the purpose of illustrating environmental structure and forms no part of the claimed design.







