FIG. 12 is a bottom view of the pump cover shown in FIG. 7.

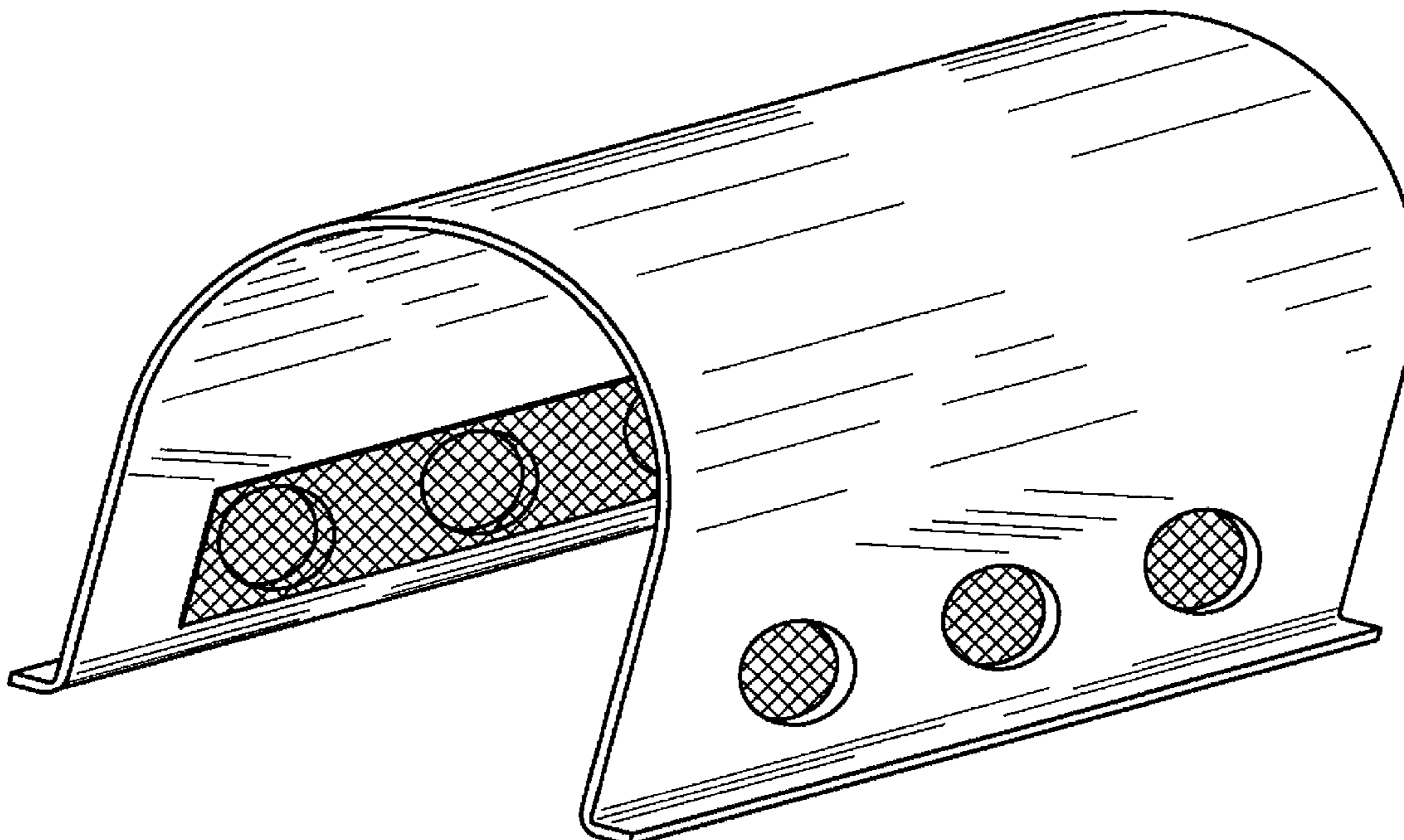

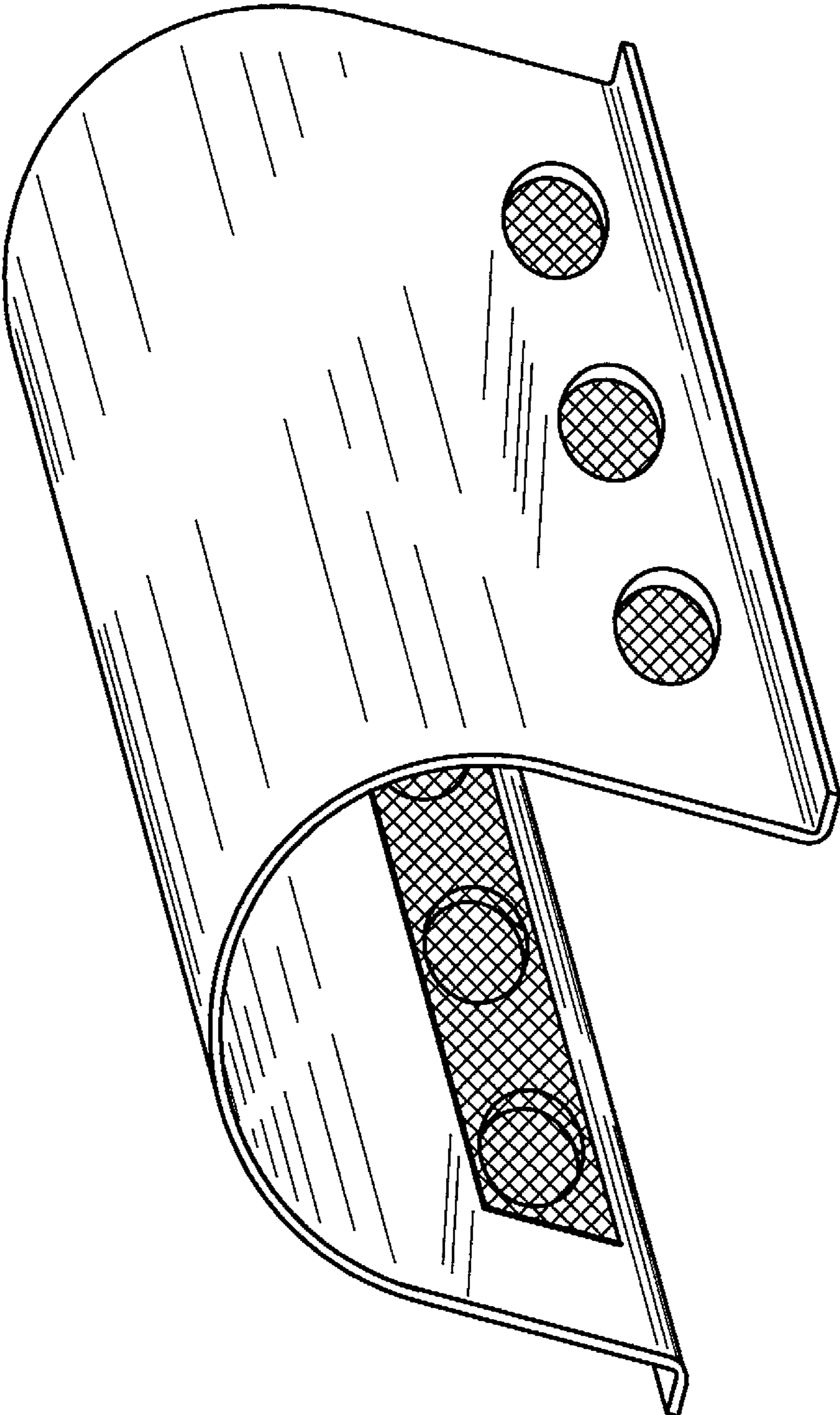

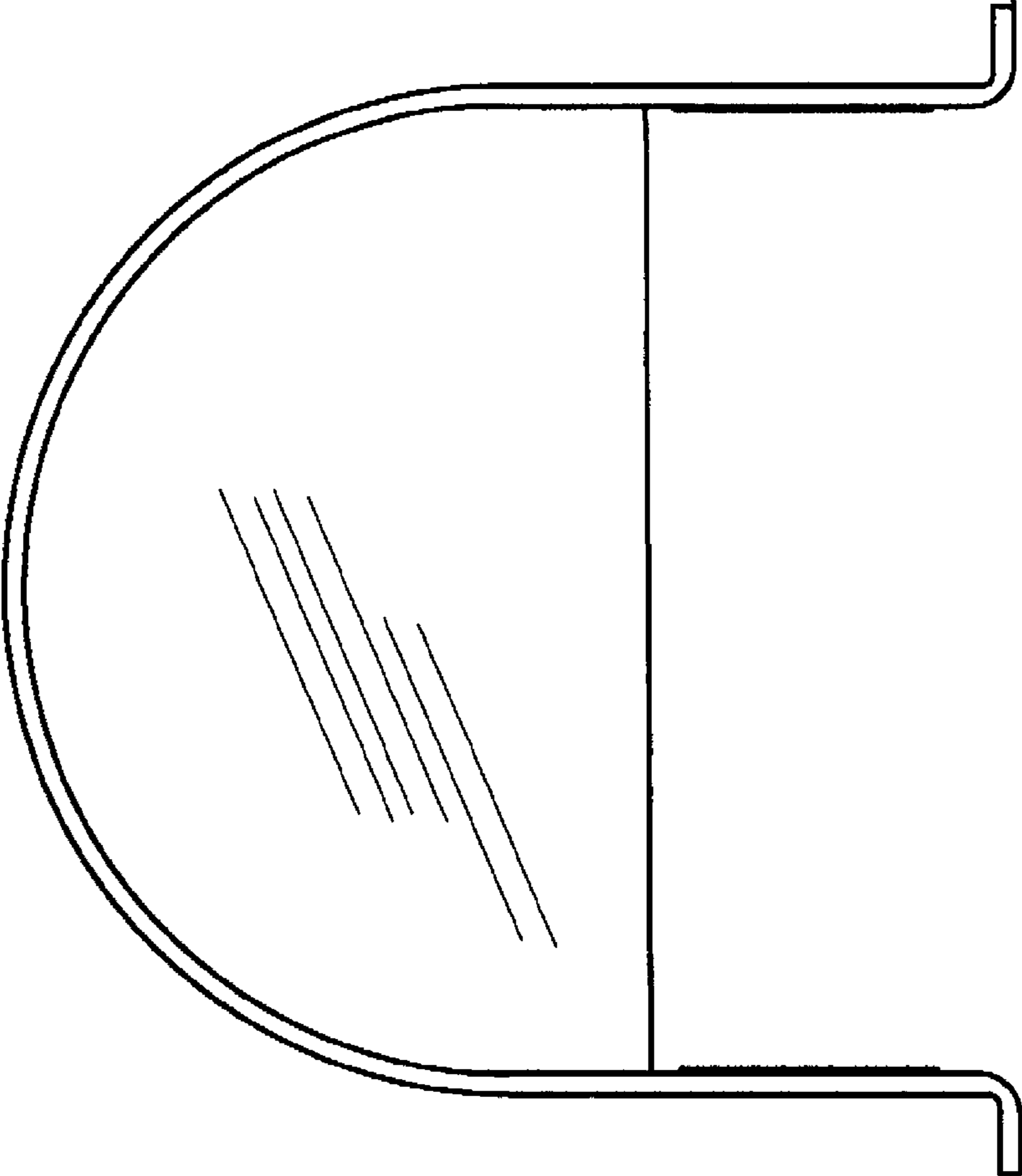

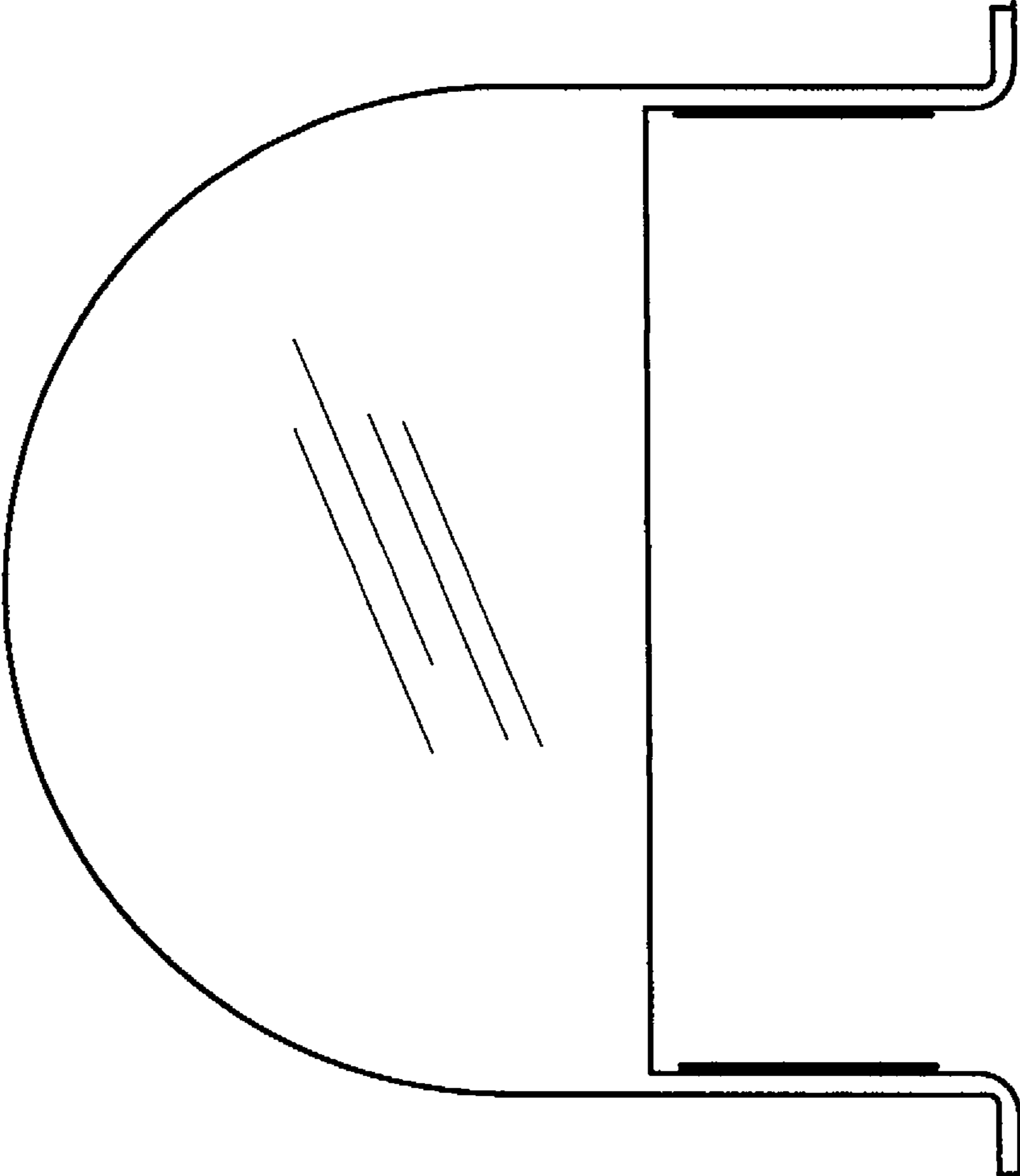

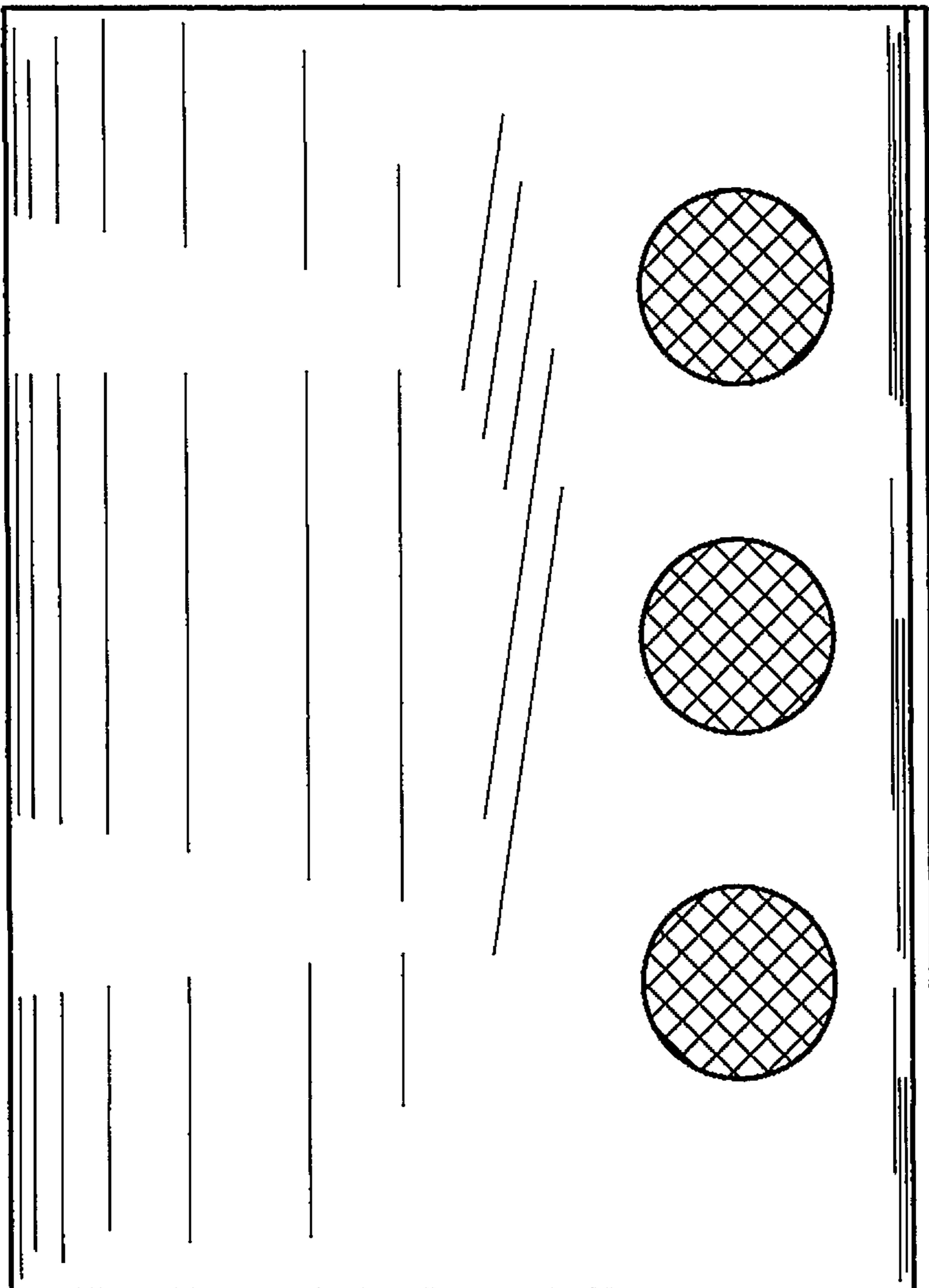

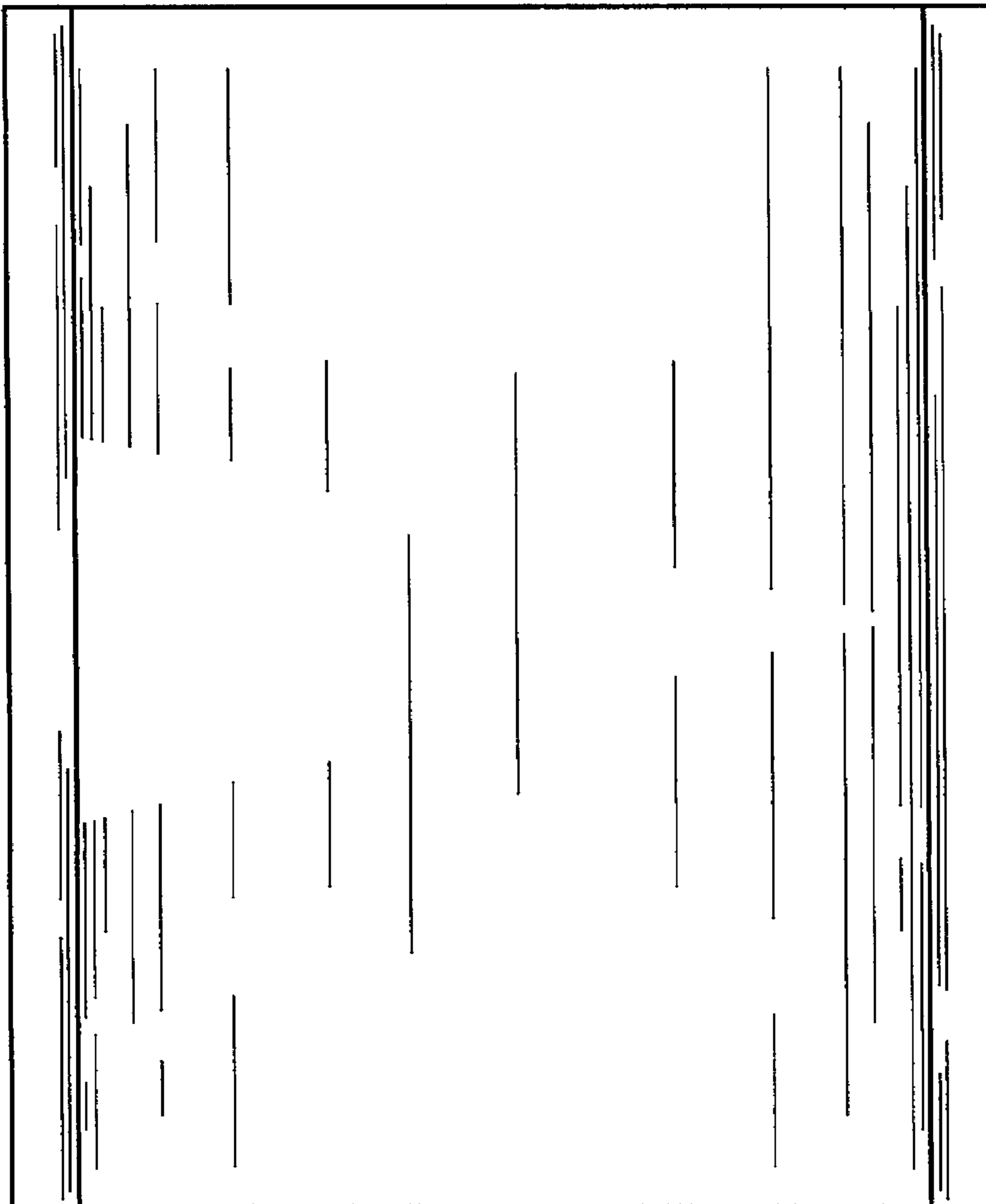
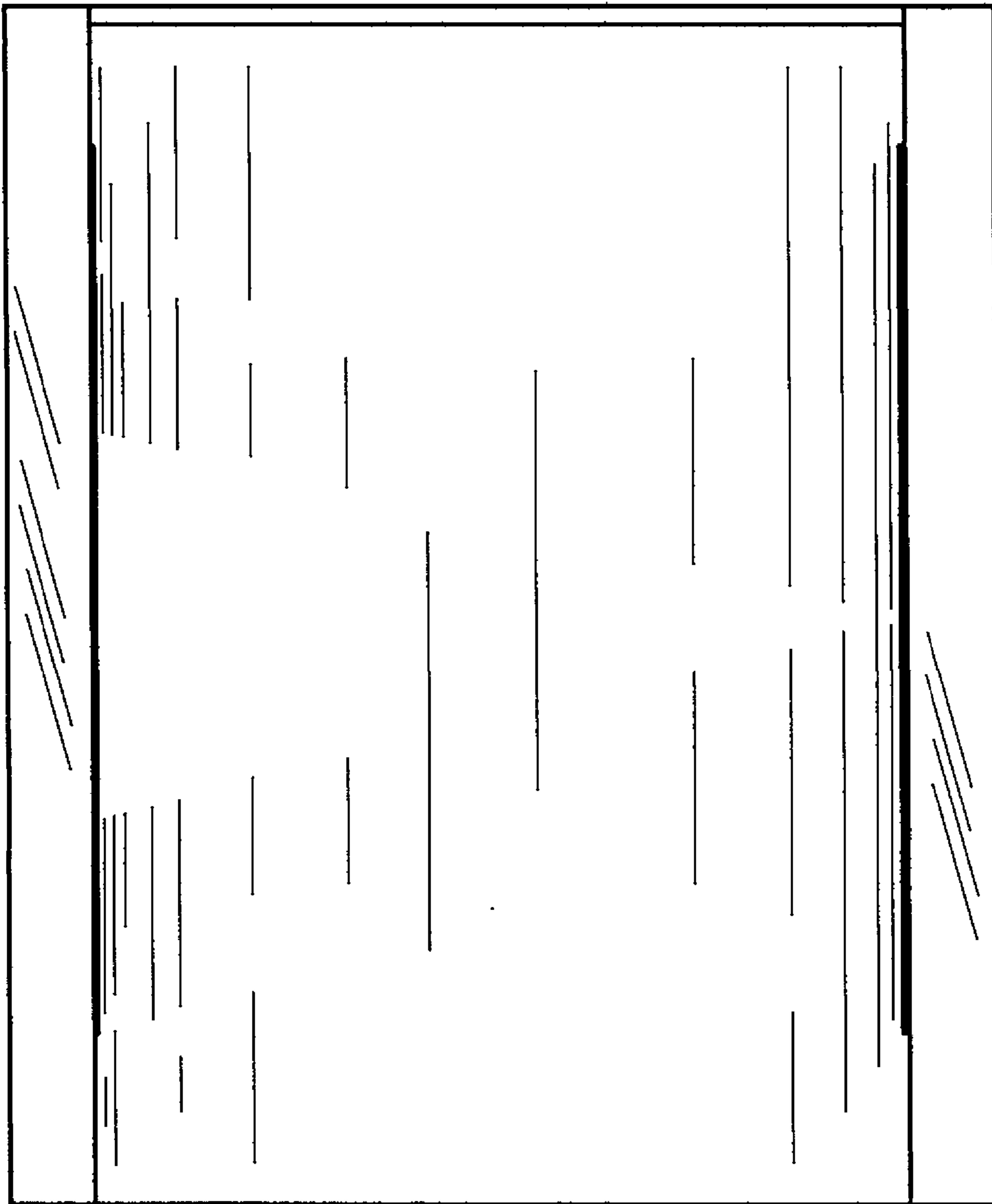

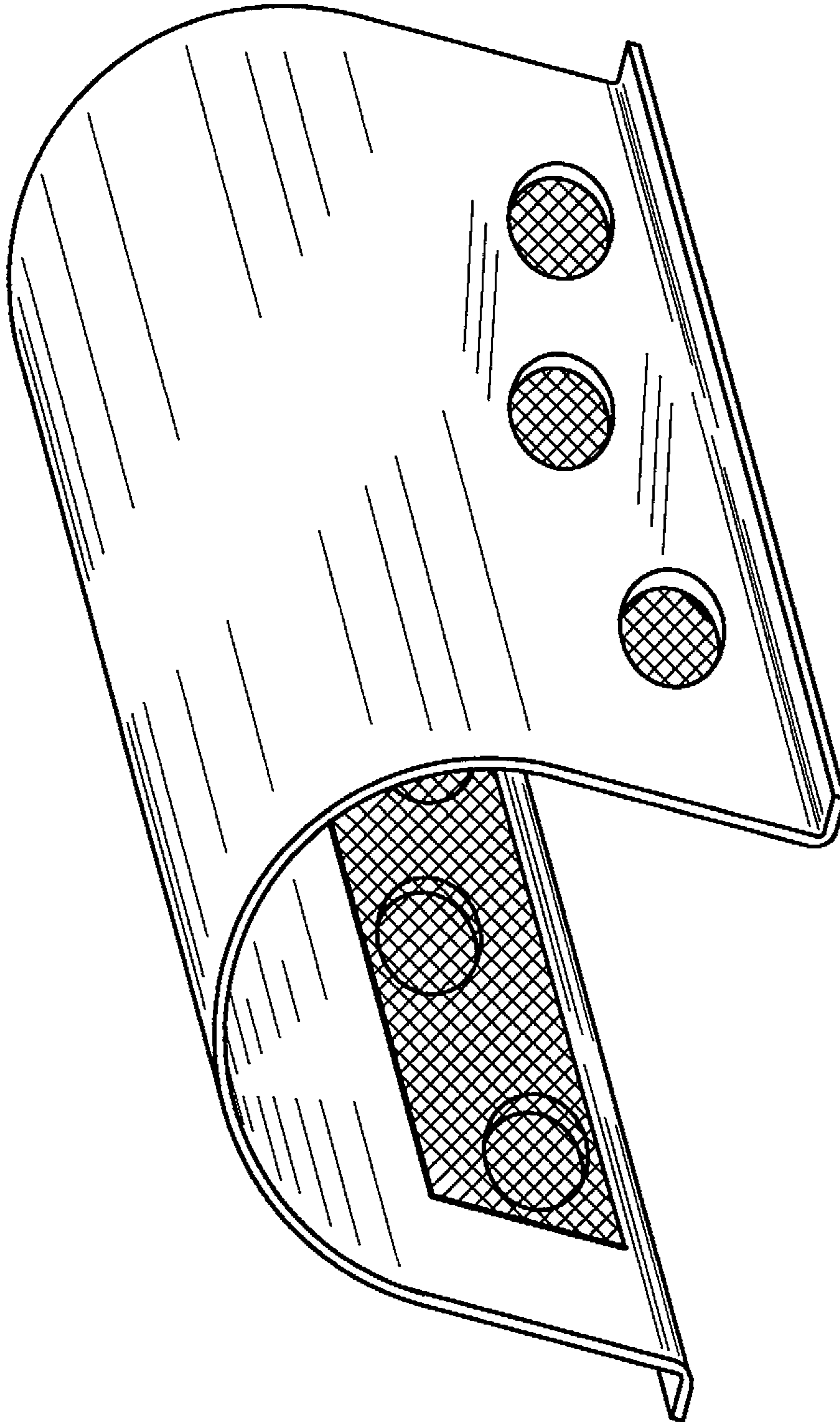

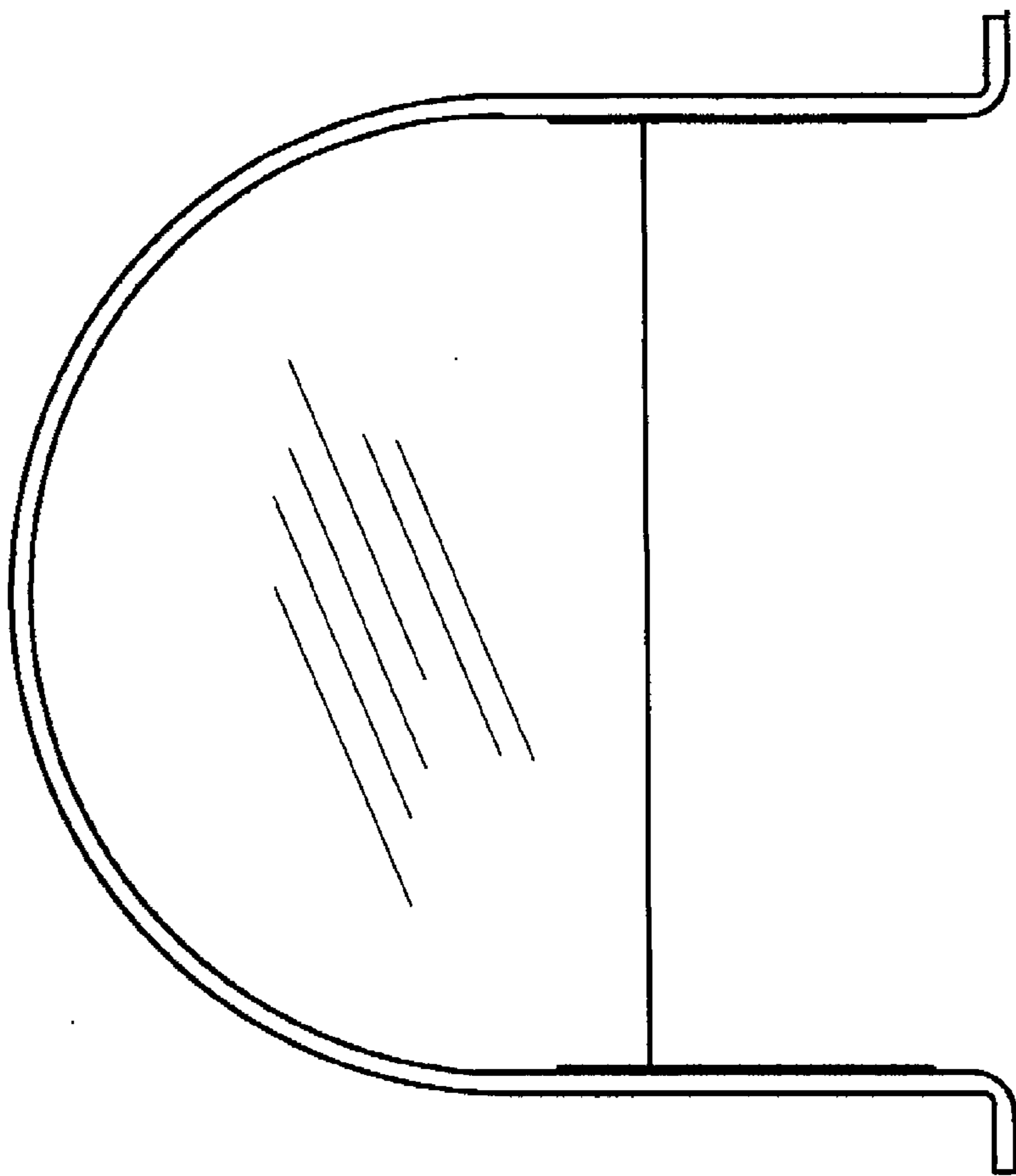

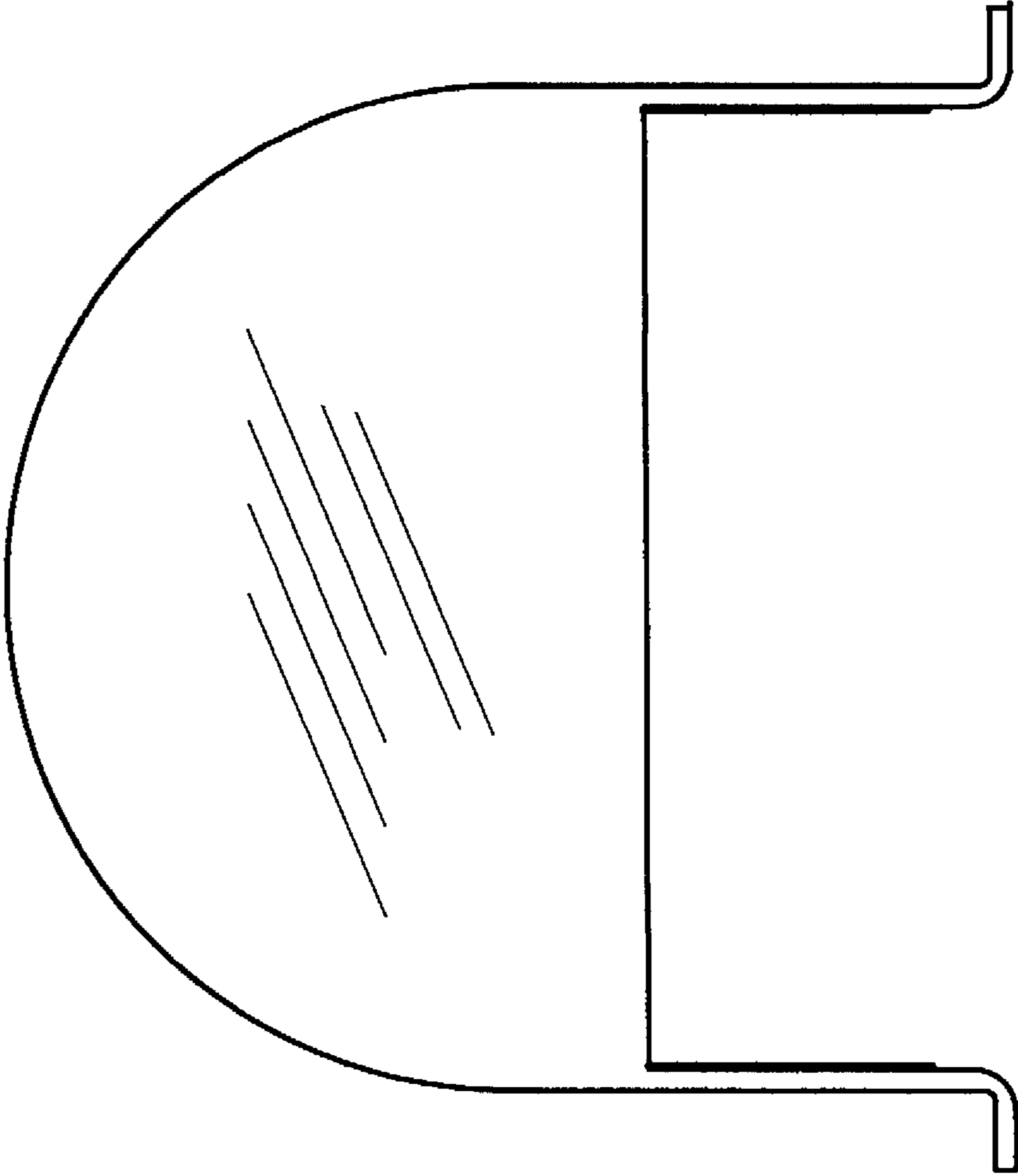

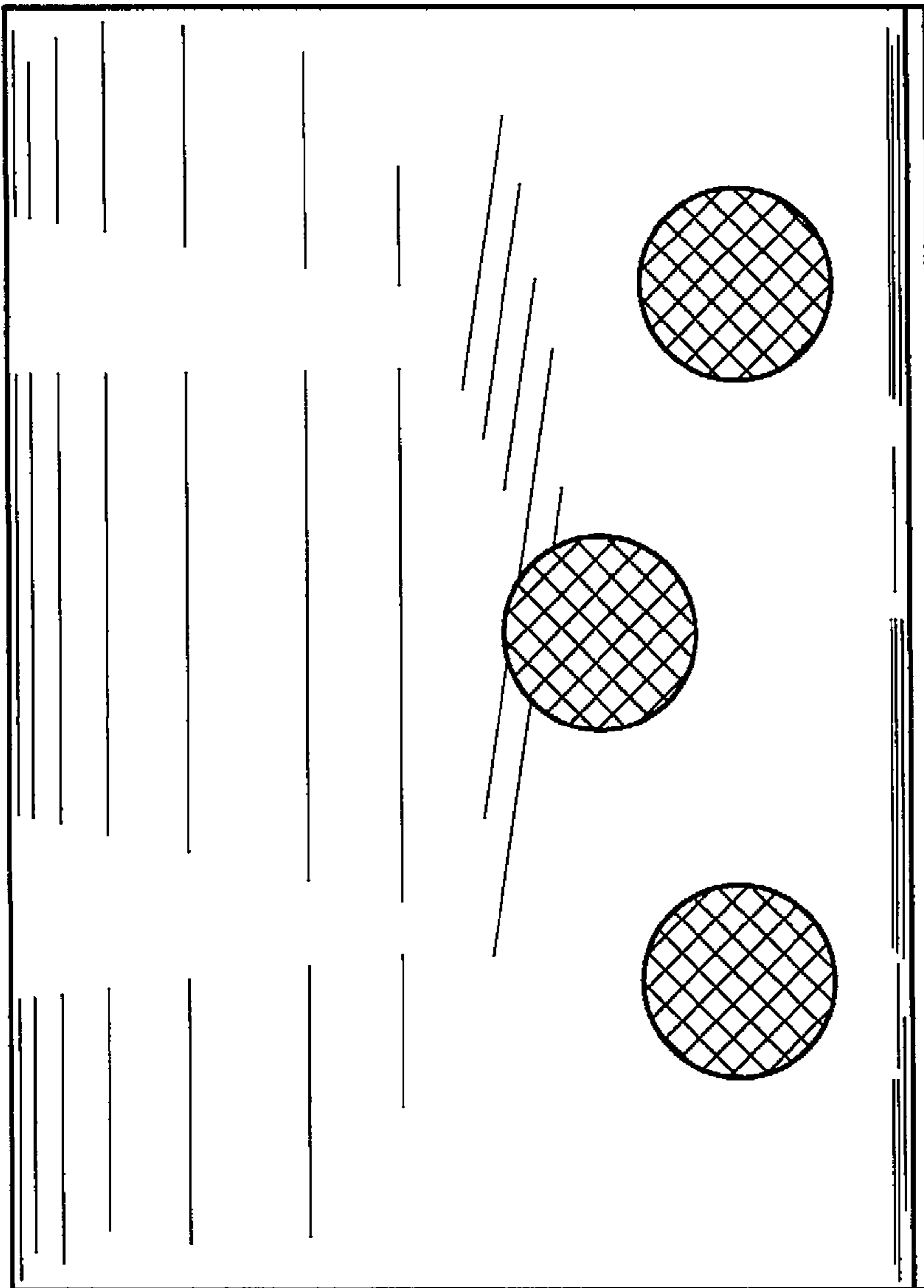

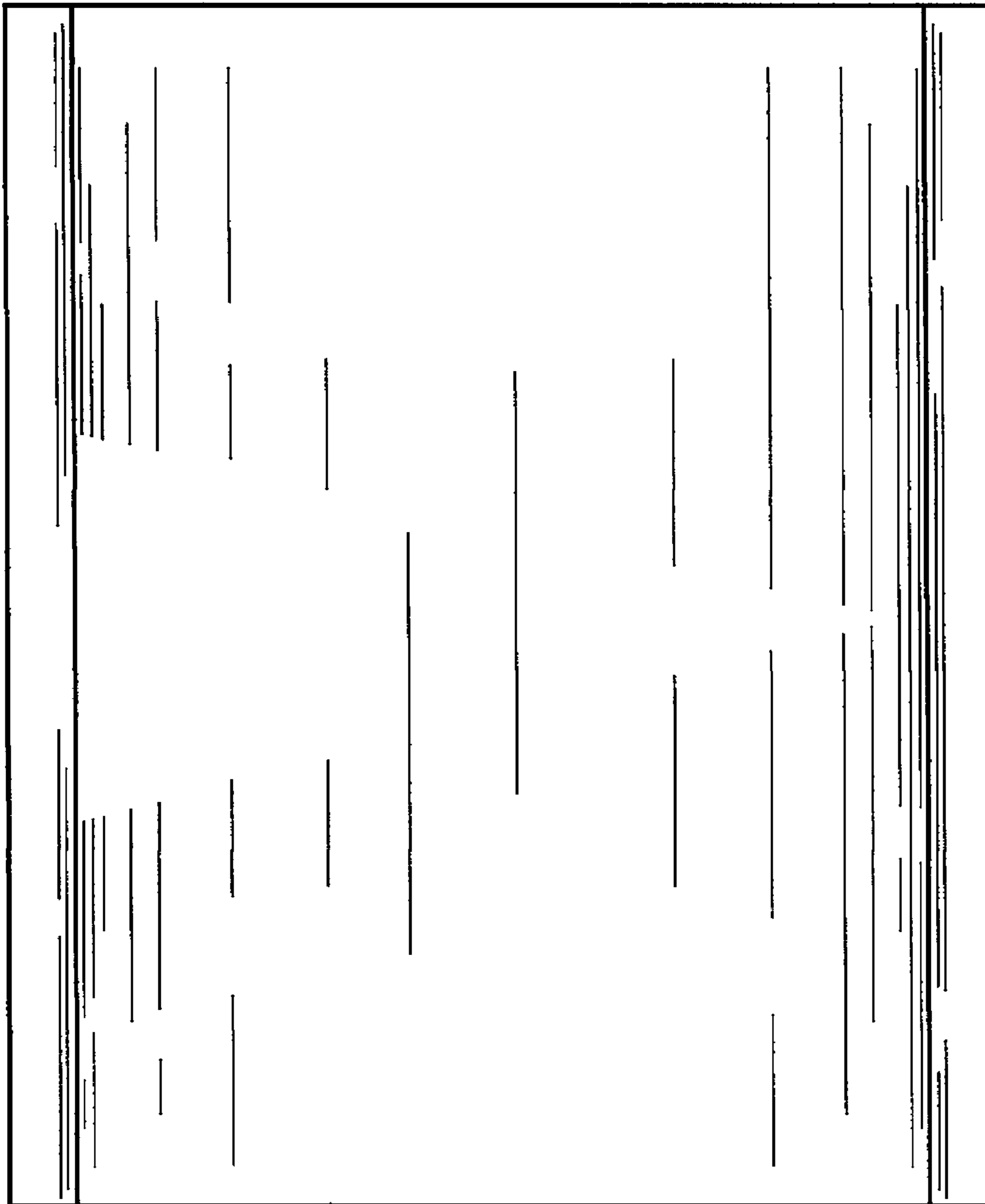
