FIG. 15 is a REAR ELEVATION view thereof.

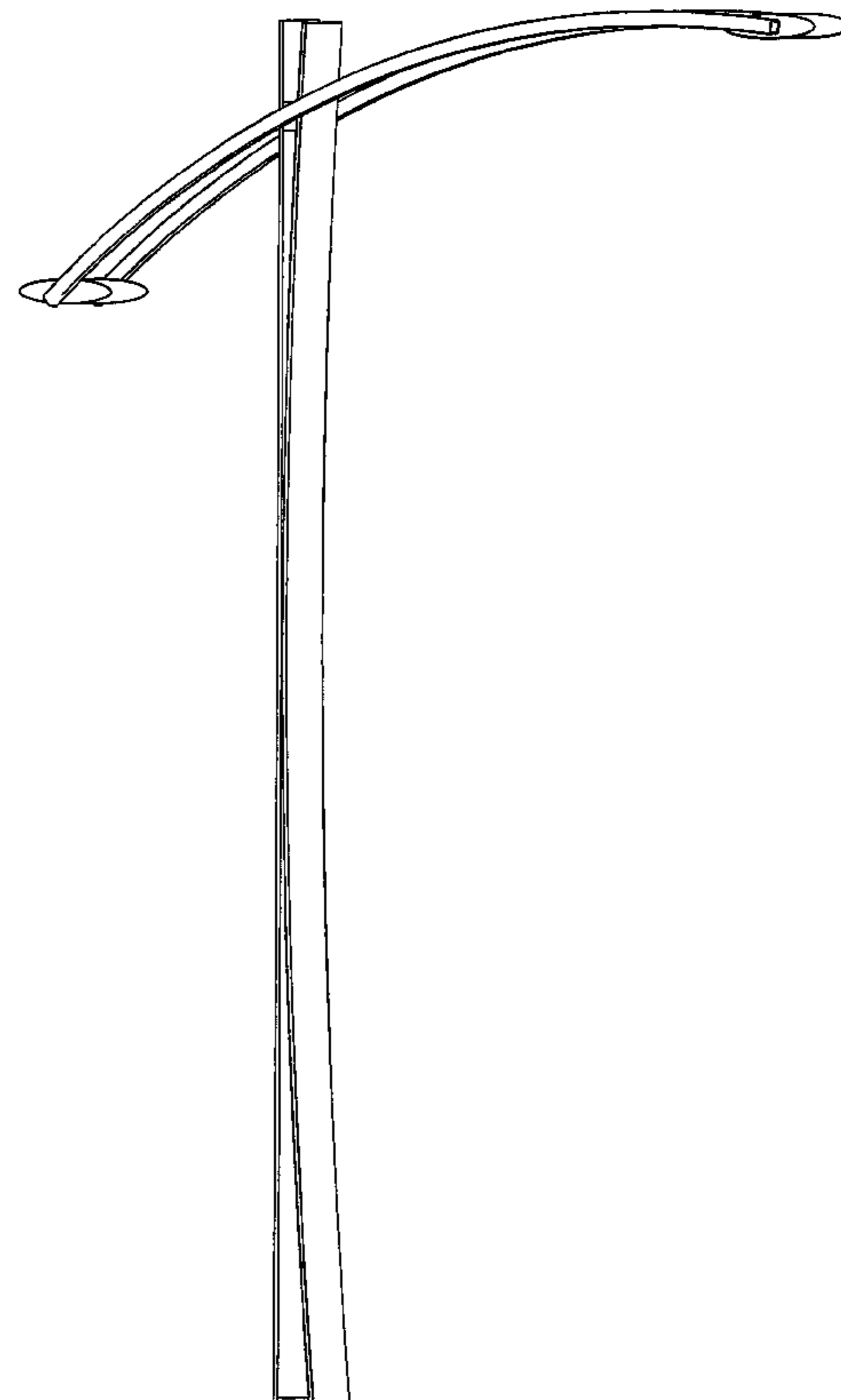
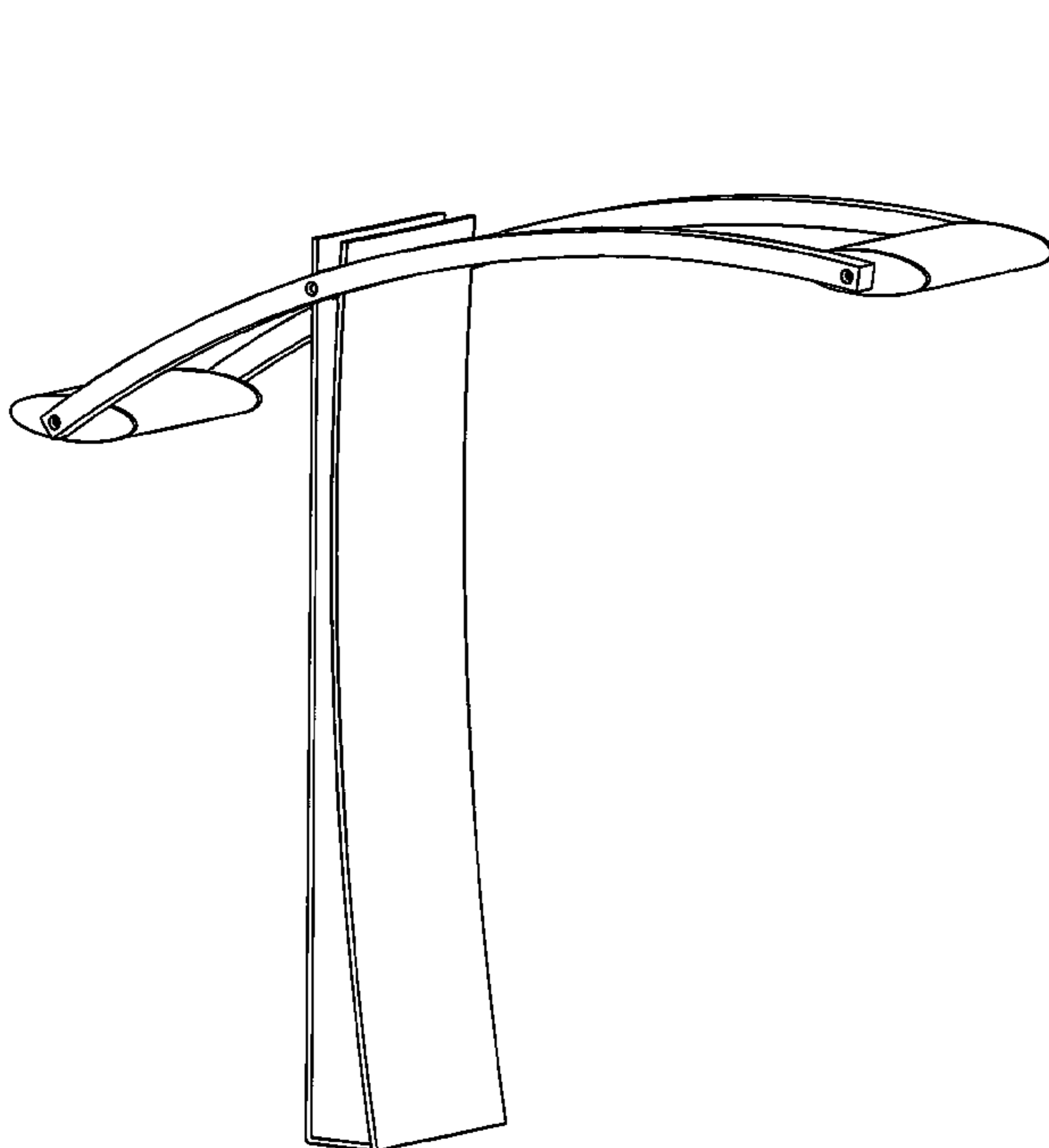

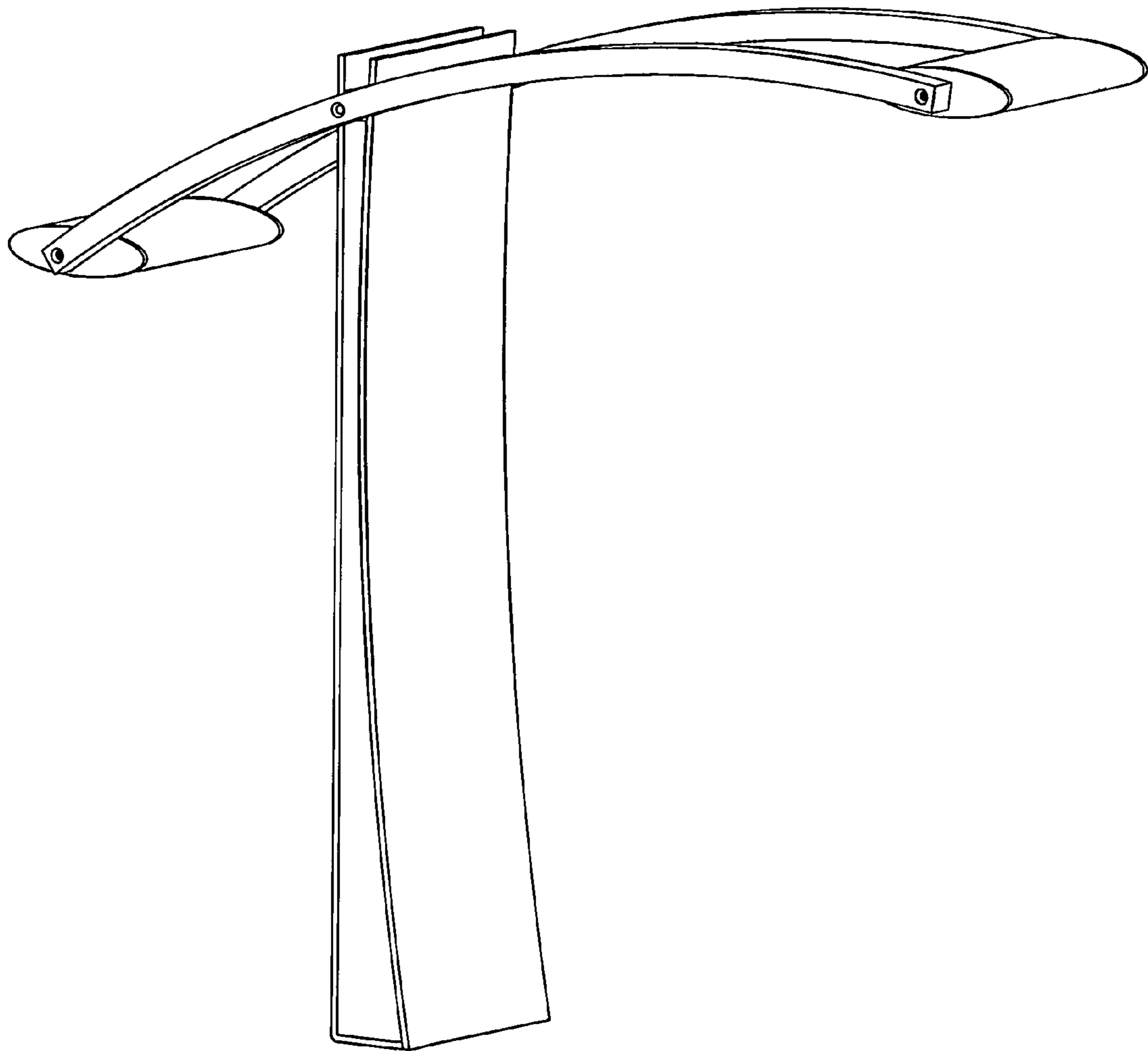

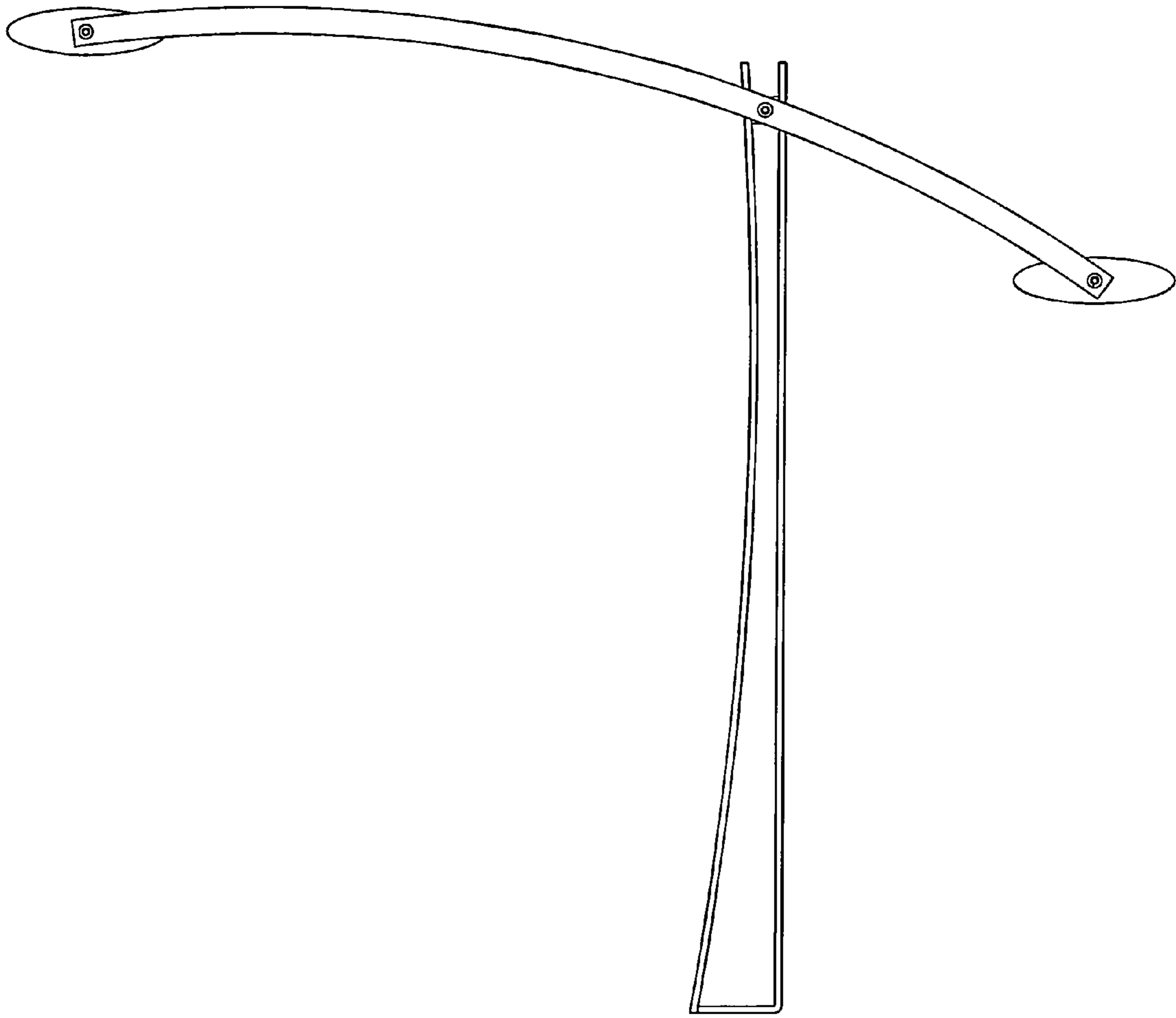

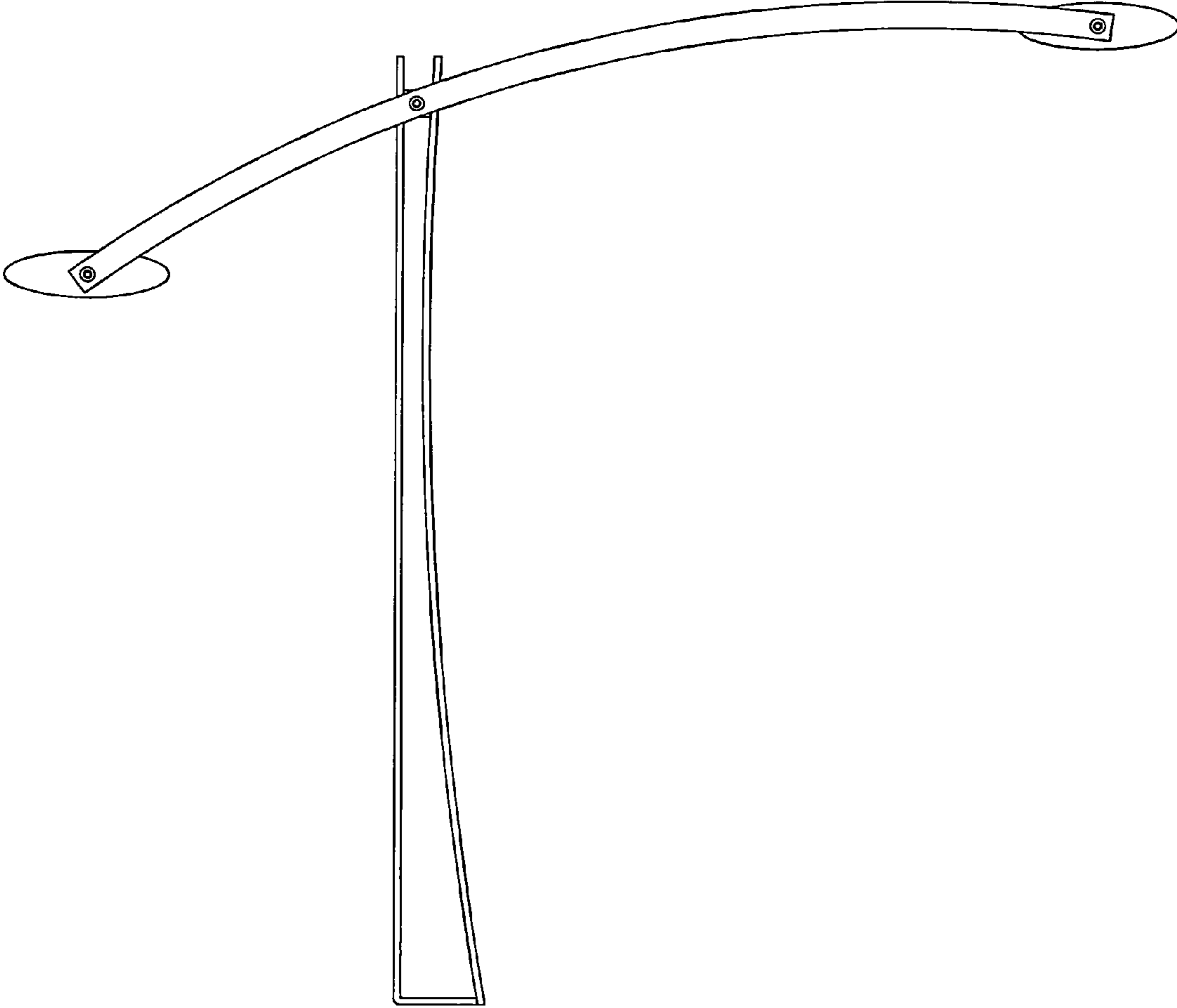

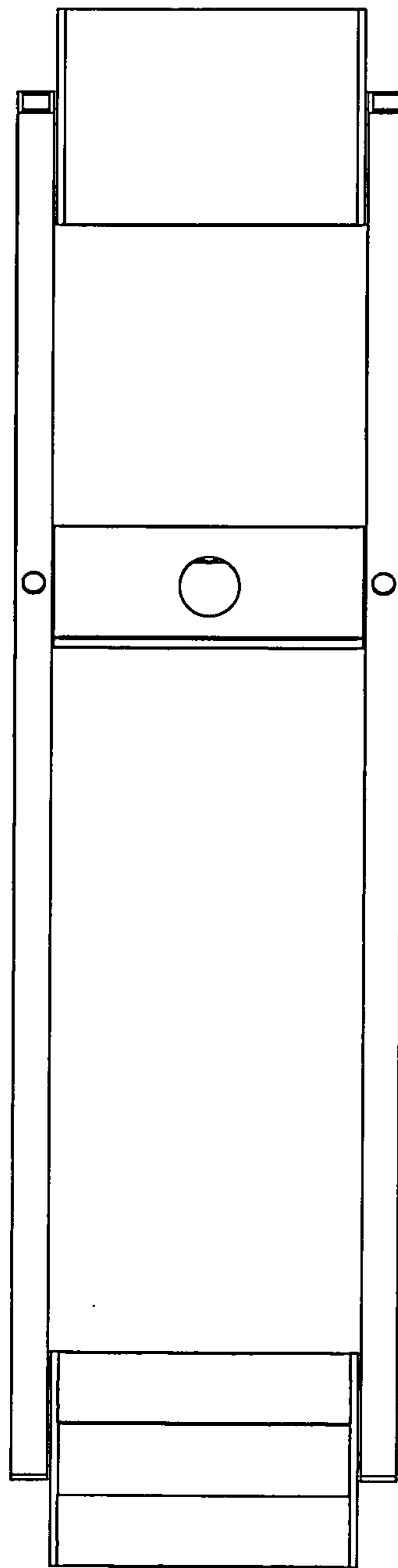

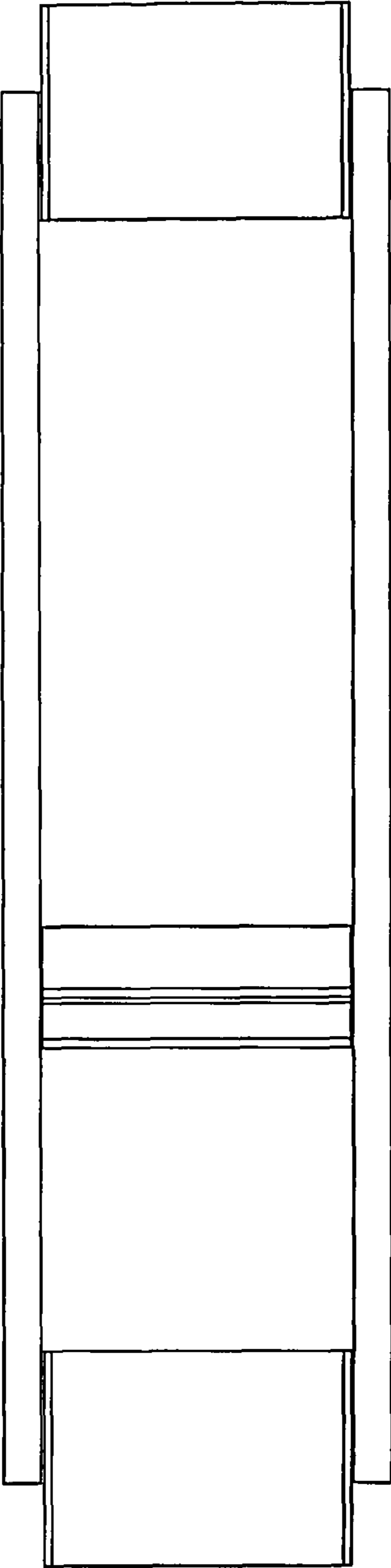

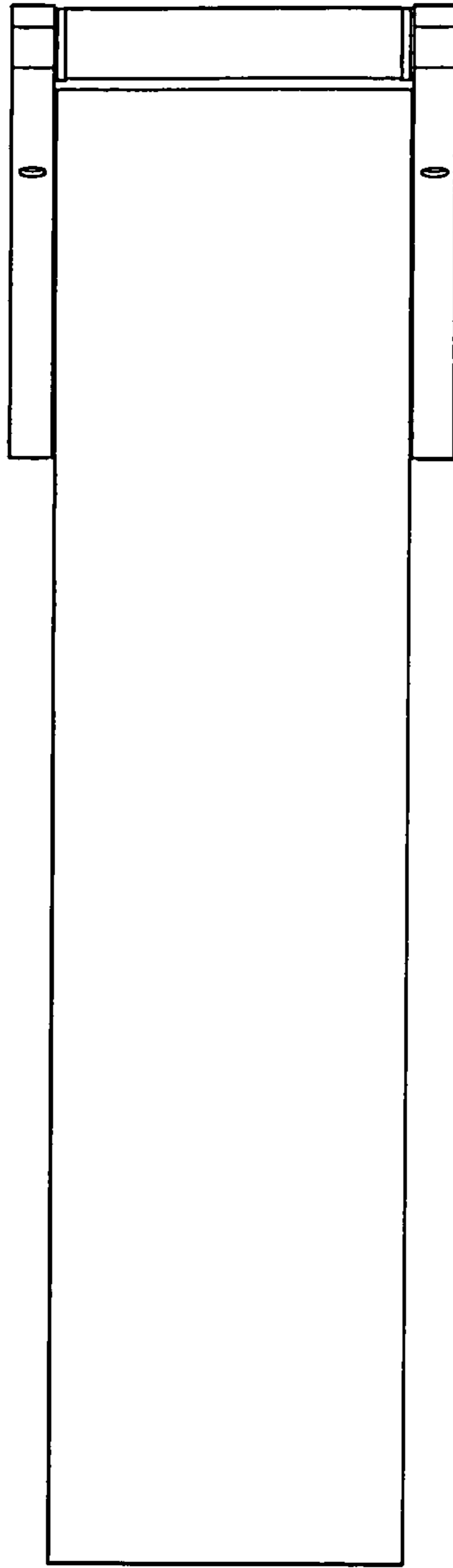

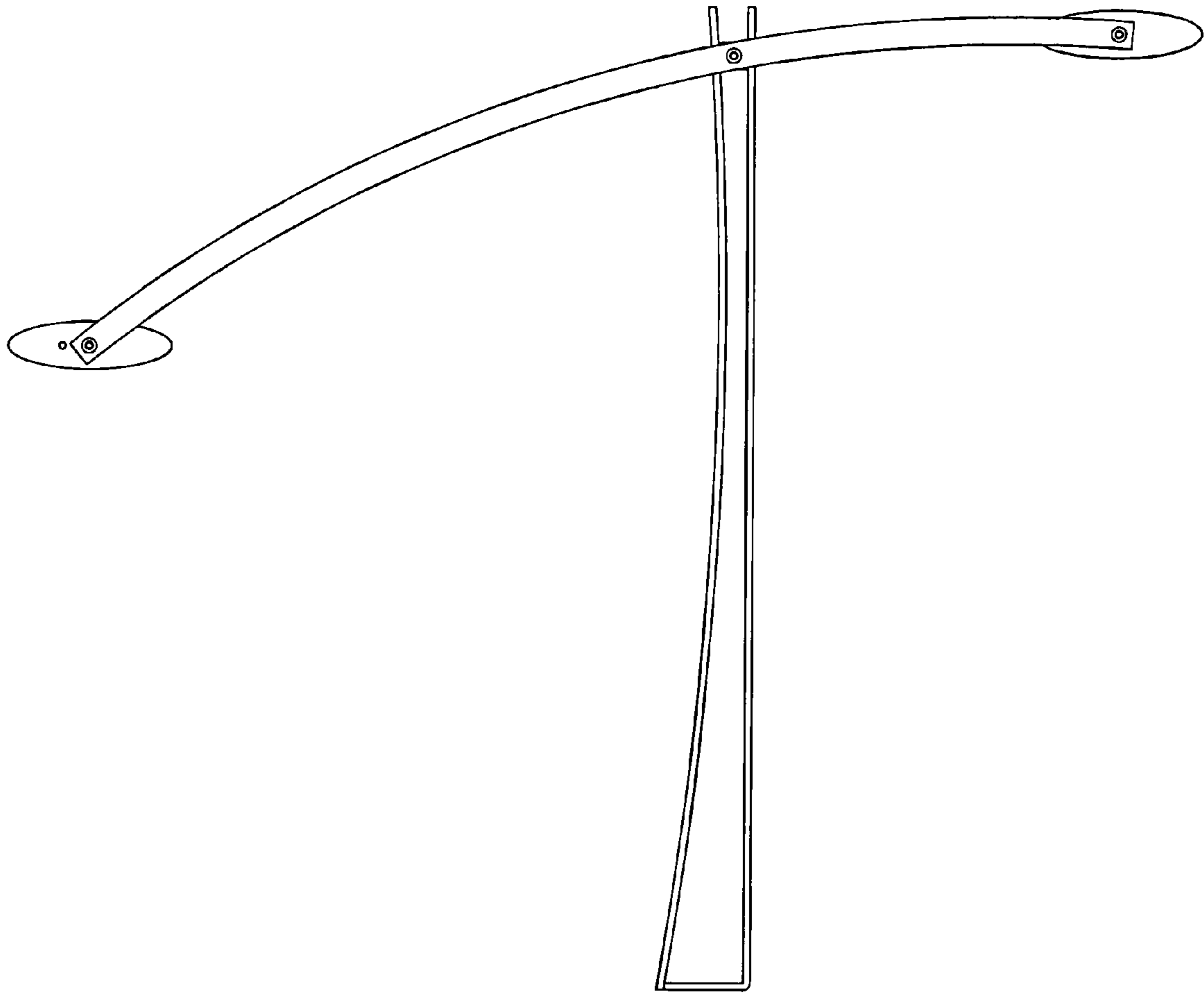

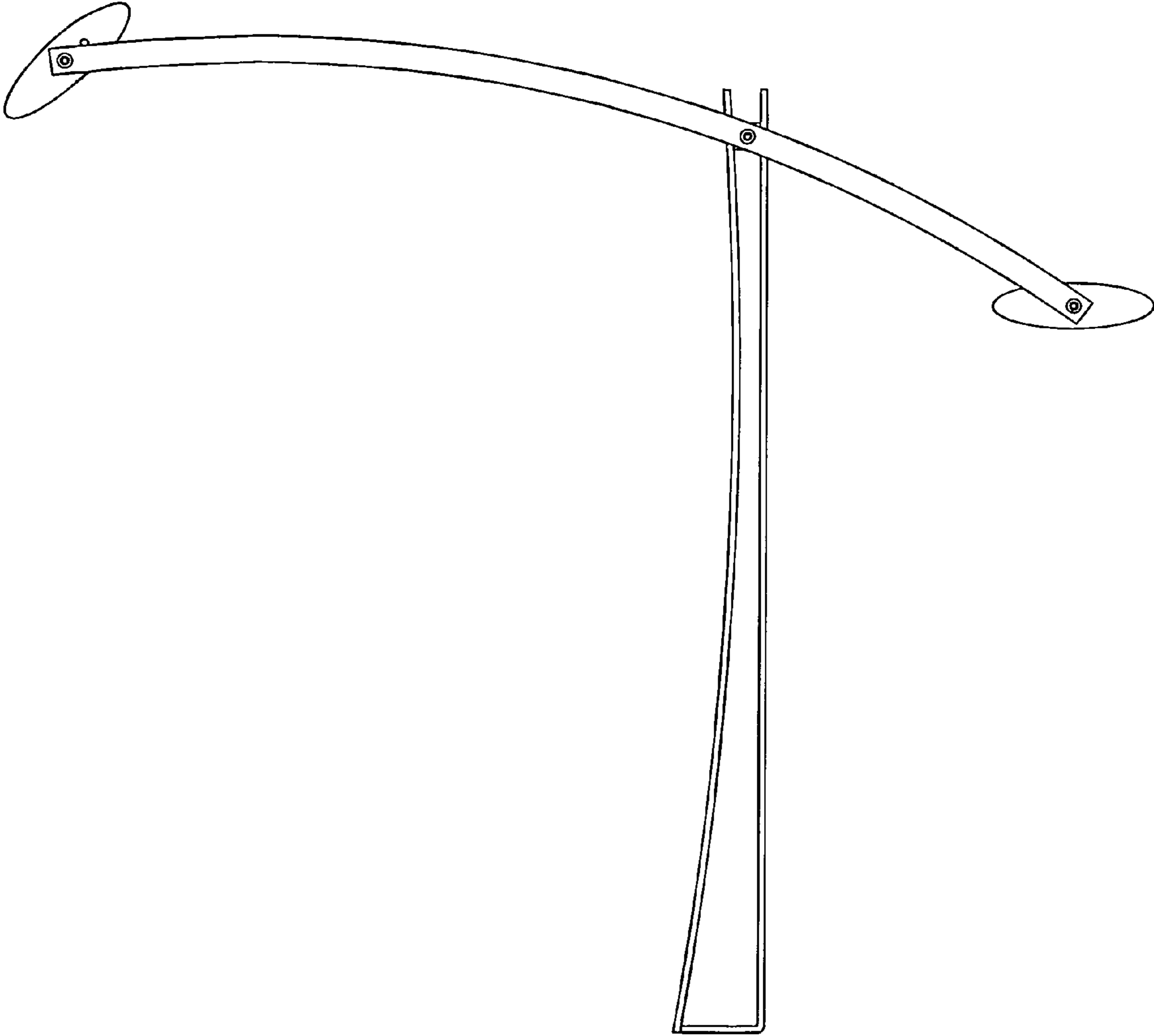

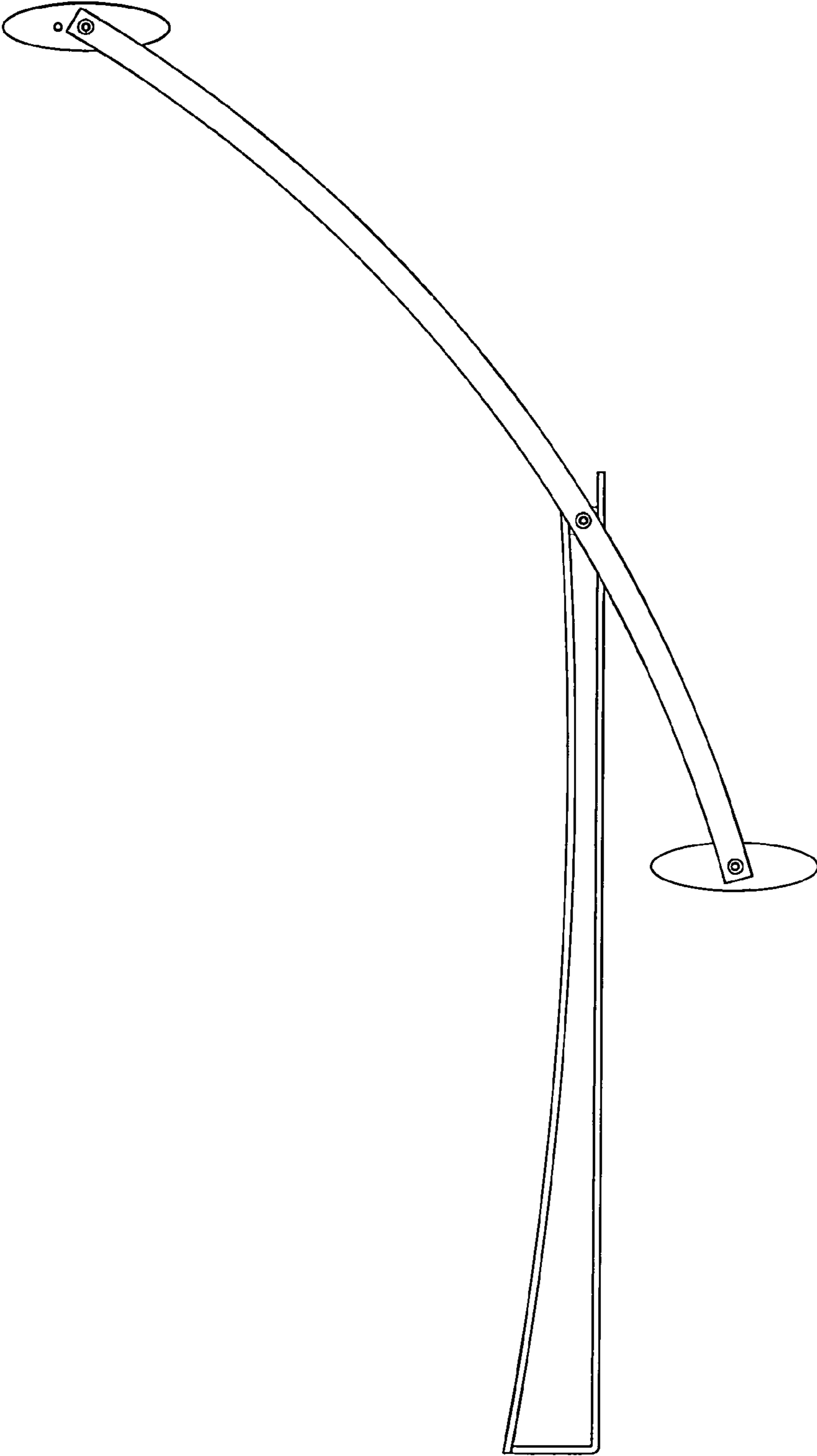

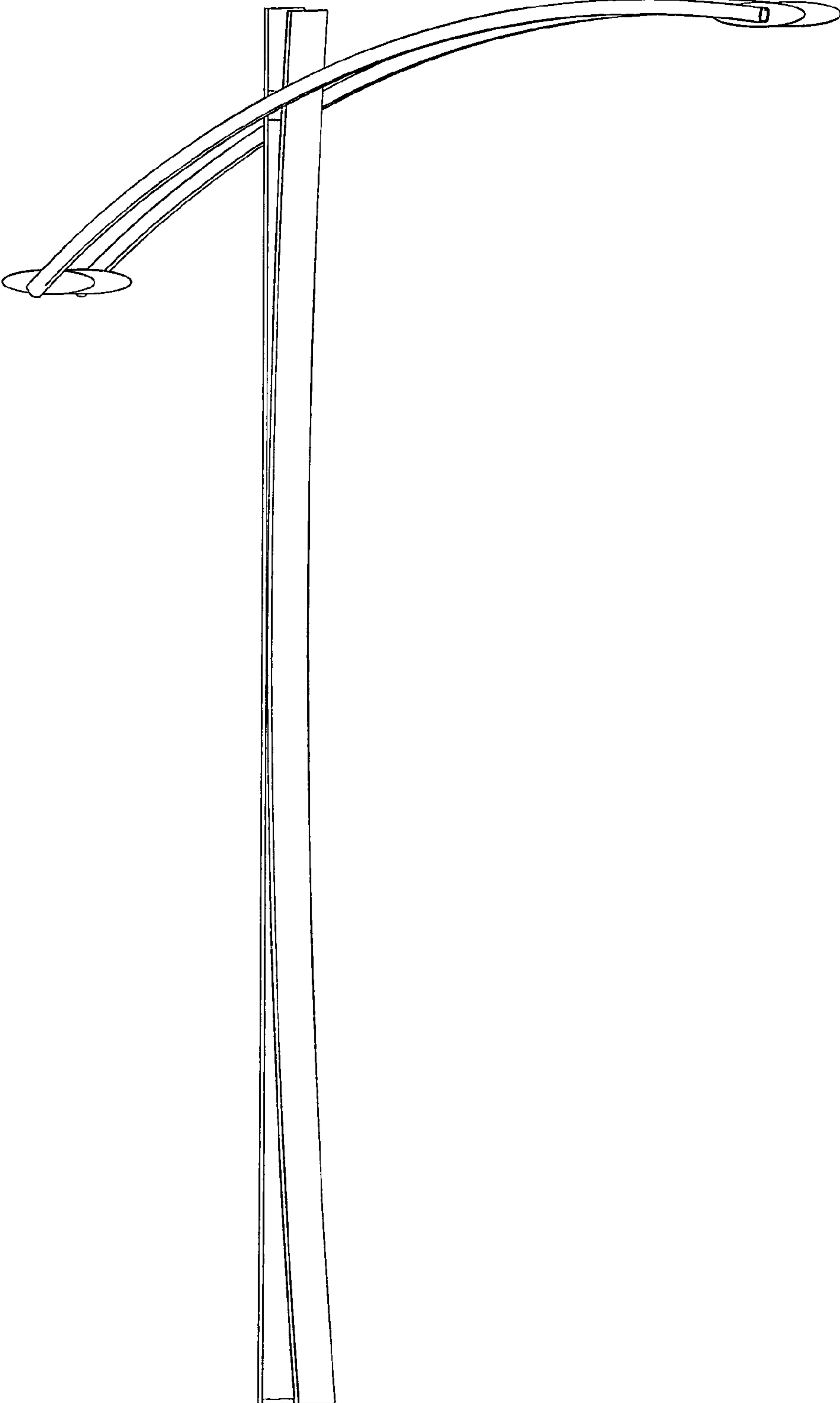

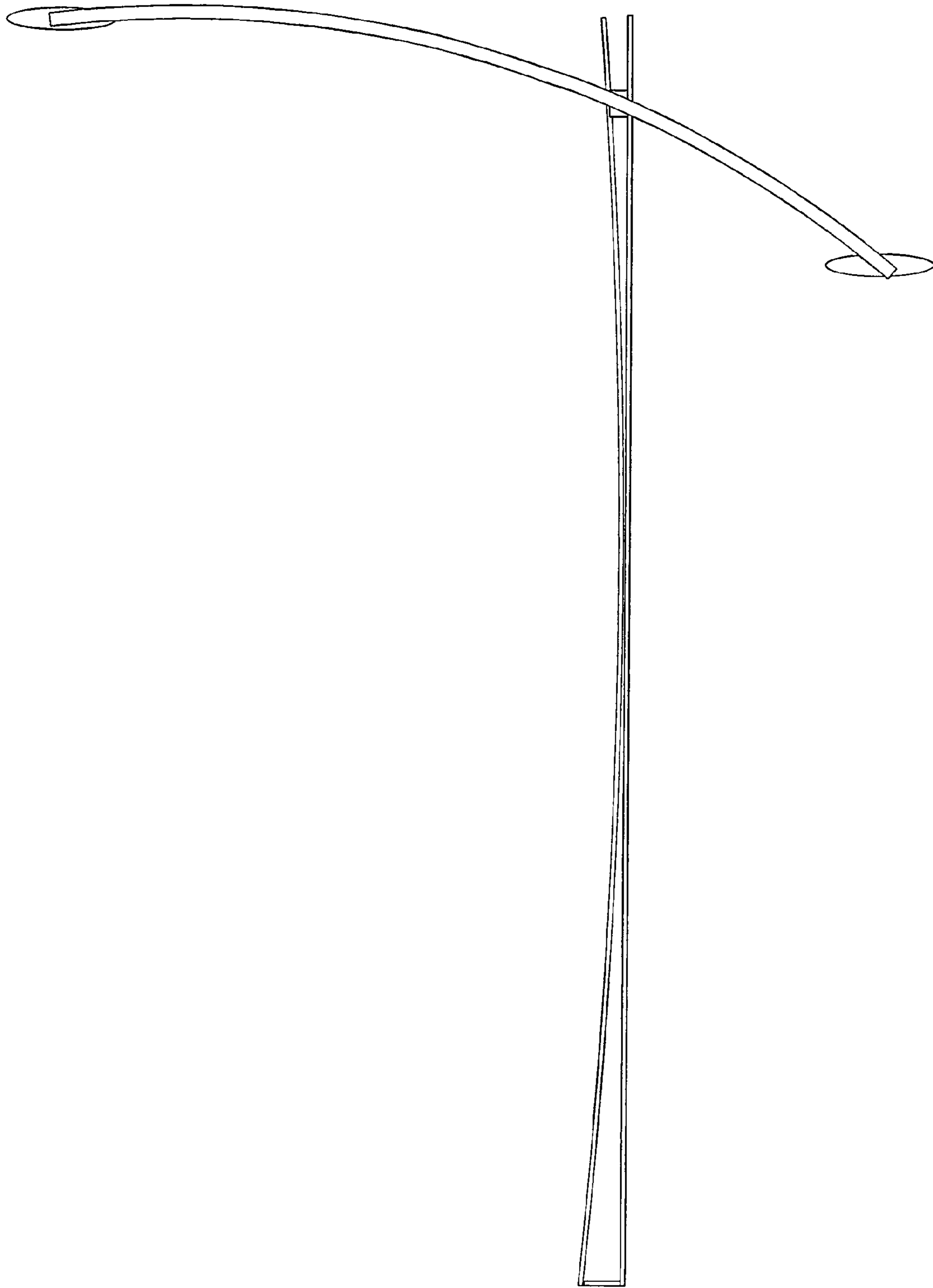

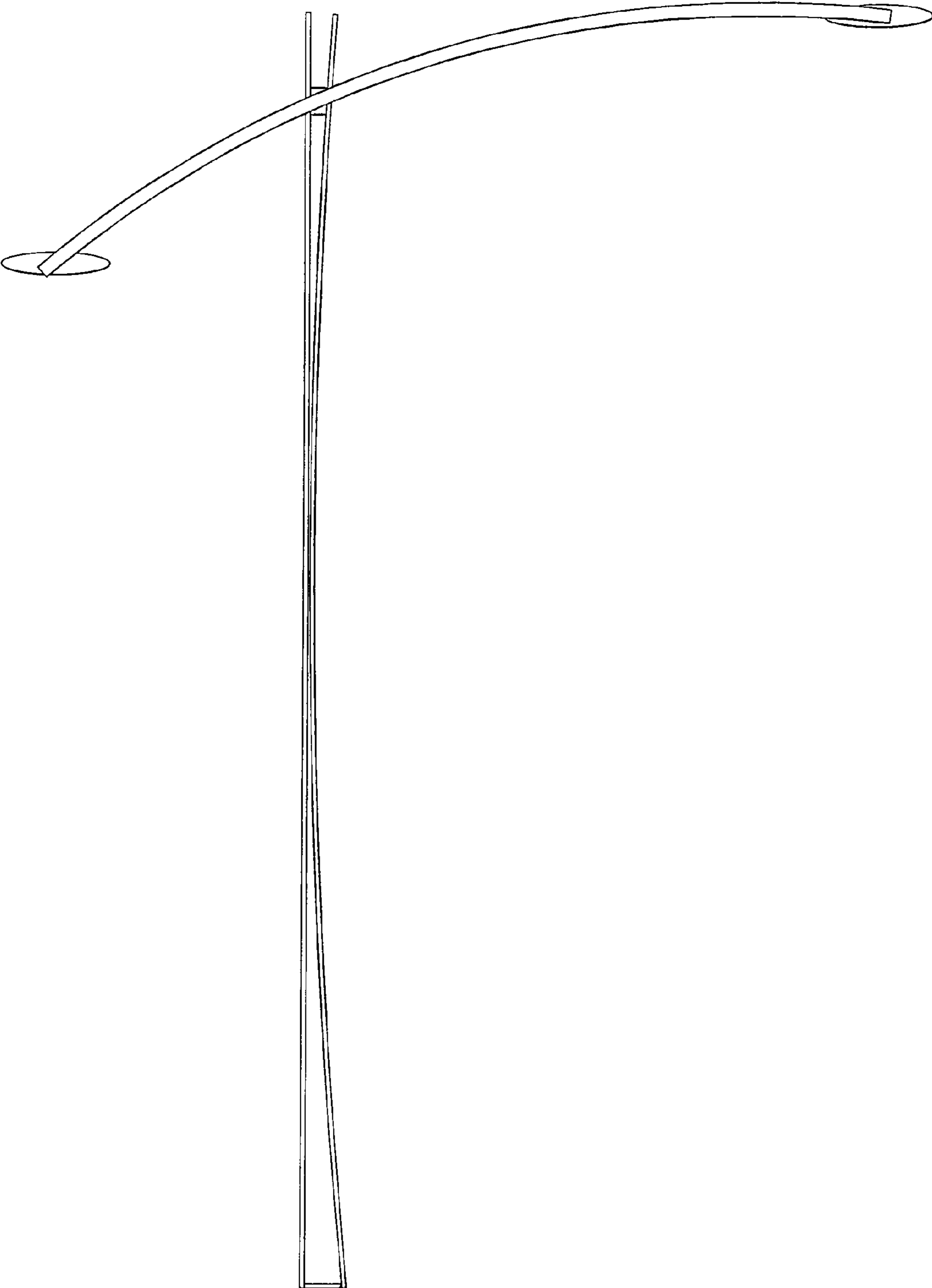

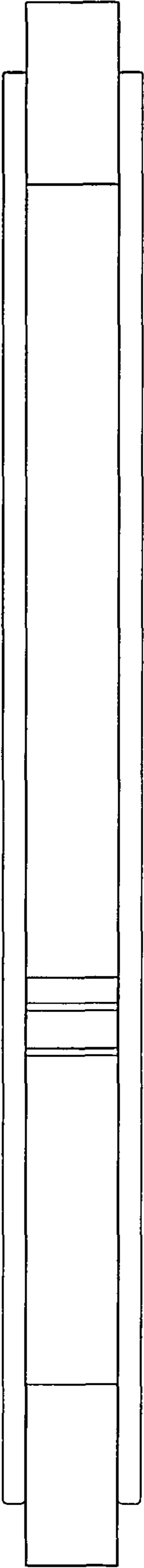

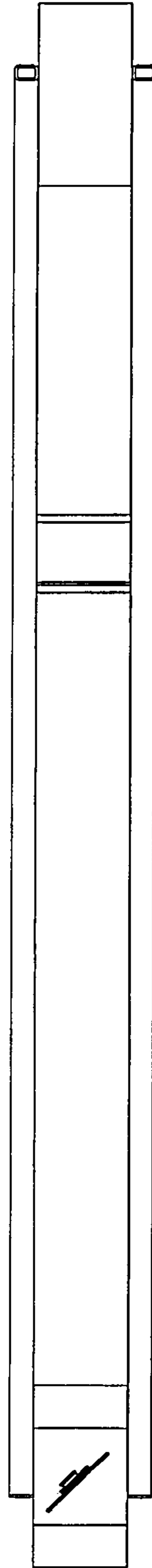

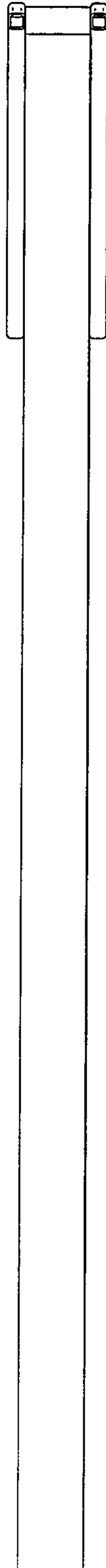
