DESCRIPTION

FIG. 1 is a front perspective view of the lighting back plate of the present invention;
 FIG. 2 is a front elevation view of the lighting back plate of the present invention;
 FIG. 3 is a rear elevation view of the lighting back plate of the present invention;

 FIG. 7 is a bottom plan view of the lighting back plate of the present invention.

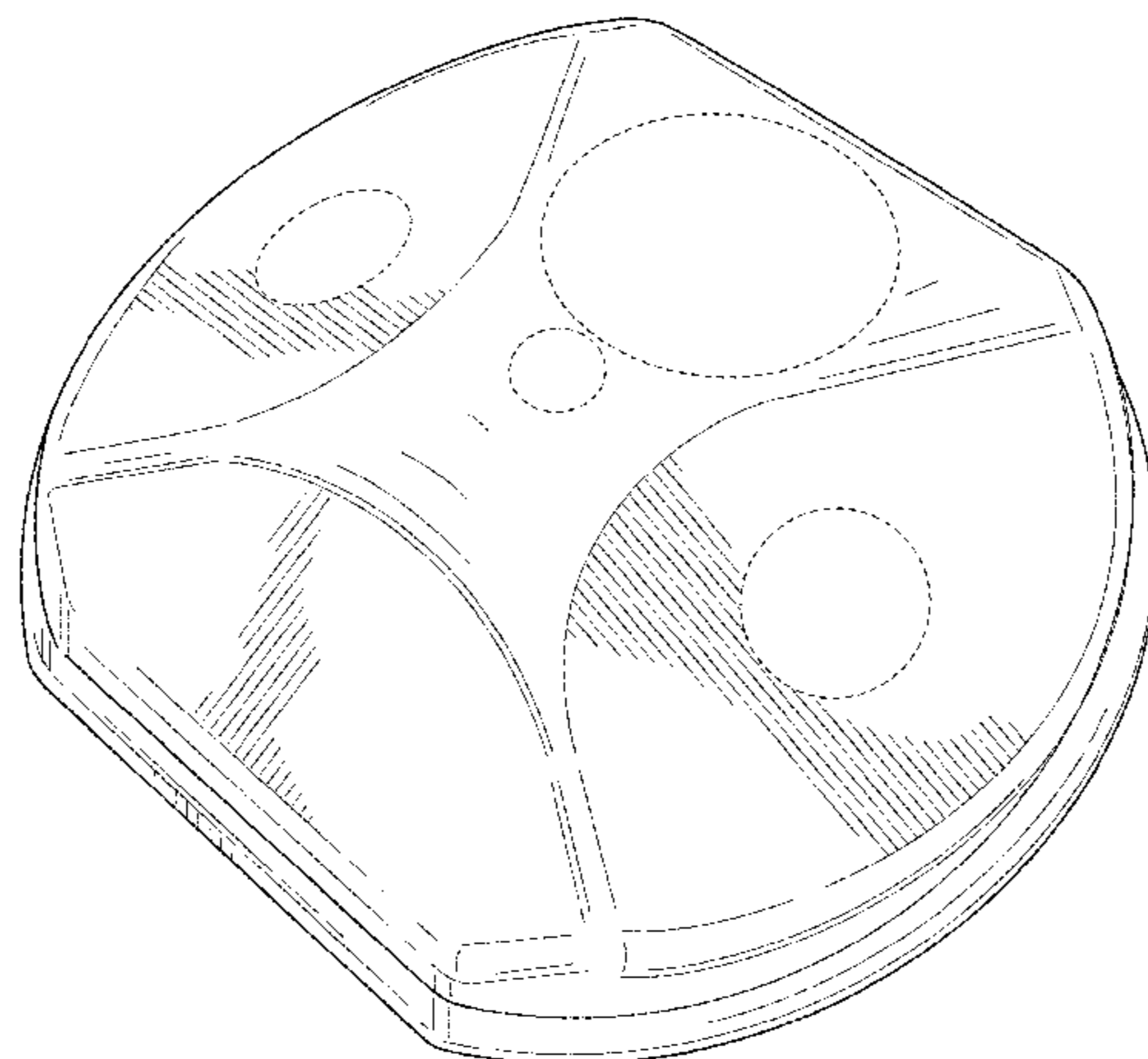

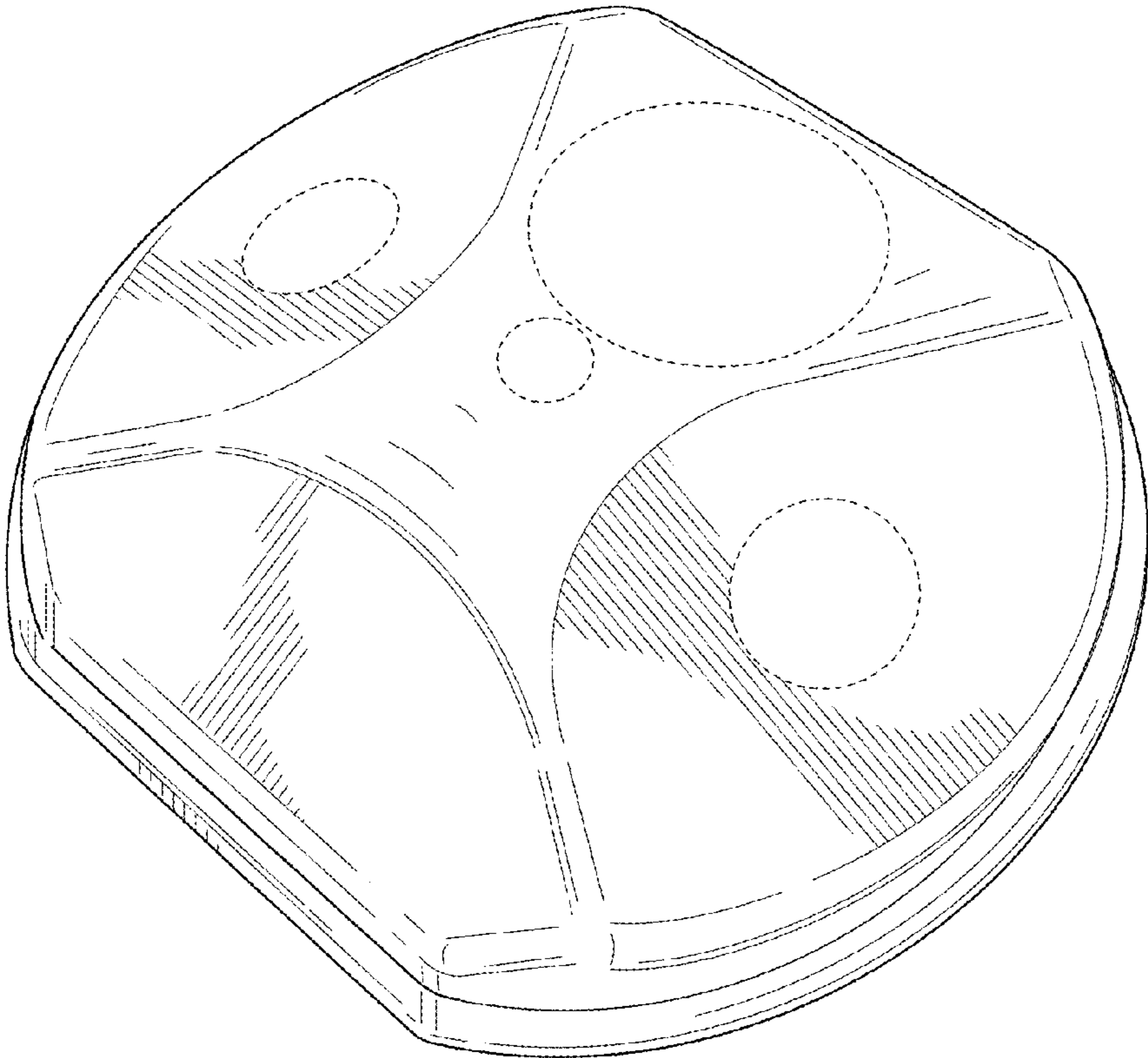

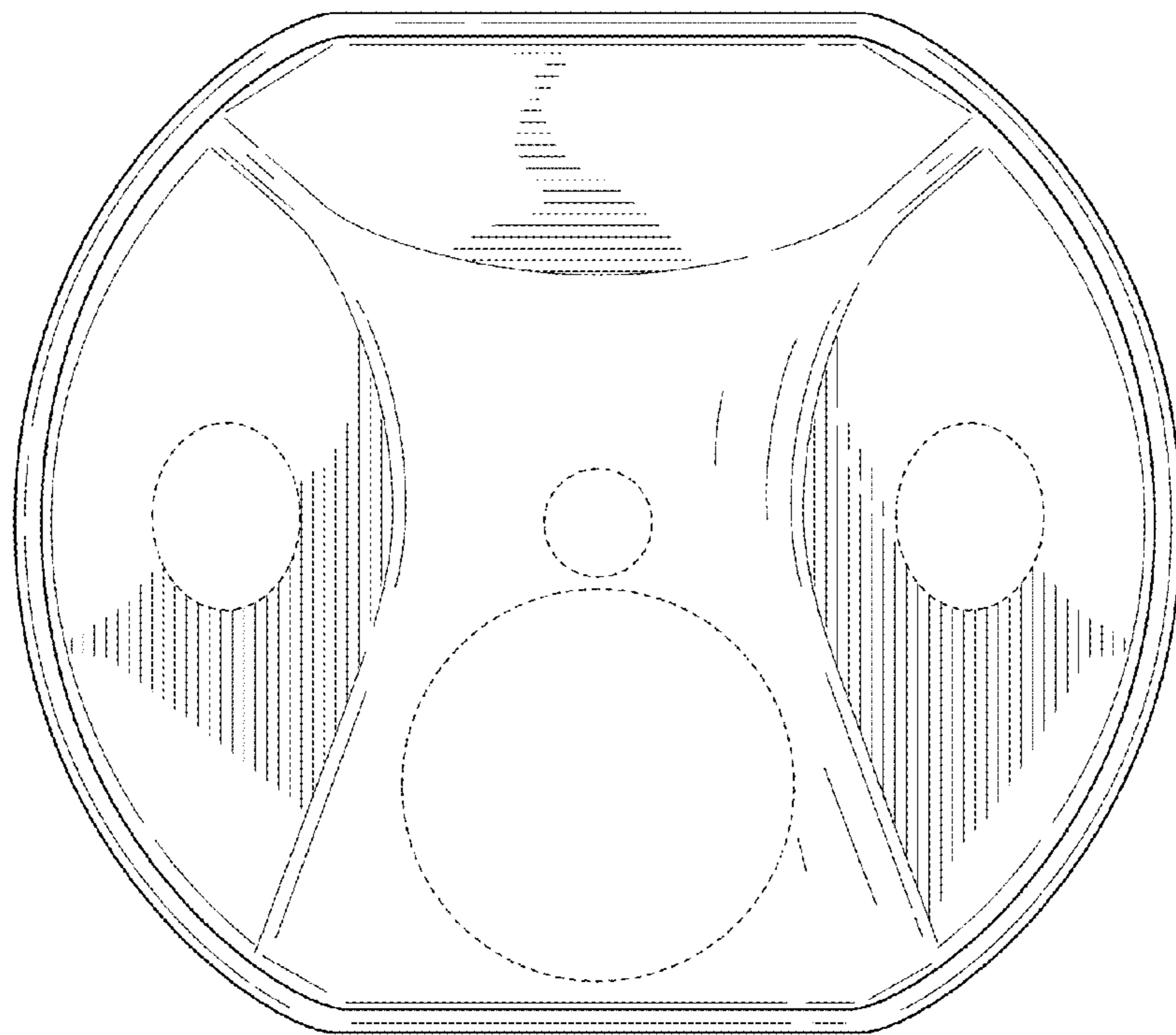

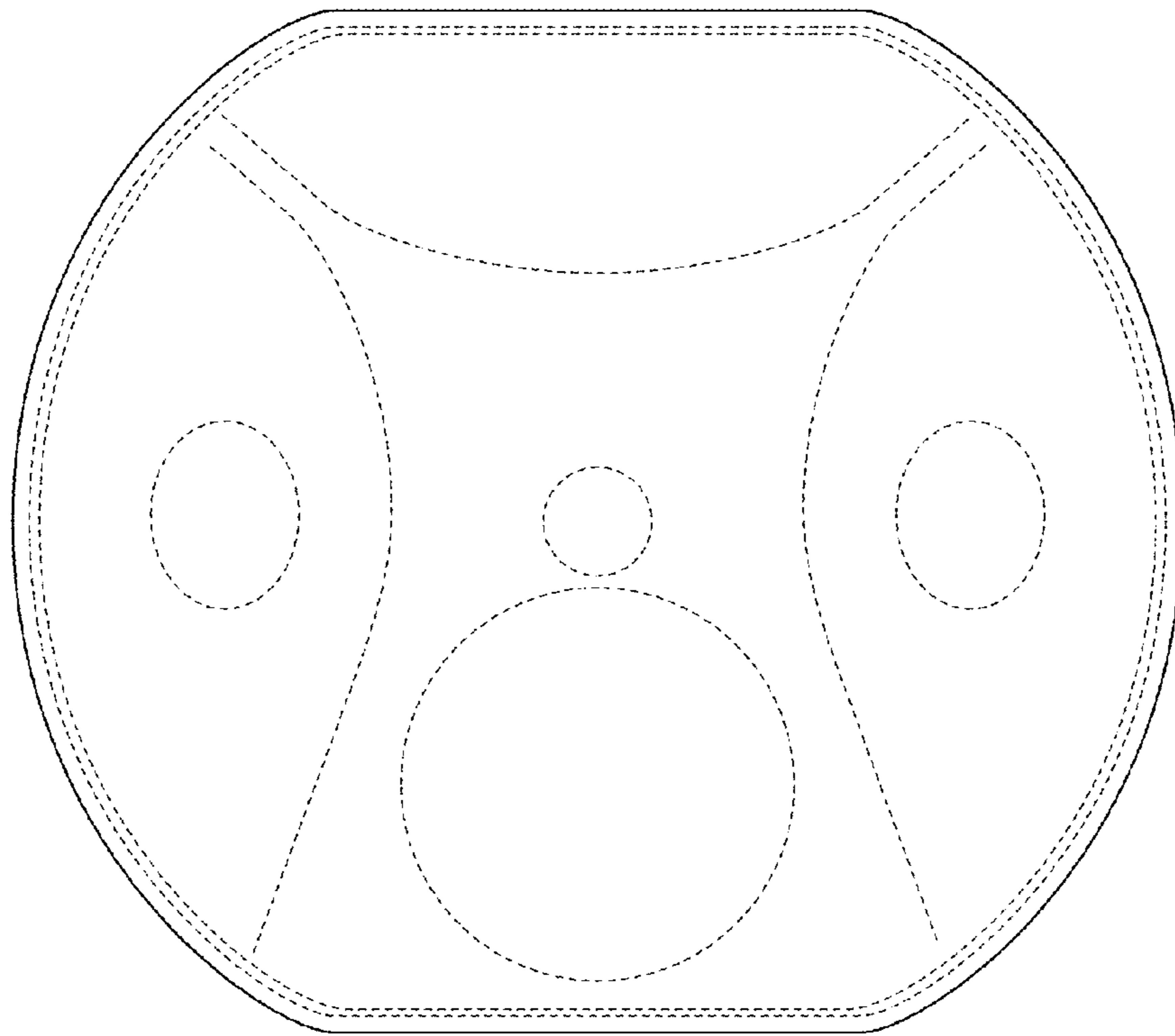

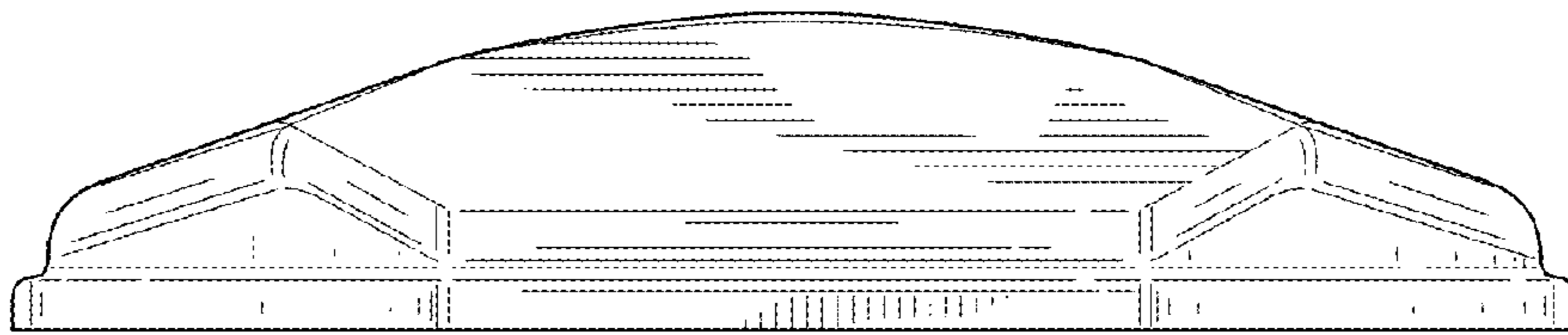

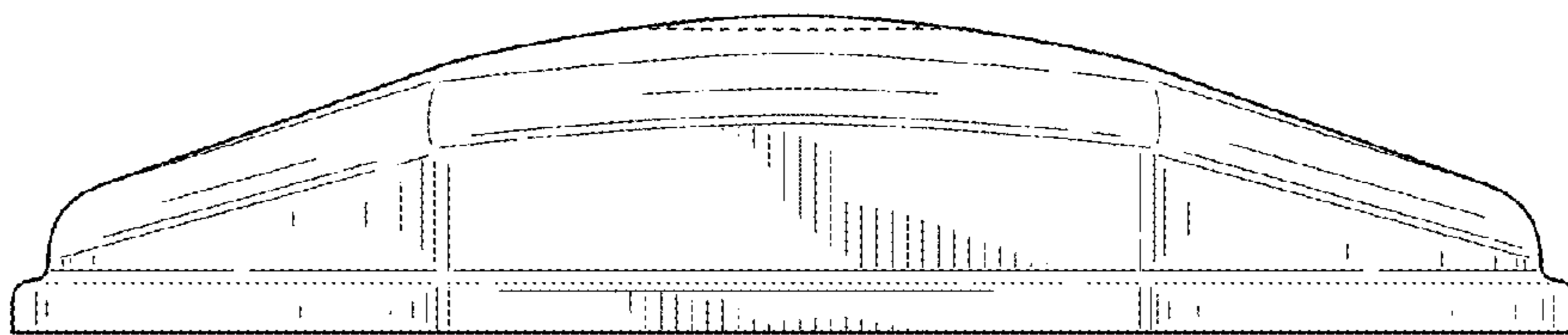

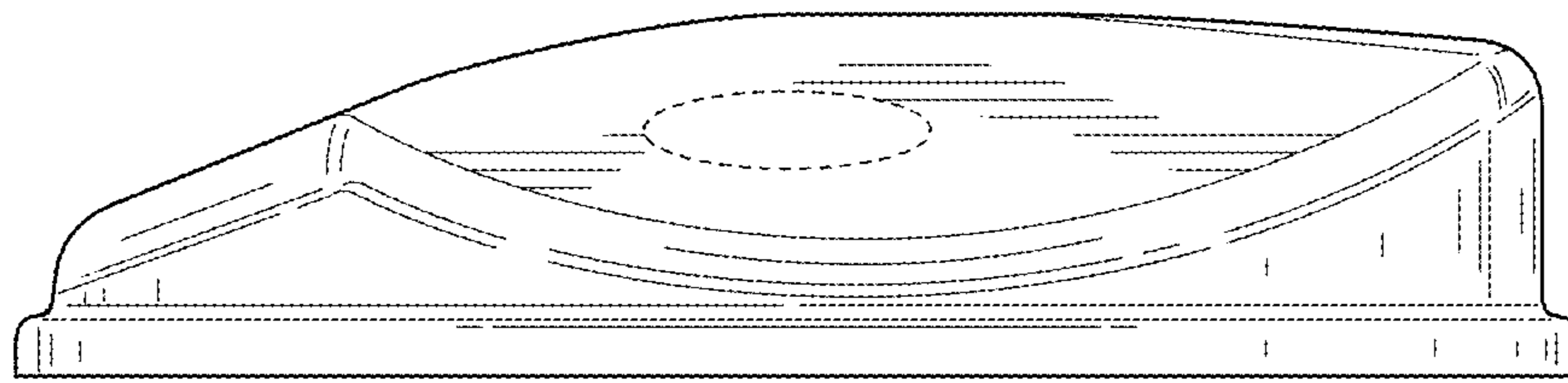

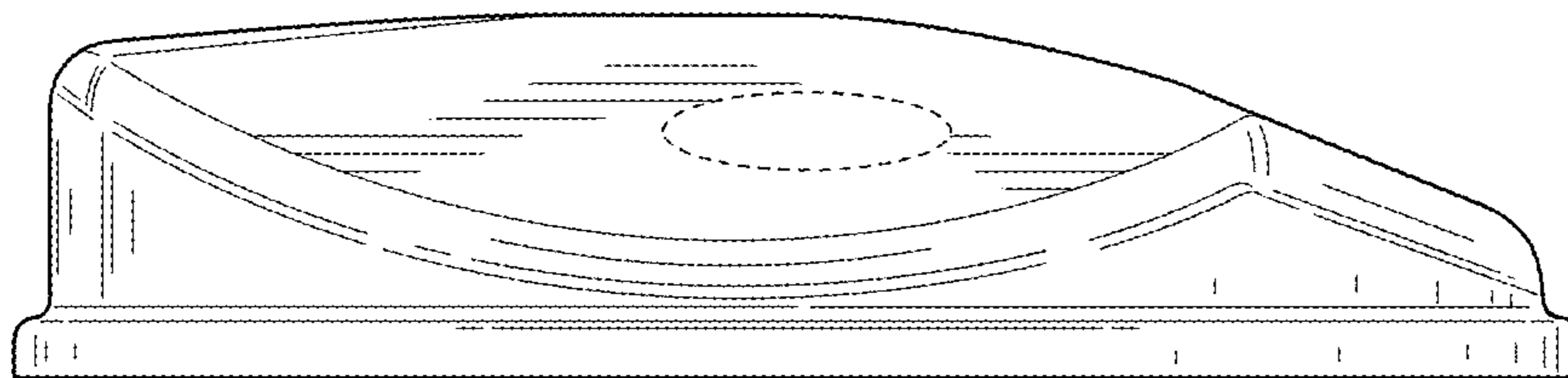
