(57) **CLAIM**

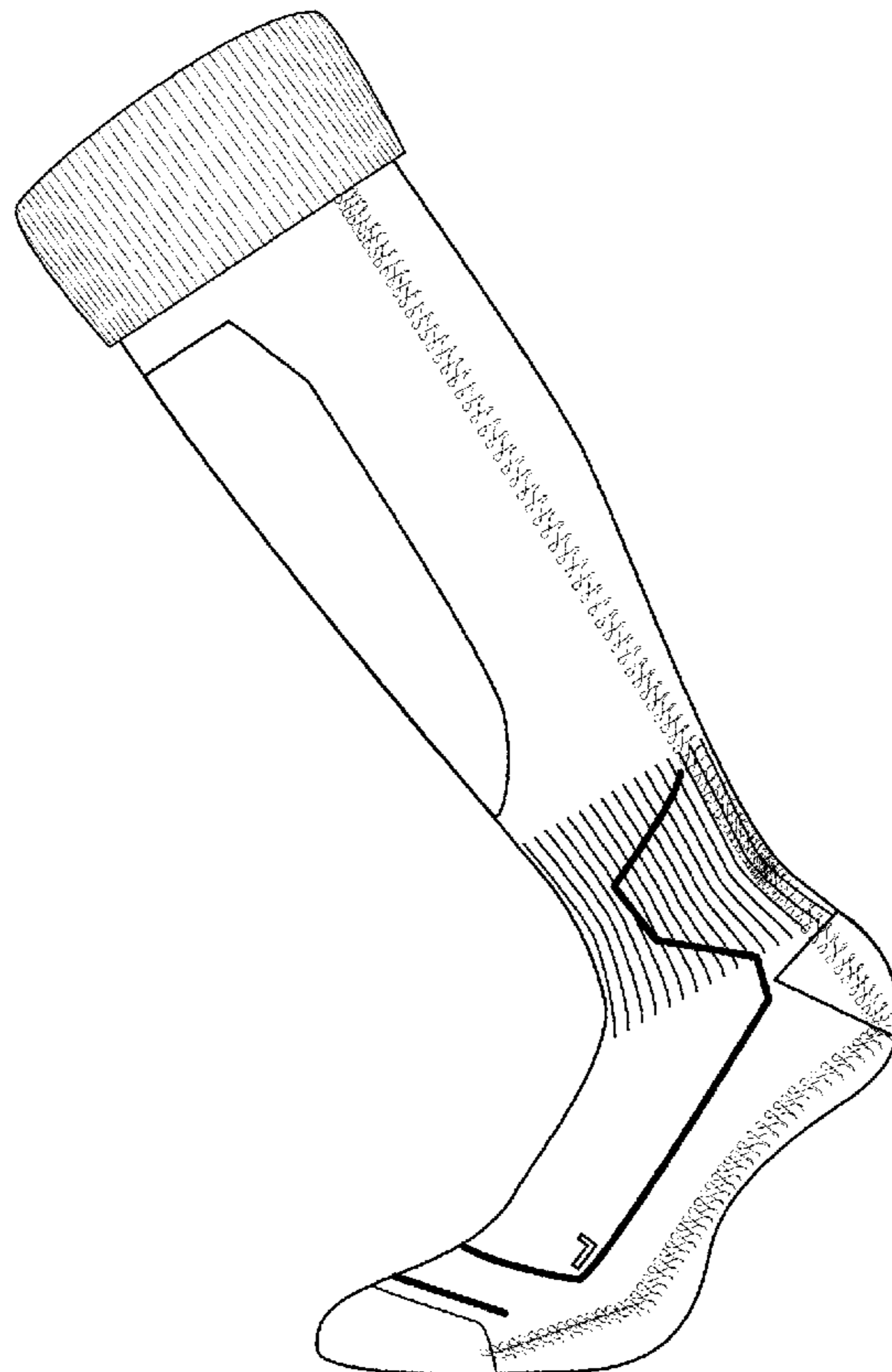
The ornamental design for a ski sock, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view of a ski sock;

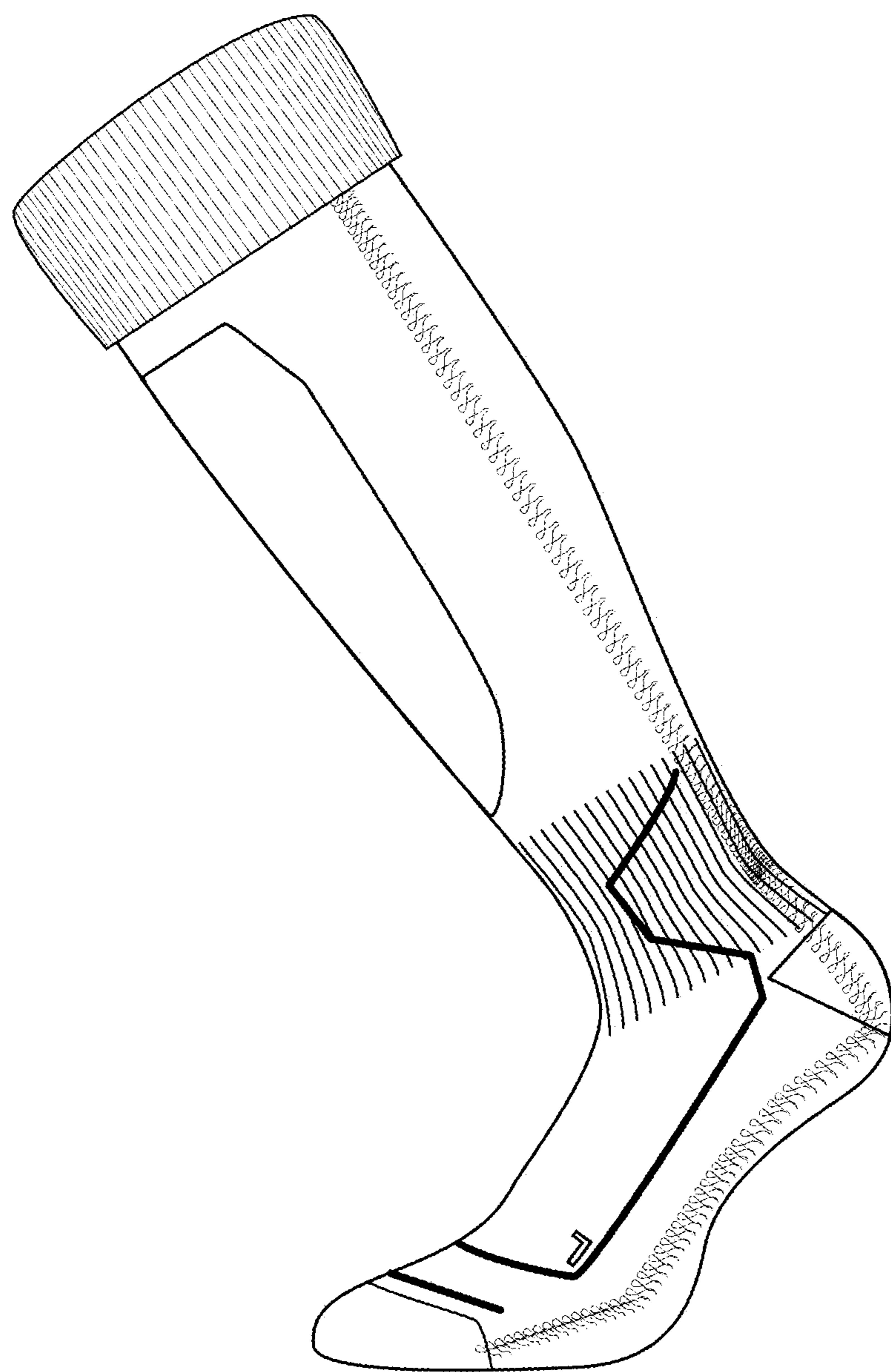

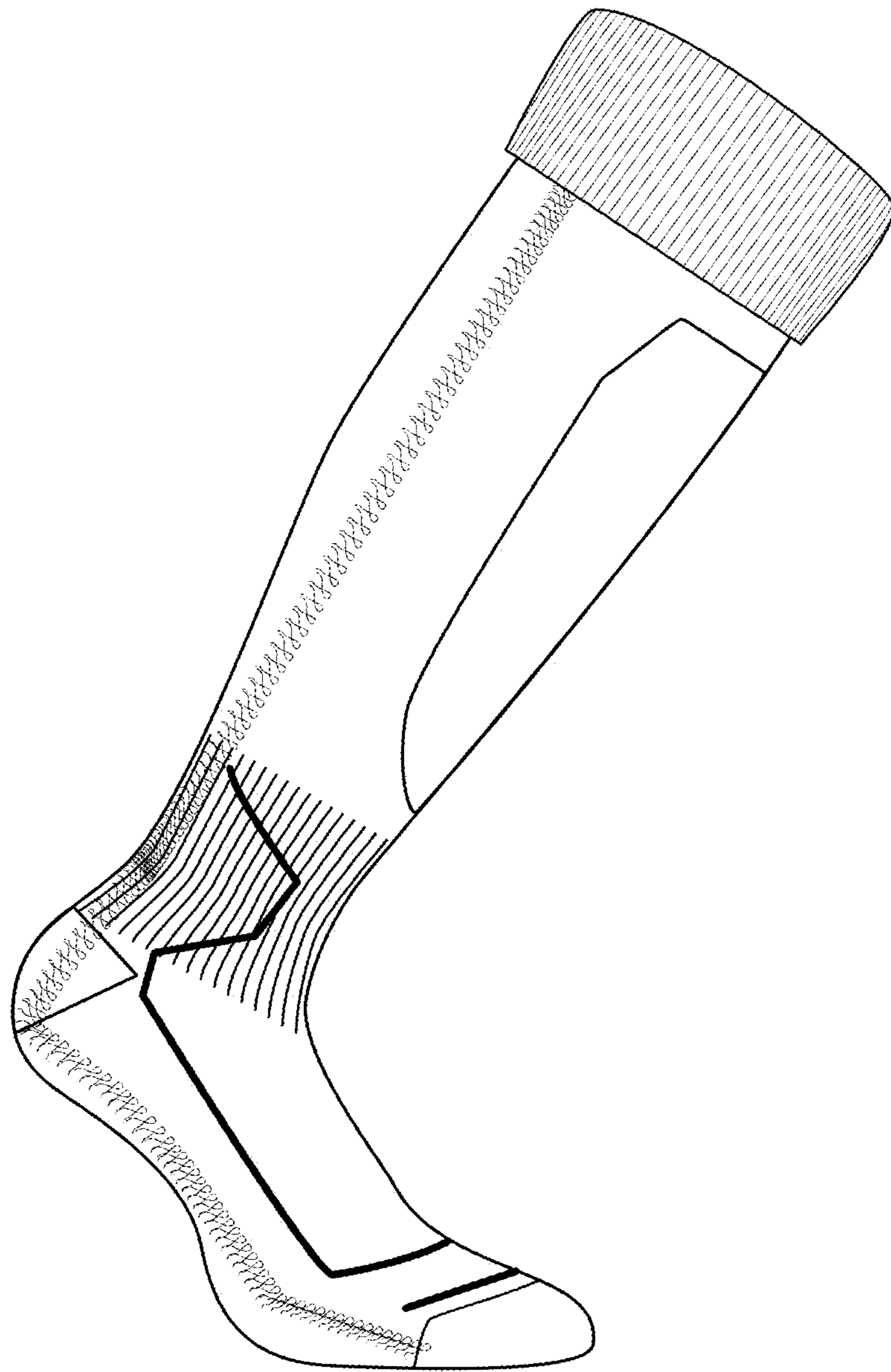

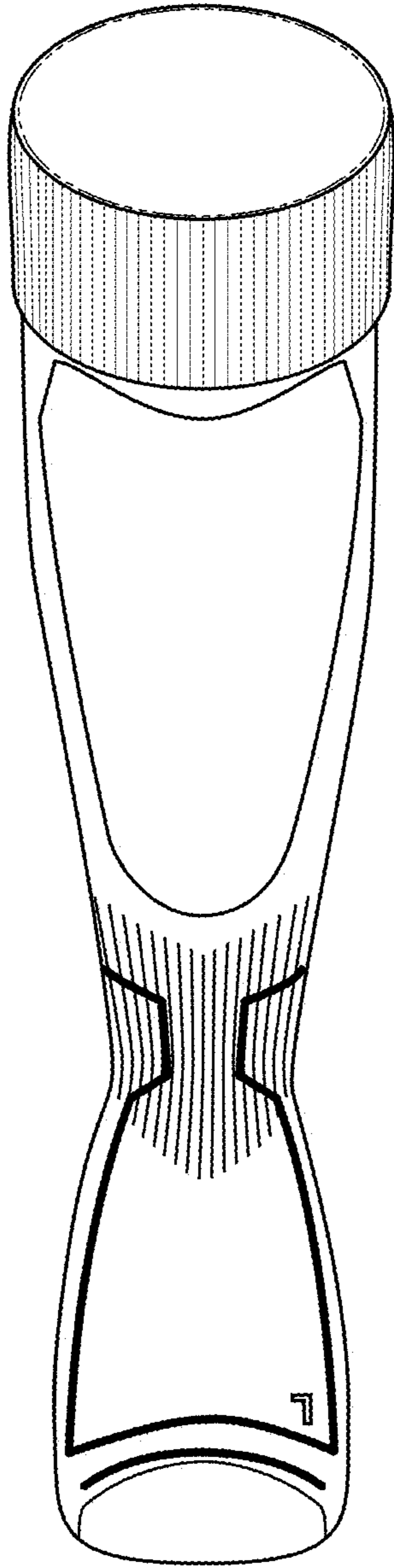

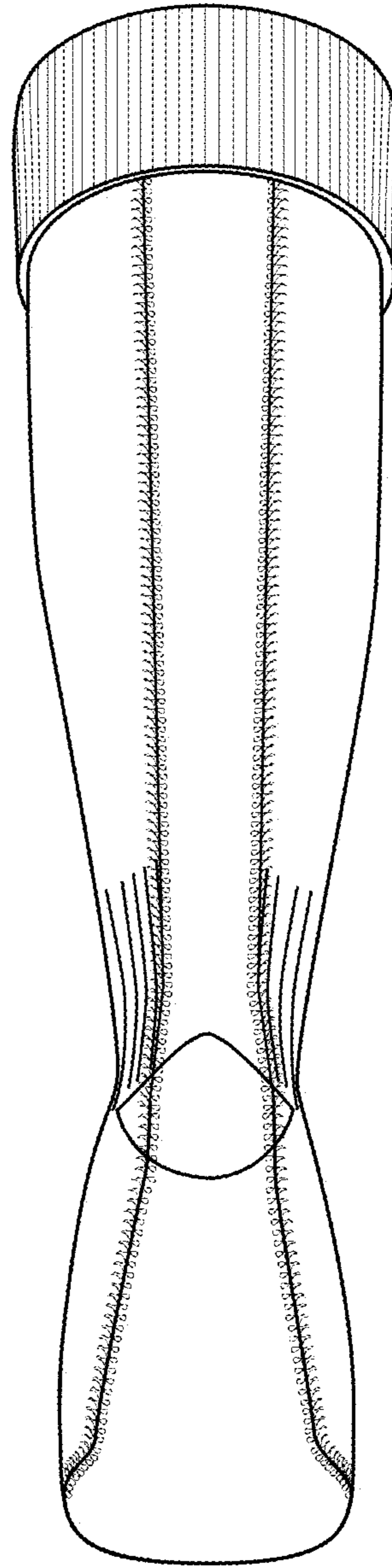
