(57) **CLAIM**

I claim the ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the toothbrush showing my new design;

FIG. 2 is a front view of the toothbrush;

FIG. 3 is a rear view of the toothbrush;

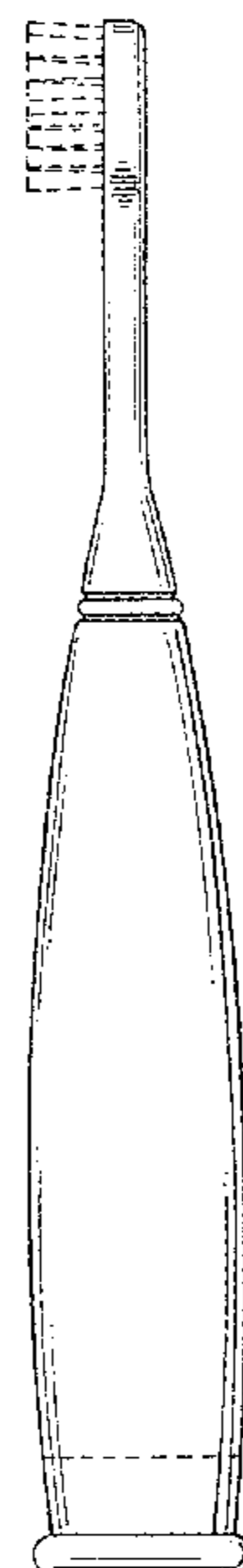
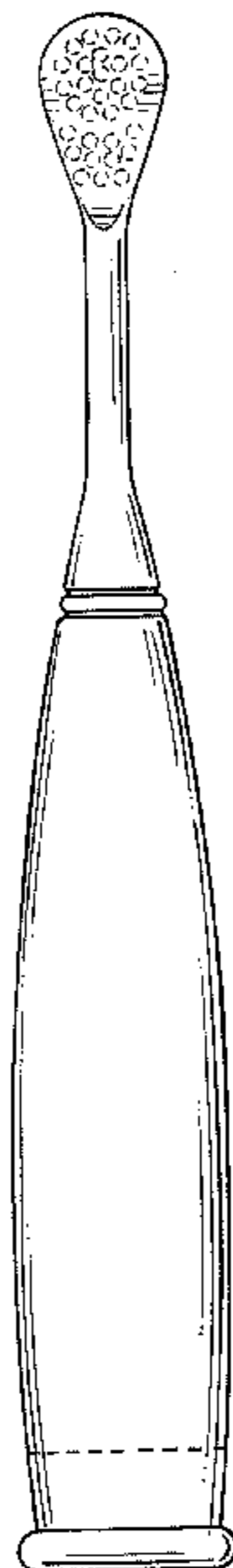
FIG. 4 is a right side view of the toothbrush;

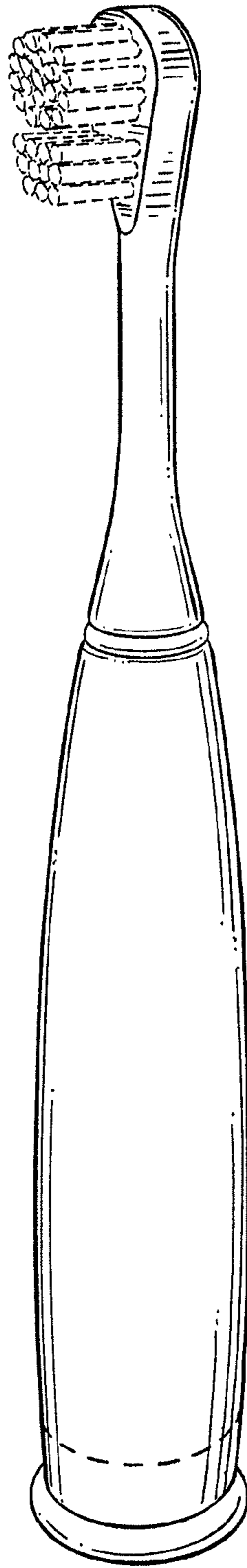

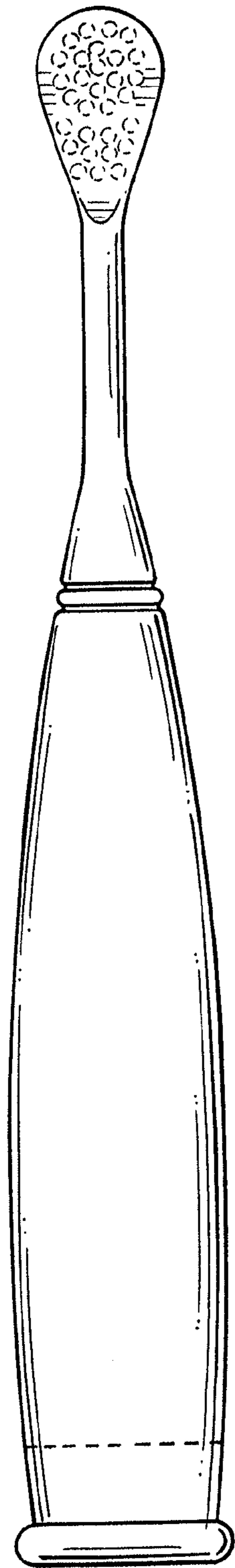

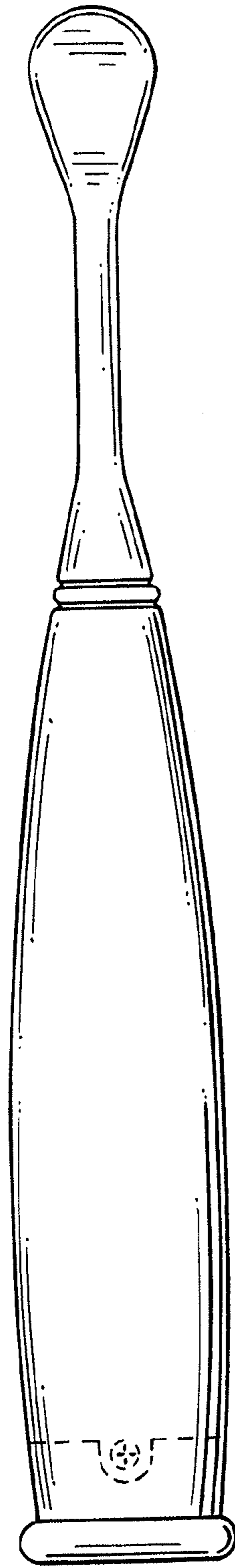

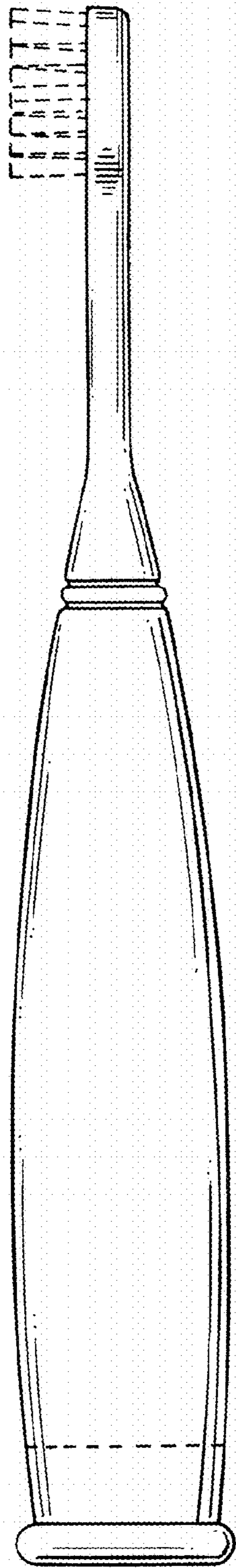

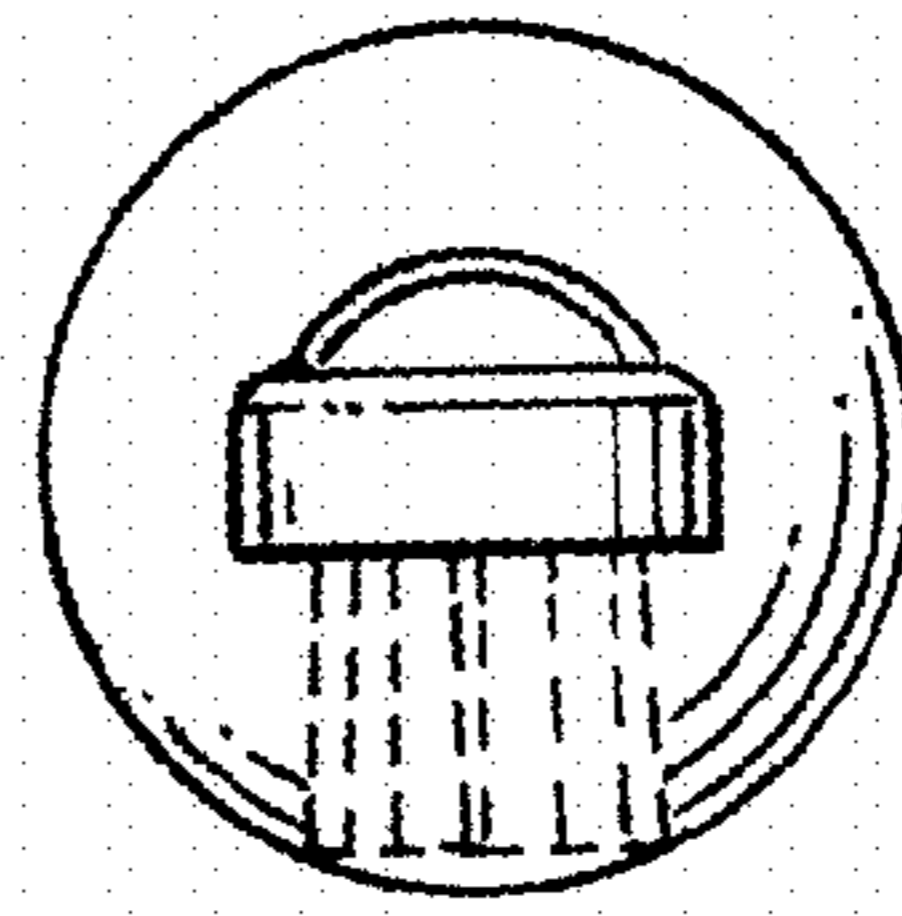

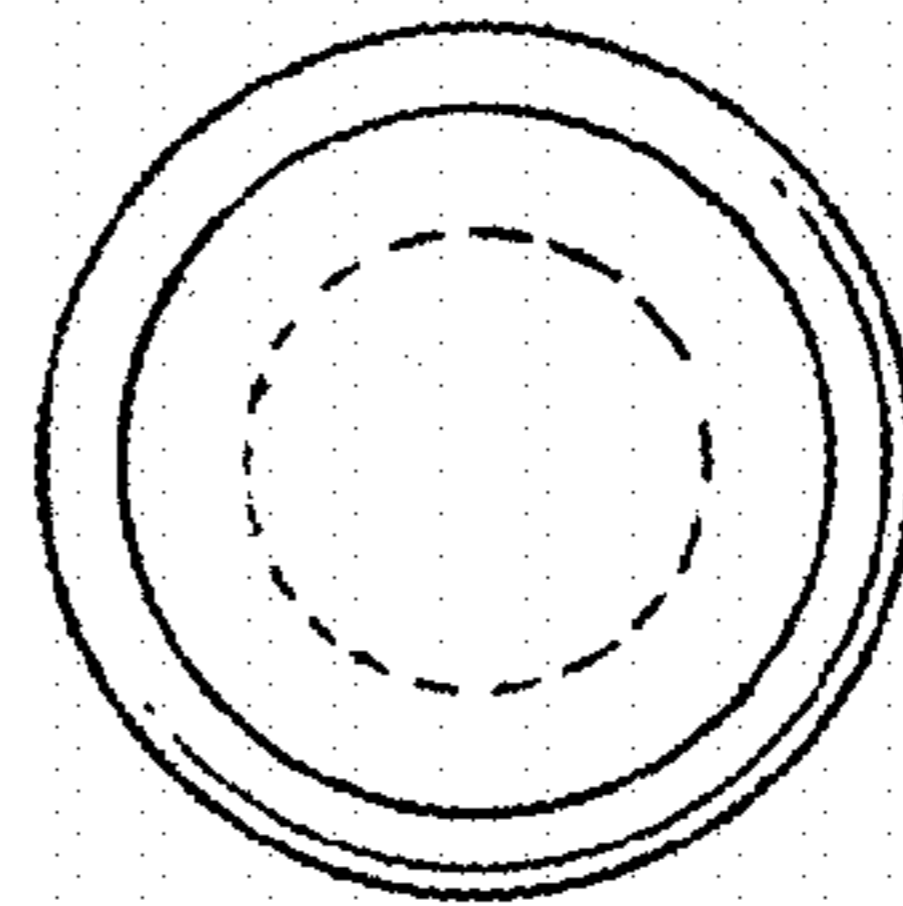
