(57) **CLAIM**

The ornamental design for a tonsil brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tonsil brush, showing my new design;

FIG. 2 is a front elevational view of a tonsil brush;

FIG. 3 is a rear elevational view of a tonsil brush;

FIG. 4 is a left-side elevational view of a tonsil brush;

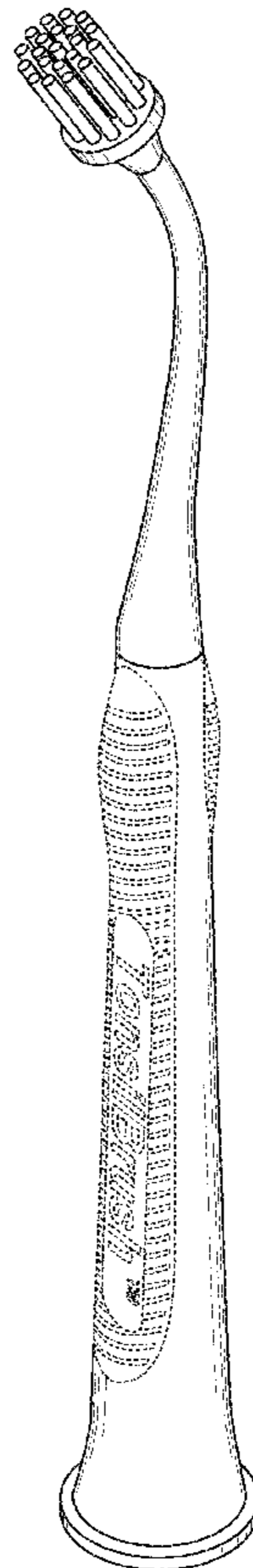
FIG. 5 is a right-side elevational view of a tonsil brush;

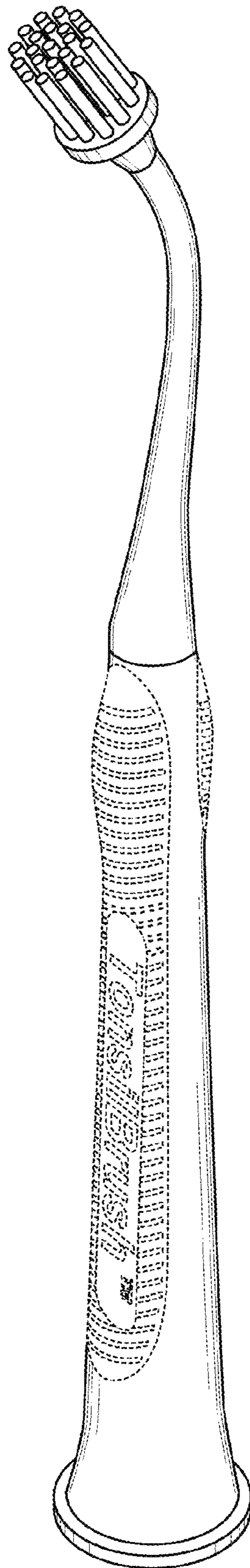

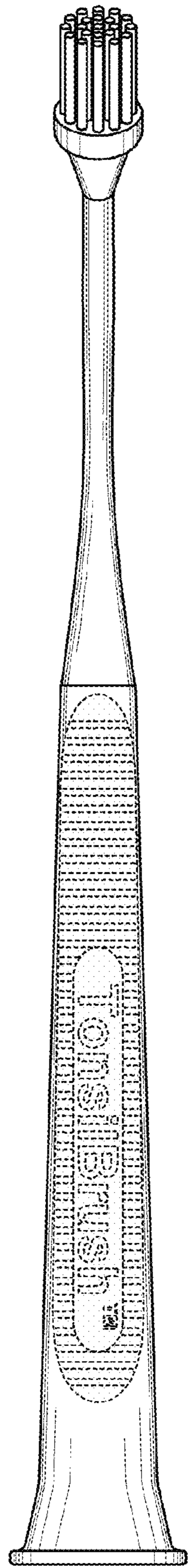

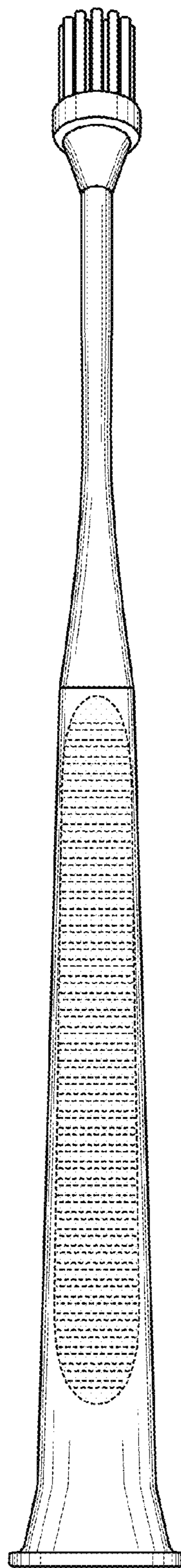

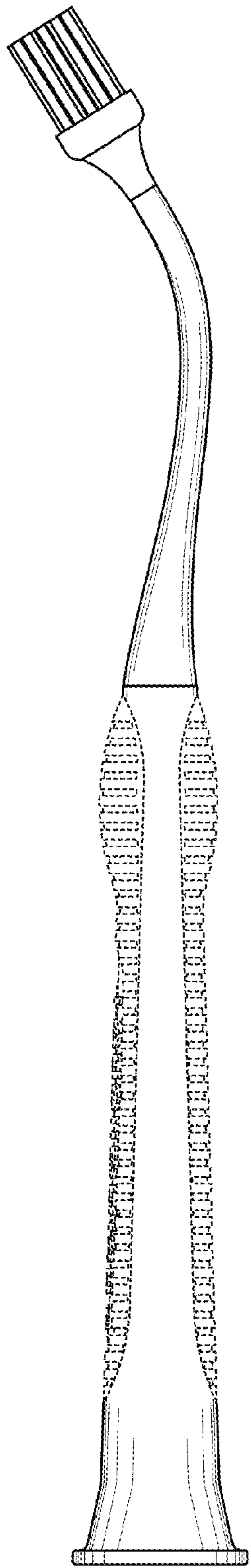

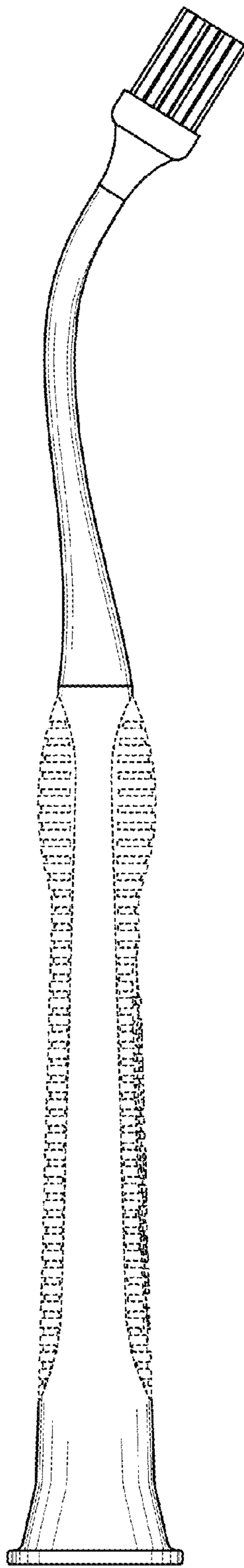

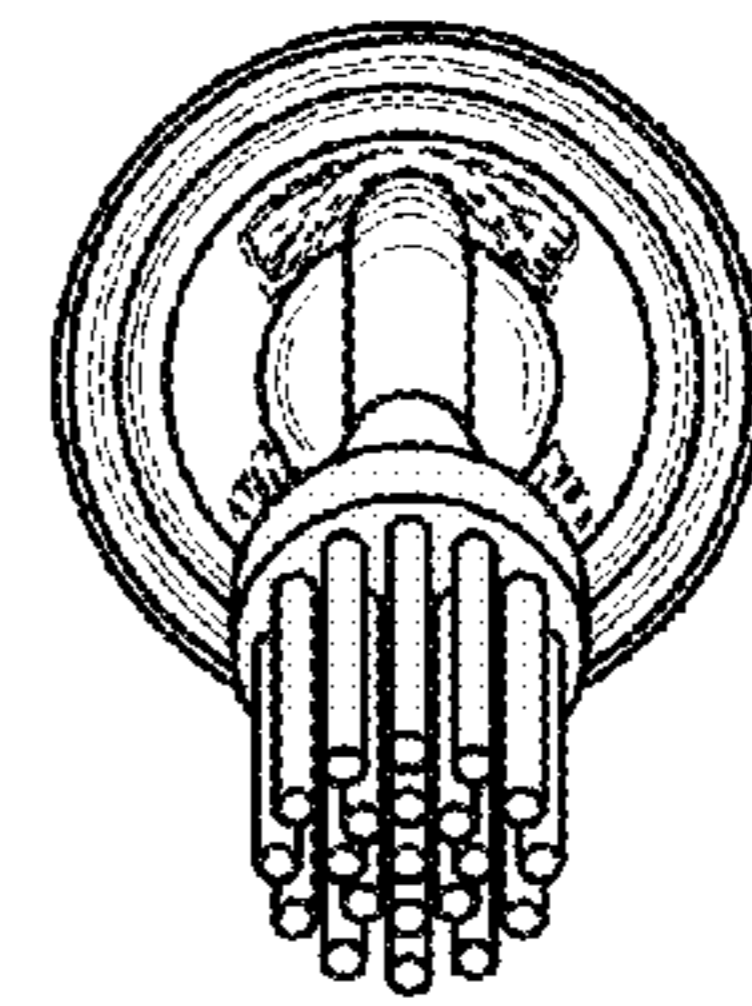

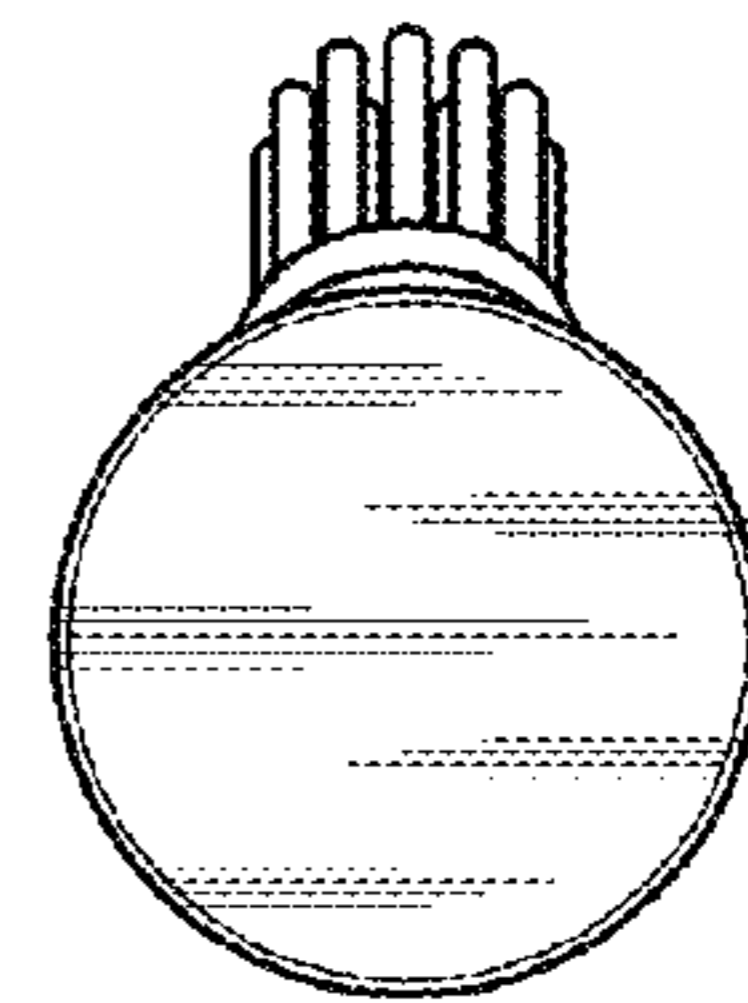
