(57) **CLAIM**

The ornamental design for a seat for motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the seat for motor vehicle; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is an elevation view thereof from the left side; FIG. 6 is an elevation view thereof from the right side; and, FIG. 7 is a top plan view thereof. 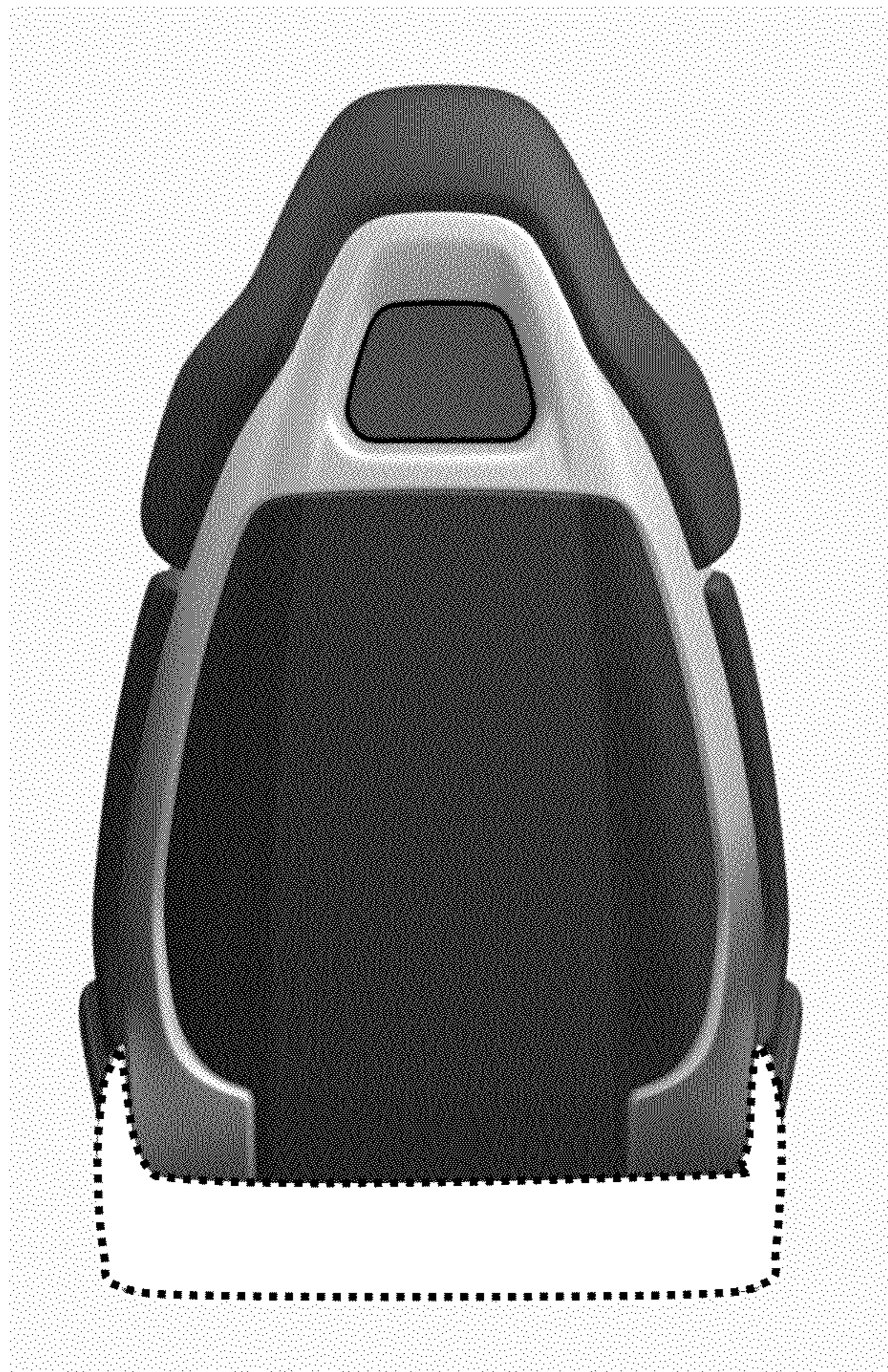

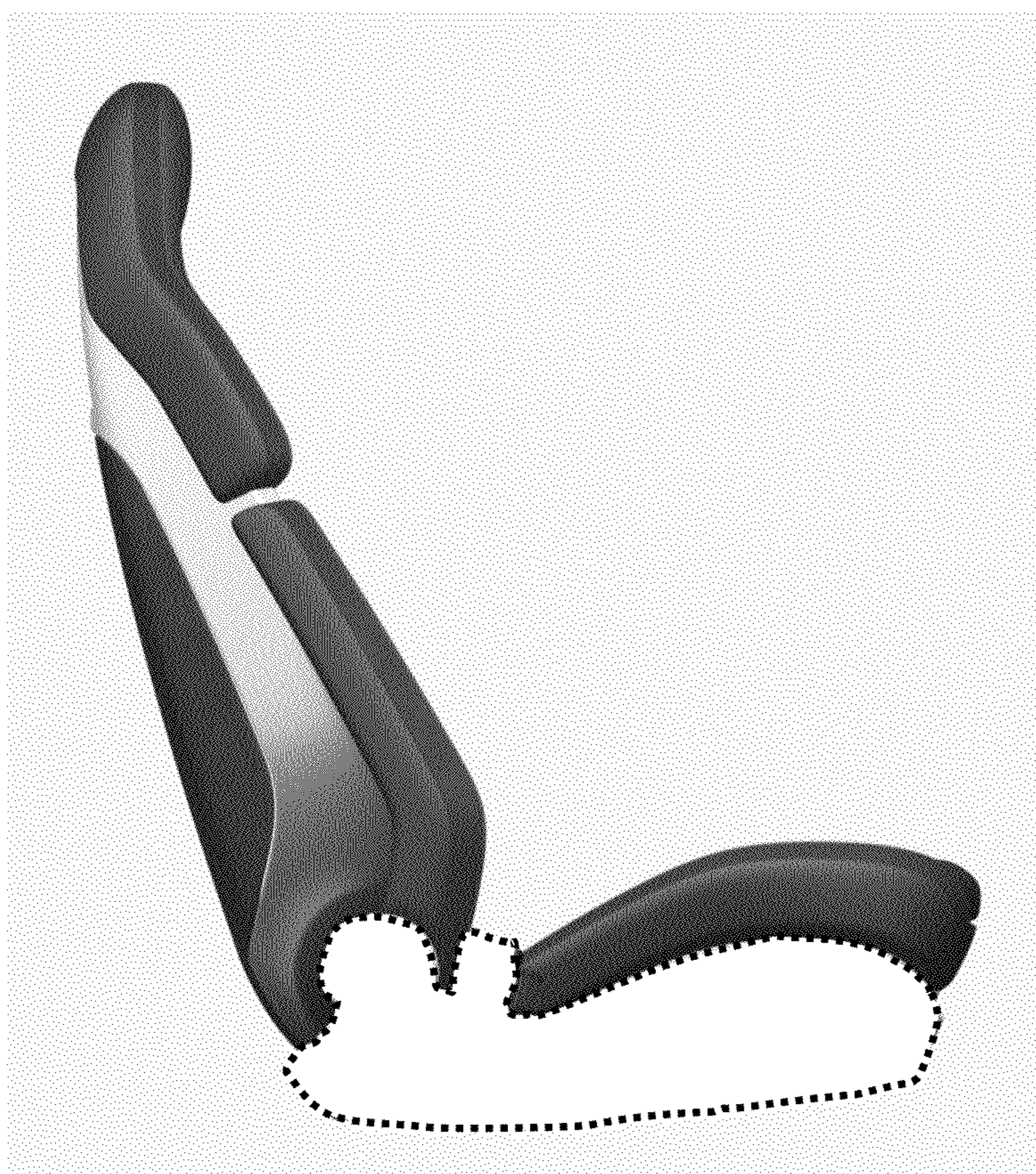

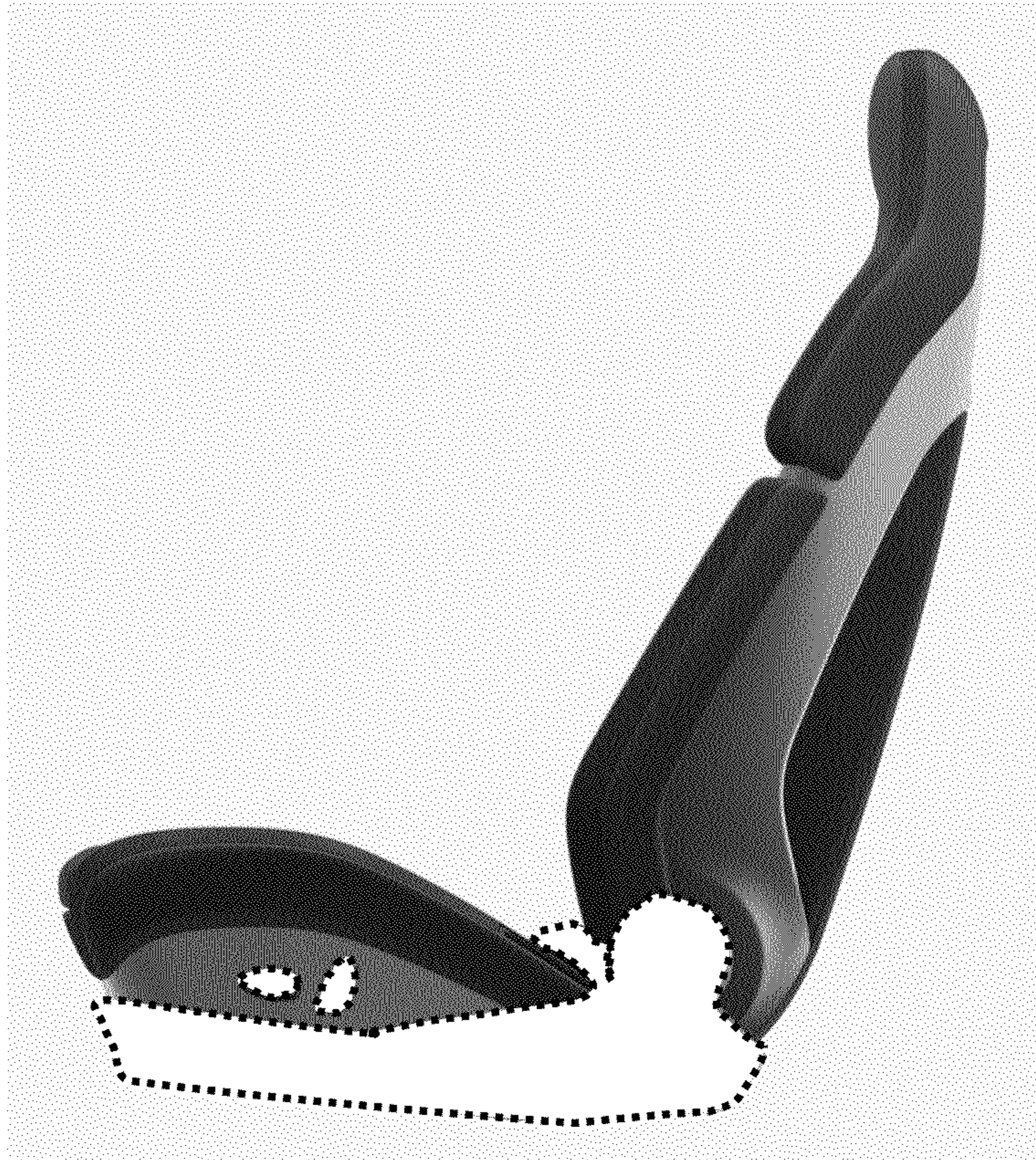
