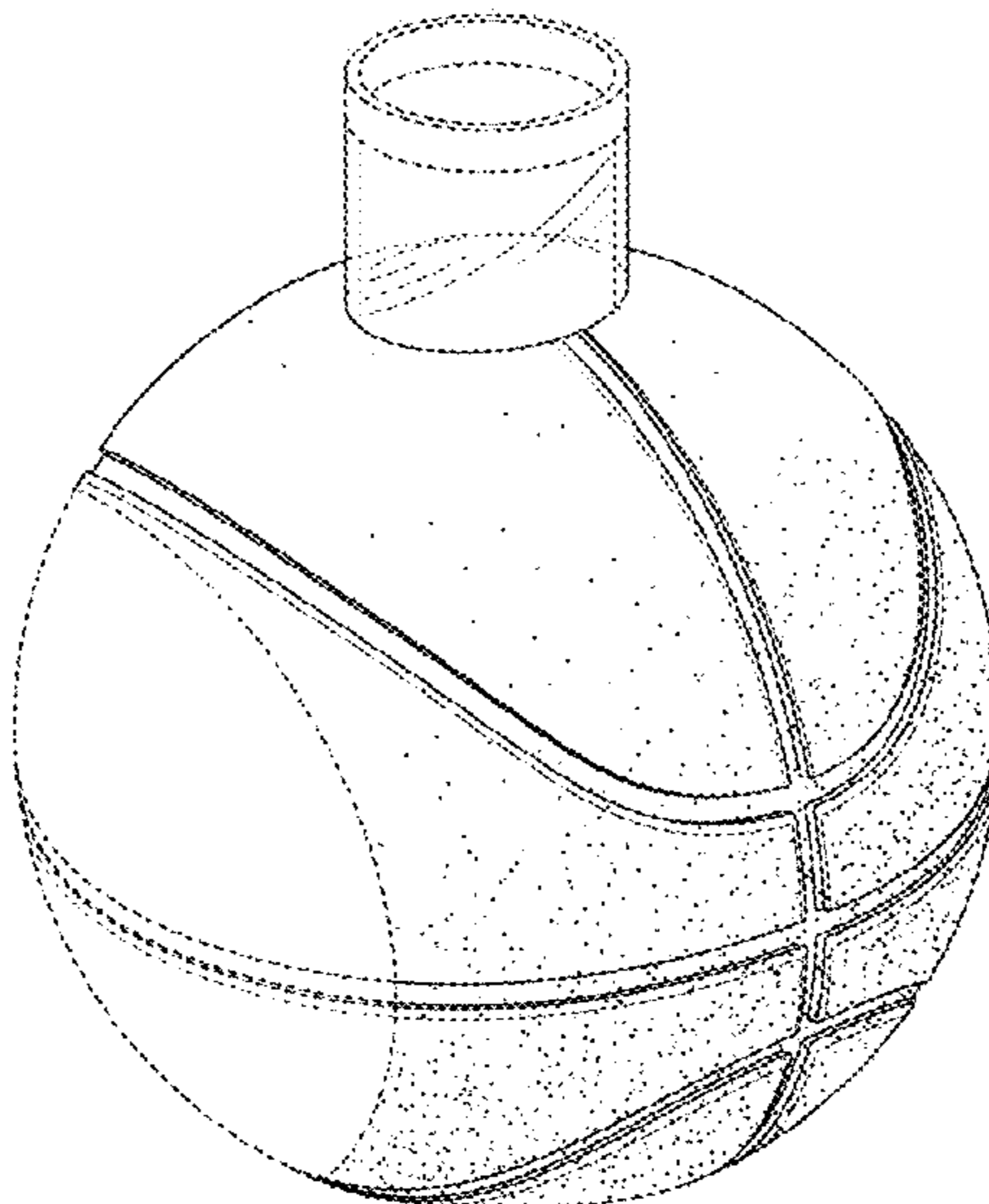

DESCRIPTION

FIG. 1 is a front/right side perspective view of the basketball shot glass design.
FIG. 2 is a front view of the basketball shot glass design.
FIG. 3 is a rear view of the basketball shot glass design.
FIG. 4 is a left side view of the basketball shot glass design.
FIG. 5 is a right side view of the basketball shot glass design.
FIG. 6 is a top view of the basketball shot glass design; and,
FIG. 7 is a bottom view of the basketball shot glass design.
The broken lines shown in FIGS. 1-7 represent portions of the basketball shot glass that form no part of the claim.

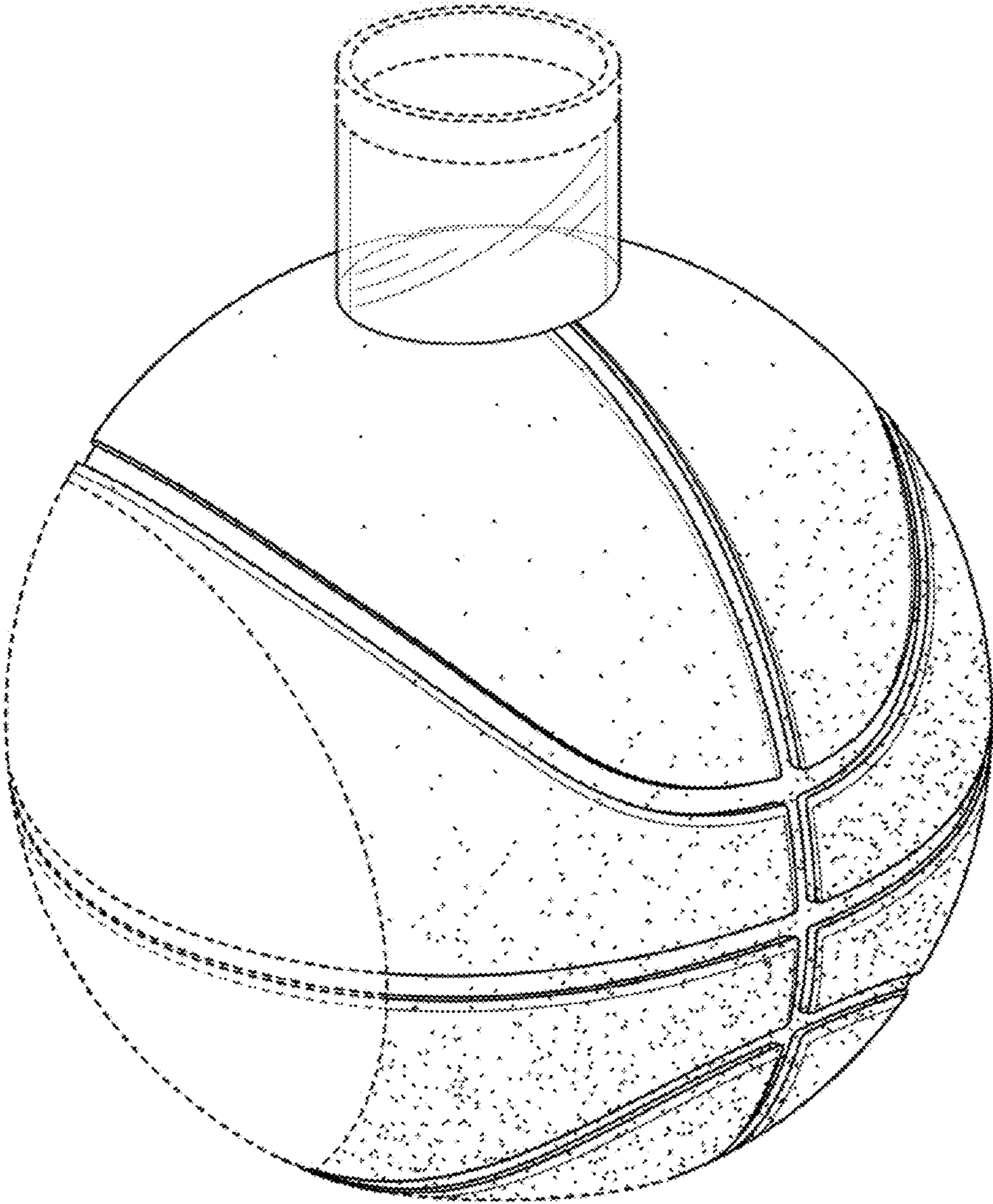

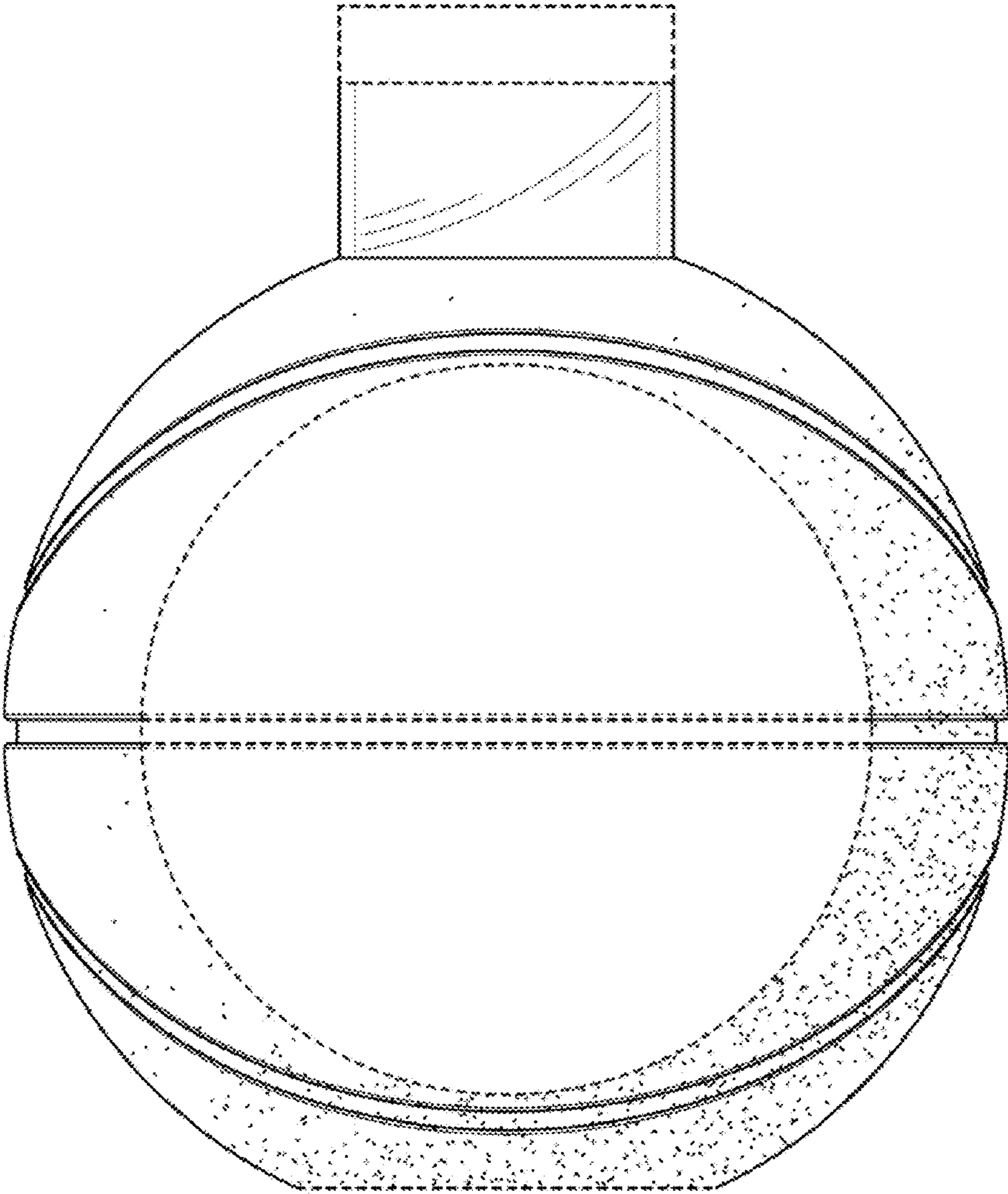

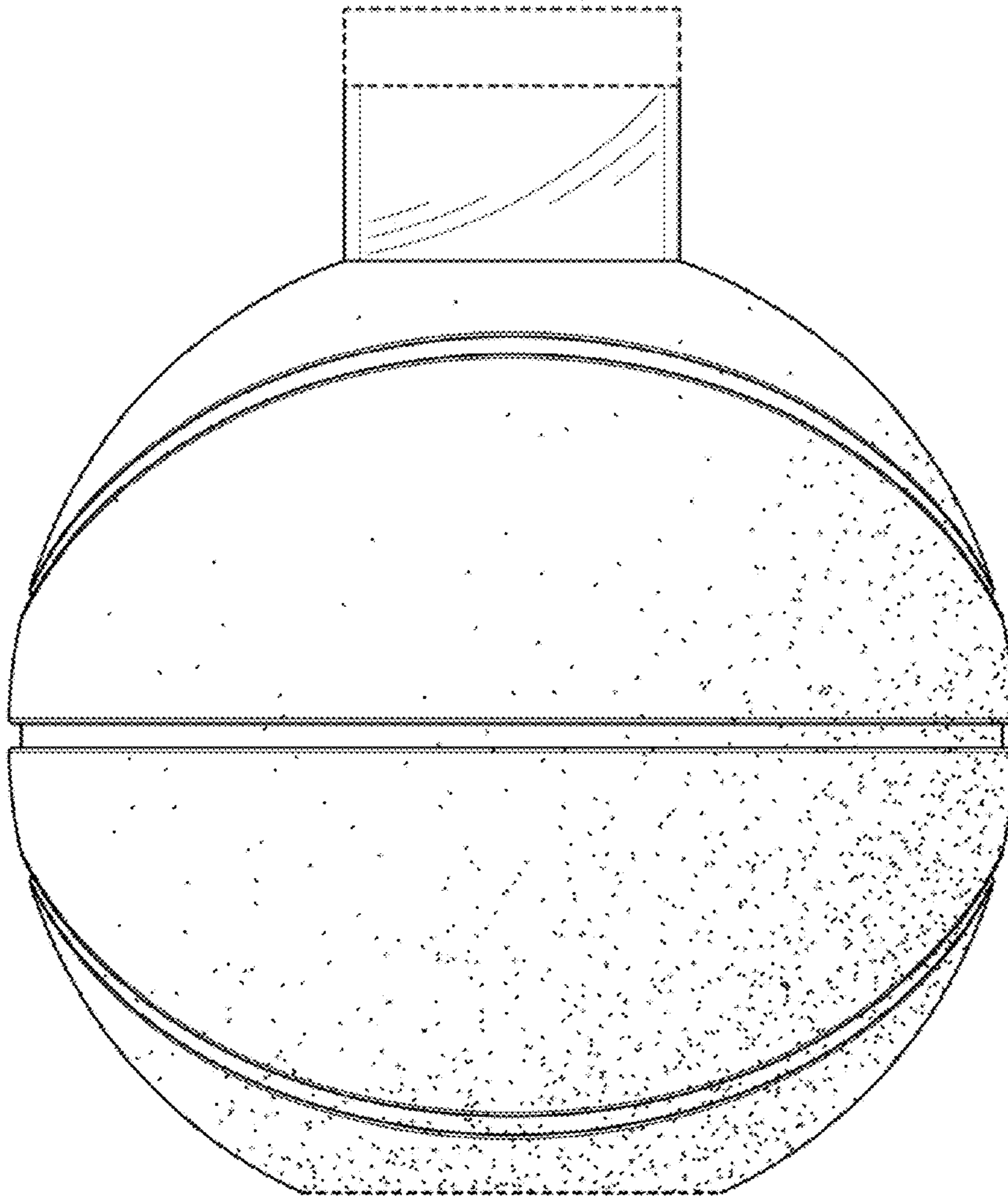

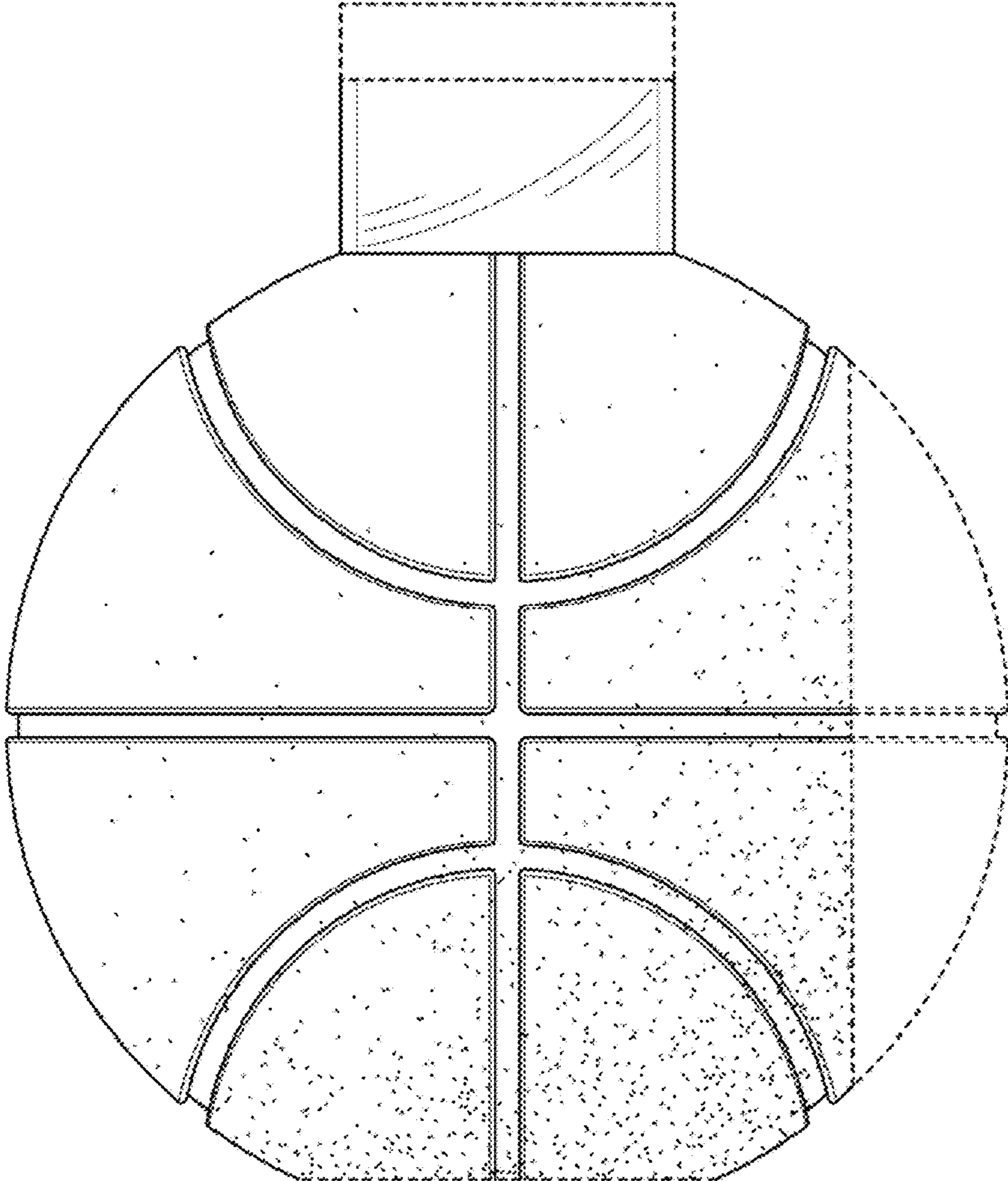

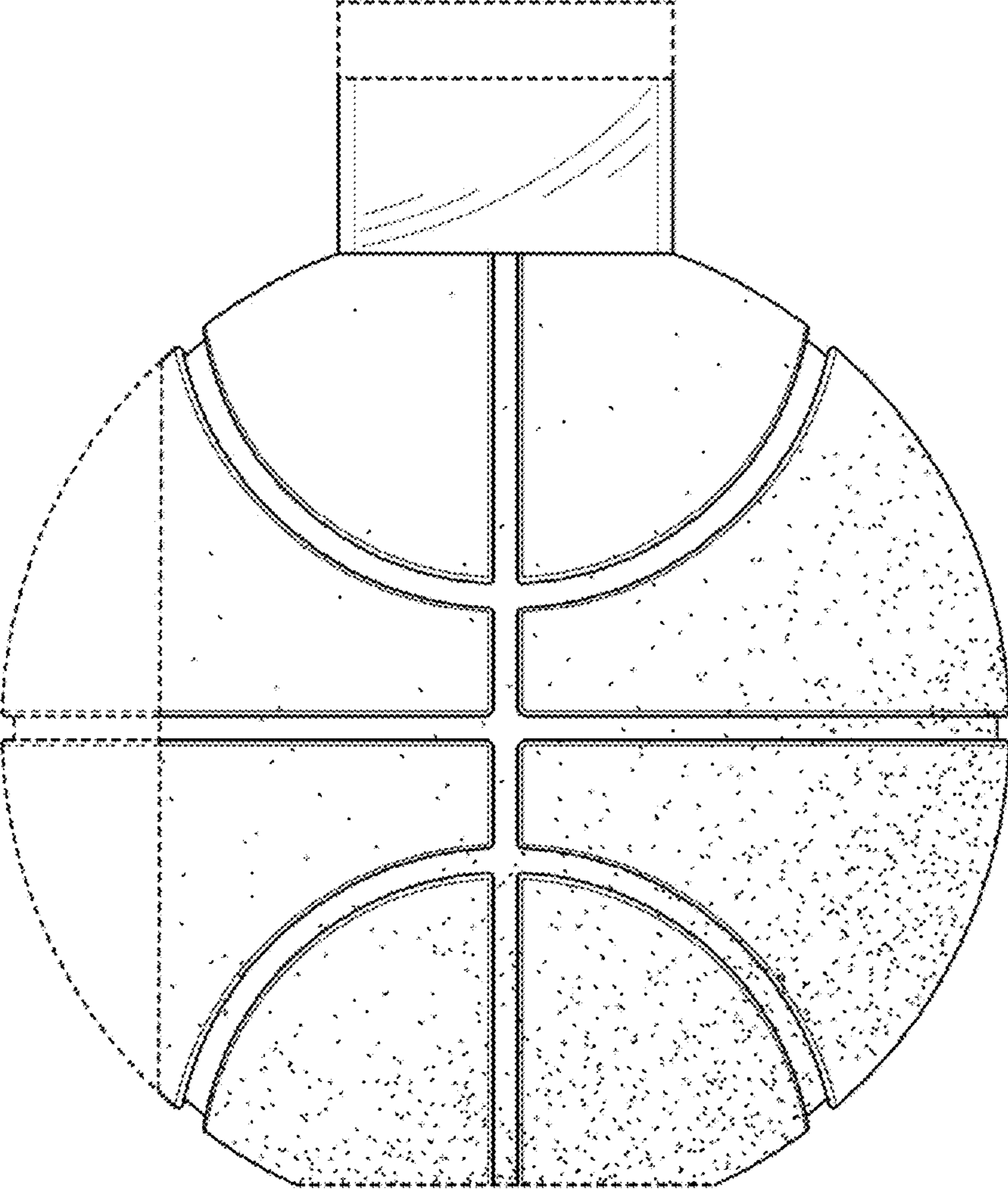

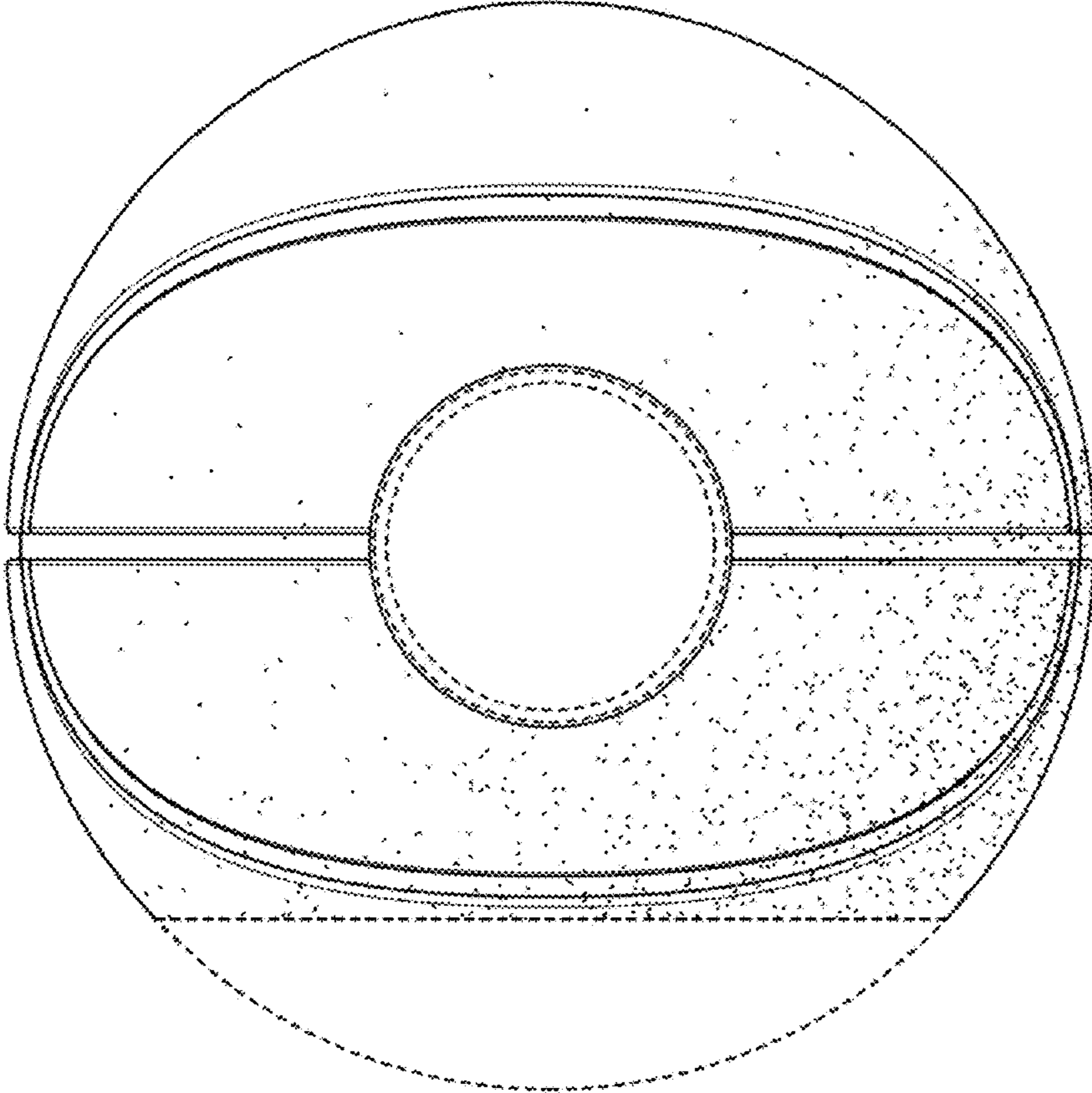

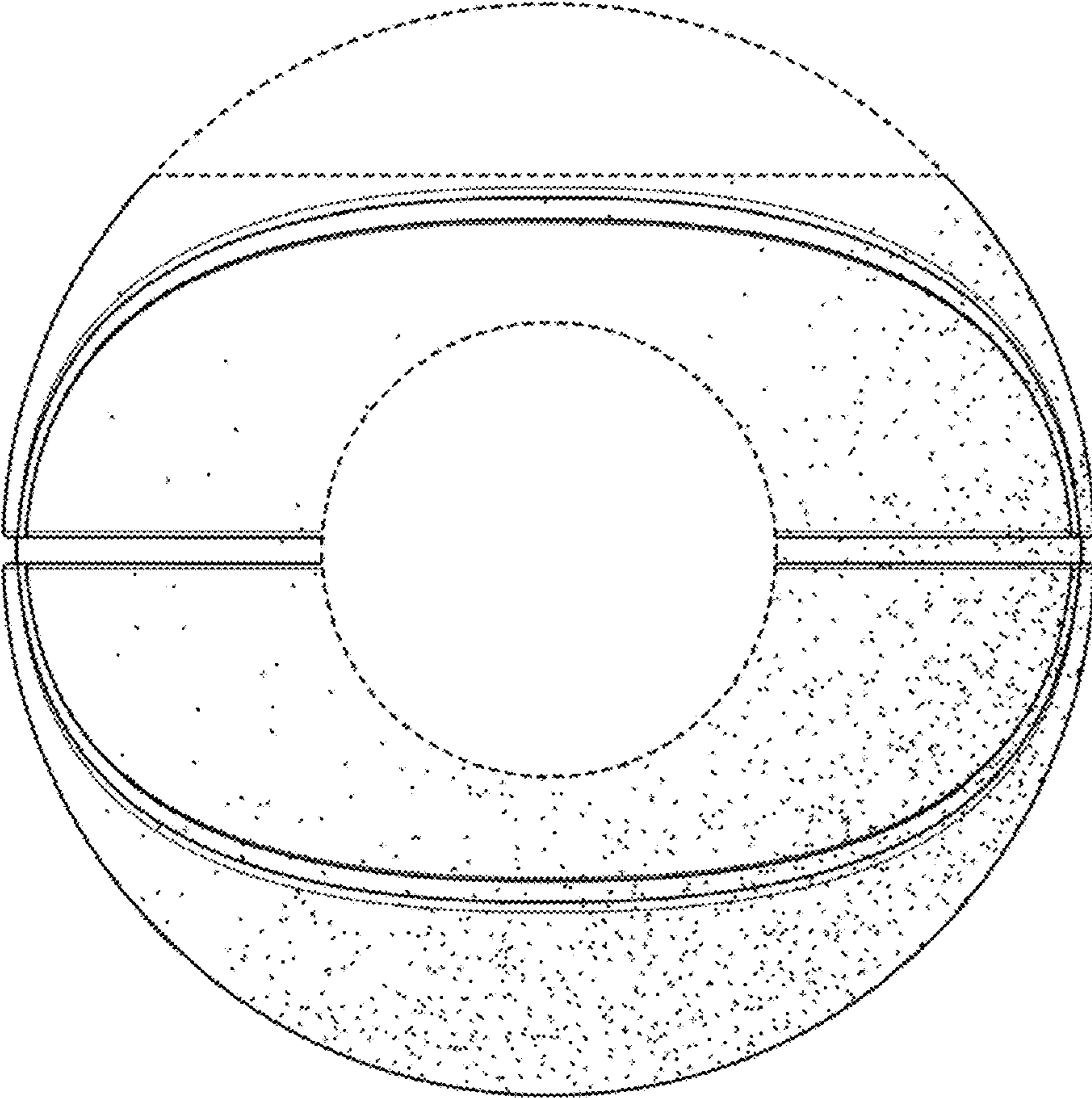
