The ornamental design for a folding chisel, as shown and described.

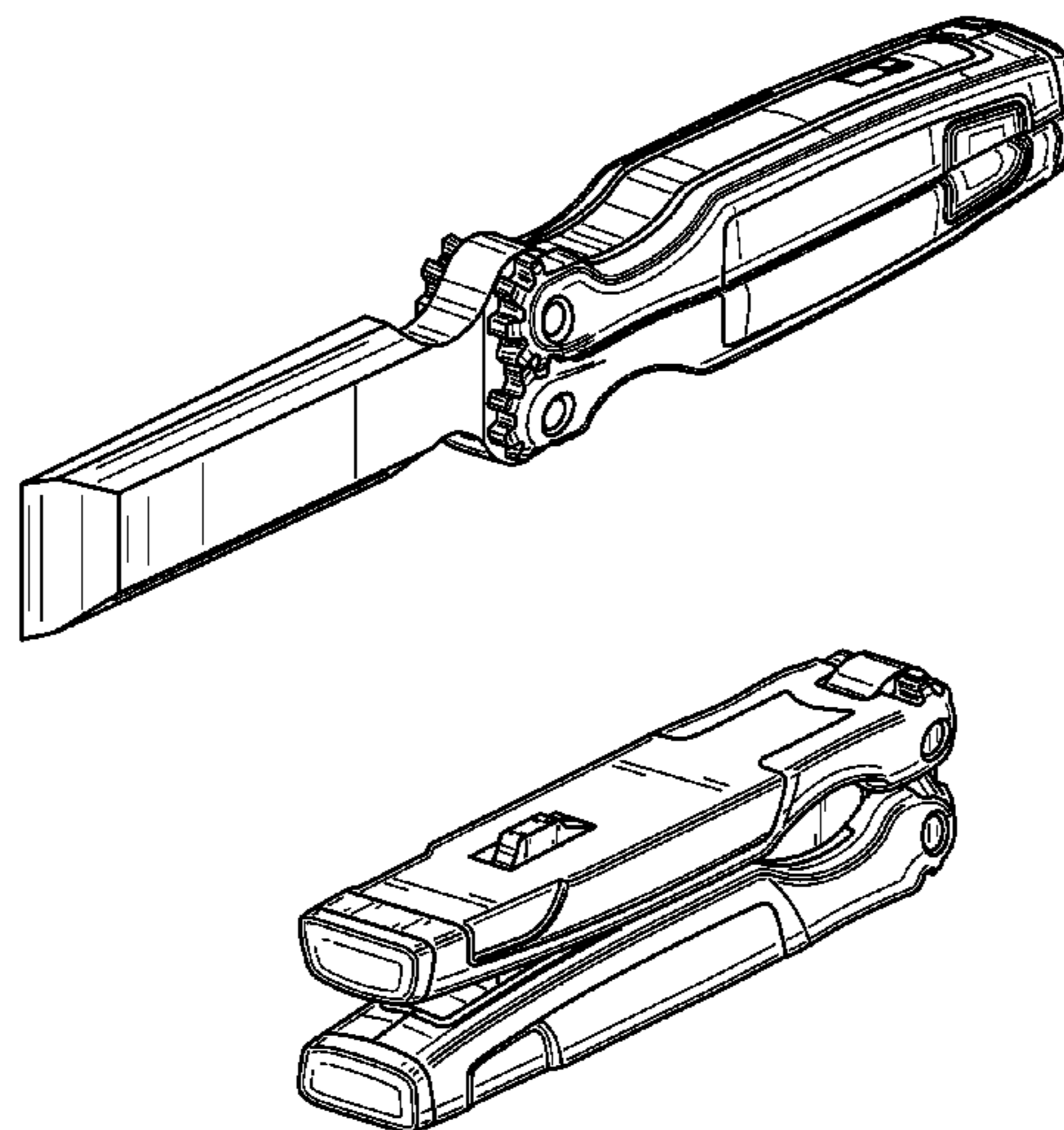
DESCRIPTION

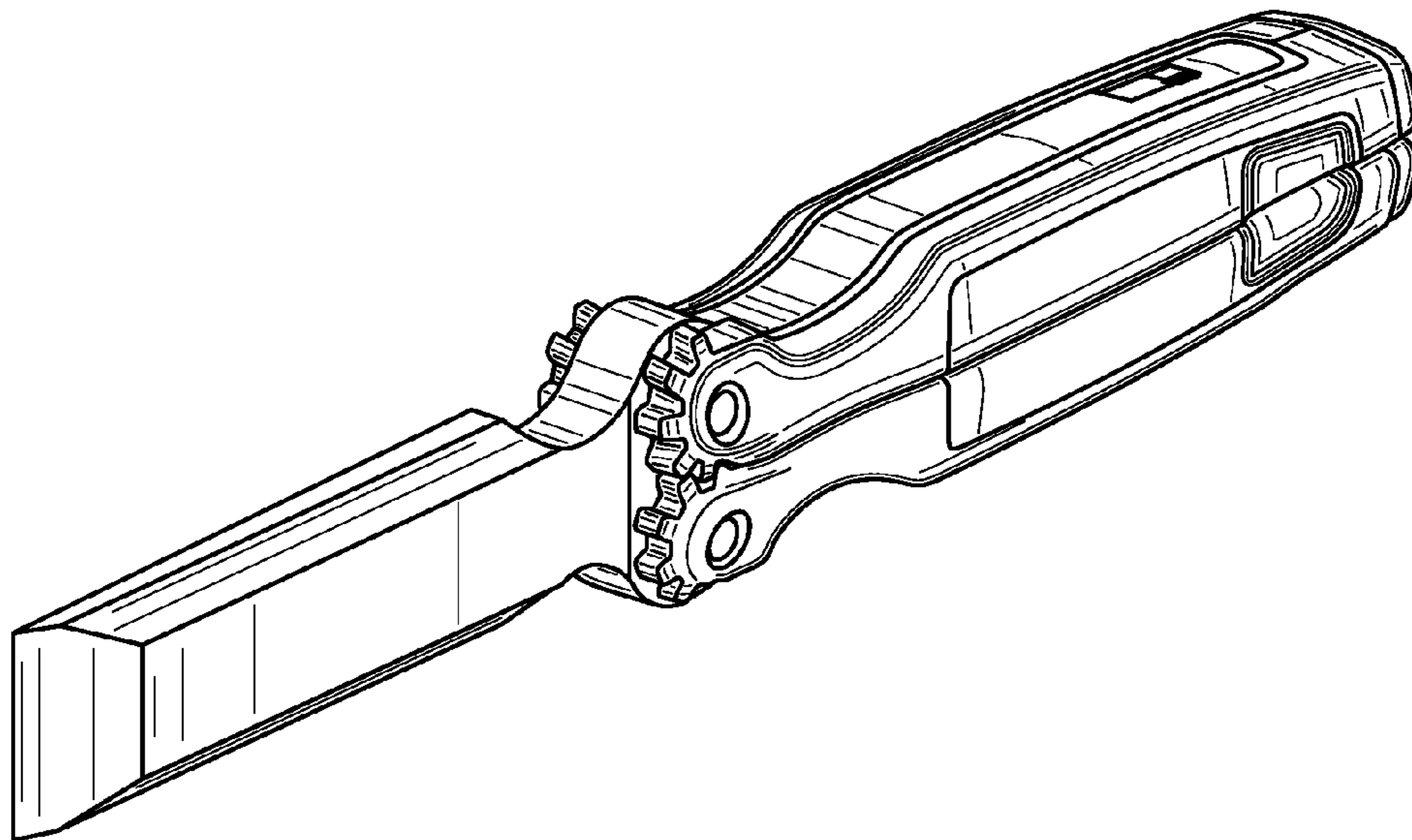

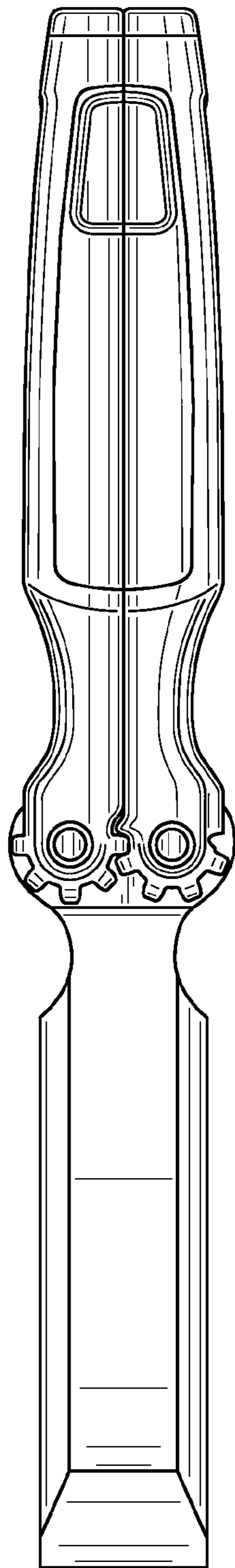

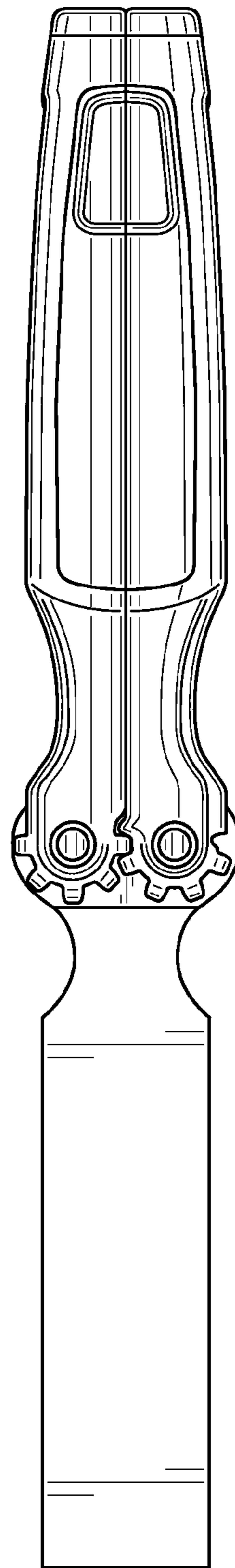

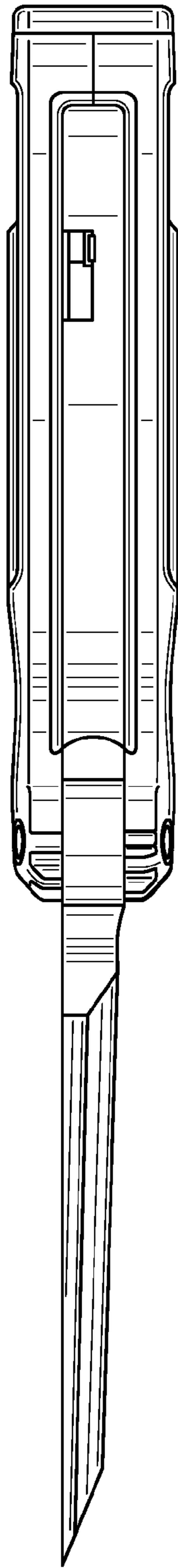

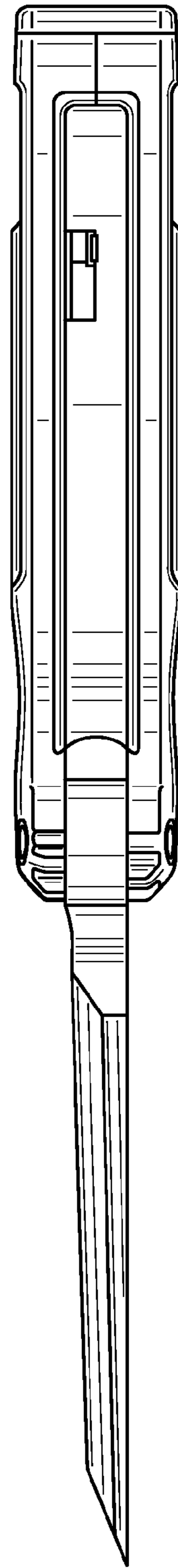

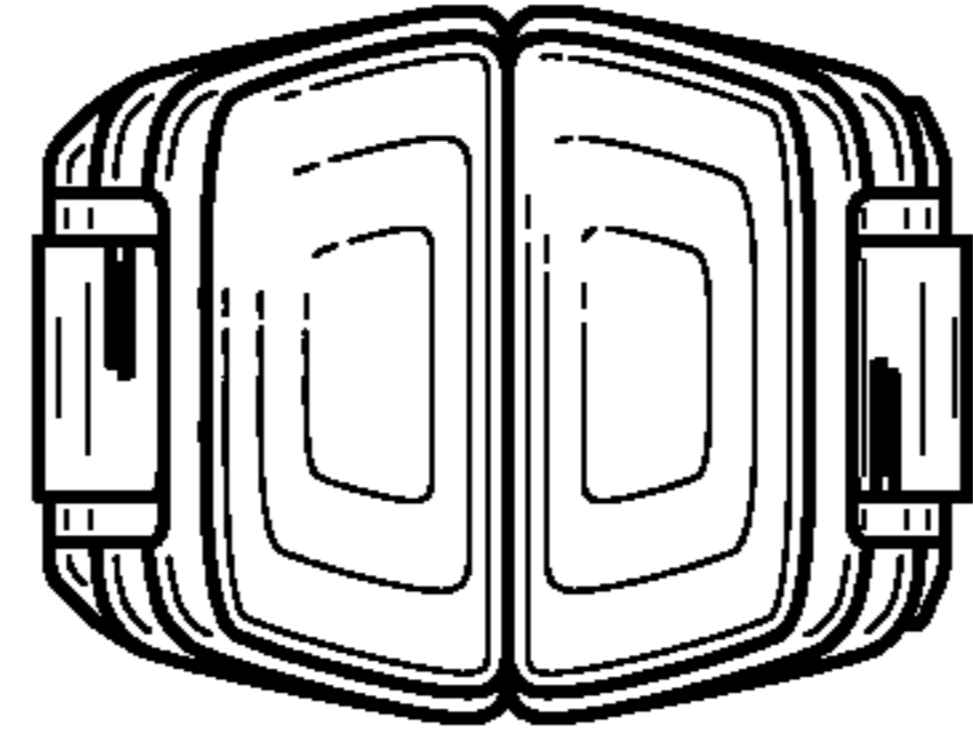

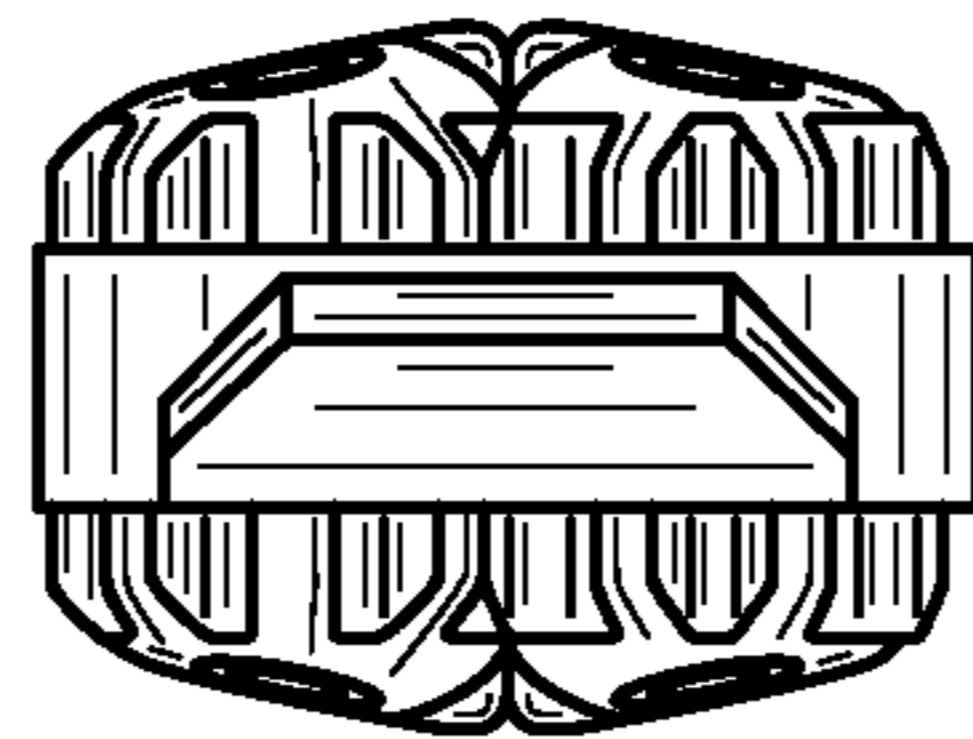

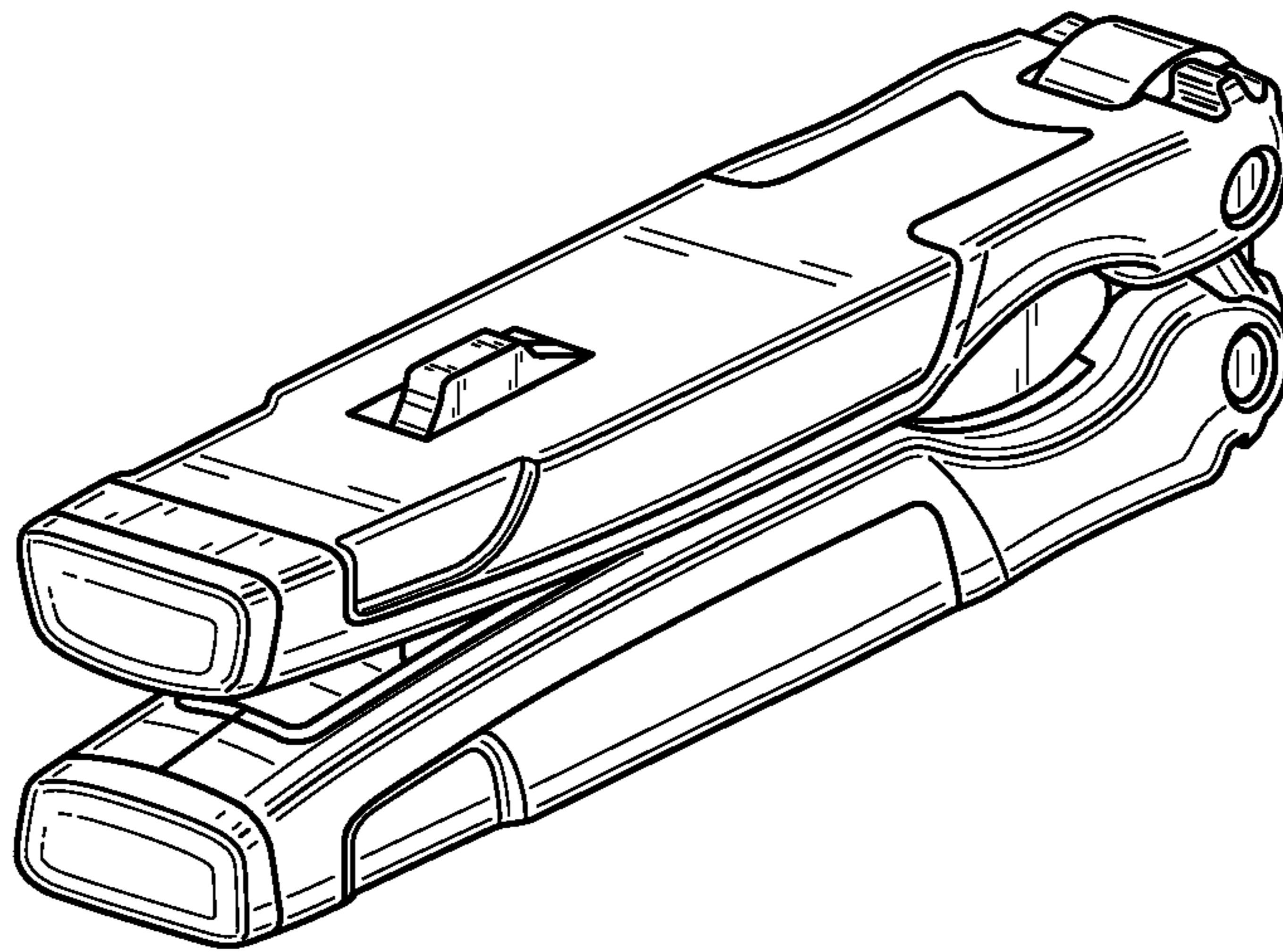

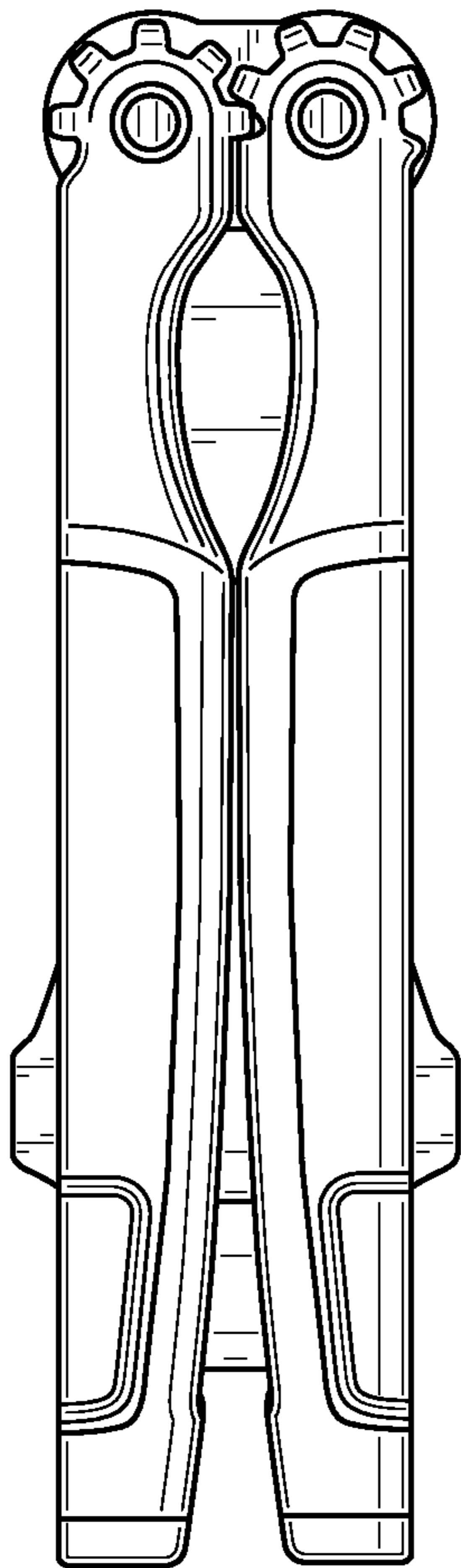

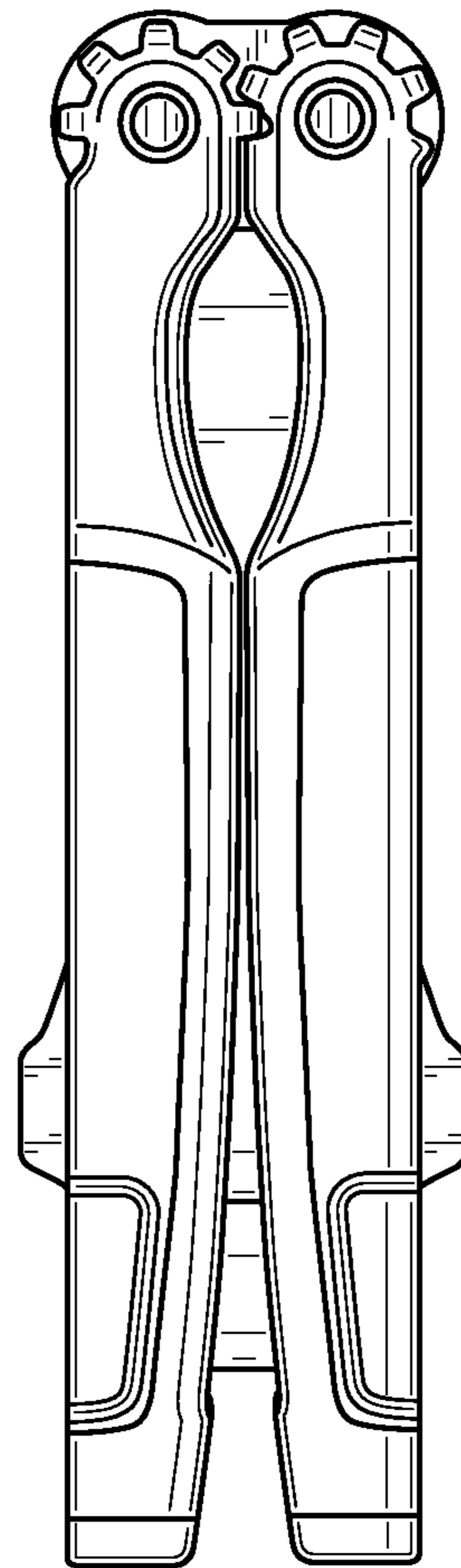

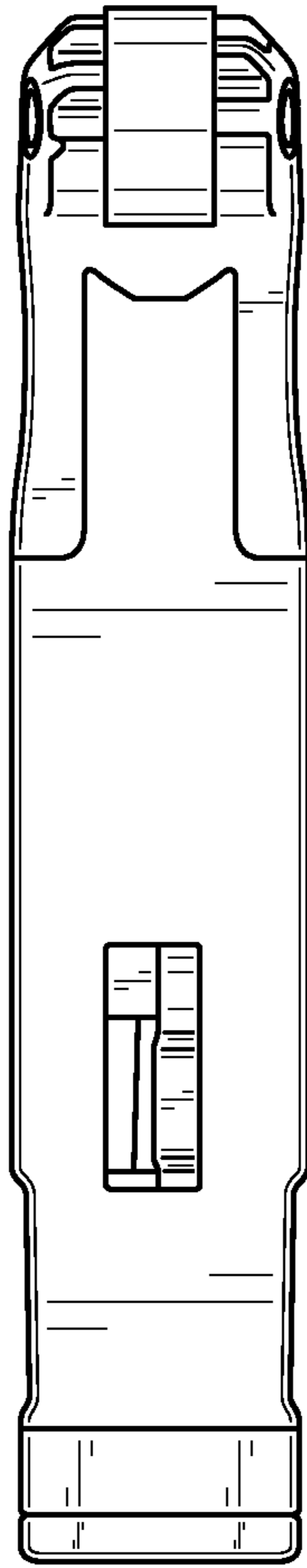

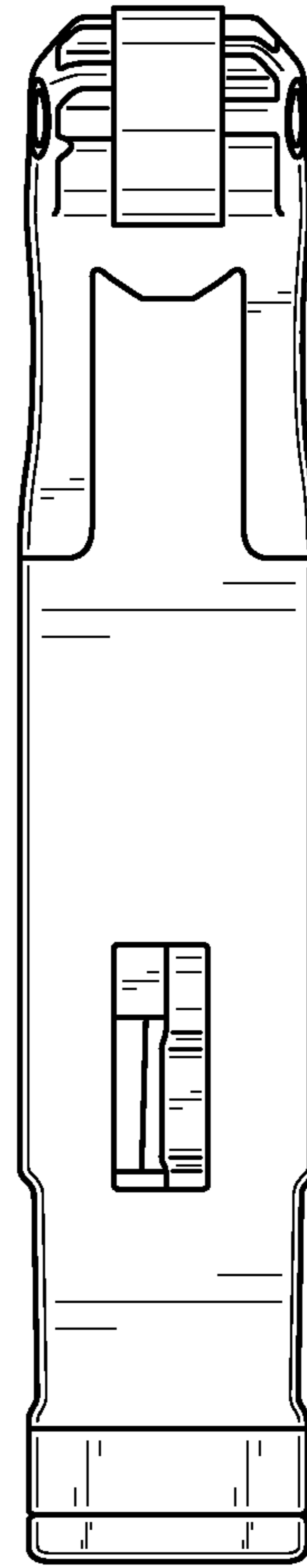

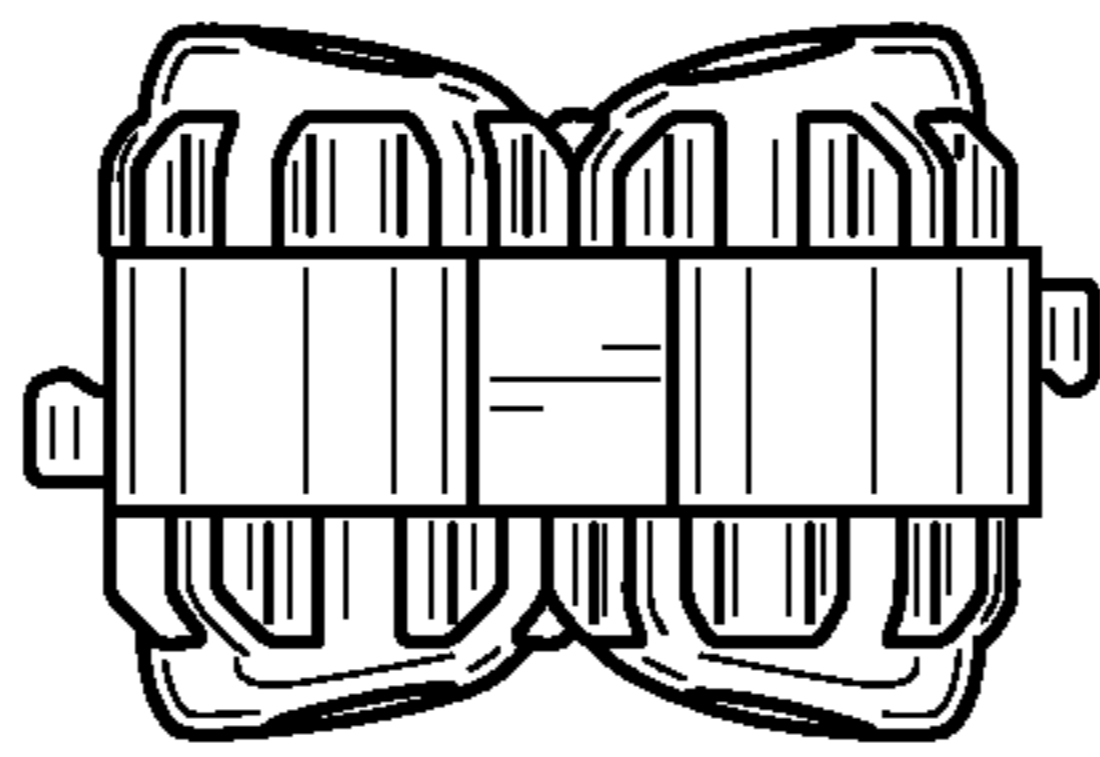

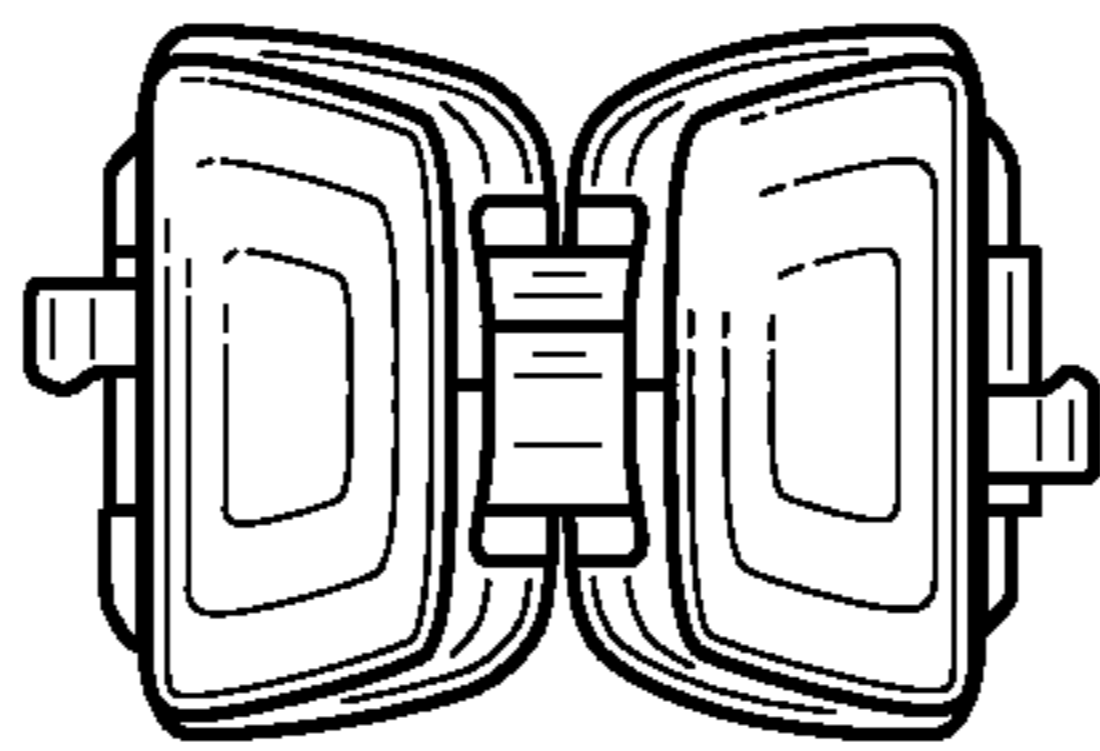
