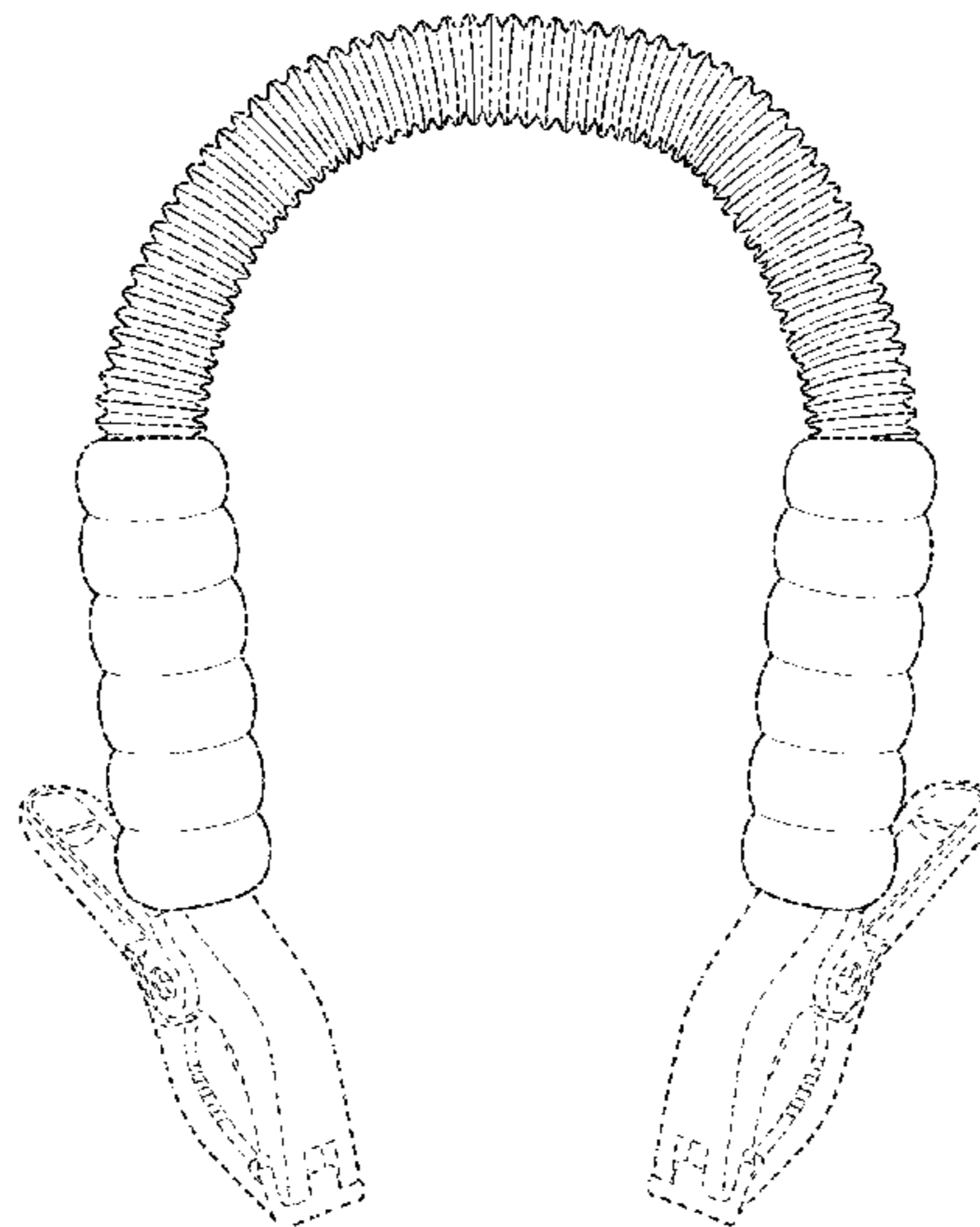
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the flexible support arm in accordance with the invention;

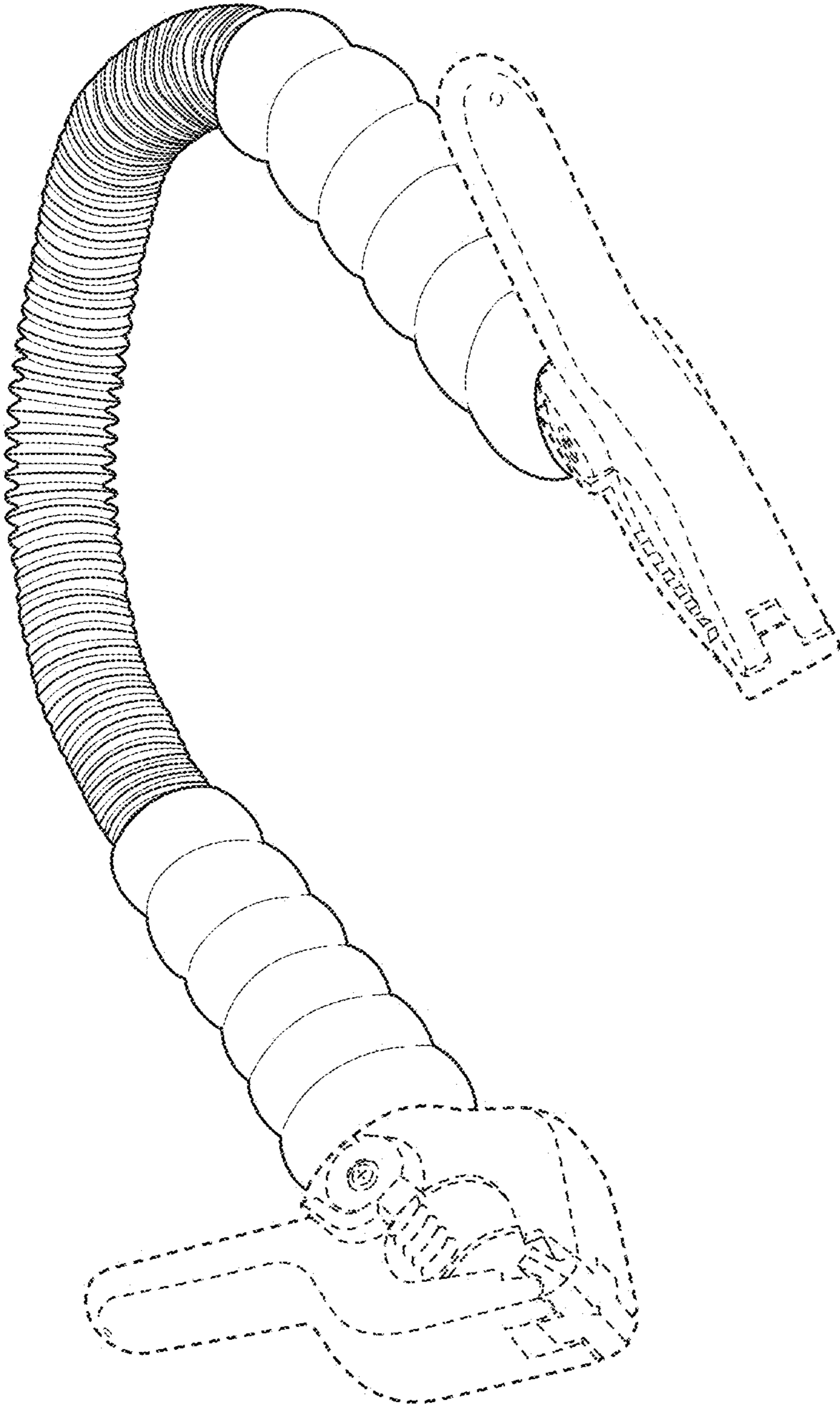

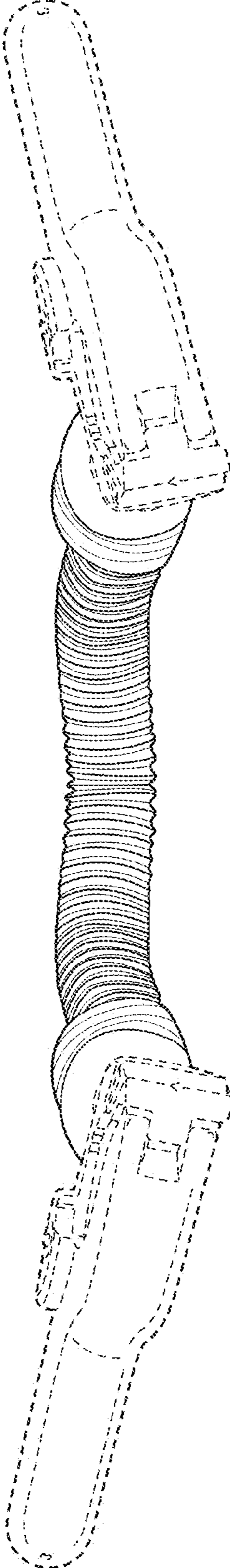

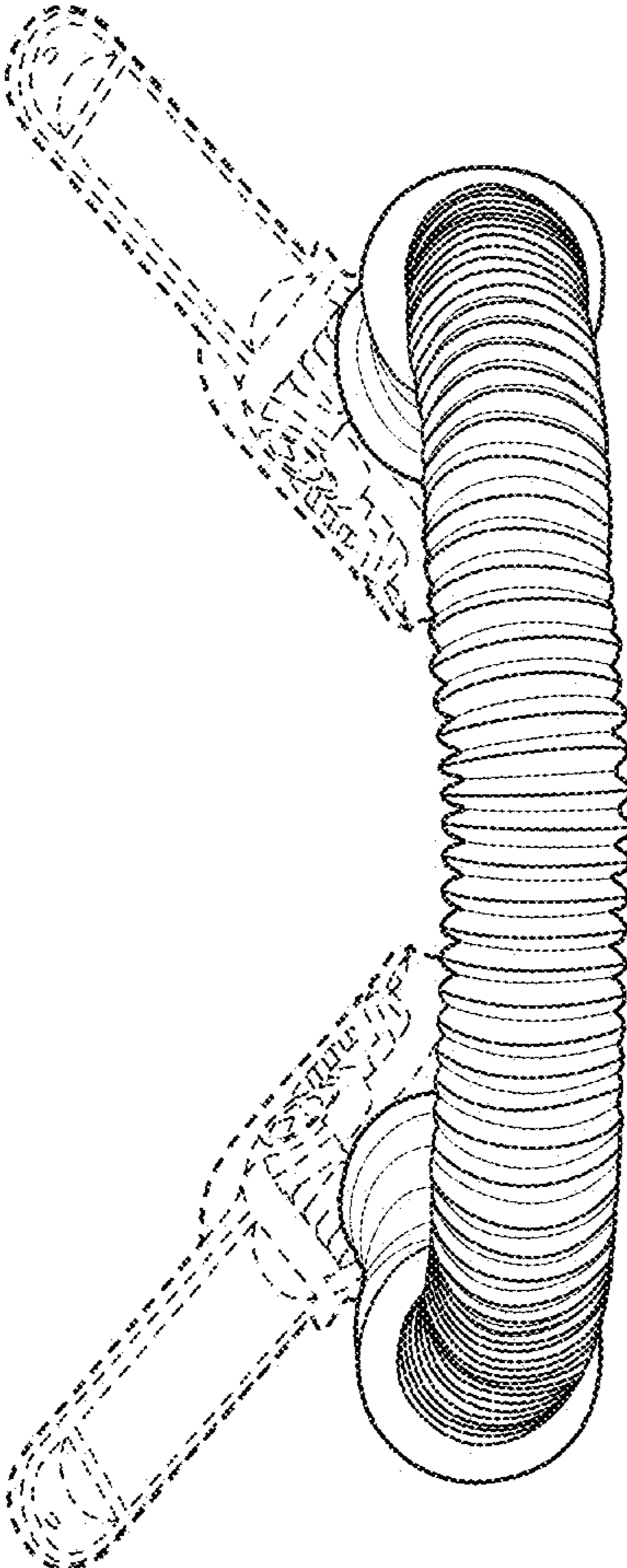

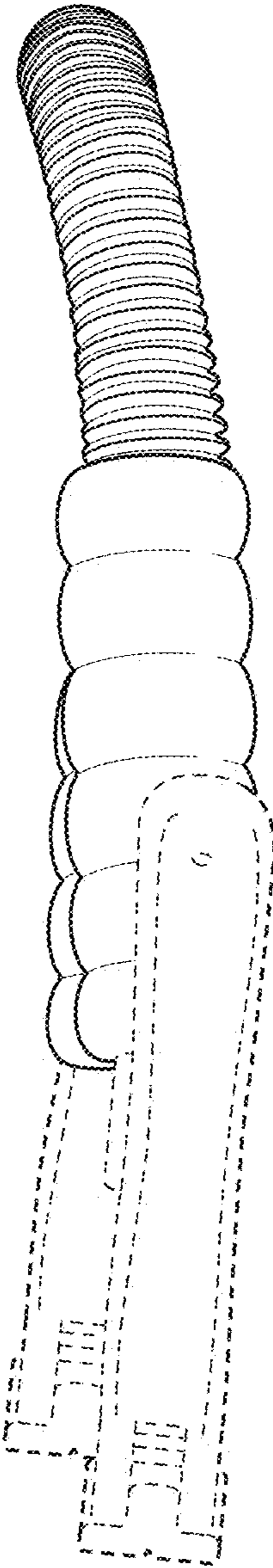

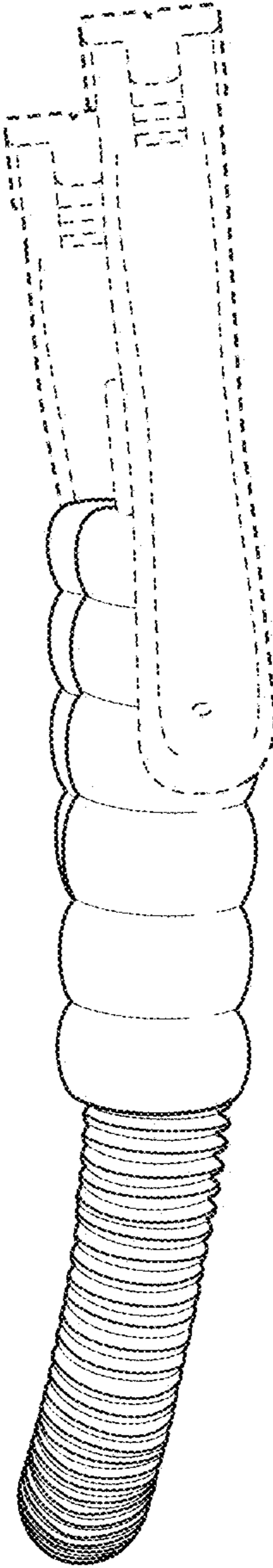

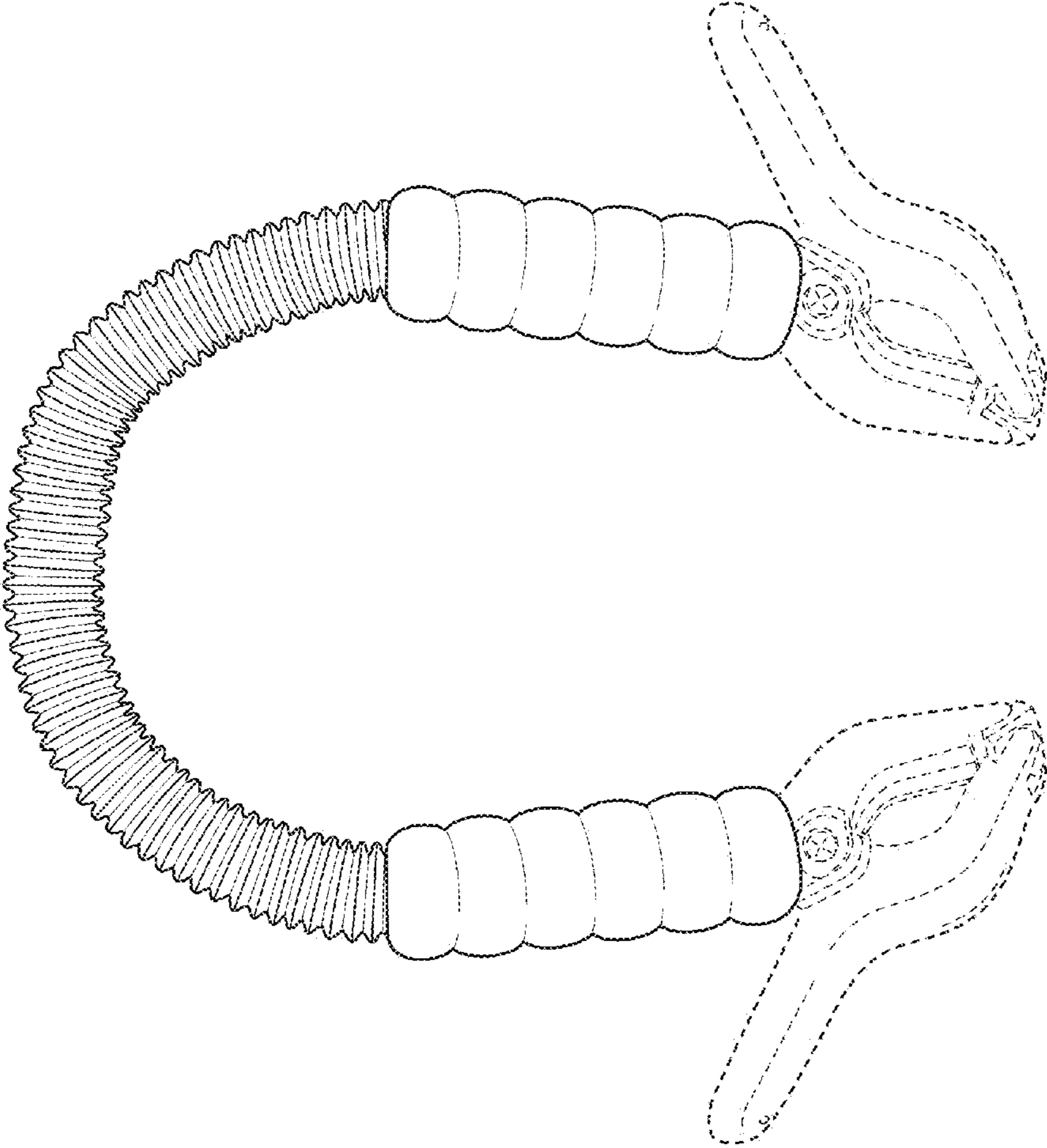

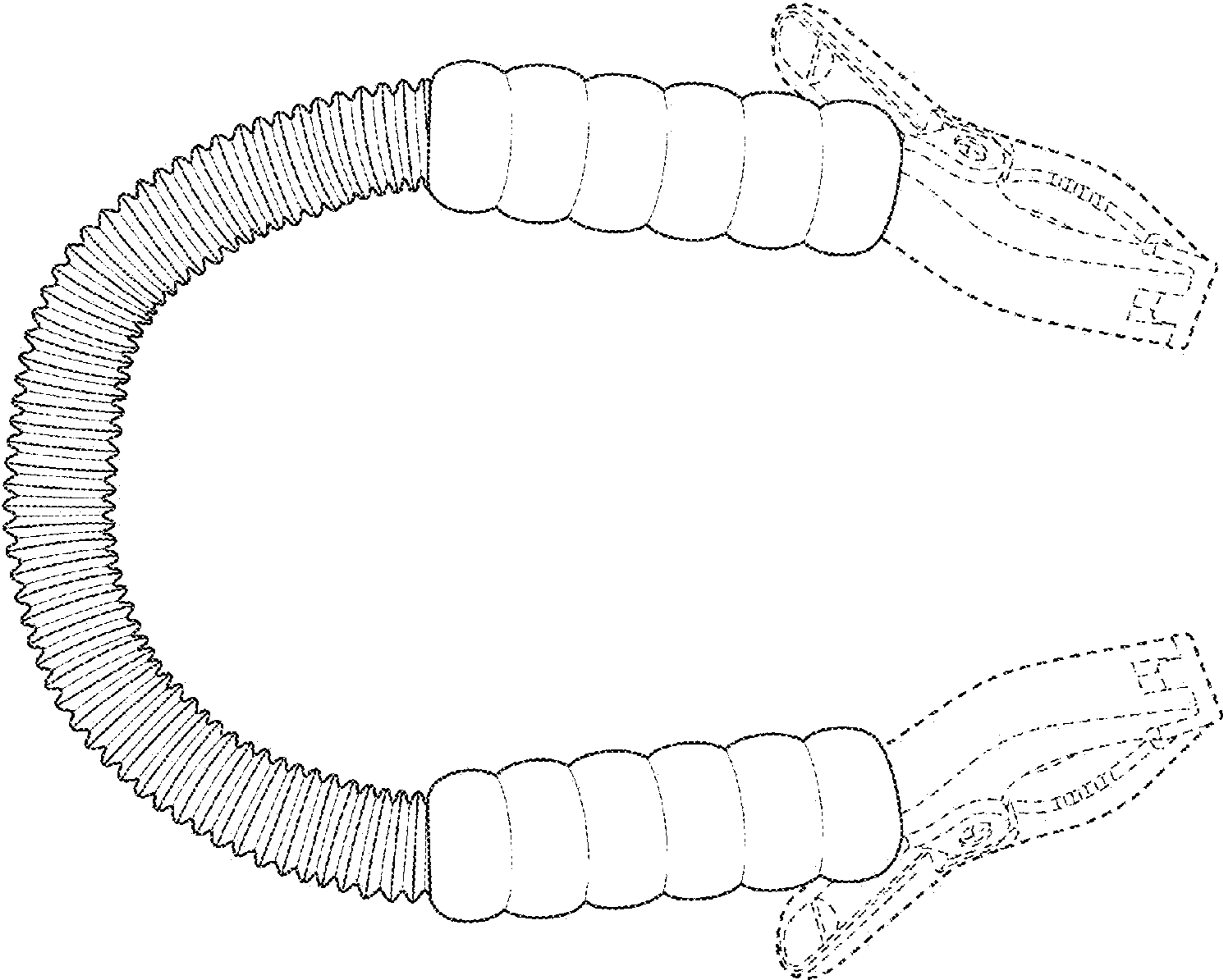

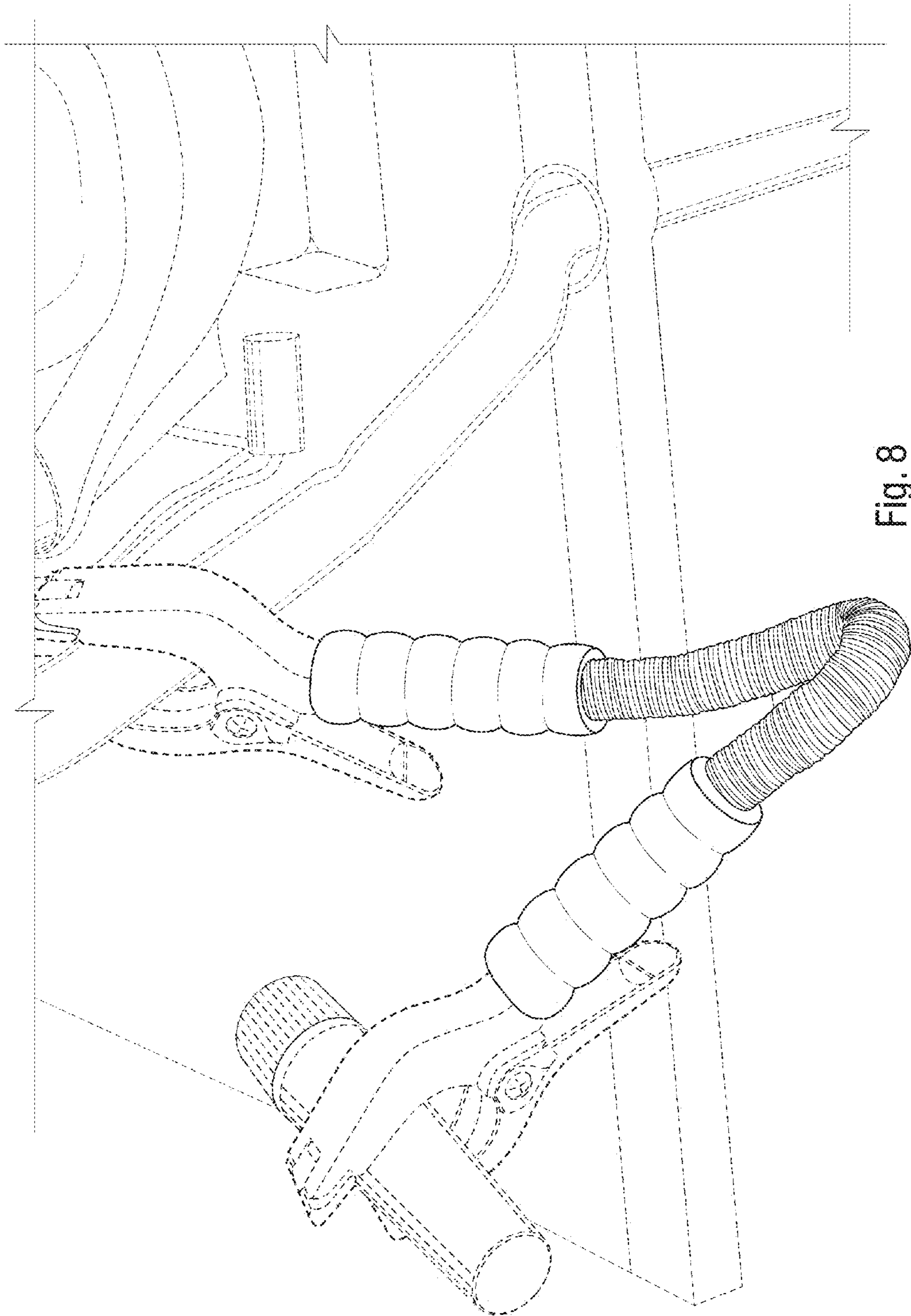
