FIG. 14 is a bottom side view of FIG. 8.

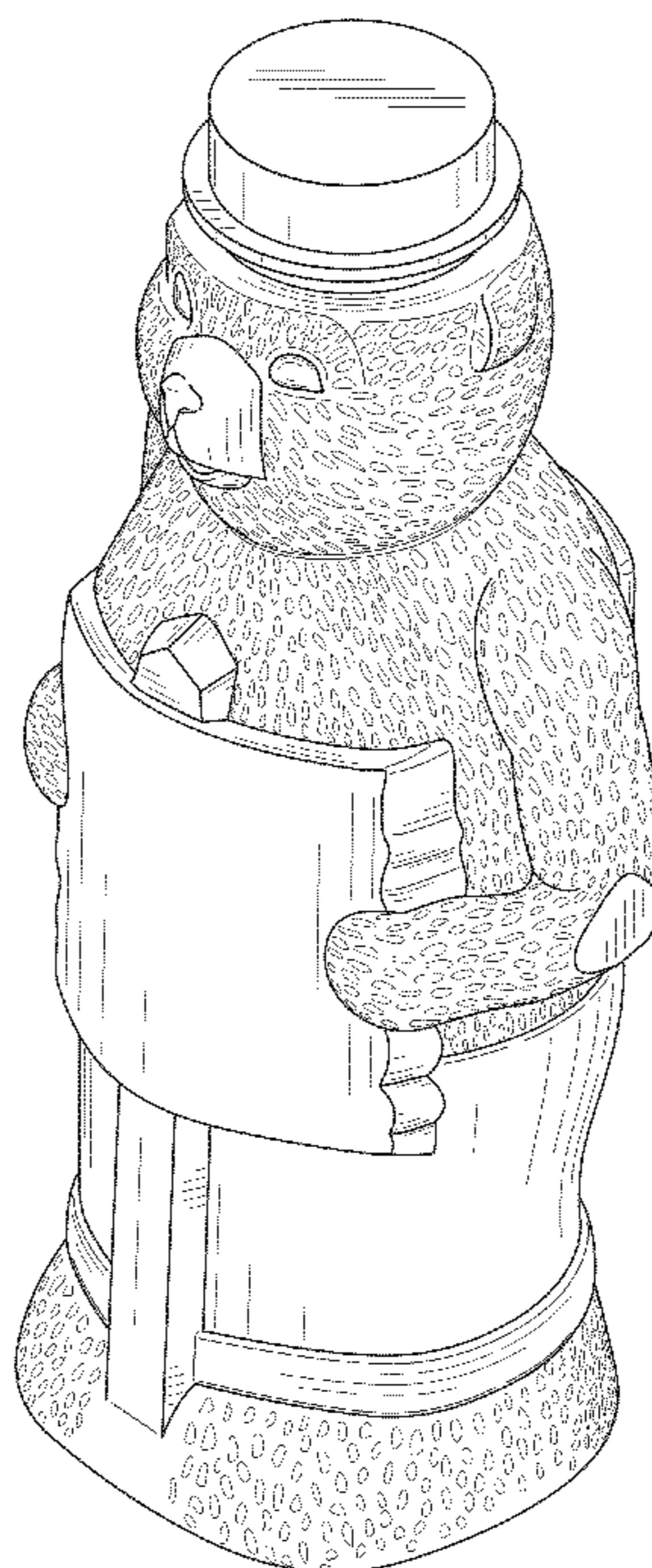

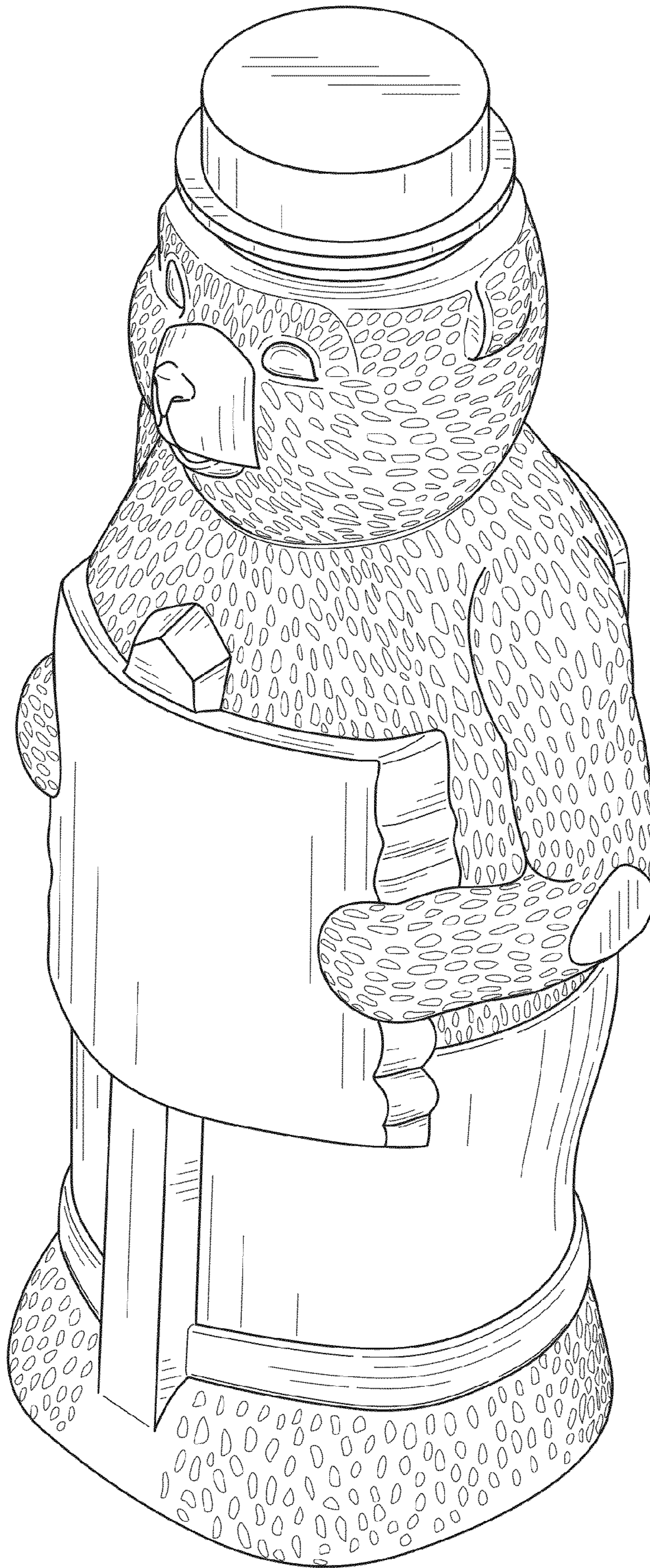

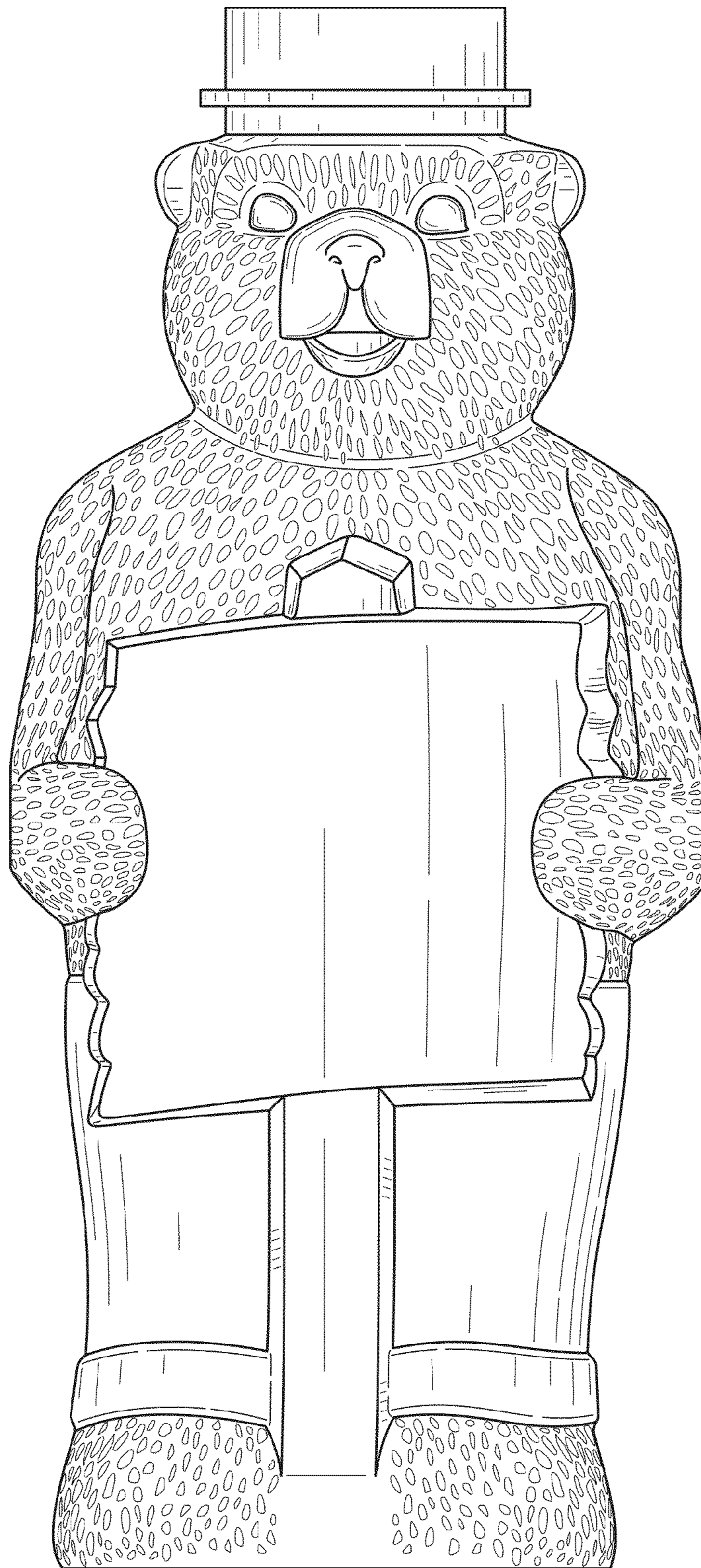

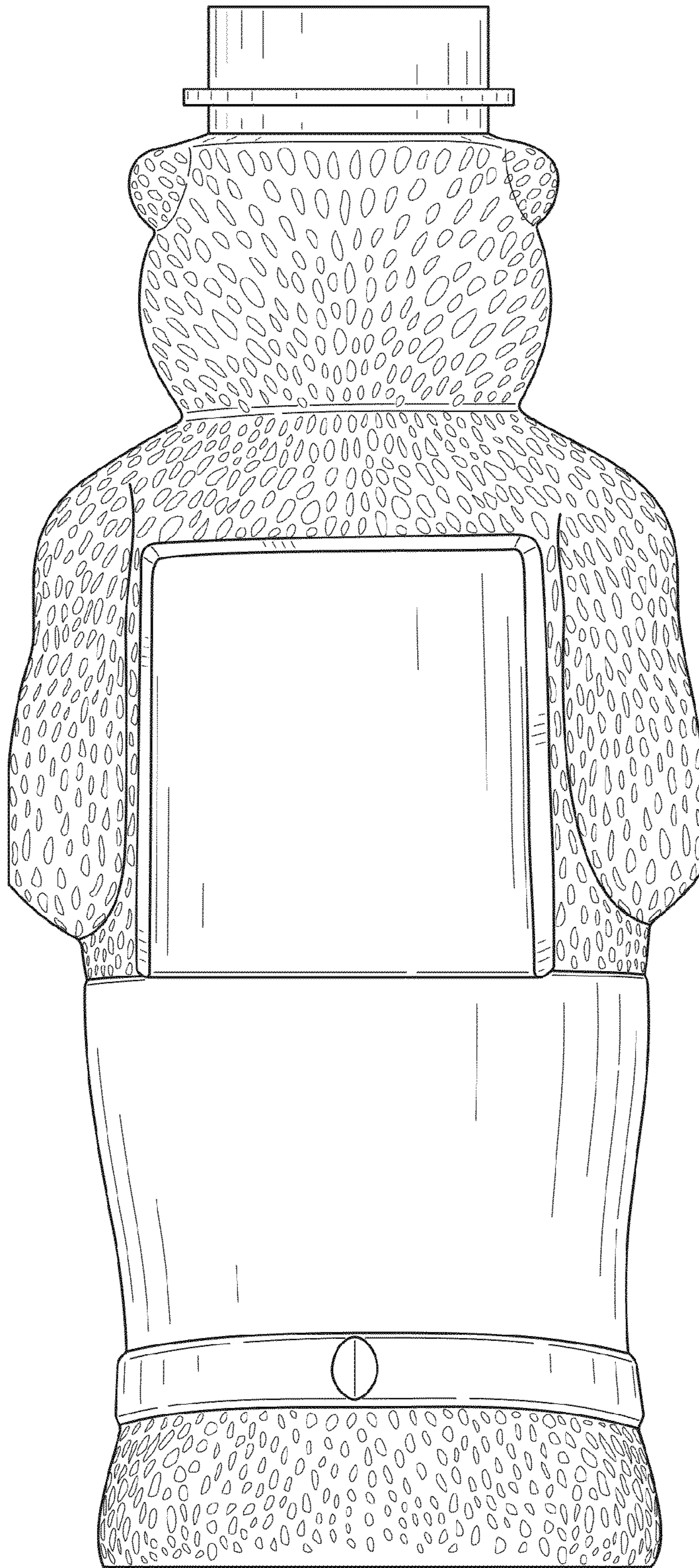

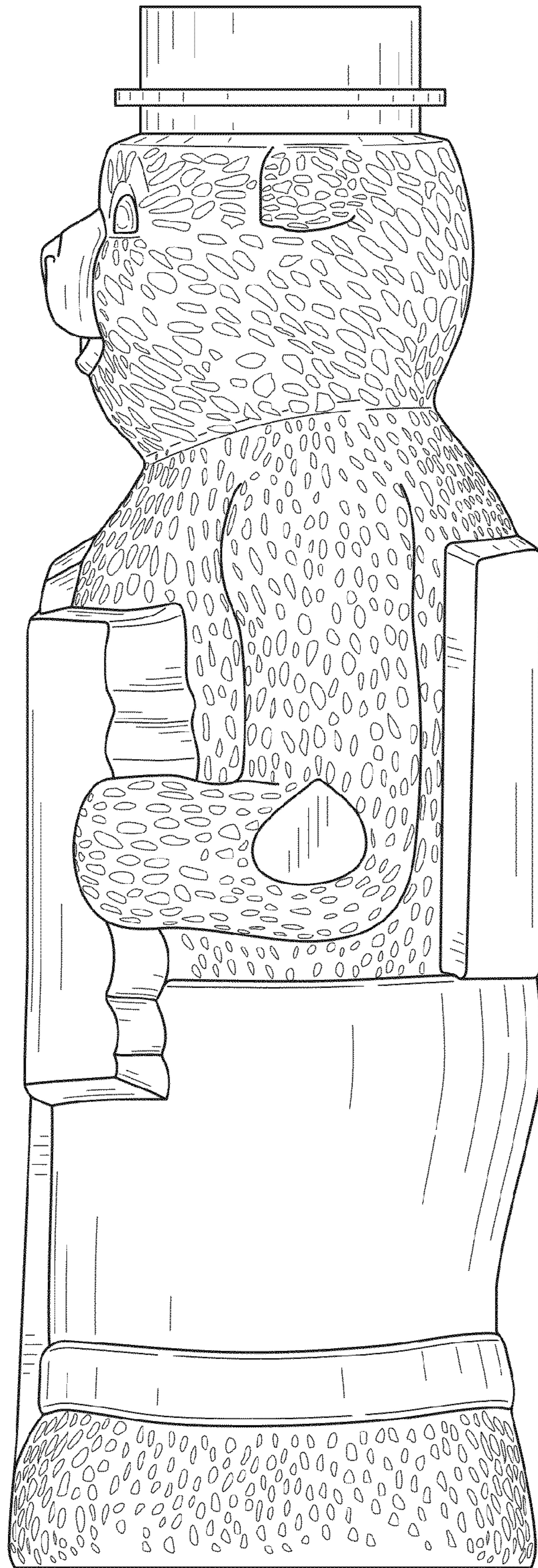

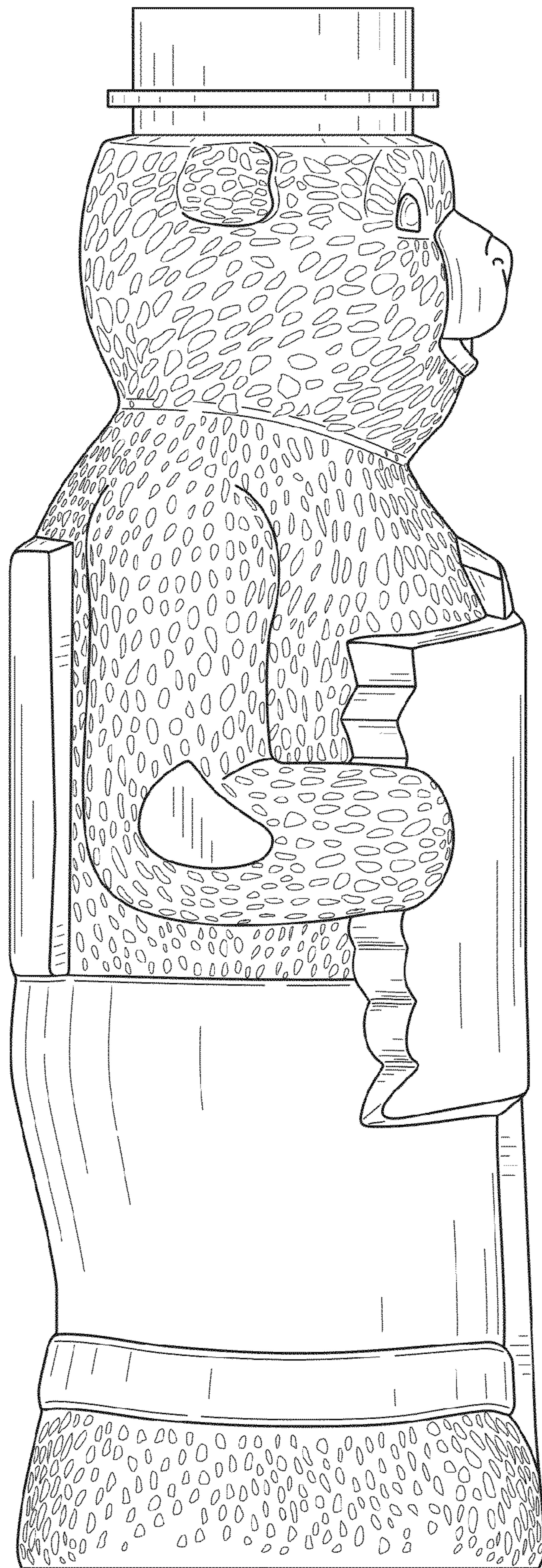

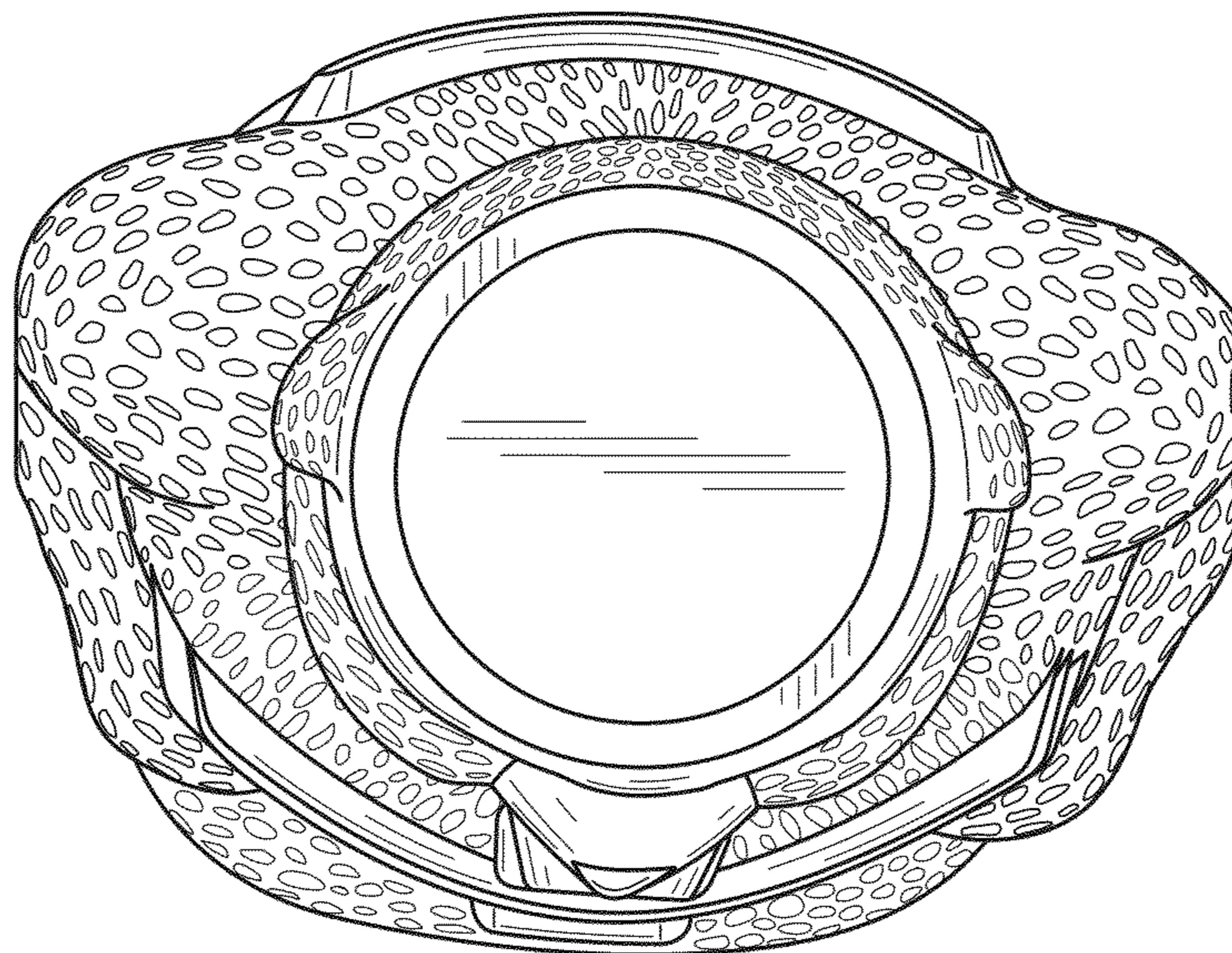

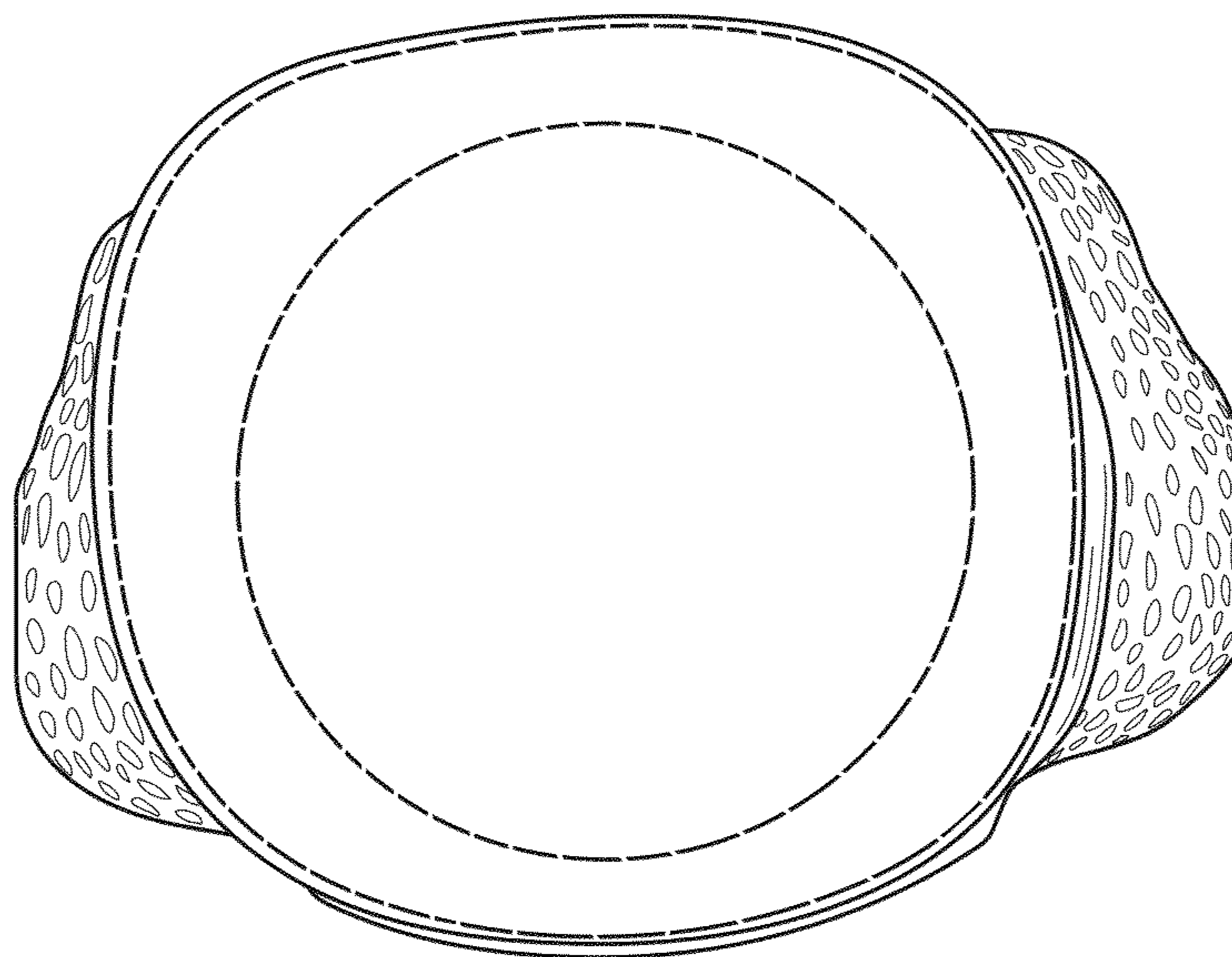

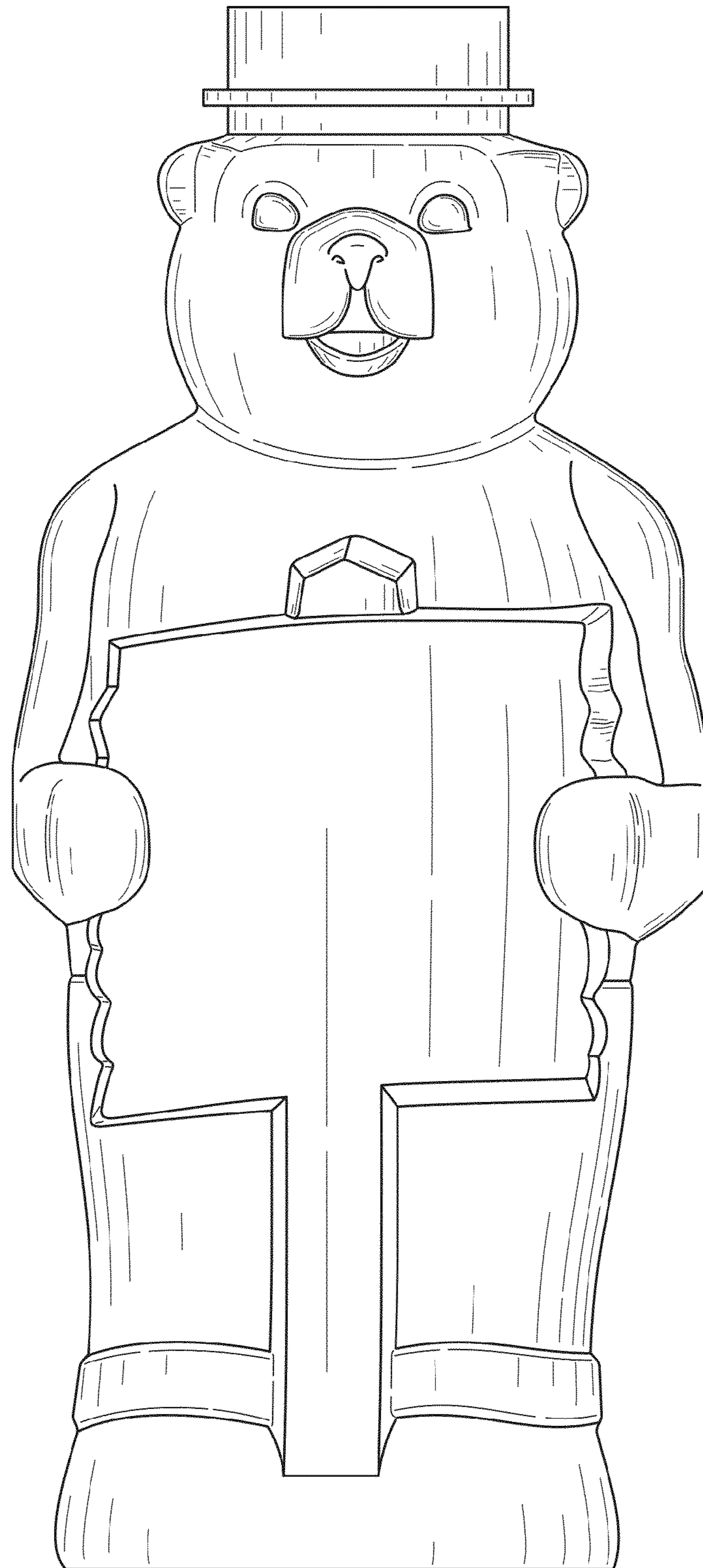

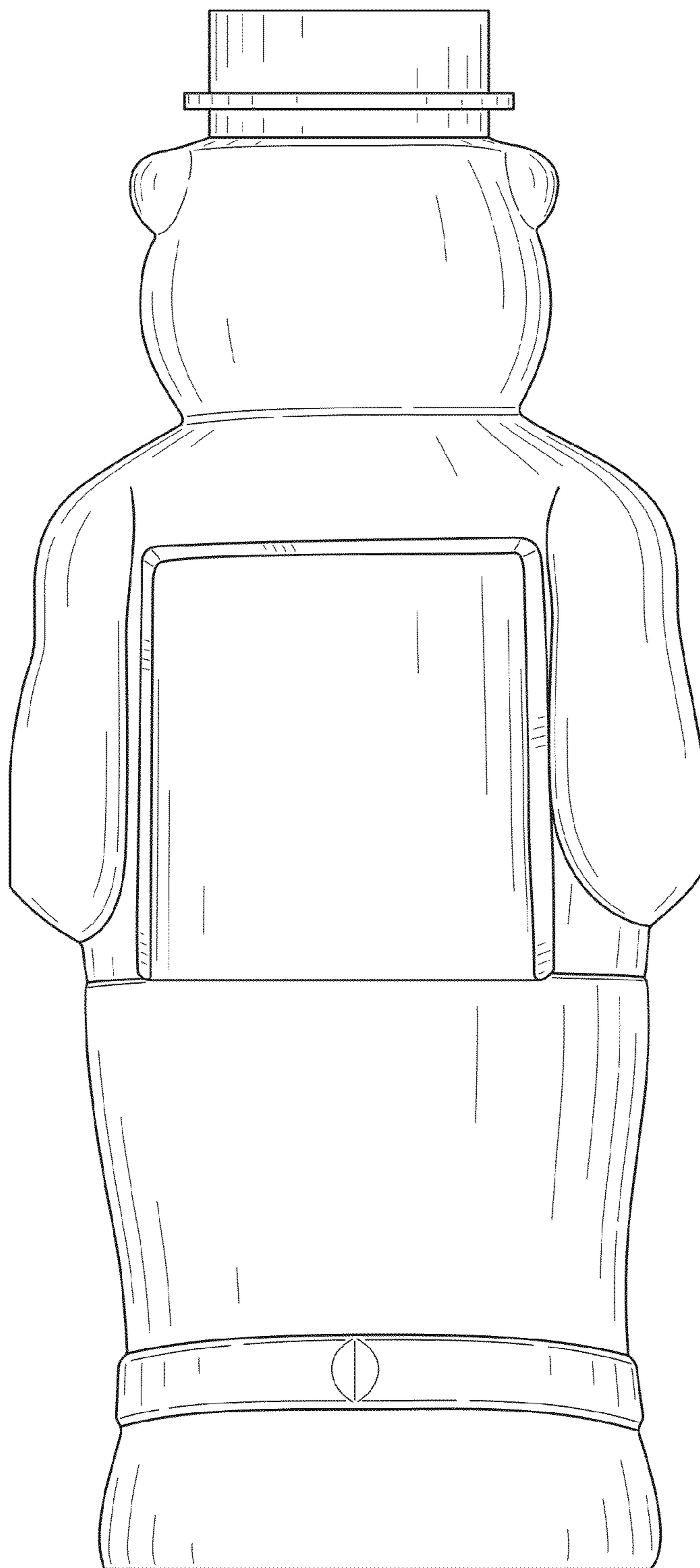

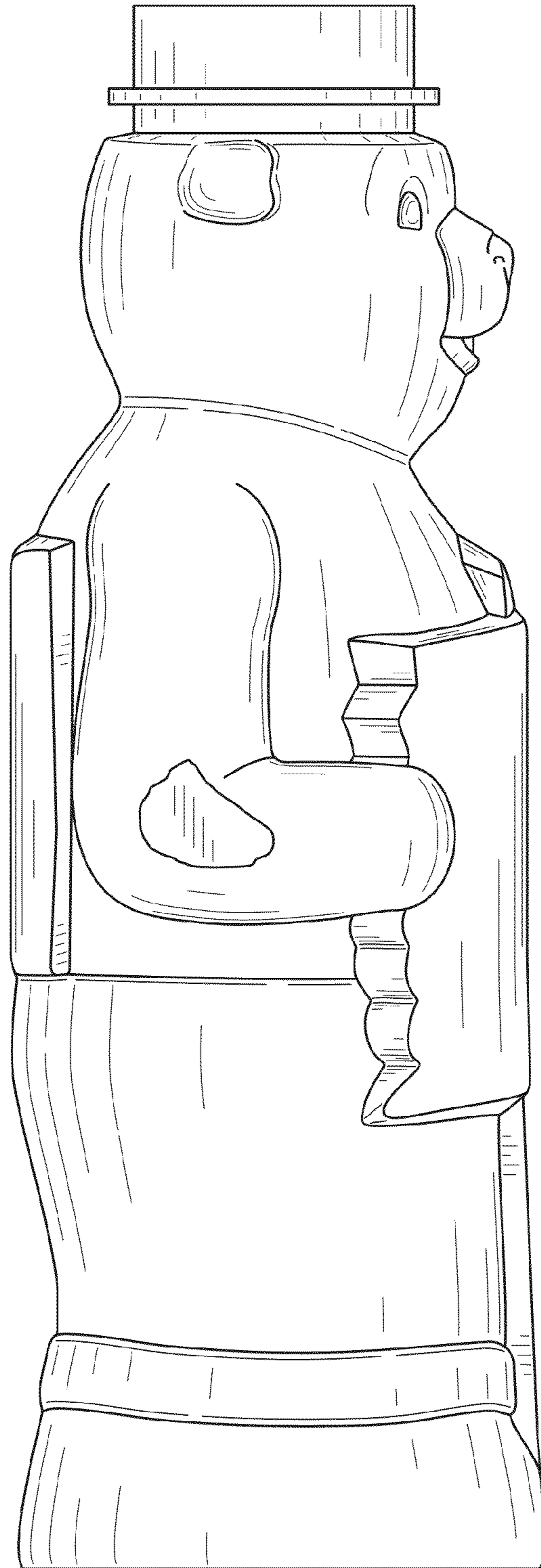

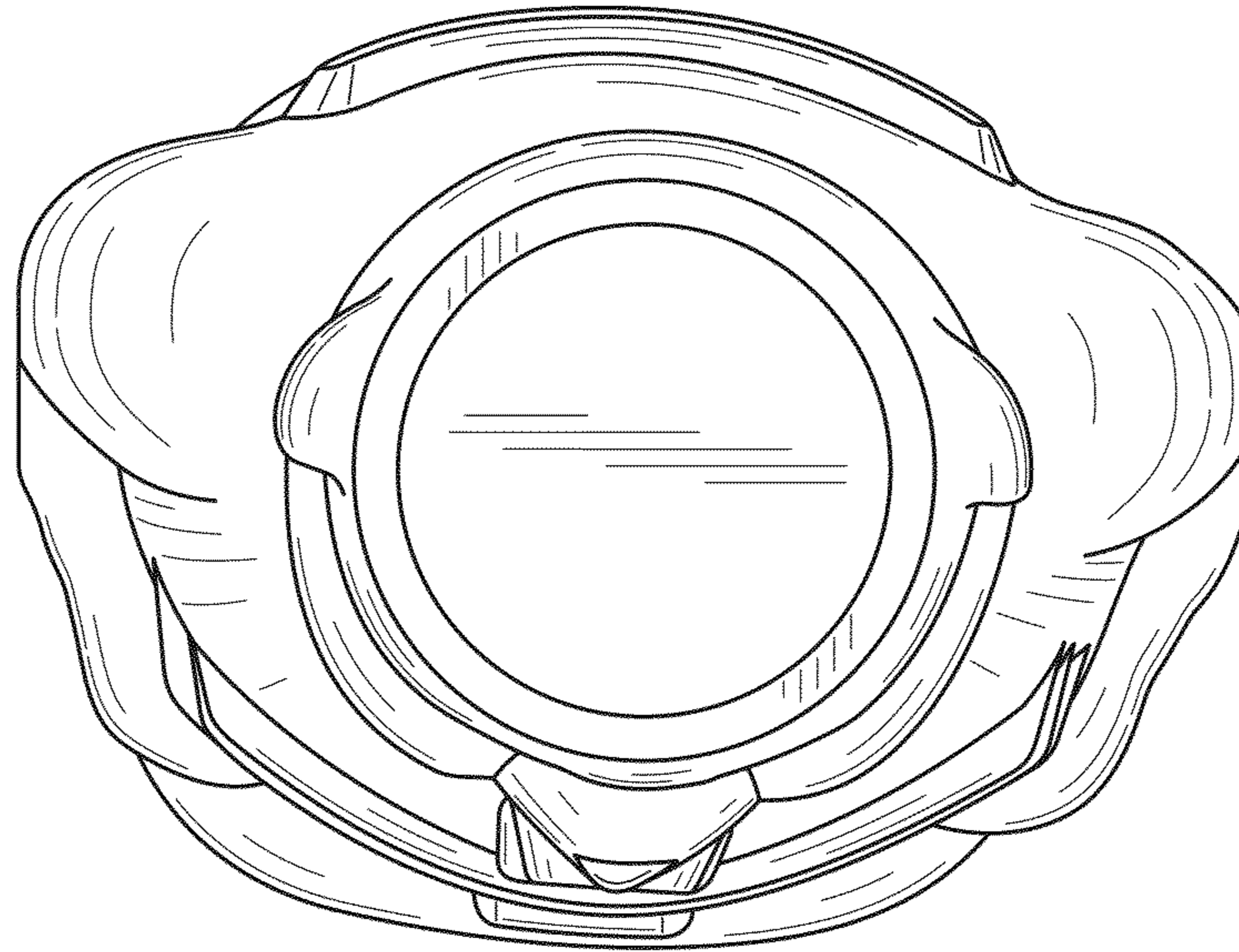

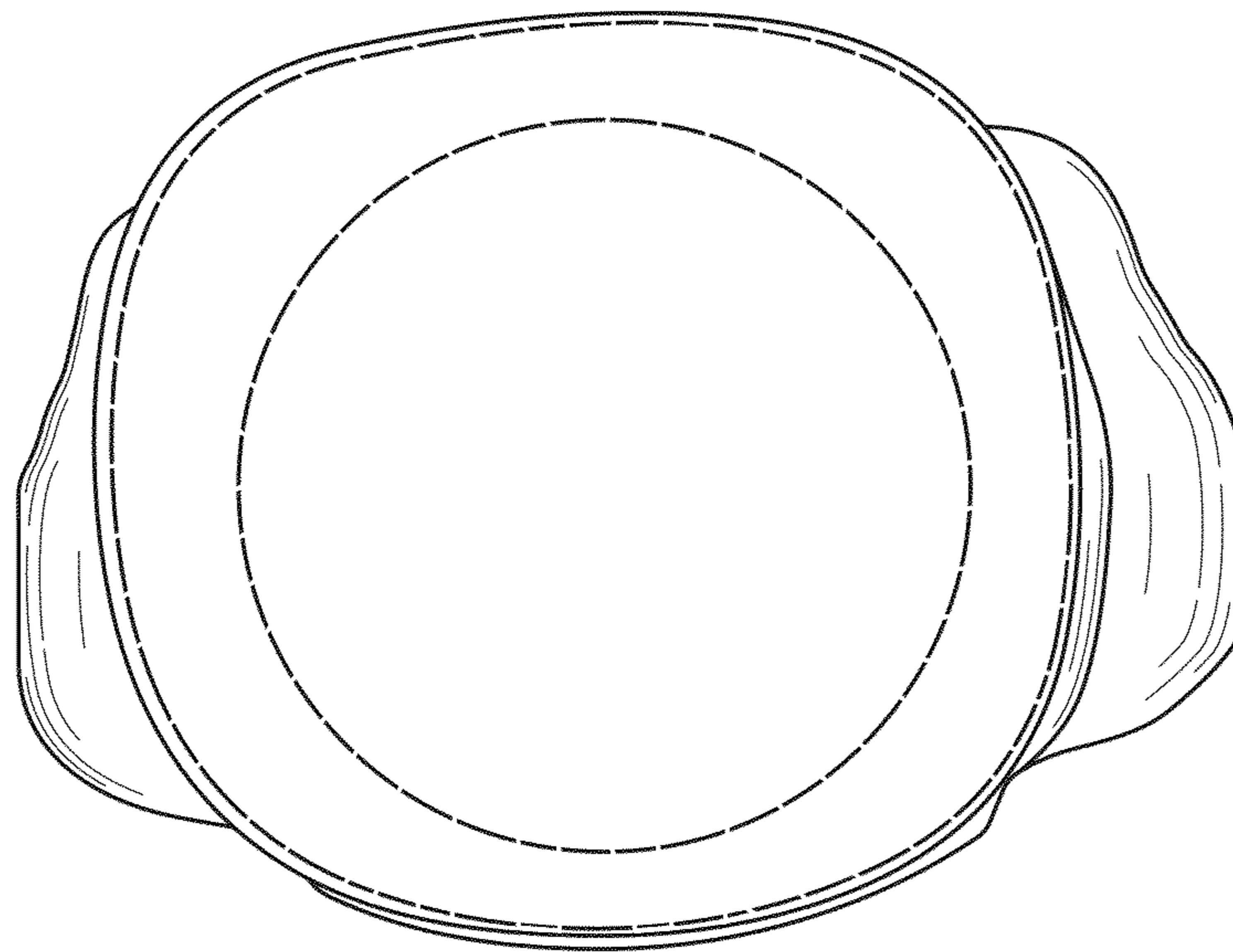
