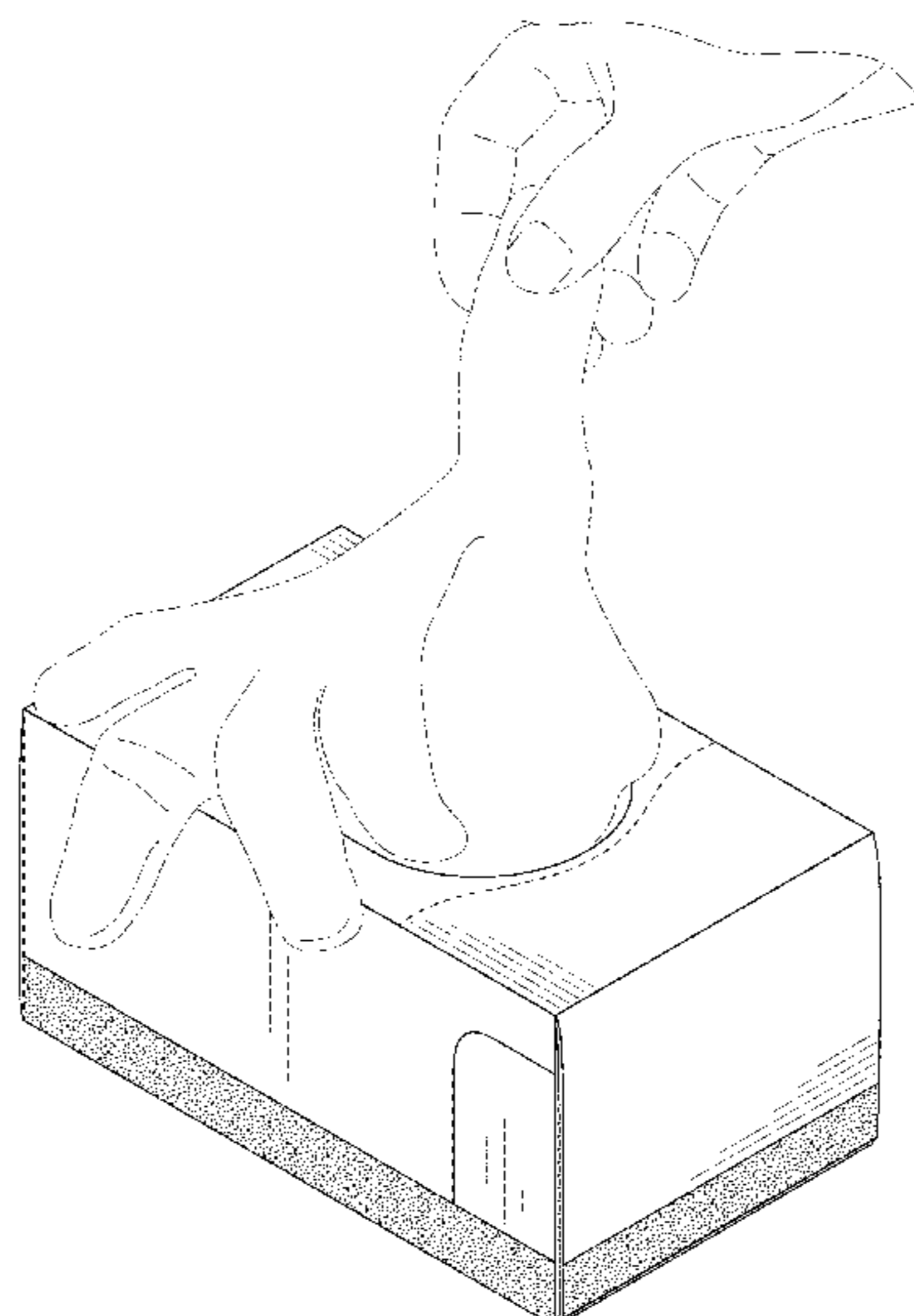
The ornamental design for packaging for sanitation gloves, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of packaging for sanitation gloves showing a first embodiment of my new design; FIG. 2 is a front perspective view thereof with the unclaimed hand and glove depictions removed; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a front perspective view of packaging for sanitation gloves showing a second embodiment of my new design; FIG. 10 is a front elevation view thereof; FIG. 11 is a rear elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a left side elevation view thereof; FIG. 14 is a top plan view thereof; and, FIG. 15 is a bottom plan view thereof.

The dotted lines shown in FIGS. 9 and 14 represent claimed perforations. The broken lines shown in FIGS. 1, 2, 7, 9 and 14 represent unclaimed subject and form no part of the claimed design. The surface stippling represents a contrast of color relative to the non-stippled areas.

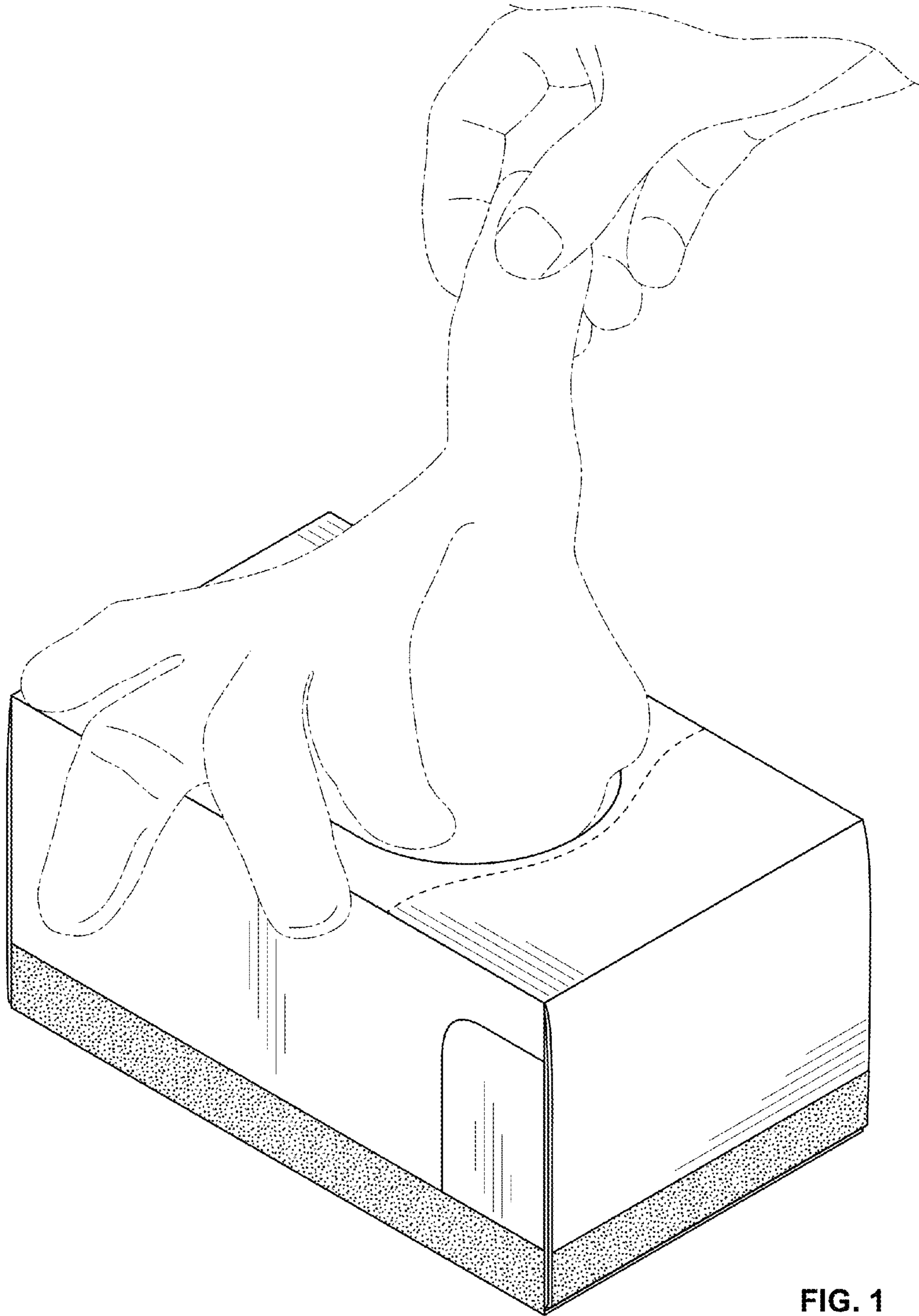

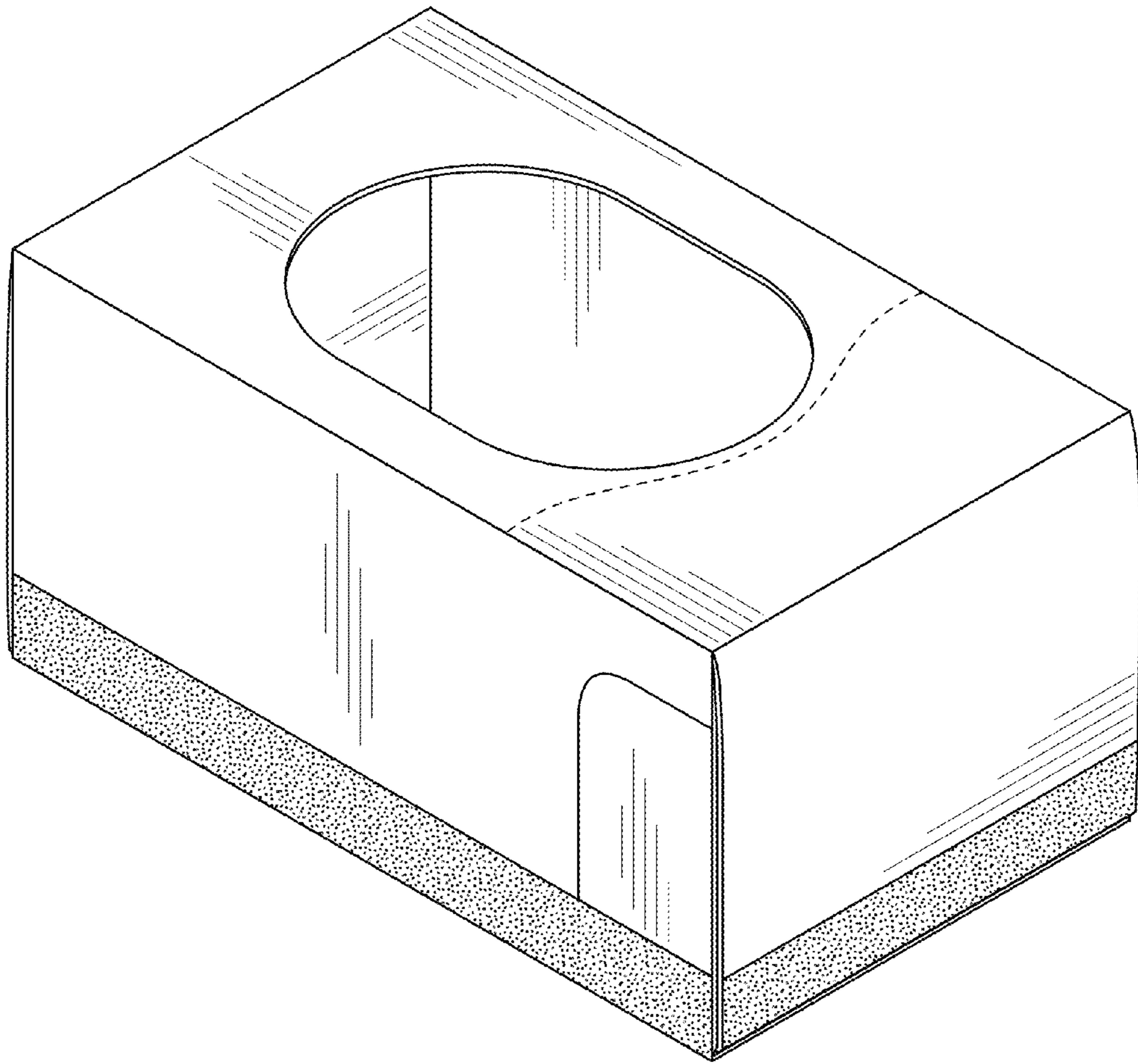

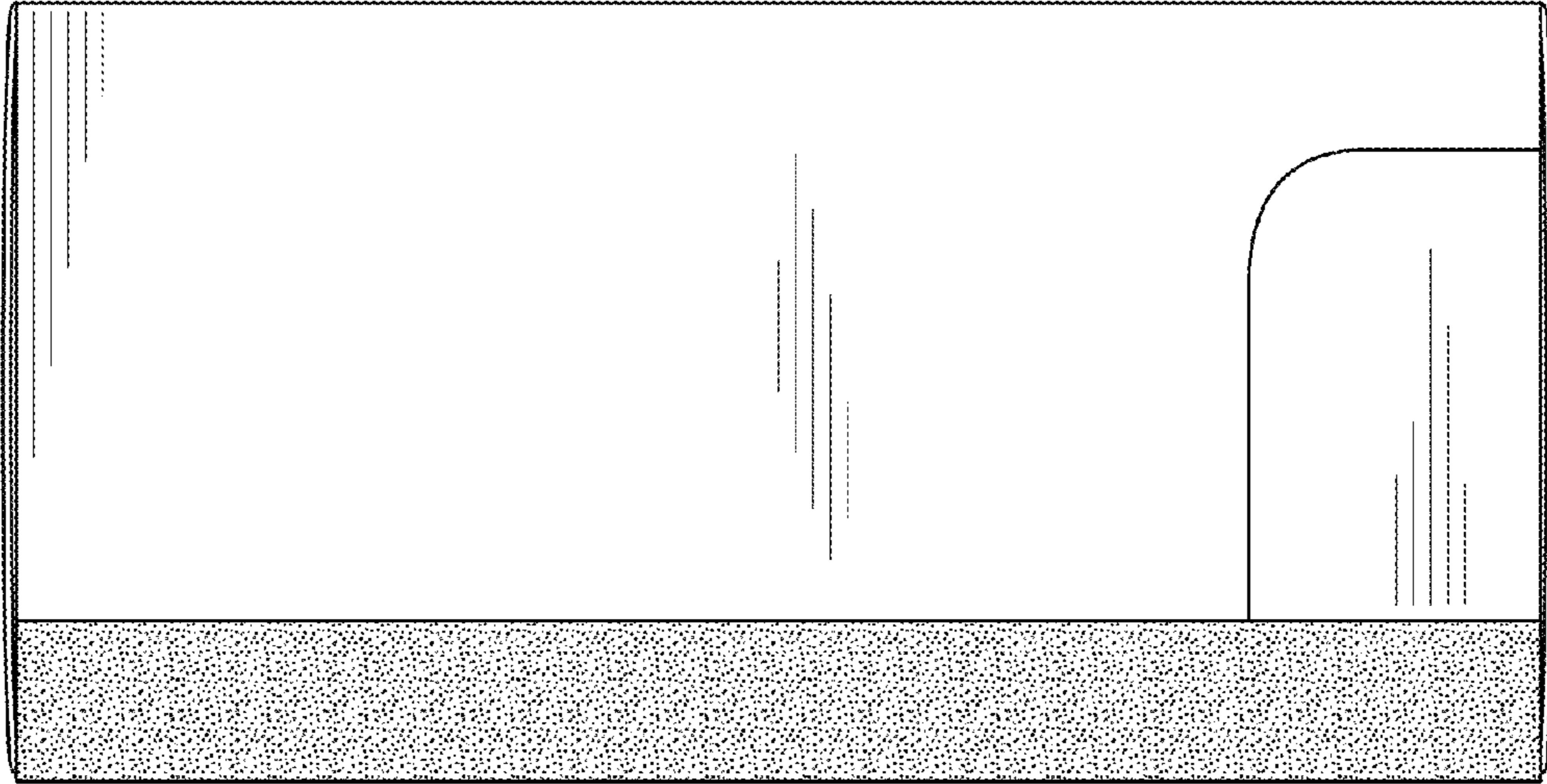

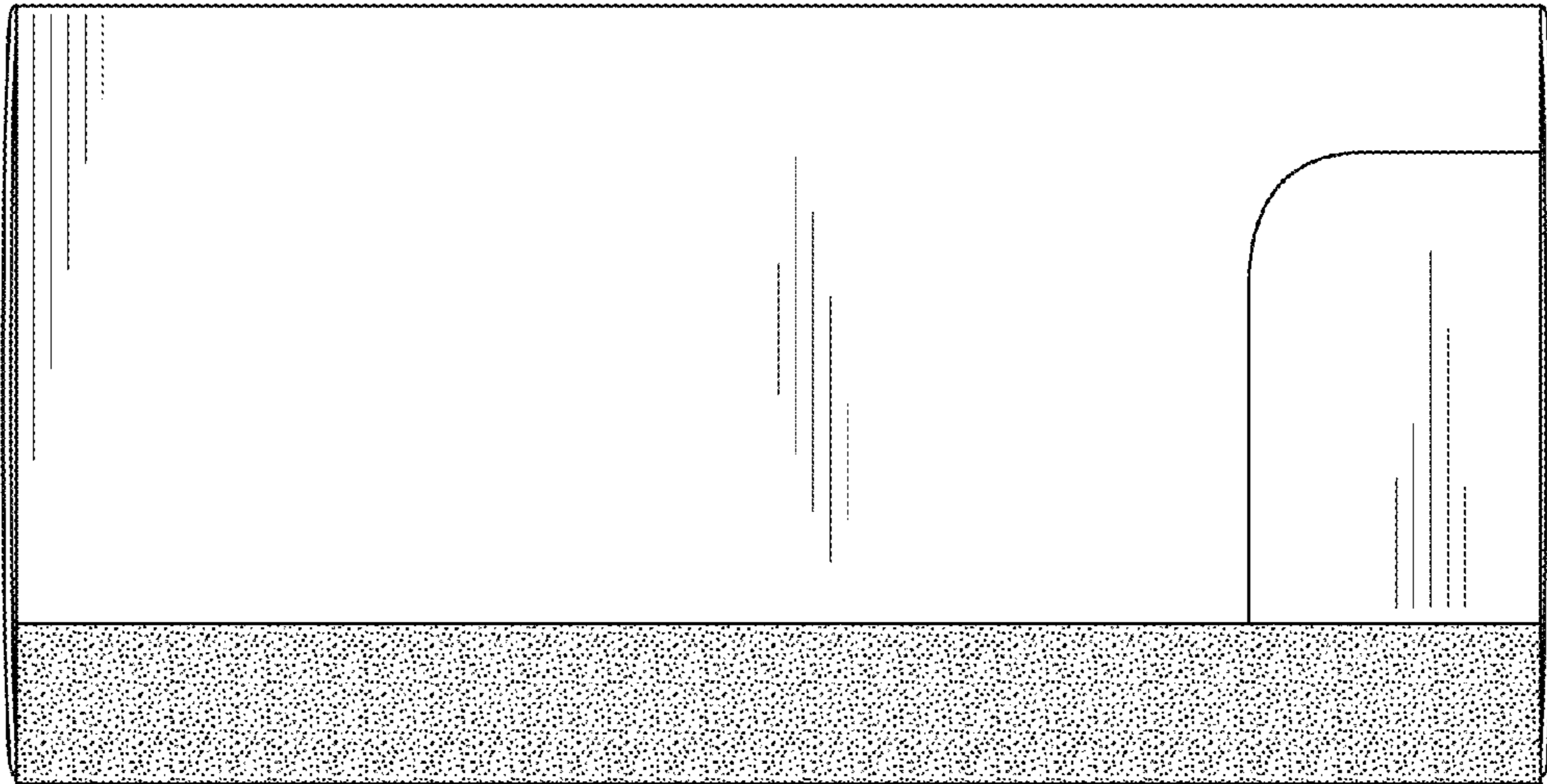

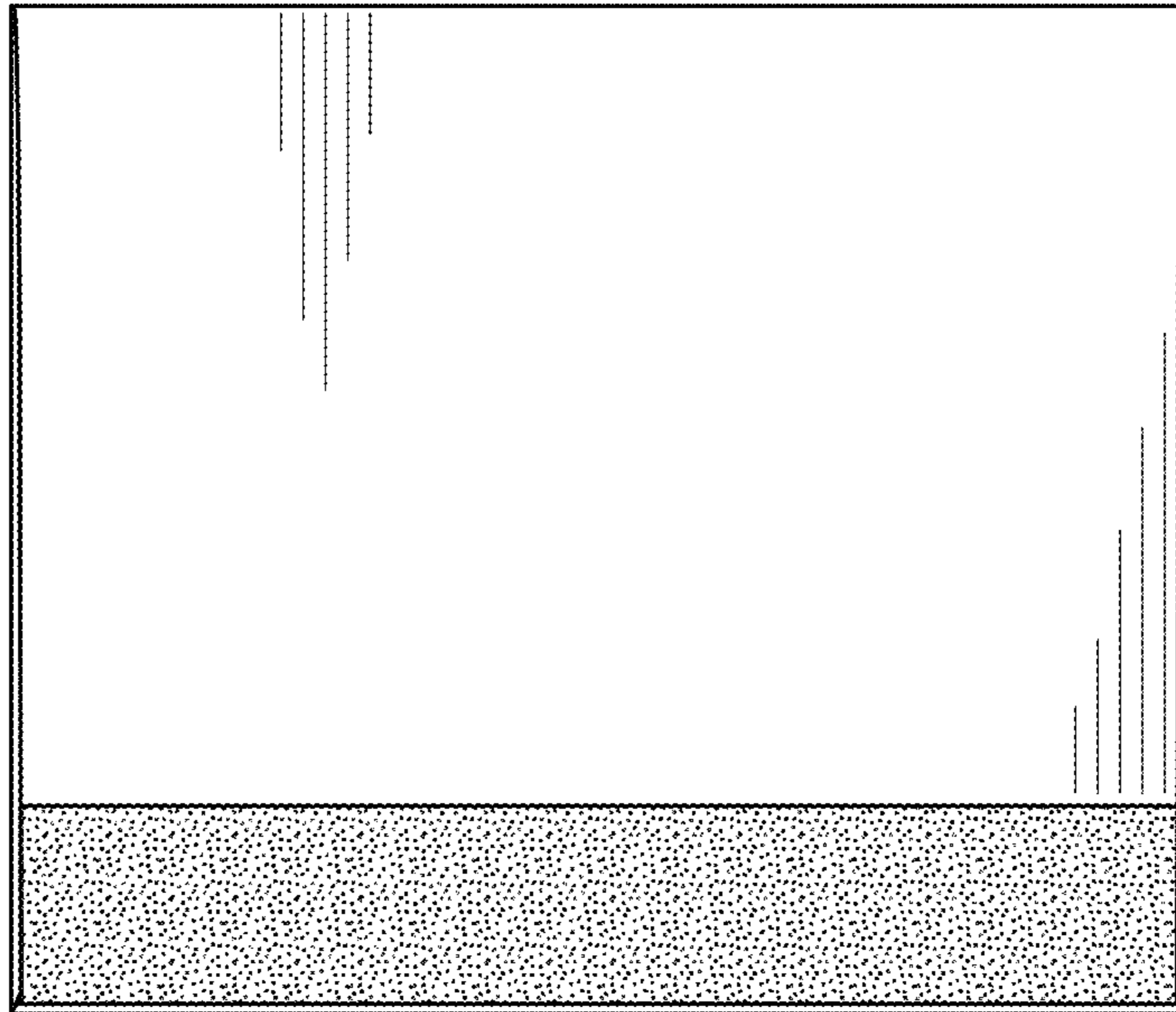

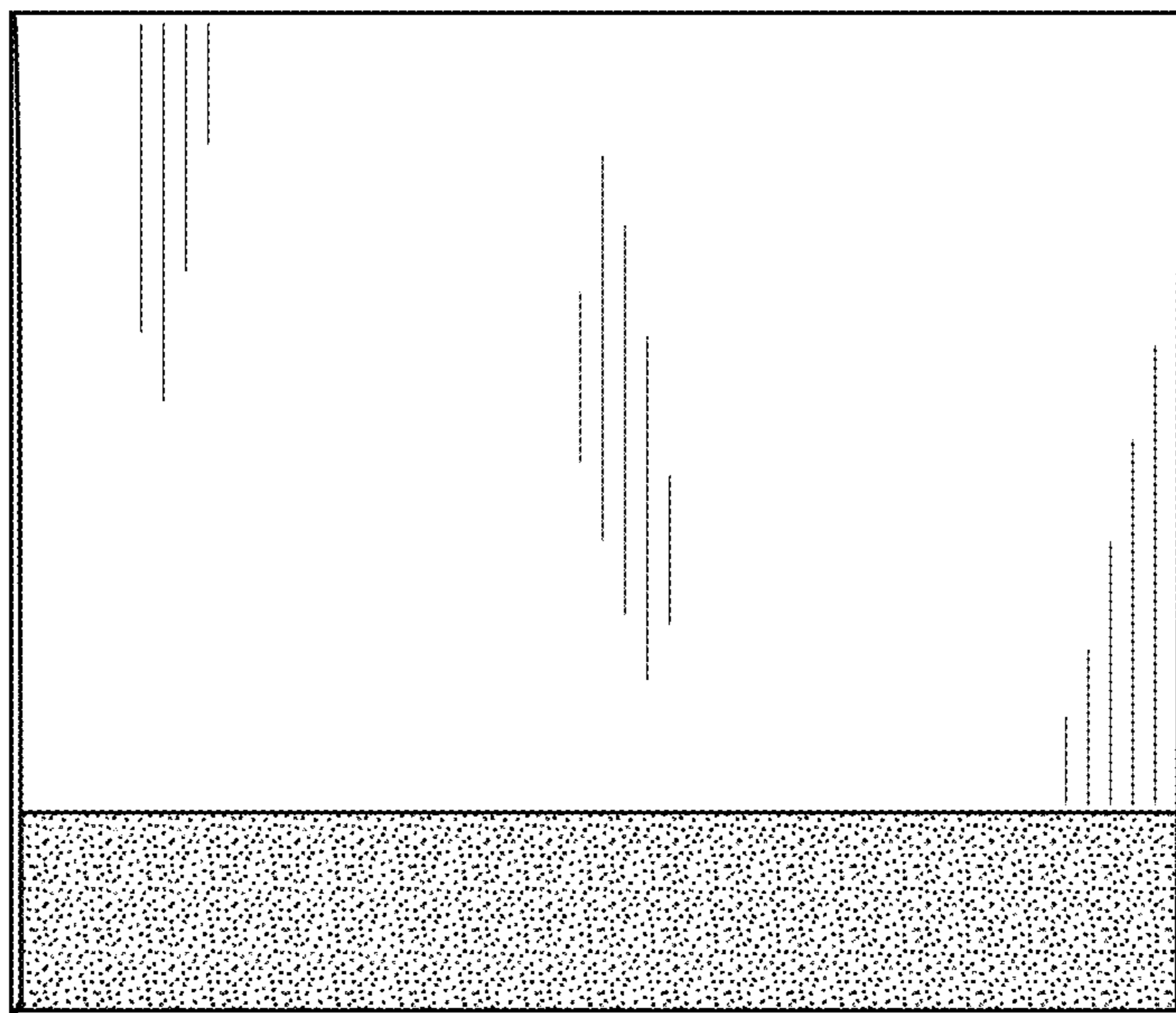

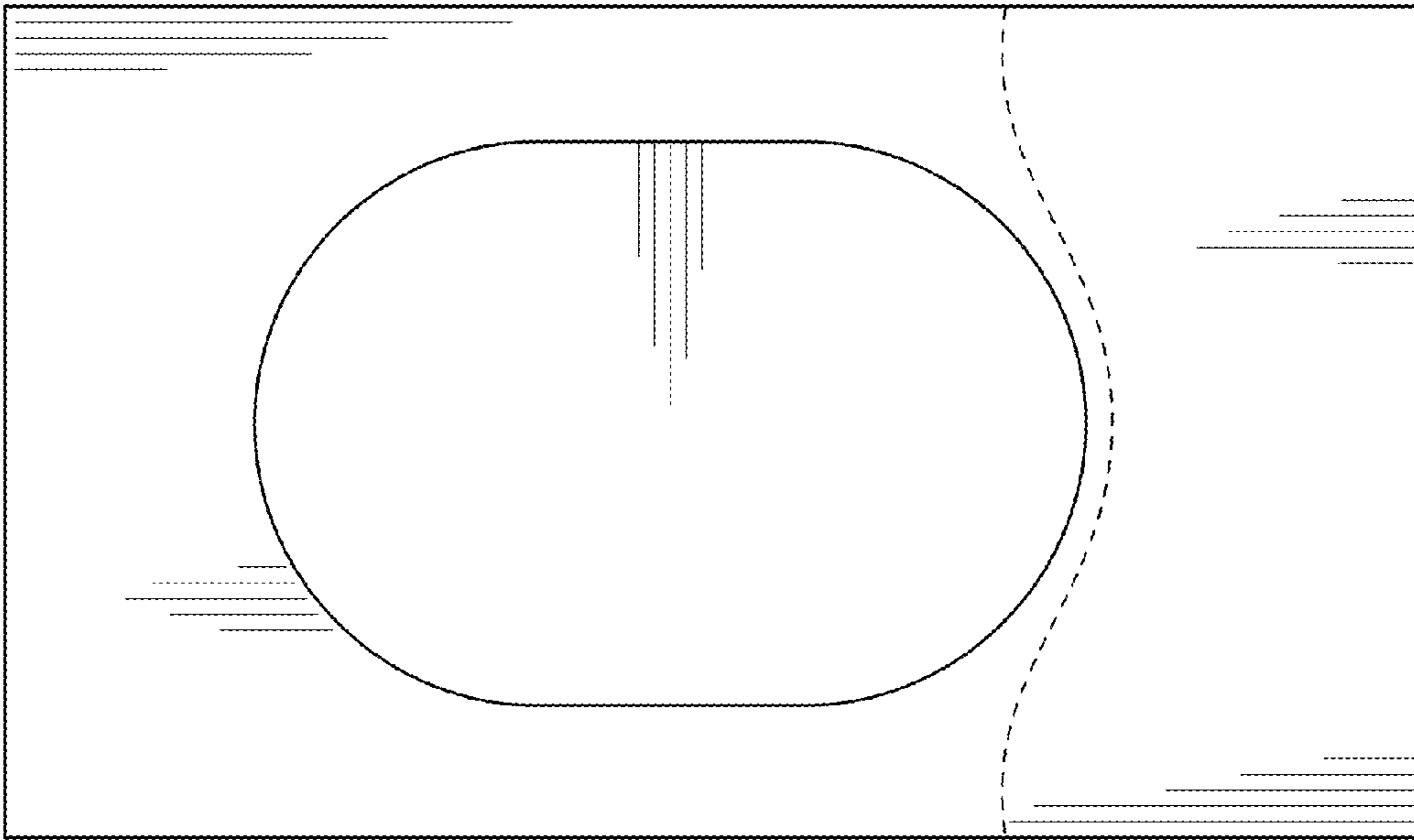

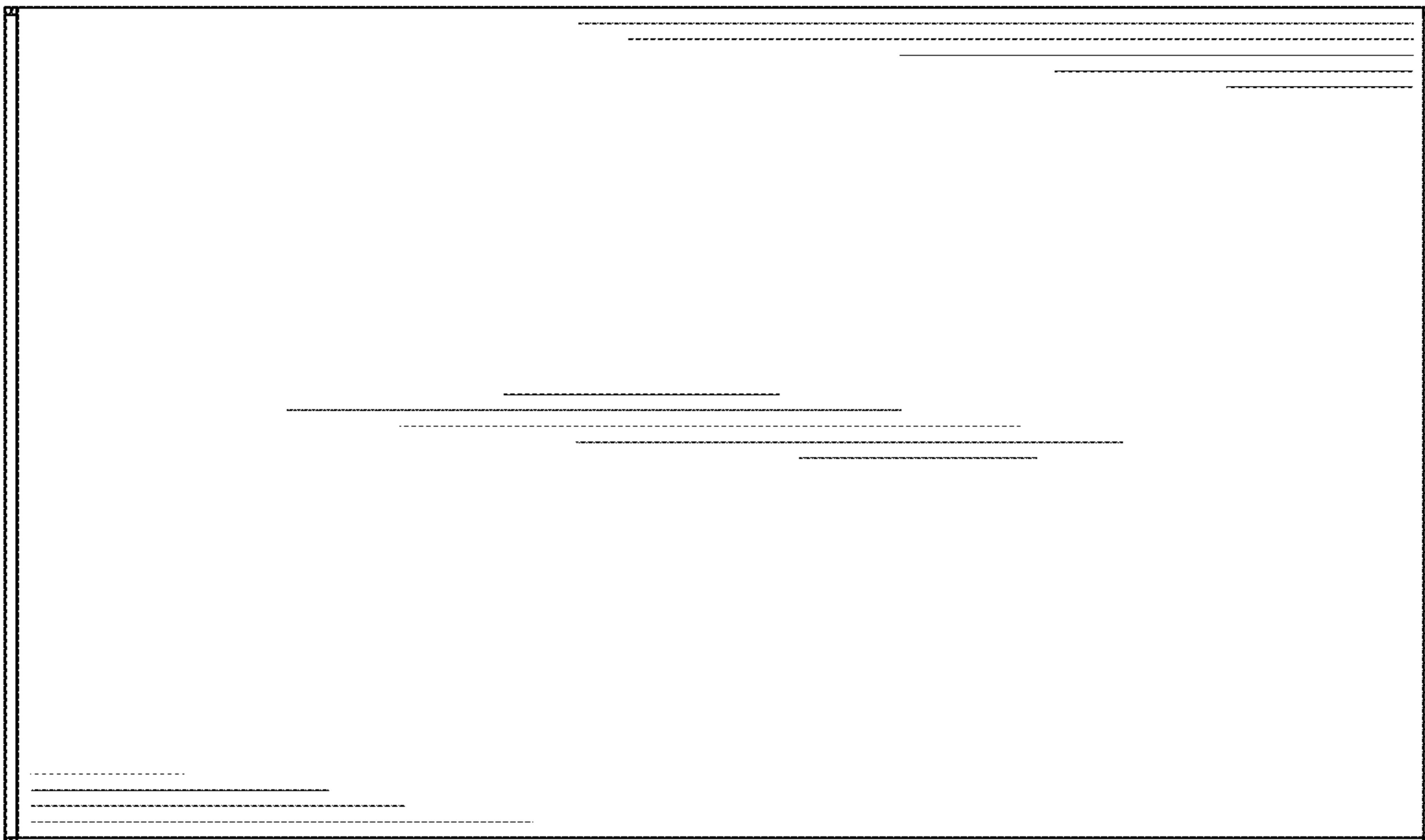

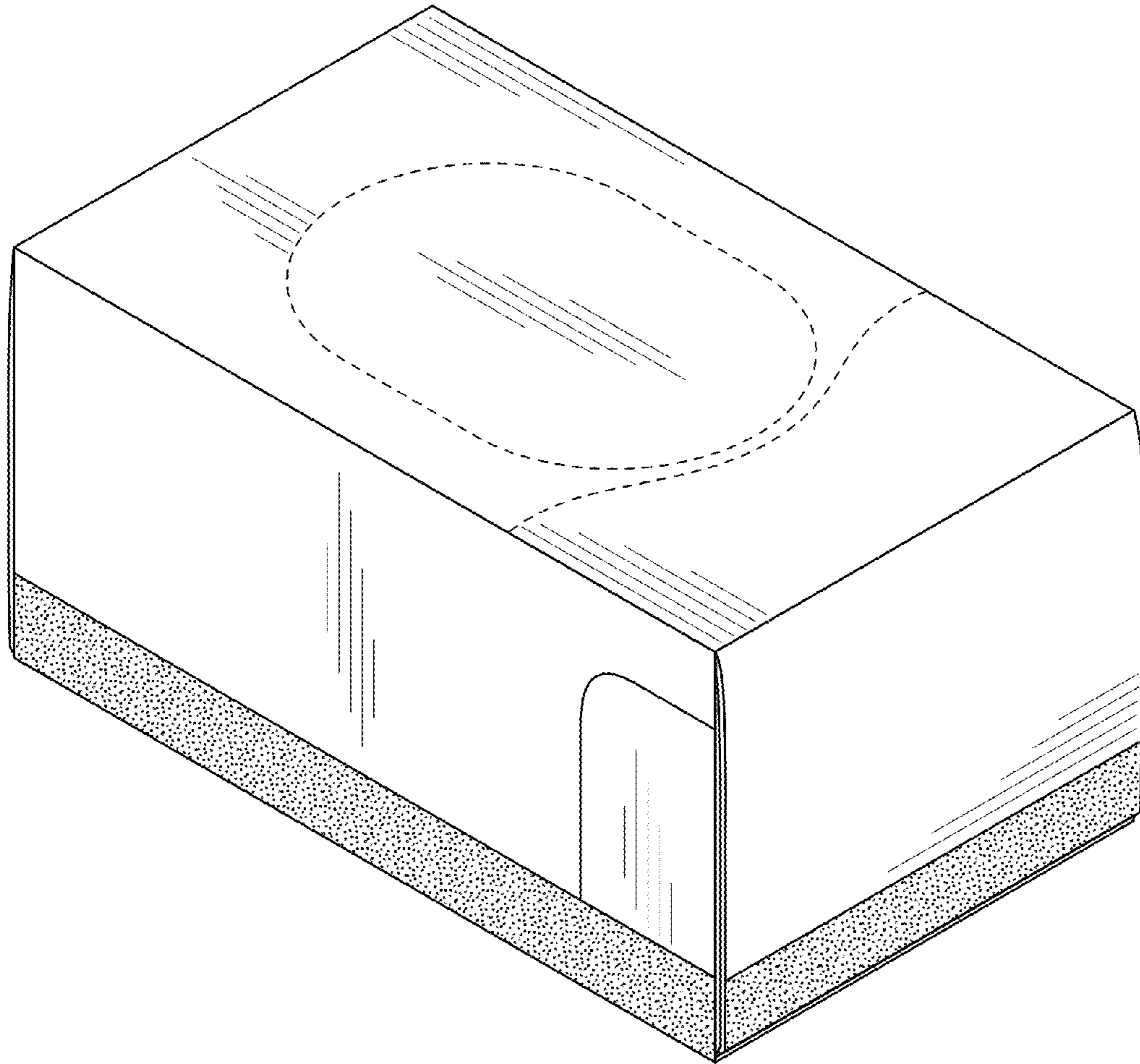

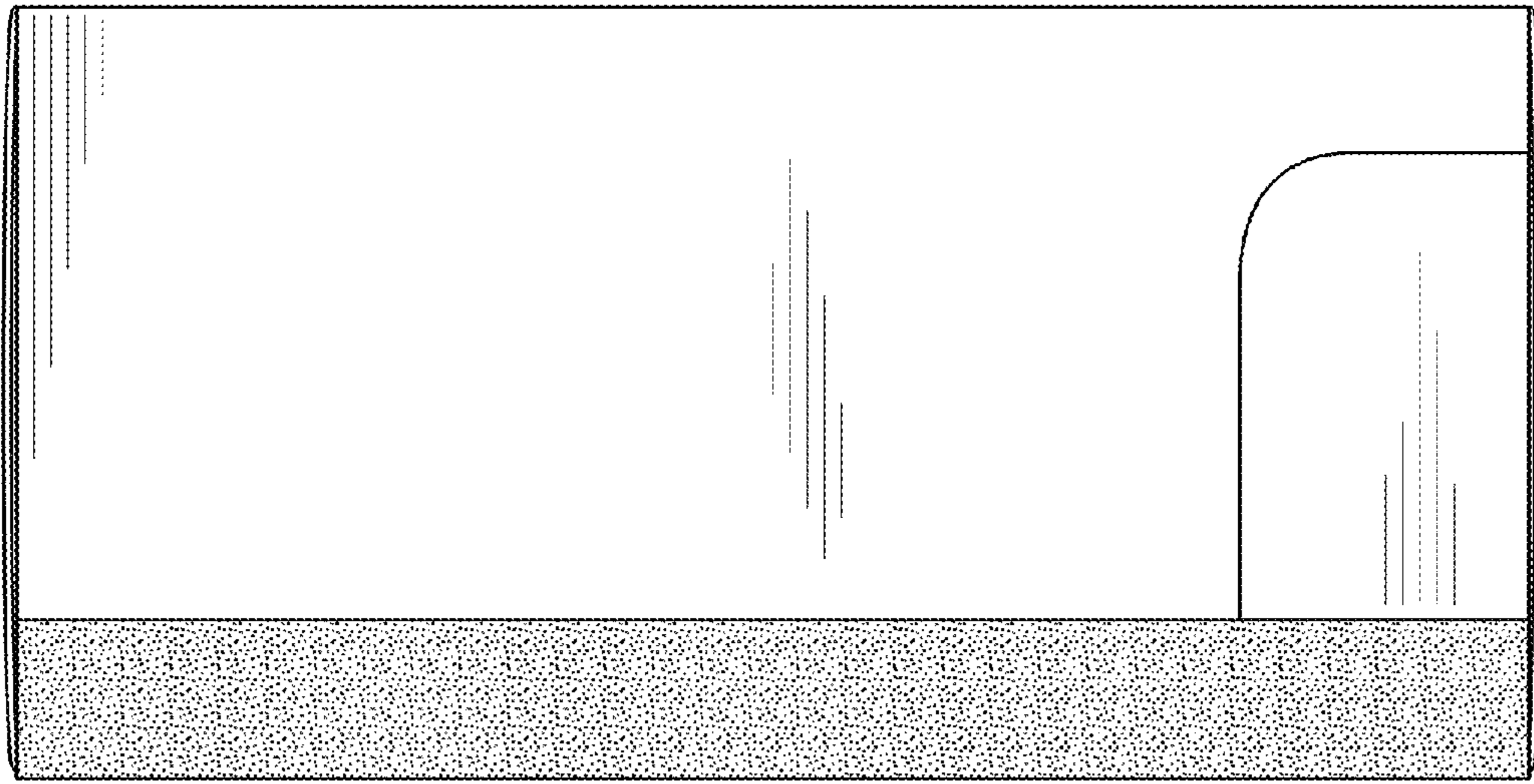

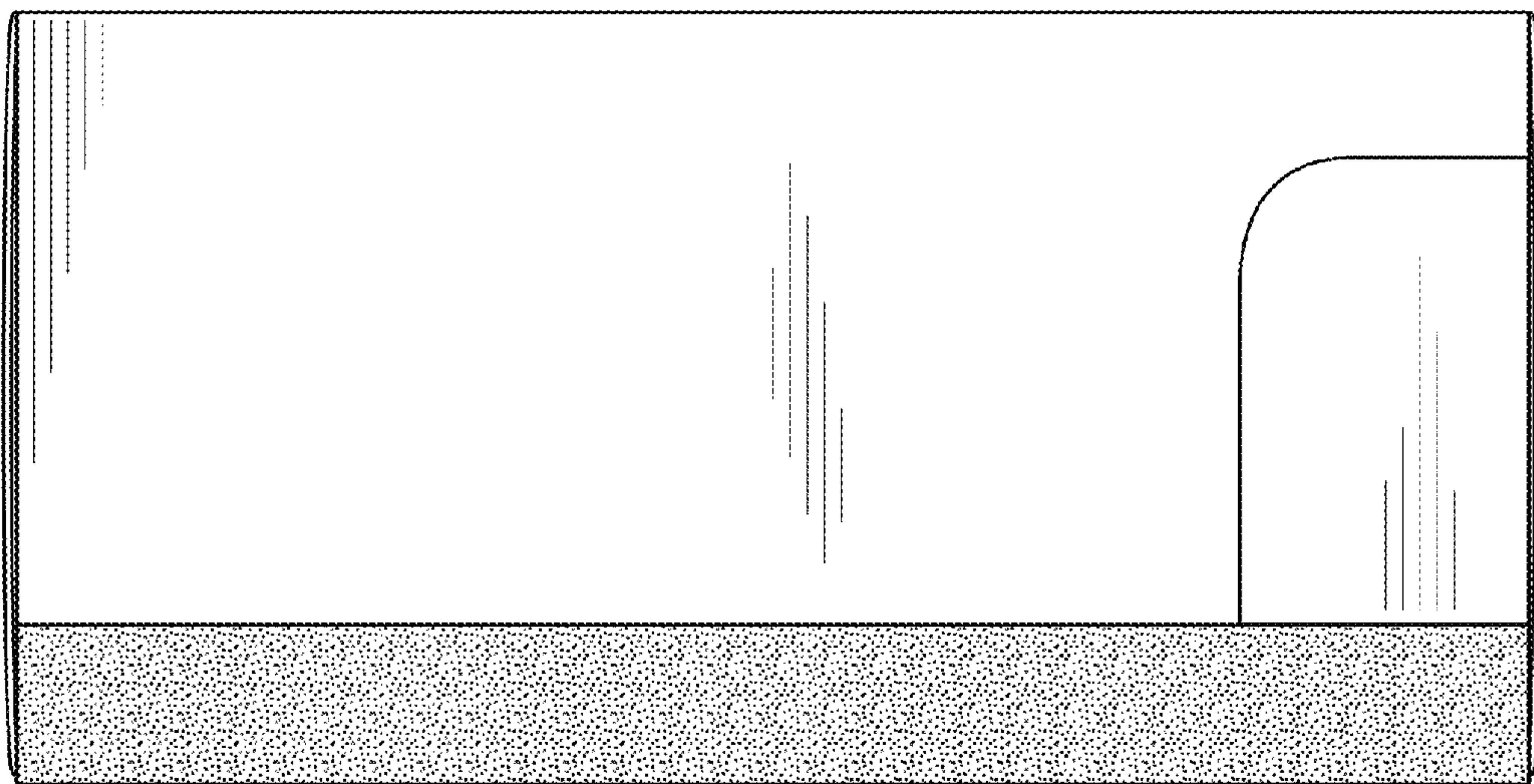

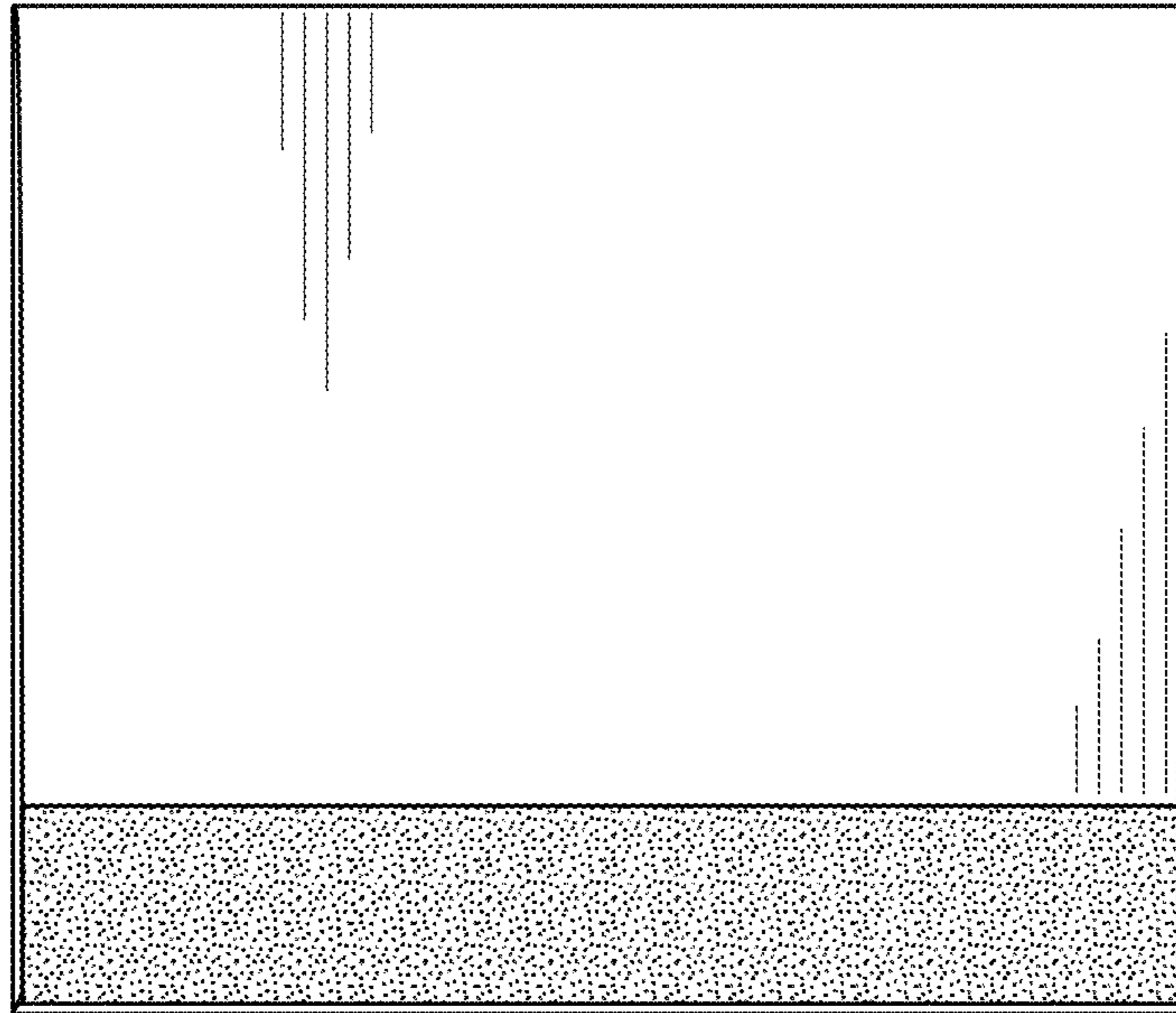

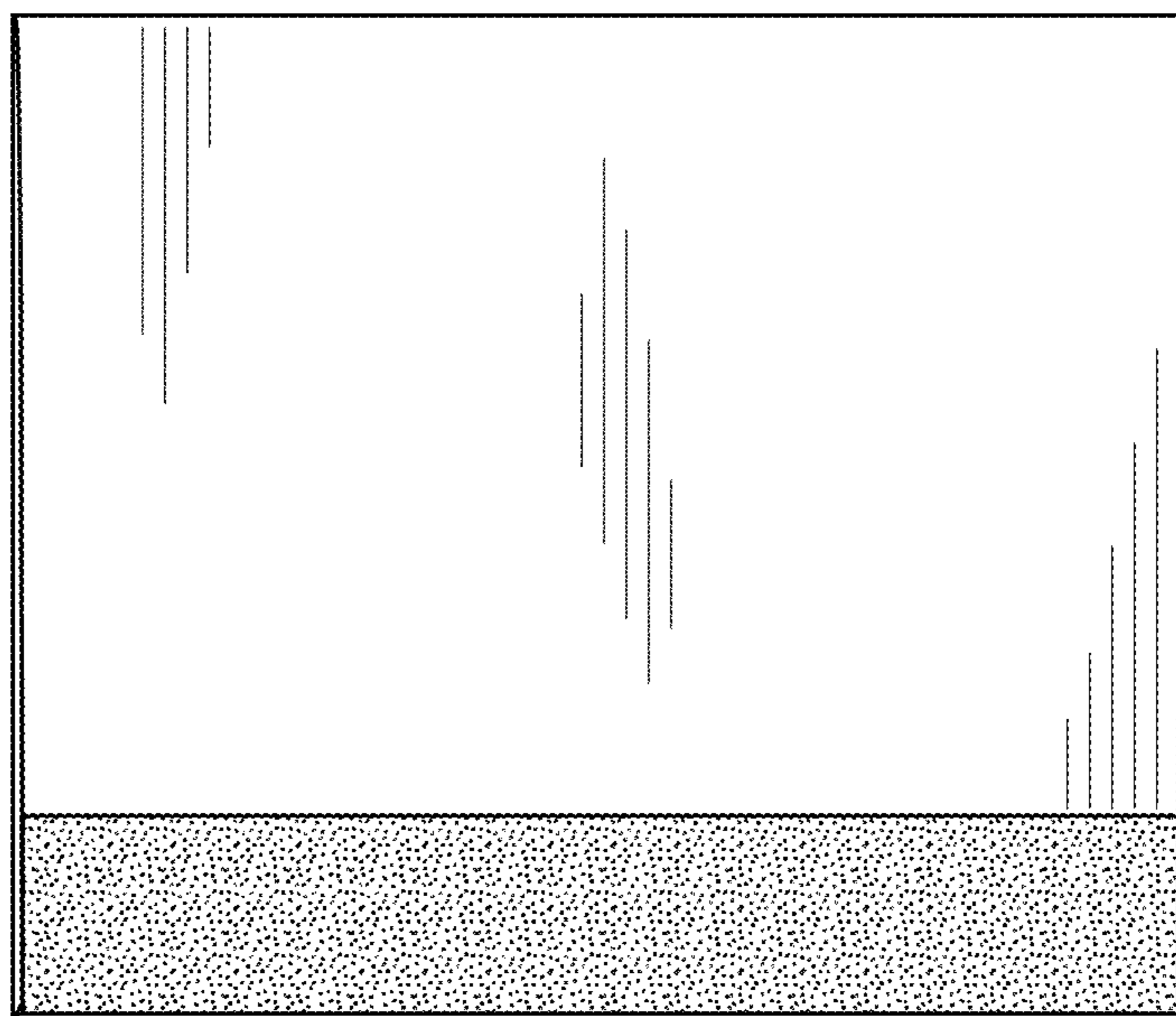

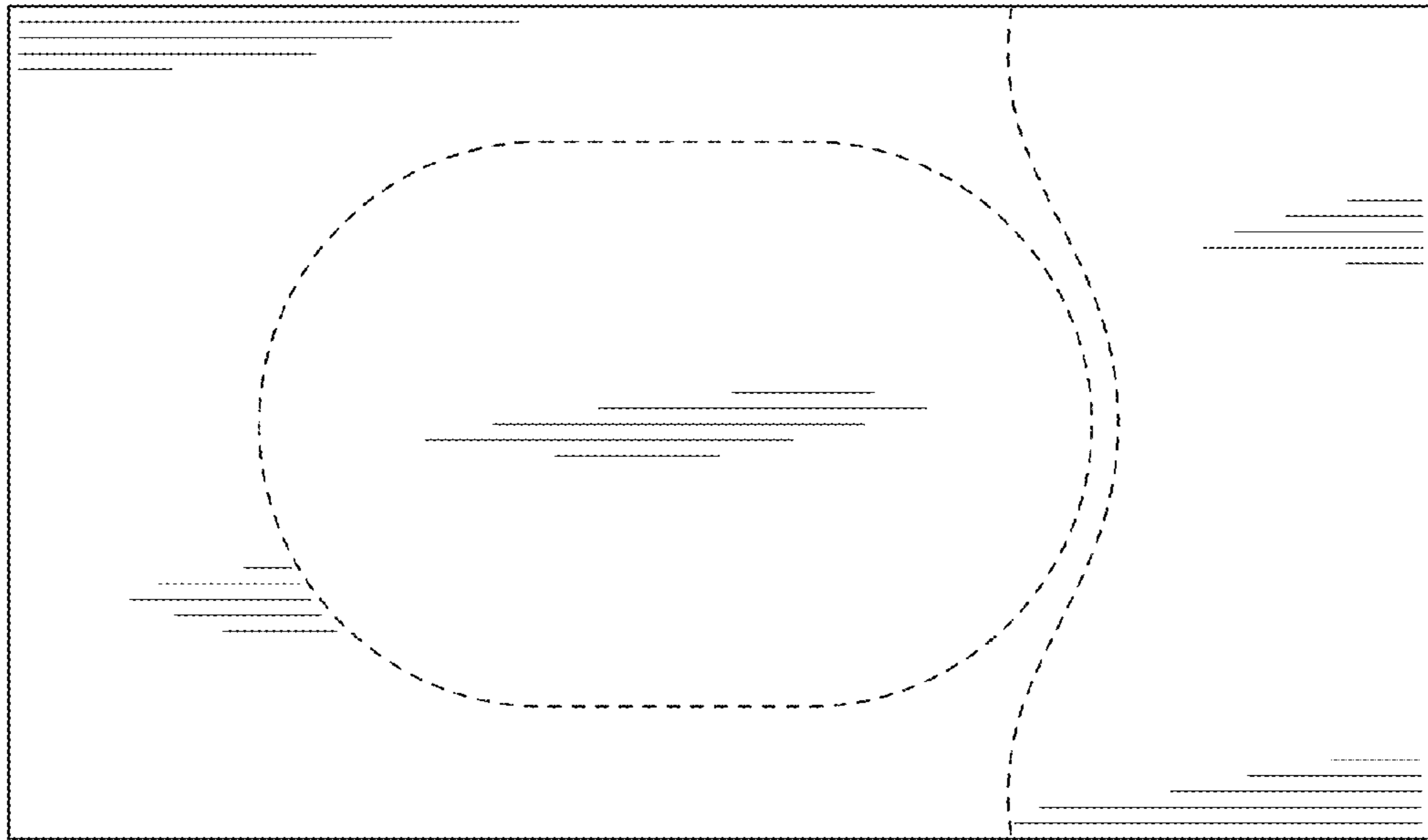

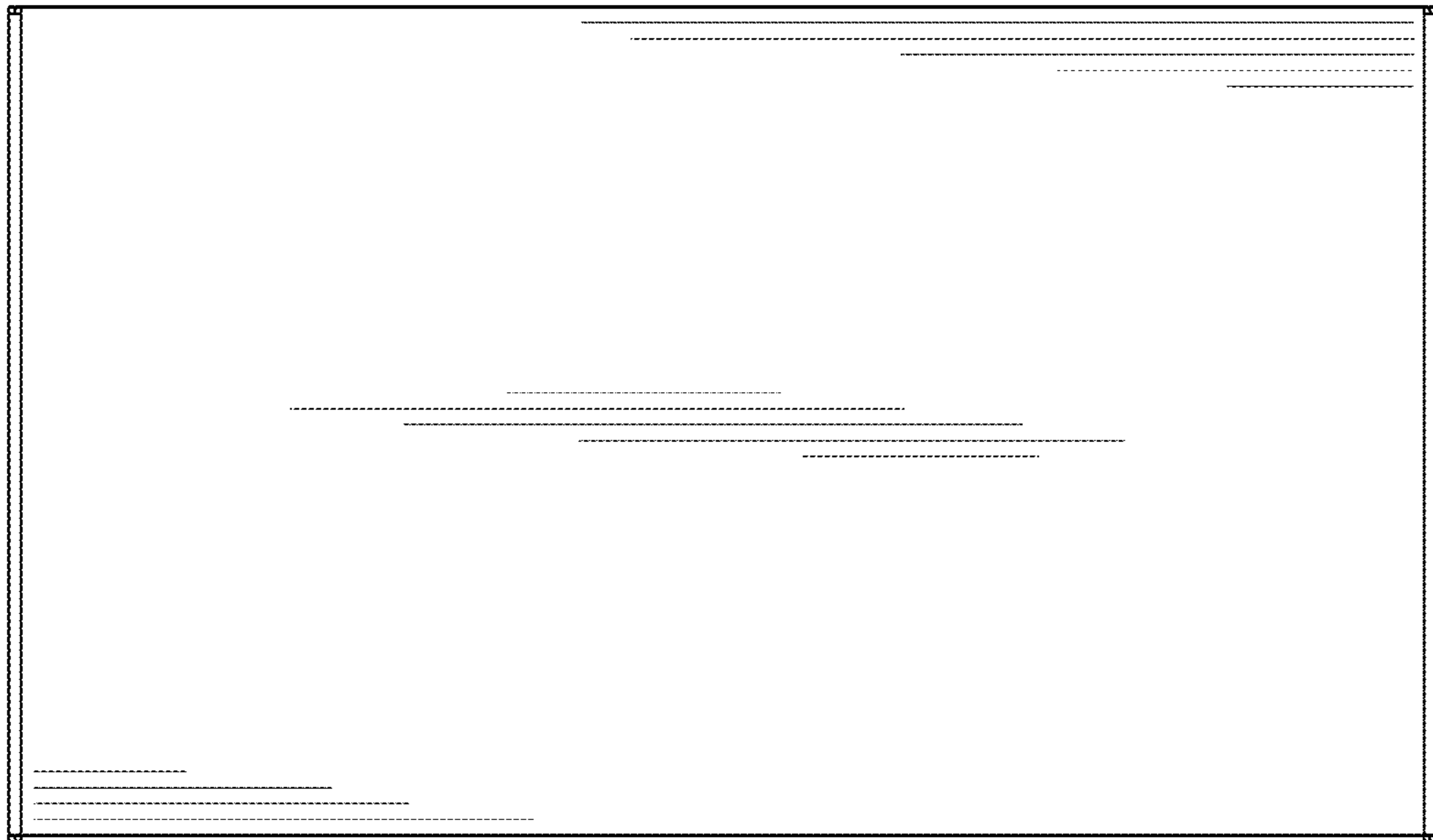
