(57) **CLAIM**

The ornamental design for a steering pad for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a steering pad for an automobile showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a right side elevation view thereof.

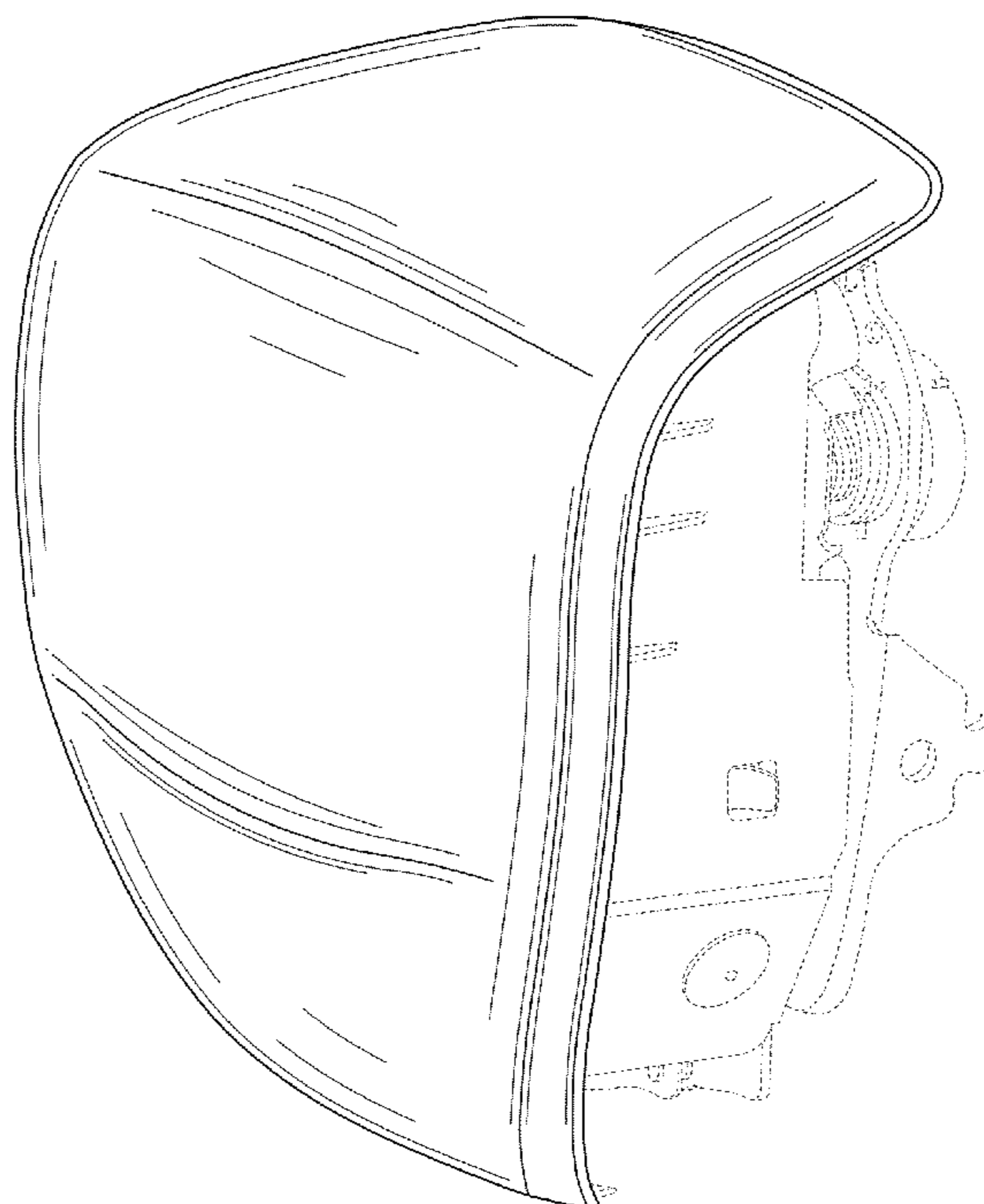

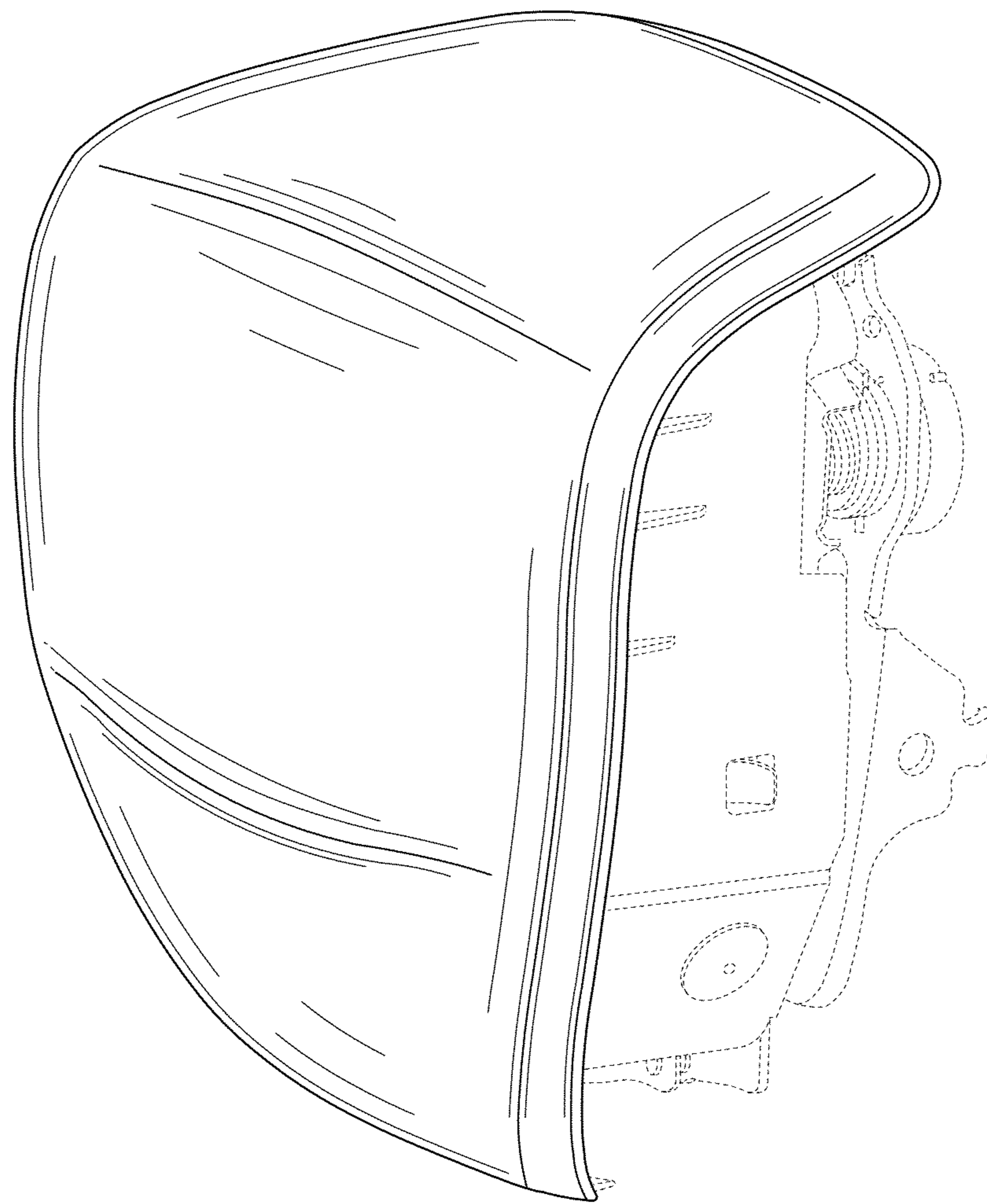

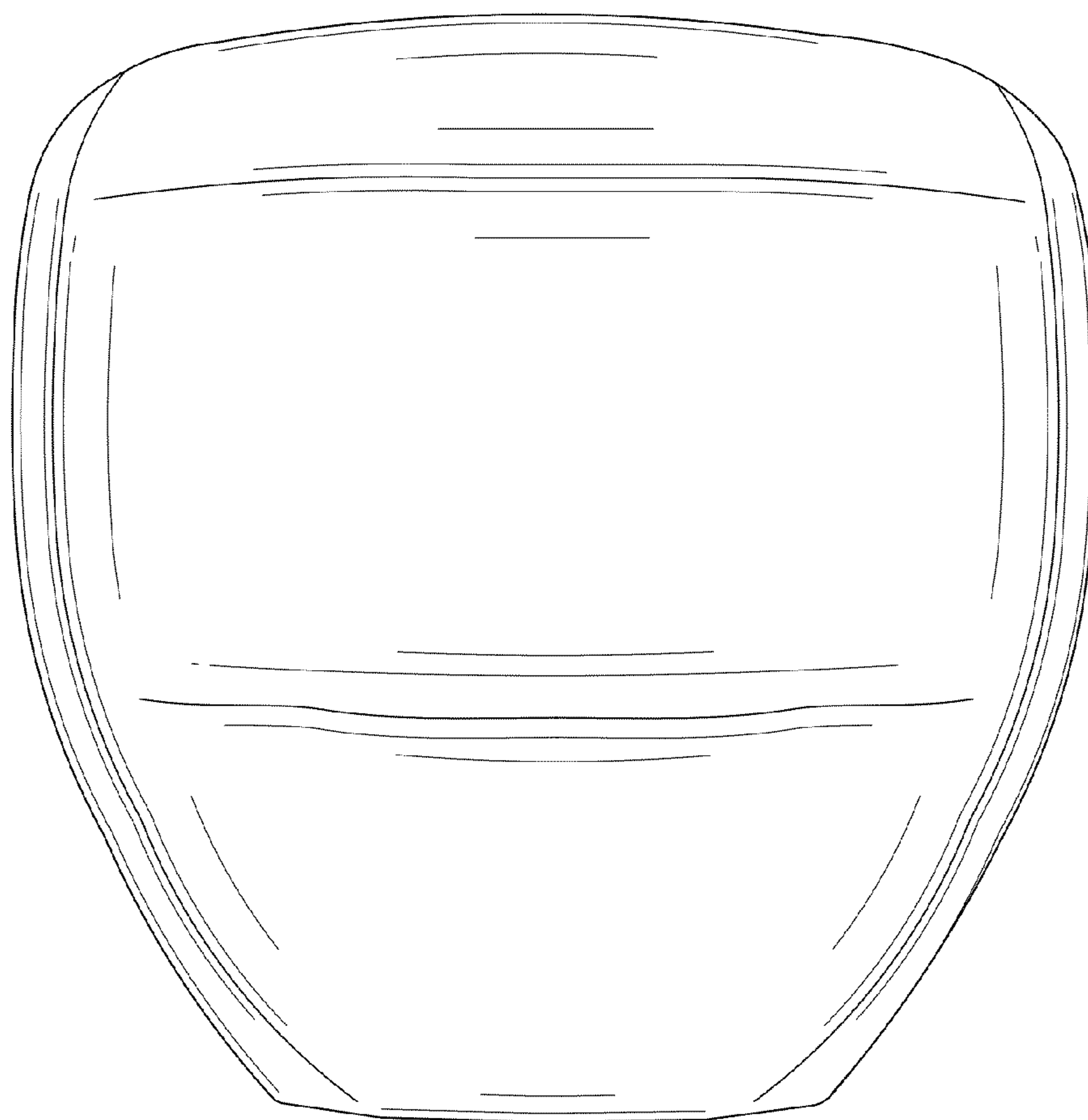

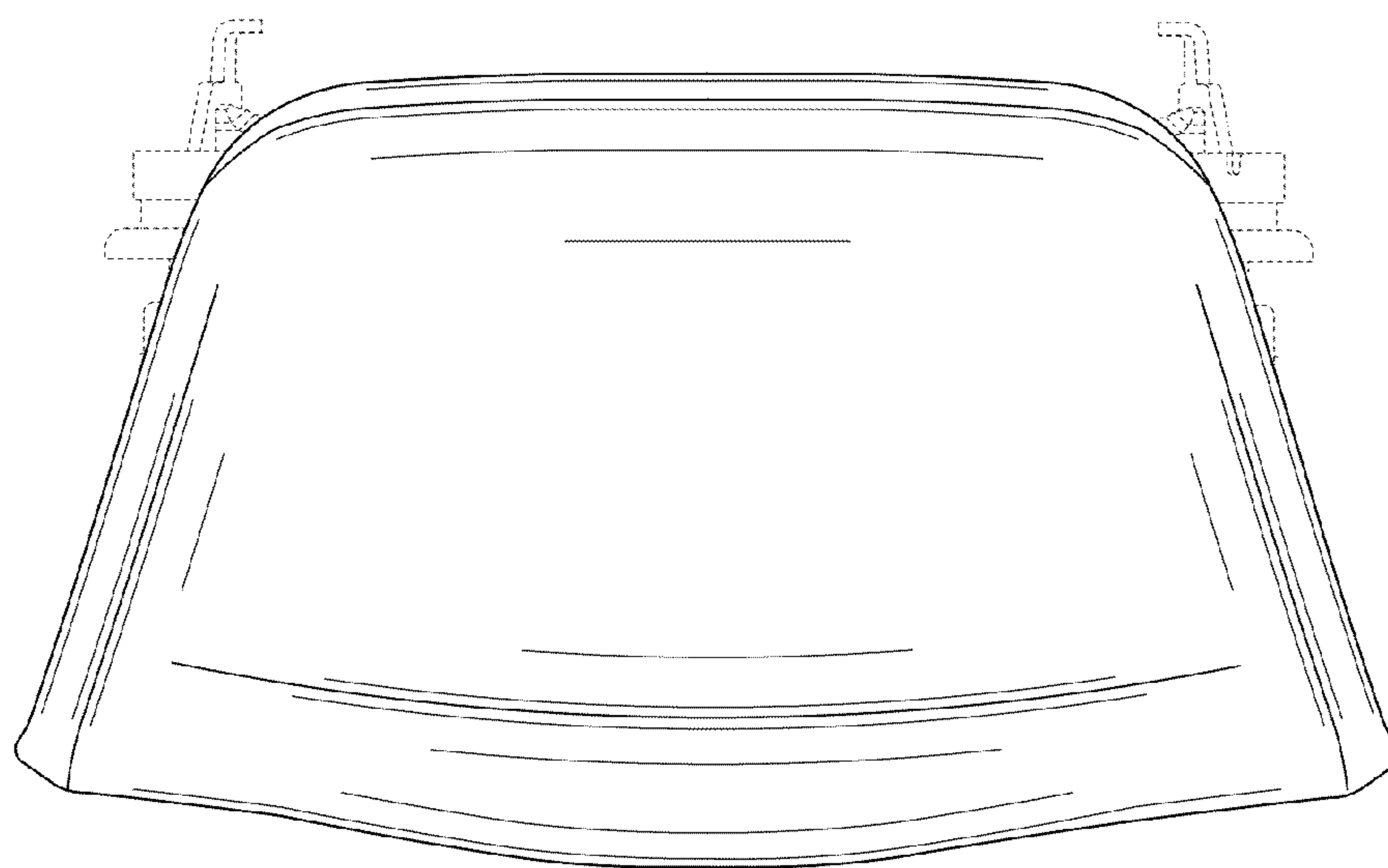
