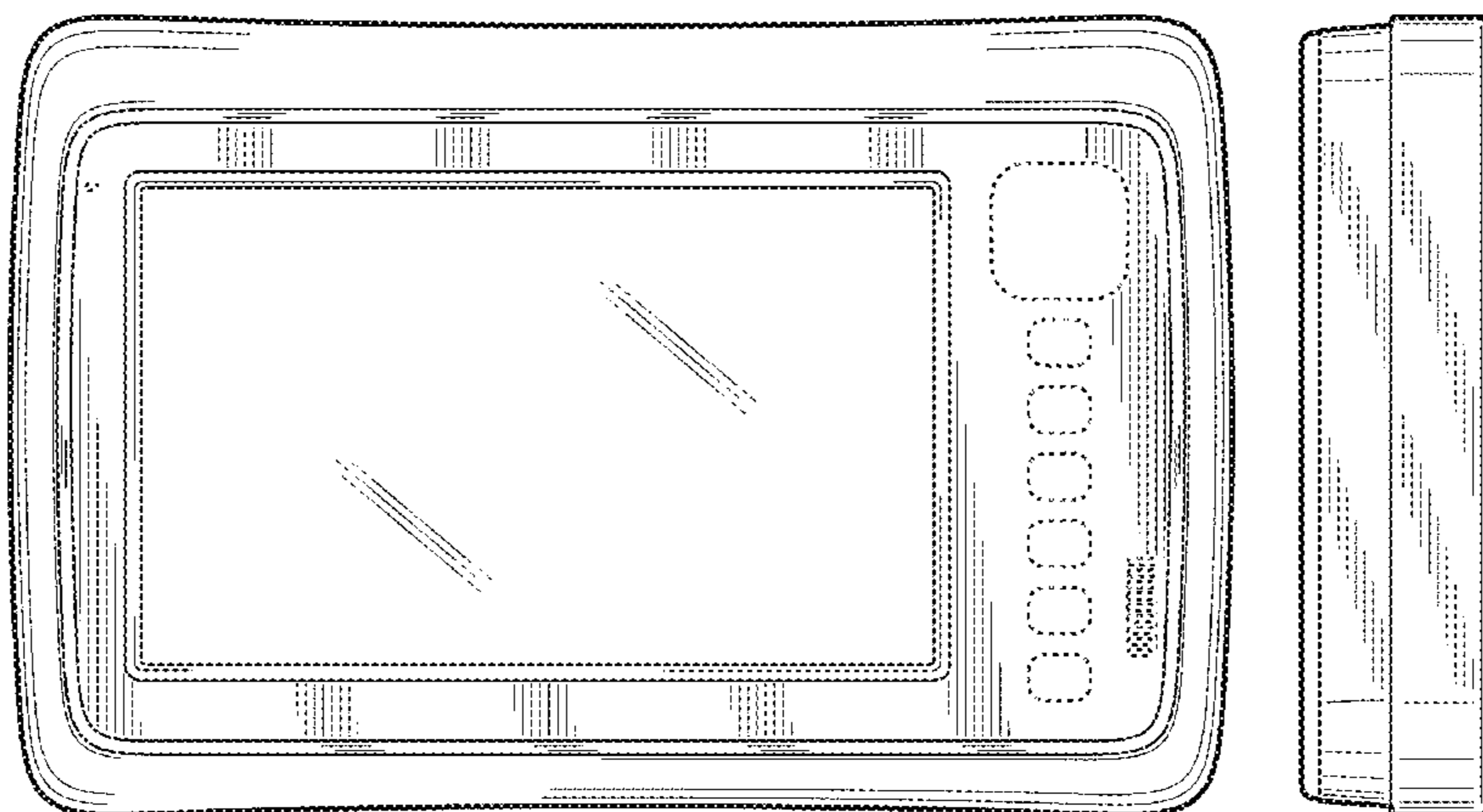

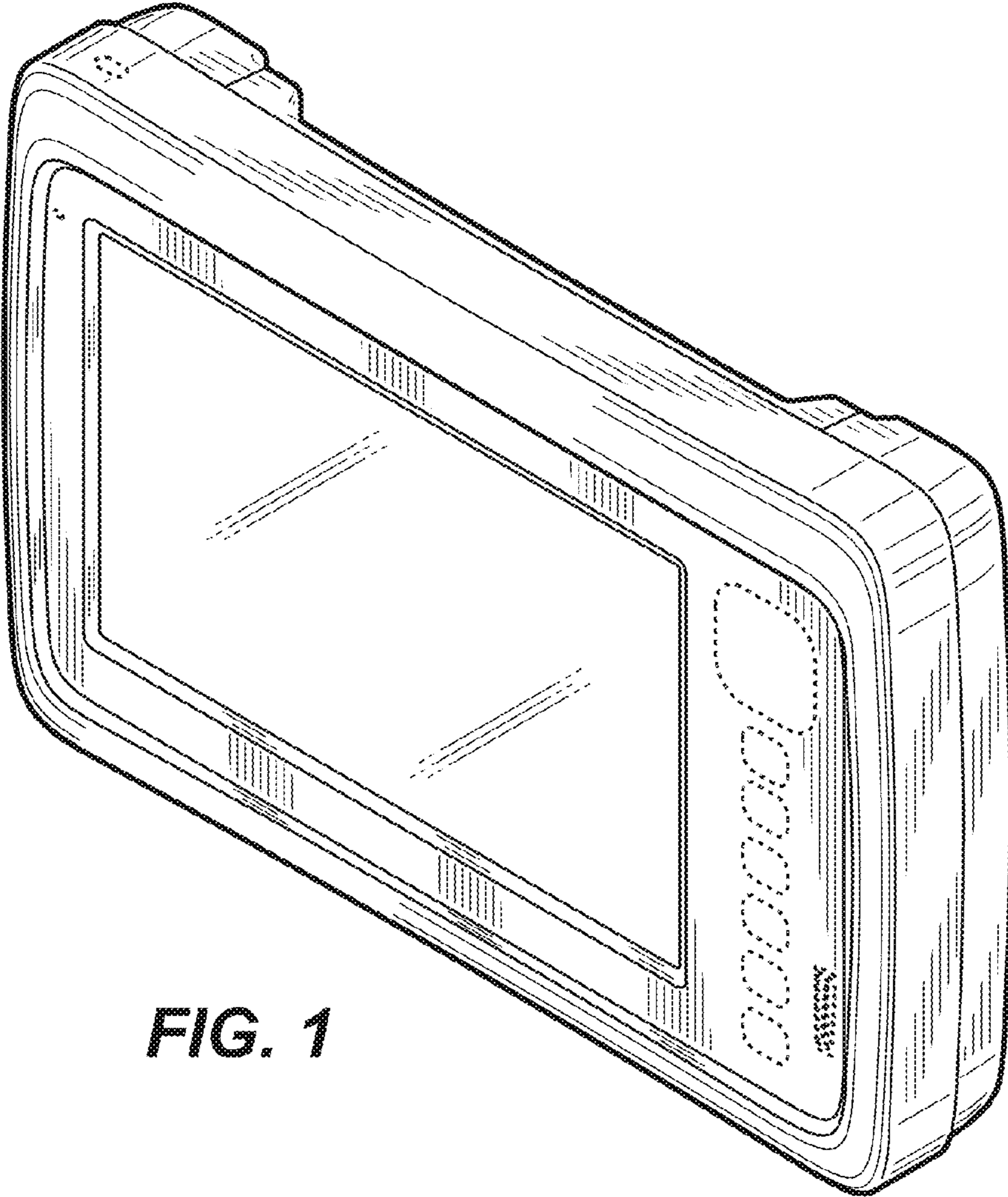

The features shown in broken line represent portions of the rugged tablet computer which form no part of the claimed design.

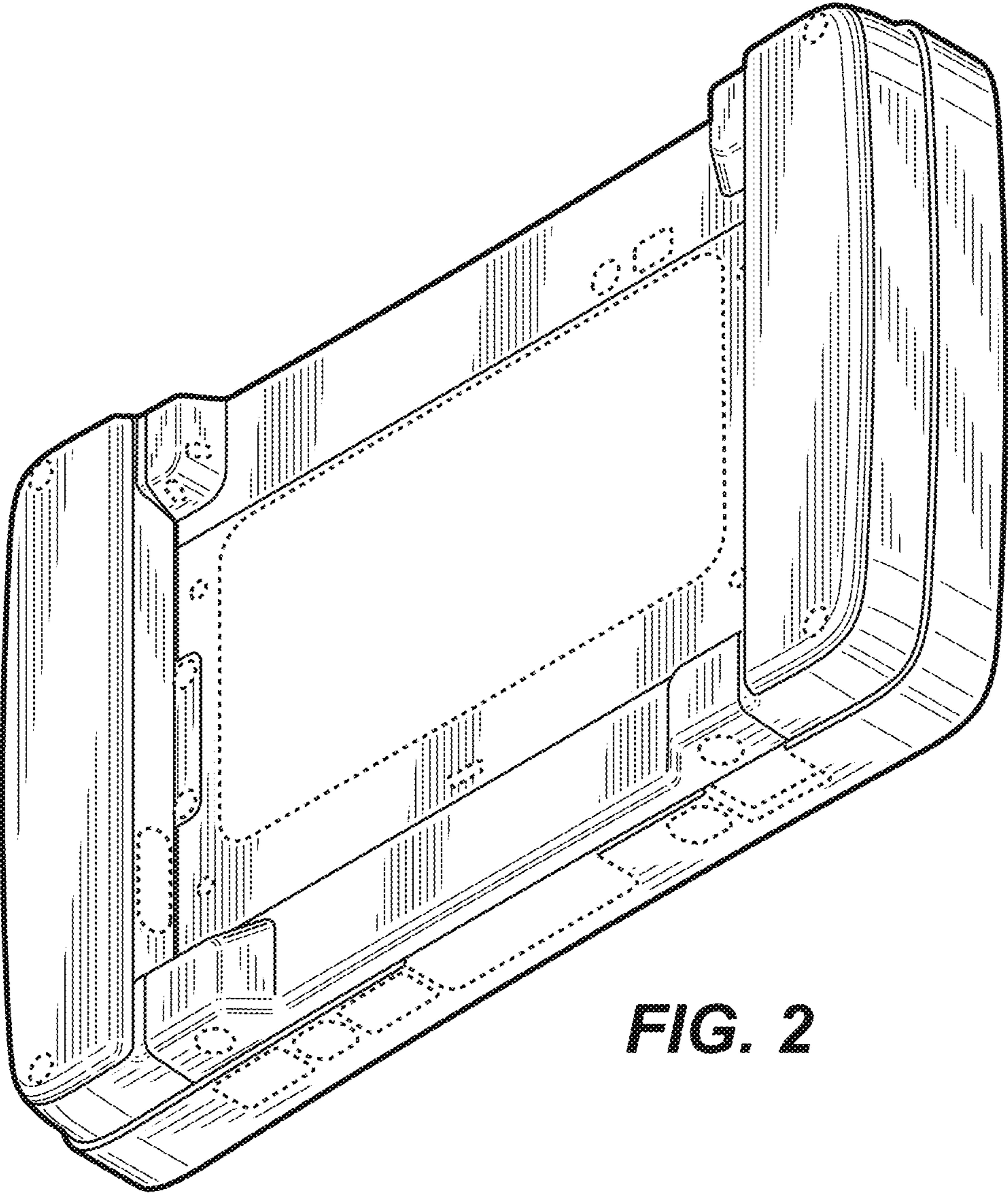

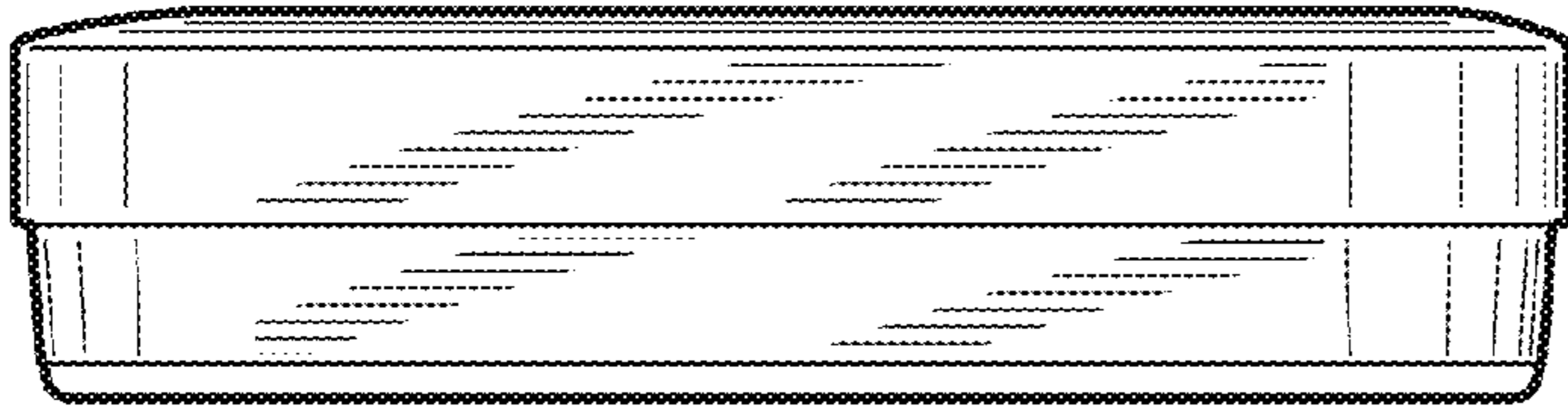

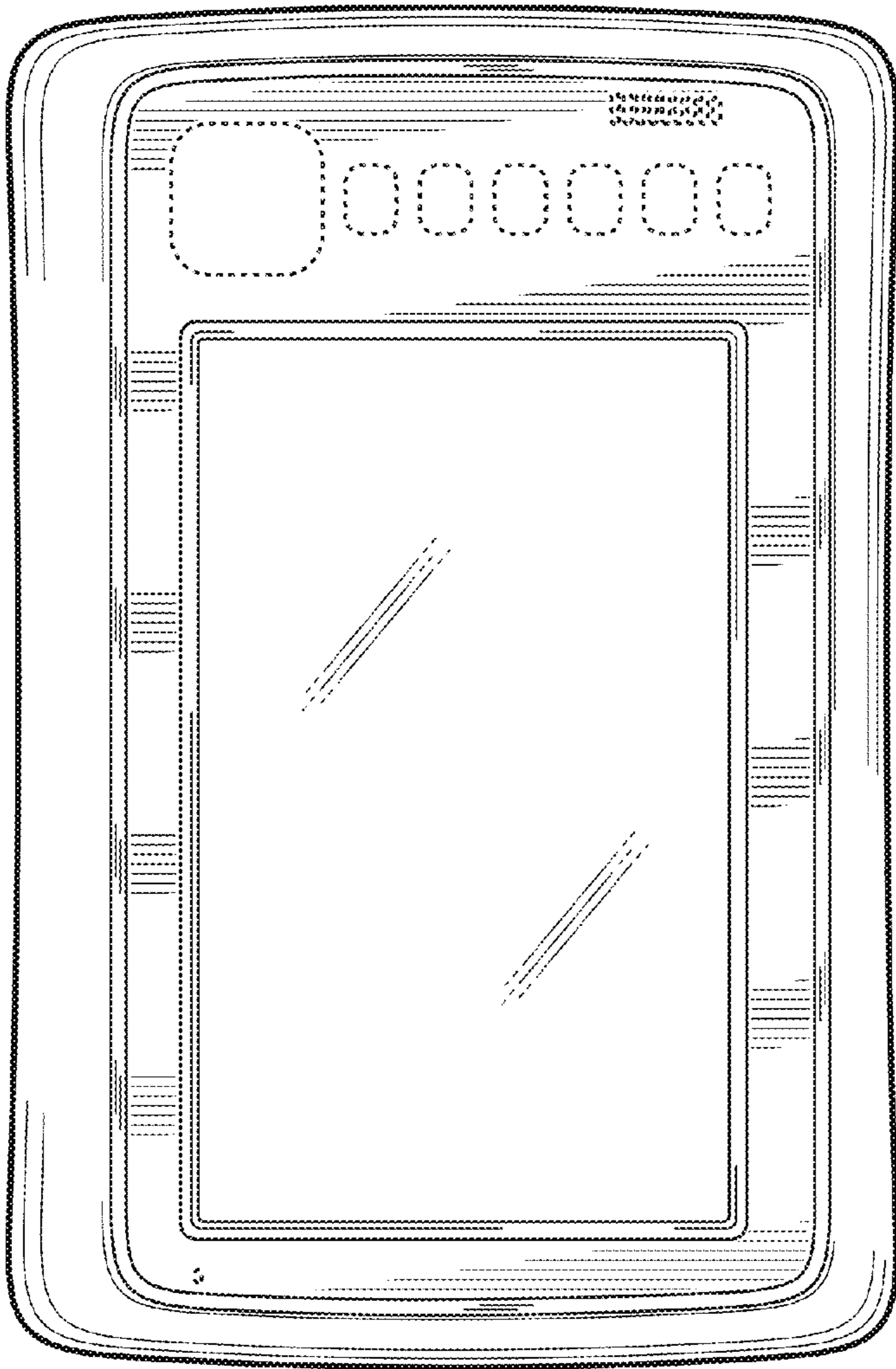

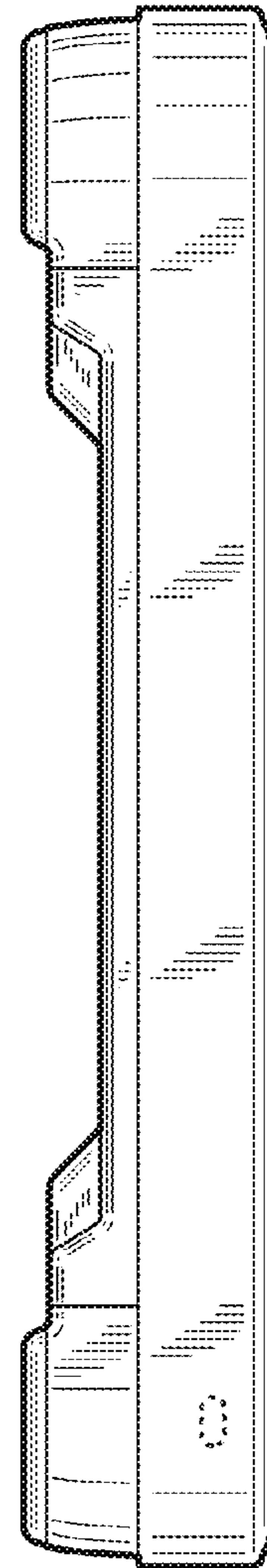

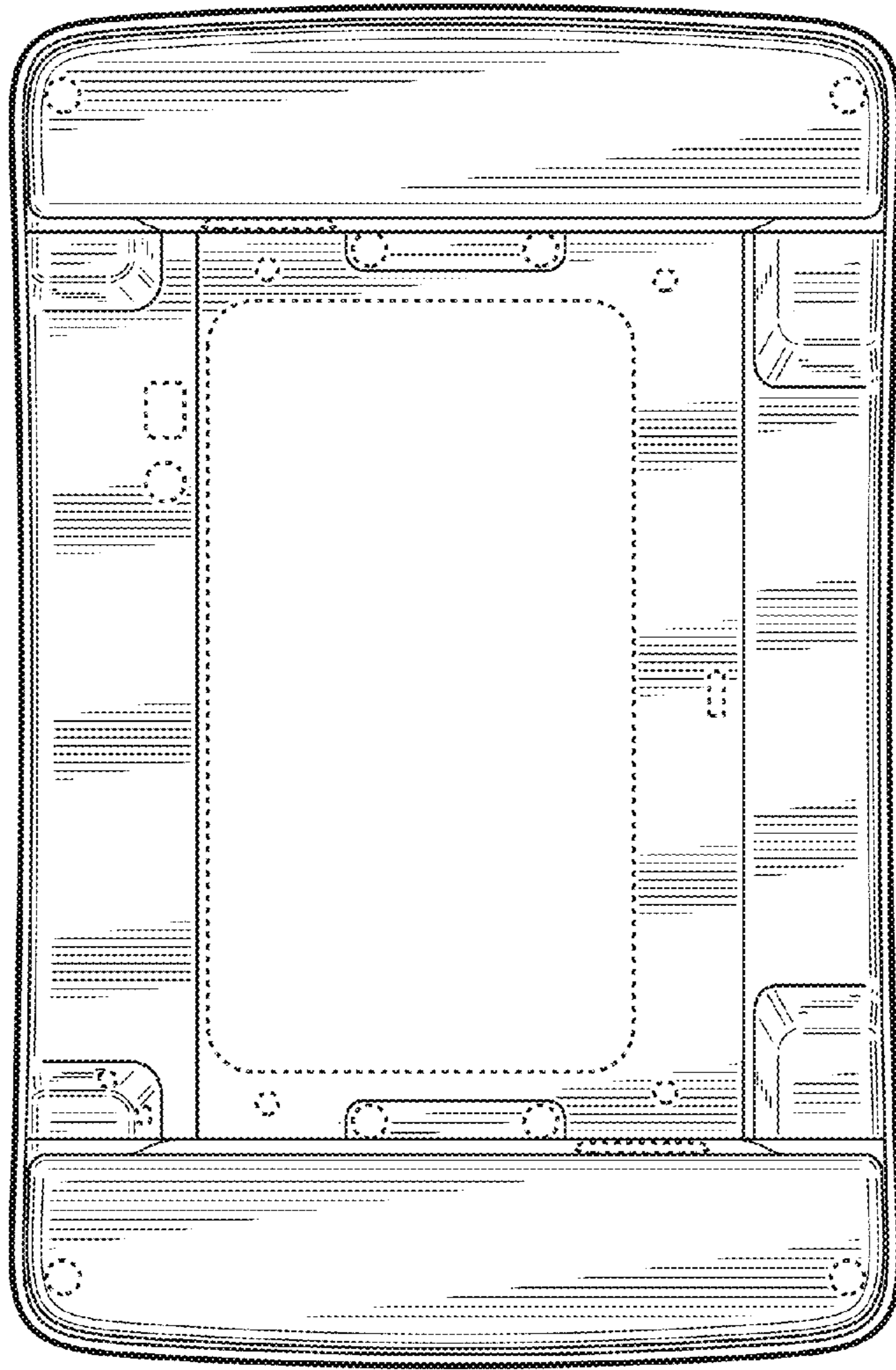

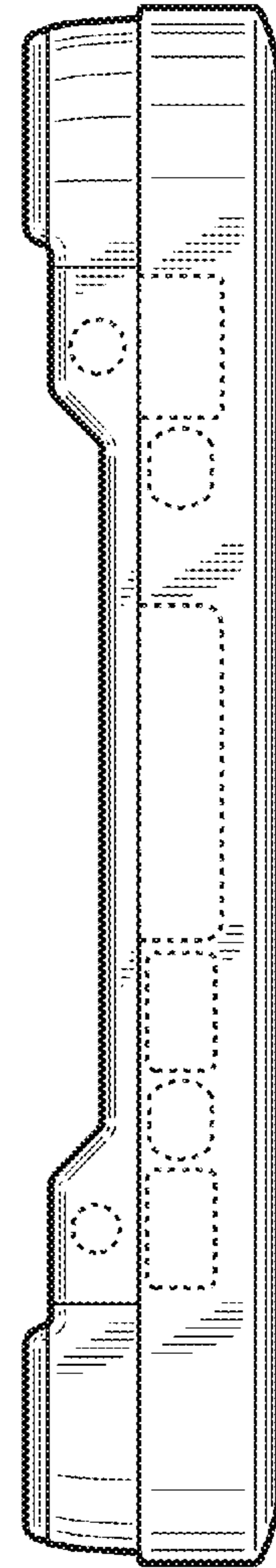
