The ornamental design for a display screen of a computing device with graphical user interface, as shown and described.

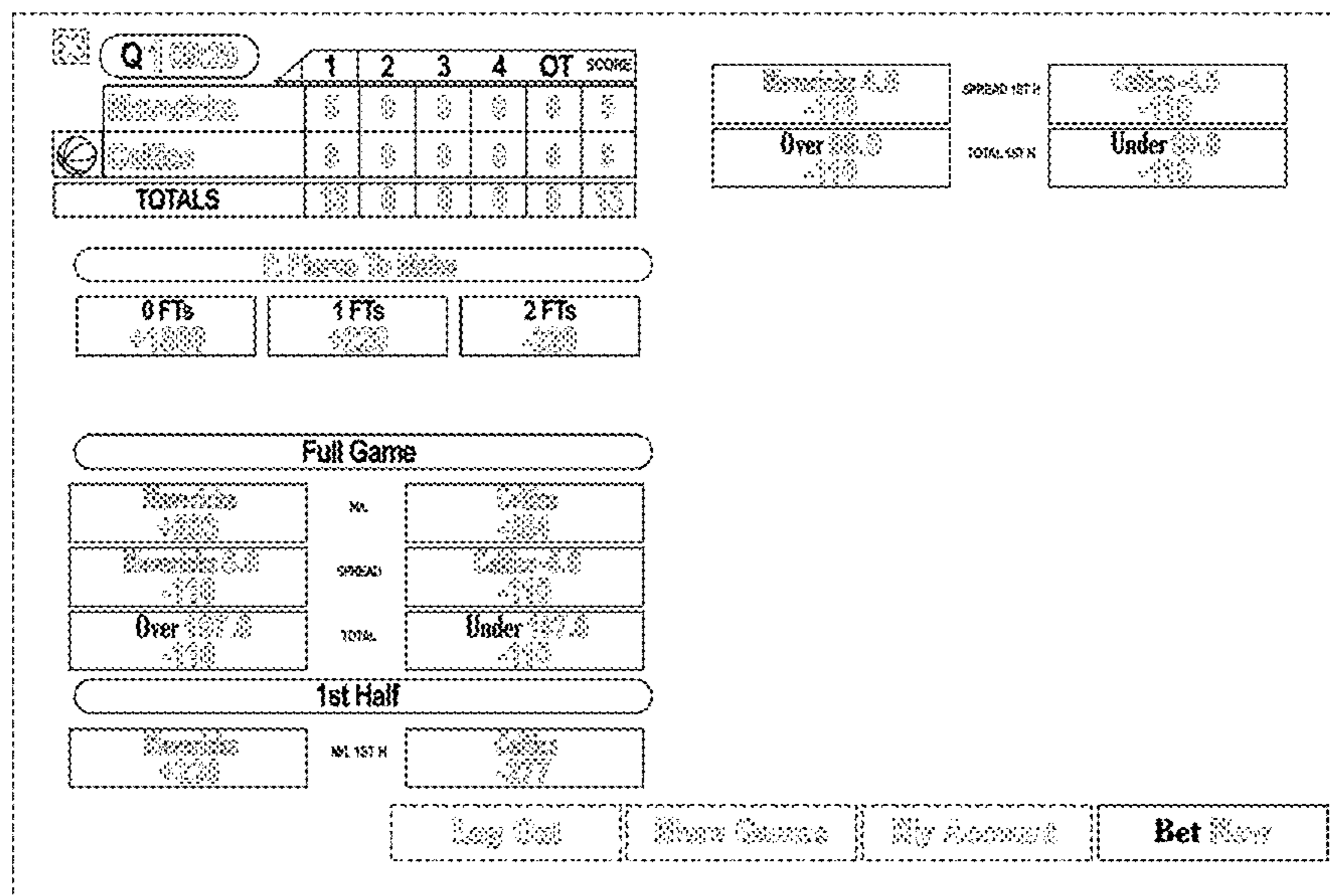
DESCRIPTION
