(57) **CLAIM**

The ornamental design for a tray, as shown and described.

DESCRIPTION

FIG. 1 is the front/right-side/top perspective view of a tray showing our new design;
FIG. 2 is the front-side elevation view thereof;
FIG. 3 is the rear-side elevation view thereof;
FIG. 4 is the left-side elevation view thereof;
FIG. 5 is the right-side elevation view thereof;
FIG. 6 is the top-side elevation view thereof;
FIG. 7 is the bottom-side elevation view thereof; and,
FIG. 8 shows the tray installed in an unclaimed environment. The shade lines in the Figures show the transparency and the flatness, and not surface ornamentation. The broken lines in the drawing show unclaimed environment only and form no part of the claimed design.

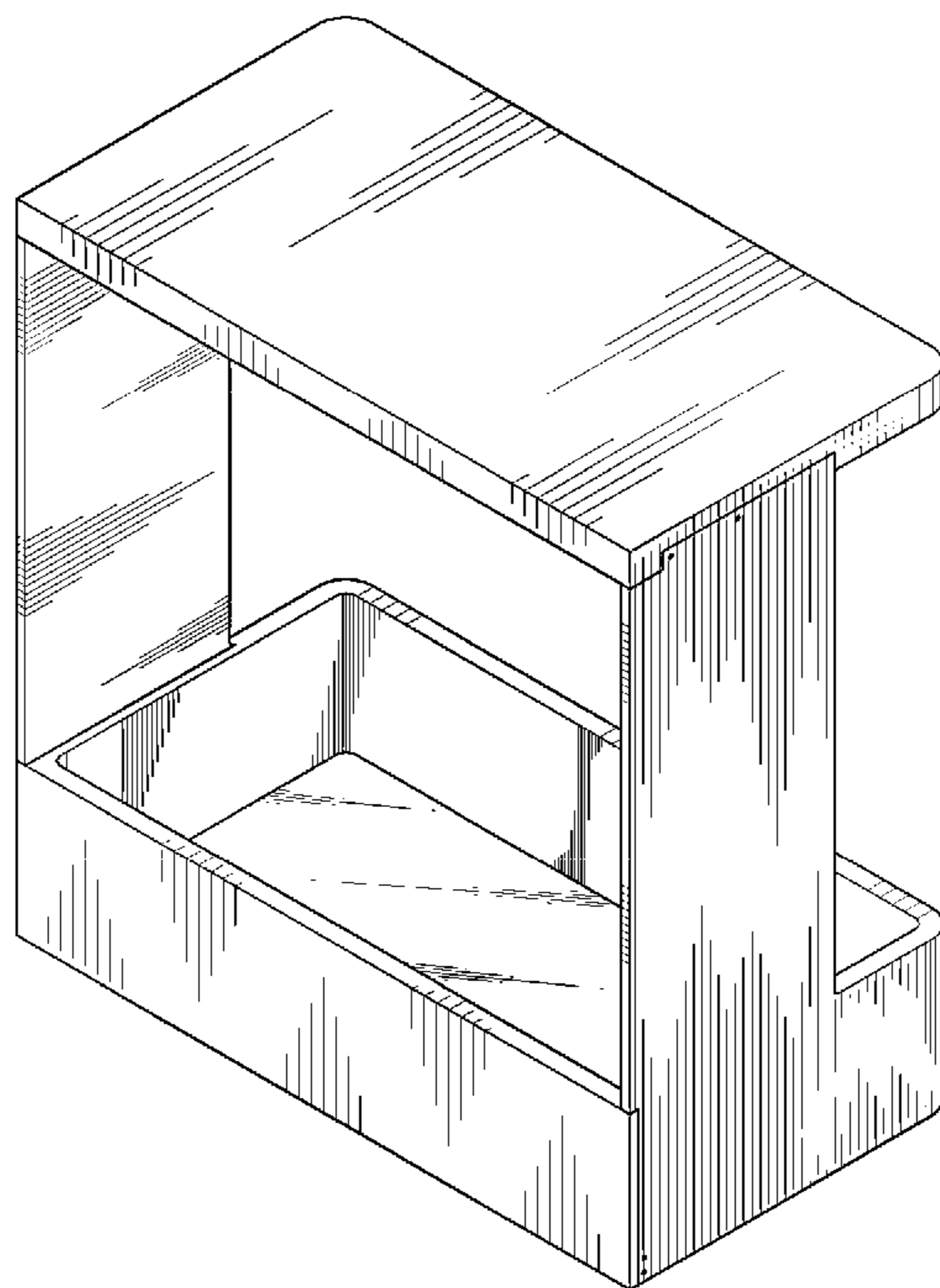

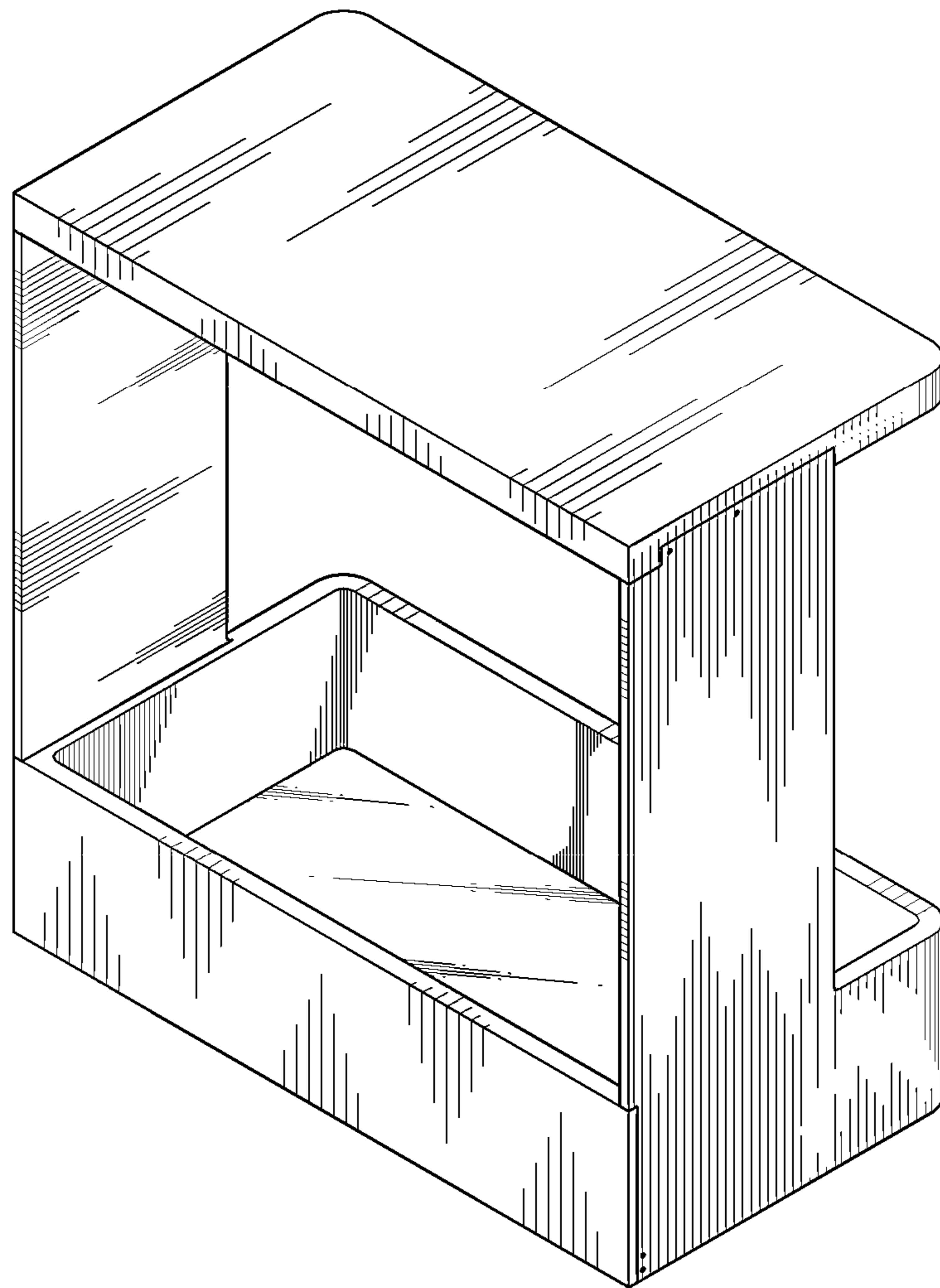

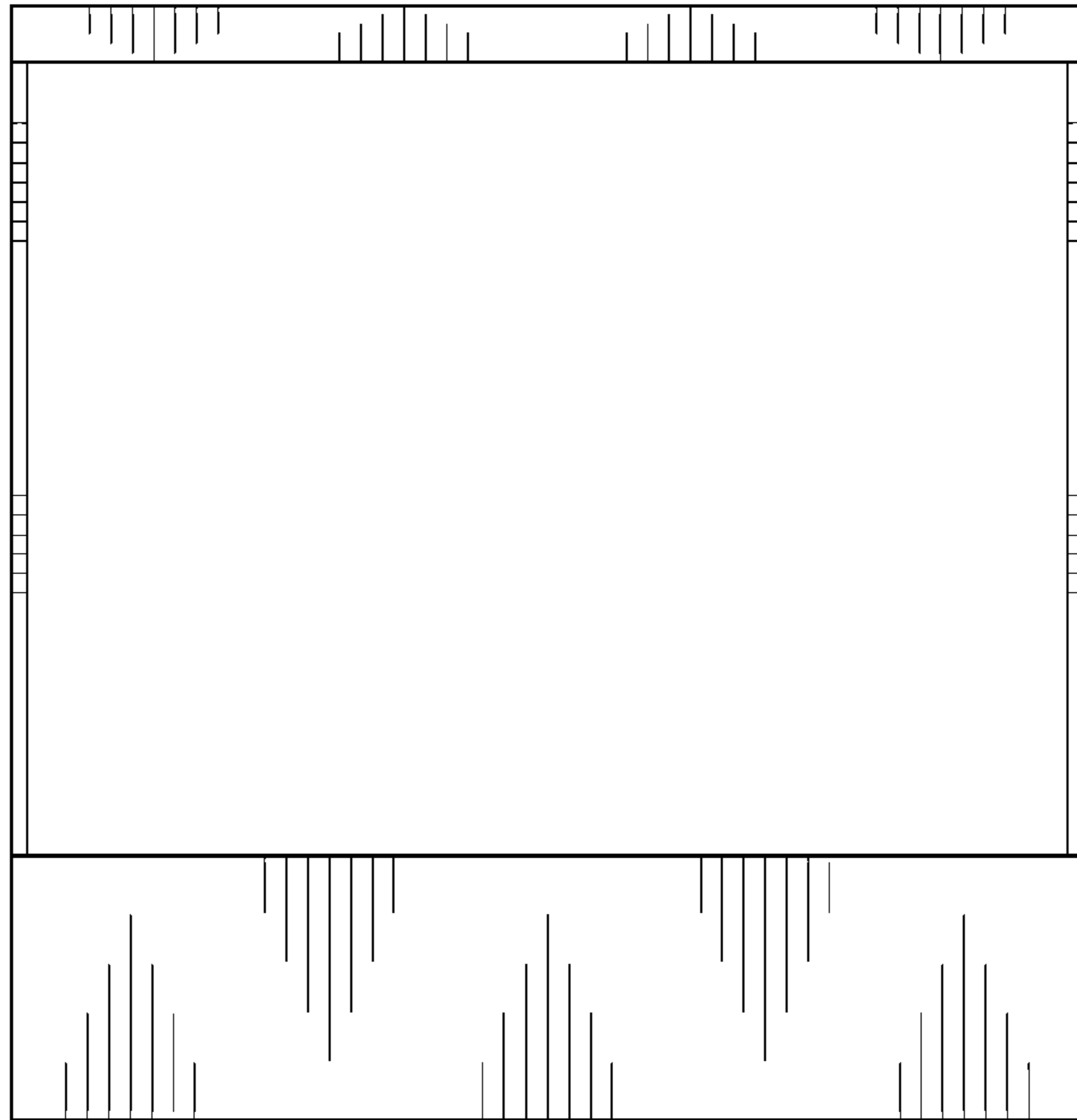

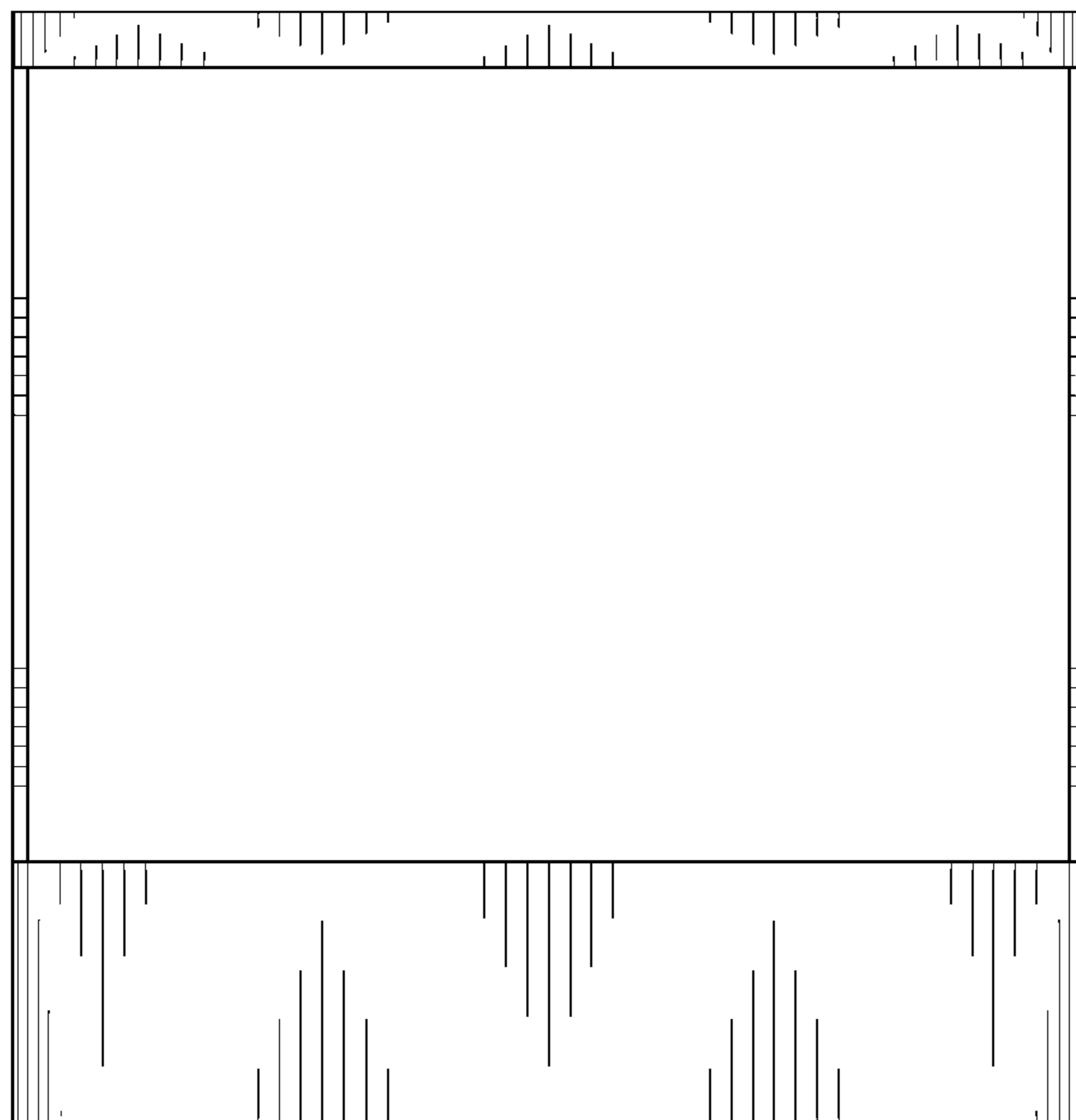

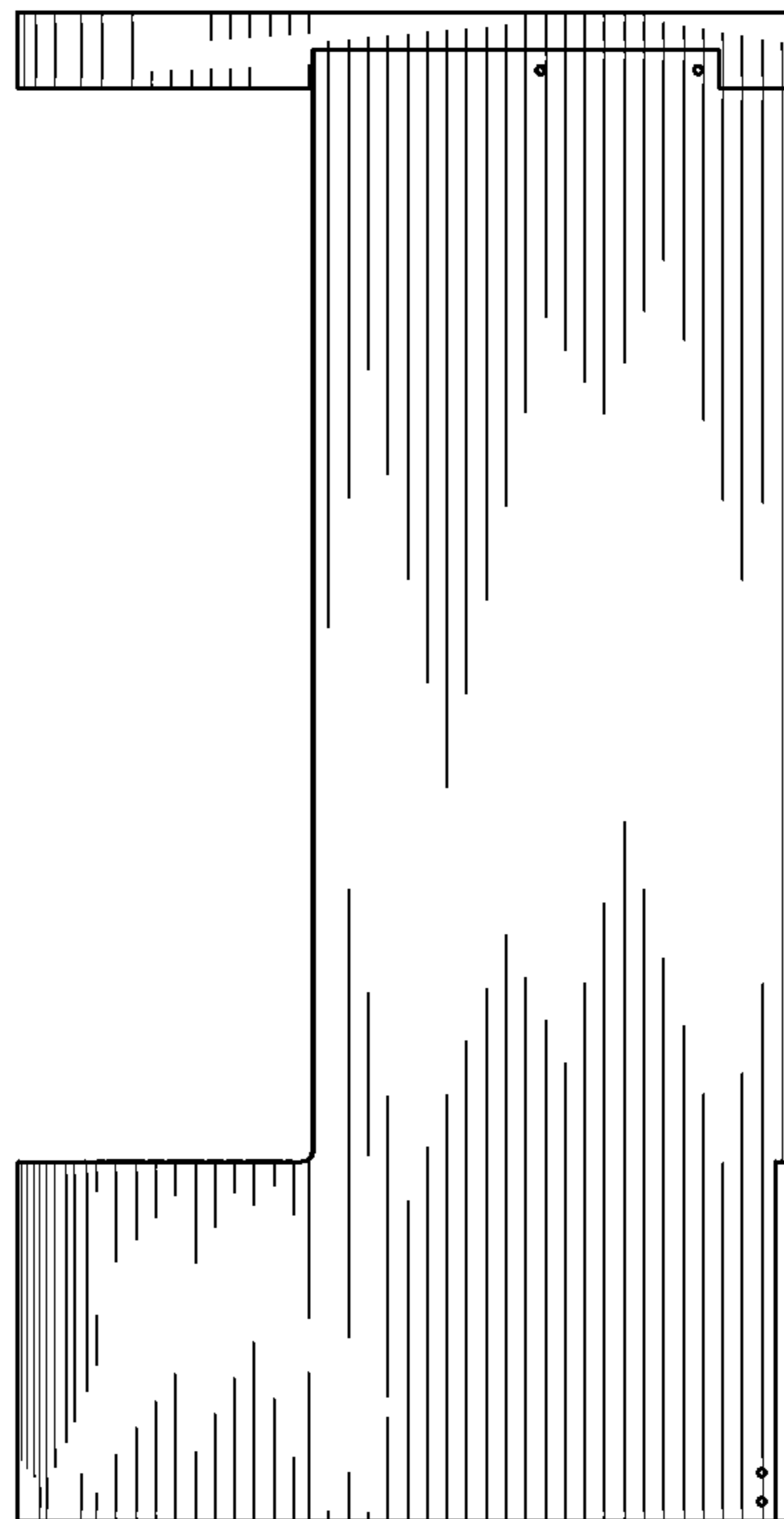

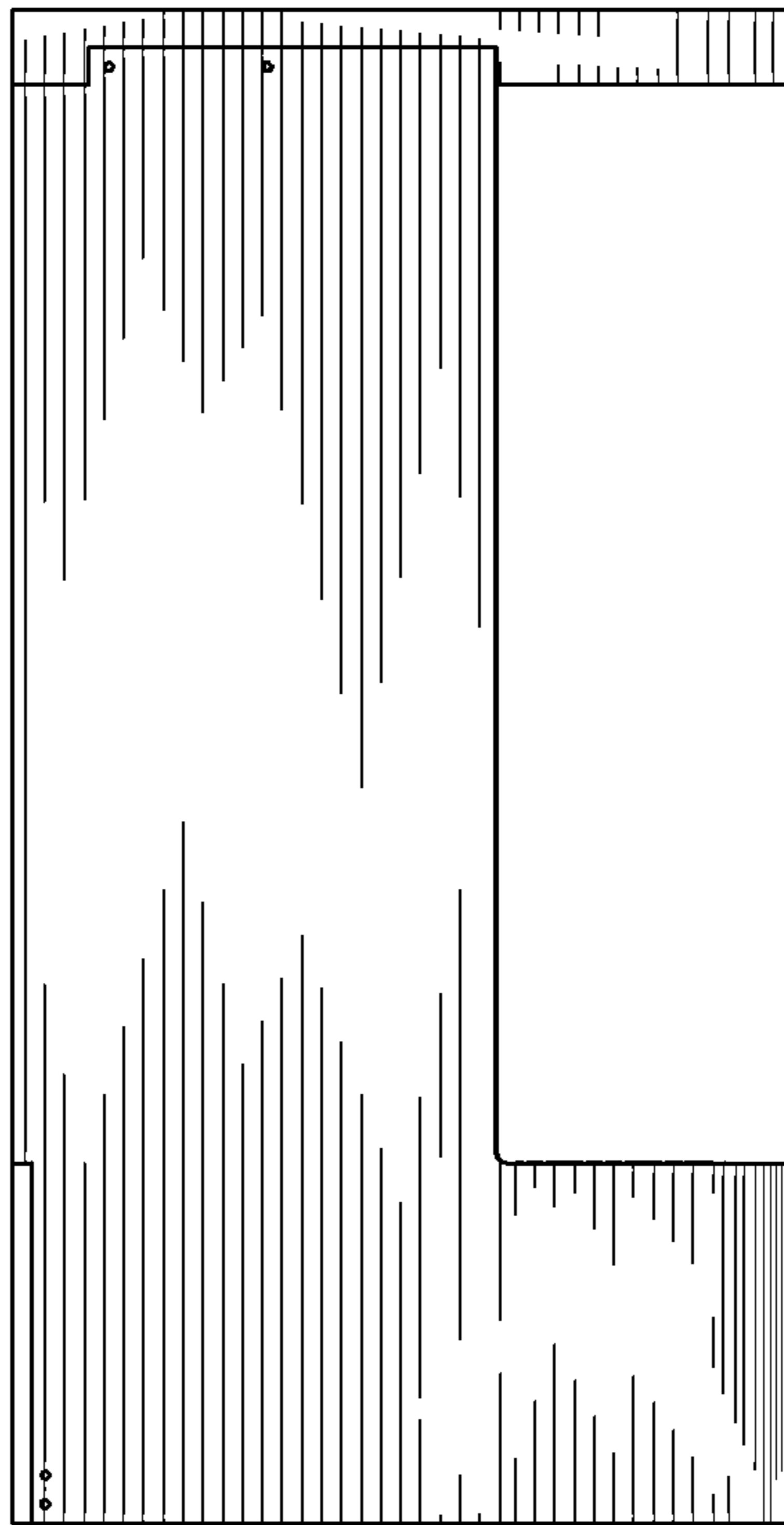

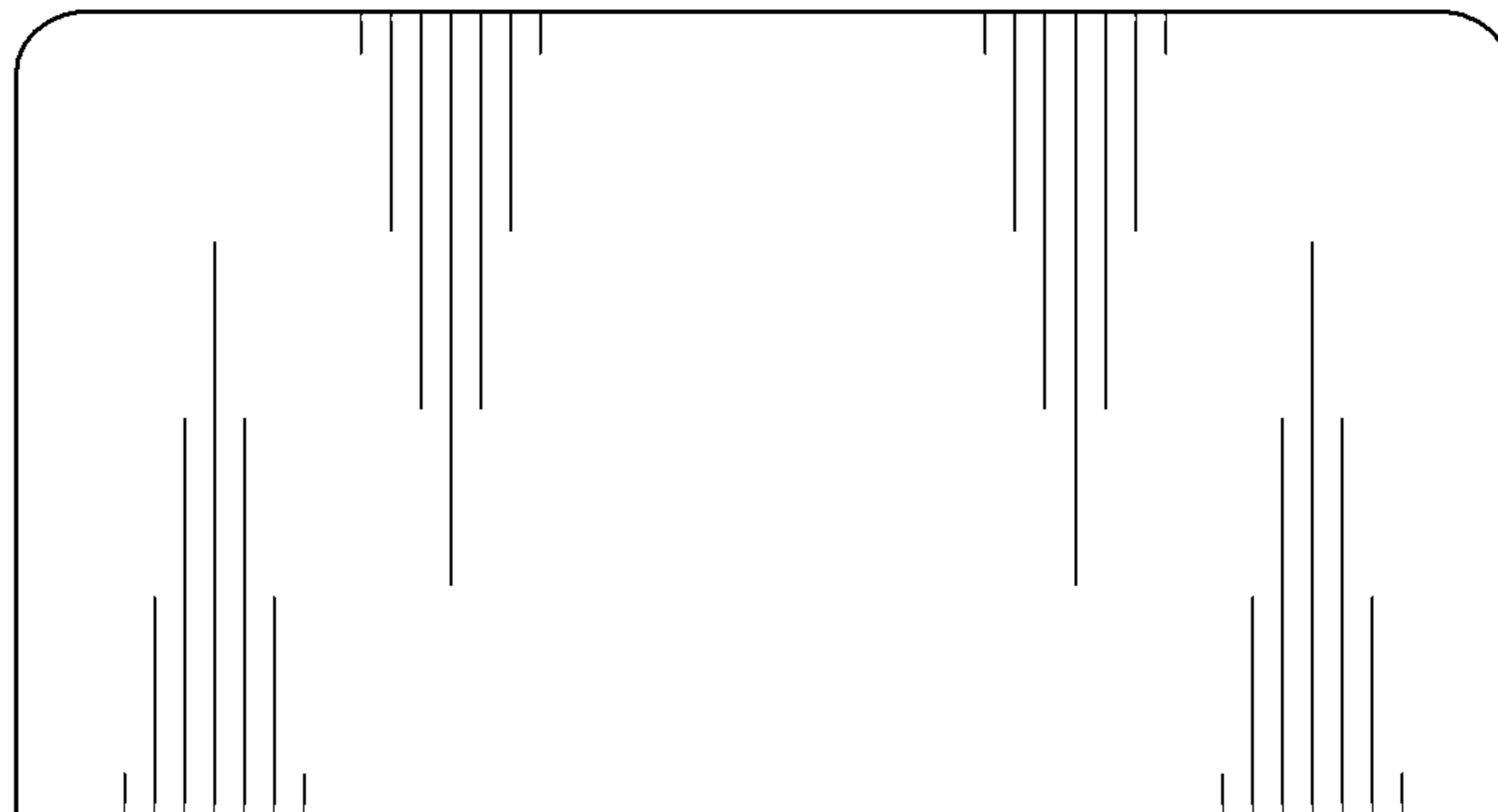

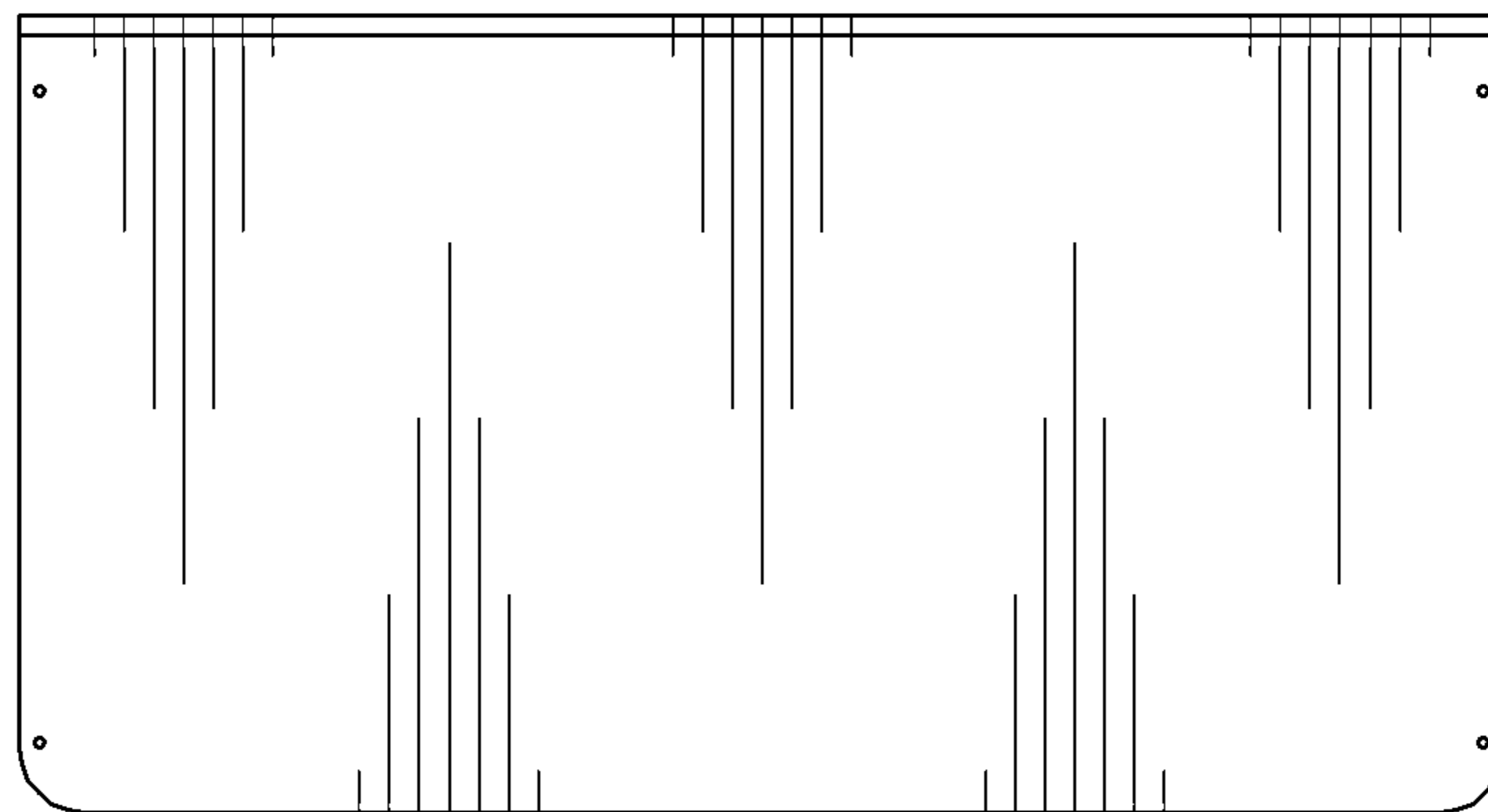
