(57) **CLAIM**

We claim the ornamental design for a refrigerator basket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refrigerator basket showing the new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left-side elevation view thereof;
FIG. 5 is a right-side elevation view thereof;
FIG. 6 is a top plan view thereof; and
FIG. 7 is a bottom plan view thereof; and
FIG. 8 is a perspective view thereof, the lid shown in an alternate open position.

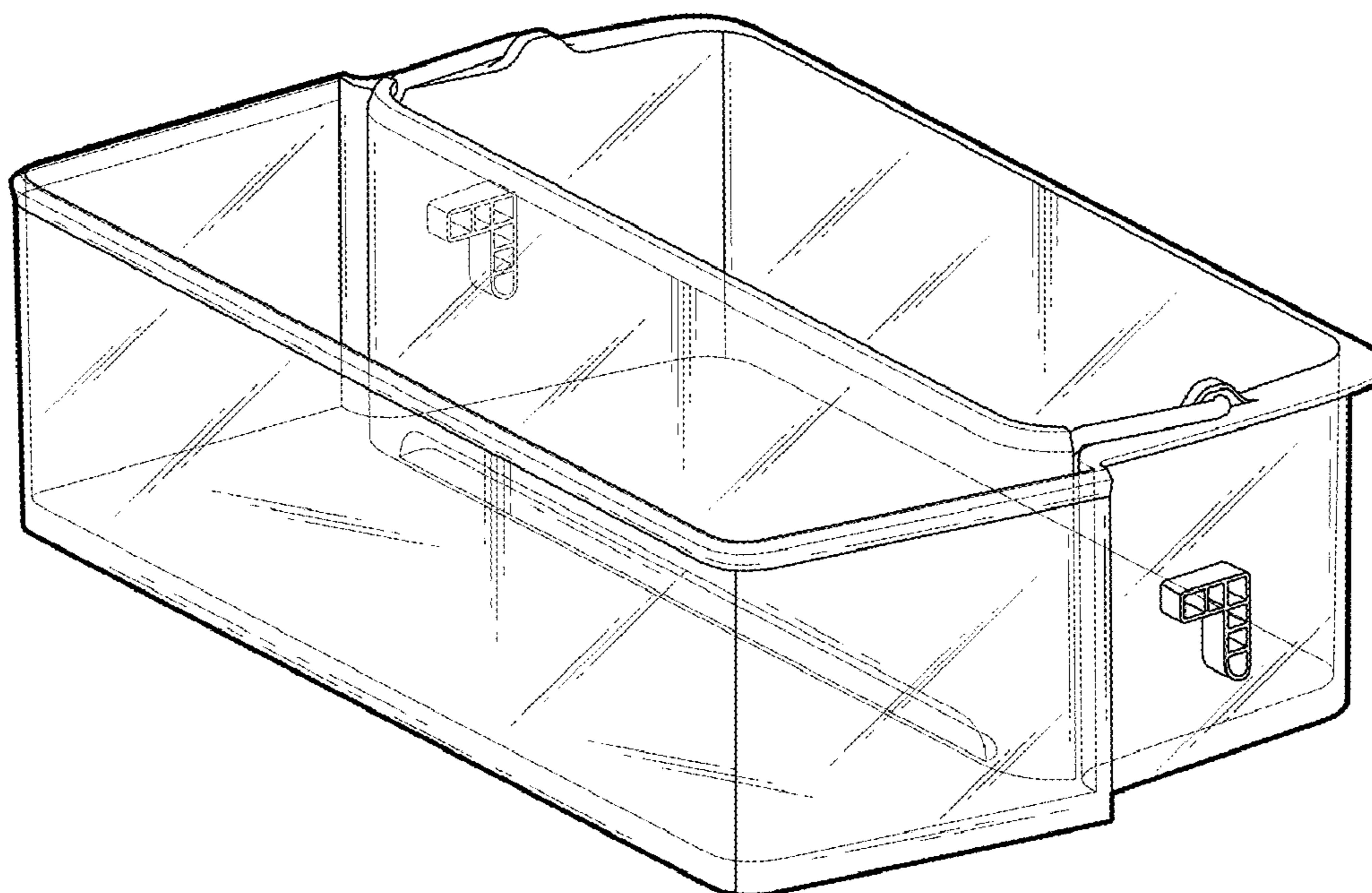

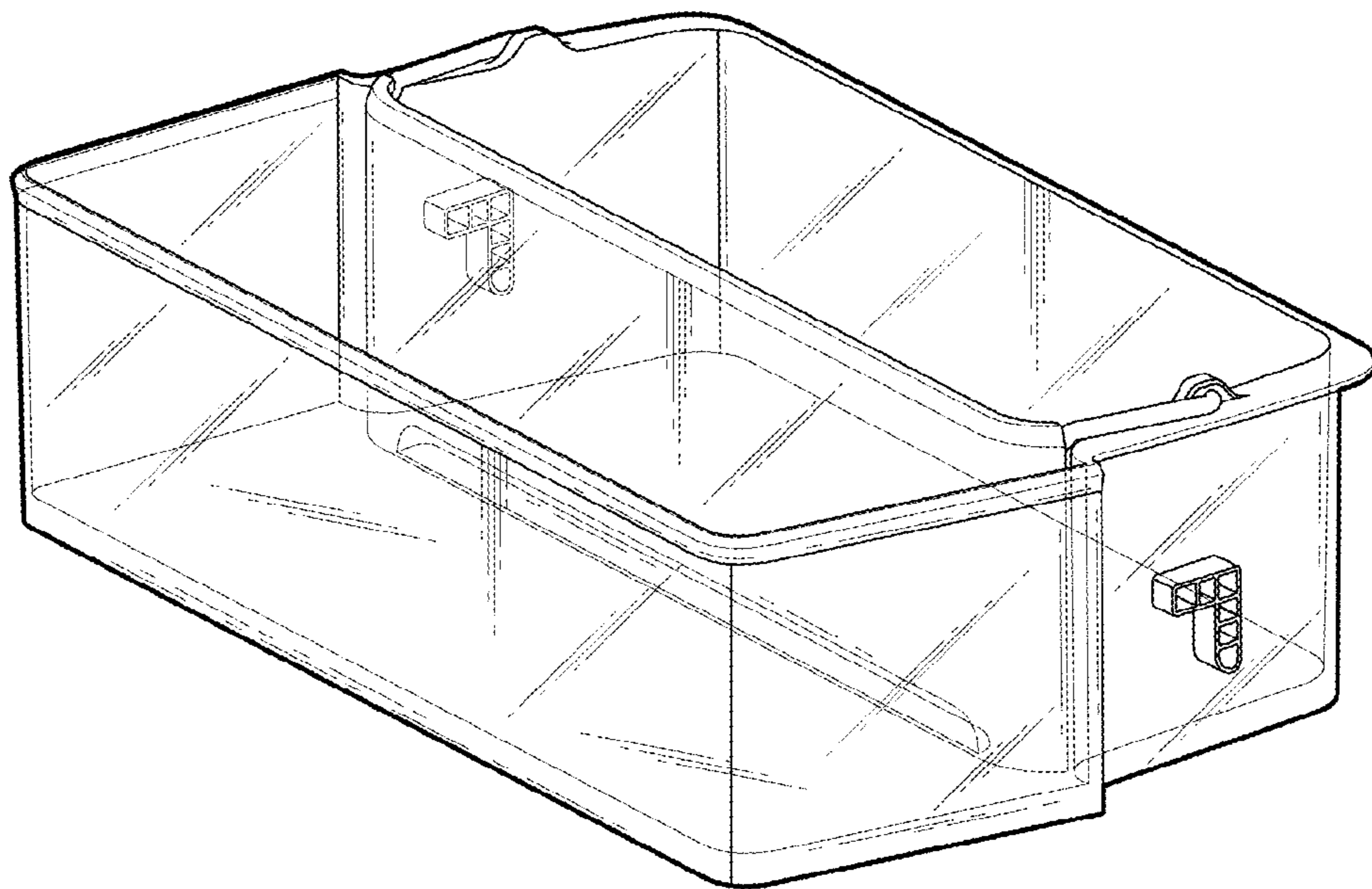

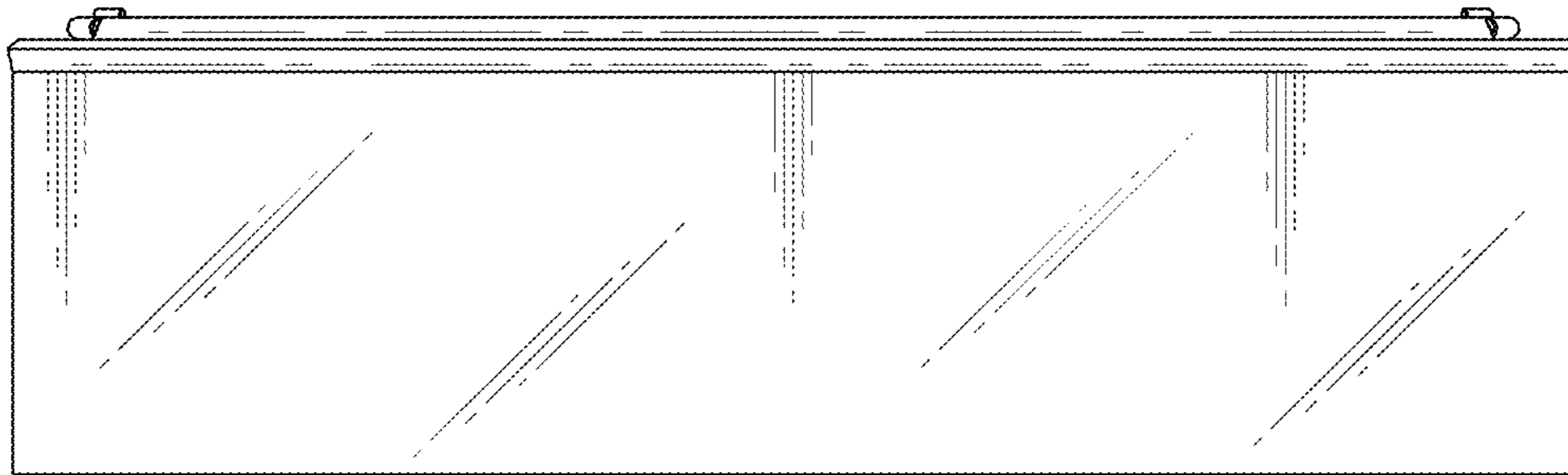

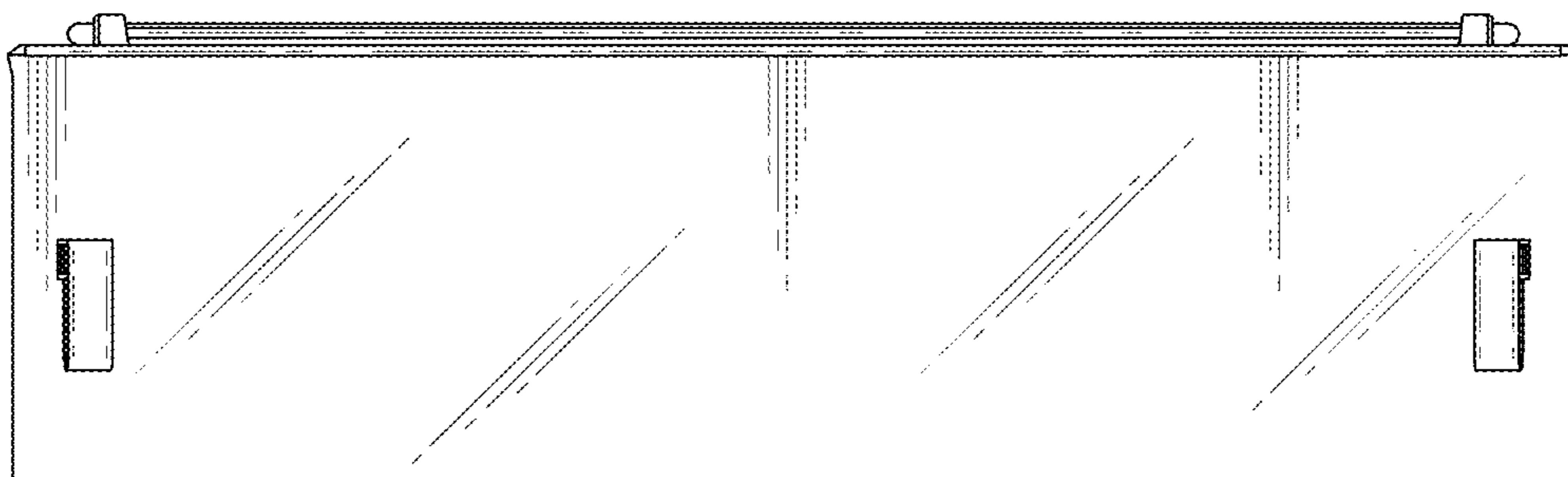

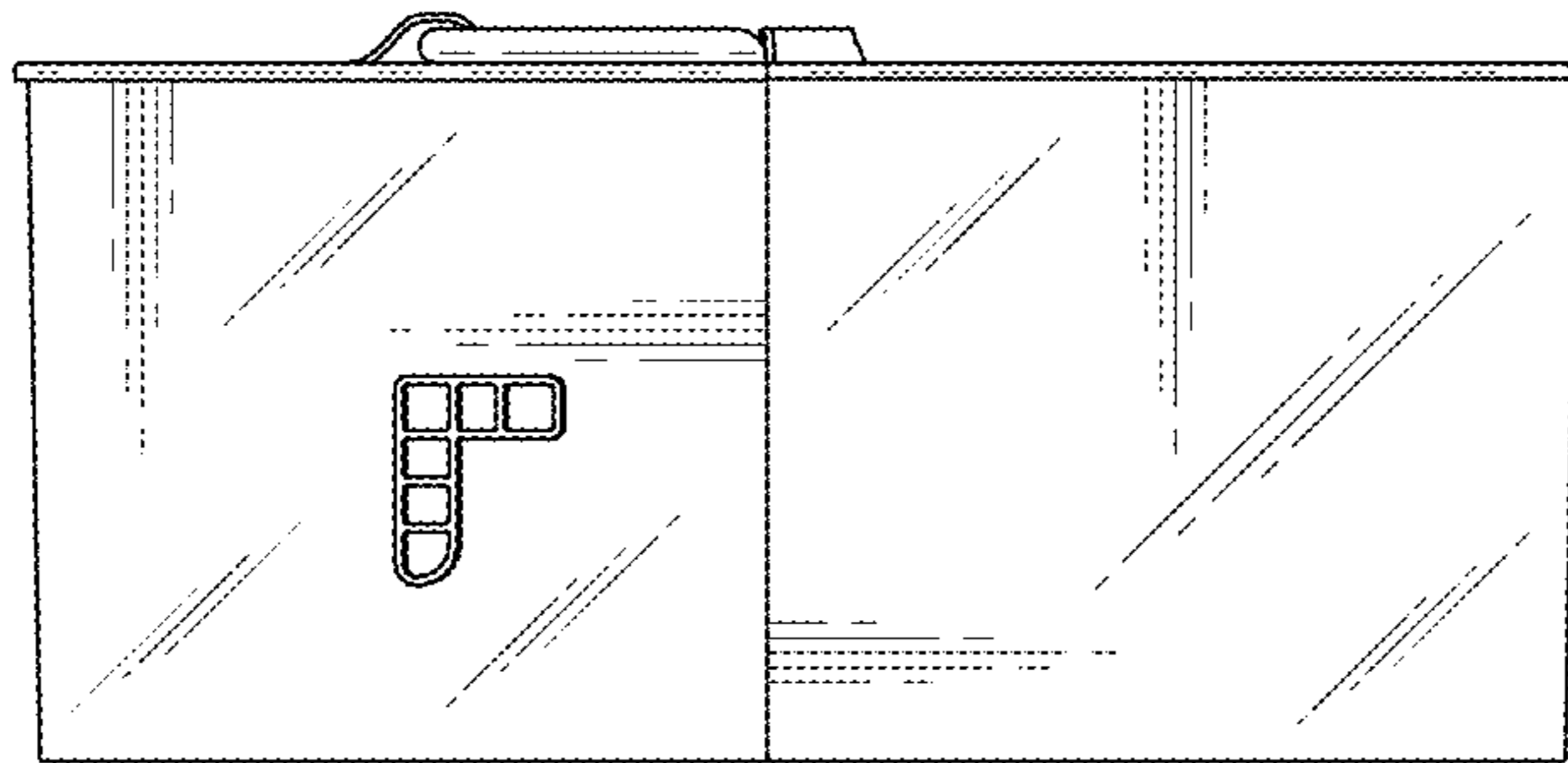

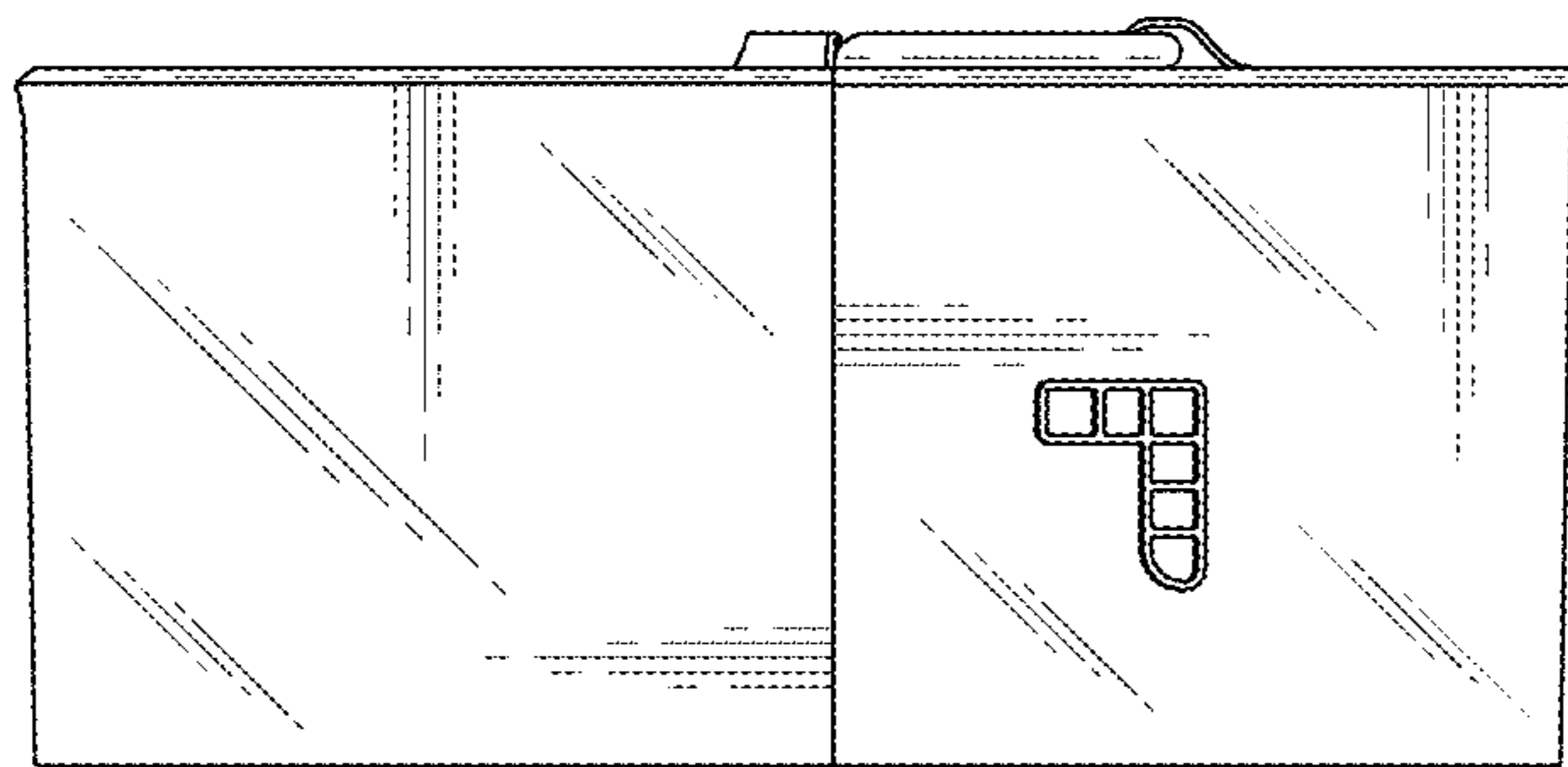

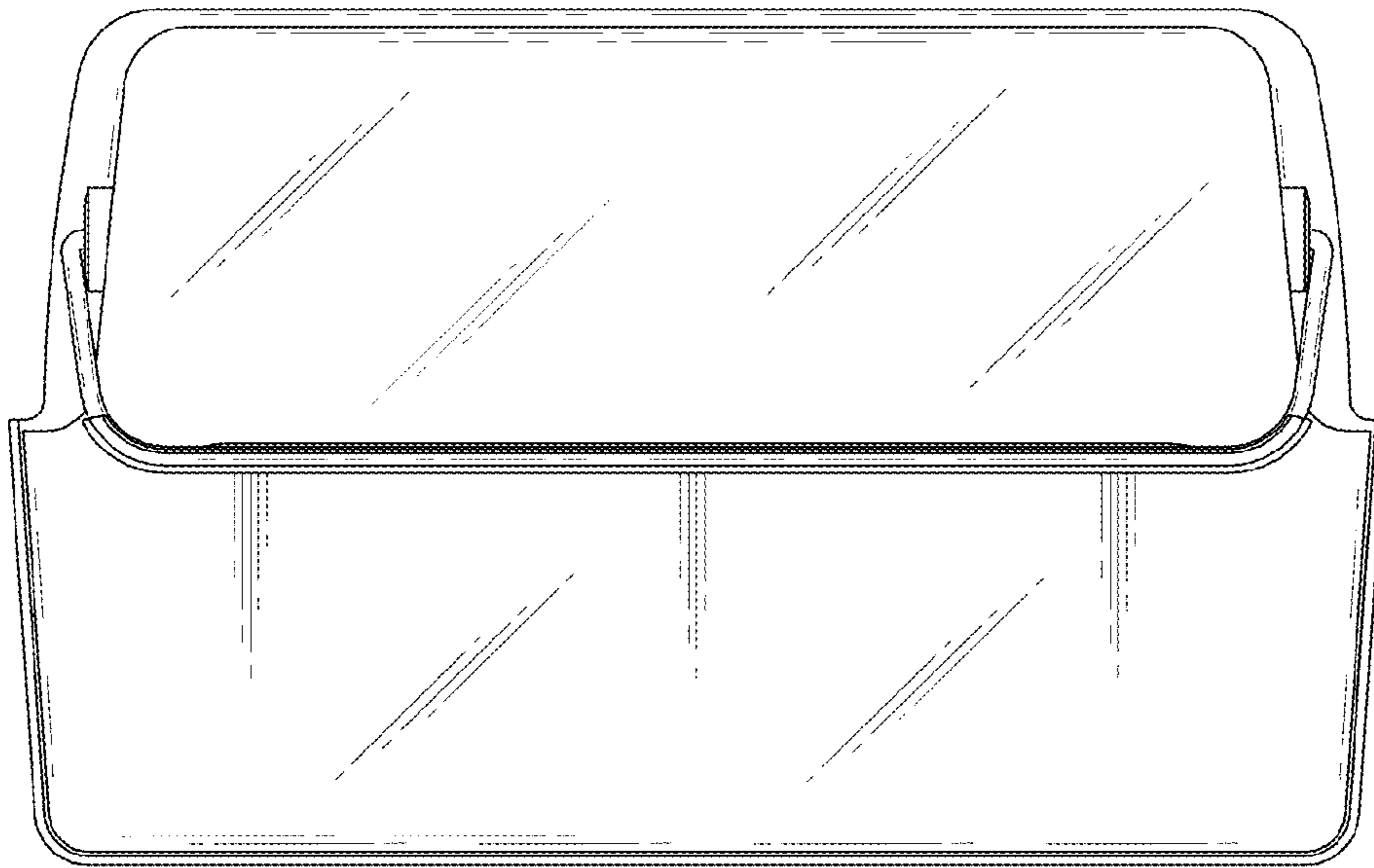

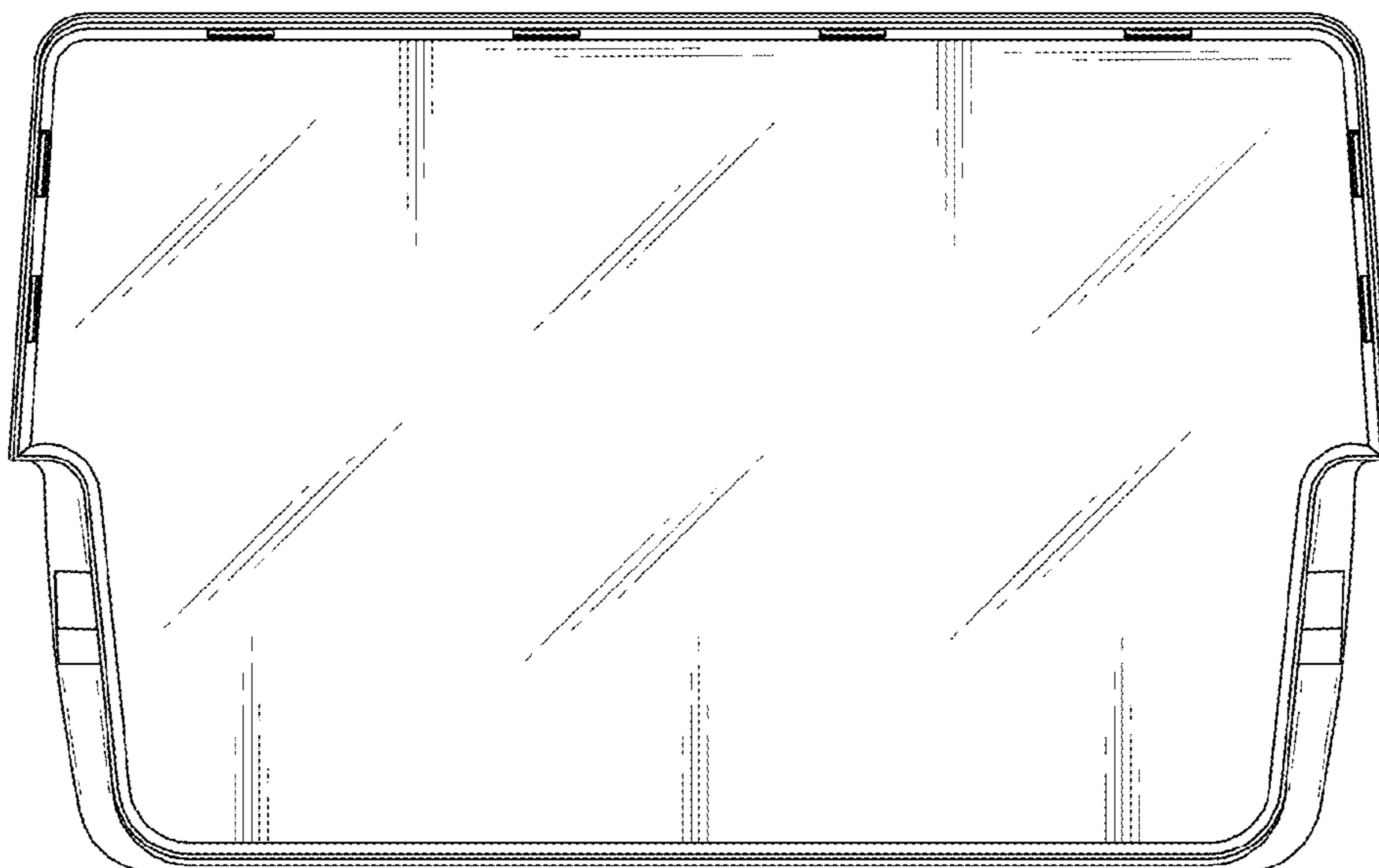
