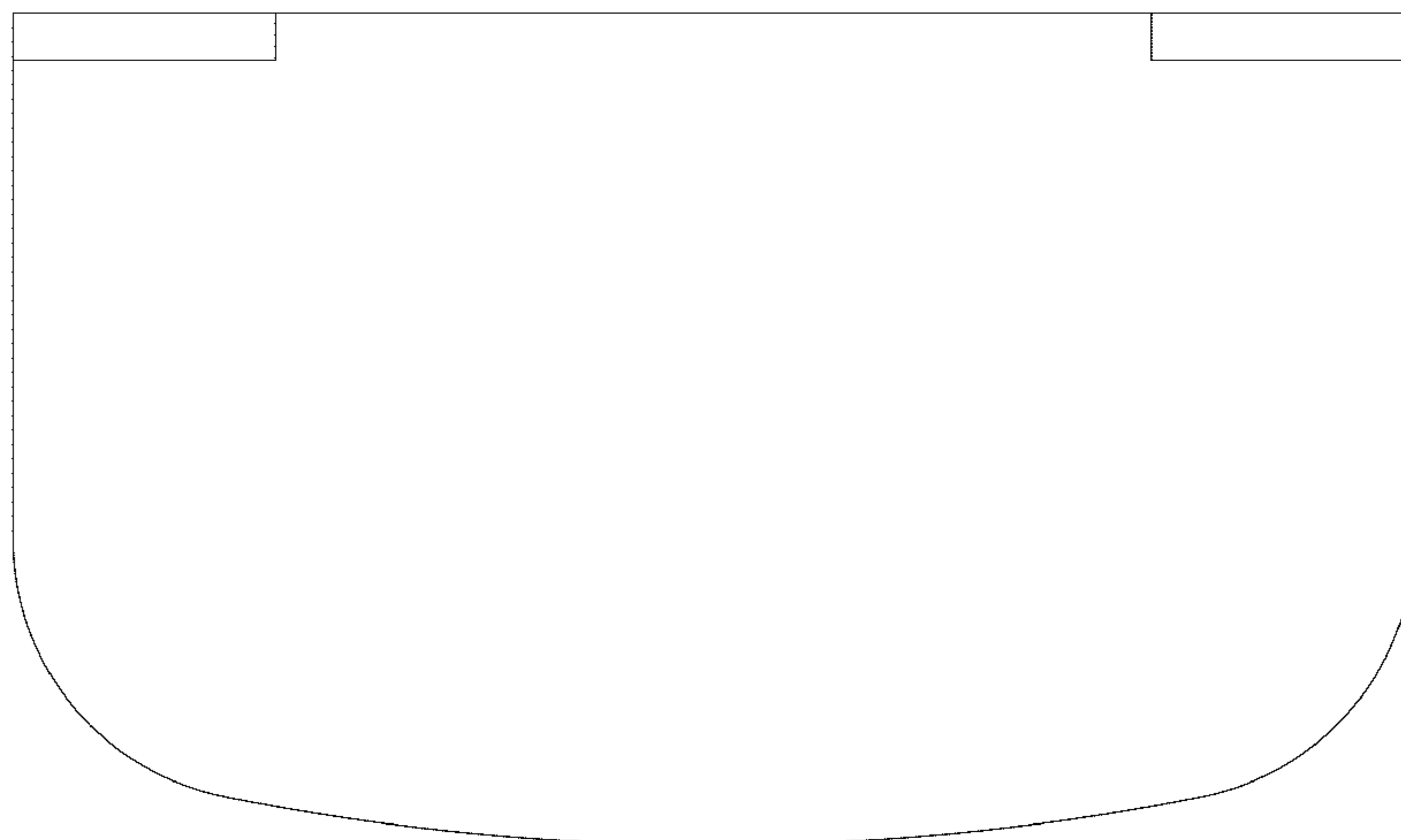
(57) **CLAIM**

The ornamental design for a fabric sunshade accessory for use with glasses, as shown and described.

DESCRIPTION

FIG. 1 is a front plan view of the fabric sunshade accessory for use with glasses;
FIG. 2 is a rear plan view thereof;
FIG. 3 is a first end view thereof;
FIG. 4 is a second end view thereof;
FIG. 5 is a side view thereof, the opposite side being identical;
FIG. 6 perspective view of the fabric sunshade accessory for use with glasses assembled with a pair of glasses; and,
FIG. 7 is a perspective view looking down on the fabric sunshade accessory for use with glasses assembled with a pair of glasses.
The broken lines in FIGS. 6 and 7 represent a pair of glasses that are environmental structure and form no part of the claimed design.

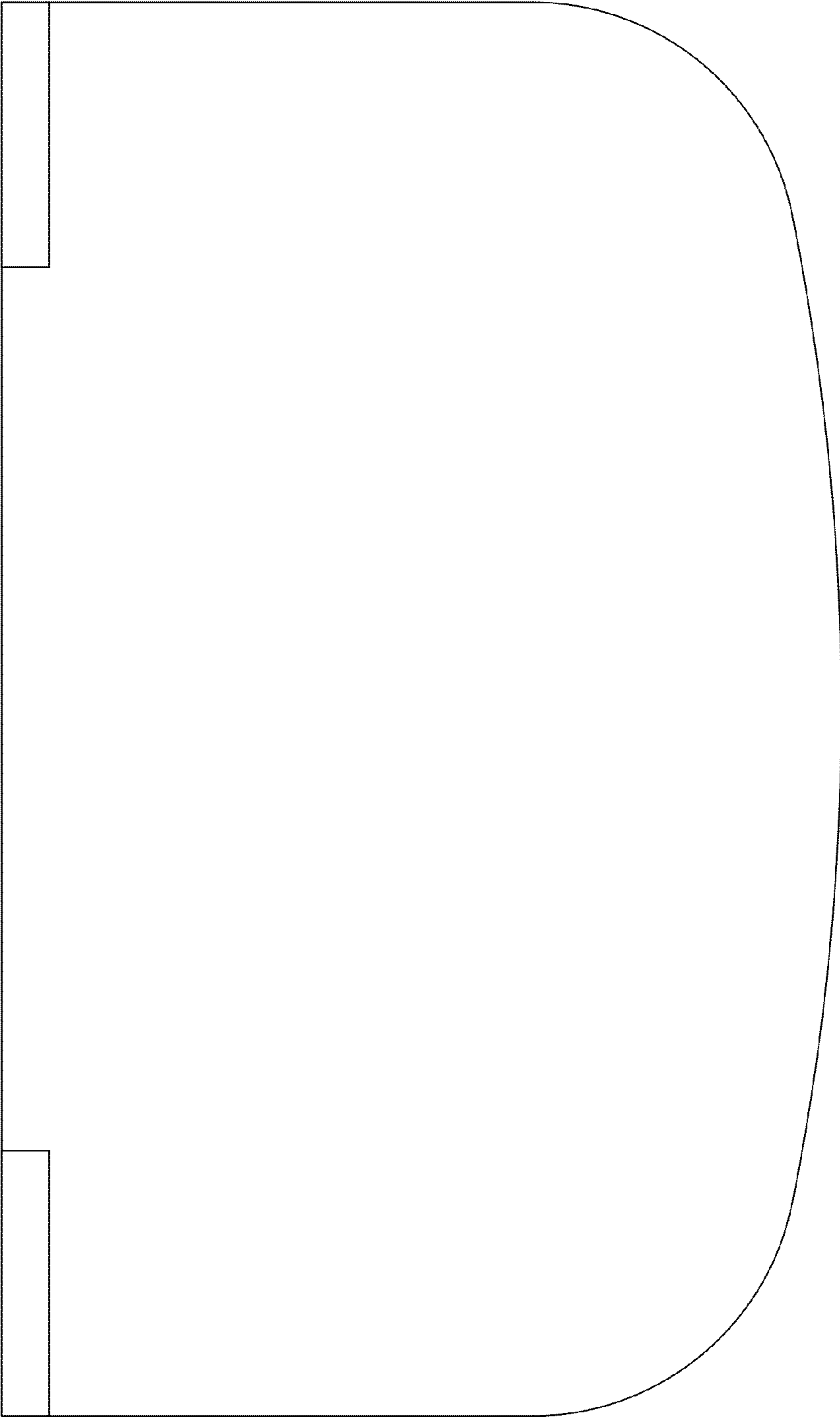

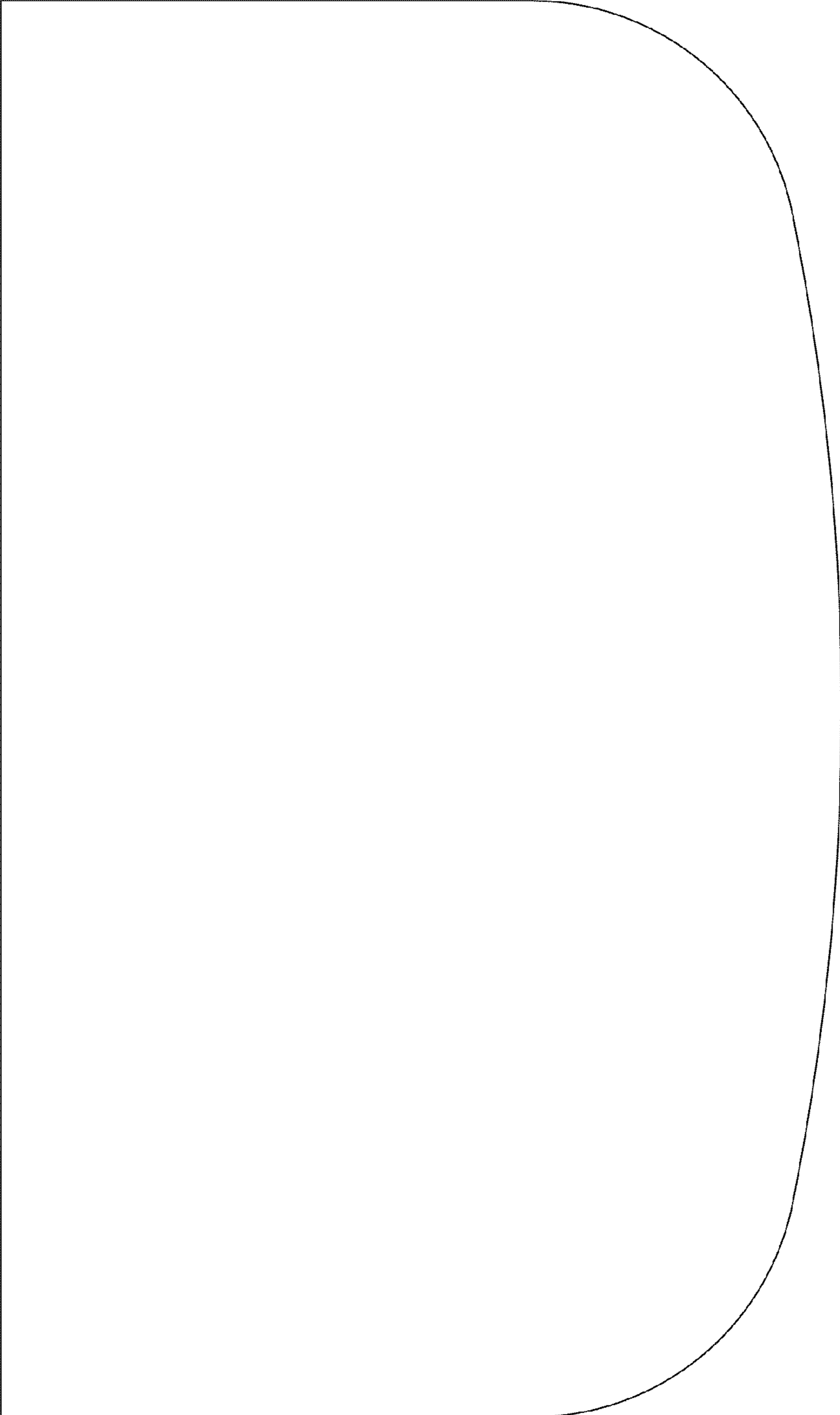

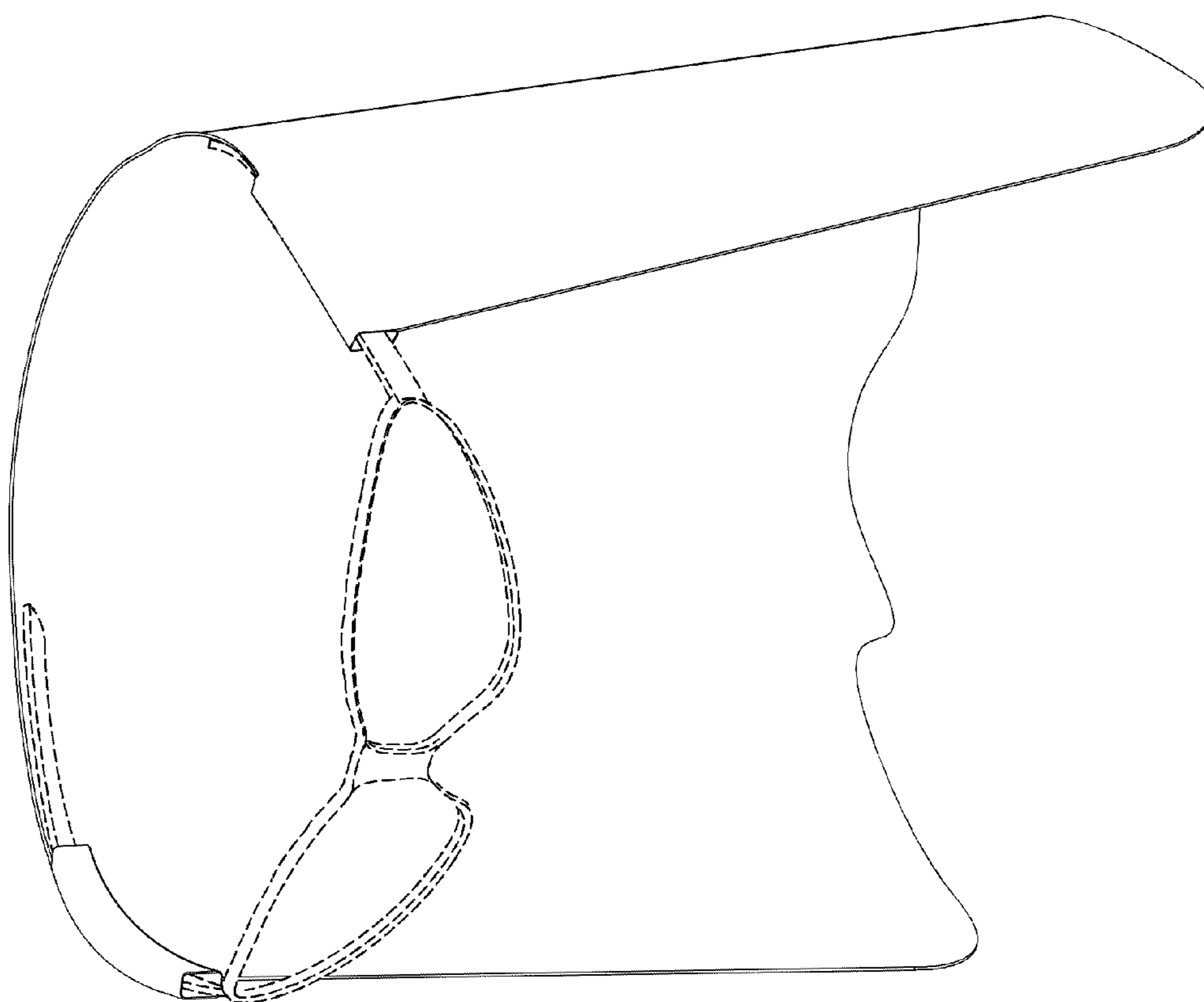

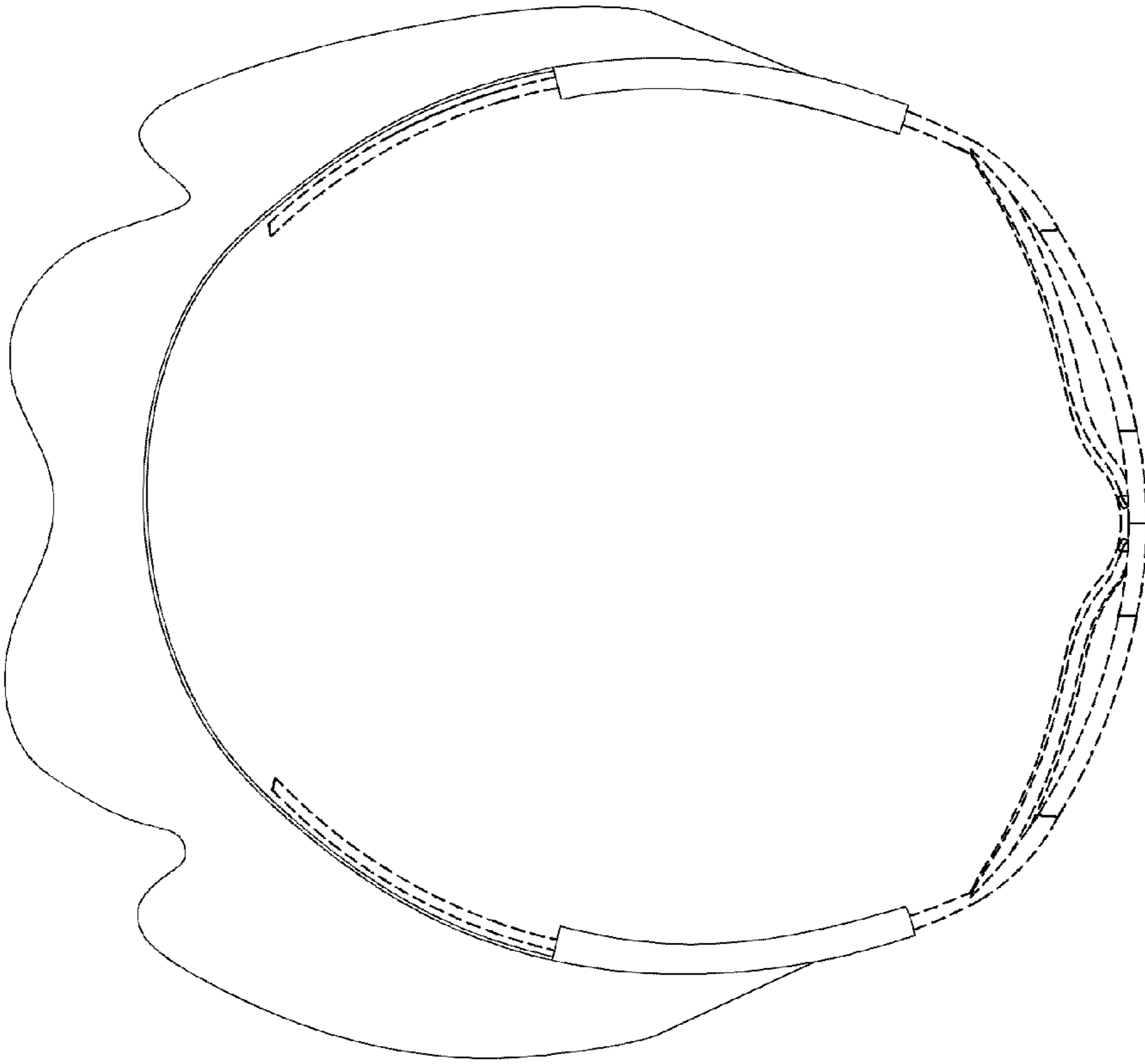
