DESCRIPTION

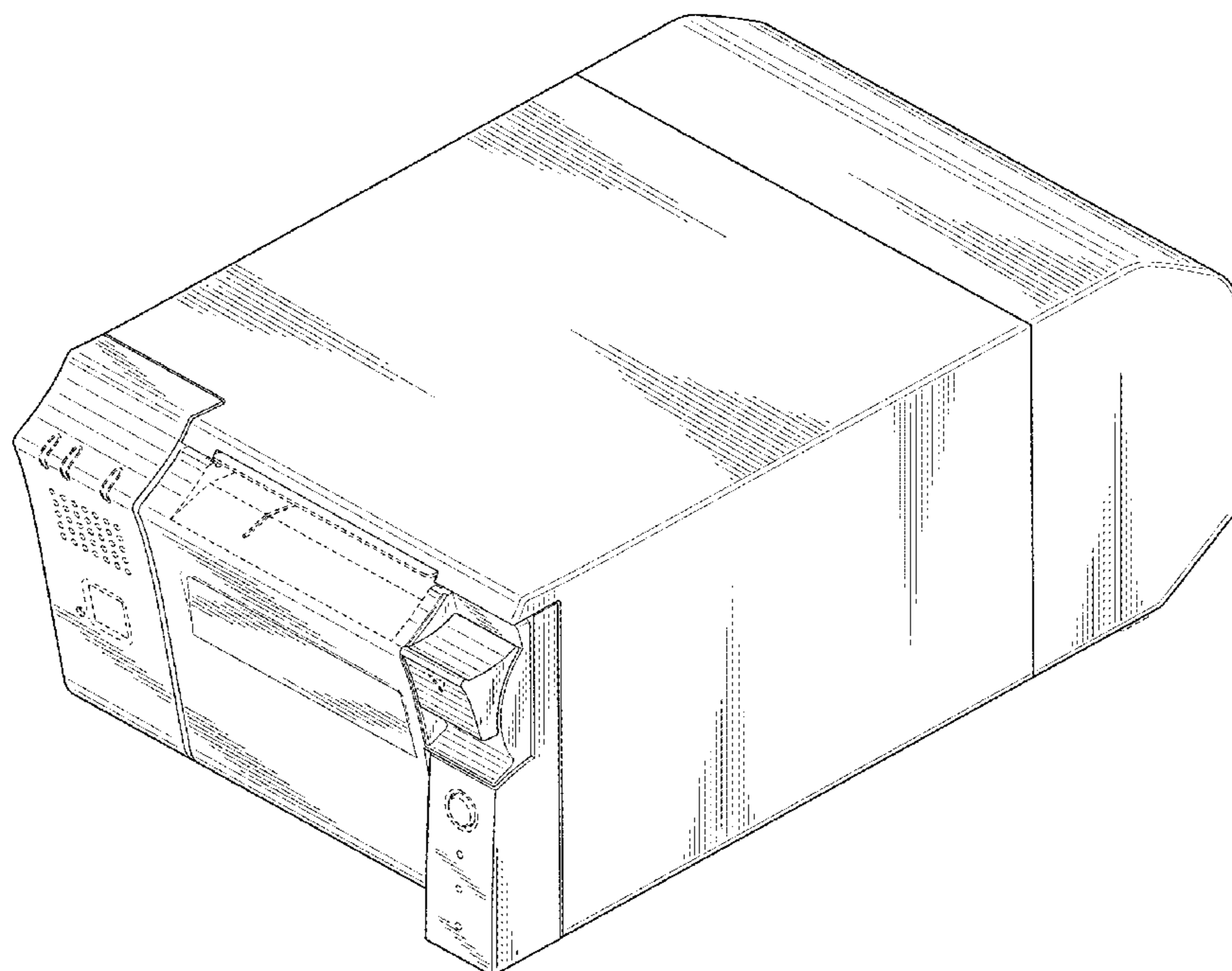

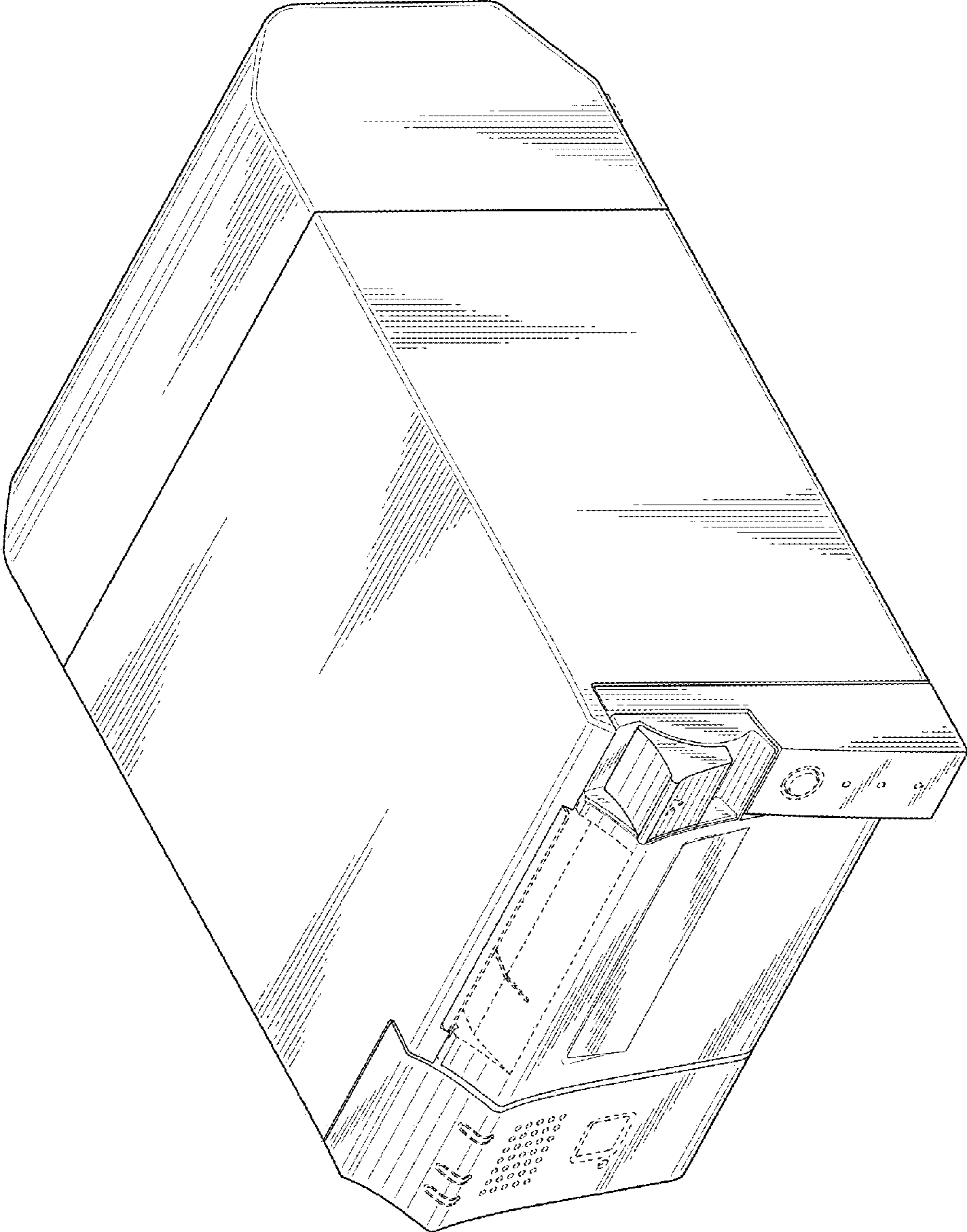

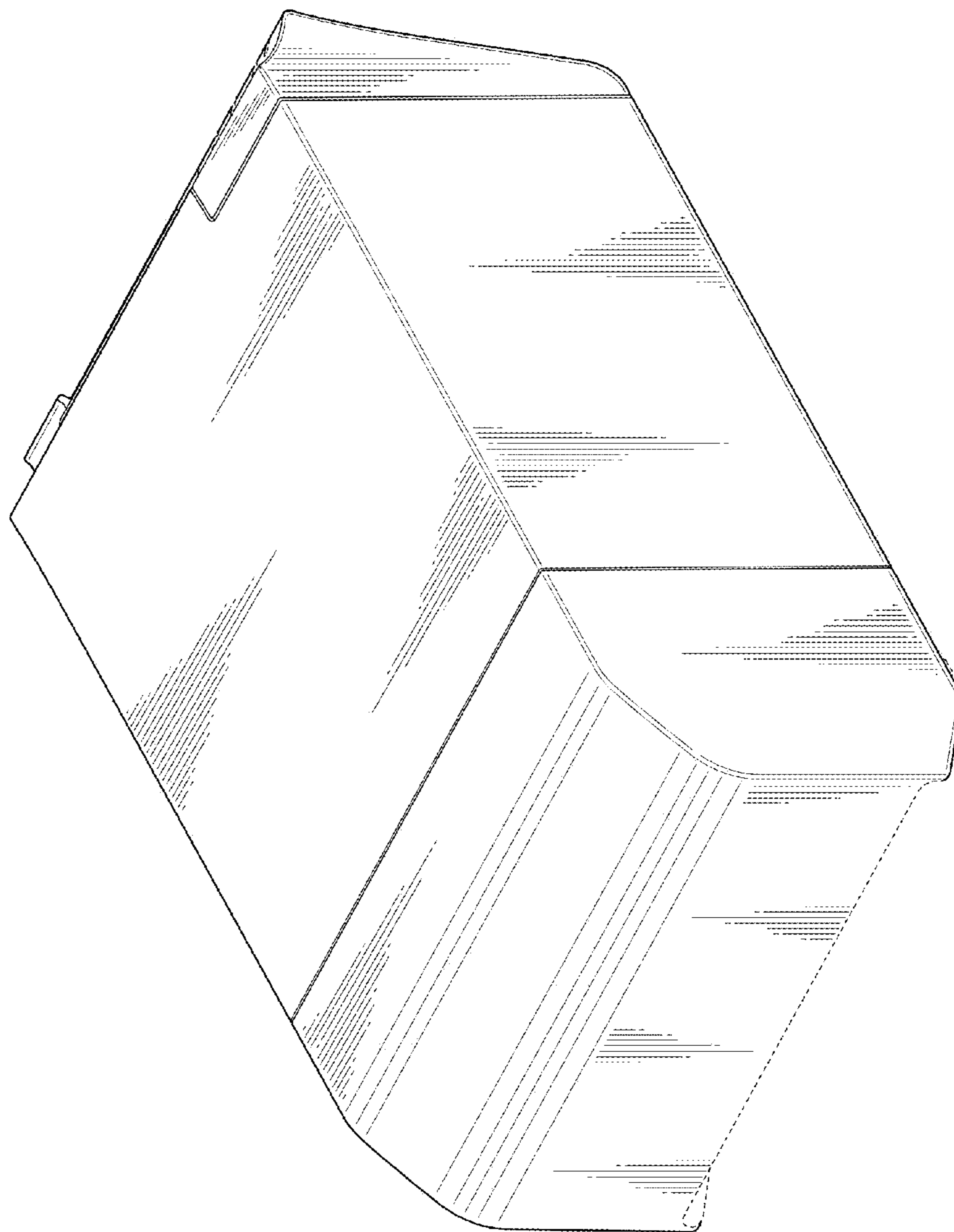

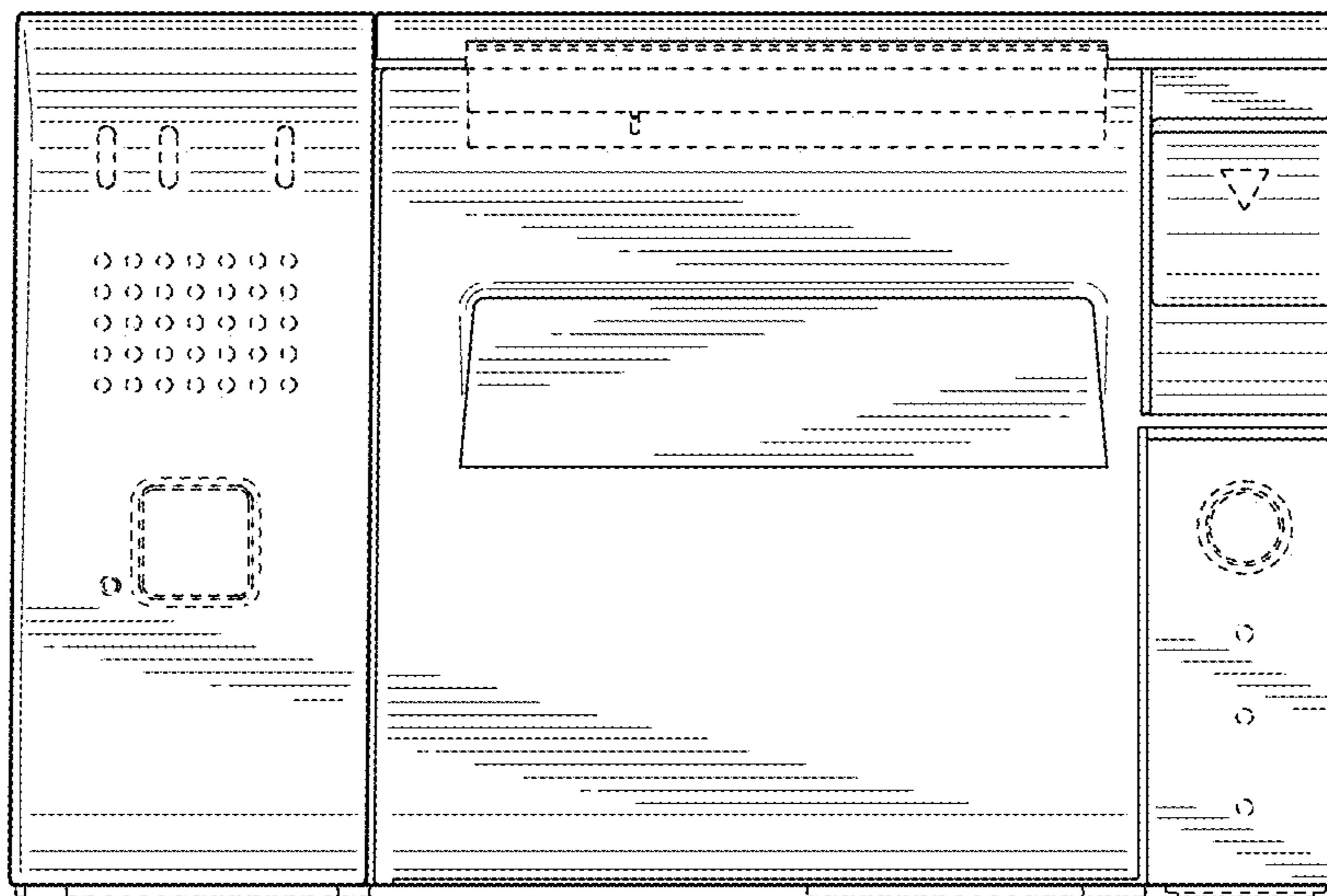

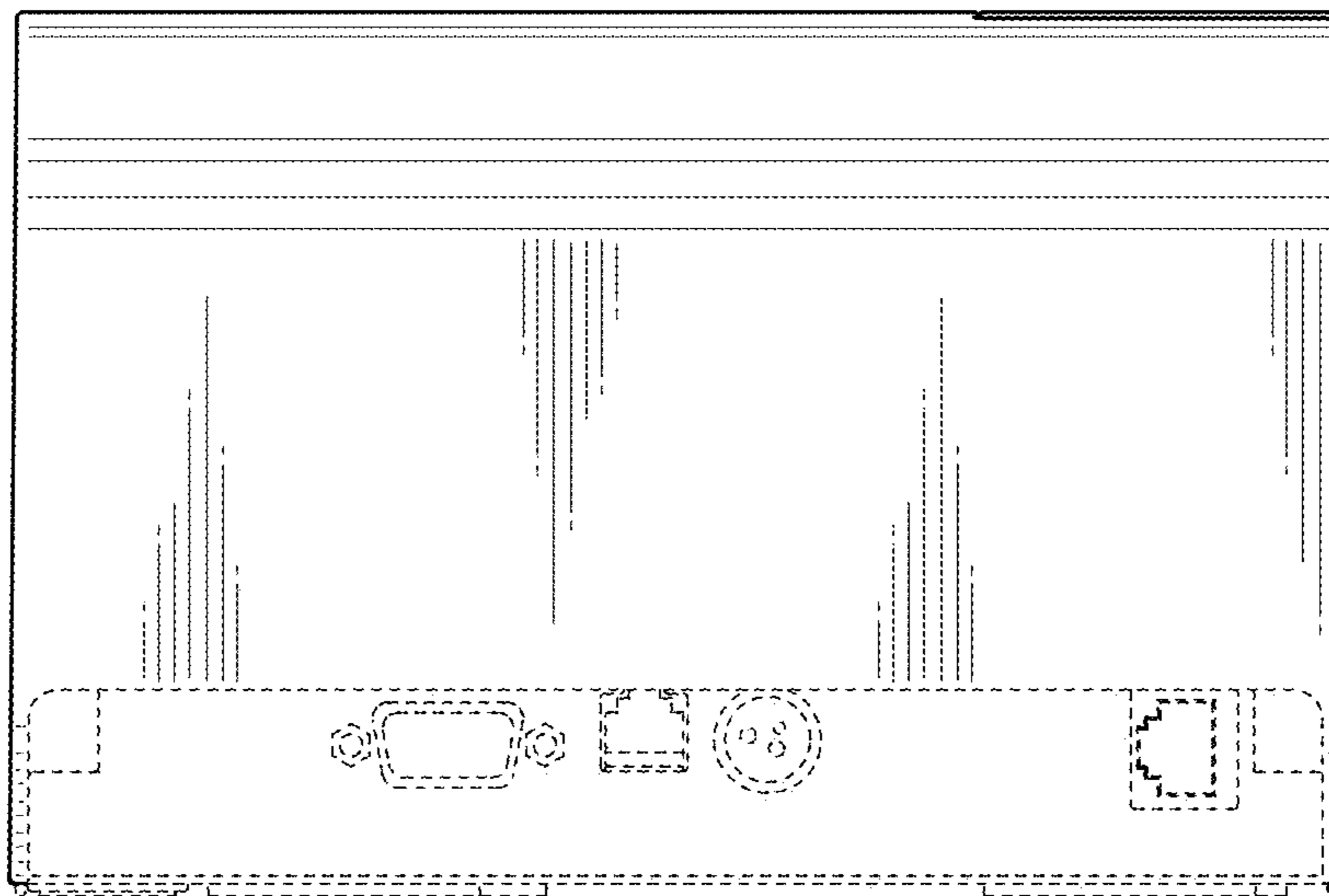

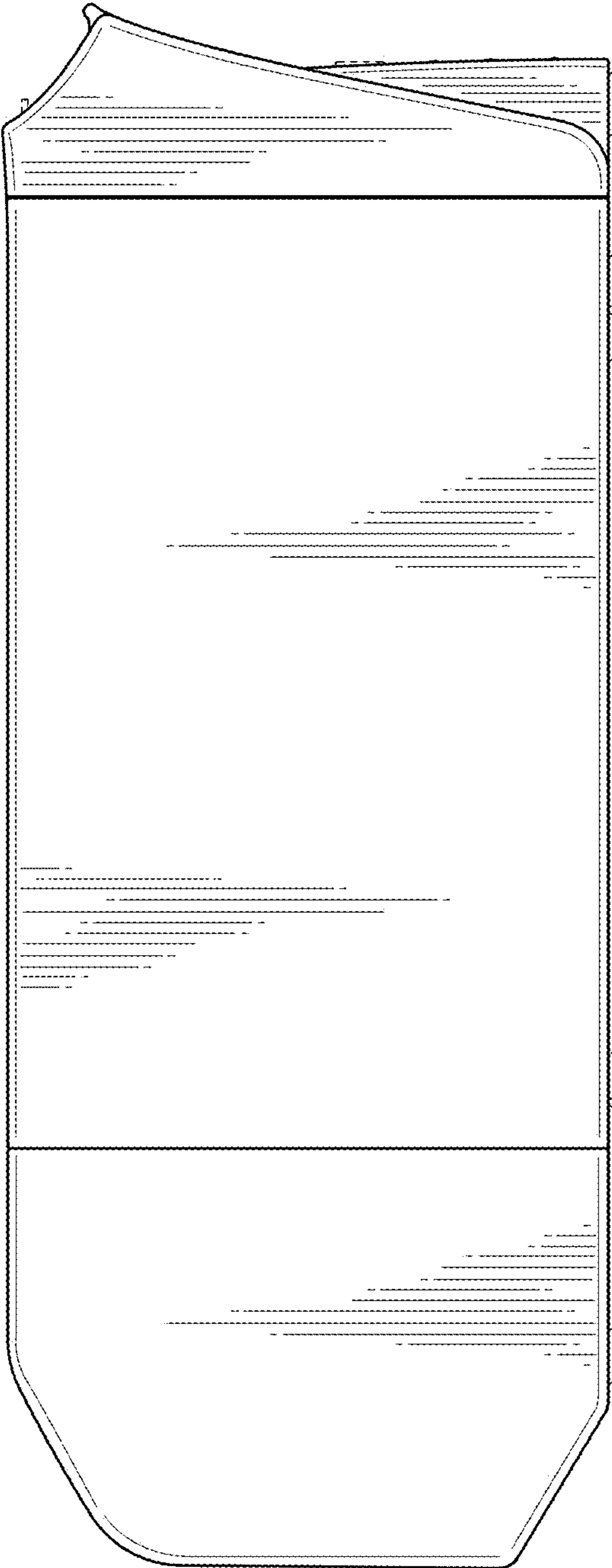

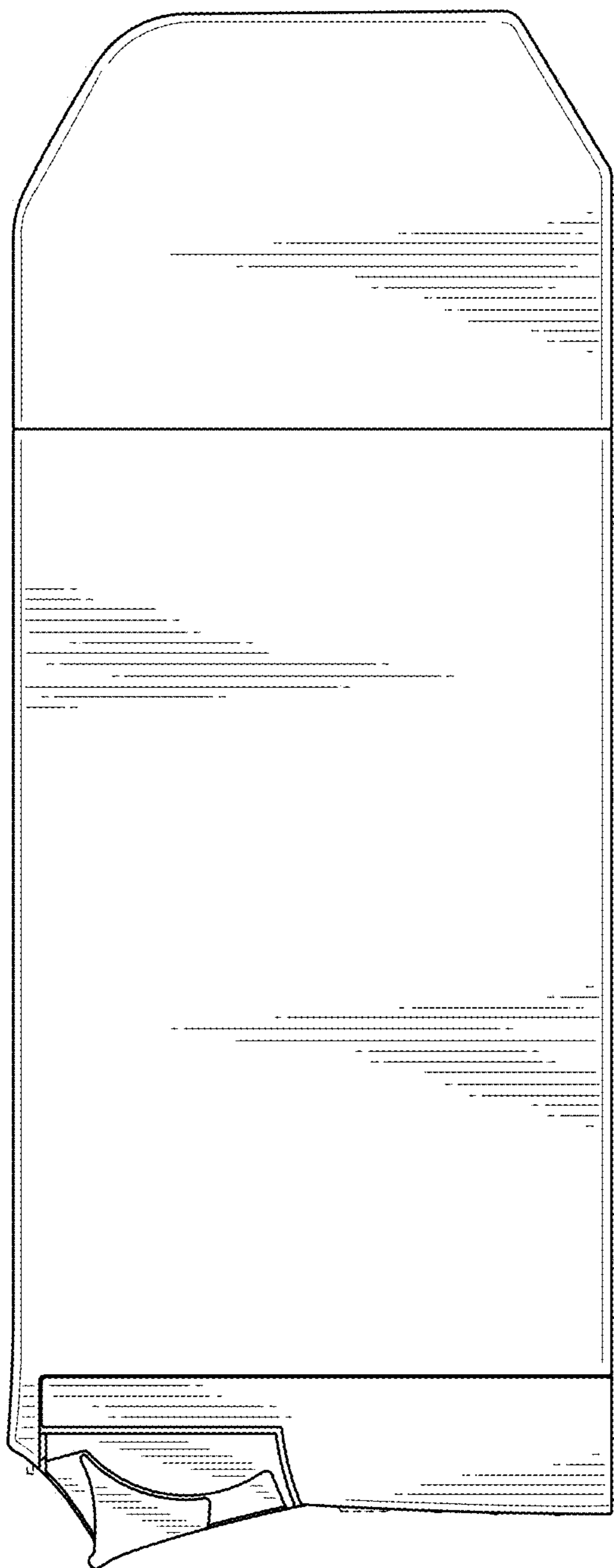

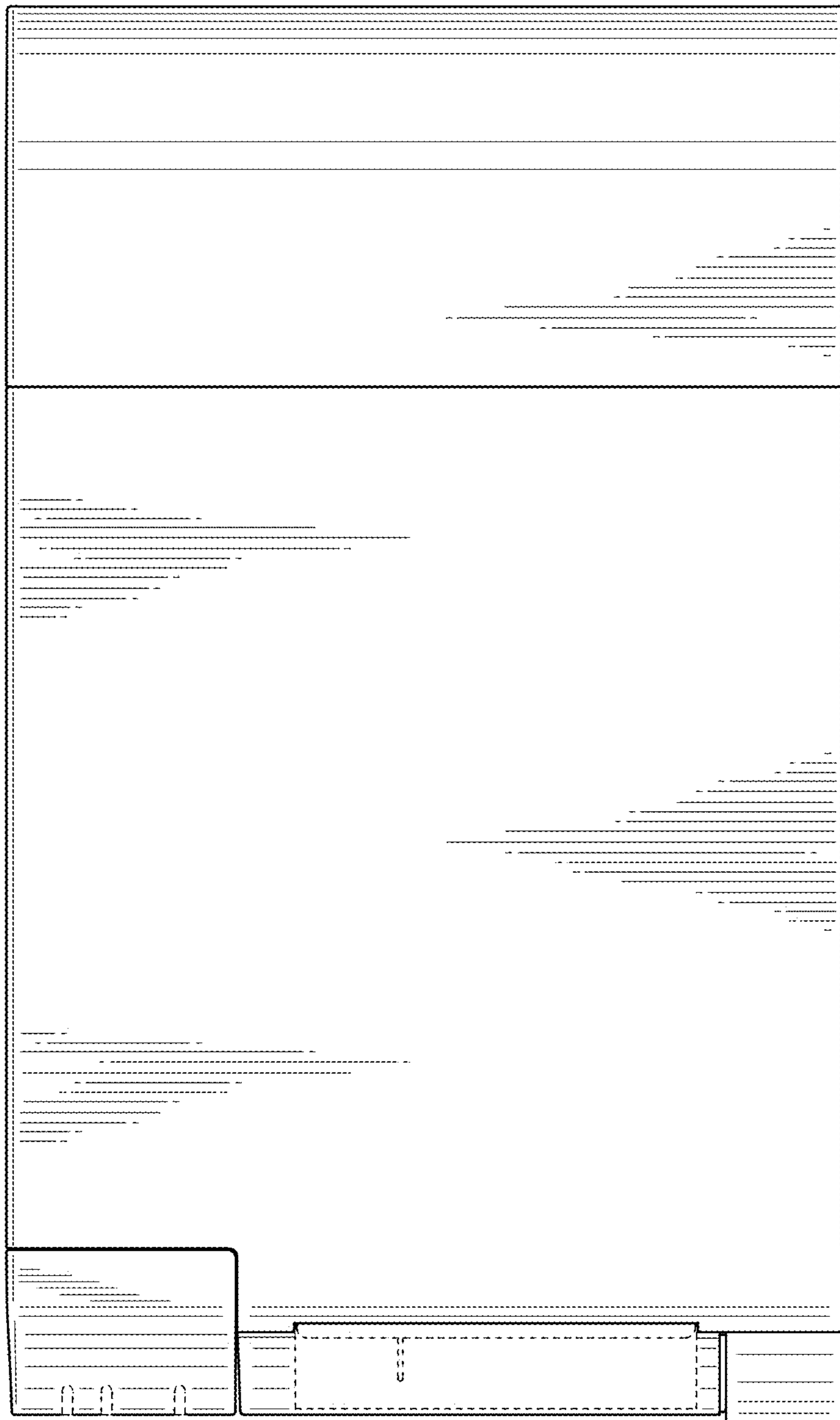
