1;

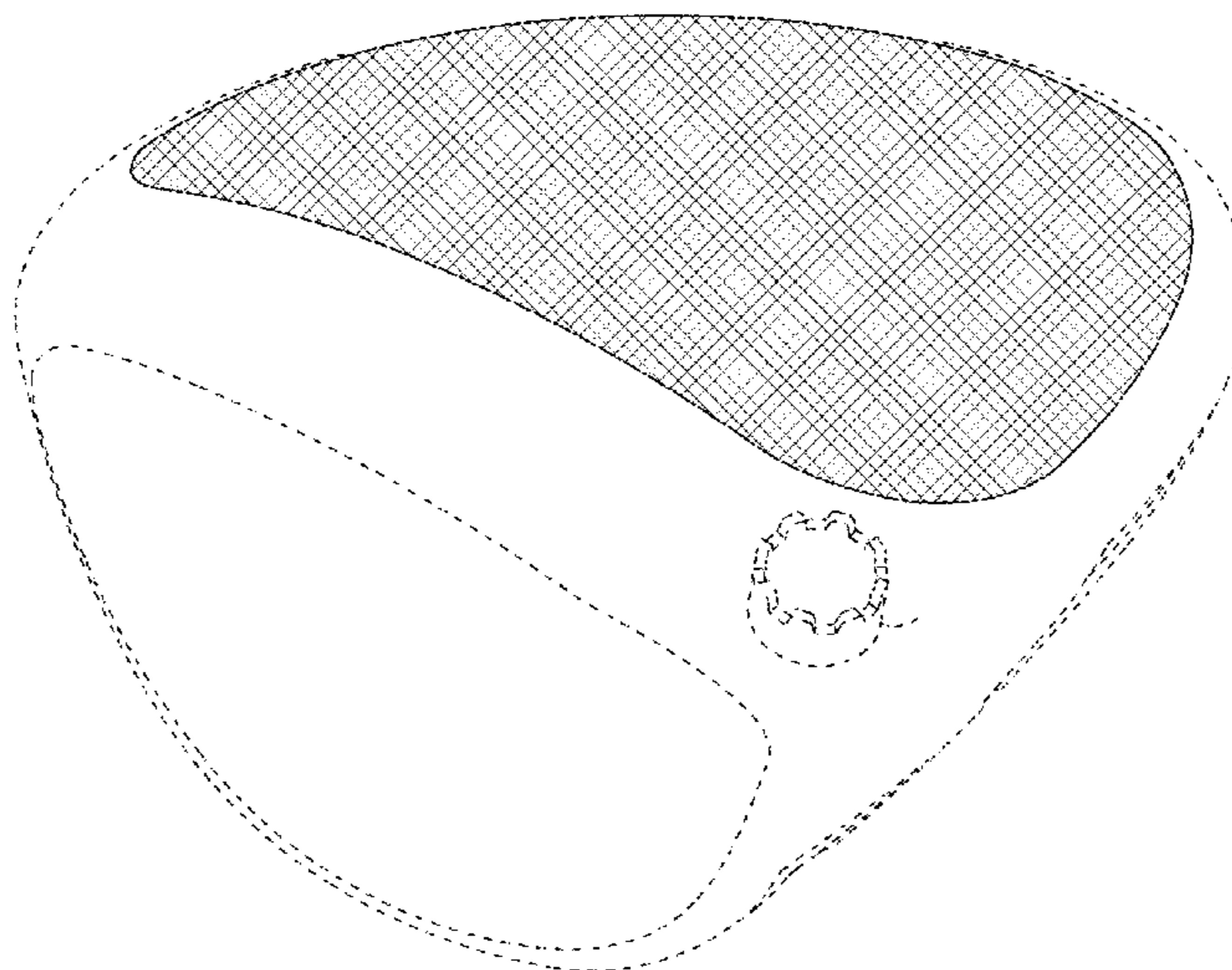
FIG. 5 illustrates a right side view of the golf club head of

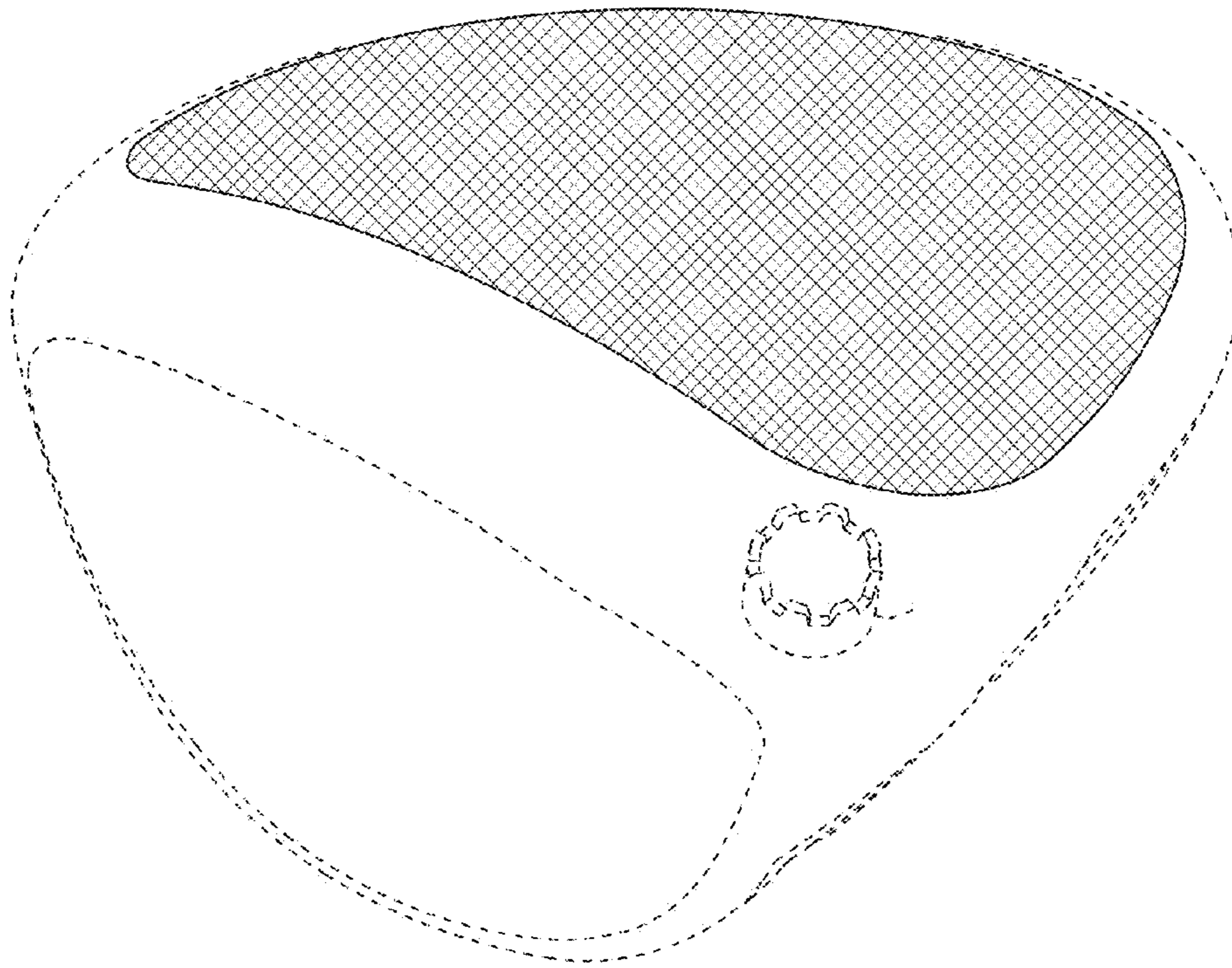

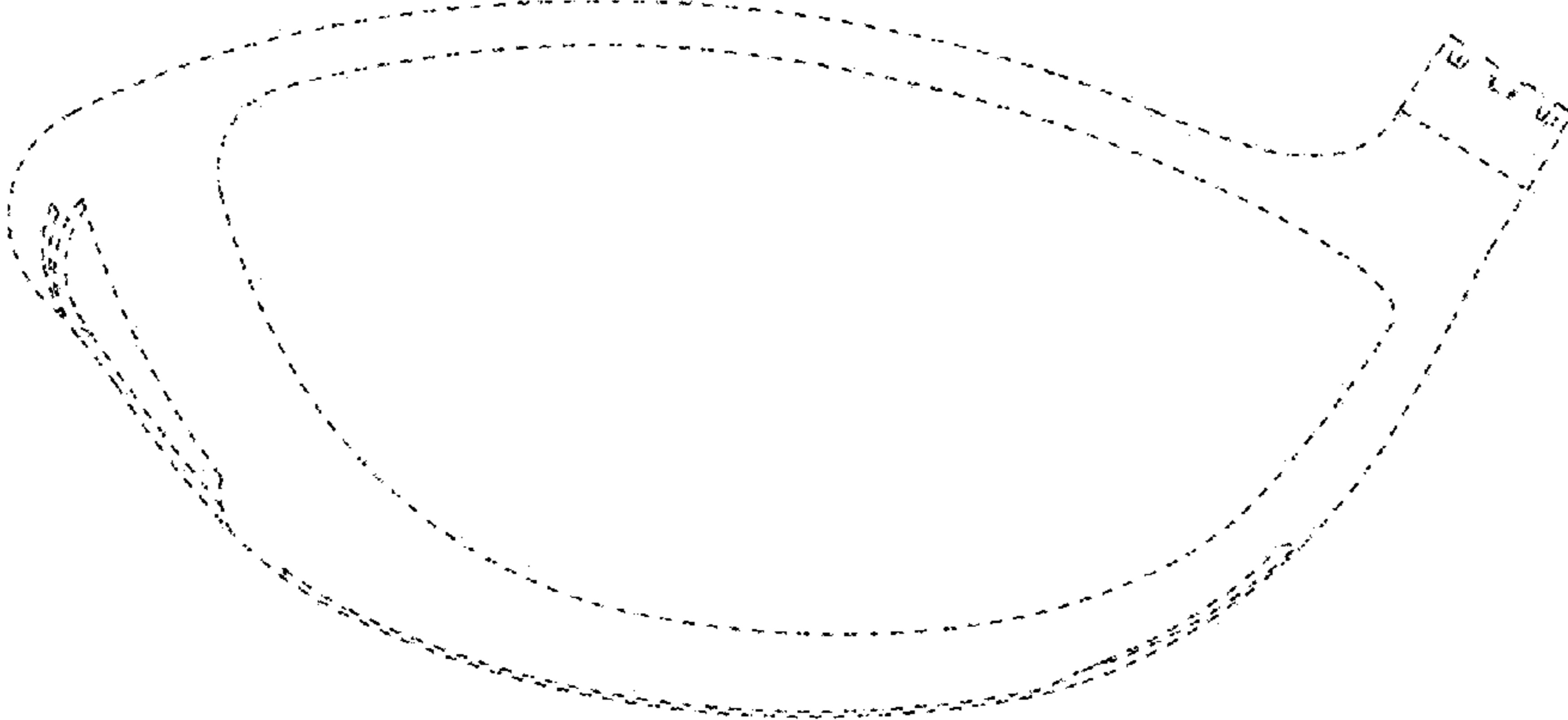

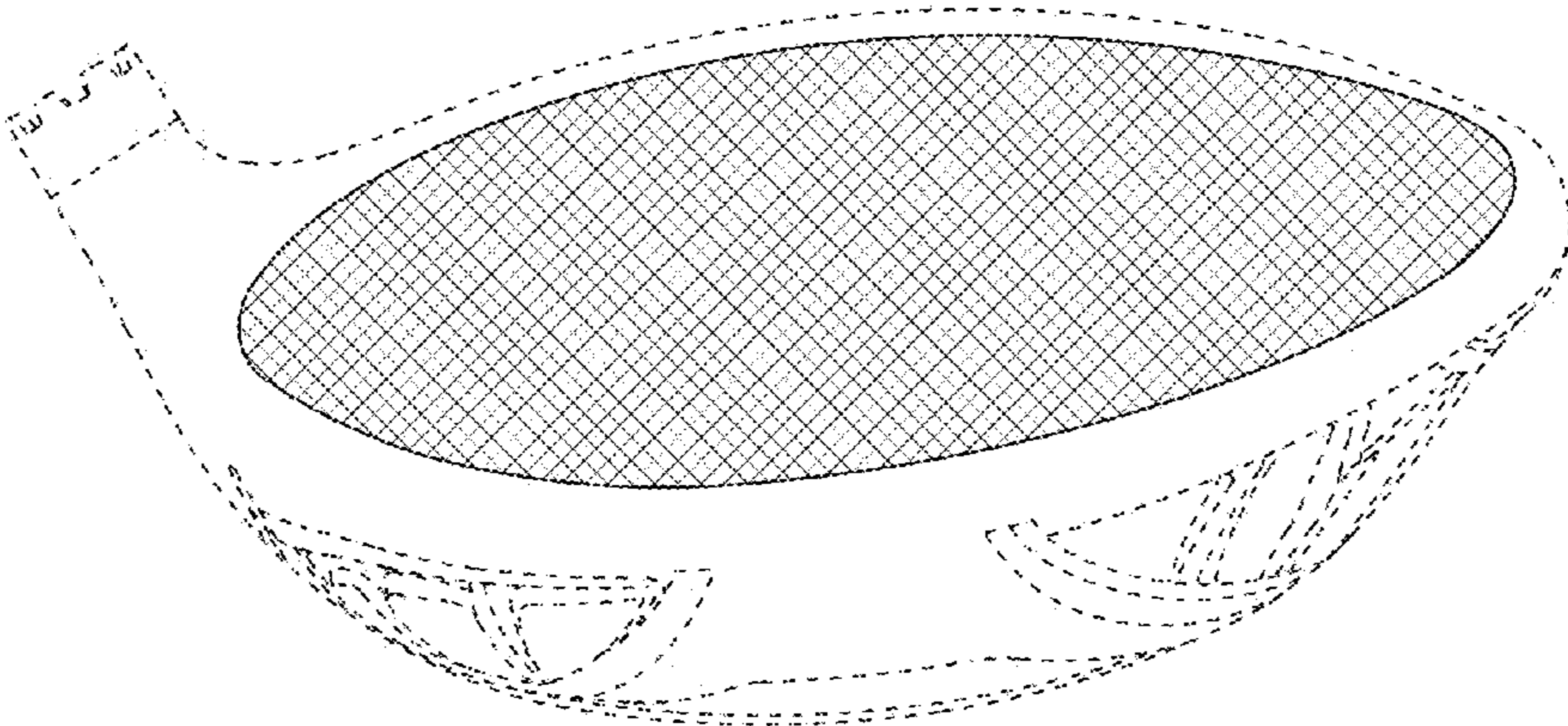

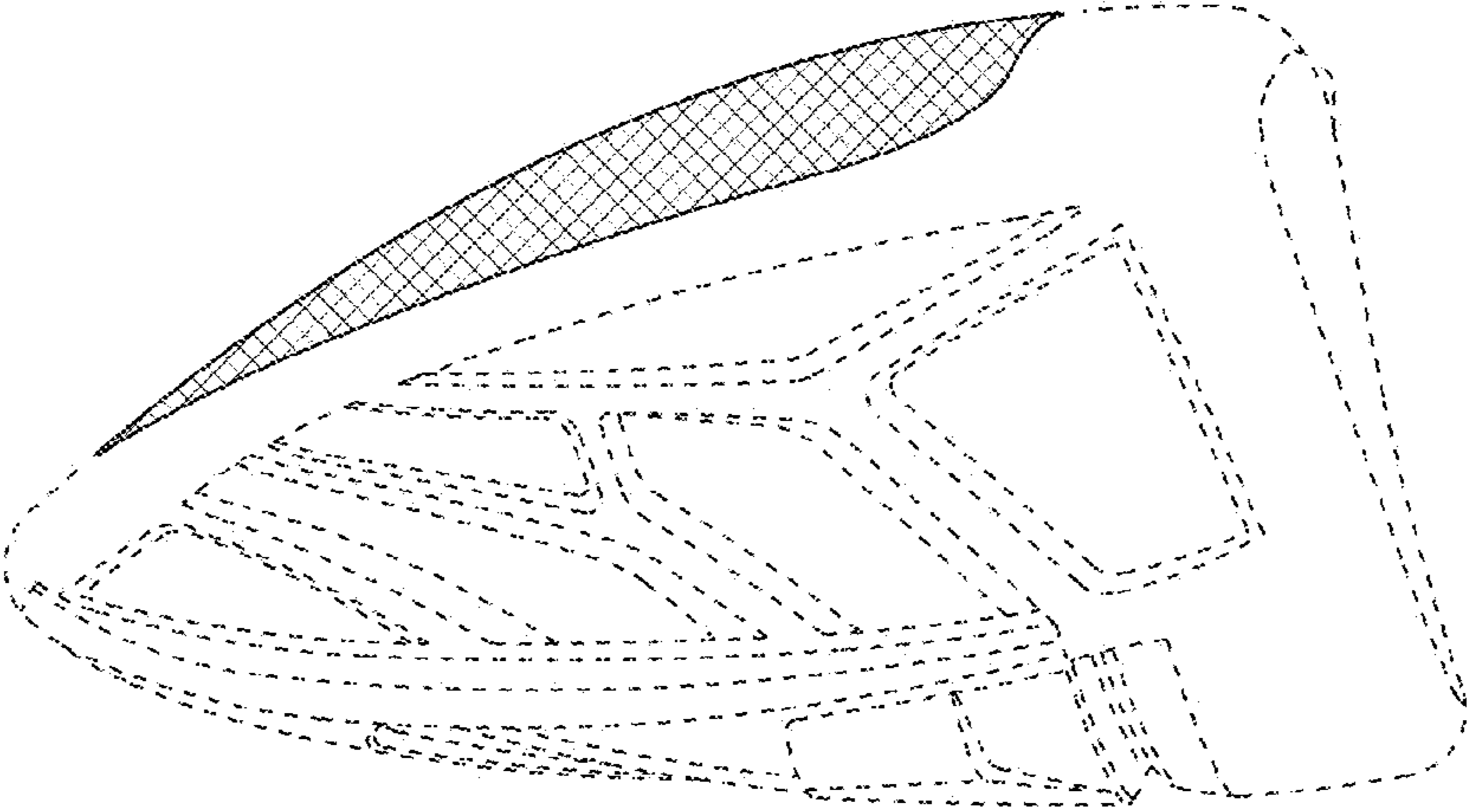

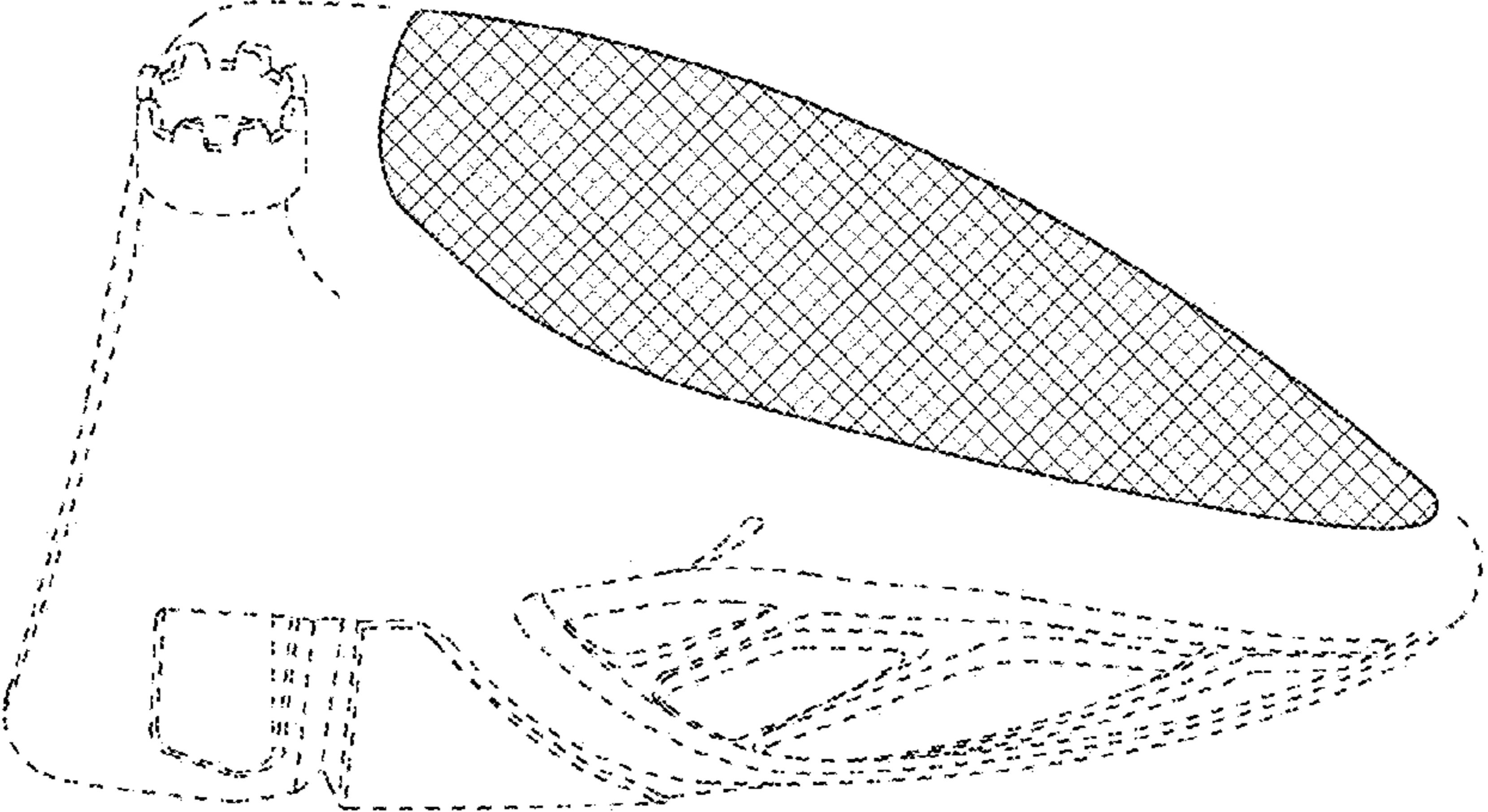

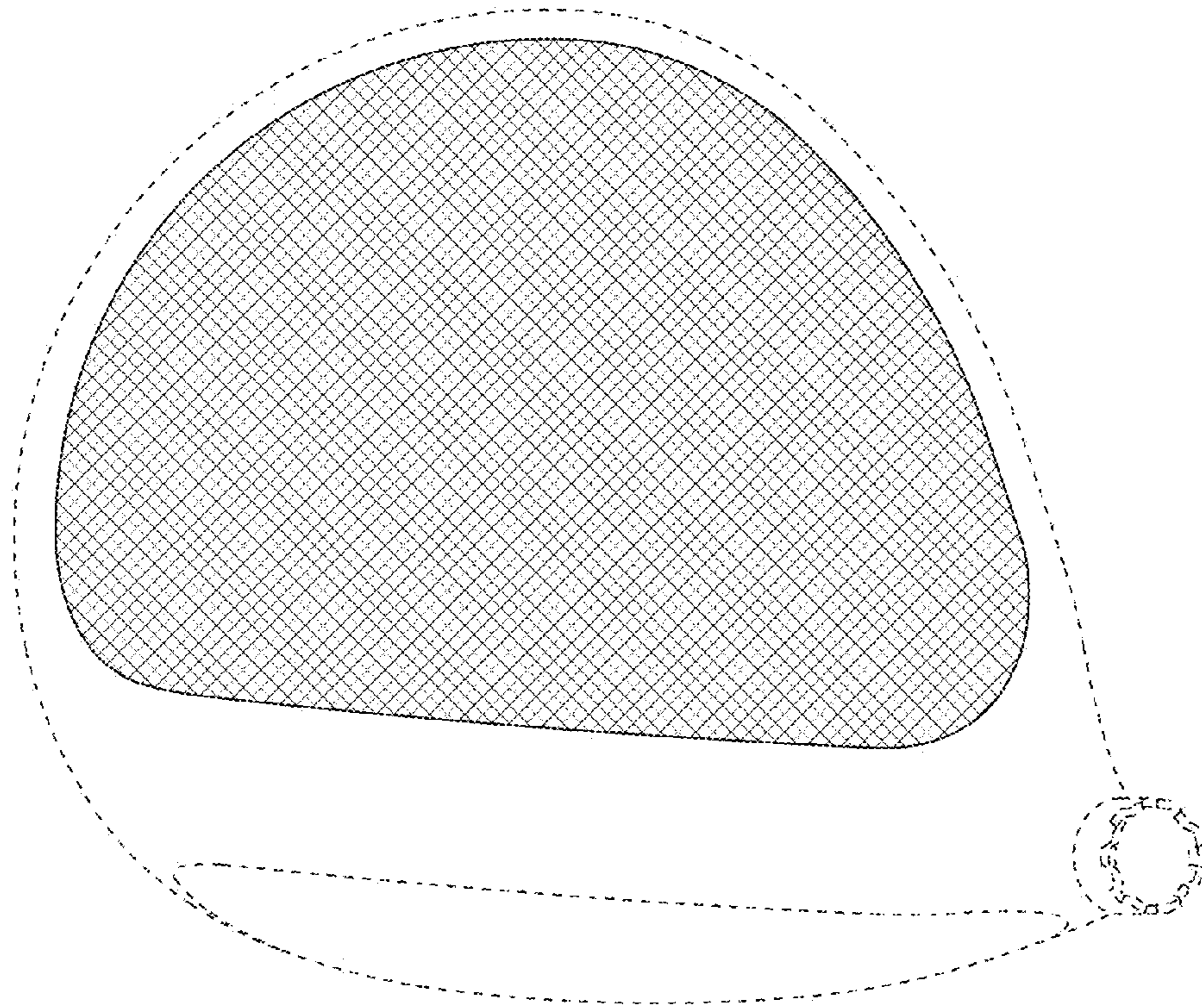

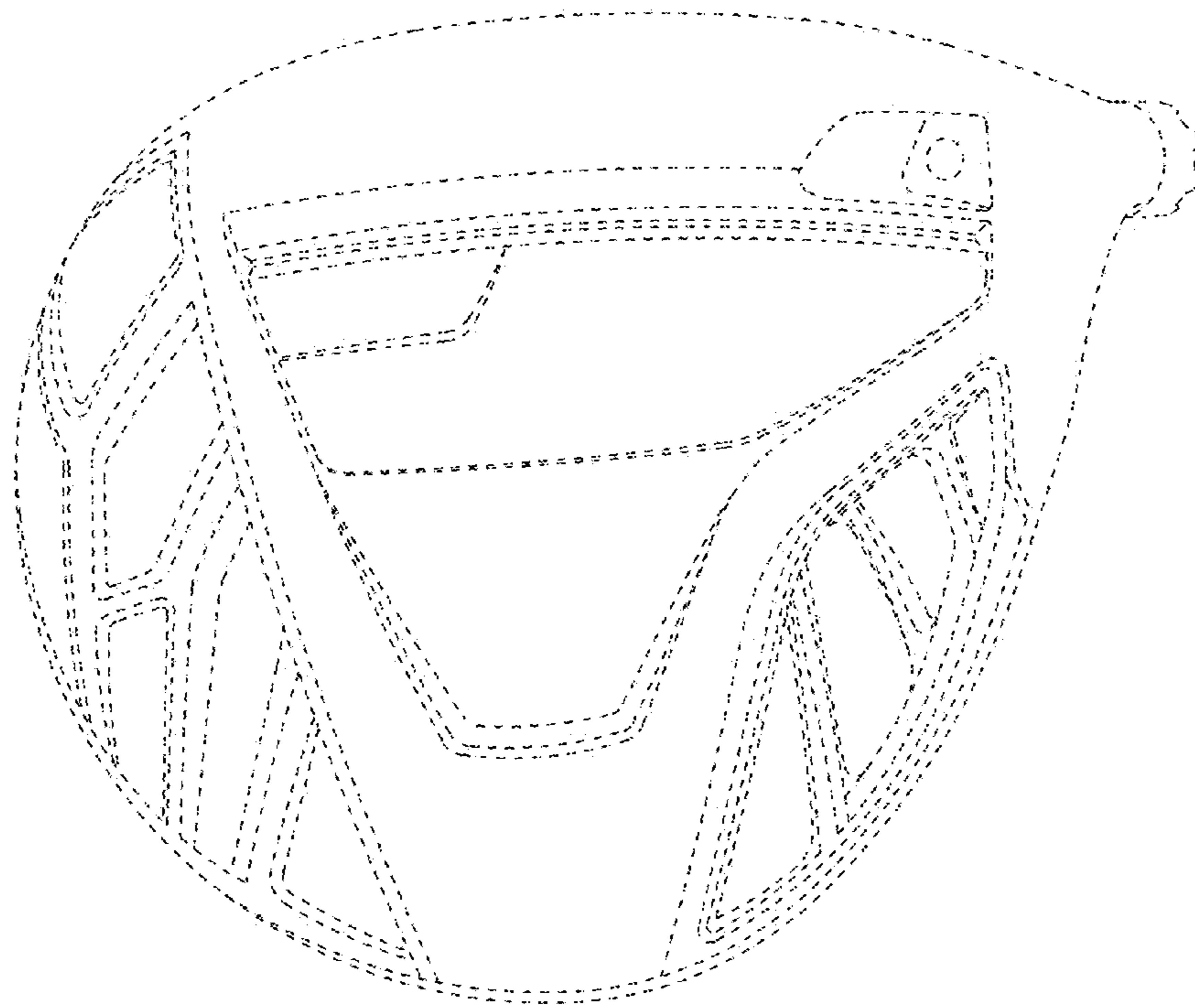
