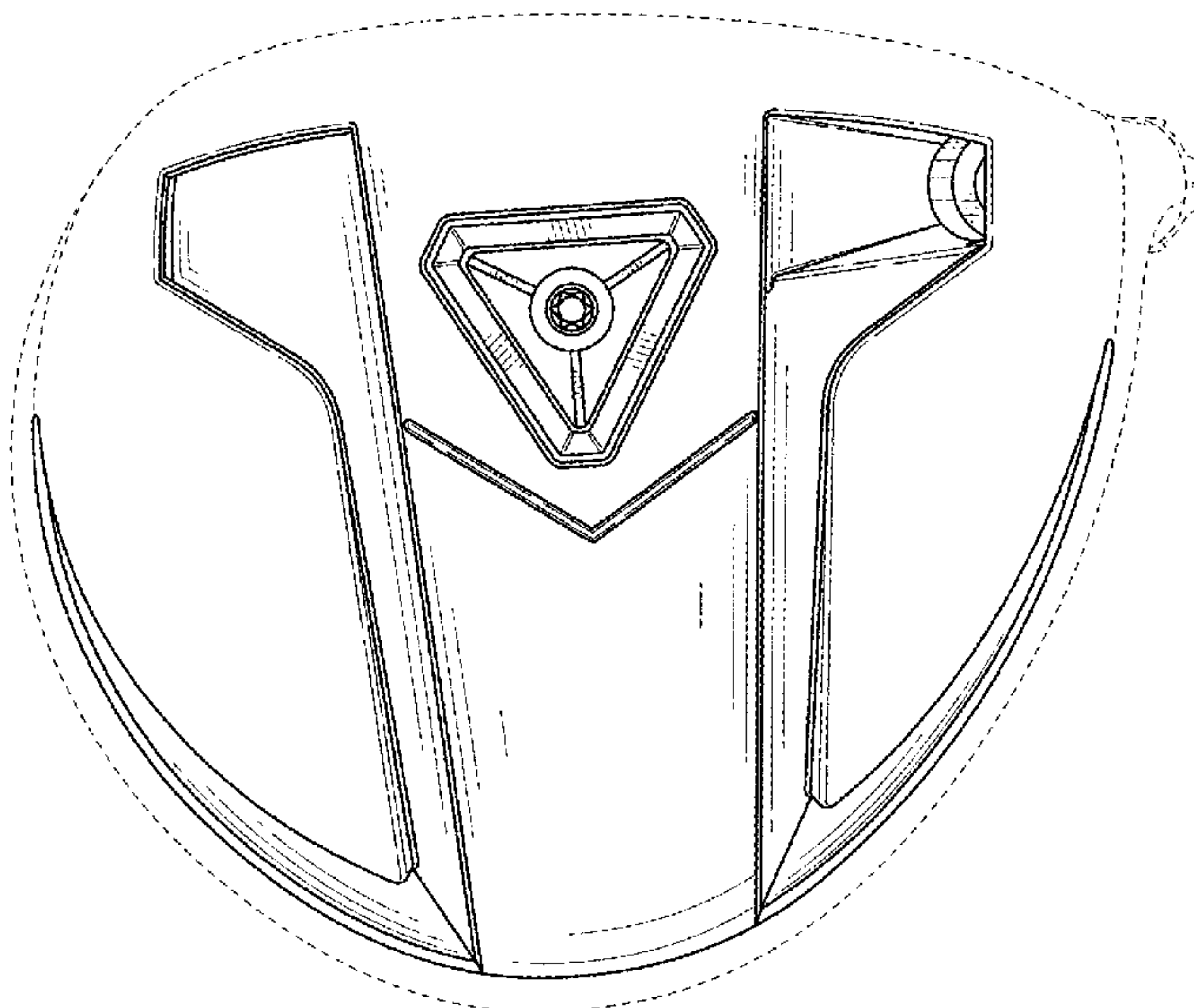
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, rear perspective view of an embodiment of a
golf club head as claimed herein;
FIG. 2 is a front elevational view thereof;

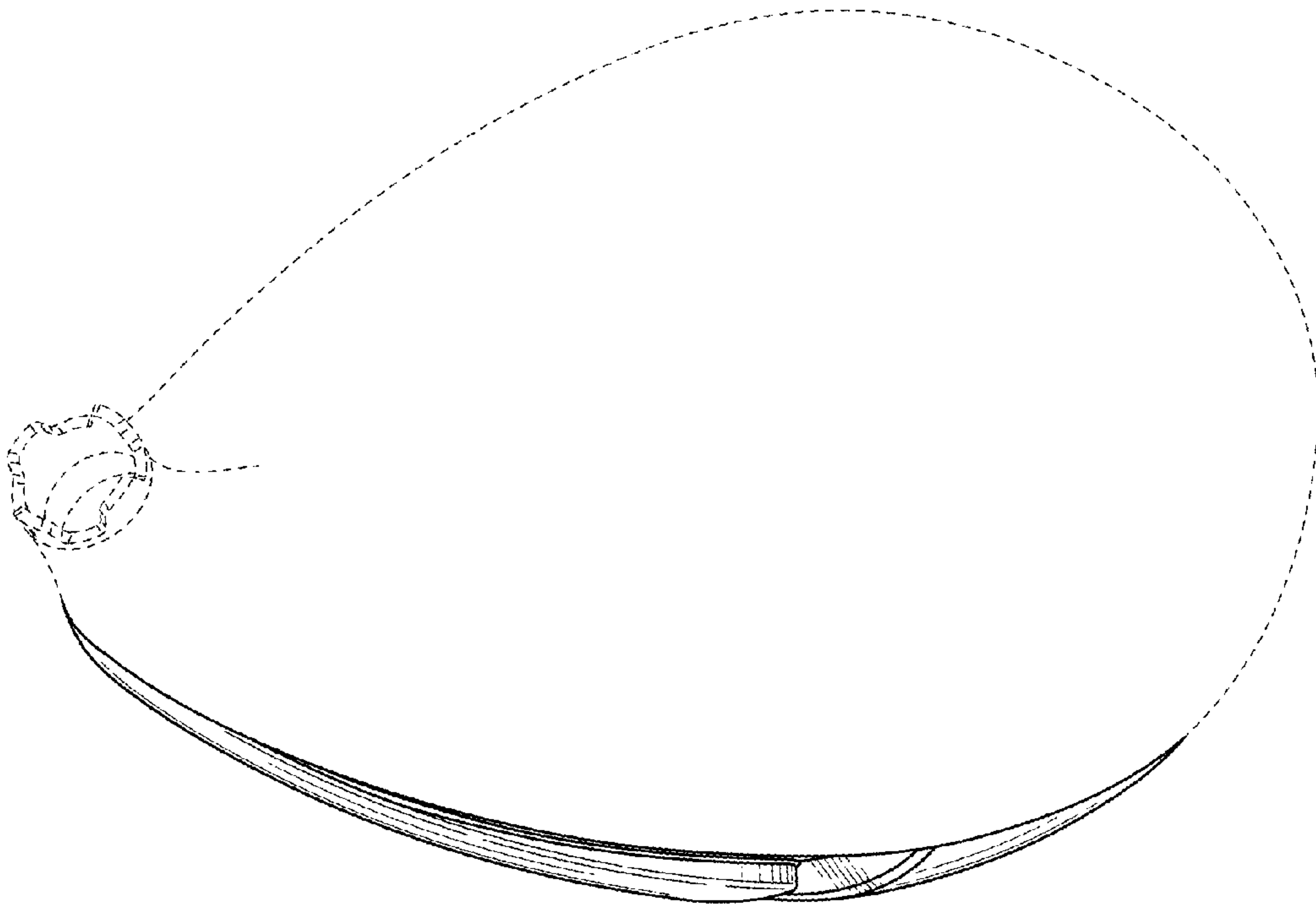

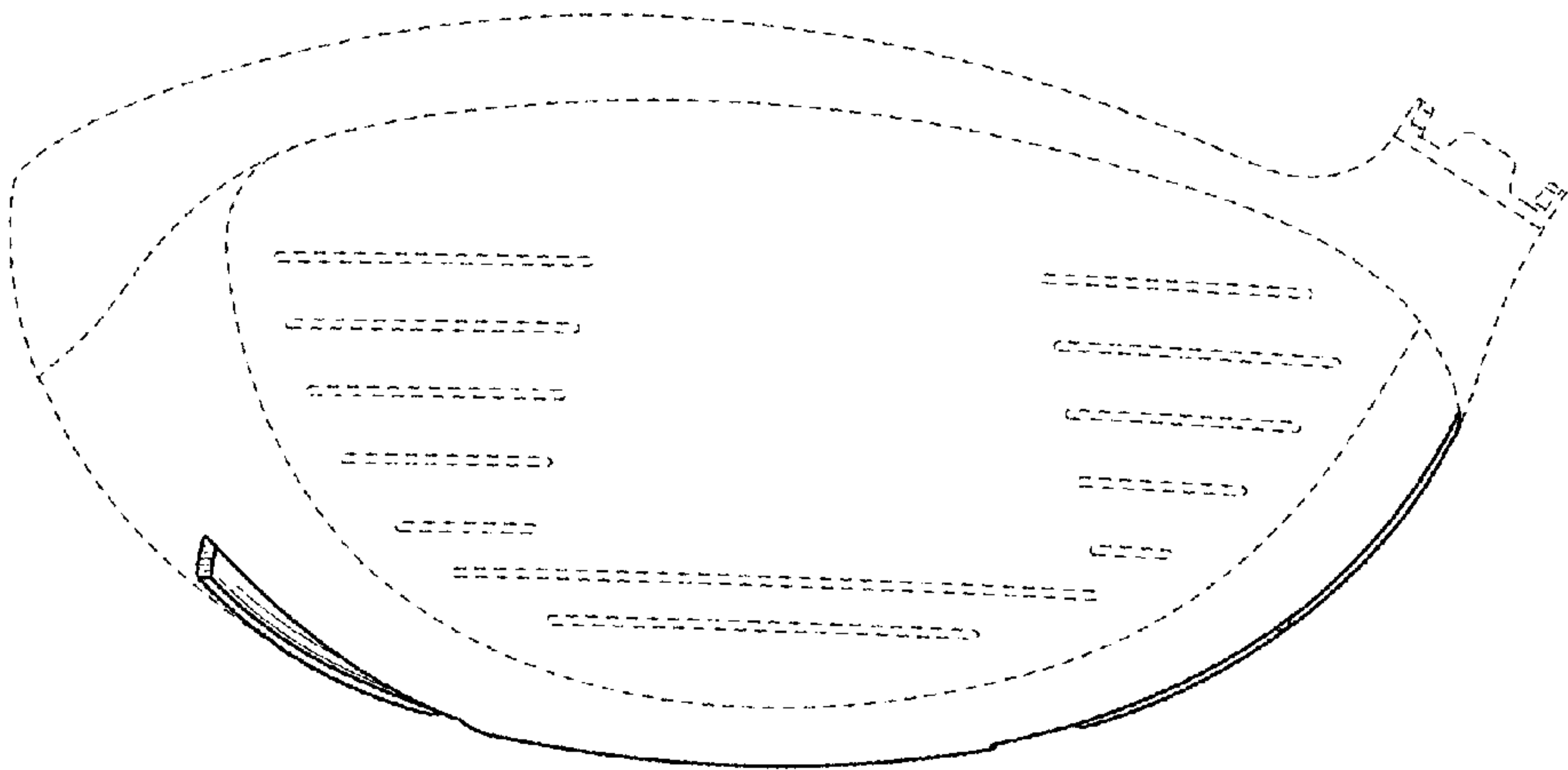

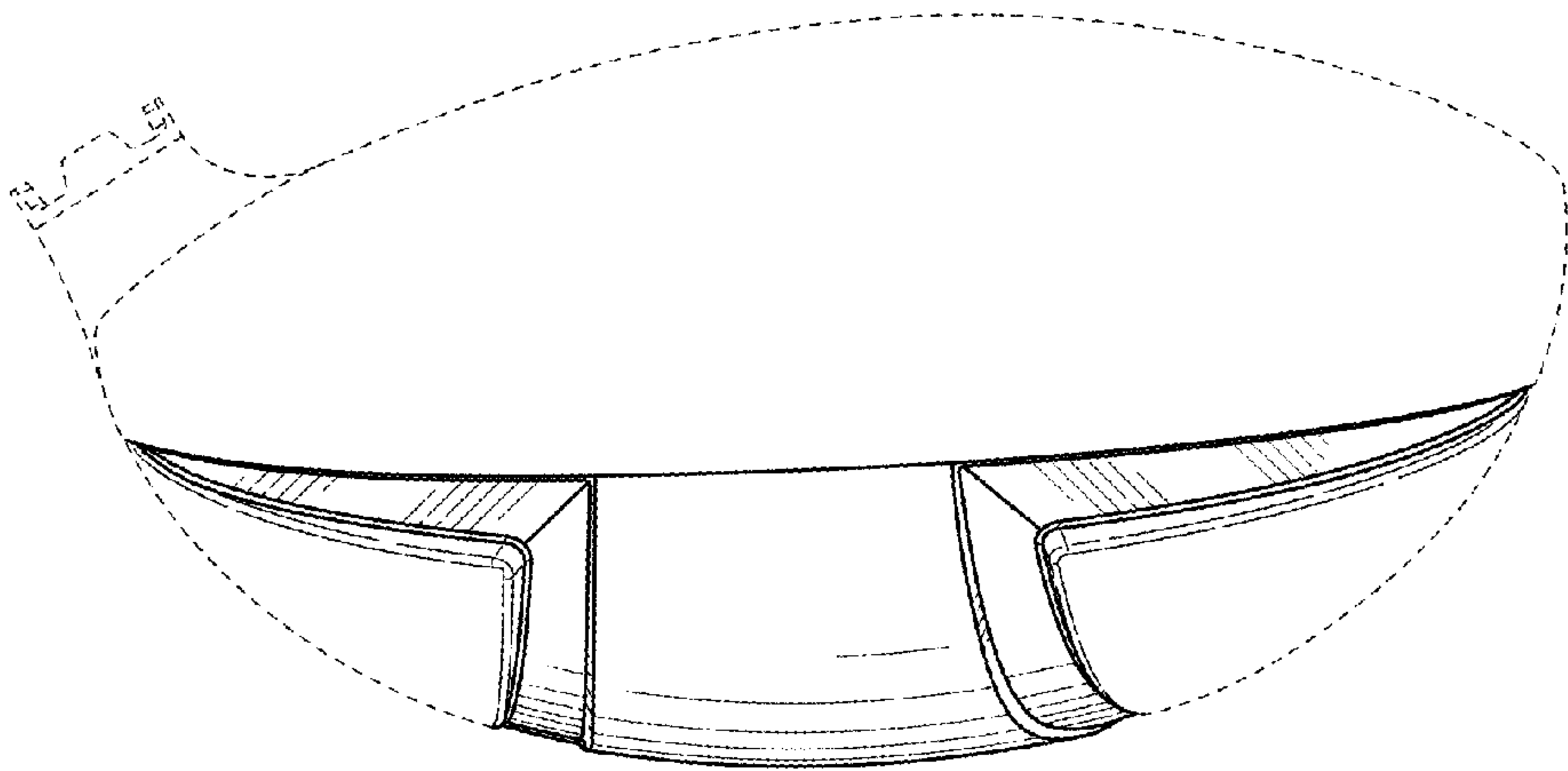

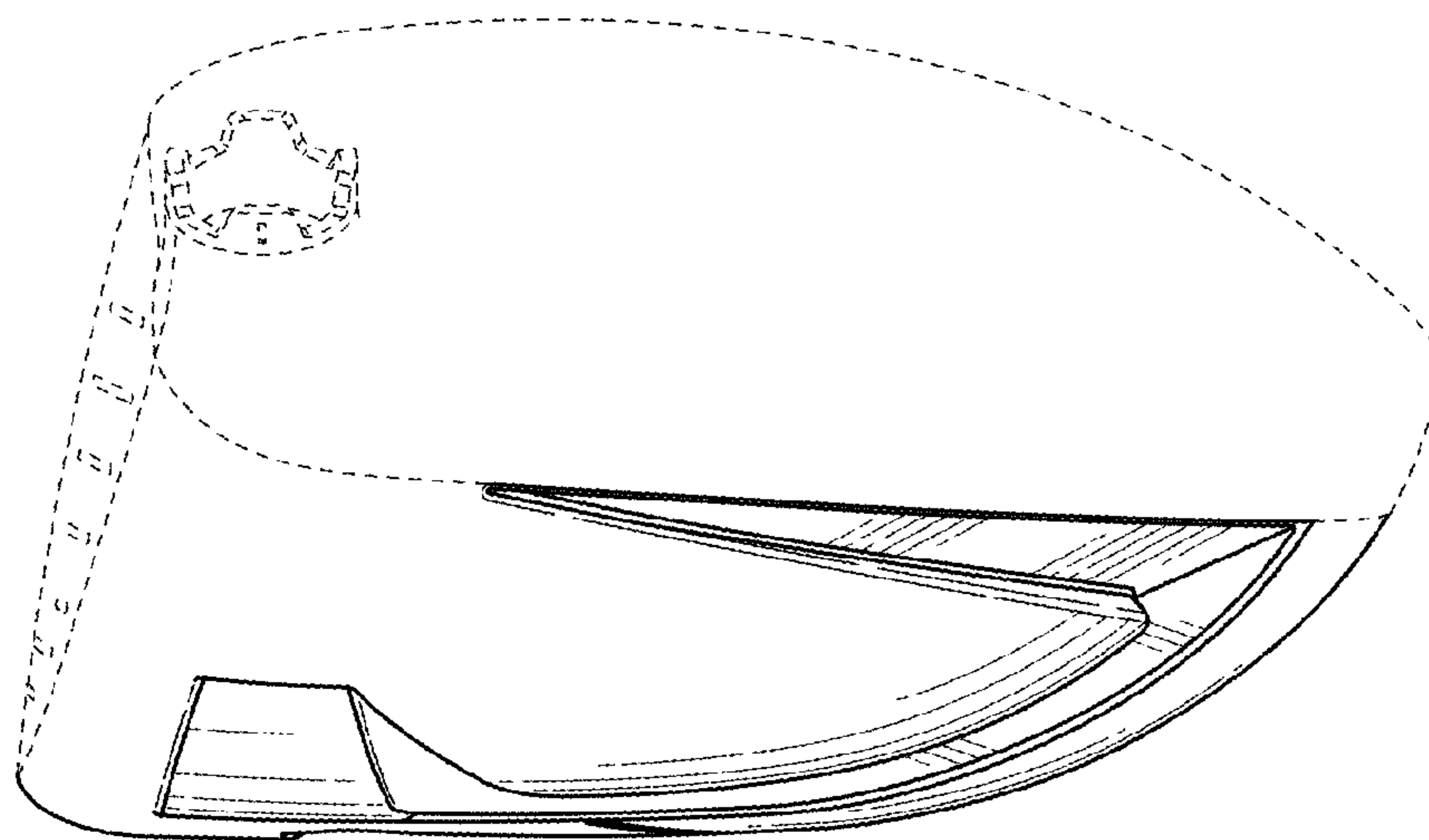

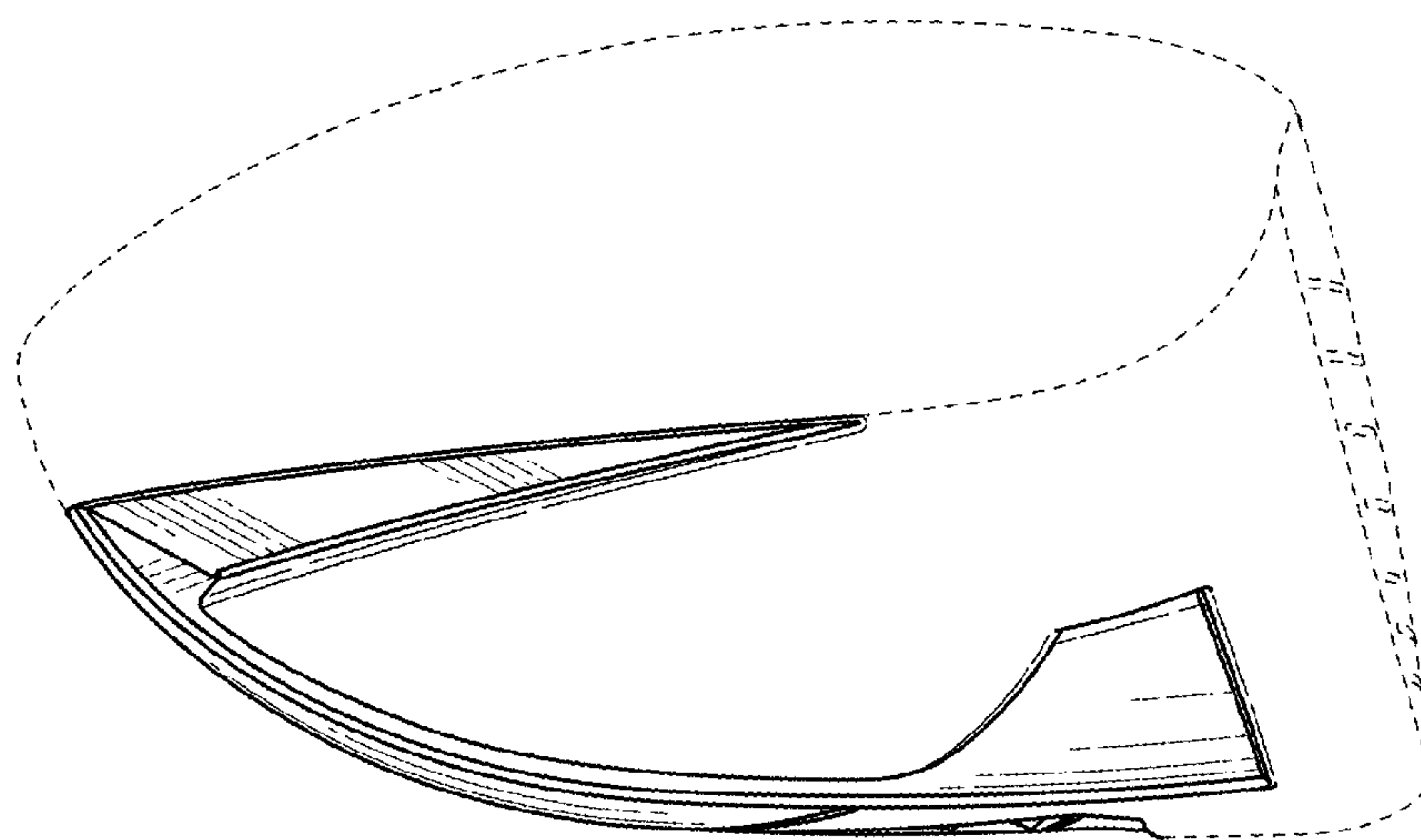

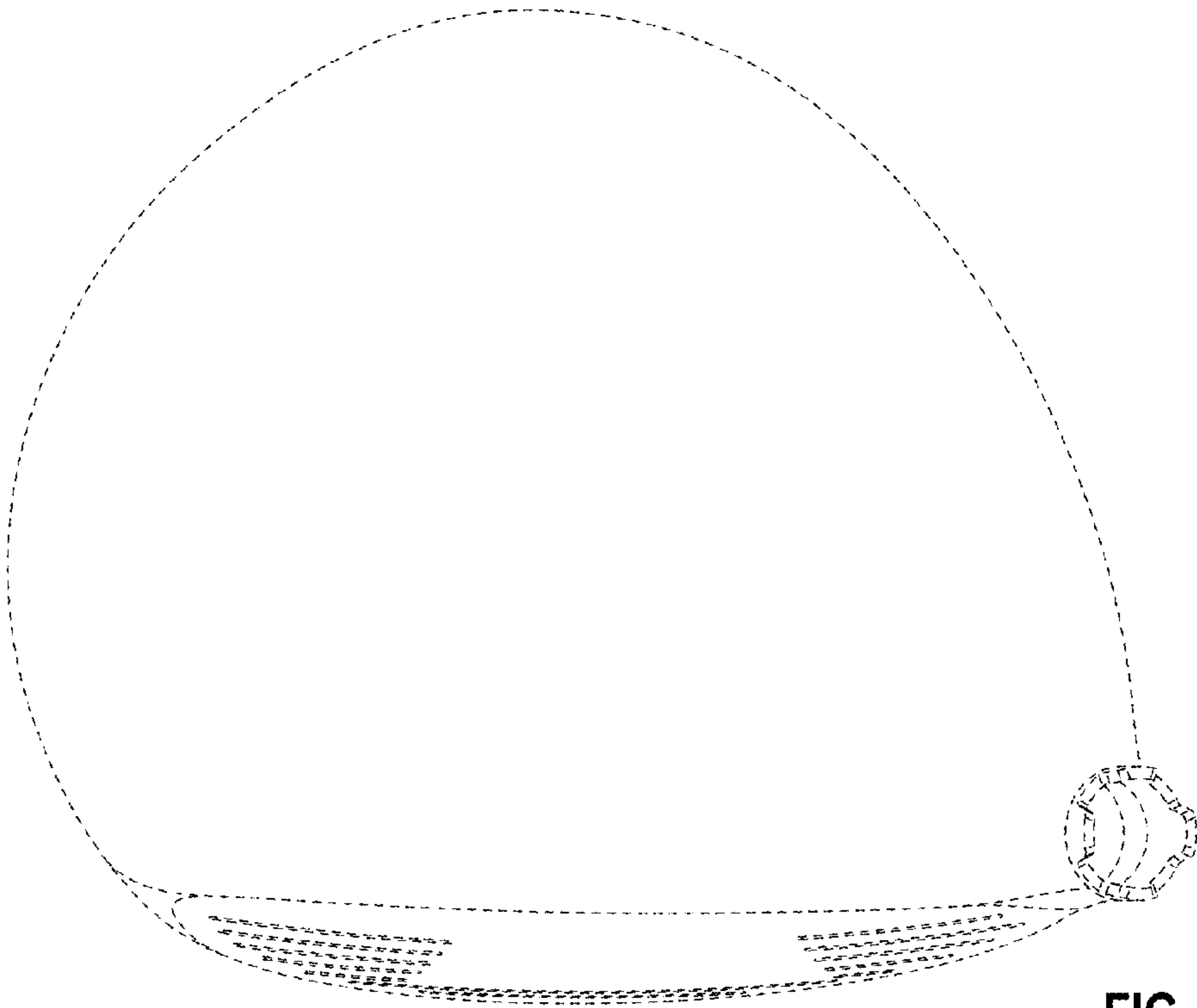

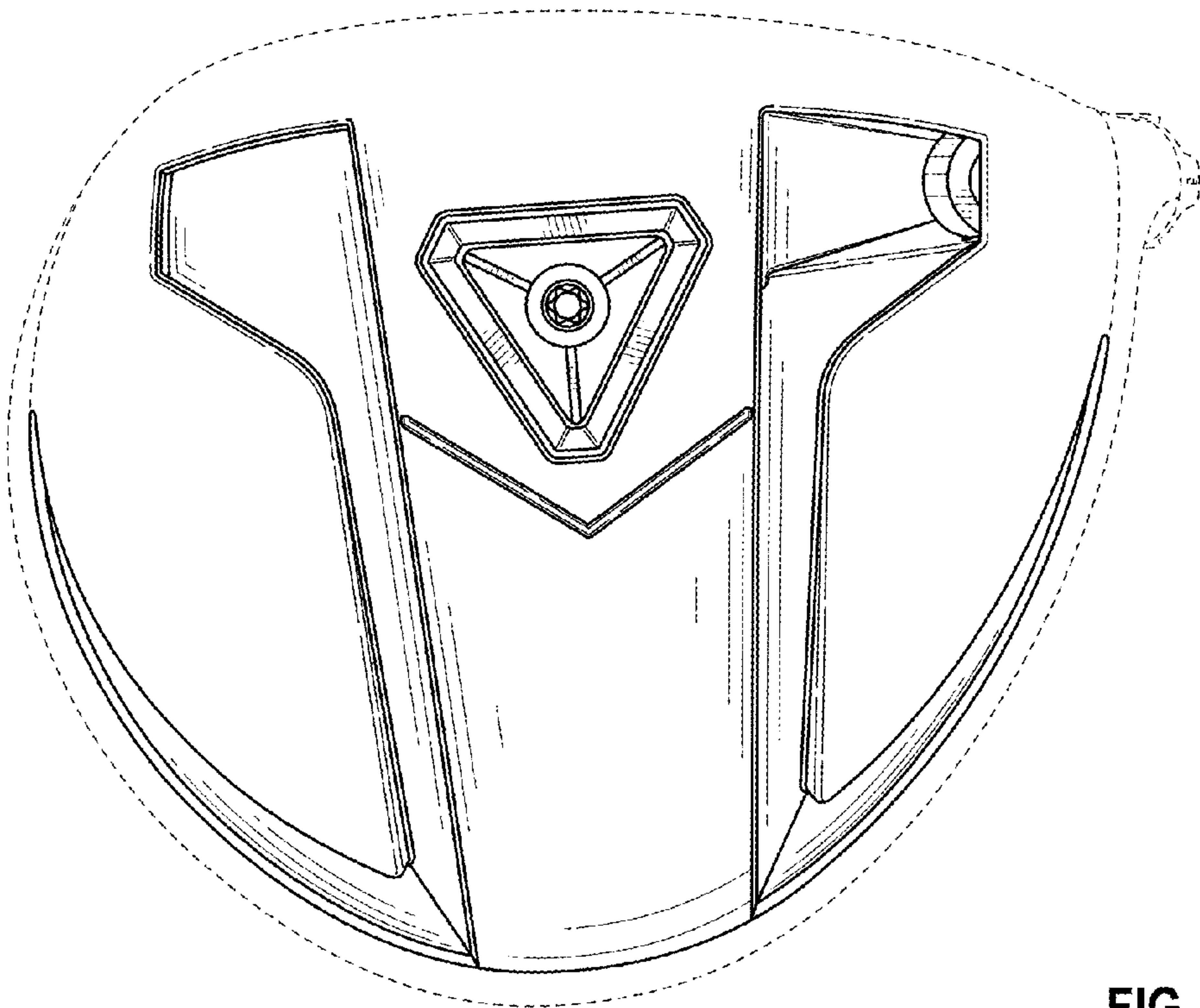
