The ornamental design for a horseshoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a horseshoe showing our new design.

FIG. 2 is a left side view of the horseshoe of FIG. 1, the right side being a mirror image thereof.

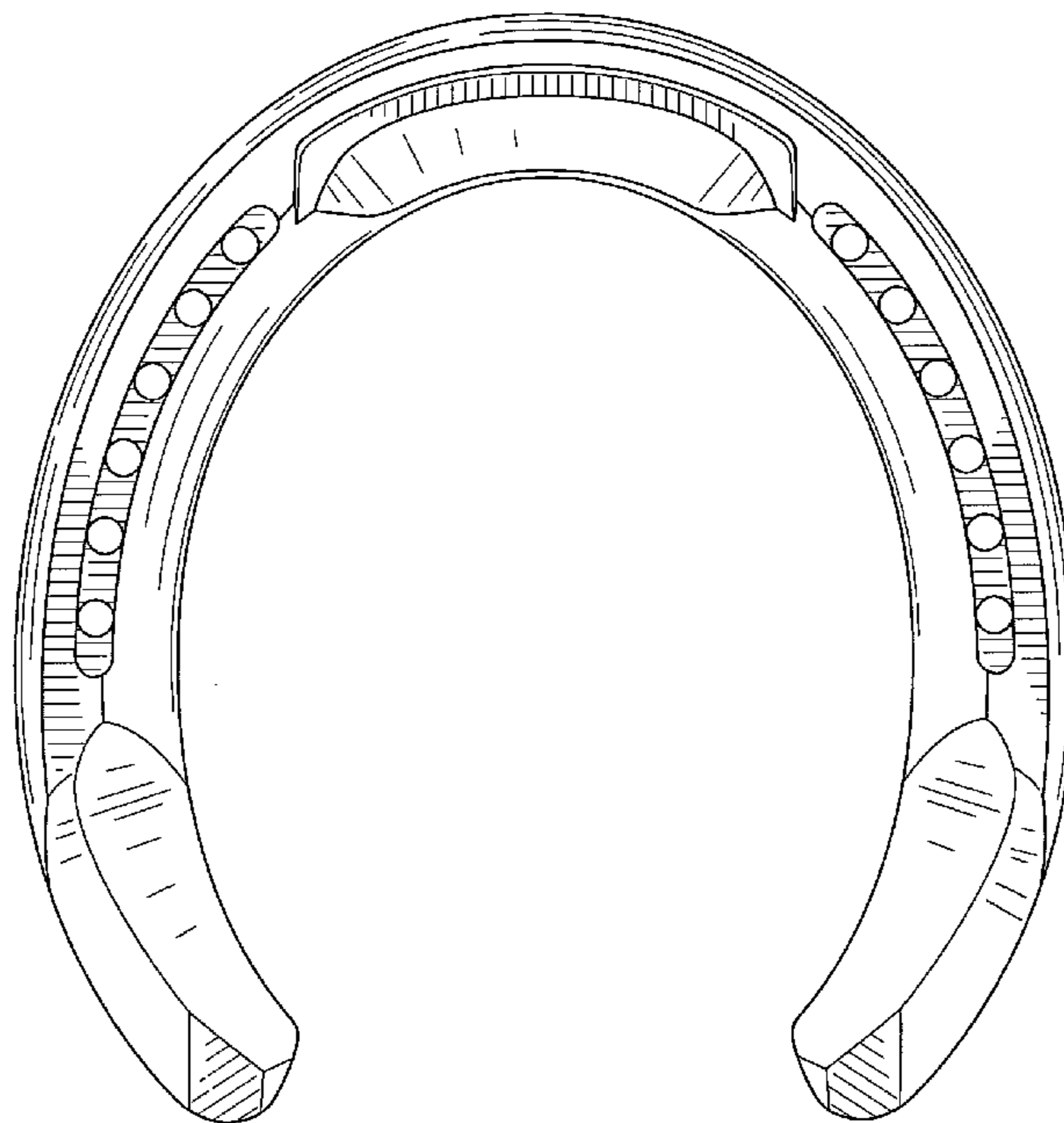
FIG. 3 is a top plan view showing the horseshoe of FIG. 1.

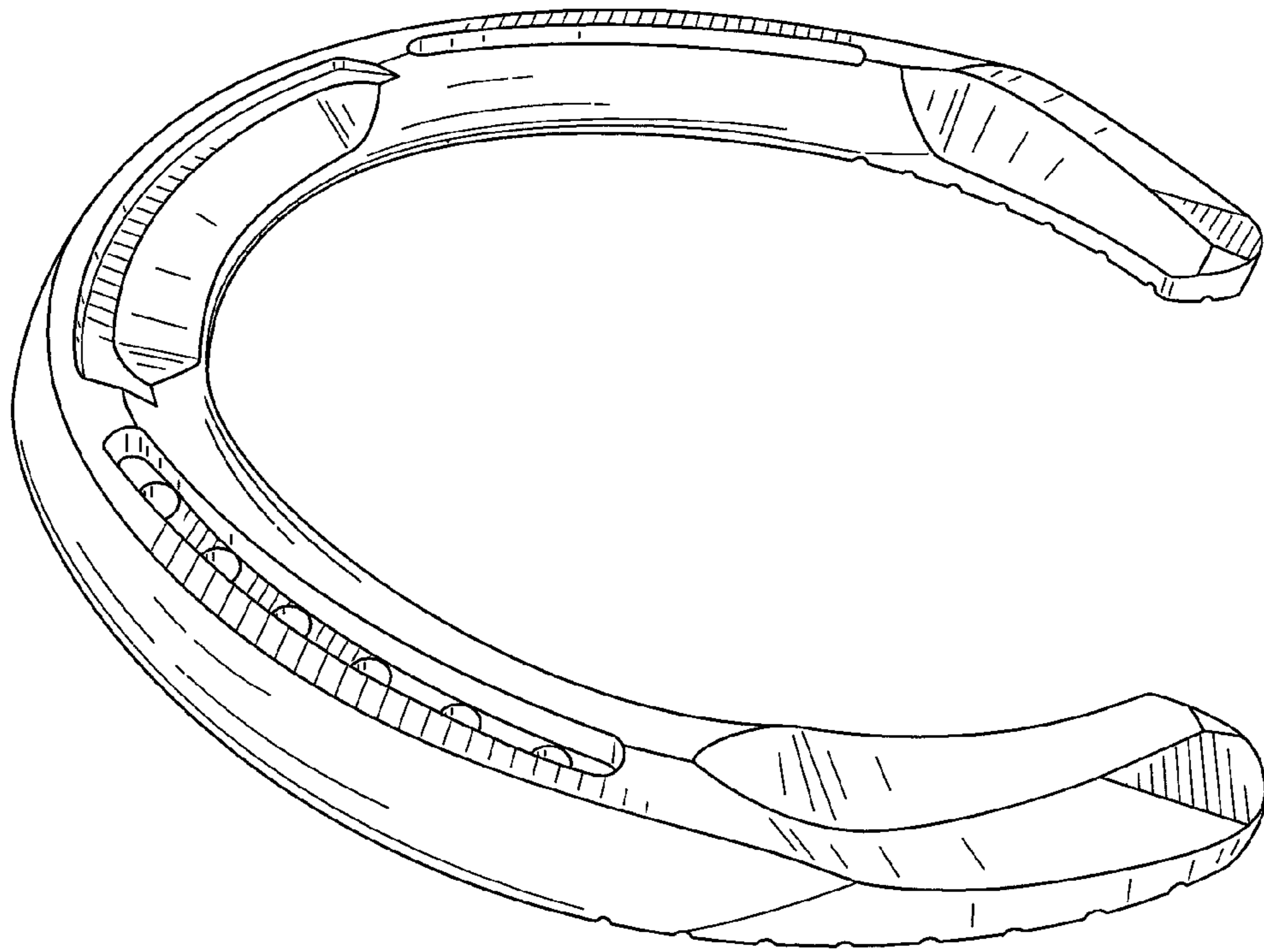

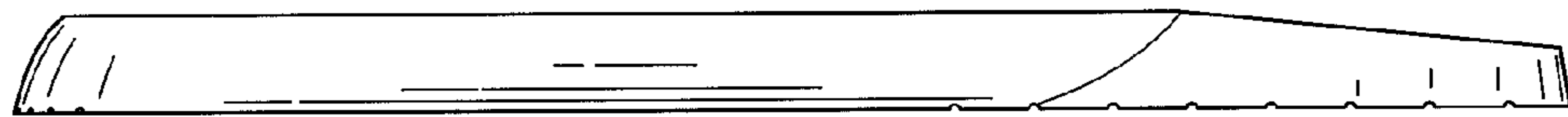

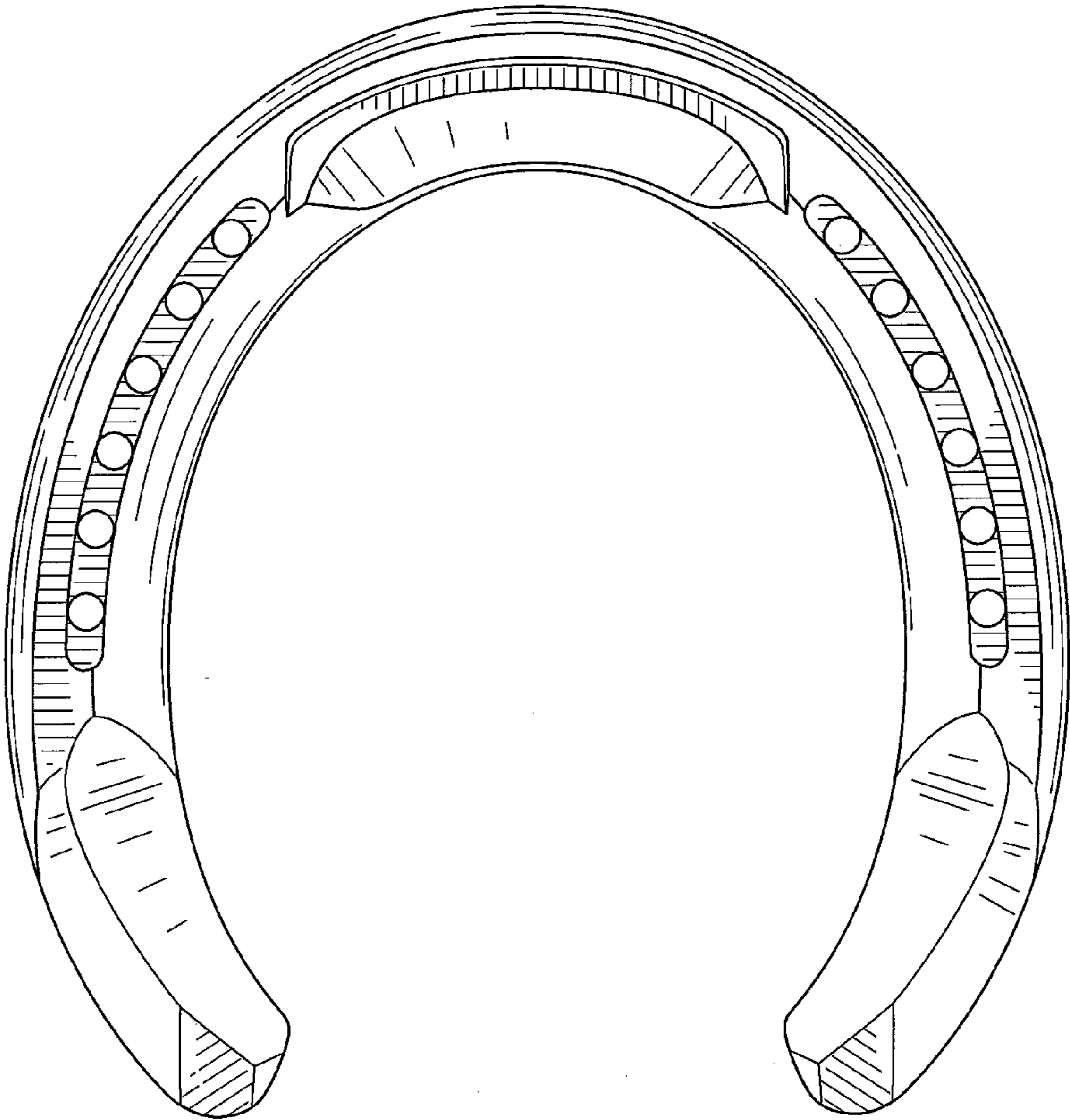

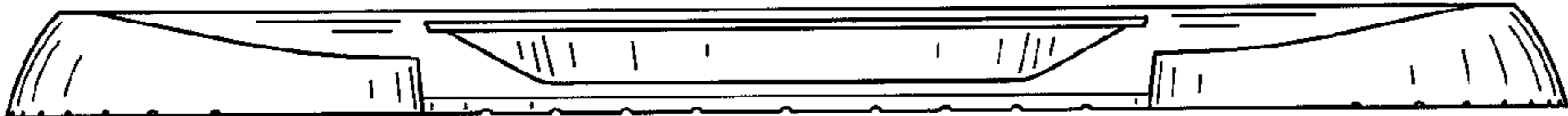

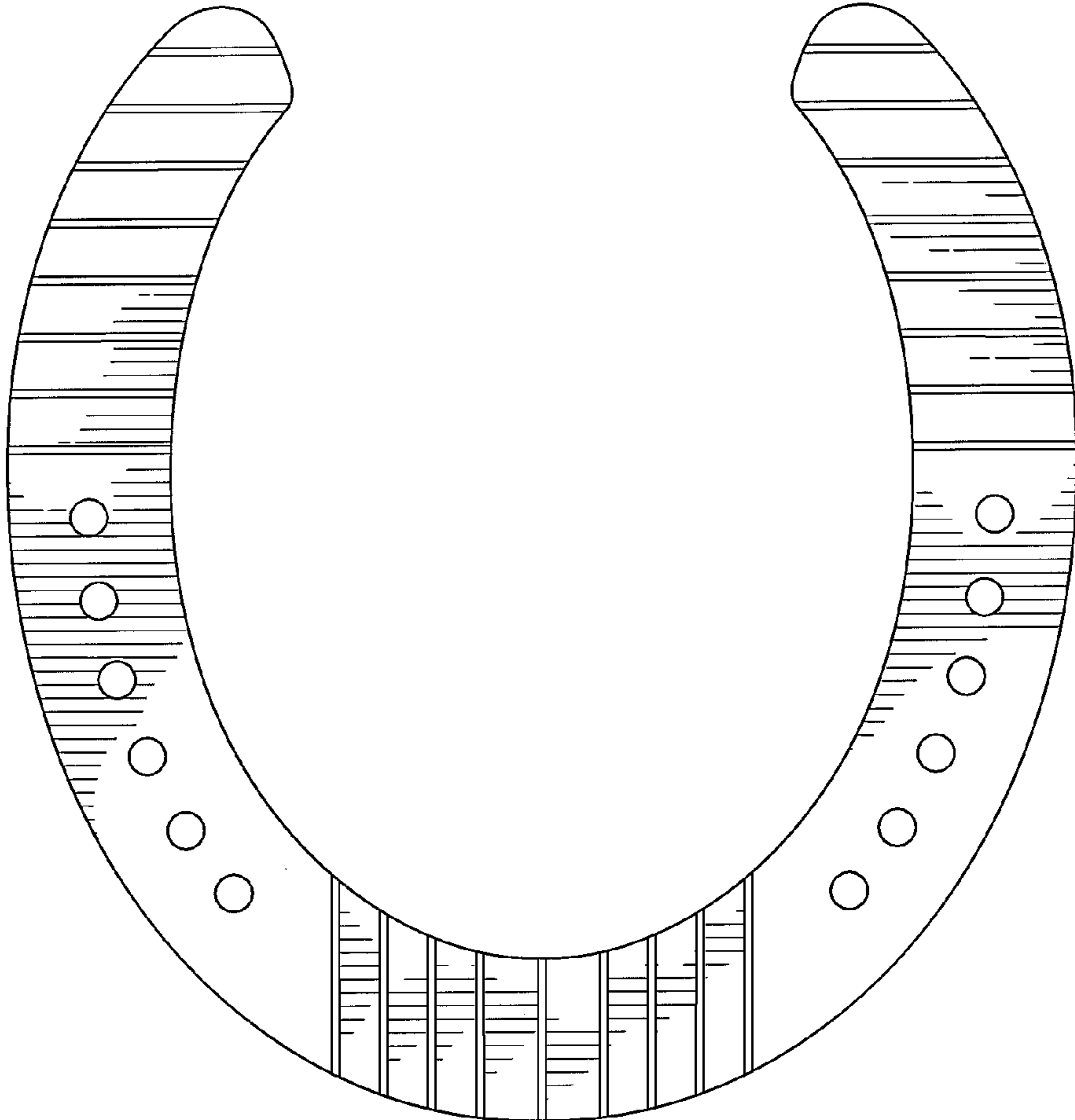

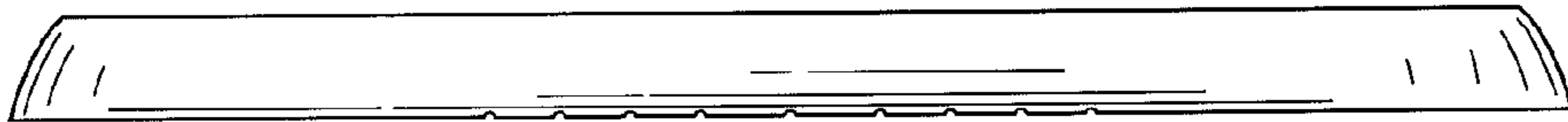
