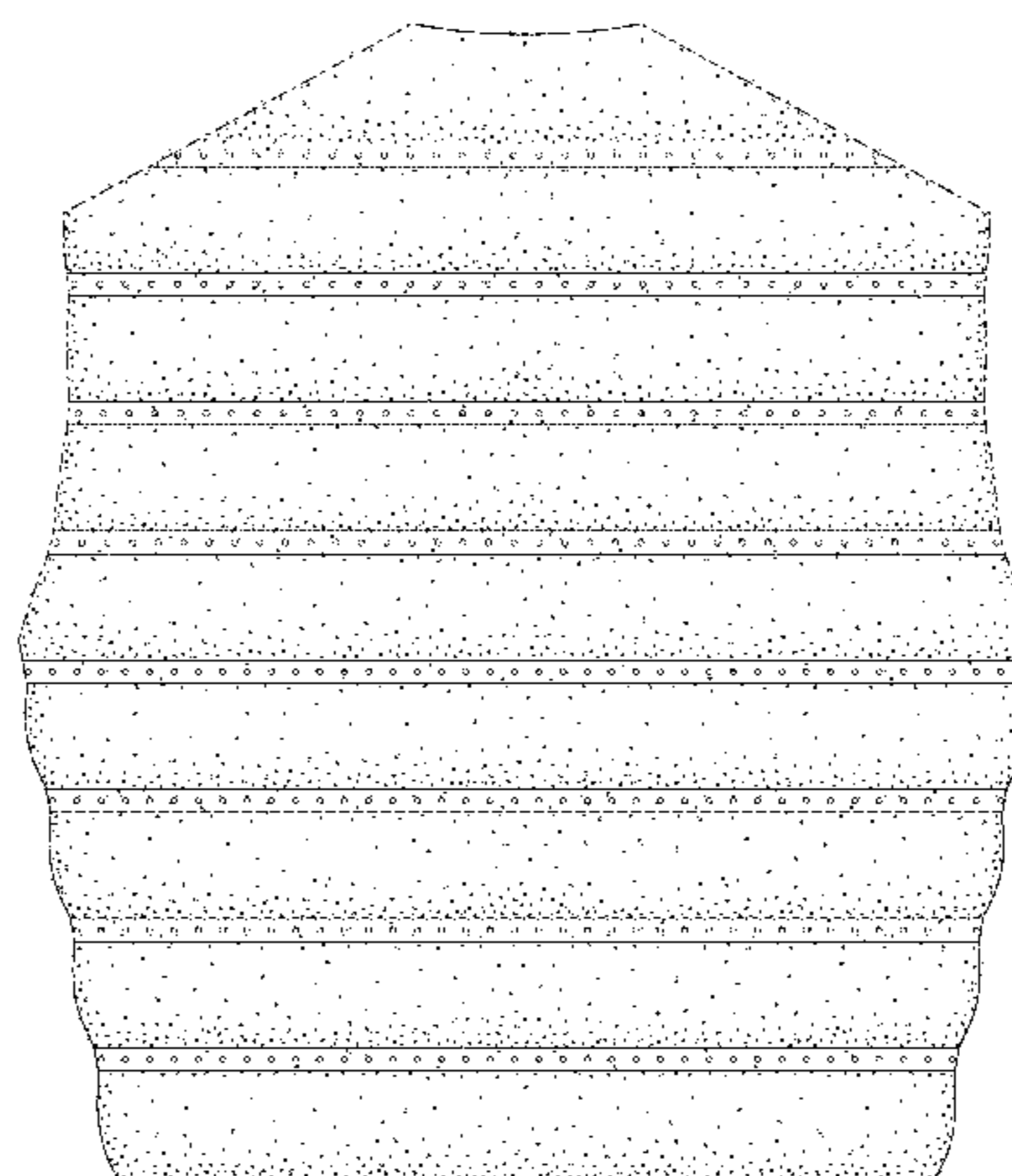
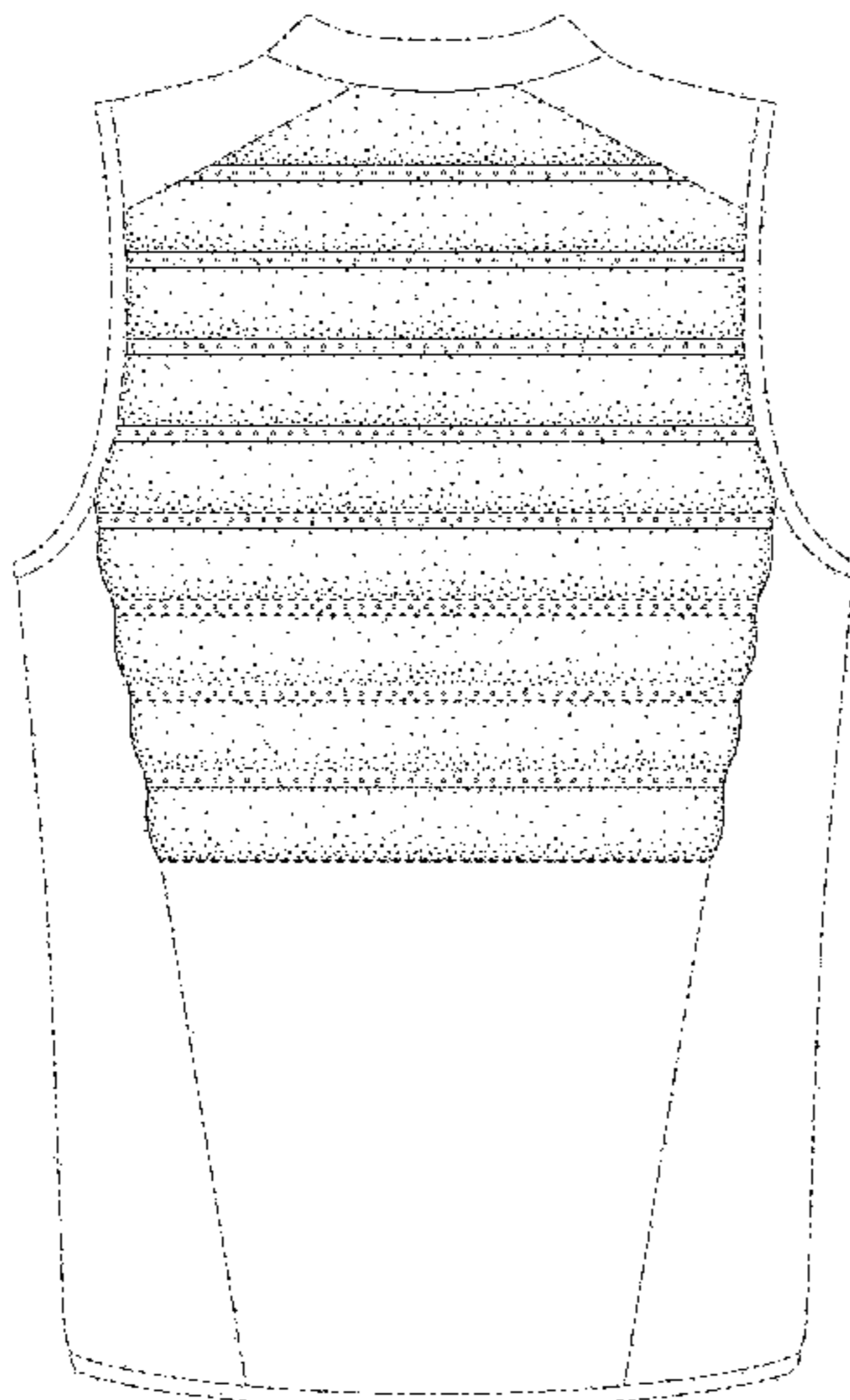
(57) **CLAIM**

The ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective rear view of a garment showing my new design in an in-use configuration; FIG. 2 is right perspective rear view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; and, FIG. 6 is an enlarged view of FIG. 3 showing the claimed area in isolation from the environment. The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines showing the remainder of the garment and the unshaded regions therein are for environmental purposes only and form no part of the claimed design.

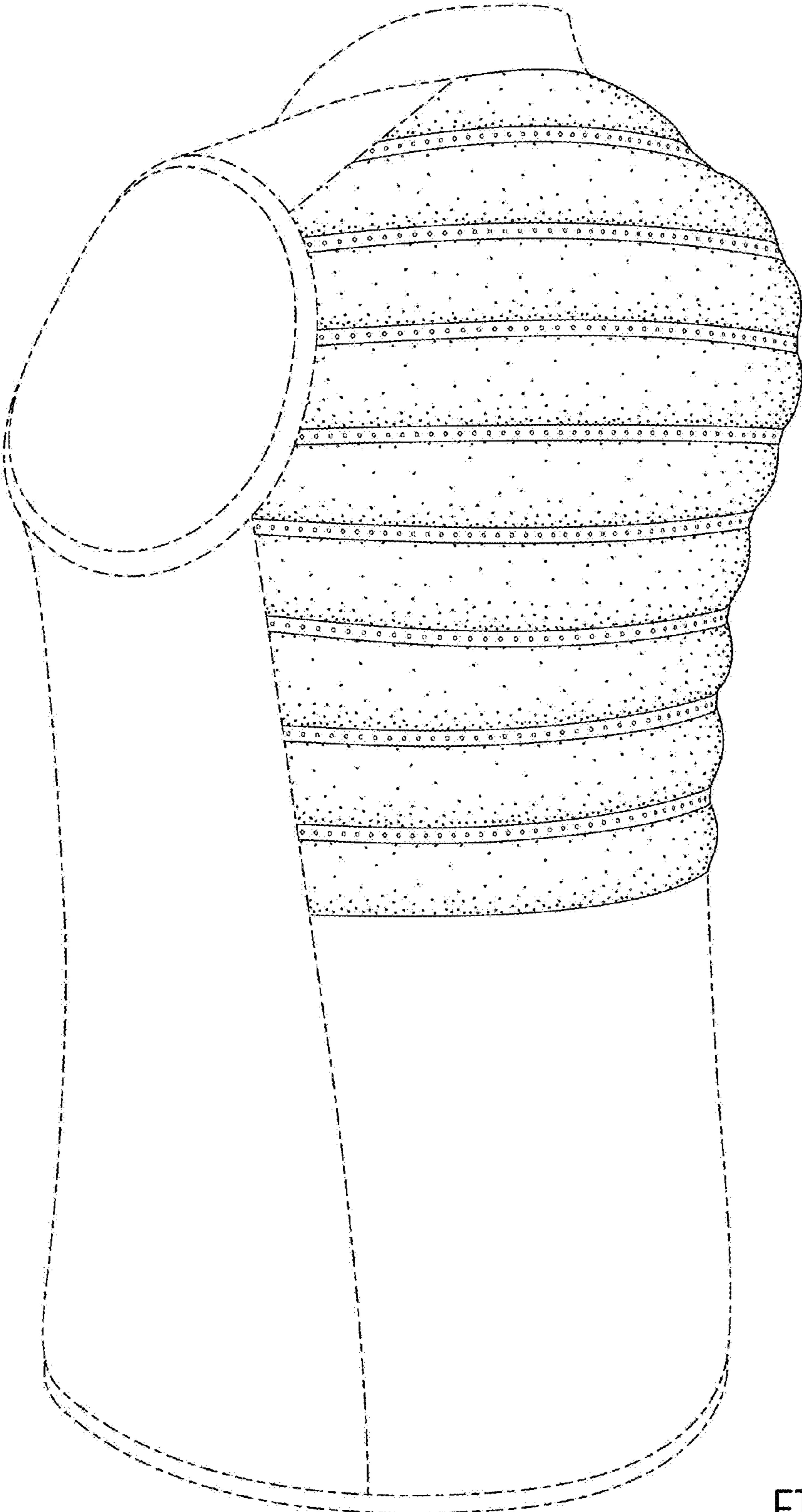

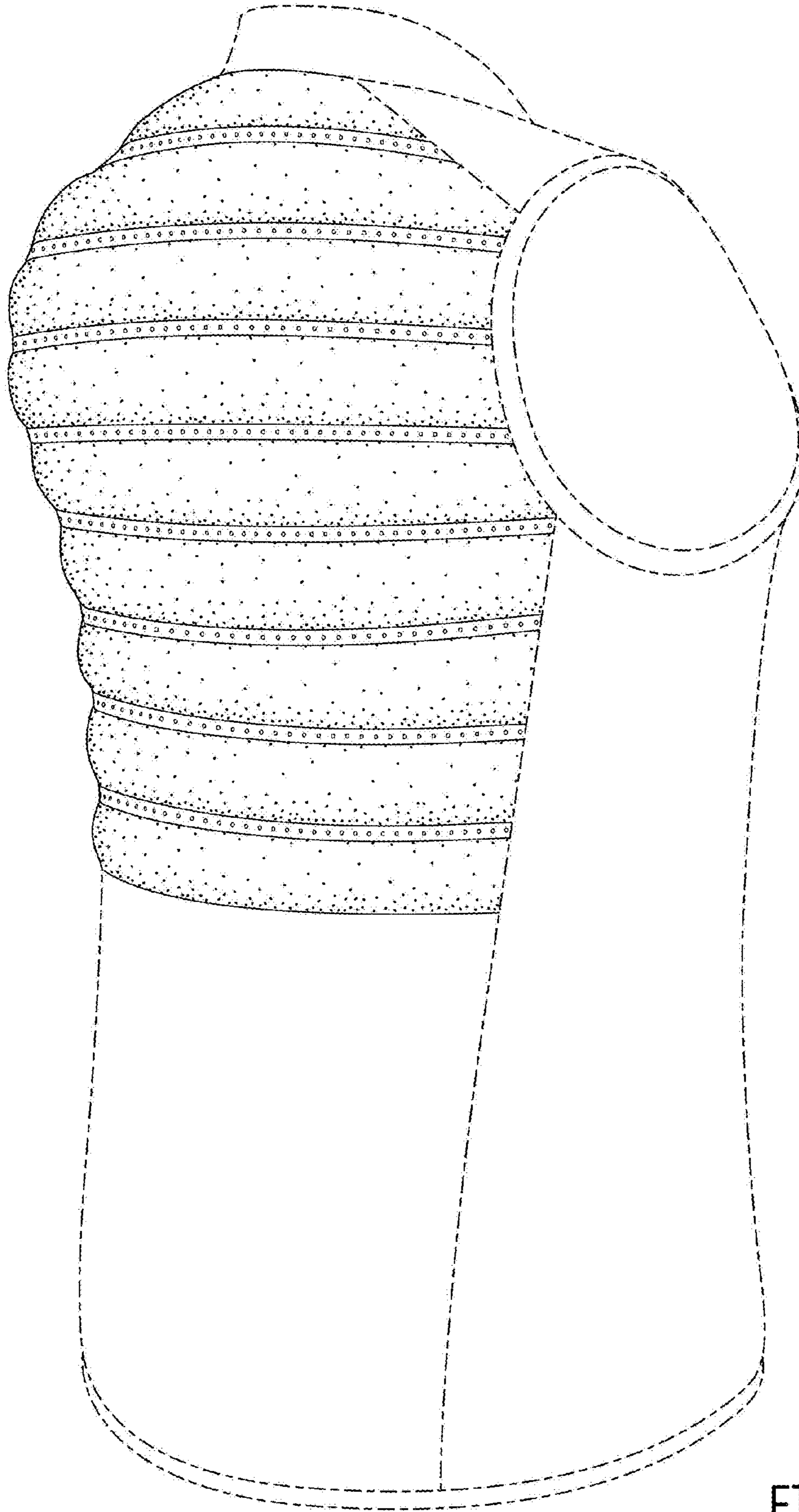

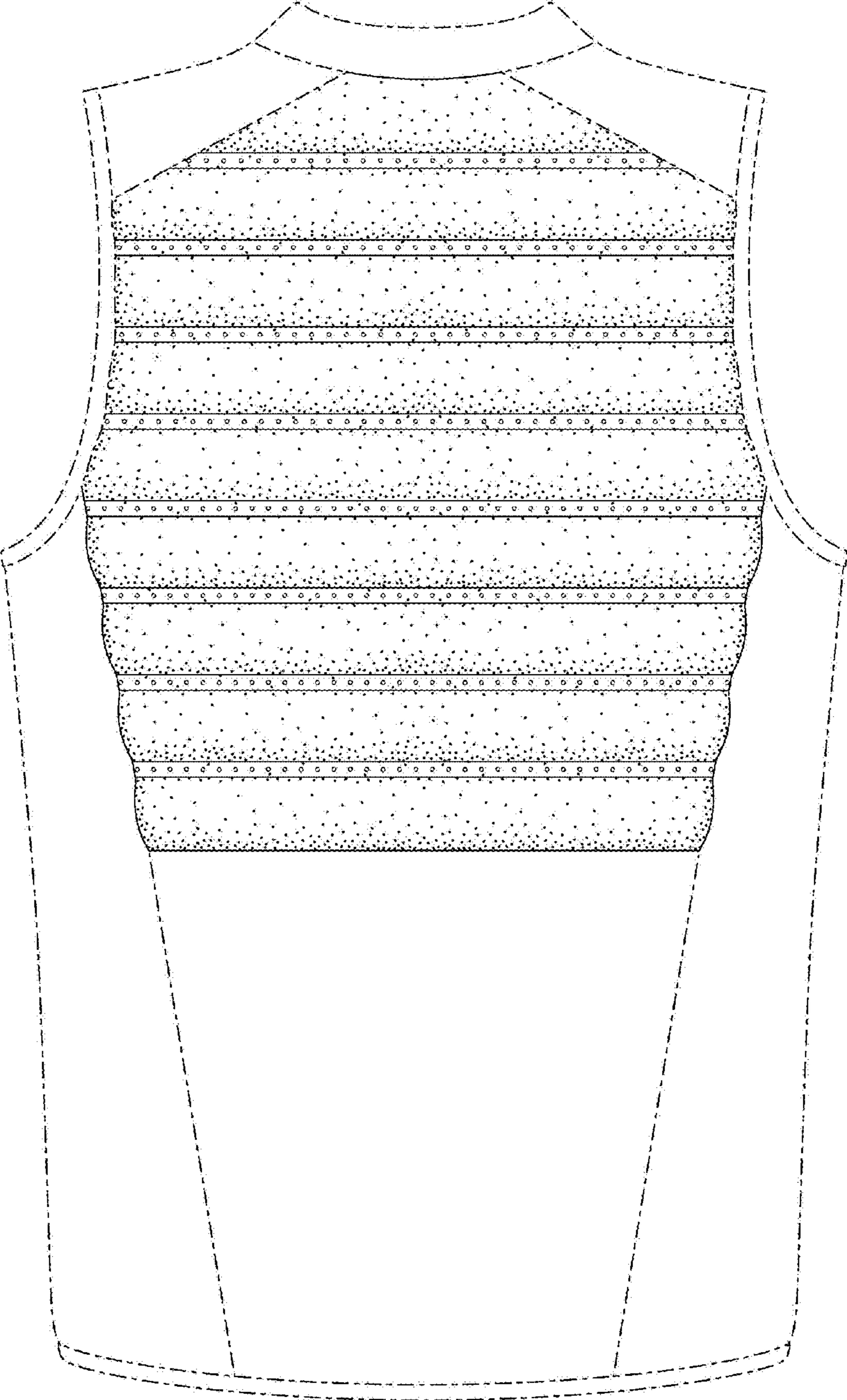

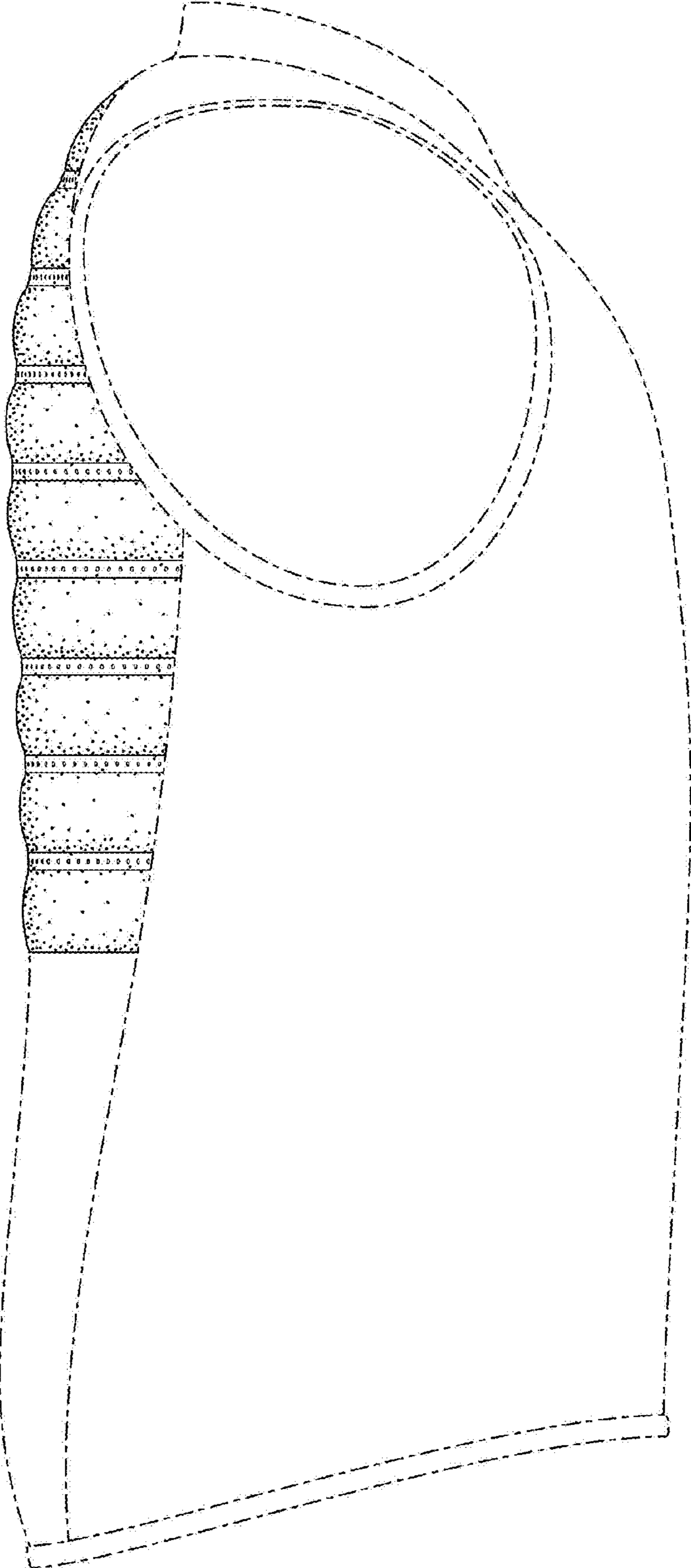

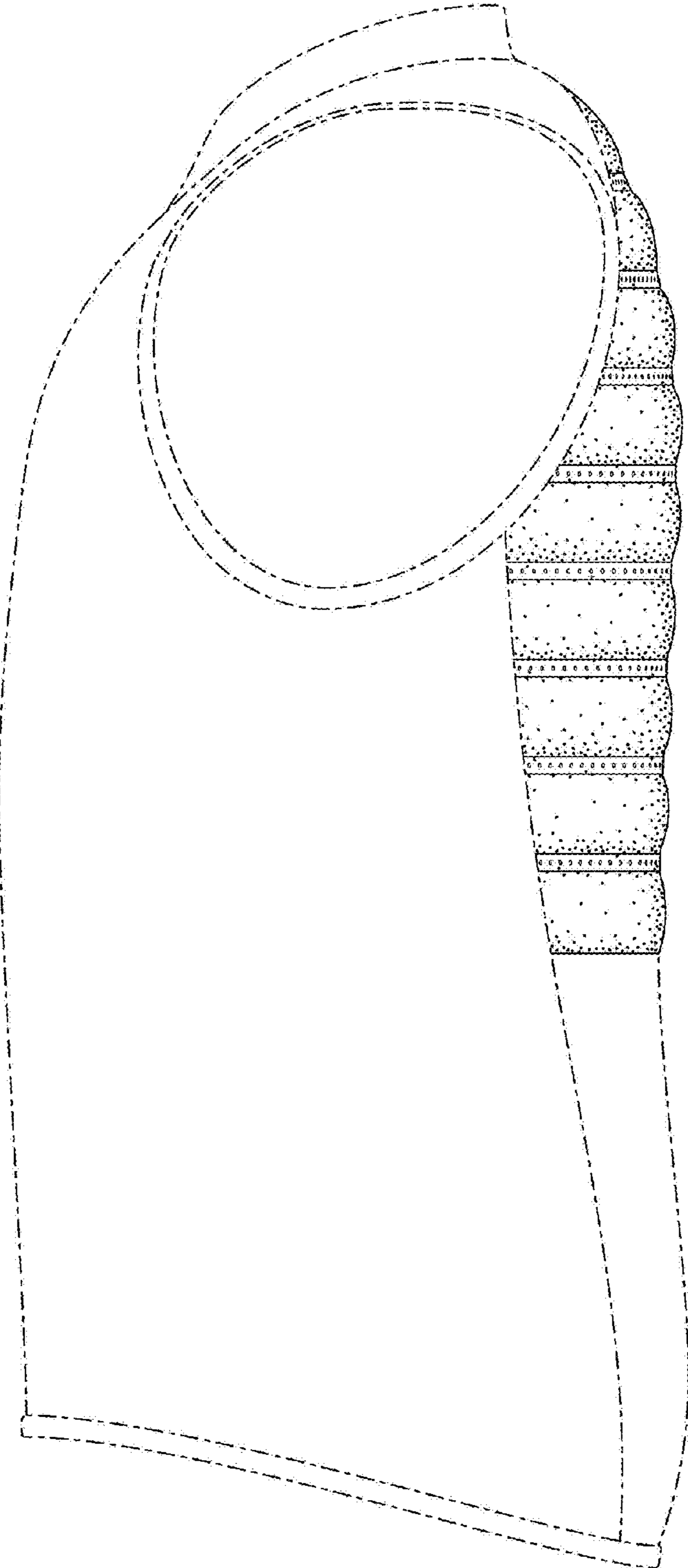

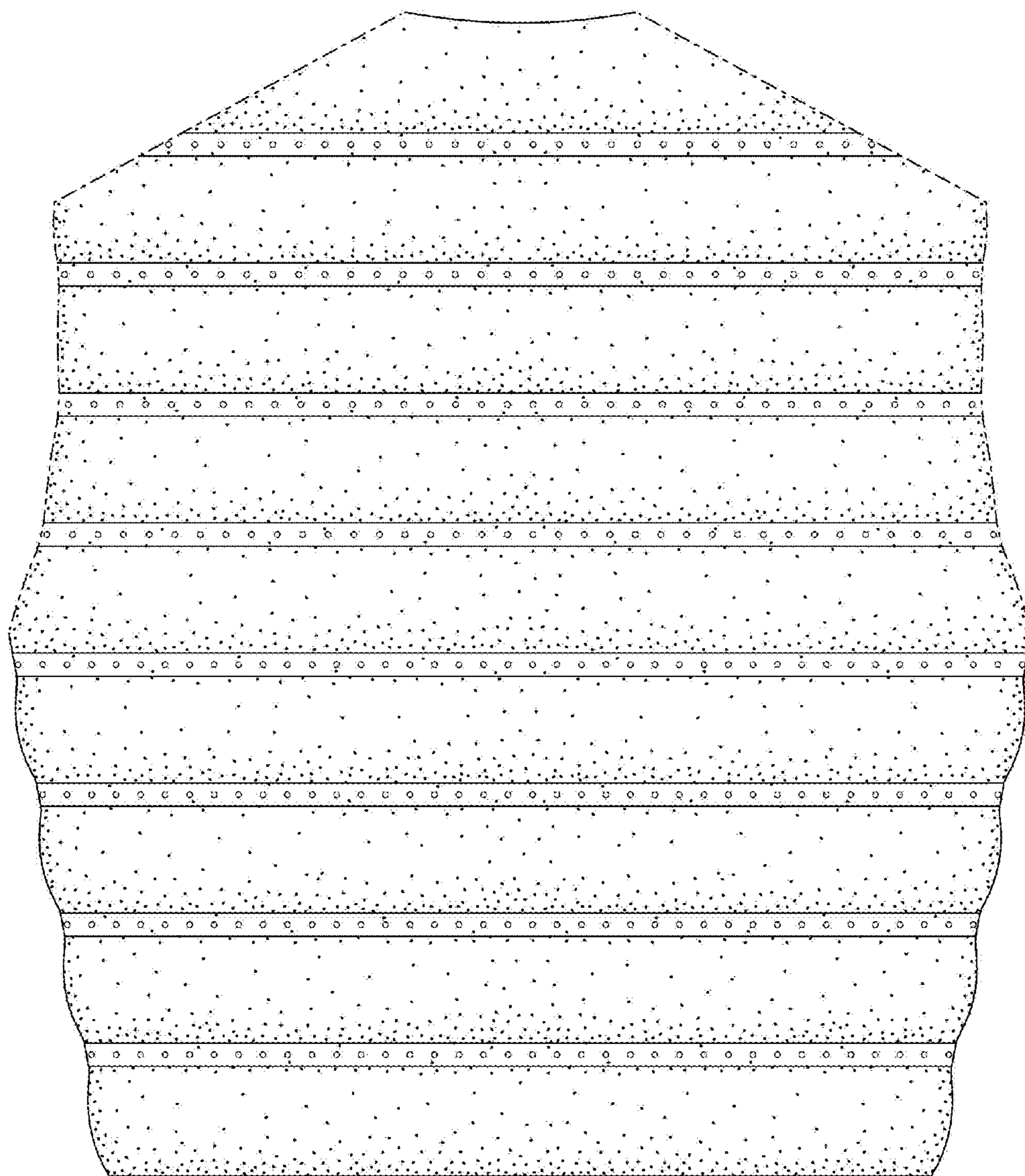
