FIG. 3 is a bottom rear perspective view thereof;

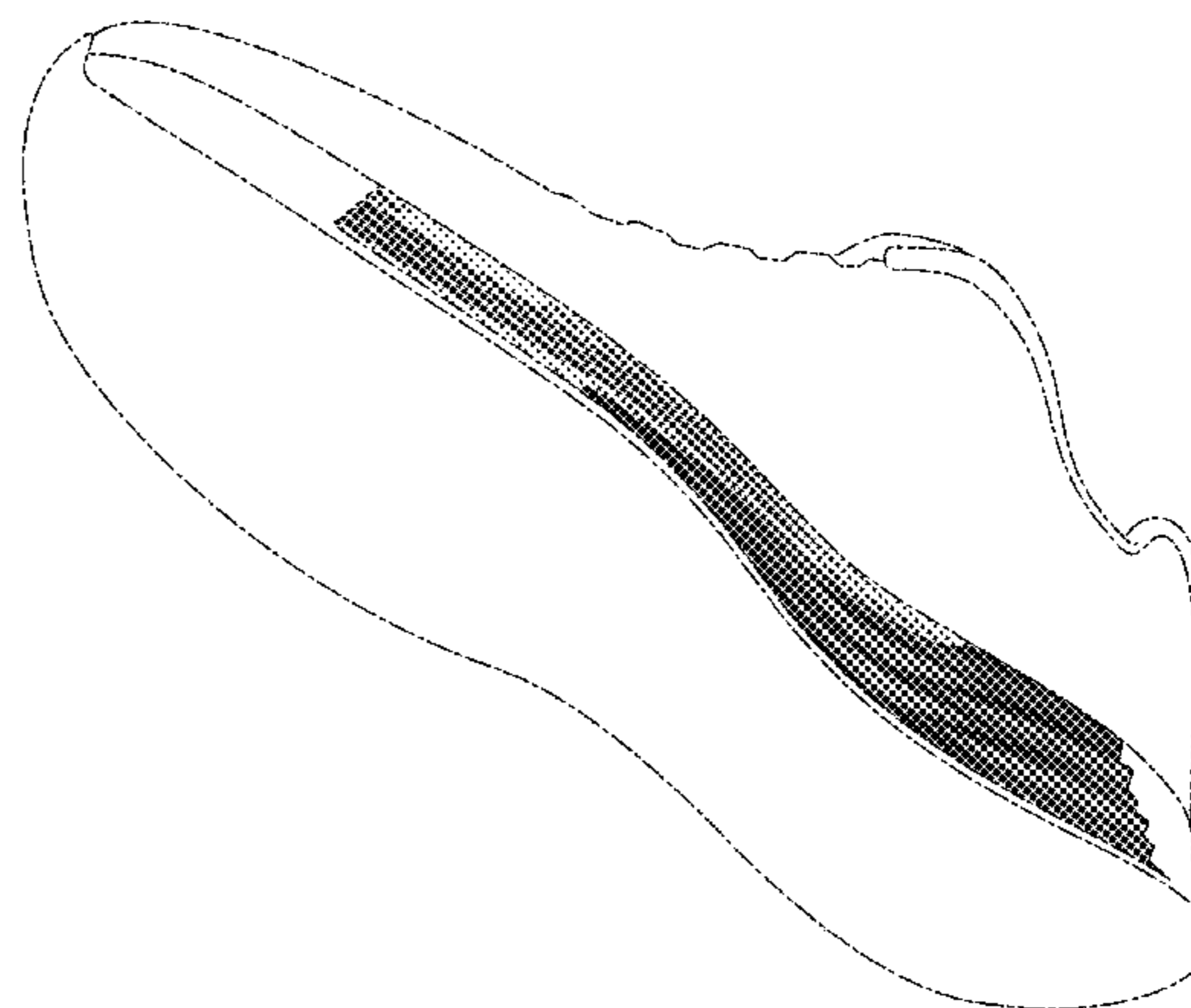
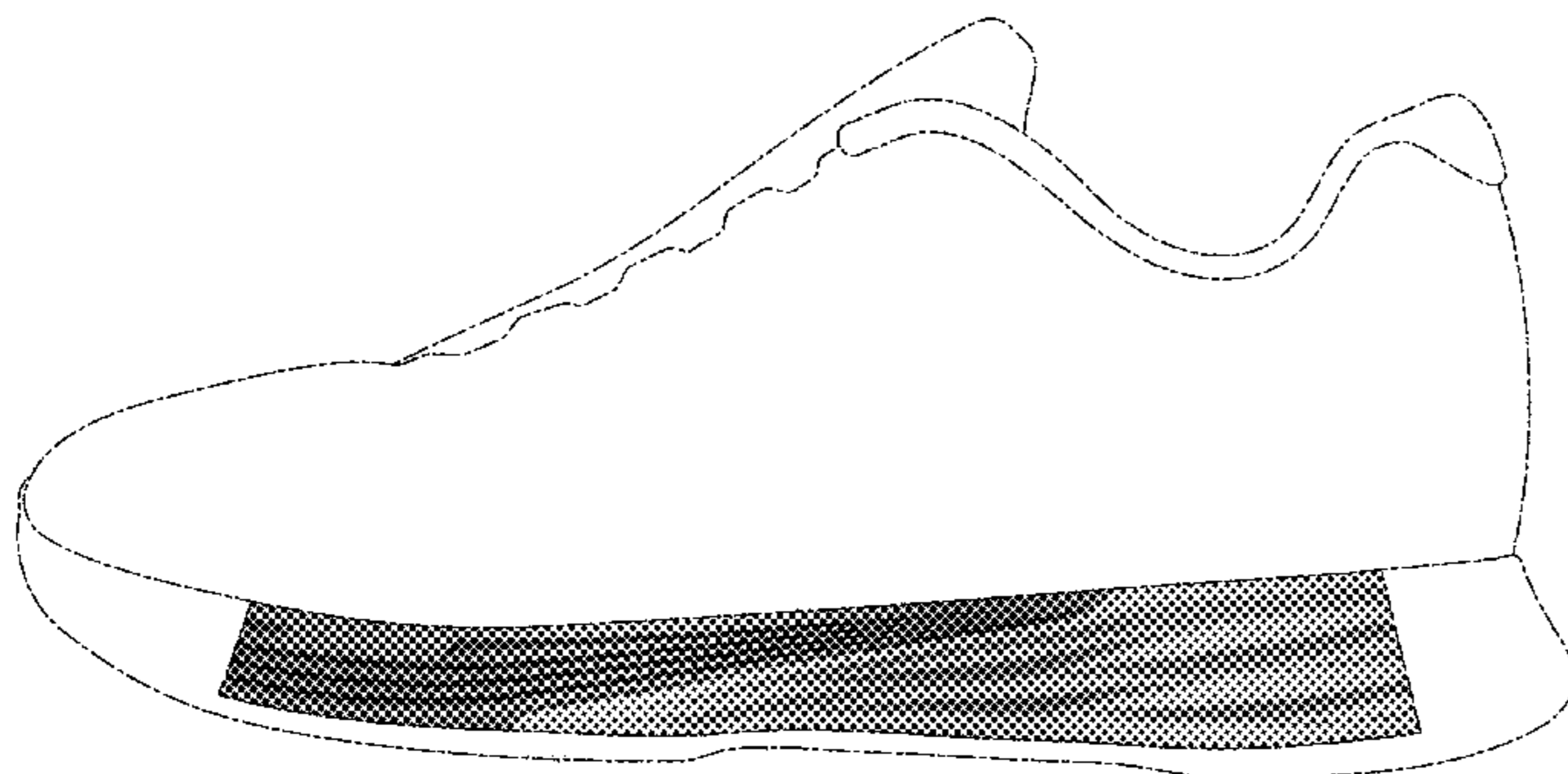
FIG. 4 is a bottom front perspective showing an alternate contrast from FIG. 1-3;

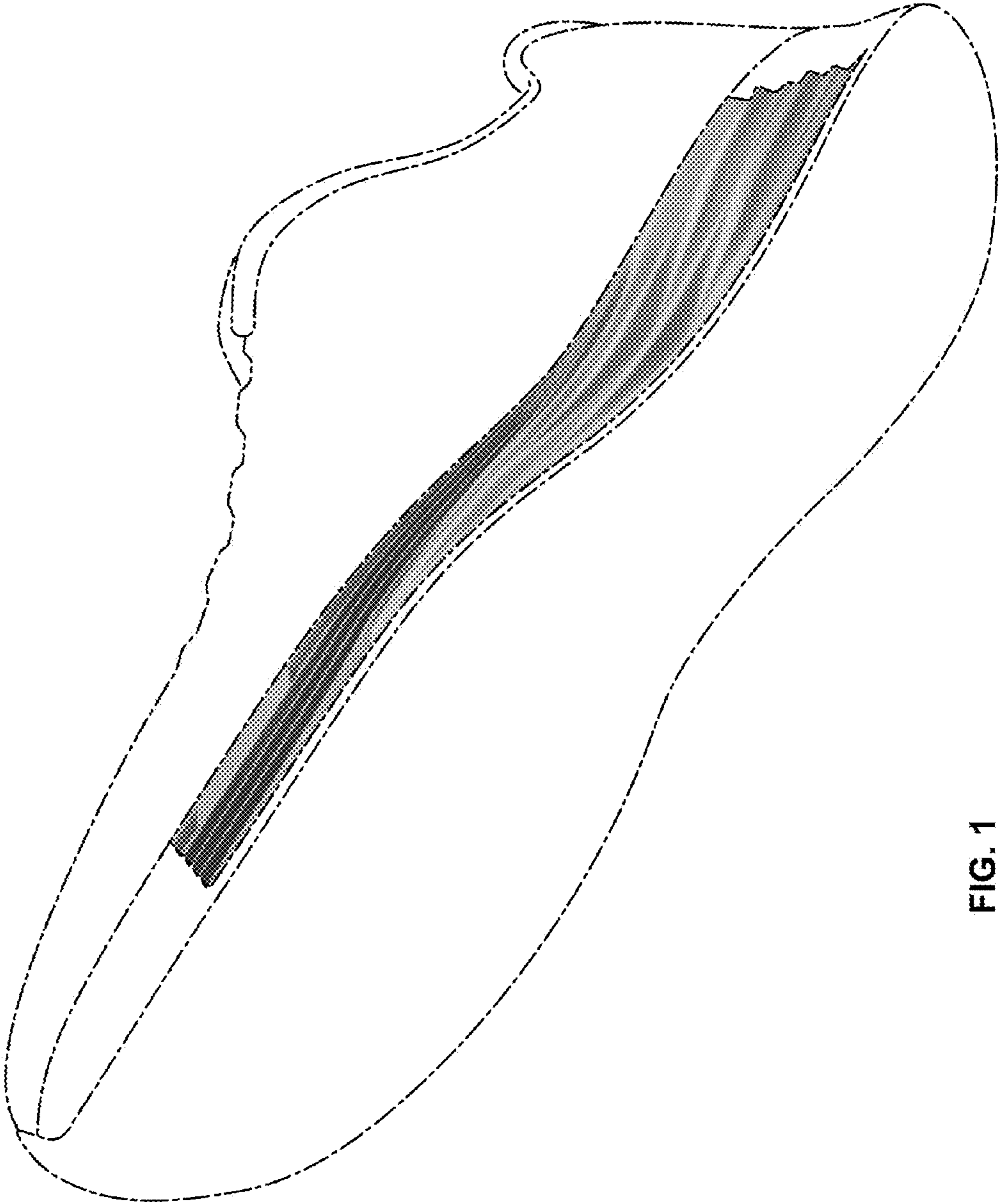

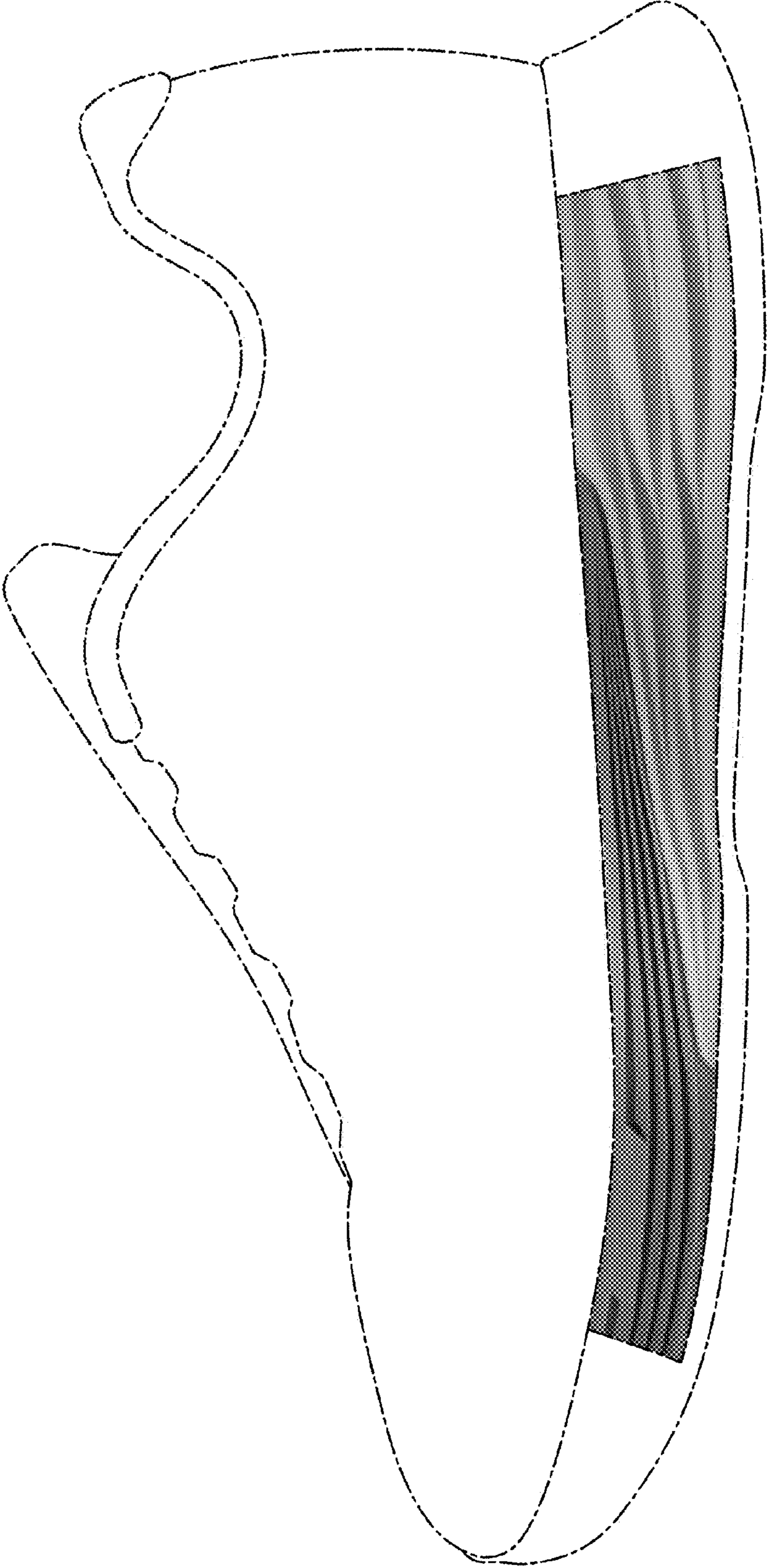

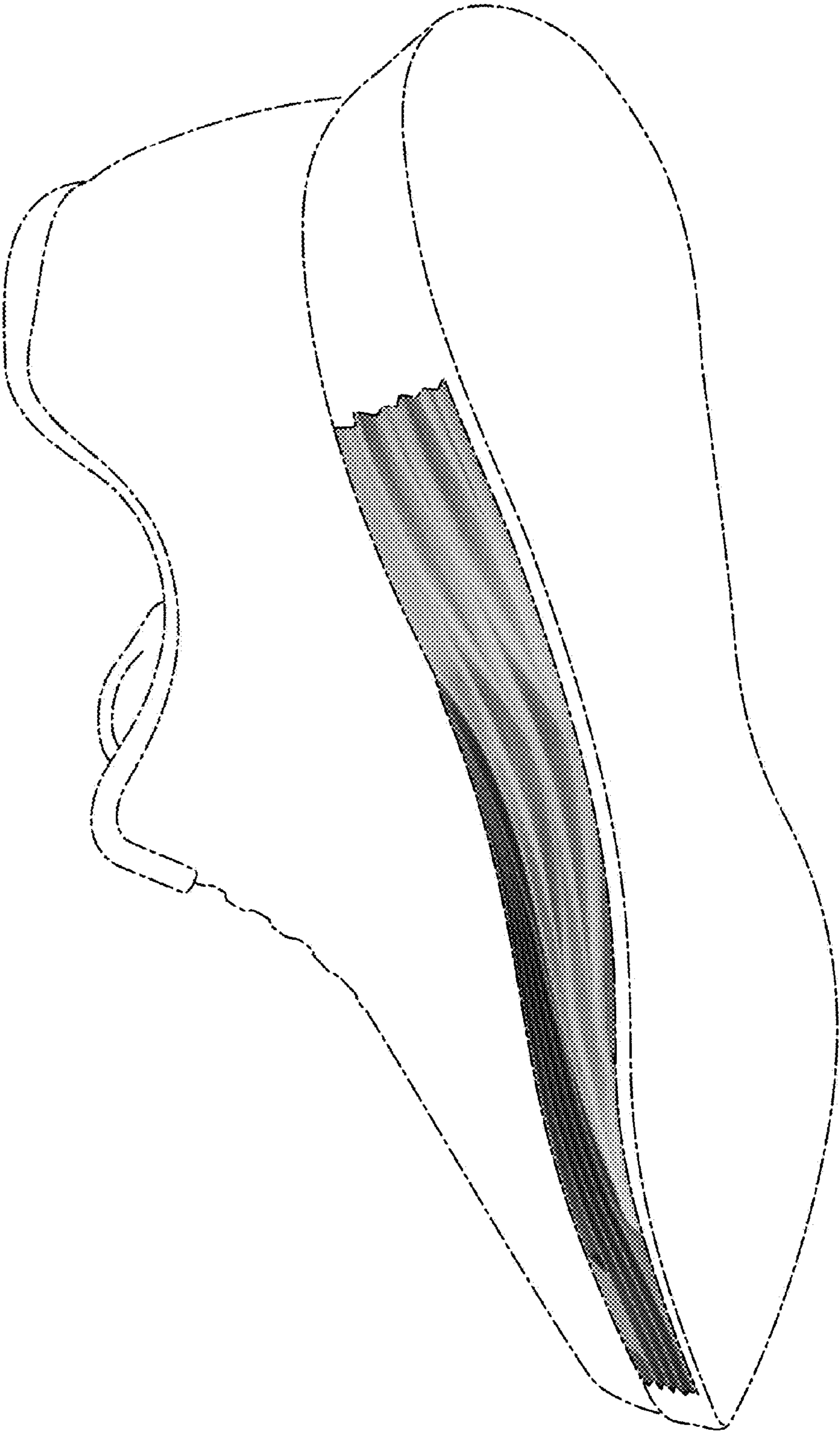

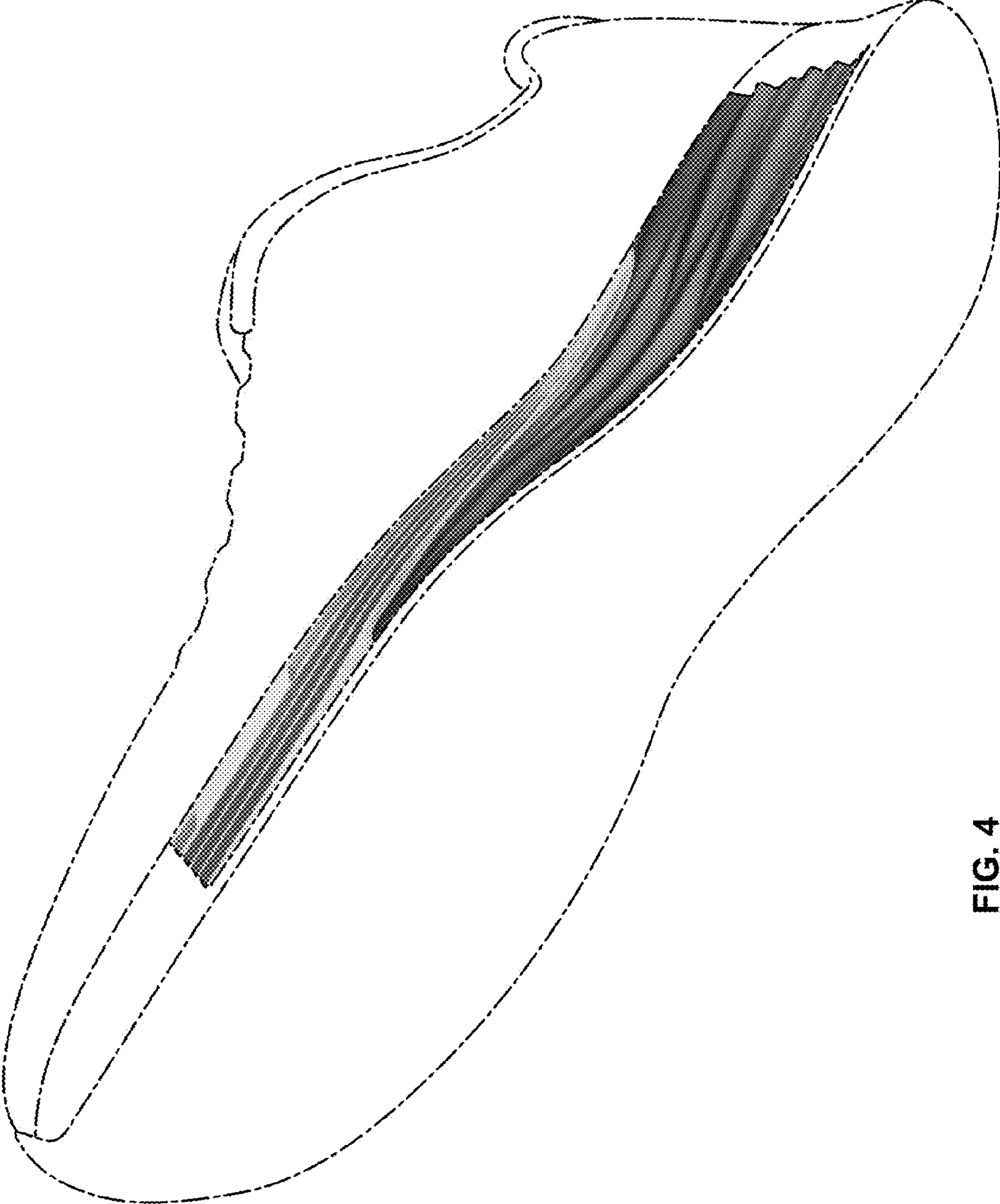

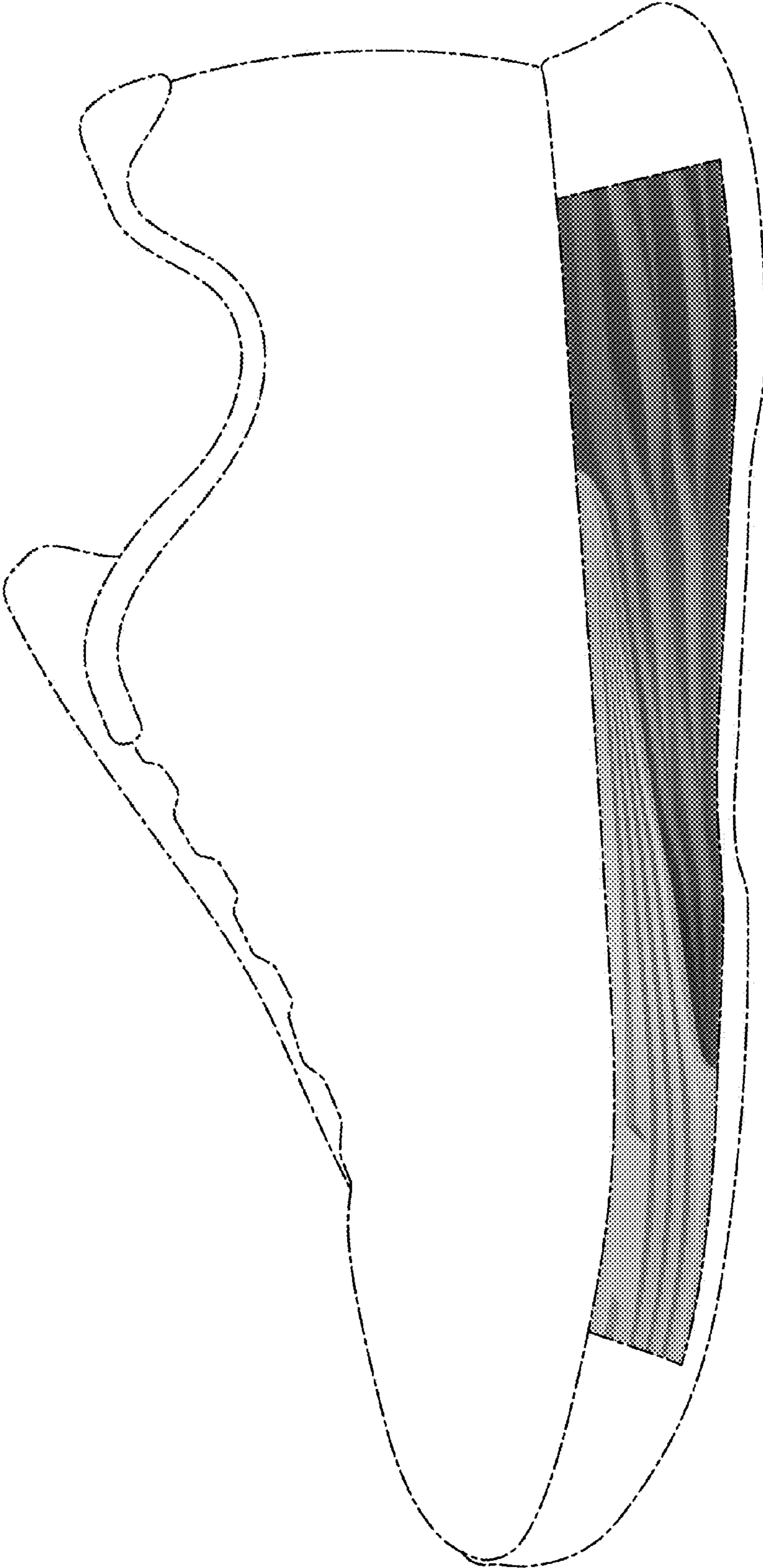

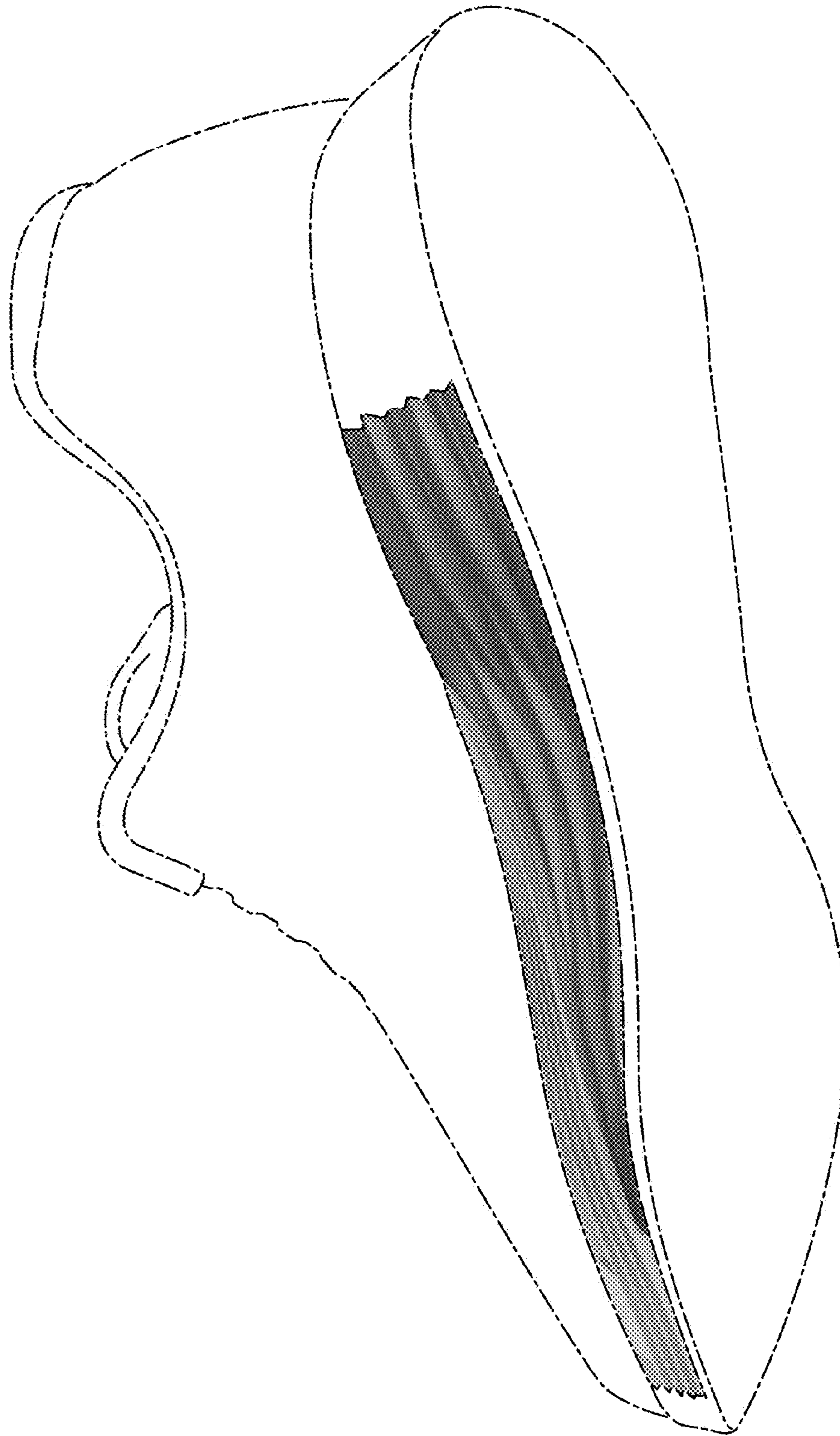
