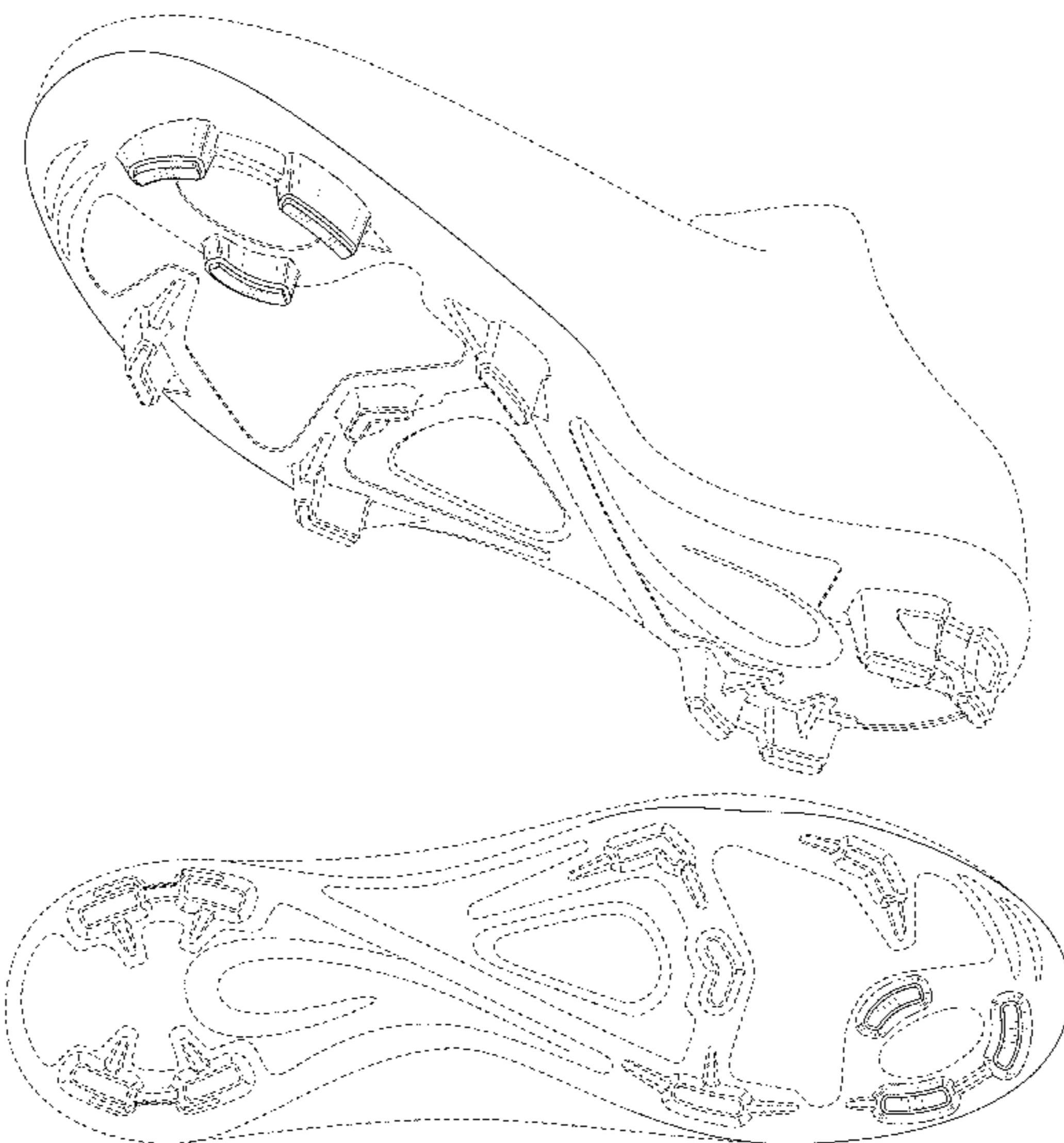
(57) **CLAIM**
The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
FIG. 2 is a plan view thereof; and,
FIG. 3 is a rear perspective view thereof.
The uneven-length broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The even-length broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

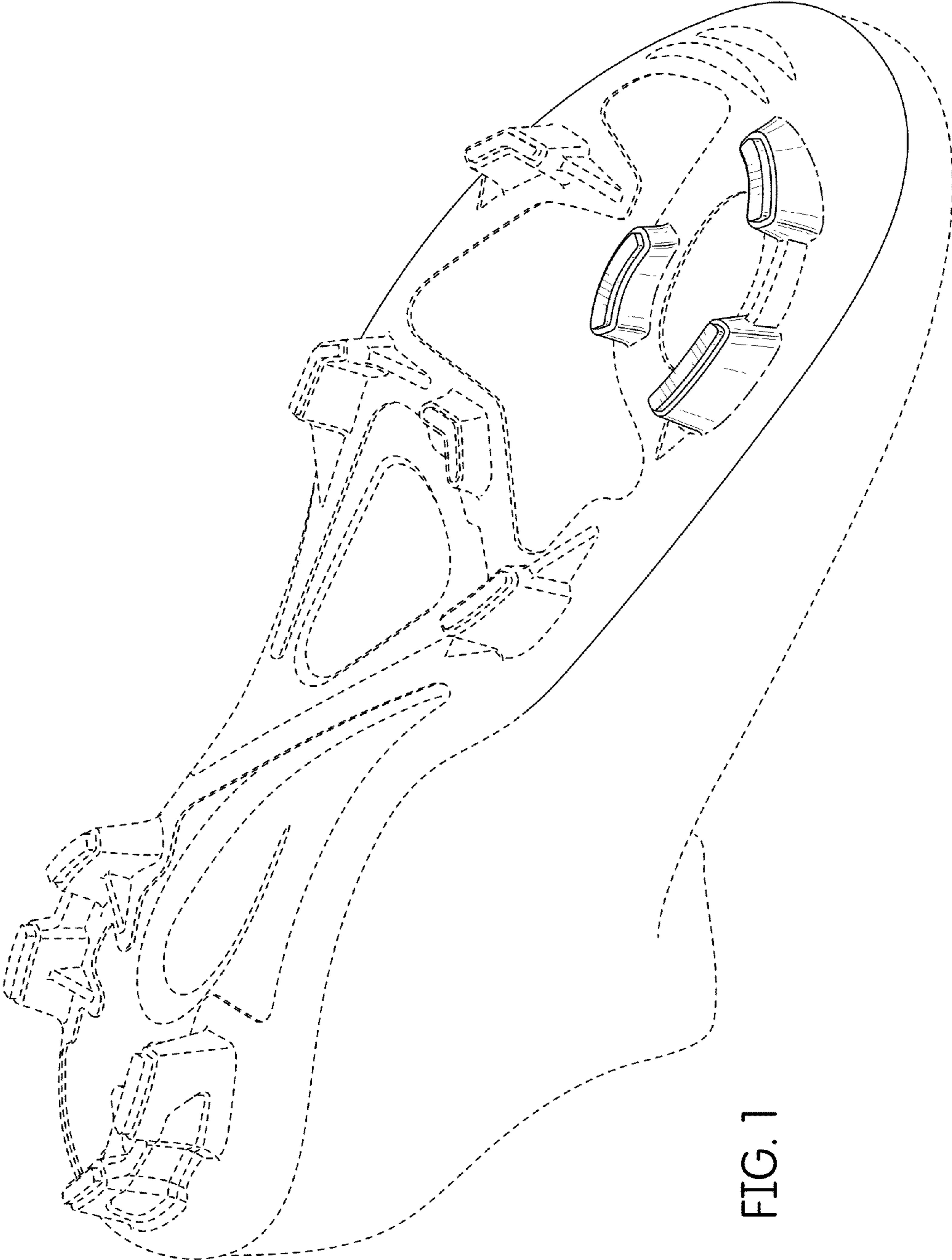

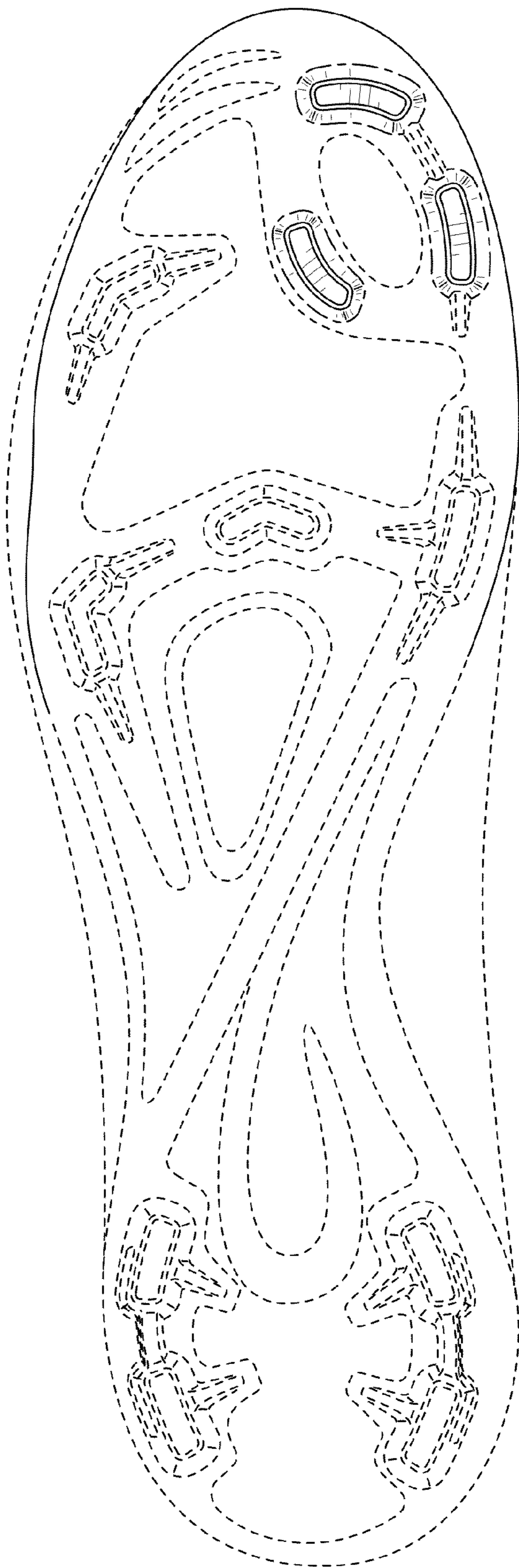

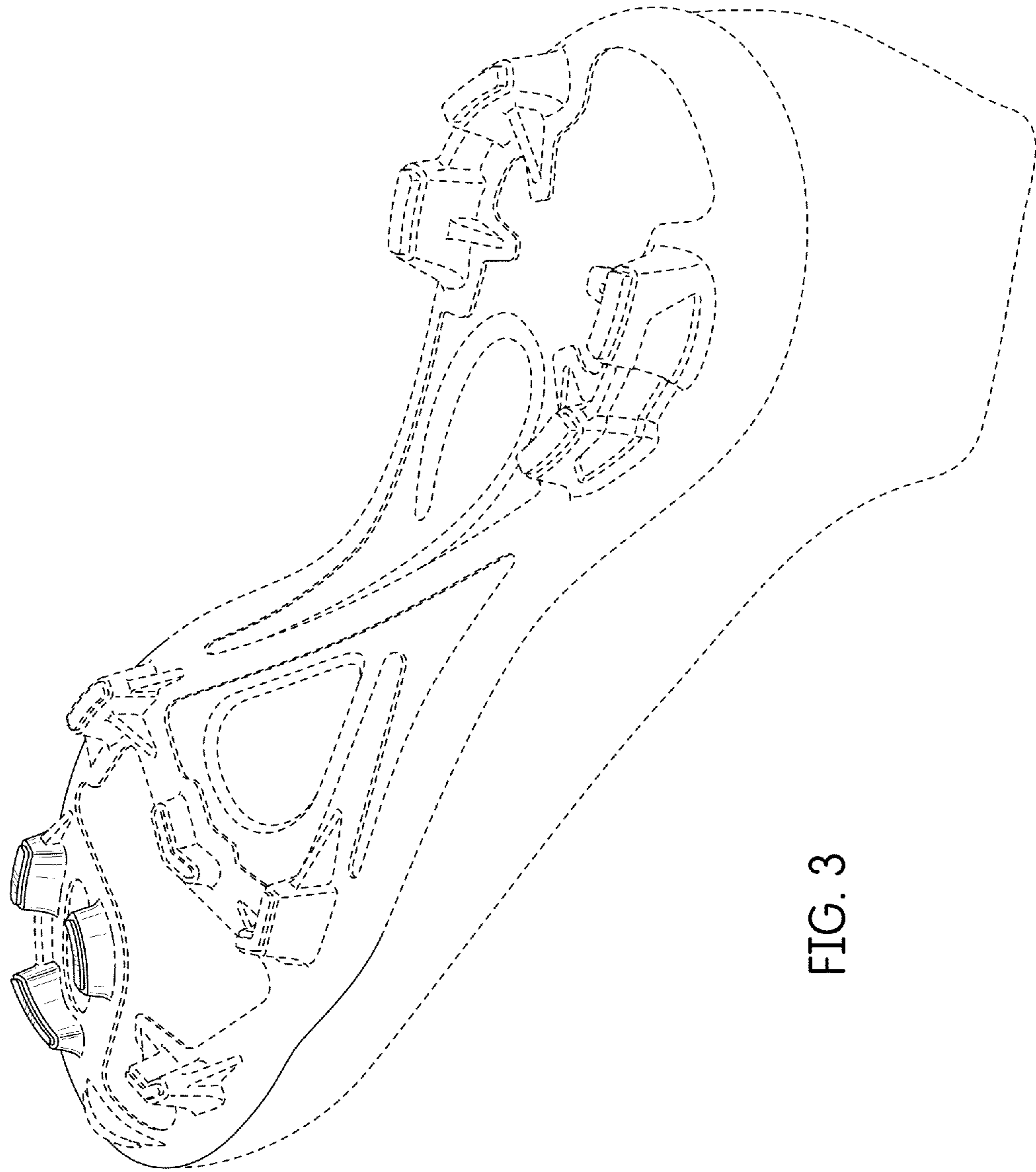
