DESCRIPTION

FIG. 1 is a perspective view of a case for electronic device showing our new design;

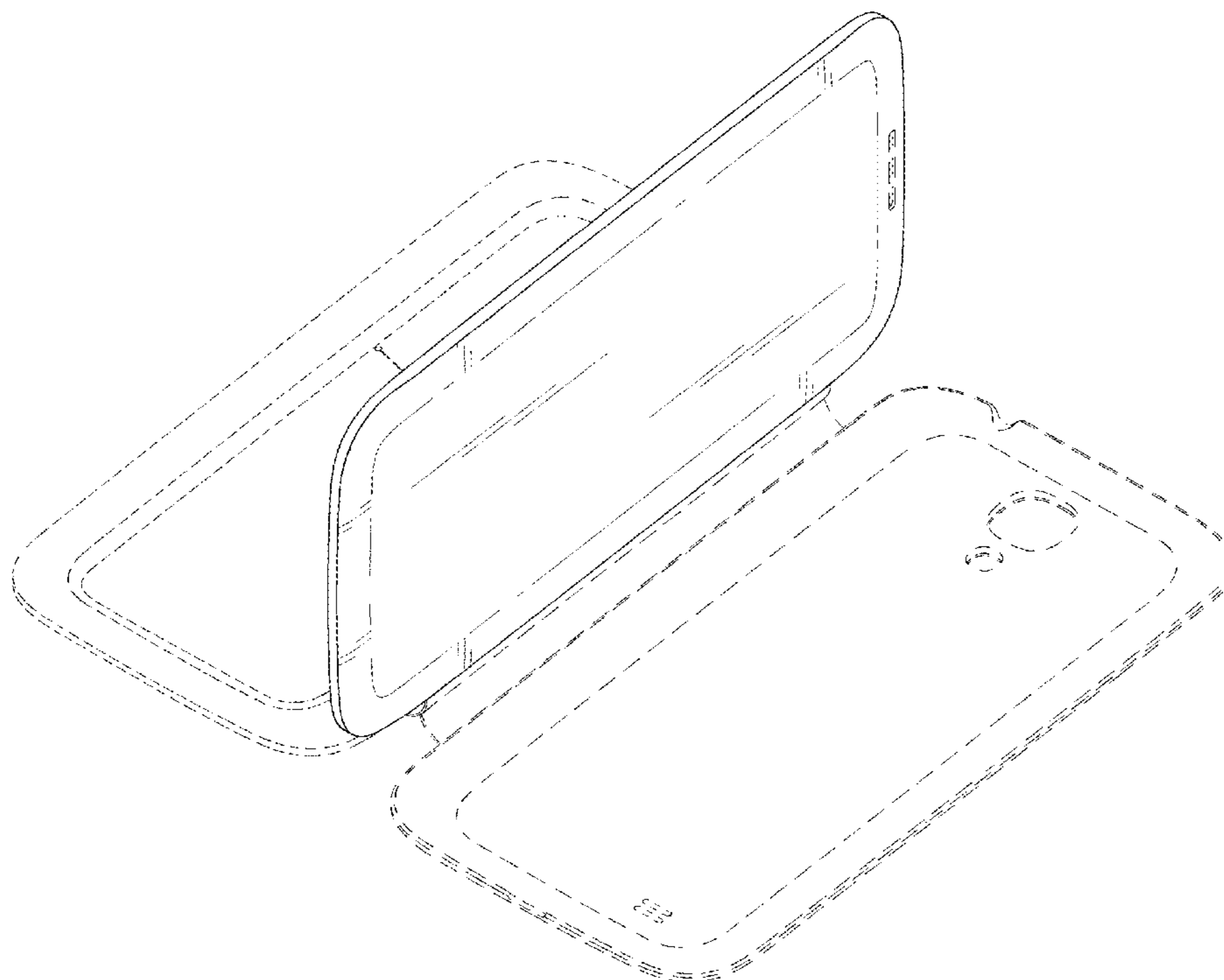

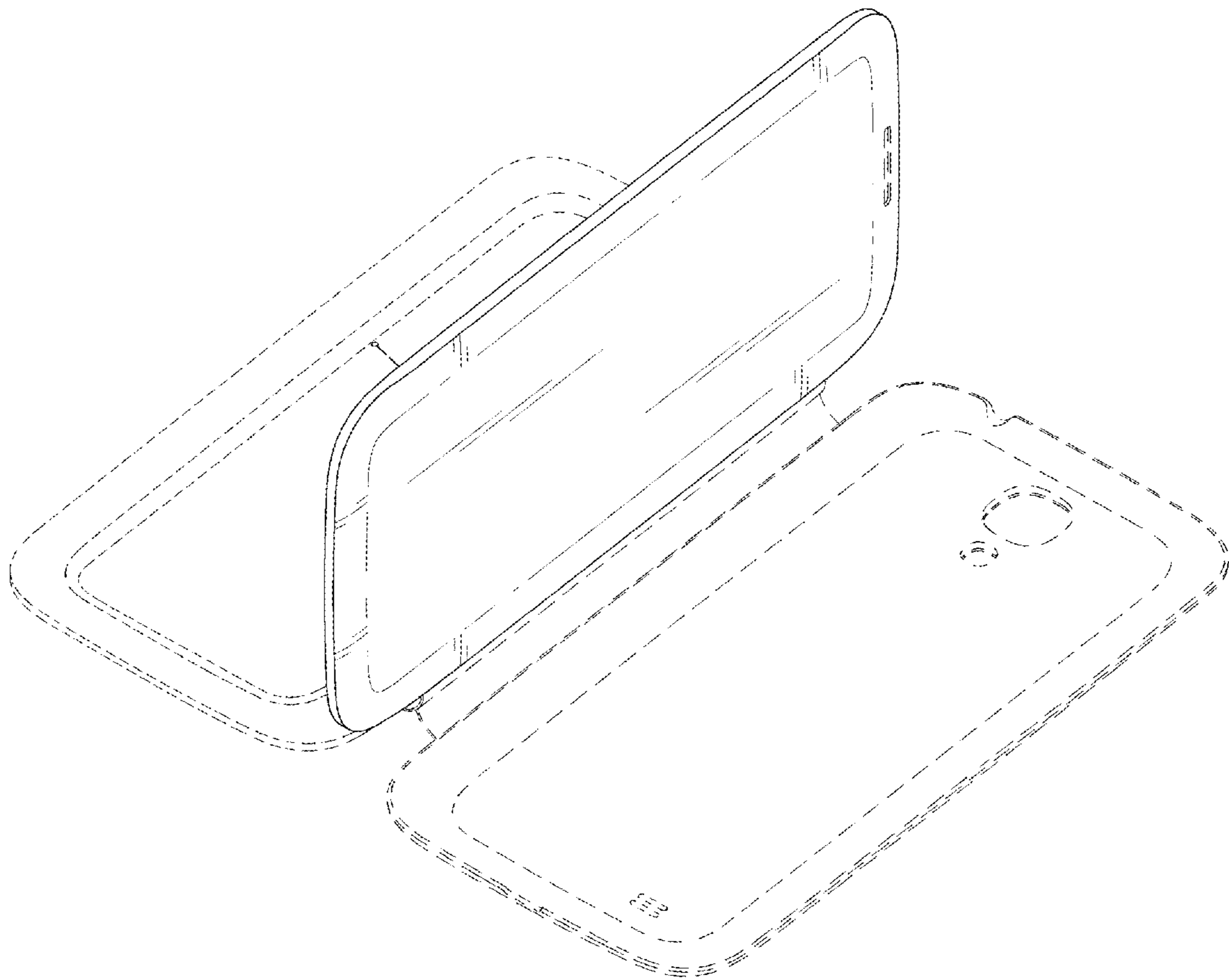

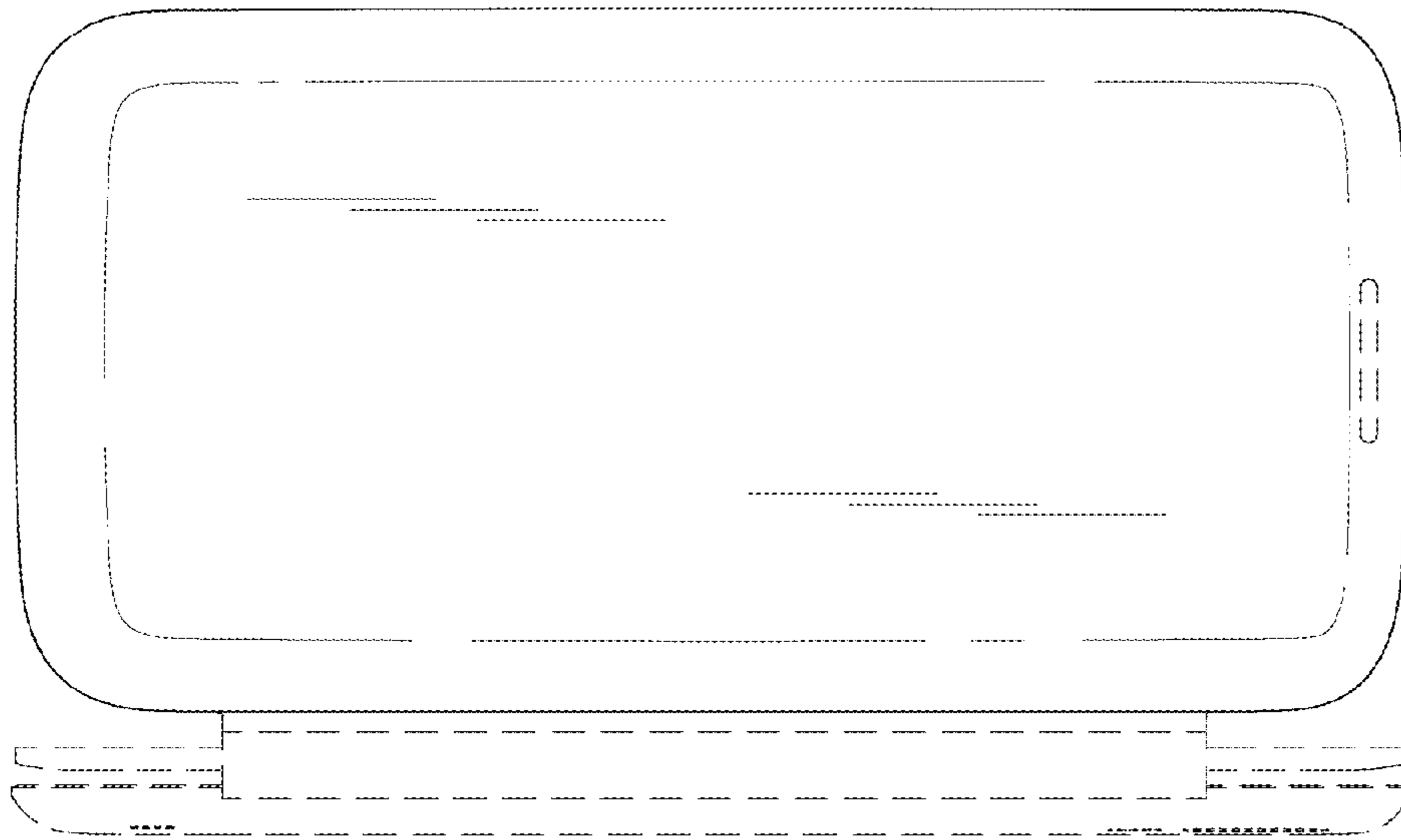

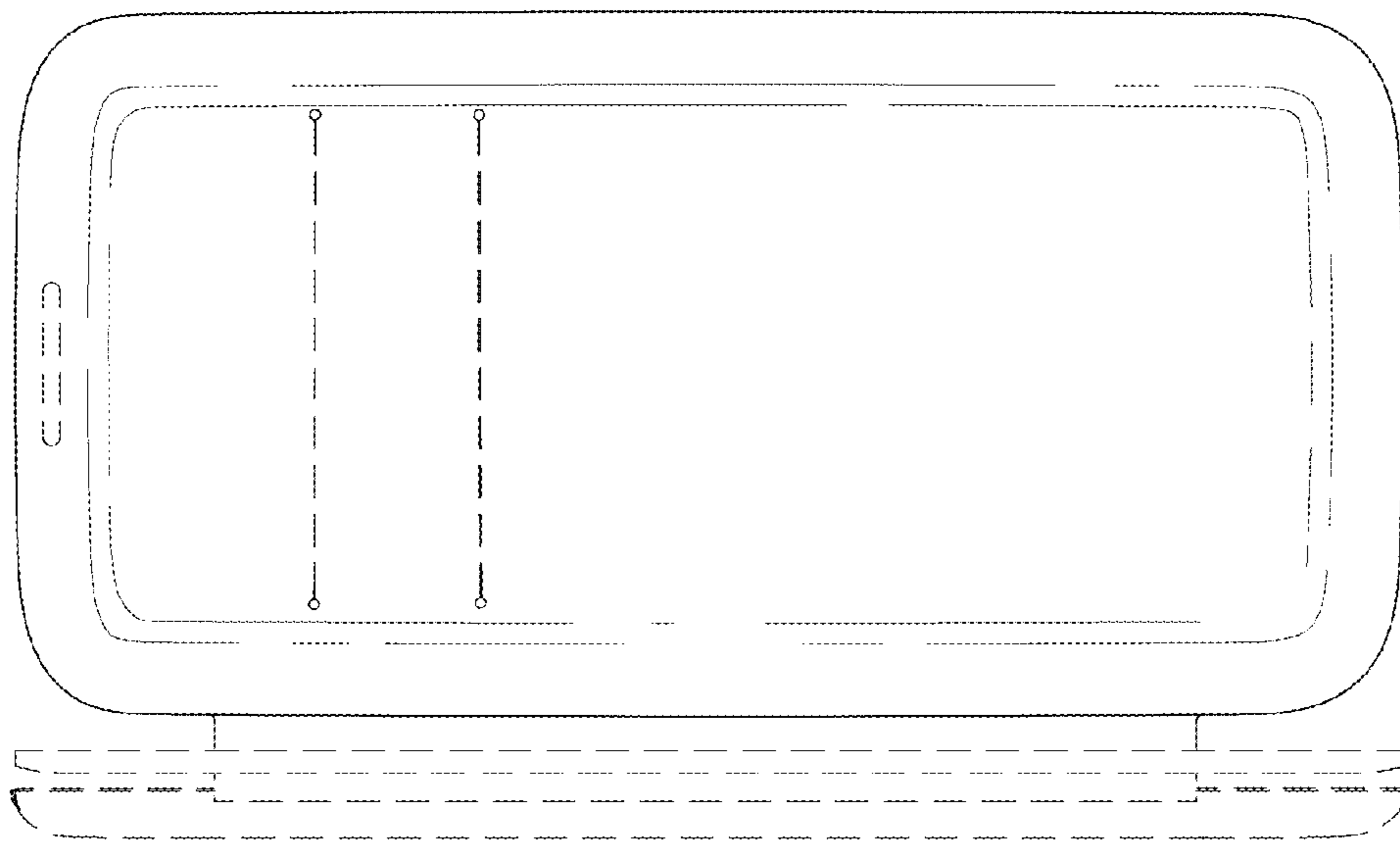

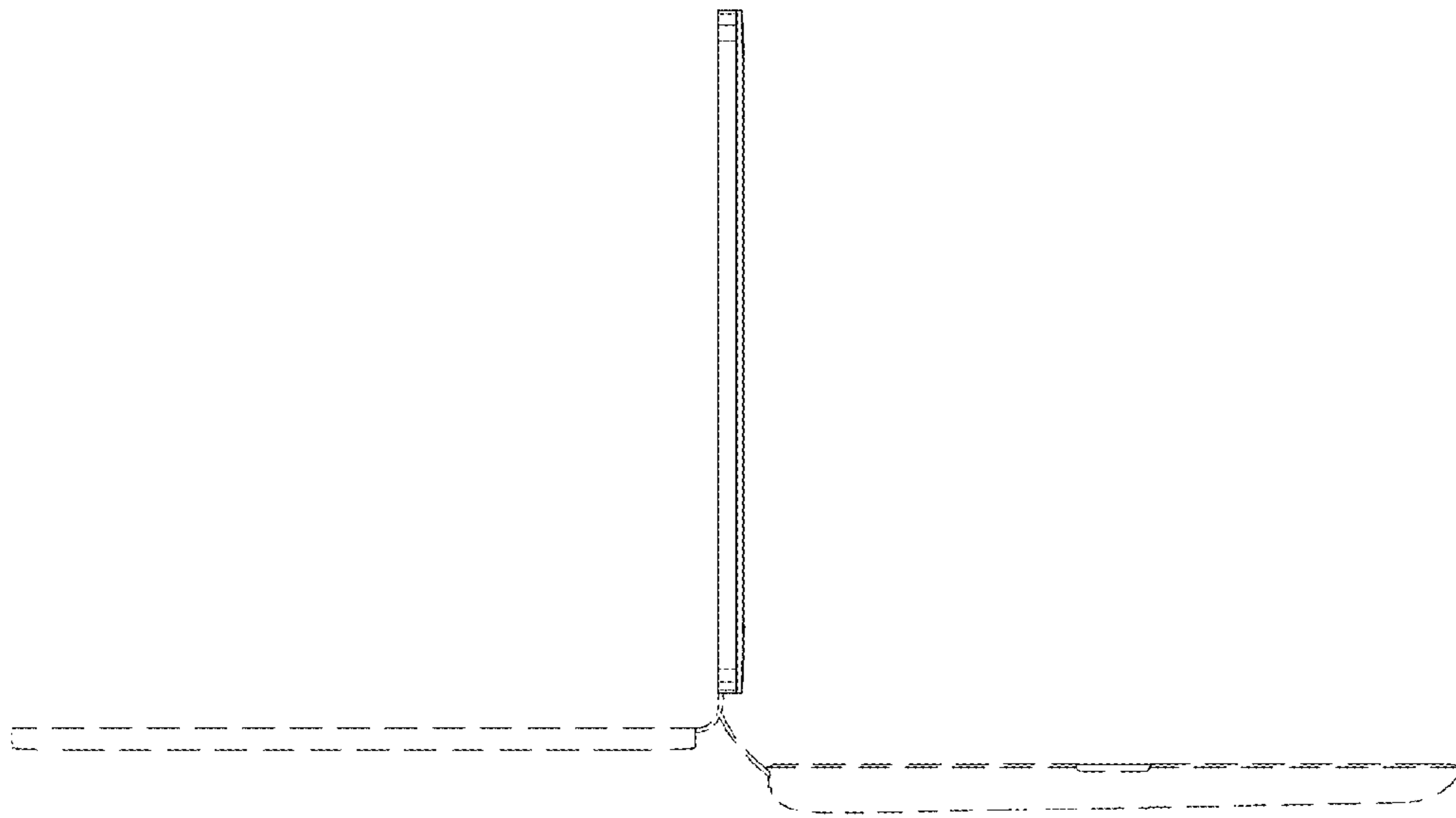

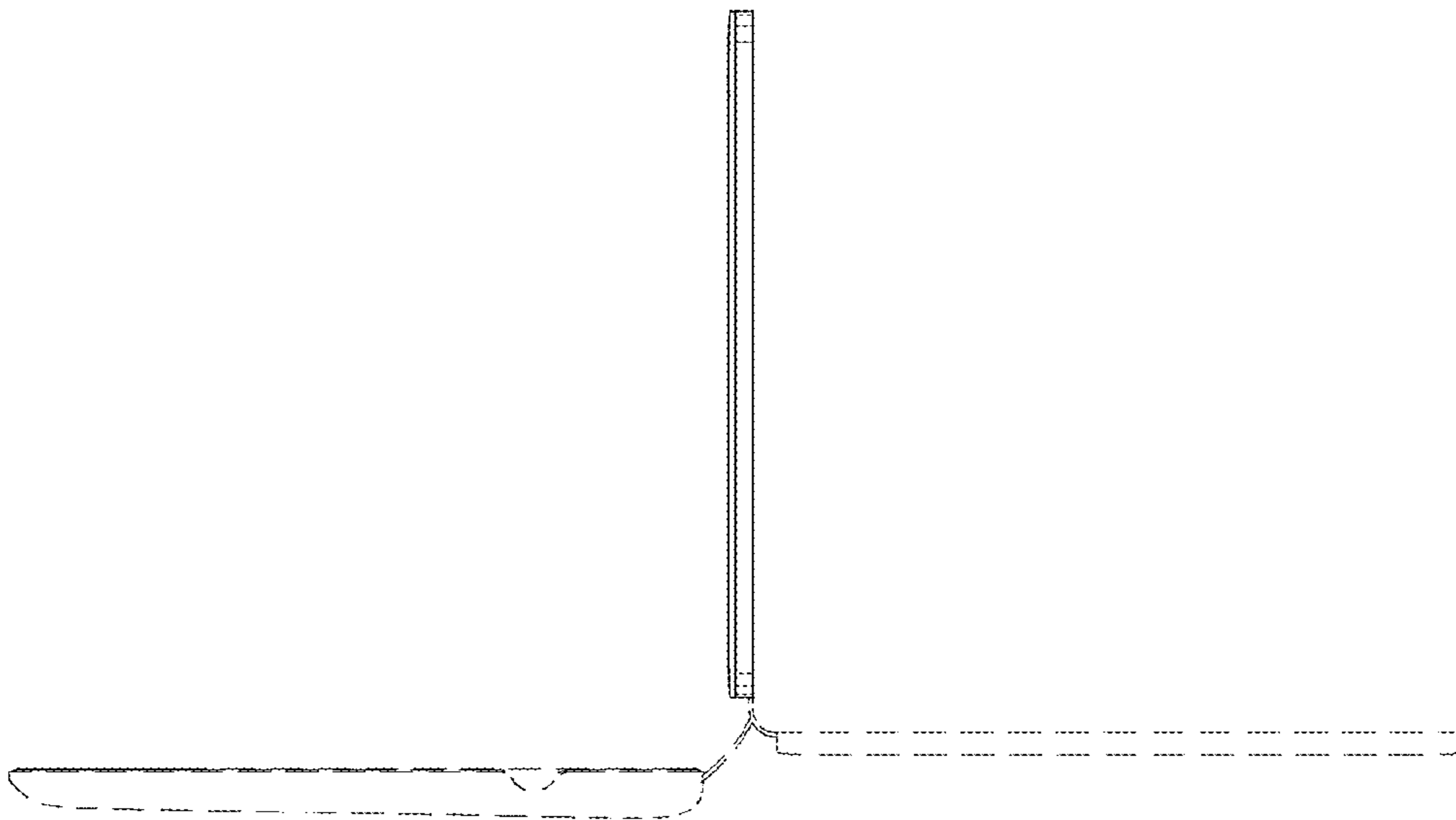

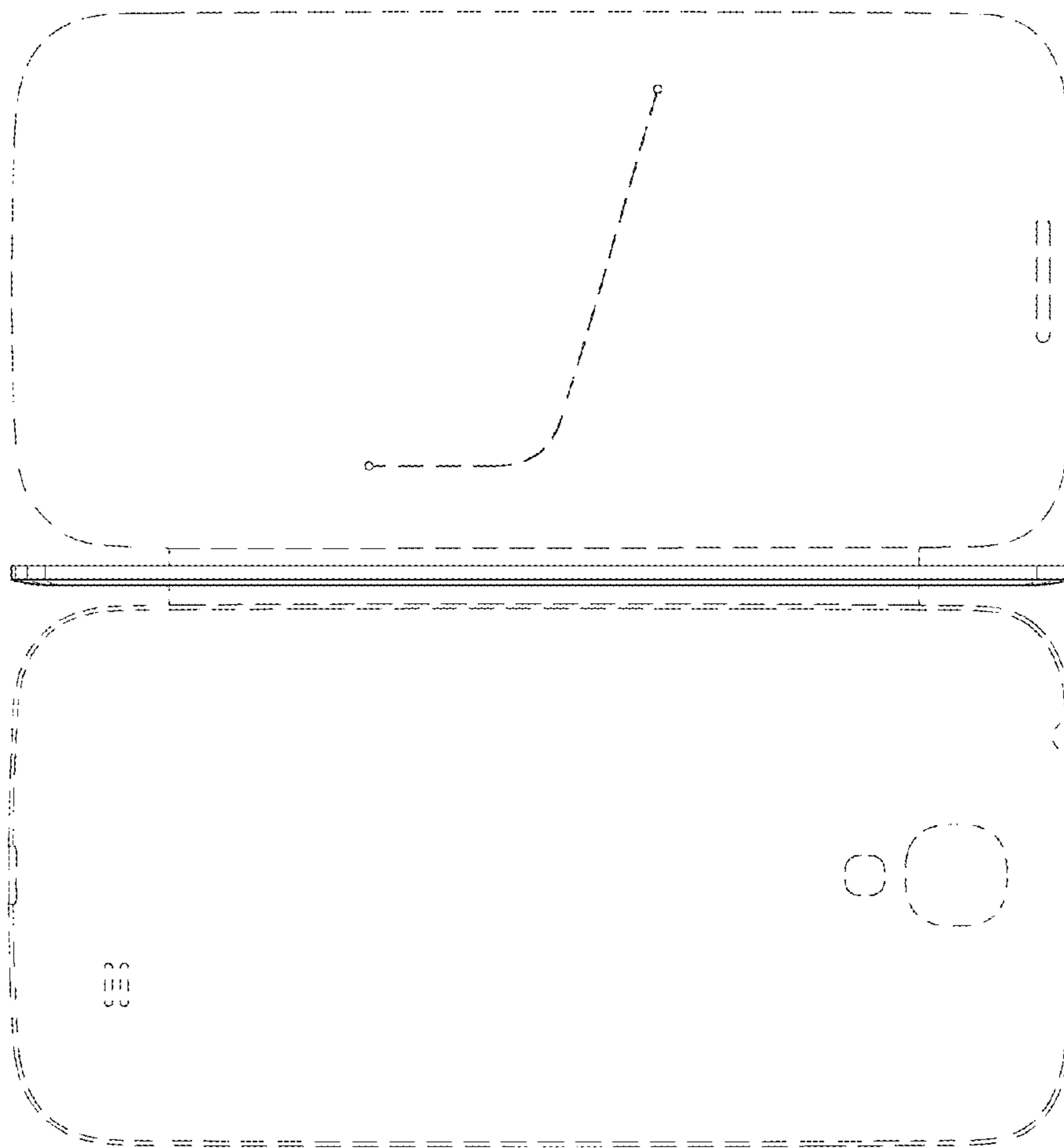

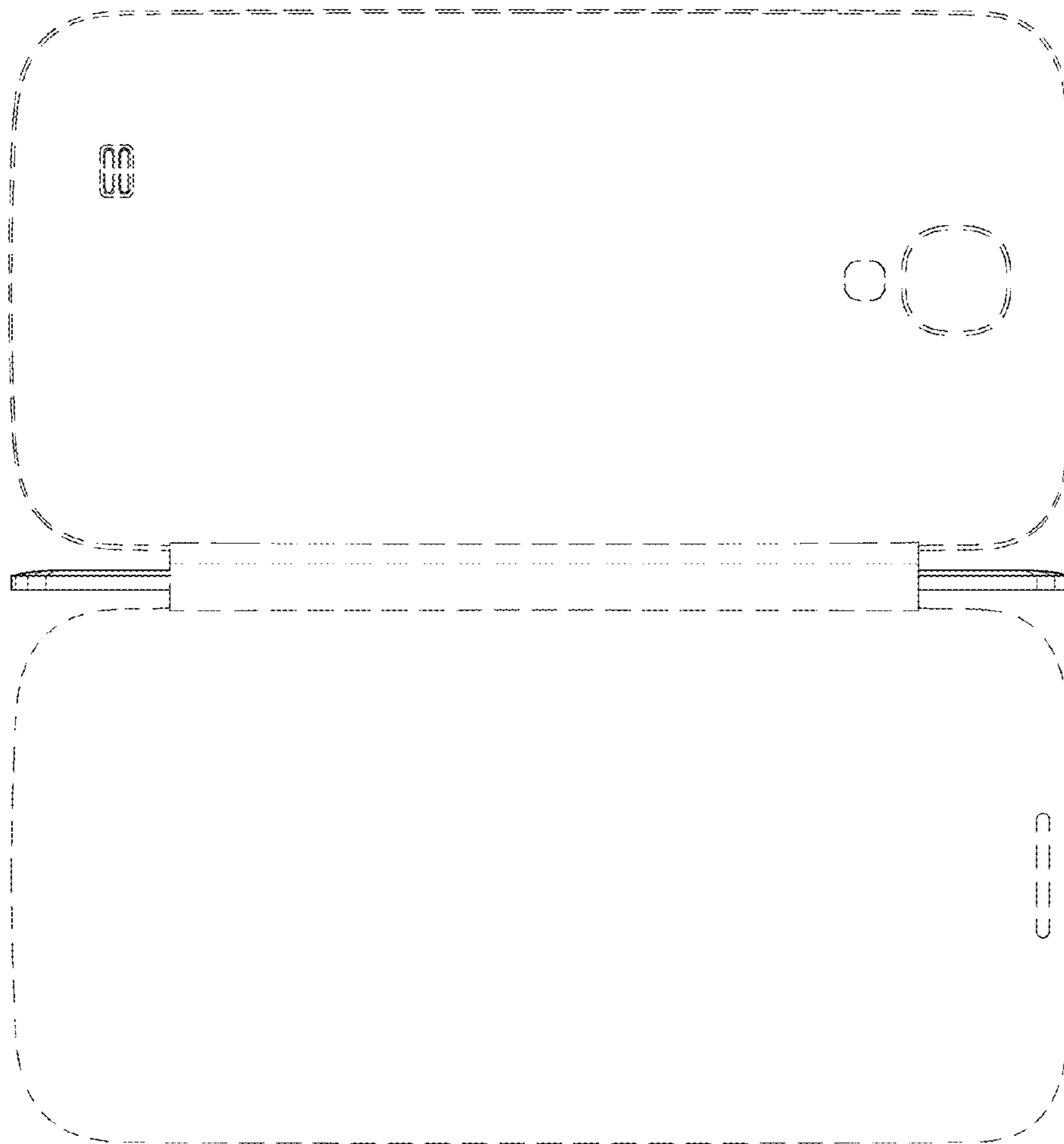

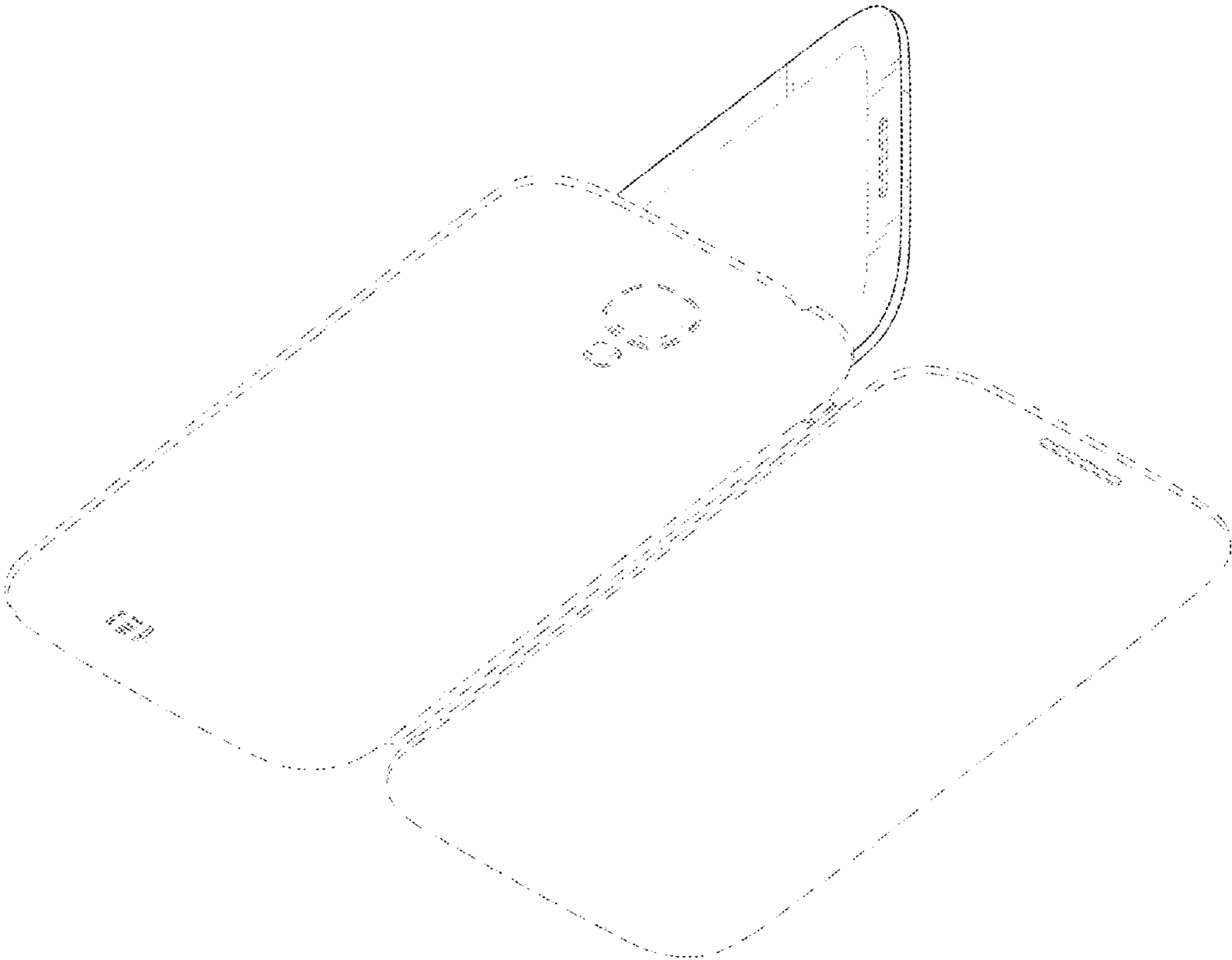
