FIG. 1 is a Left side view of the knife blade showing my new design, the Right side view being a mirror view of the Left side;

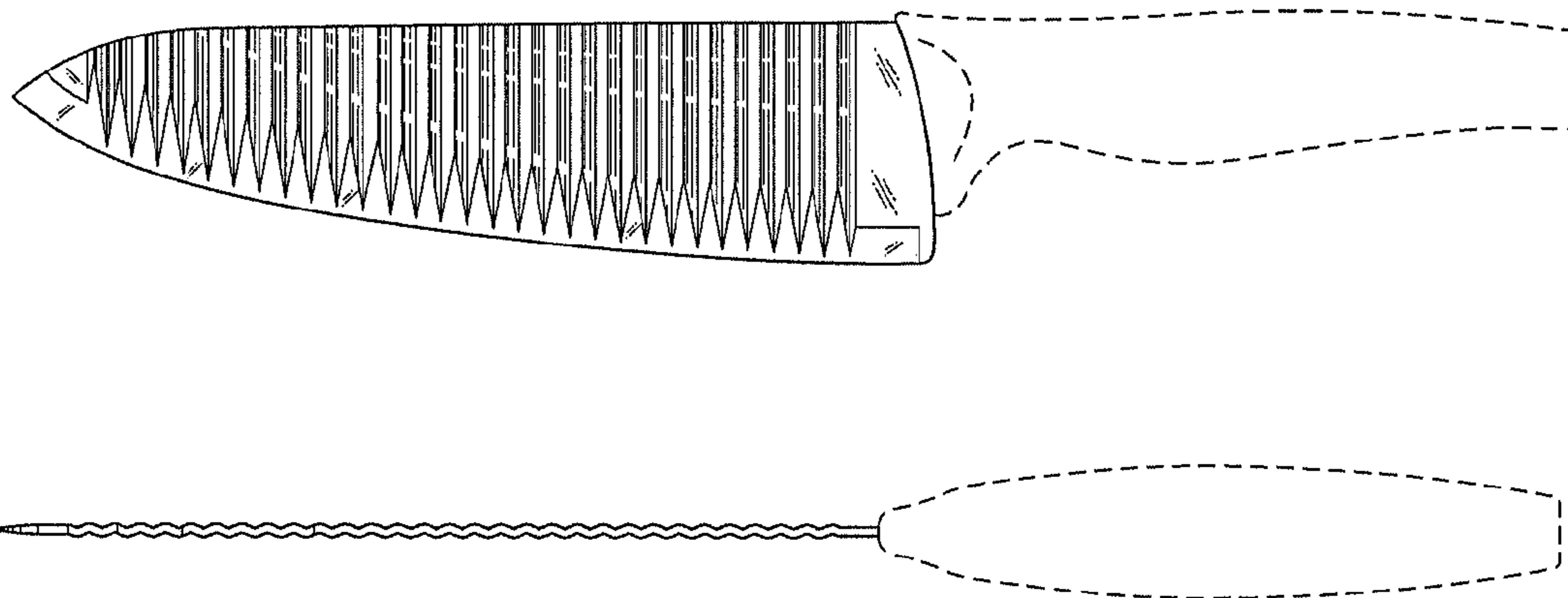
FIG. 2 is a Top side view thereof;

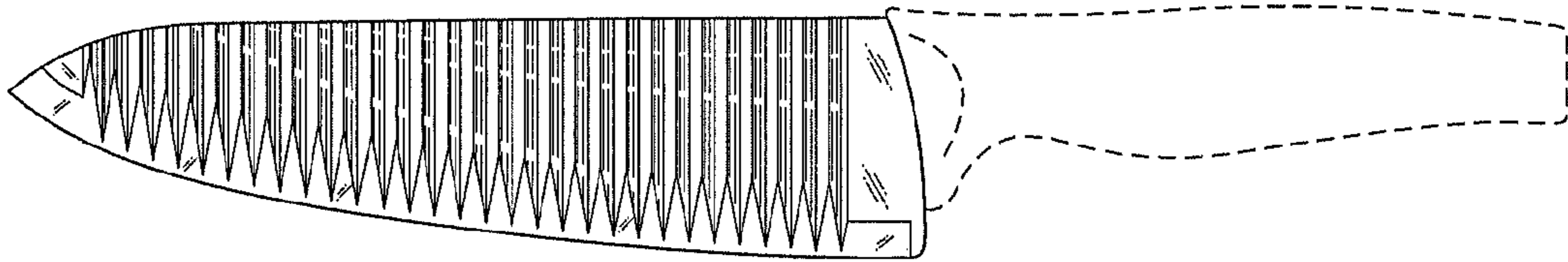

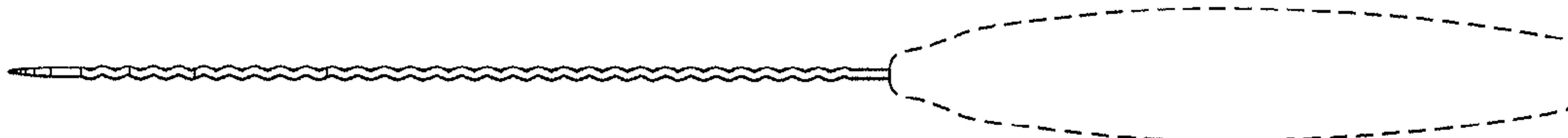

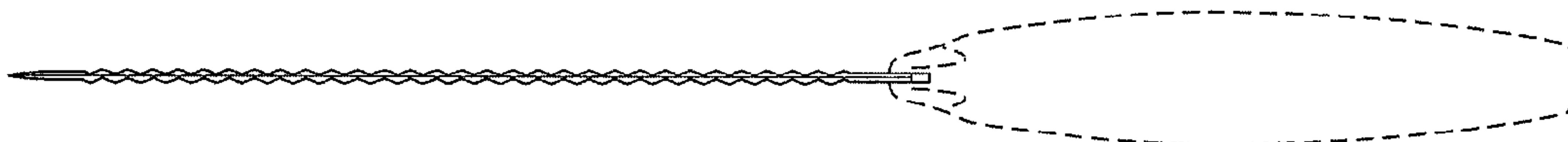

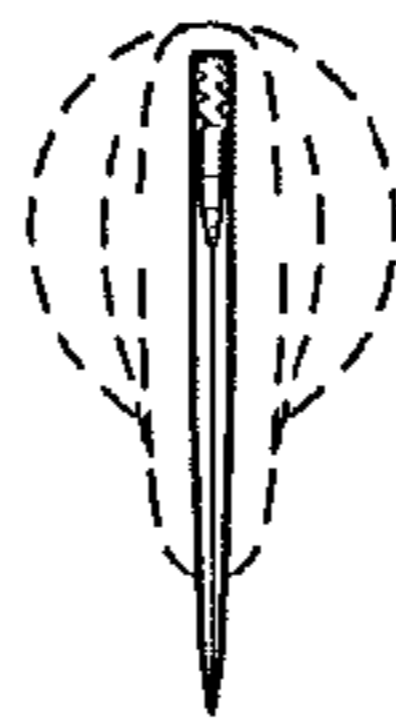
