DESCRIPTION

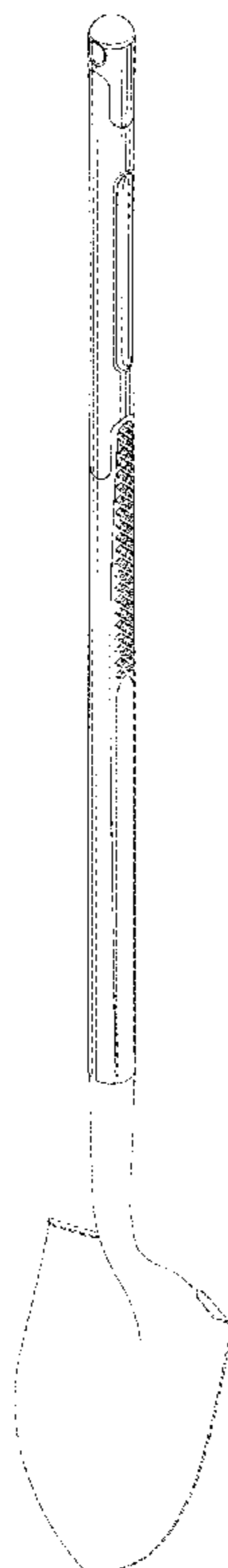
FIG. 1 is a perspective view of a the tool handle showing my new design;

 The broken line showing of portions of the tool handle is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

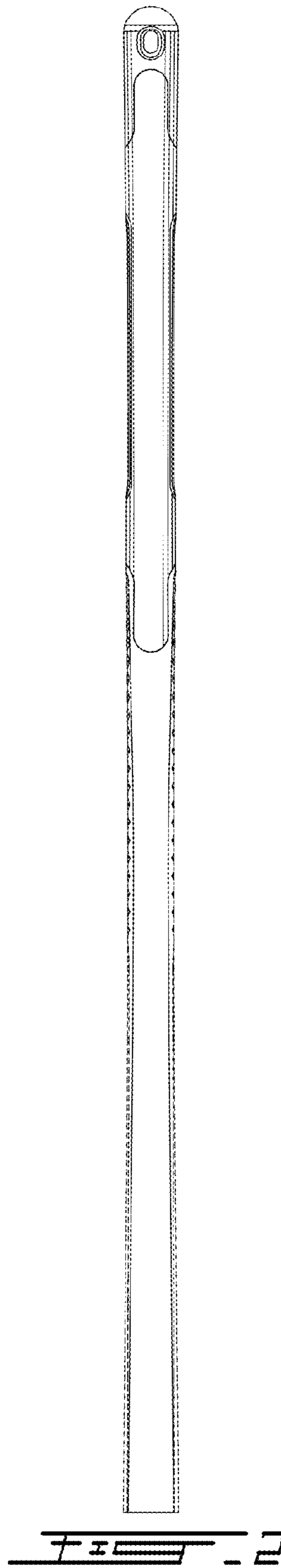
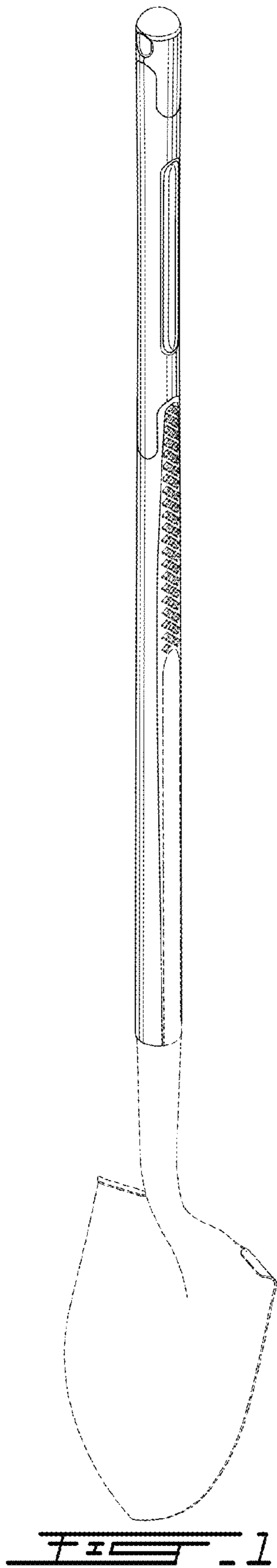

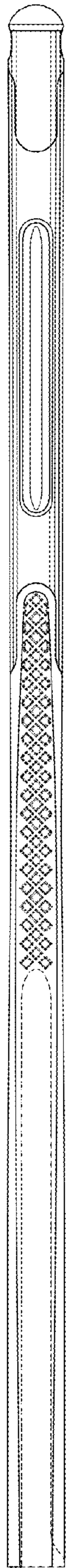

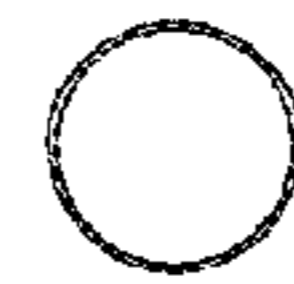
