(57) **CLAIM**

We claim the ornamental design for a spade, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of the claimed design;

FIG. 5 is a right side view of the claimed design of FIG. 1;

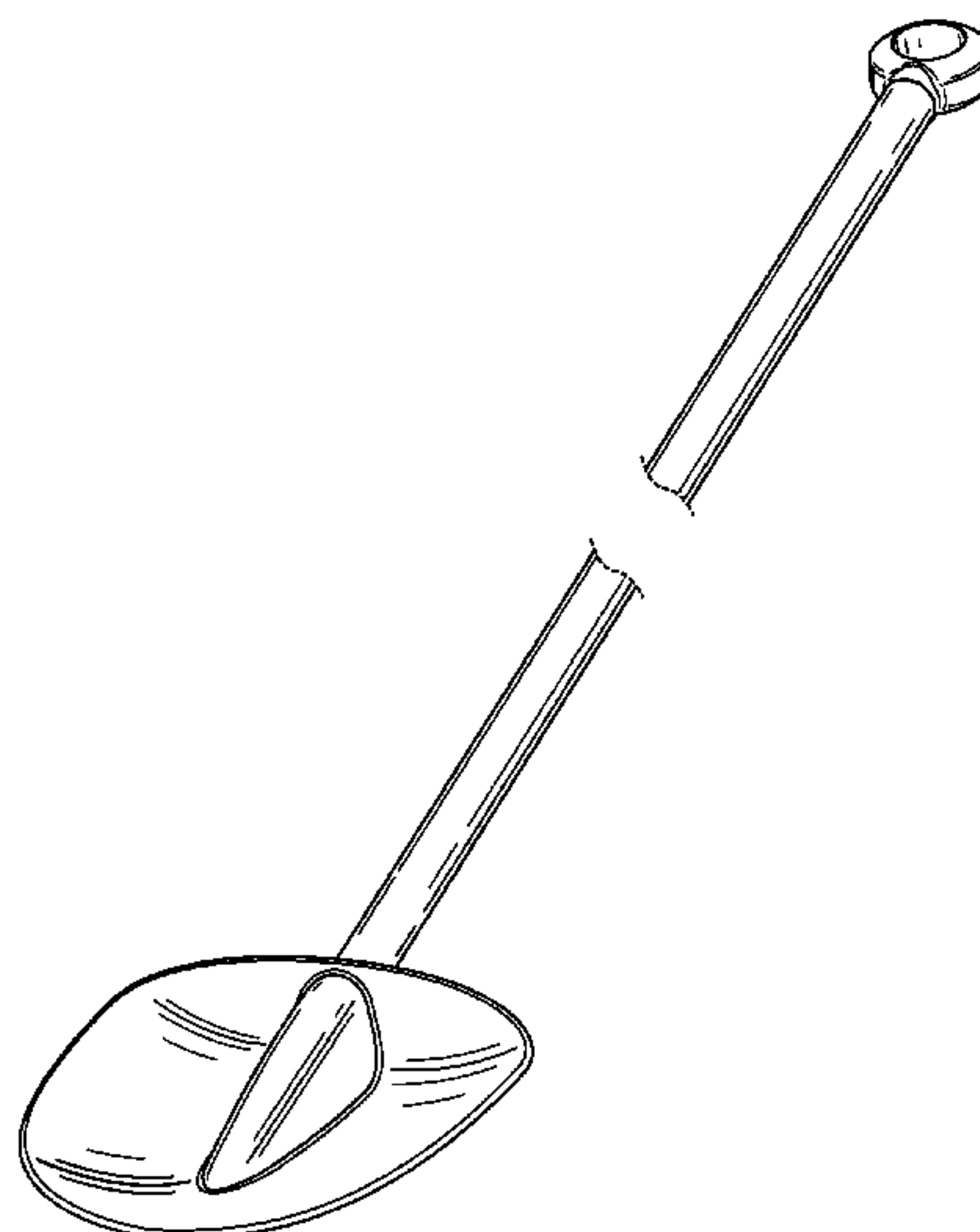
FIG. 6 is a left side view of the claimed design of FIG. 1;

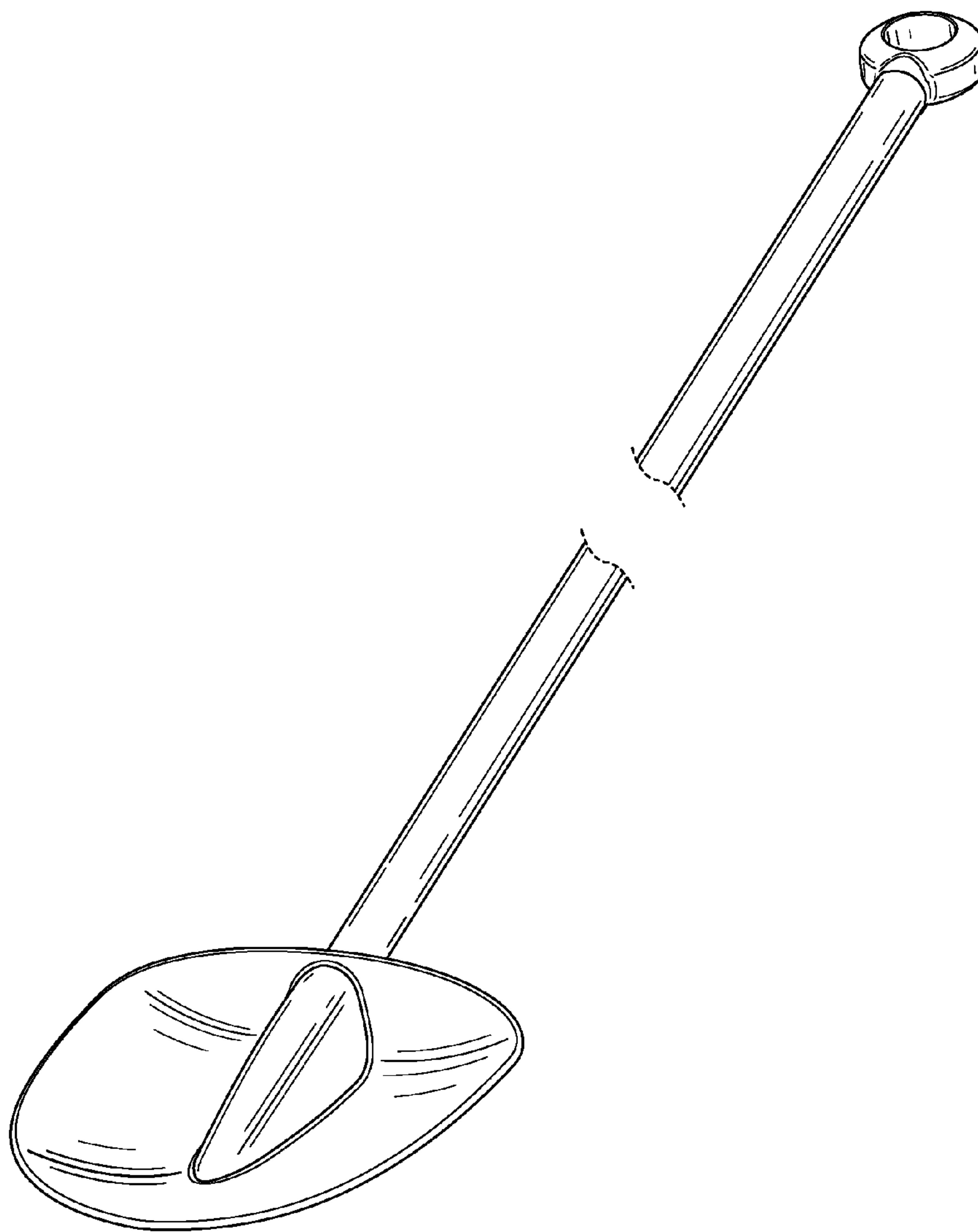

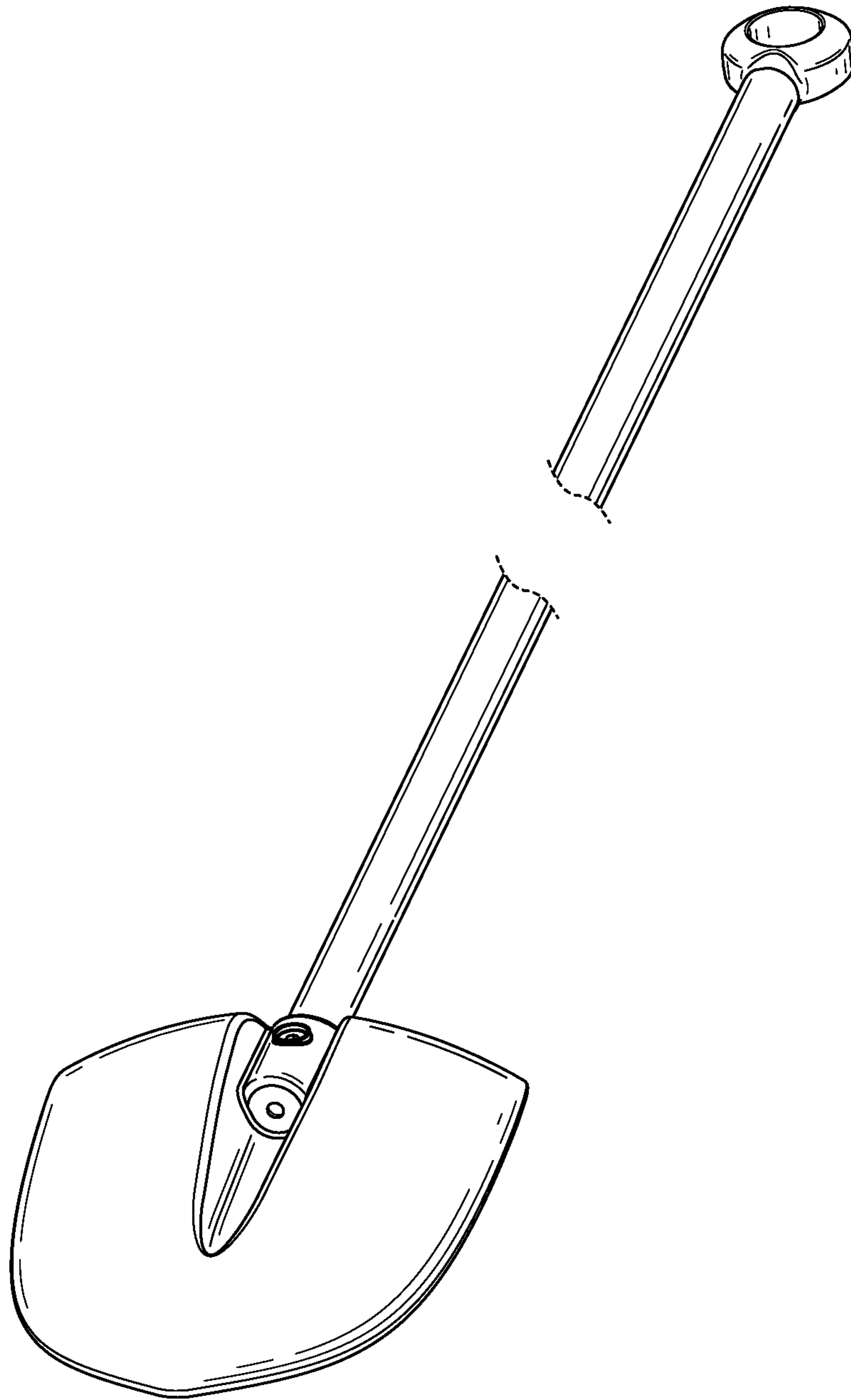

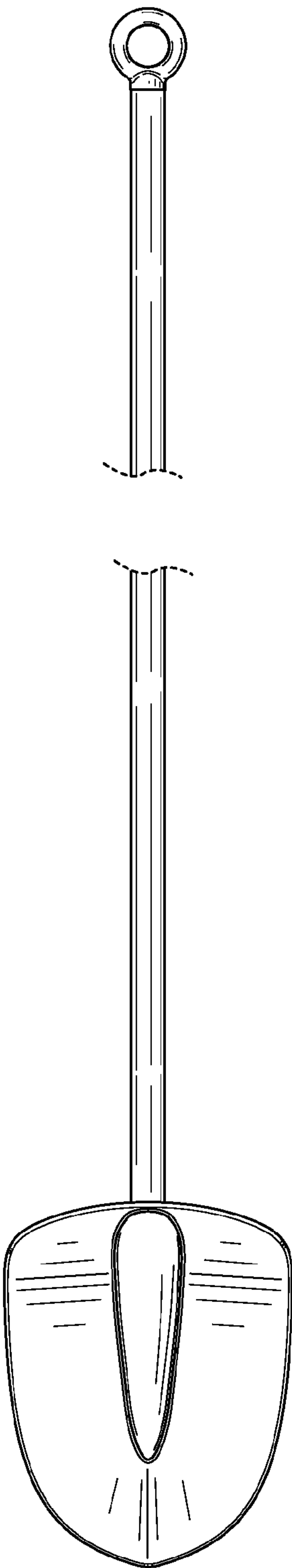

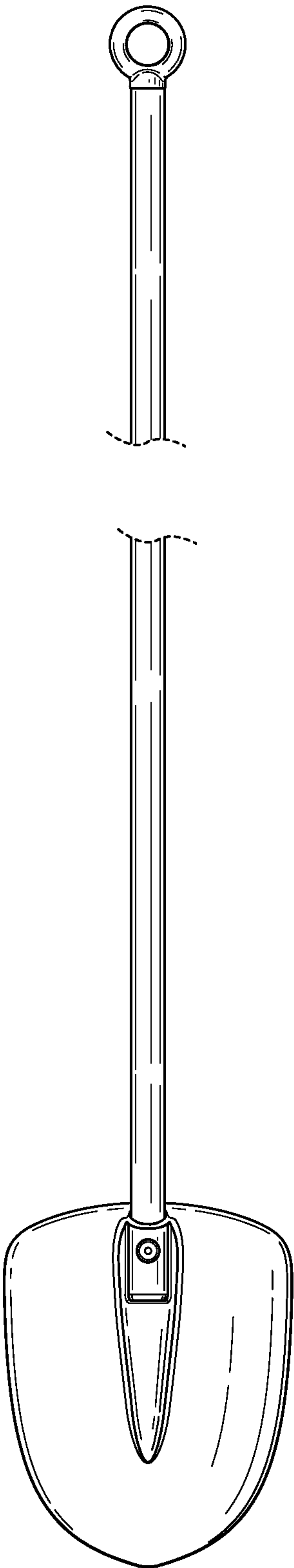

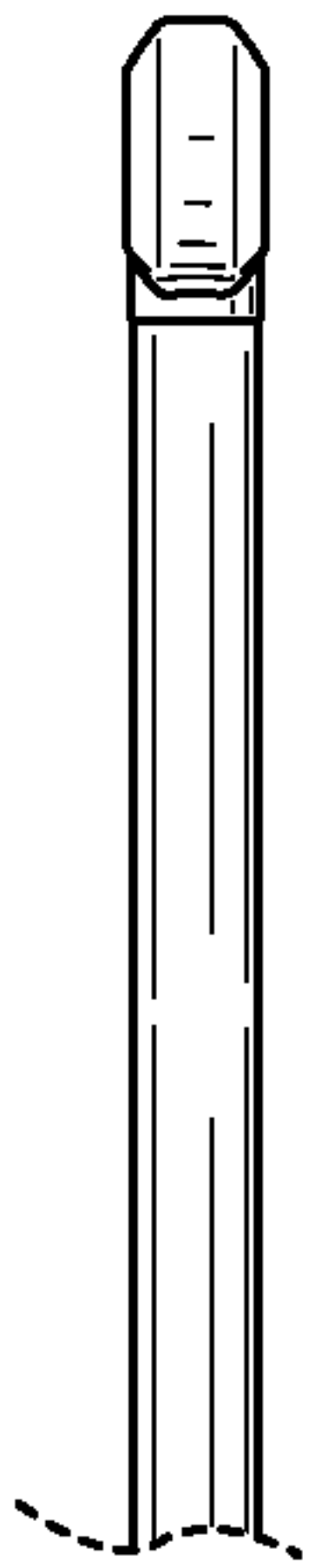

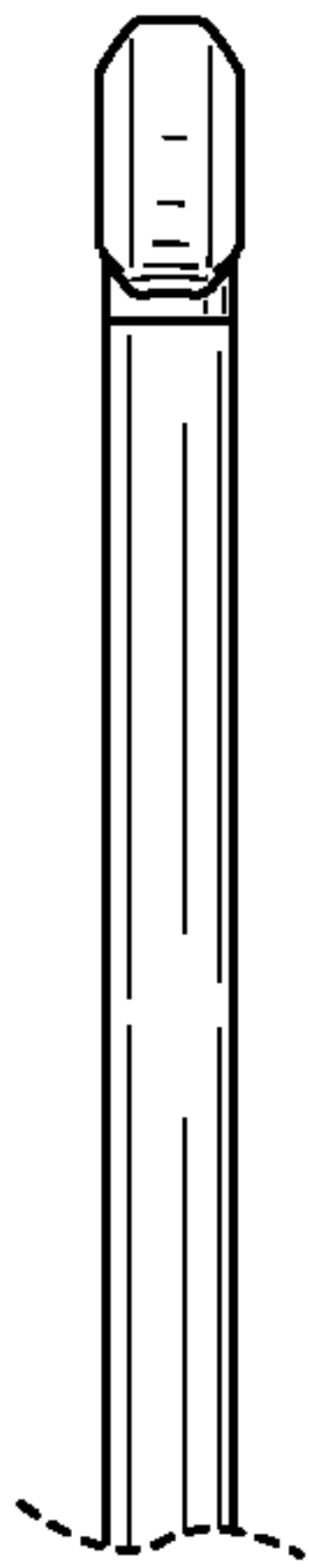

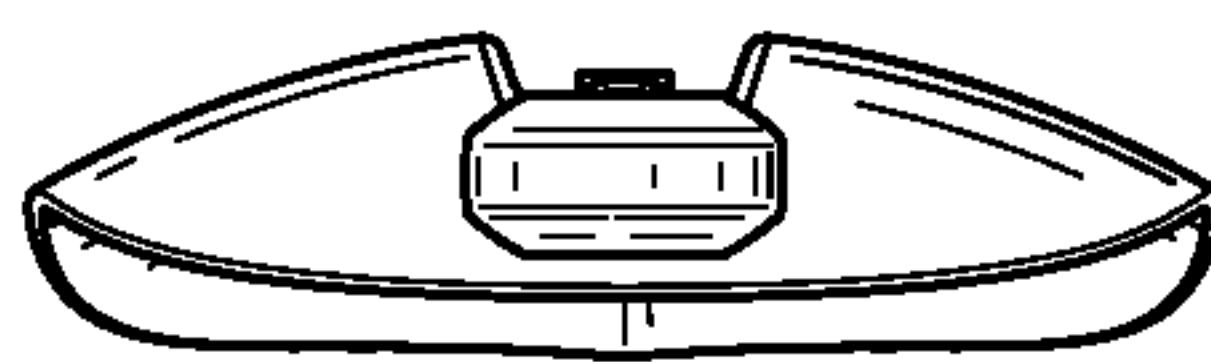

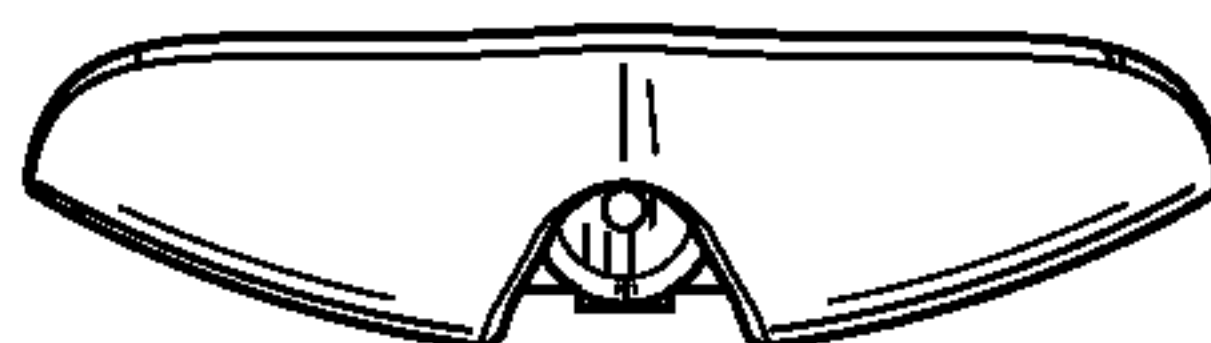
