(57) **CLAIM**

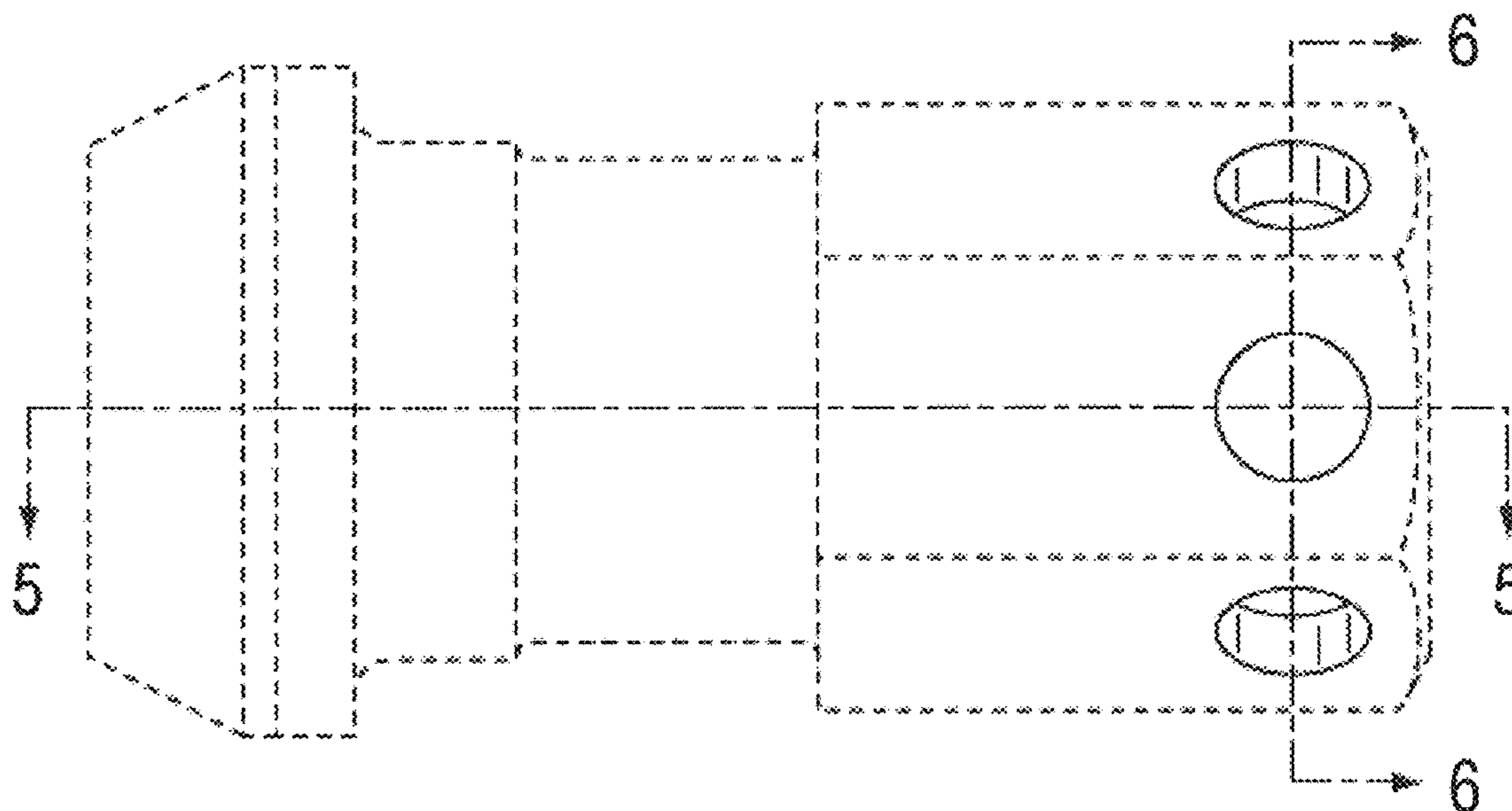
The ornamental design for a wheel nut, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a wheel nut, showing my design, with the rear elevational view being a mirror image thereof;
FIG. 2 is a top, plan view thereof, with the bottom view being a mirror image thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a cross-sectional view thereof taken along lines 5-5 in FIG. 1; and,
FIG. 6 is a cross-sectional view thereof taken along lines 6-6 in FIG. 1.

The broken lines represent environmental structures and form no part of the claim.

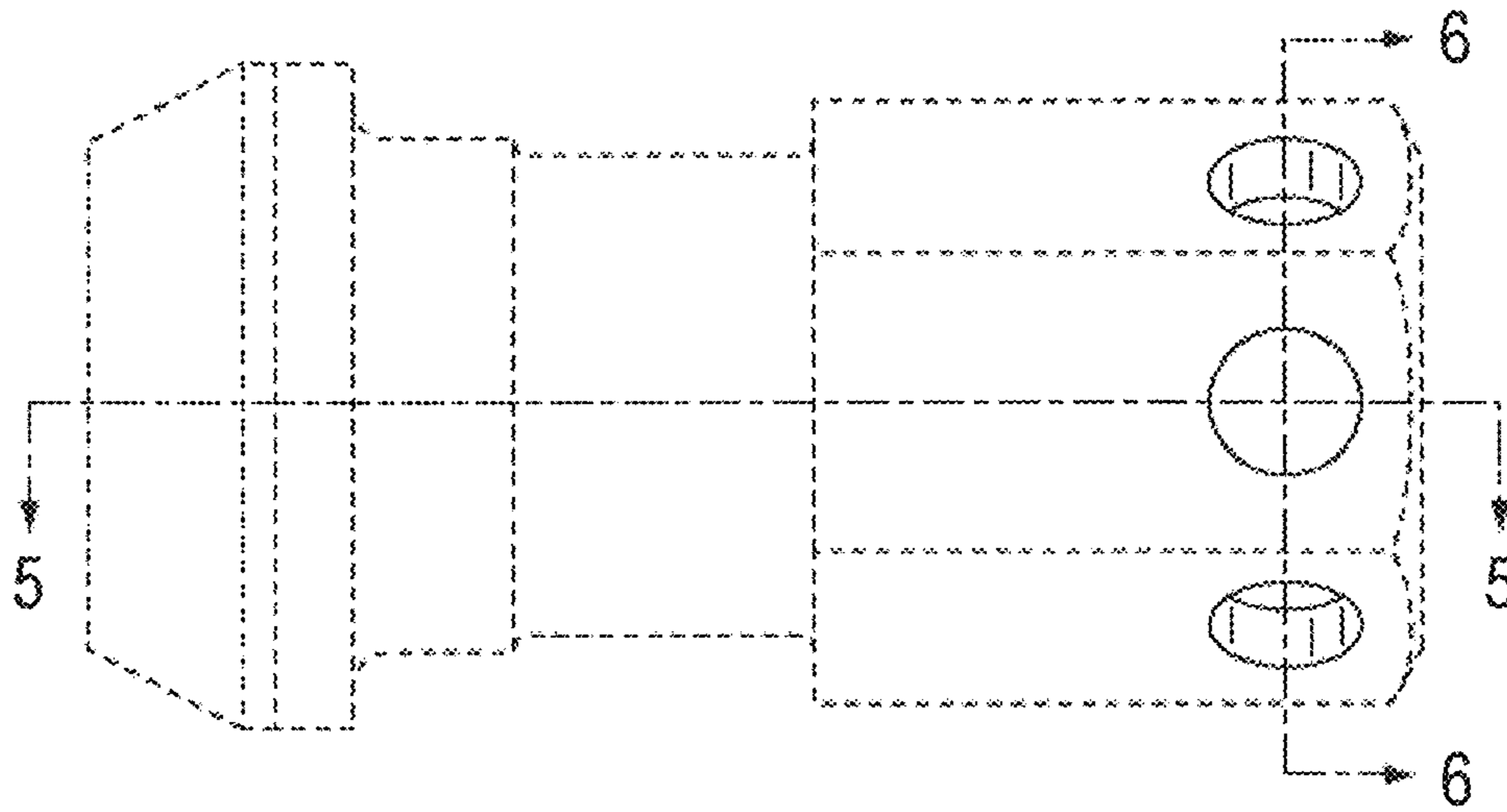

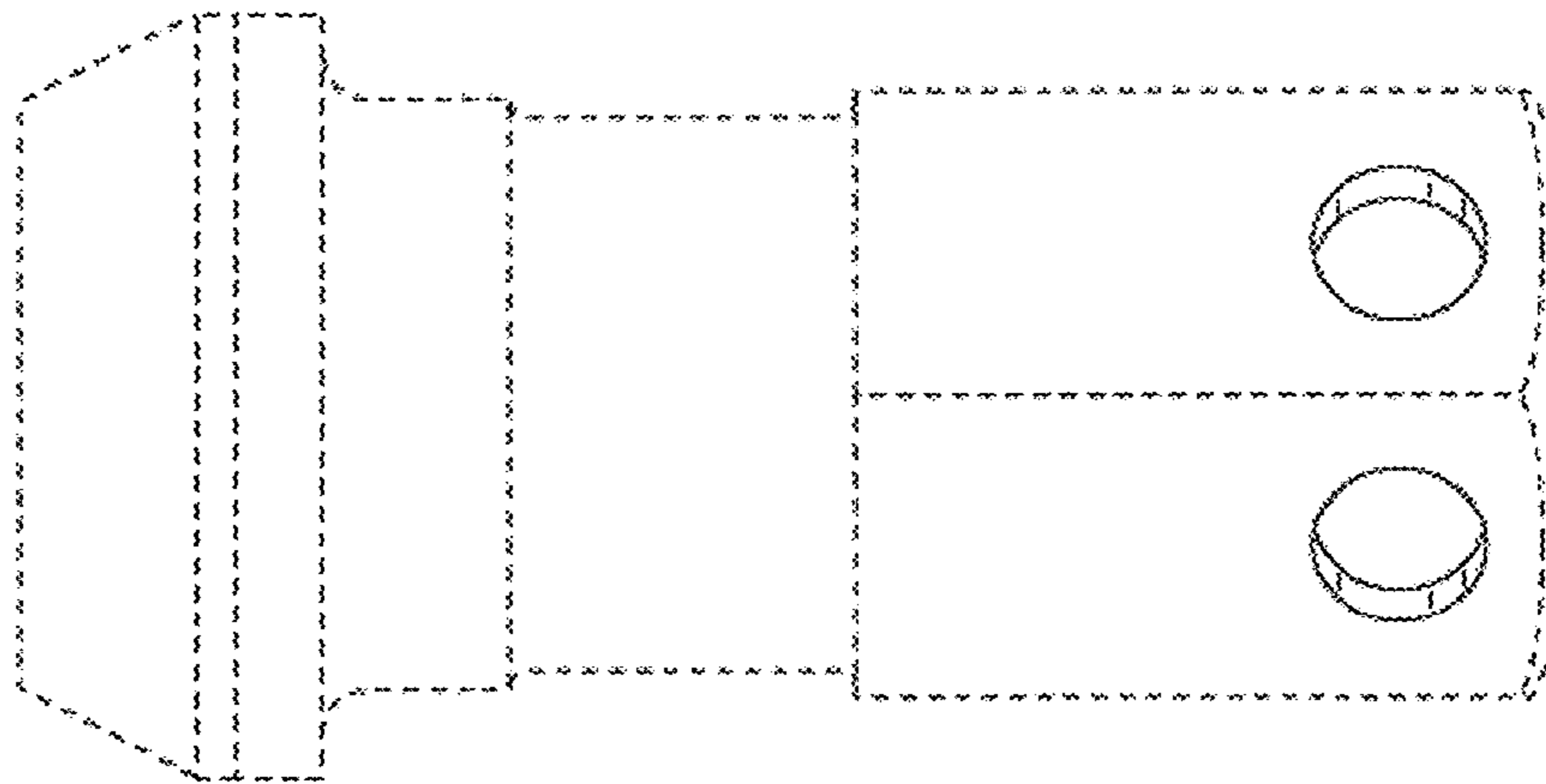

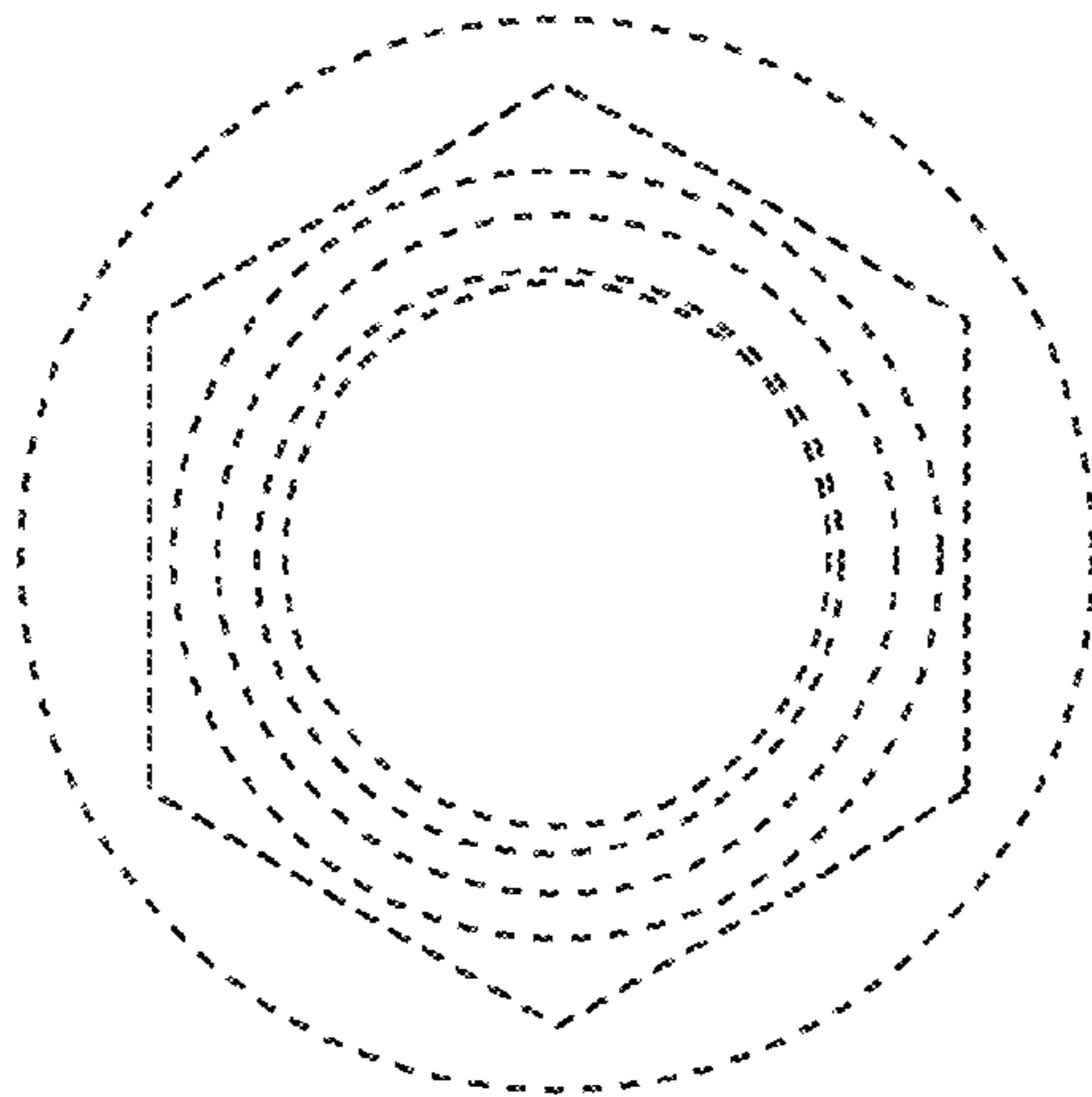

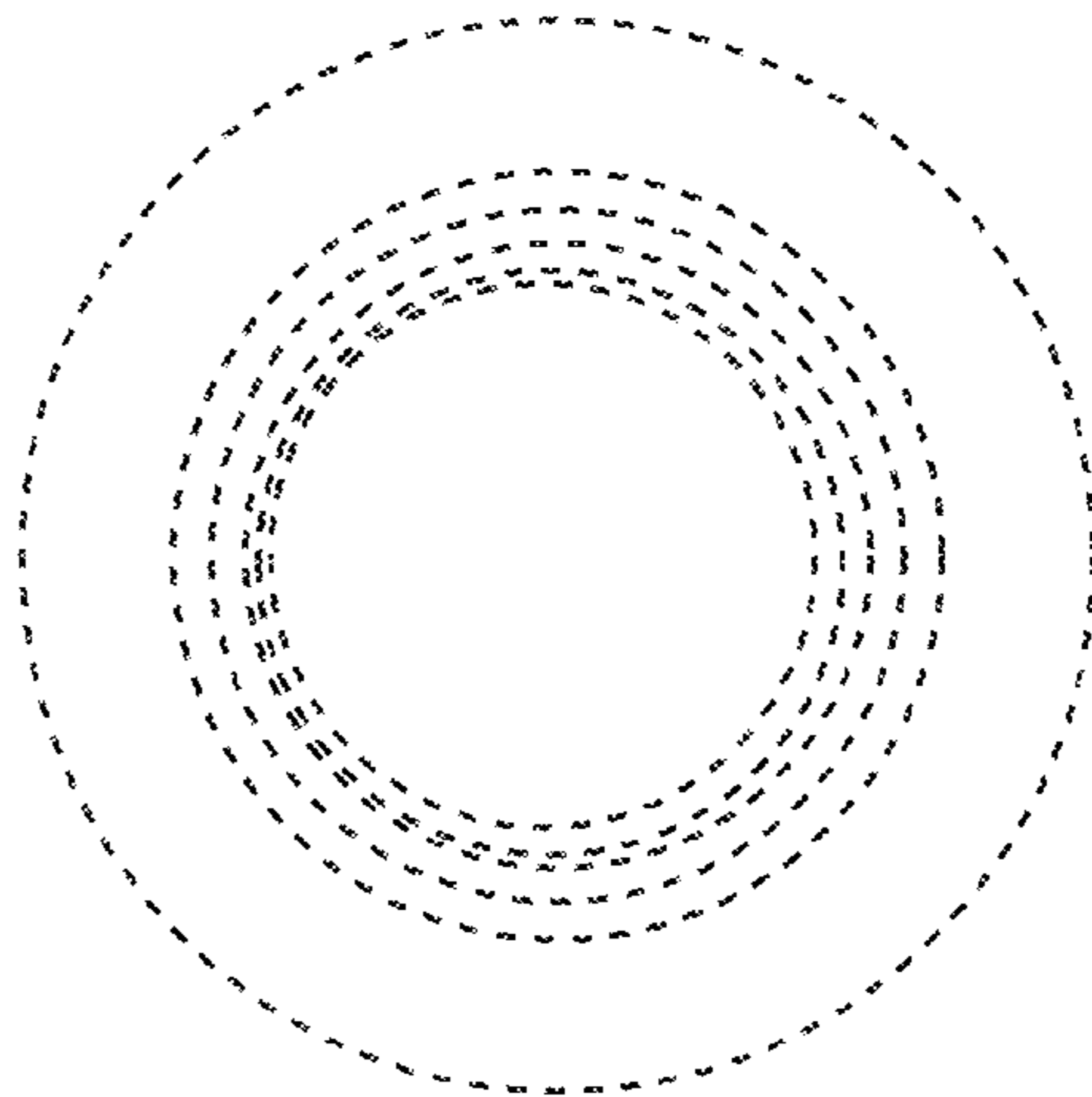

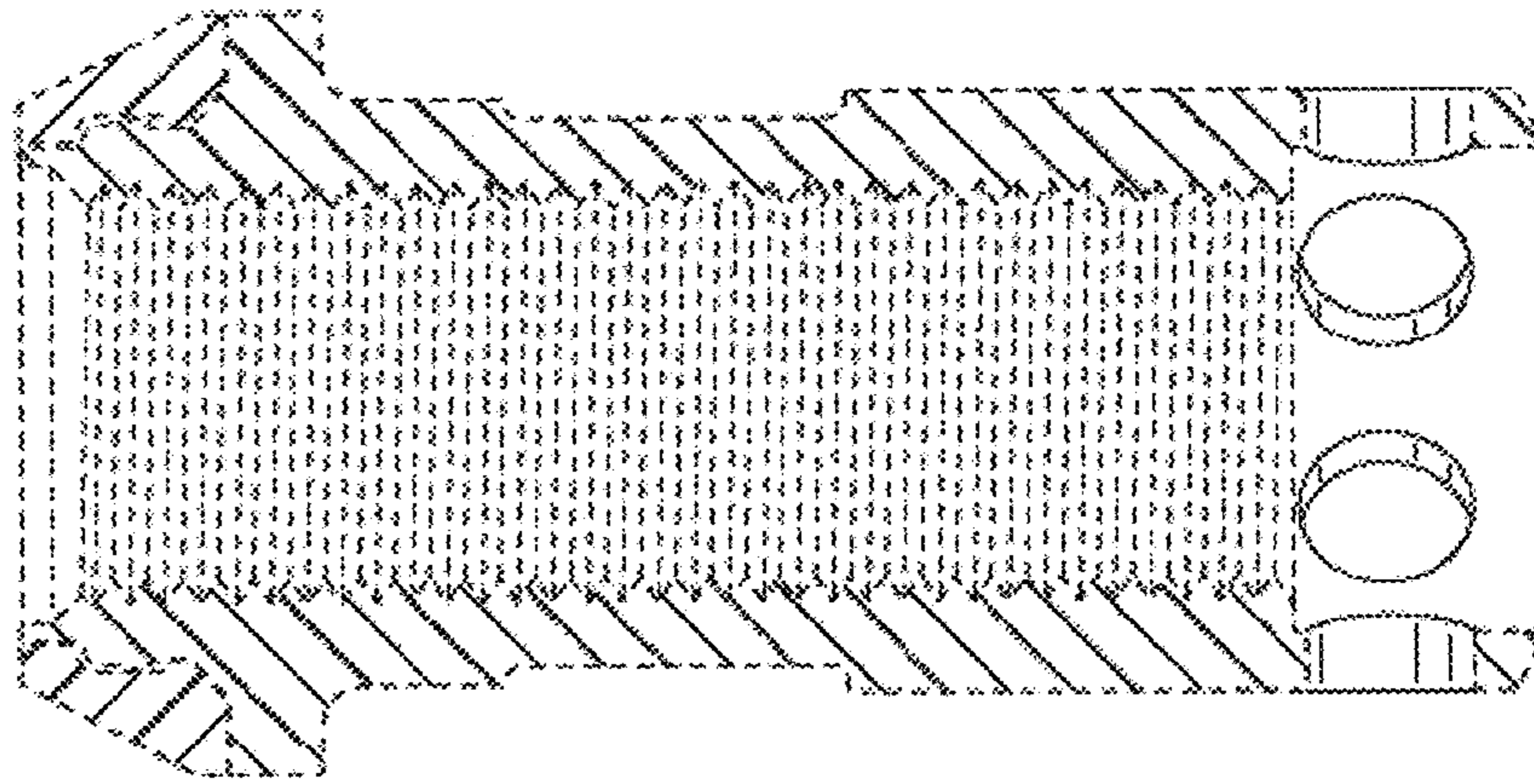

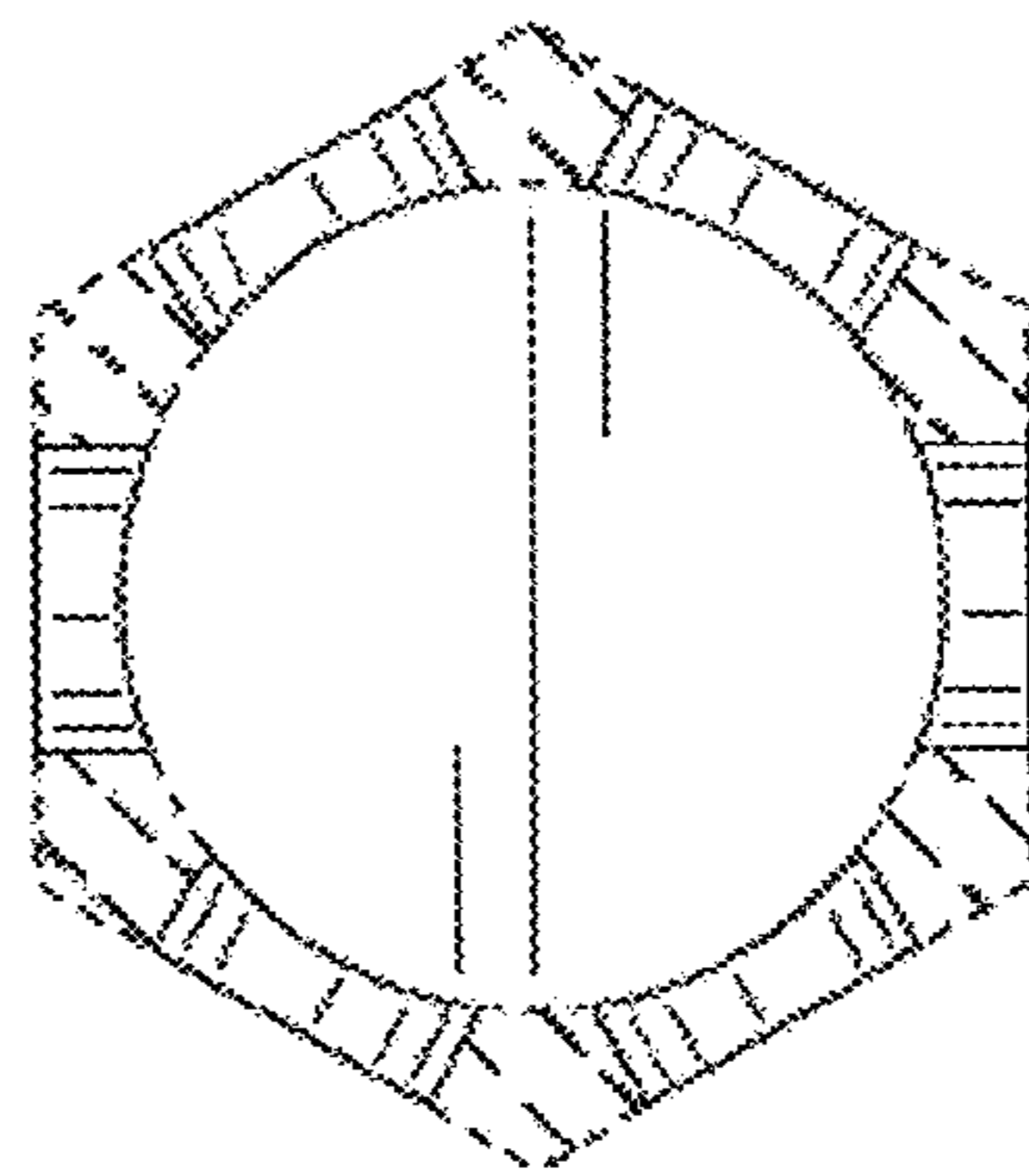
