(57) **CLAIM**

The ornamental design for packaging, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of packaging showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

The dashed lines illustrating portions of the packaging are for environmental purposes only and form no part of the claimed design.

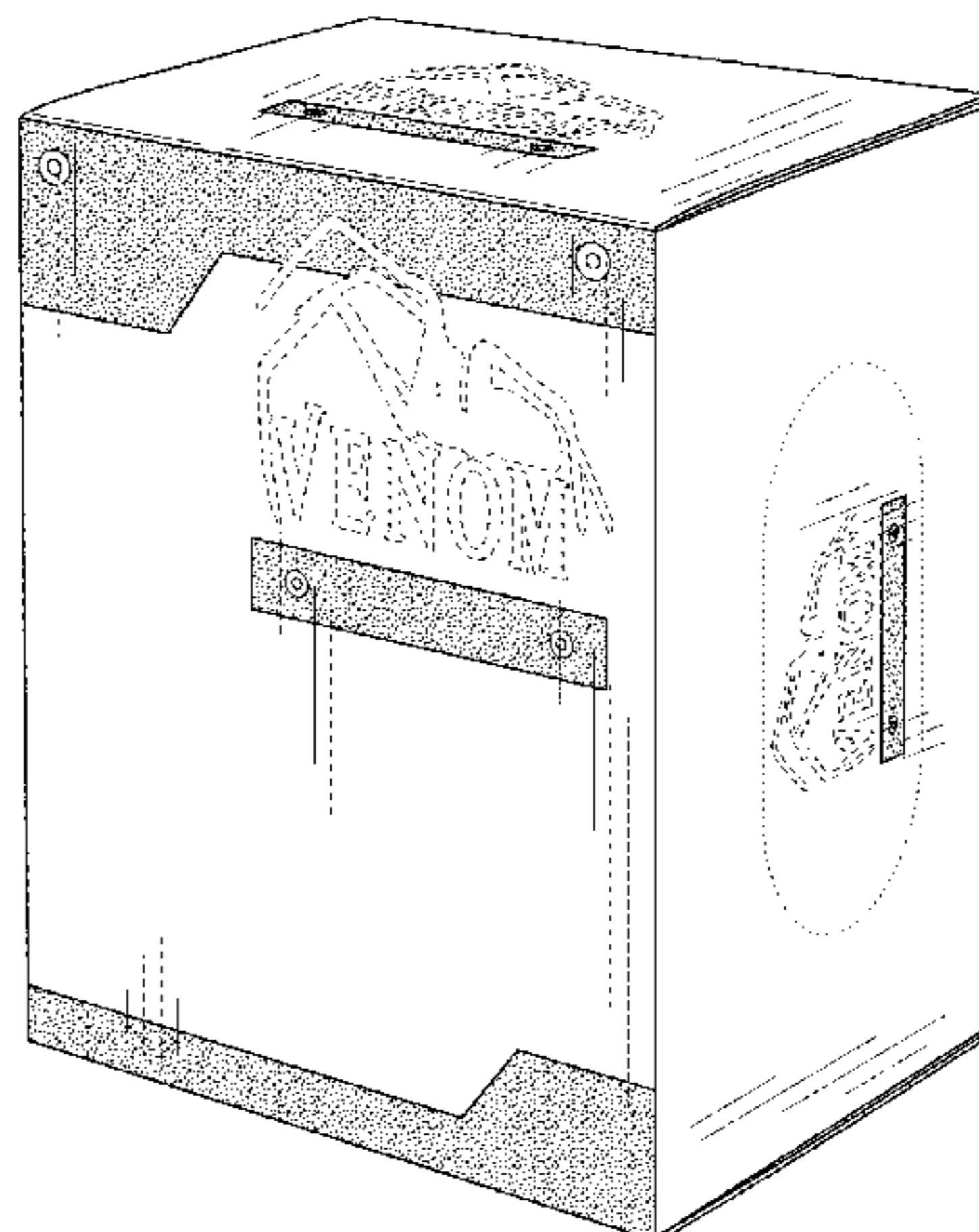
The stippled areas represent areas of contrasting color to adjacent non-stippled areas. No particular colors are being claimed.

The dotted lines shown in FIGS. 1 and 4 represent perforations and form no part of the claimed design.

The vertical and horizontal shade lines in the figures are used to show that the surfaces are substantially planar and not to be interpreted as surface ornamentation.

The inventors contemplate that other embodiments of their design may include any part, portion, element or combination of elements of the claimed design.

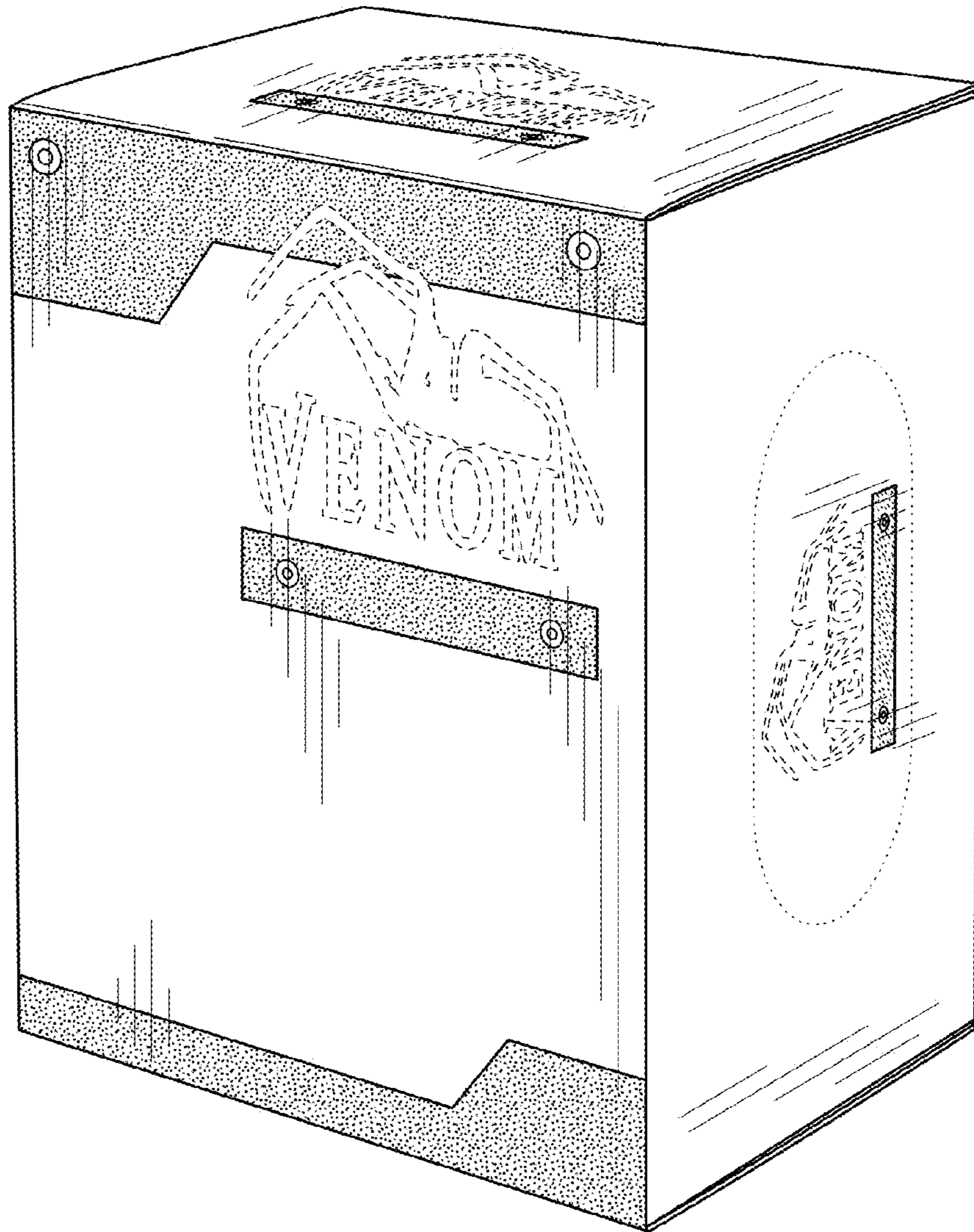

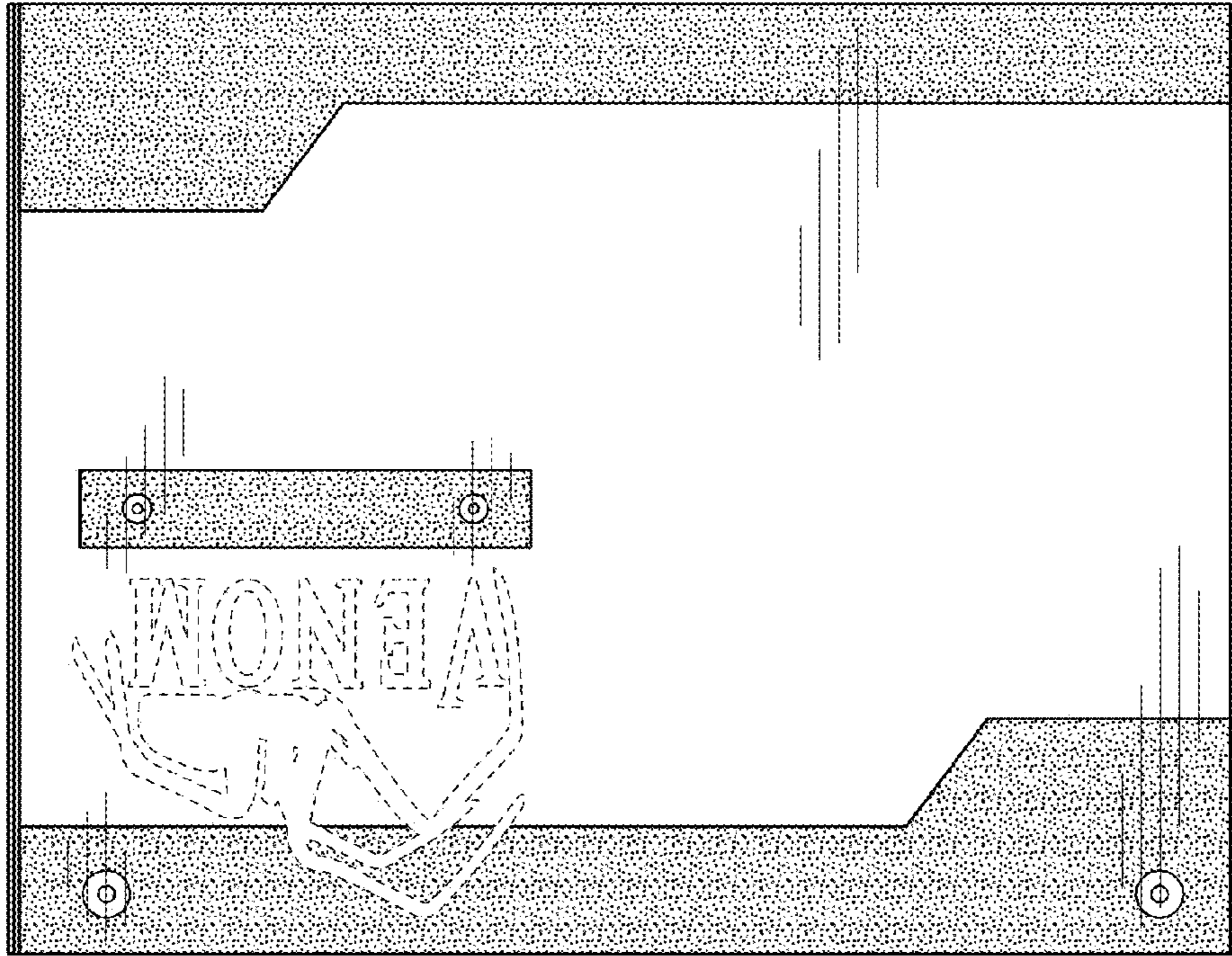

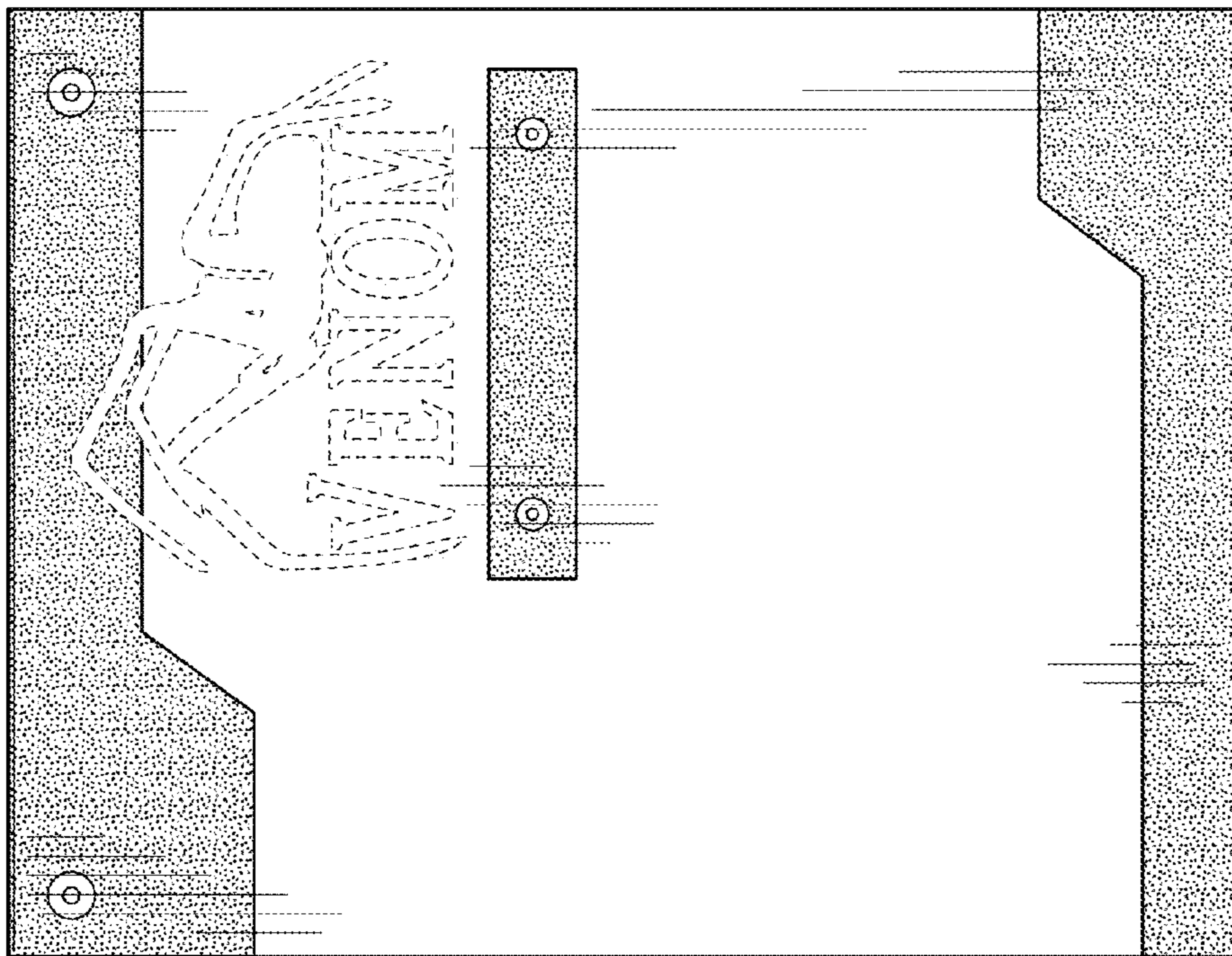

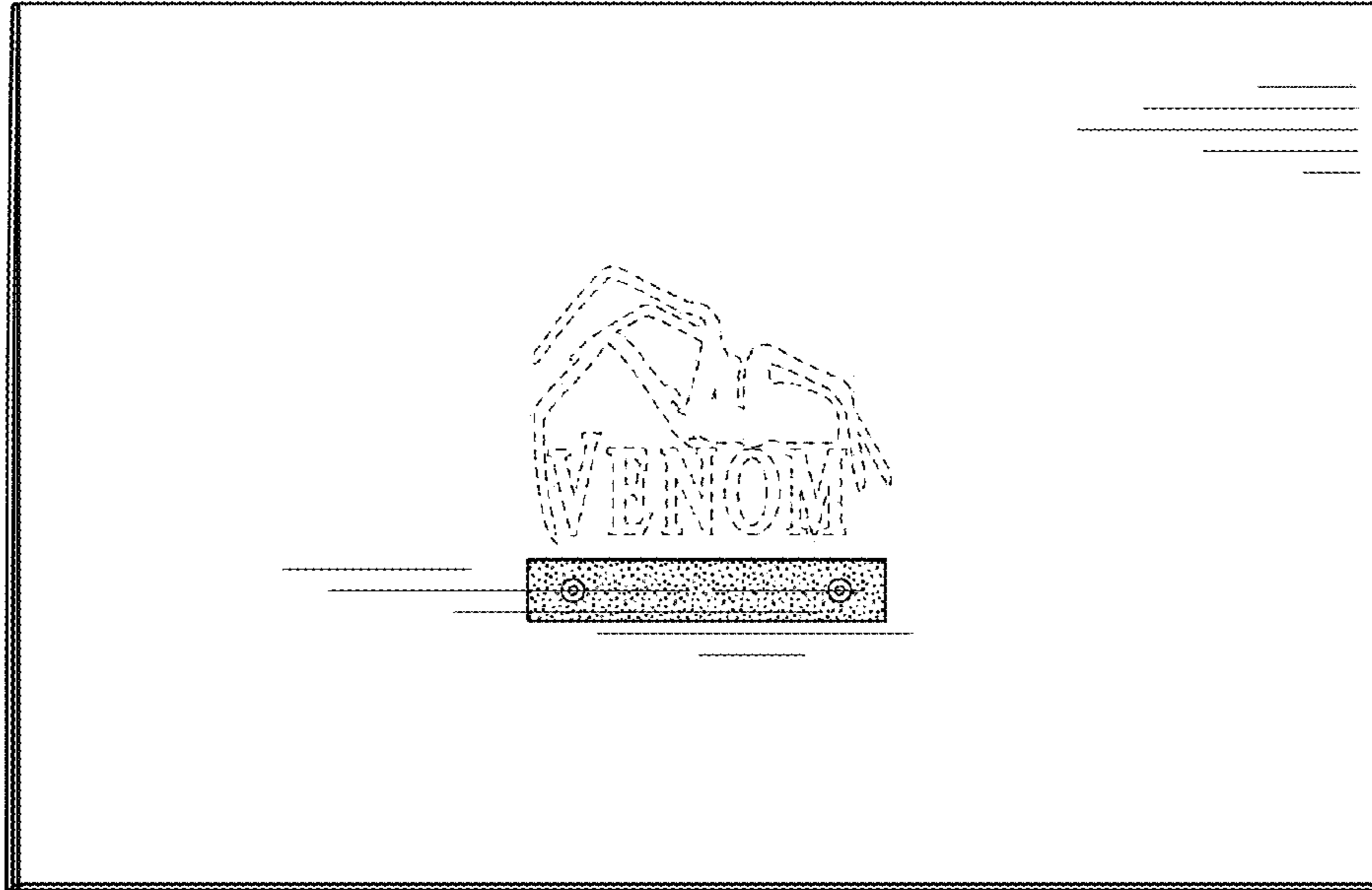

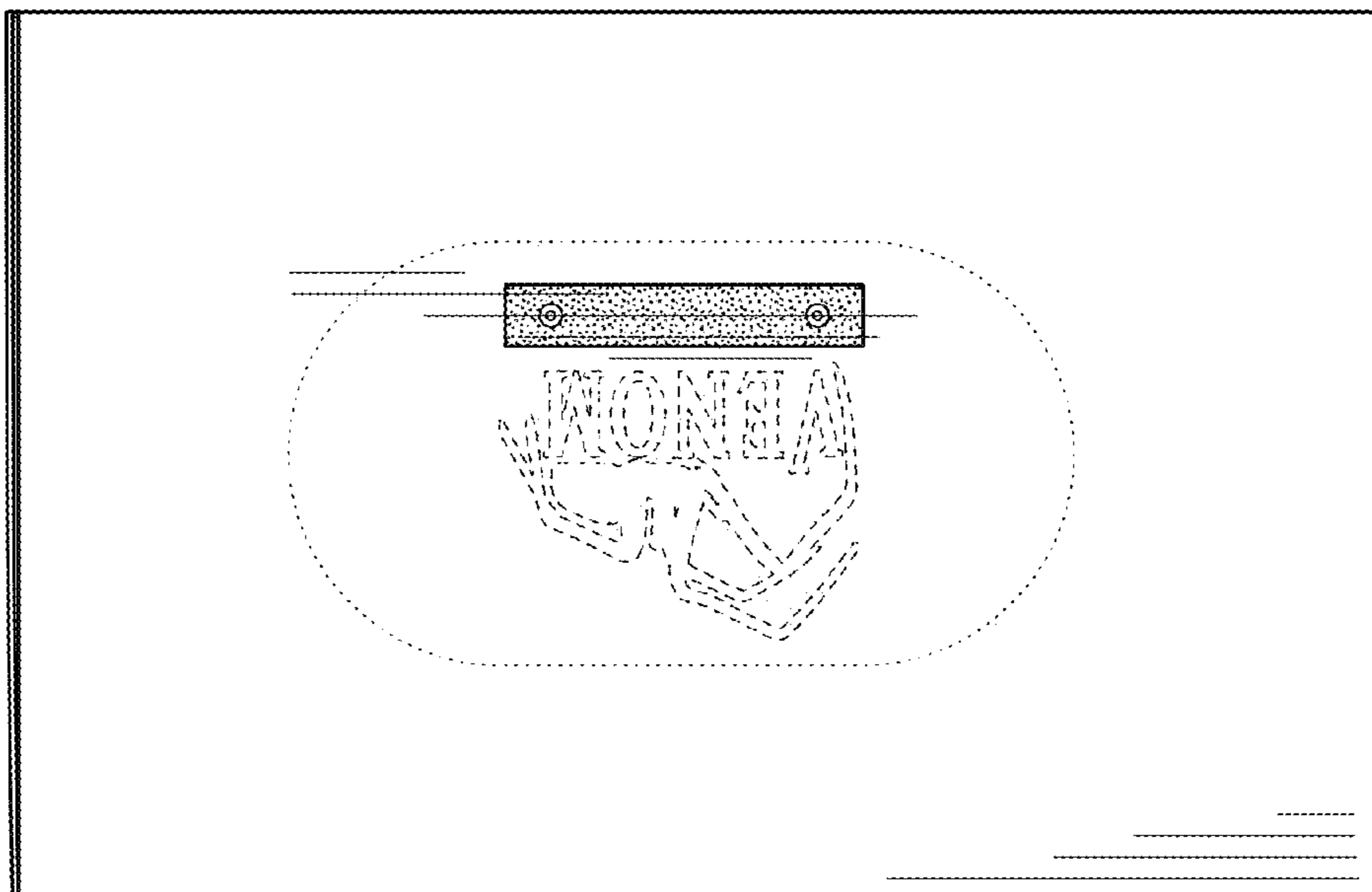

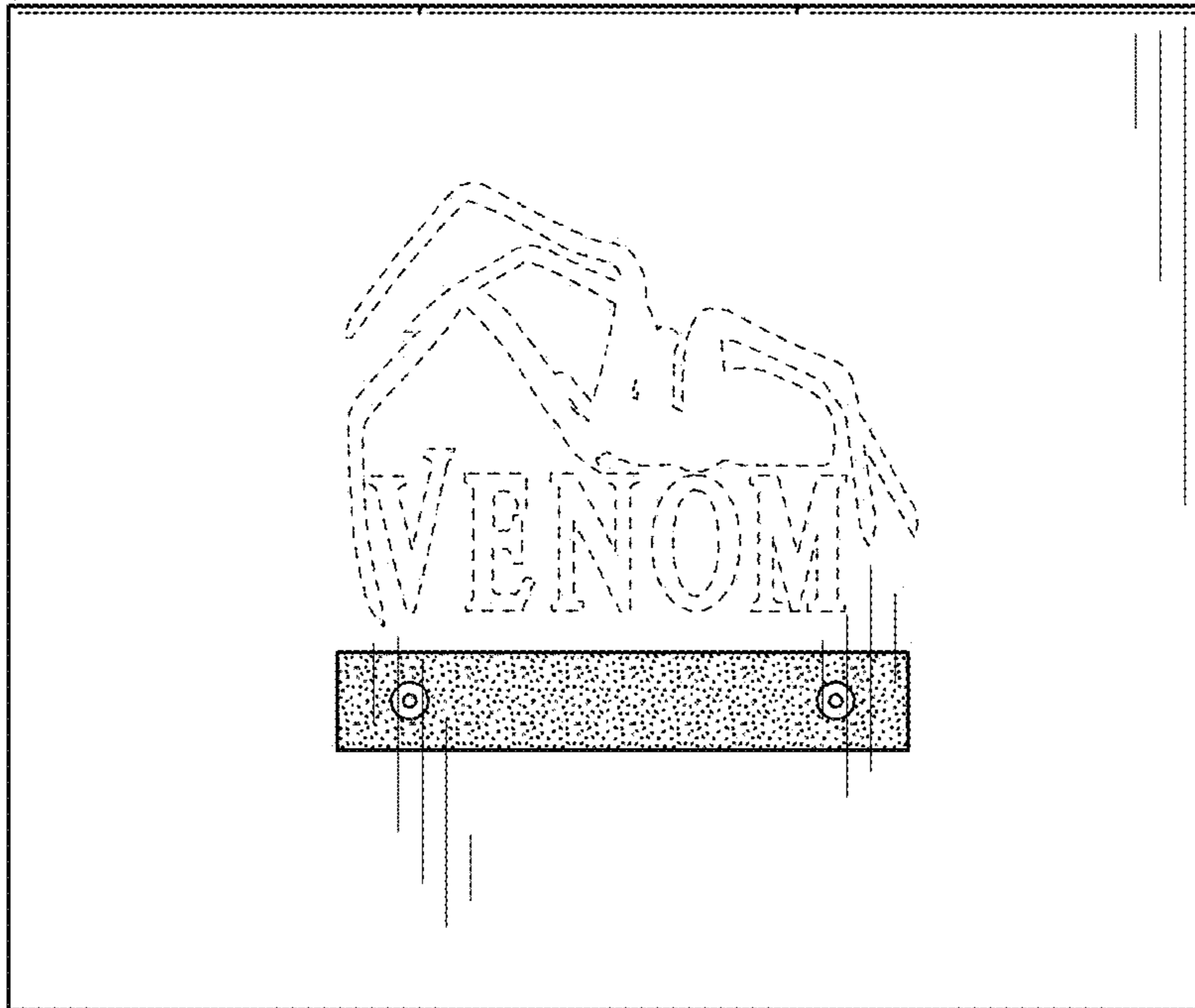
