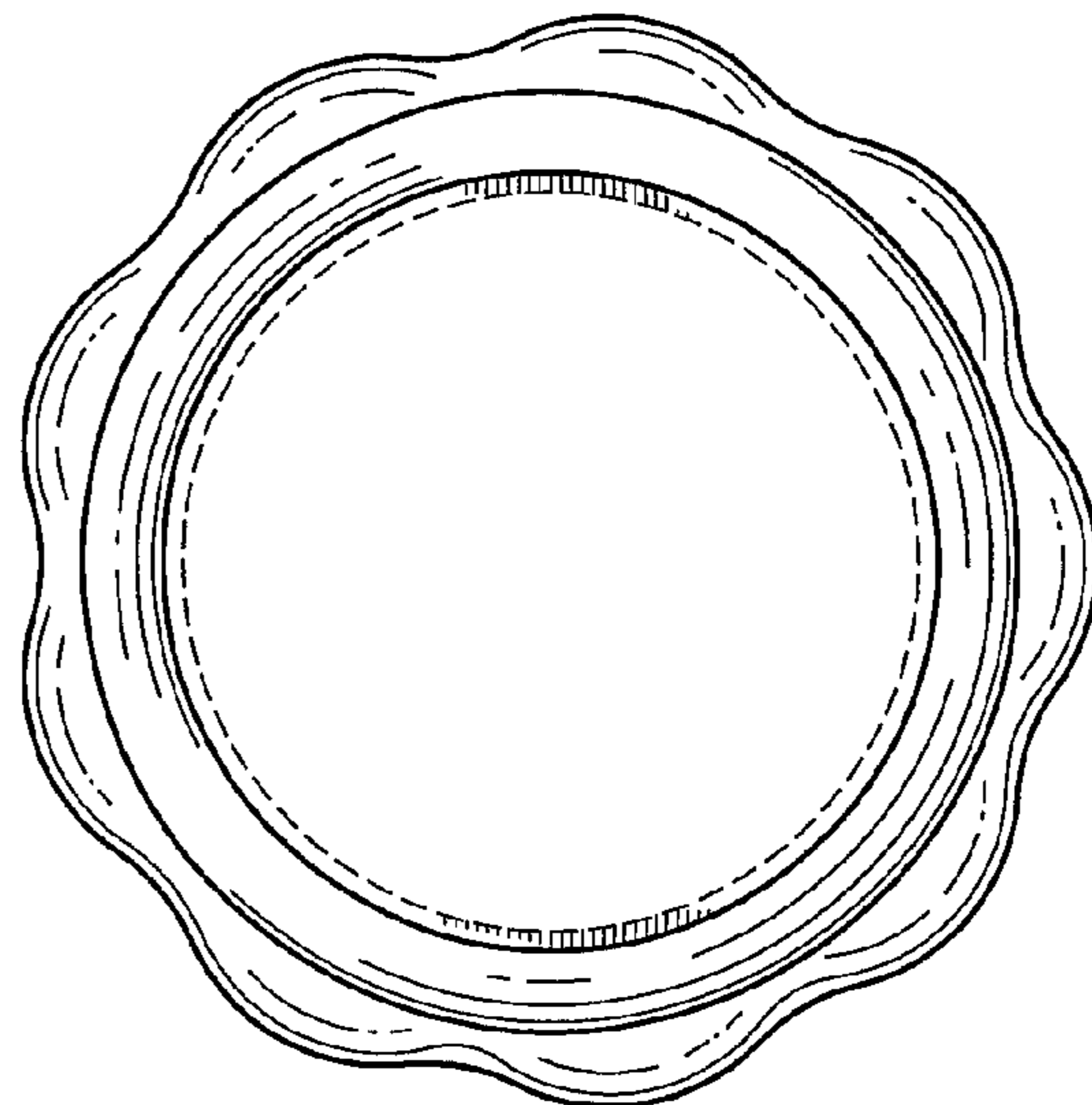
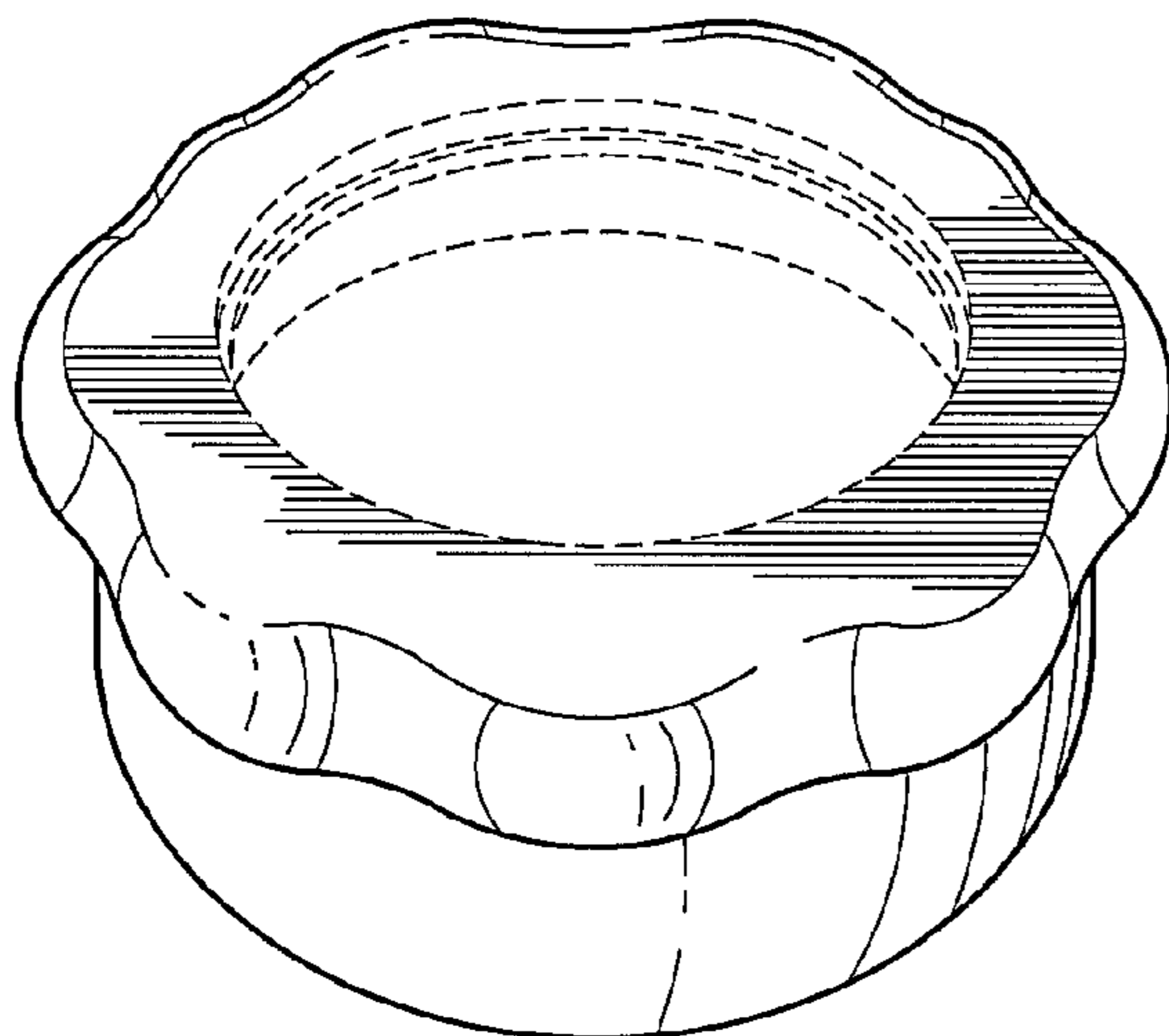
(57) **CLAIM**

I claim the ornamental design for a dispenser base, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dispenser base.

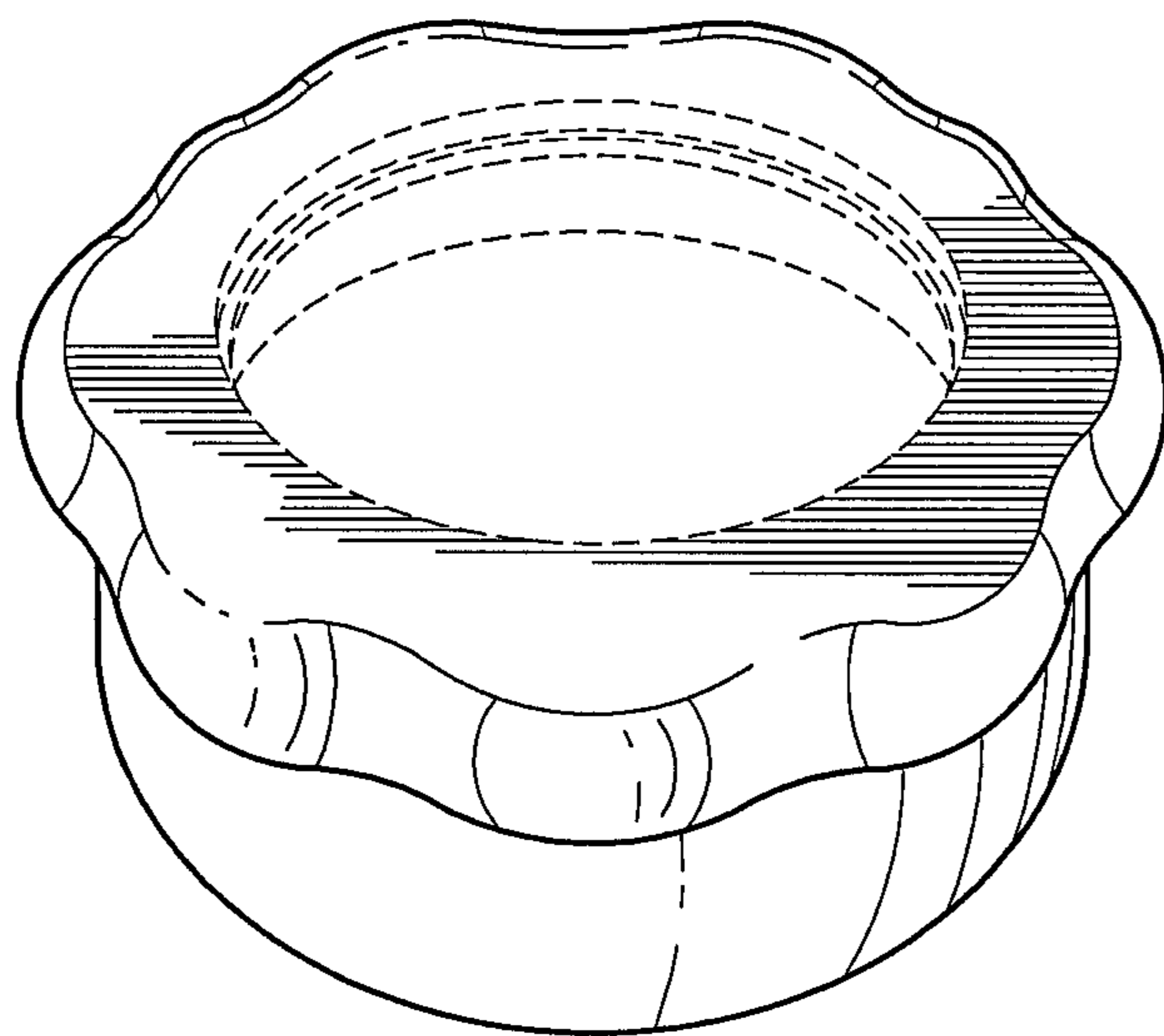

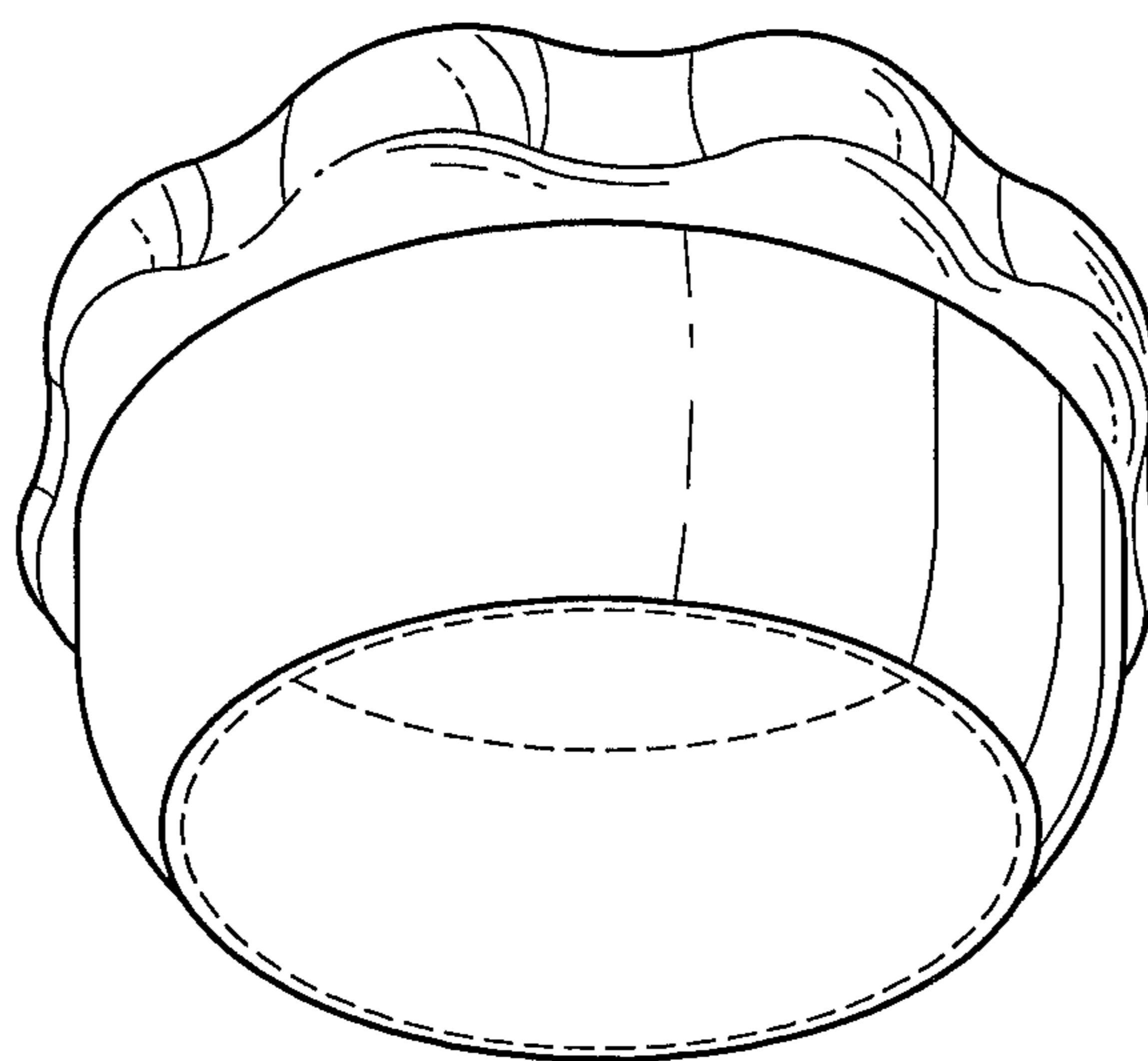

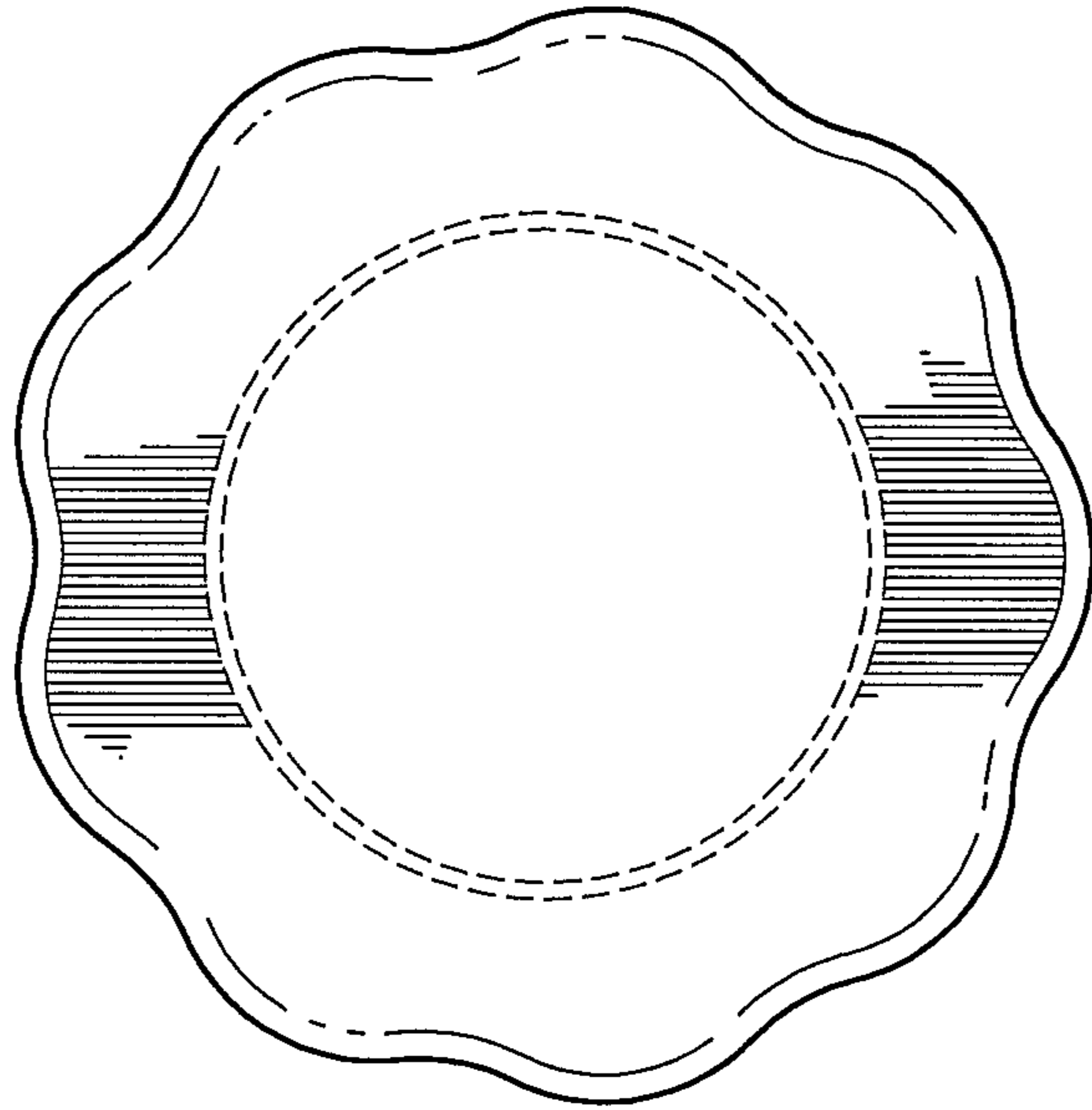

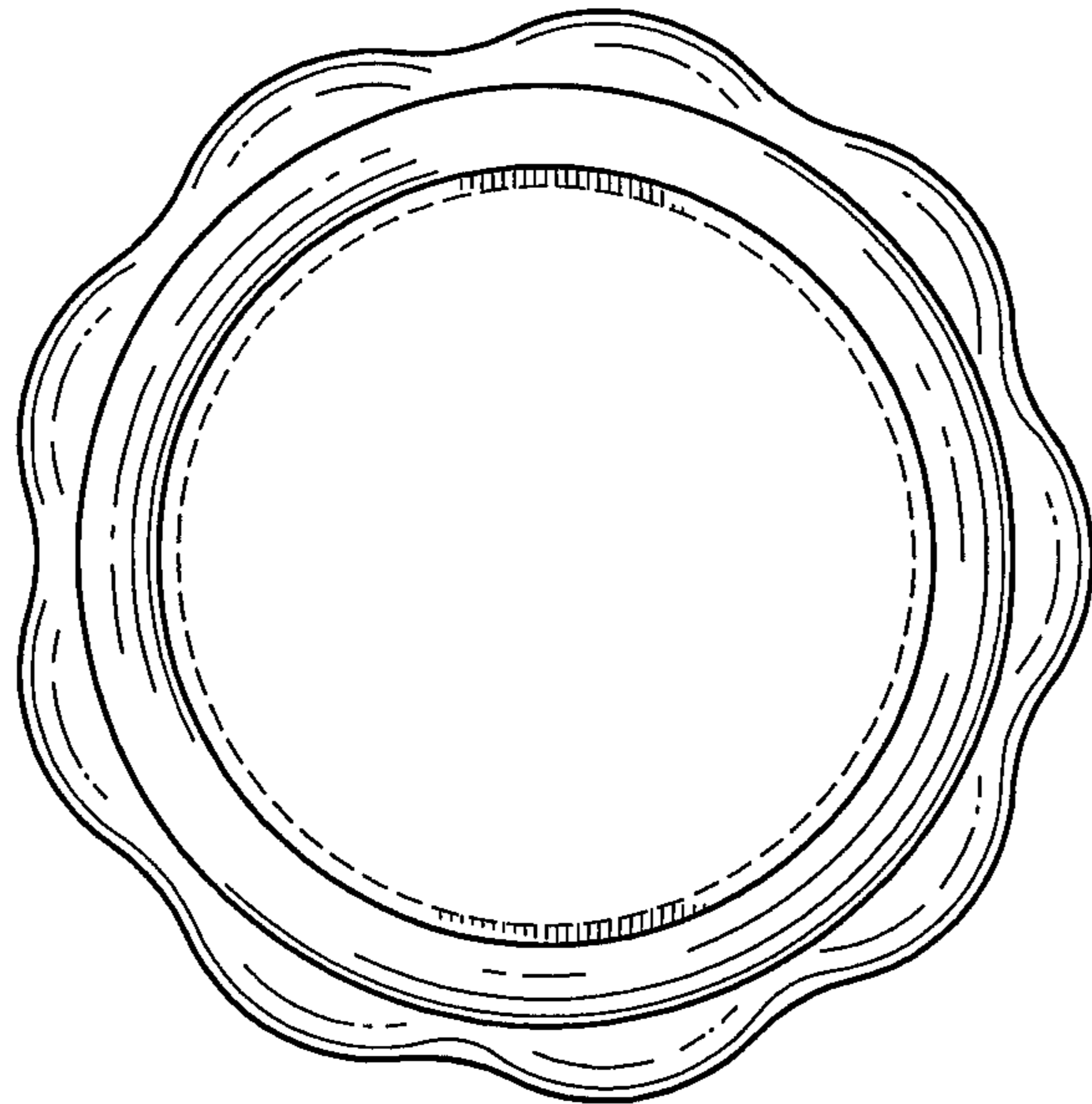
