I claim the ornamental design for a combined watch dial and hands, as shown and described.

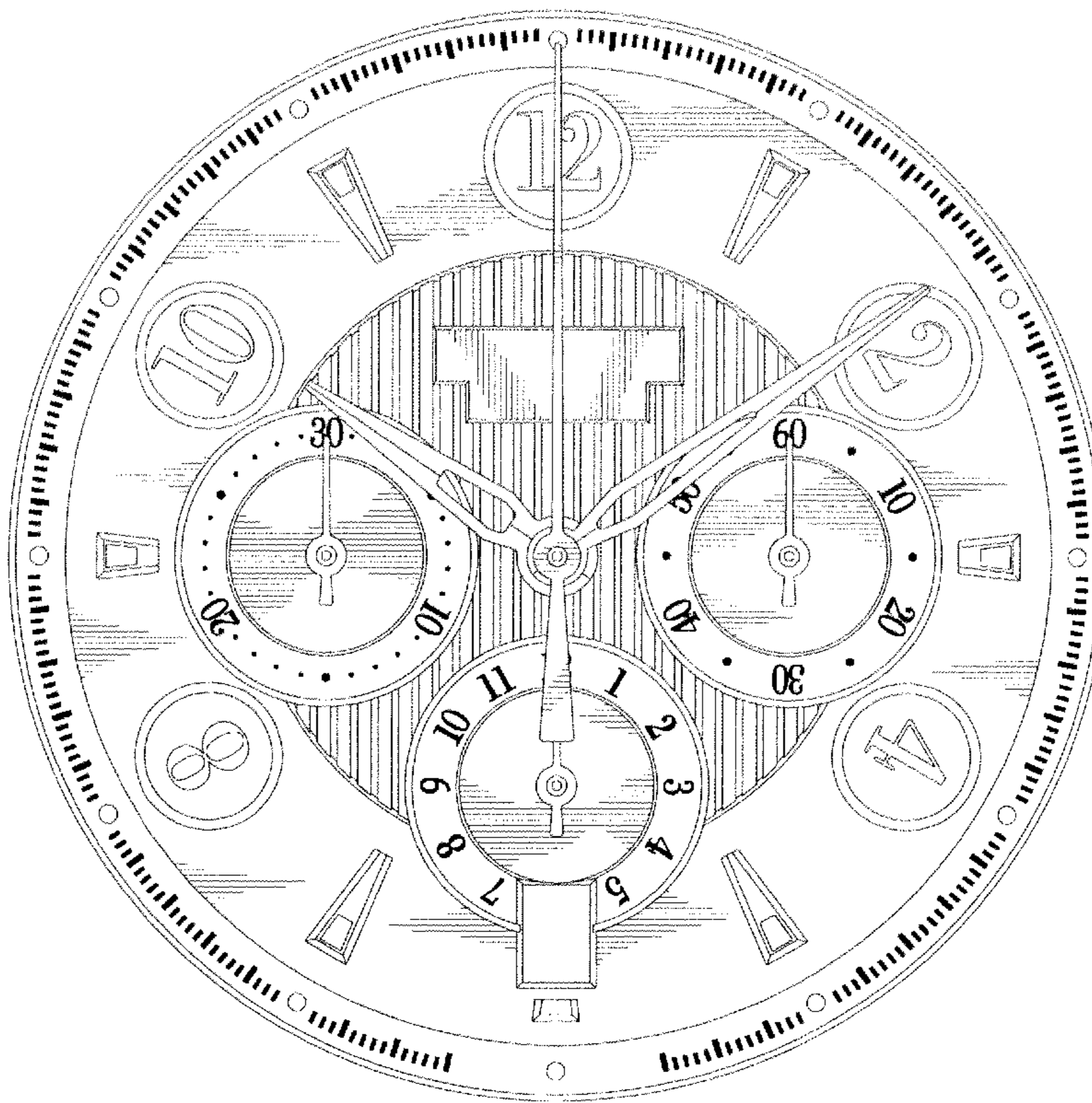
DESCRIPTION

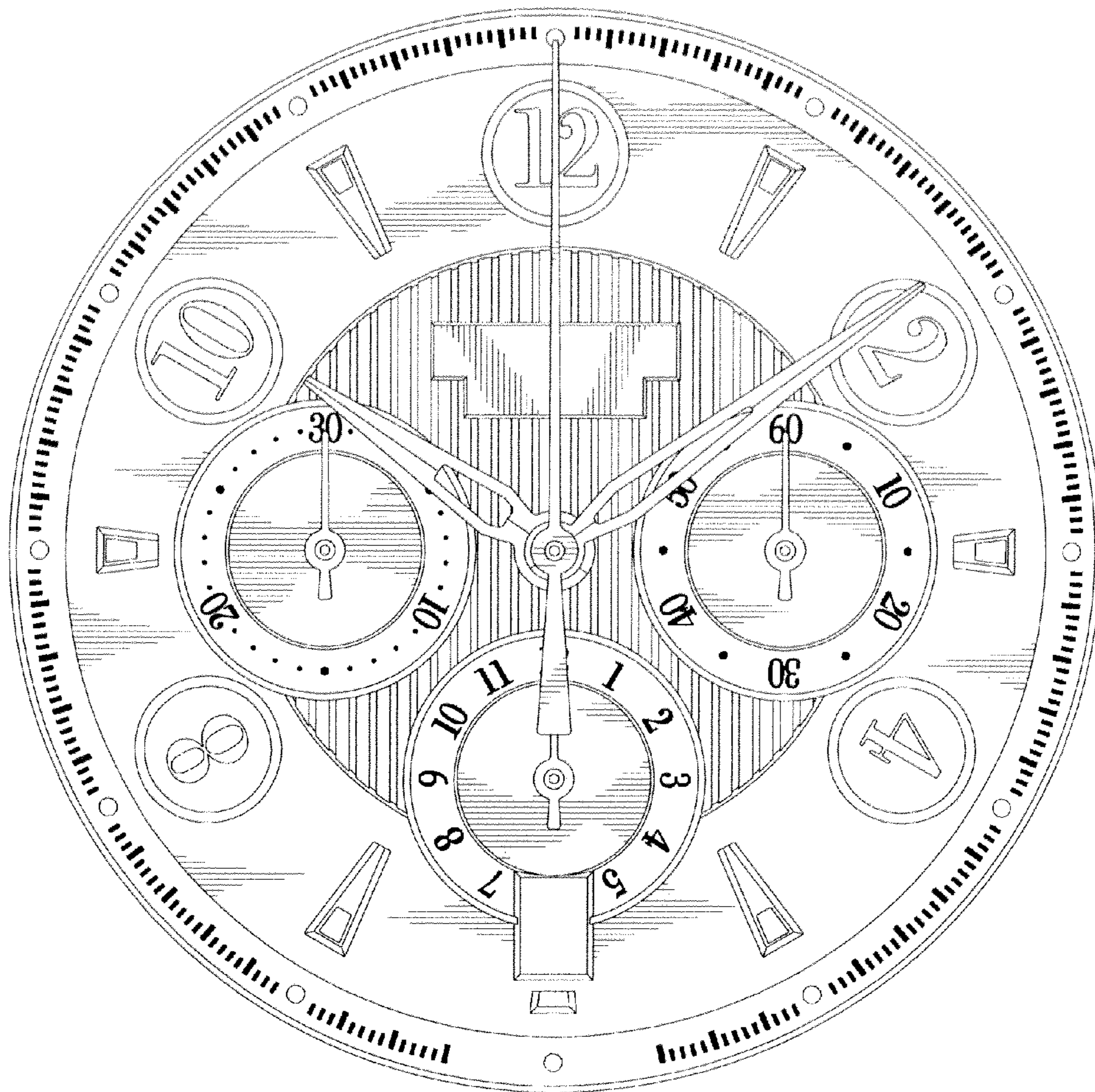

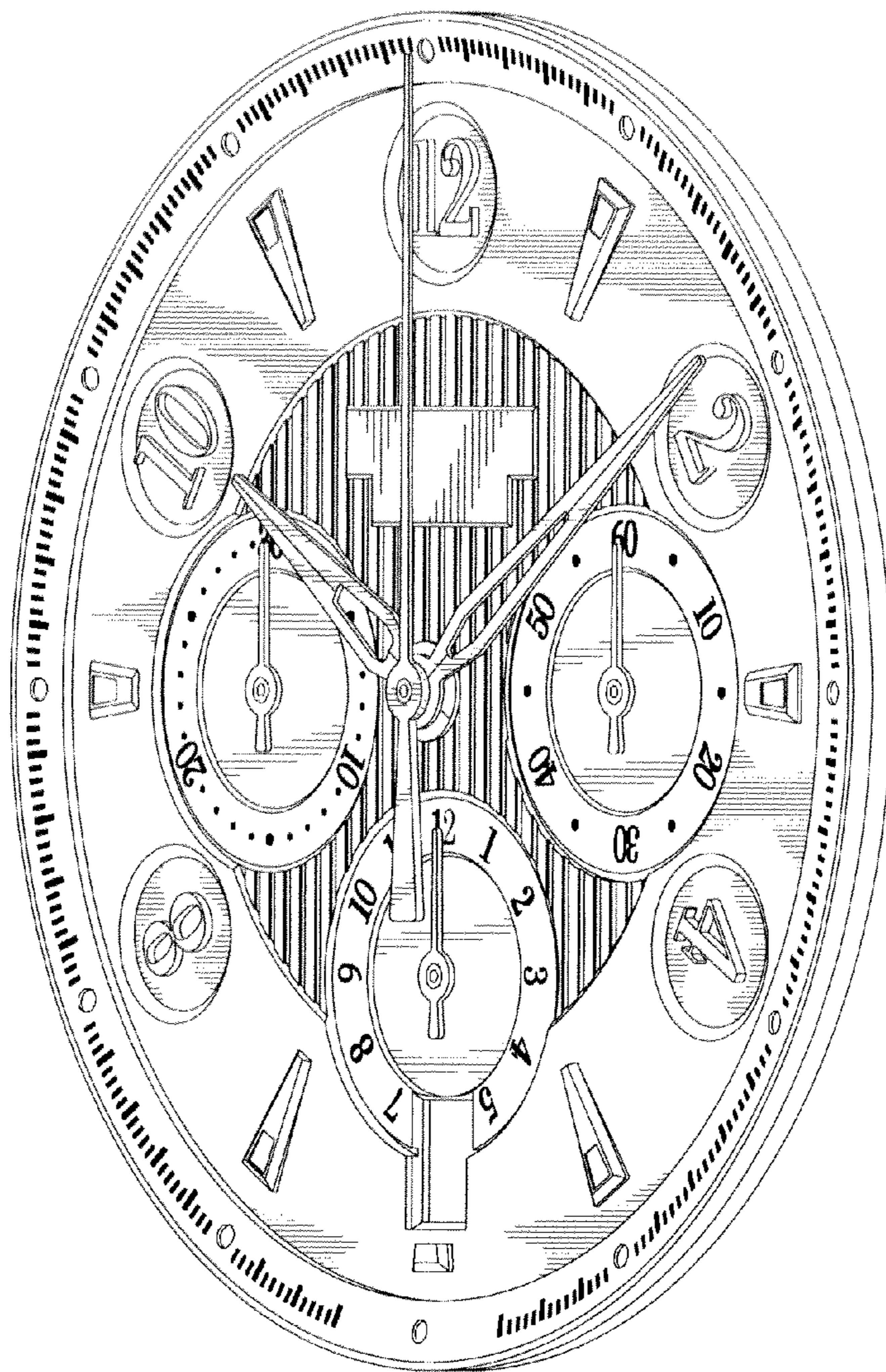
