The ornamental design for a vase, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the invention, fully assembled.

FIG. 2 is an exploded view thereof.

FIG. 3 is a perspective view of the base thereof shown removed from the base for clarity of disclosure; and,

FIG. 4 is a top view thereof.

The invention is symmetrical in that the front, rear, right and left side views are identical.

The bottom thereof is unornamented; a view thereof is therefore omitted.

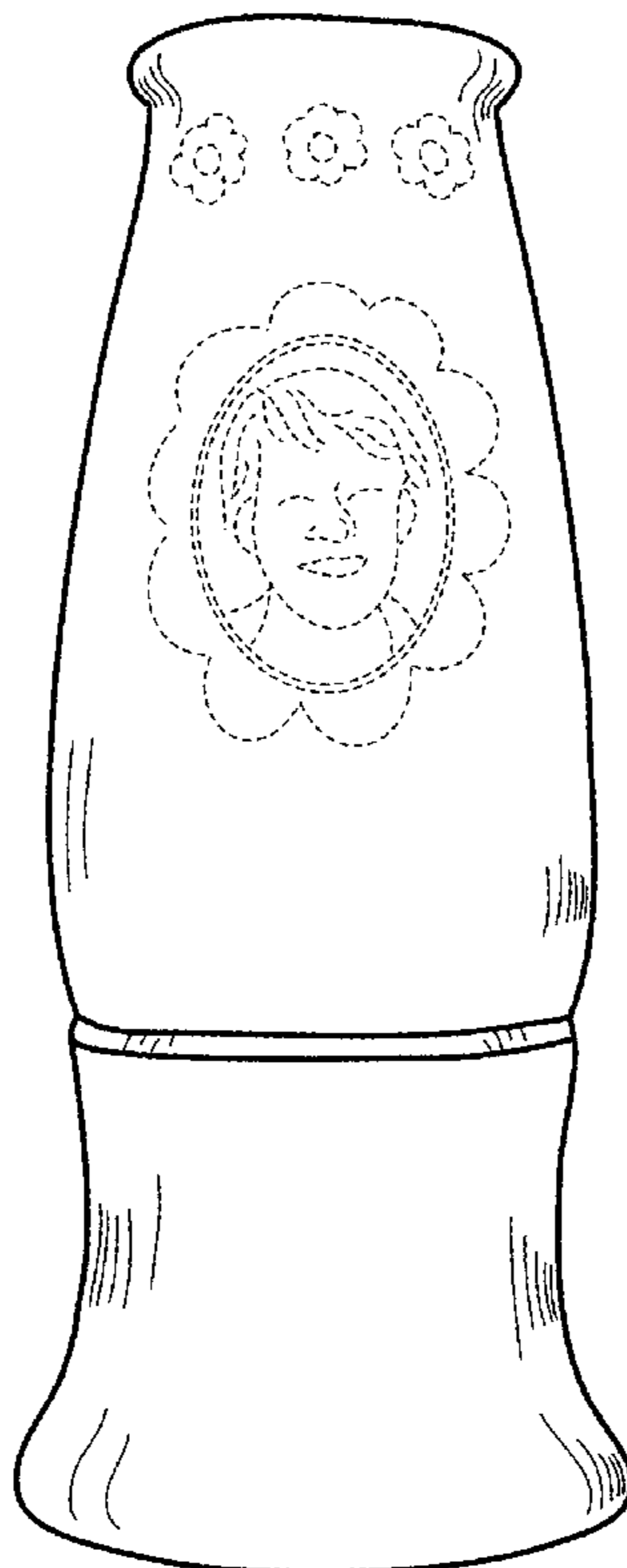

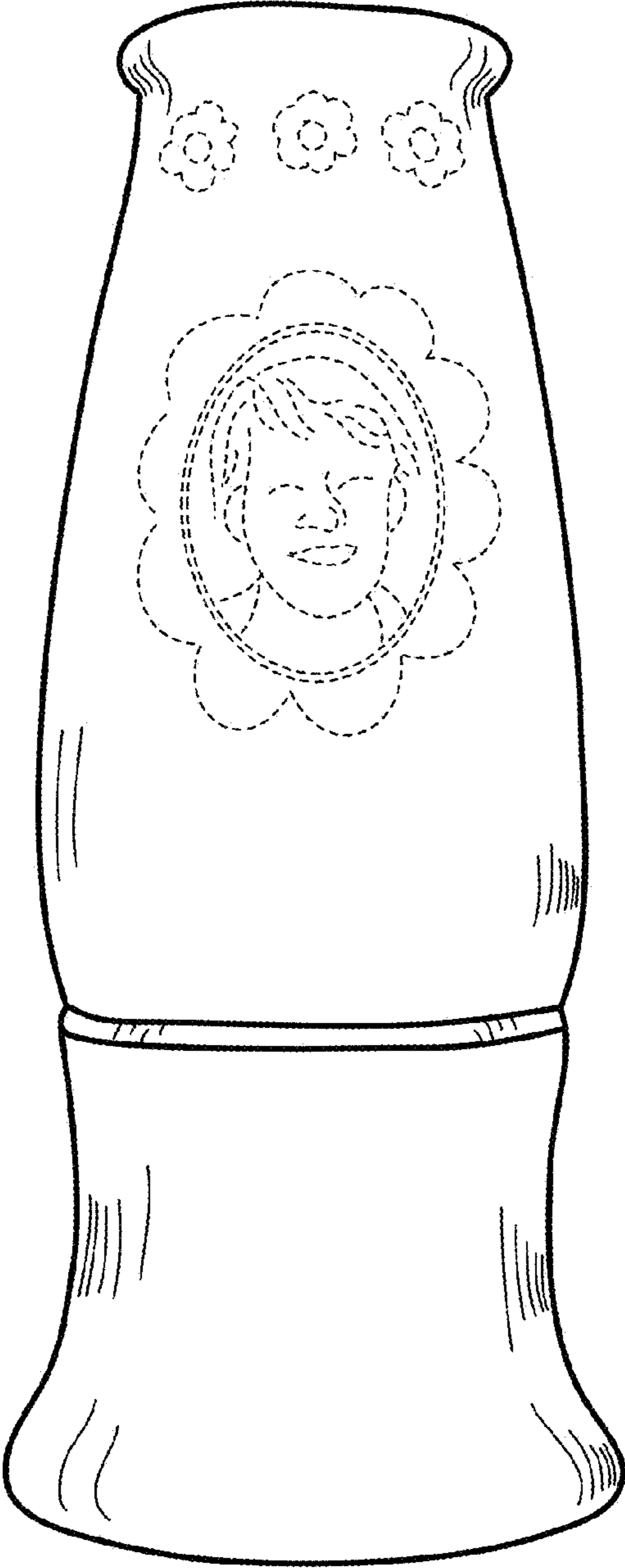

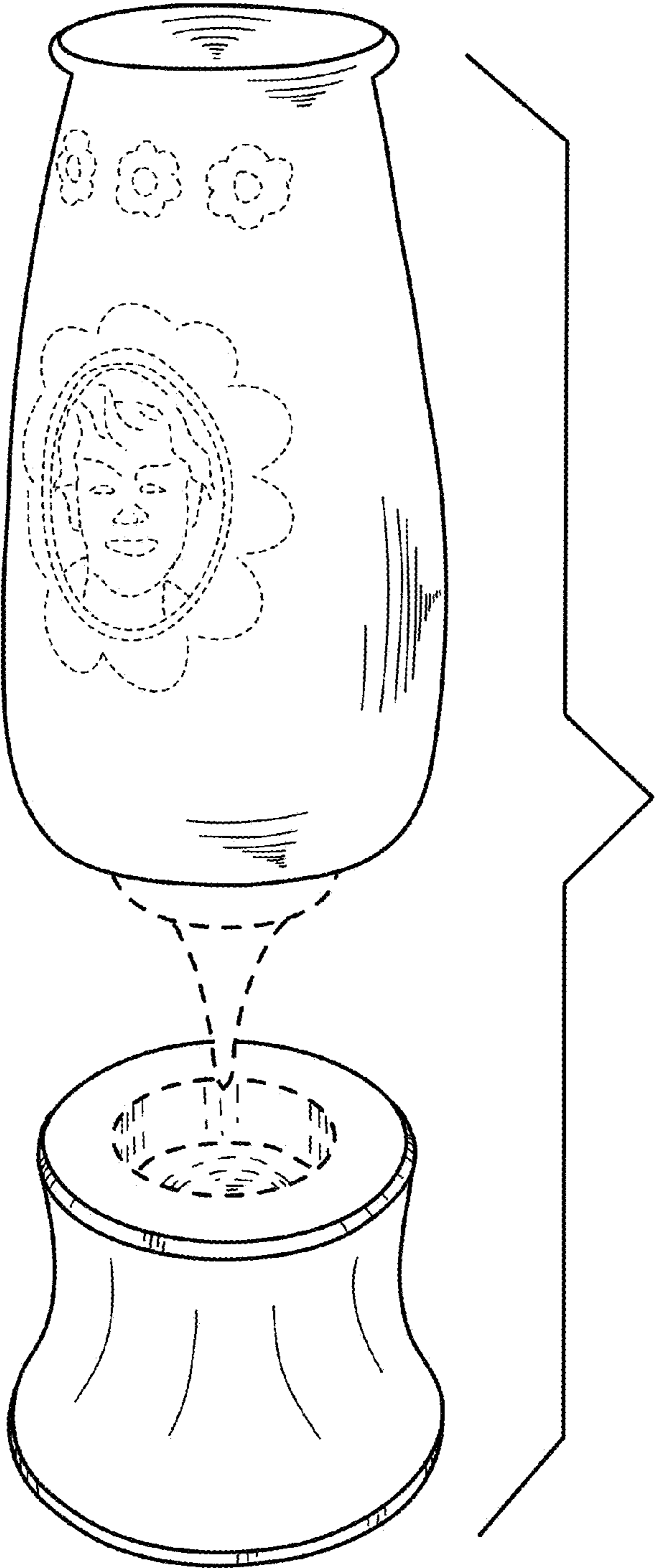

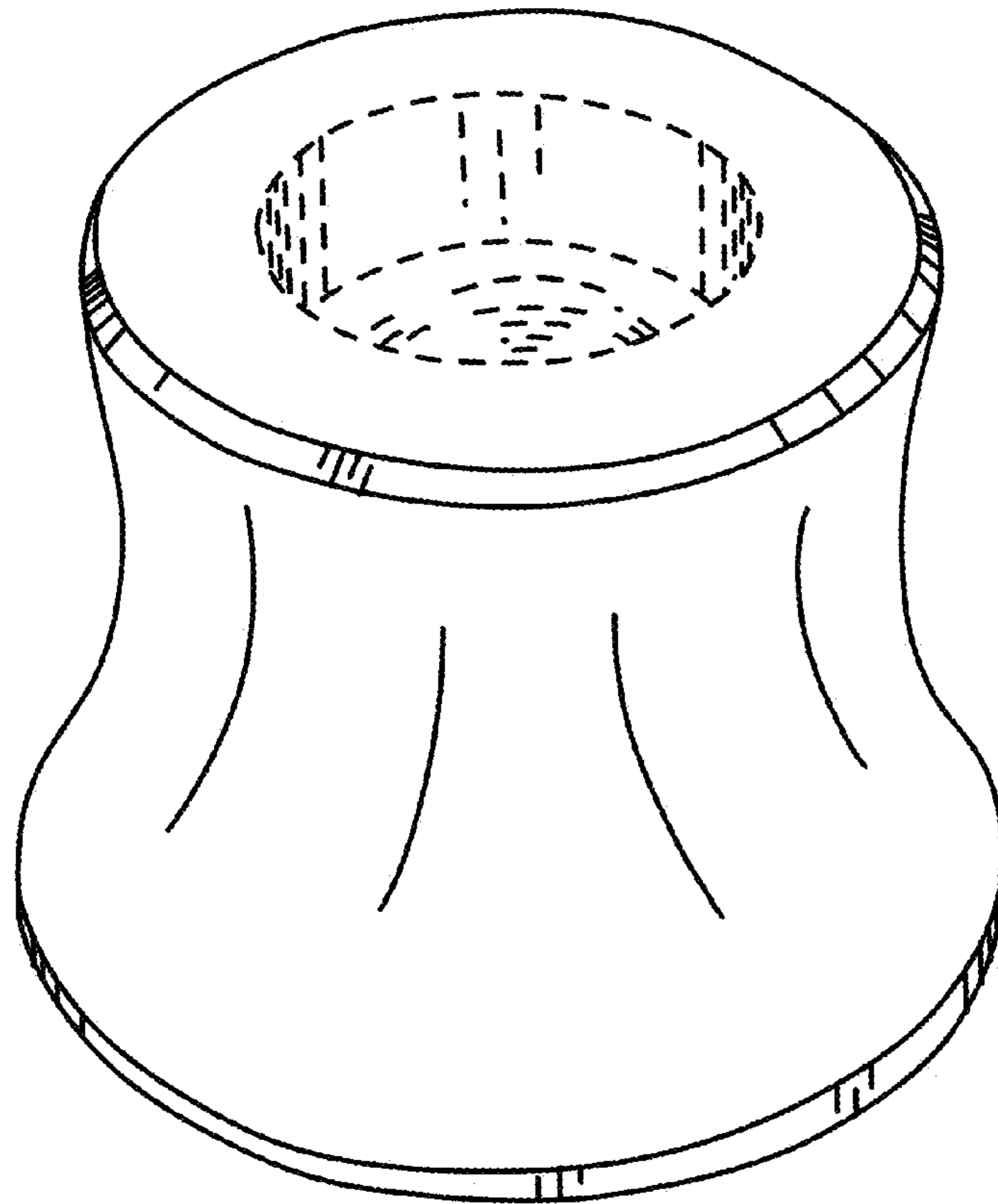


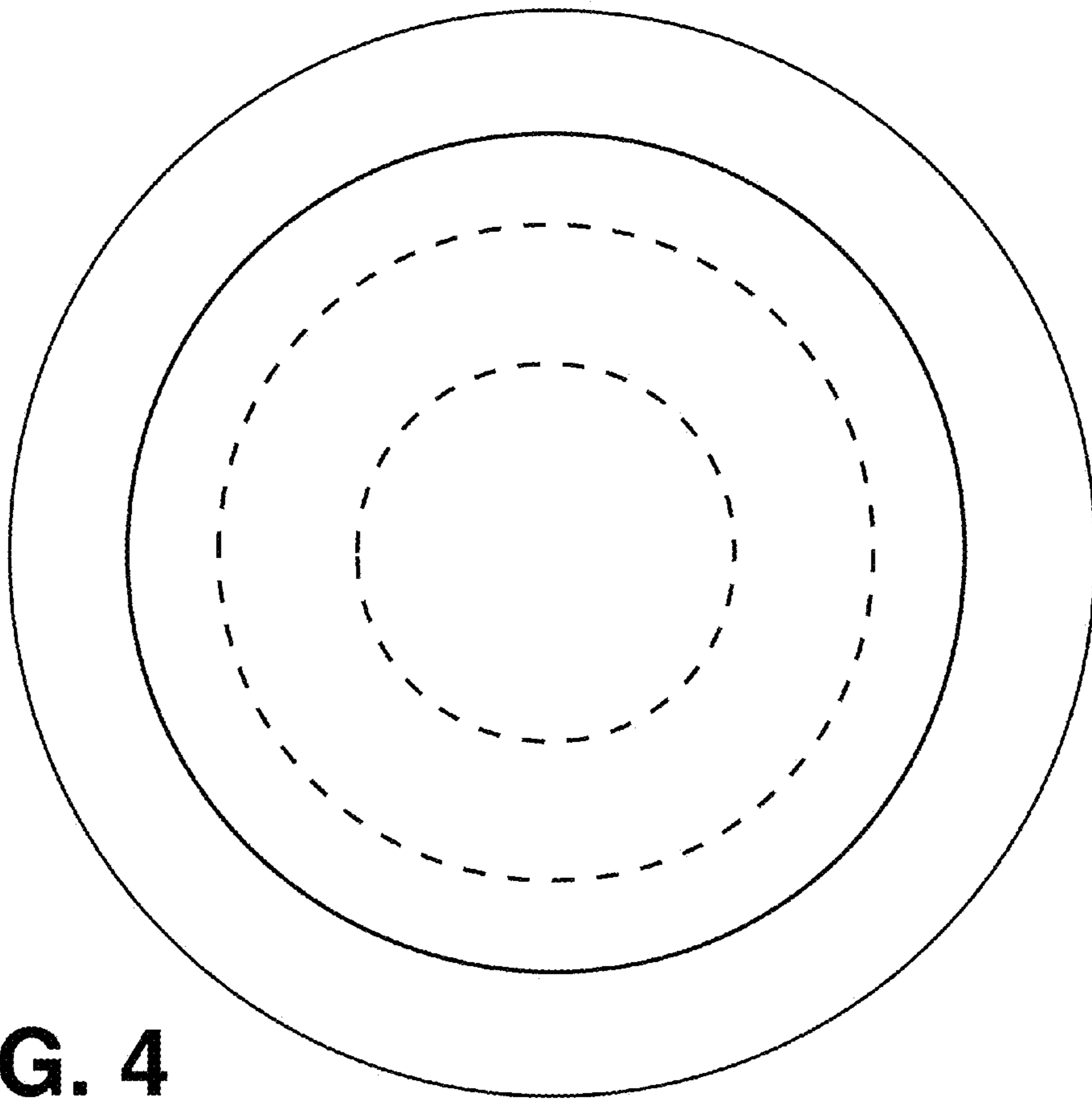
