FIG. 1 is a top perspective view of a vehicle, bumper unit for a vehicle according to our new design;

FIG. 2 is bottom perspective of the vehicle bumper unit of FIG. 1;

FIG. 3 is a front view of the vehicle bumper unit of FIG. 1;

FIG. 4 is a top view of vehicle bumper unit of FIG. 1; and,

FIG. 5 is a bottom view of vehicle bumper unit of FIG. 1.

FIGS. 1-5 illustrate a first embodiment of our novel design suitable for use on the left side of a vehicle. Our novel design also includes a second embodiment suitable for use on the right side of a vehicle, which is mirror symmetrical to FIGS. 1-5 and therefore not separately illustrated.

The rear of the vehicle bumper unit is unornamented.

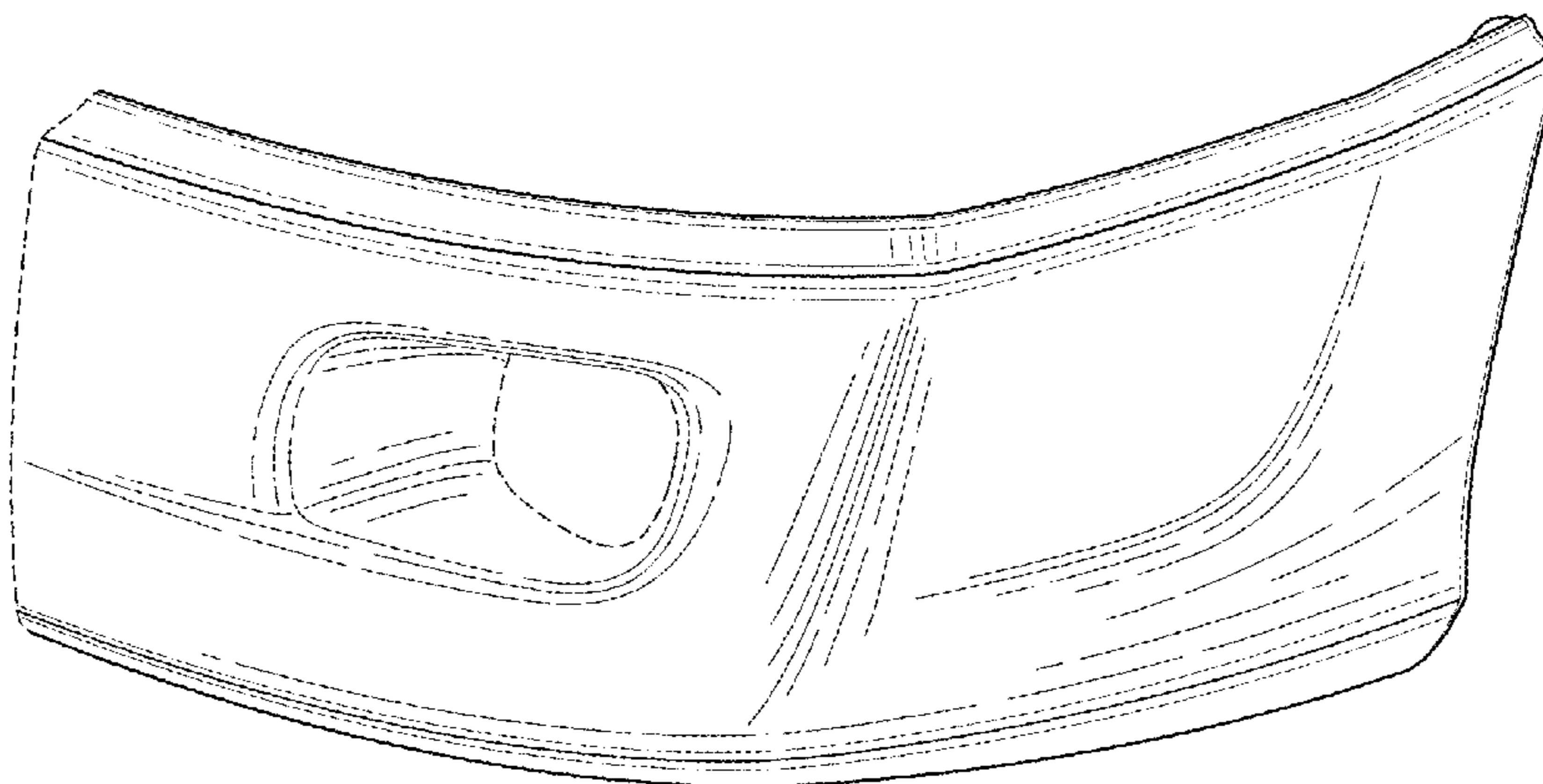

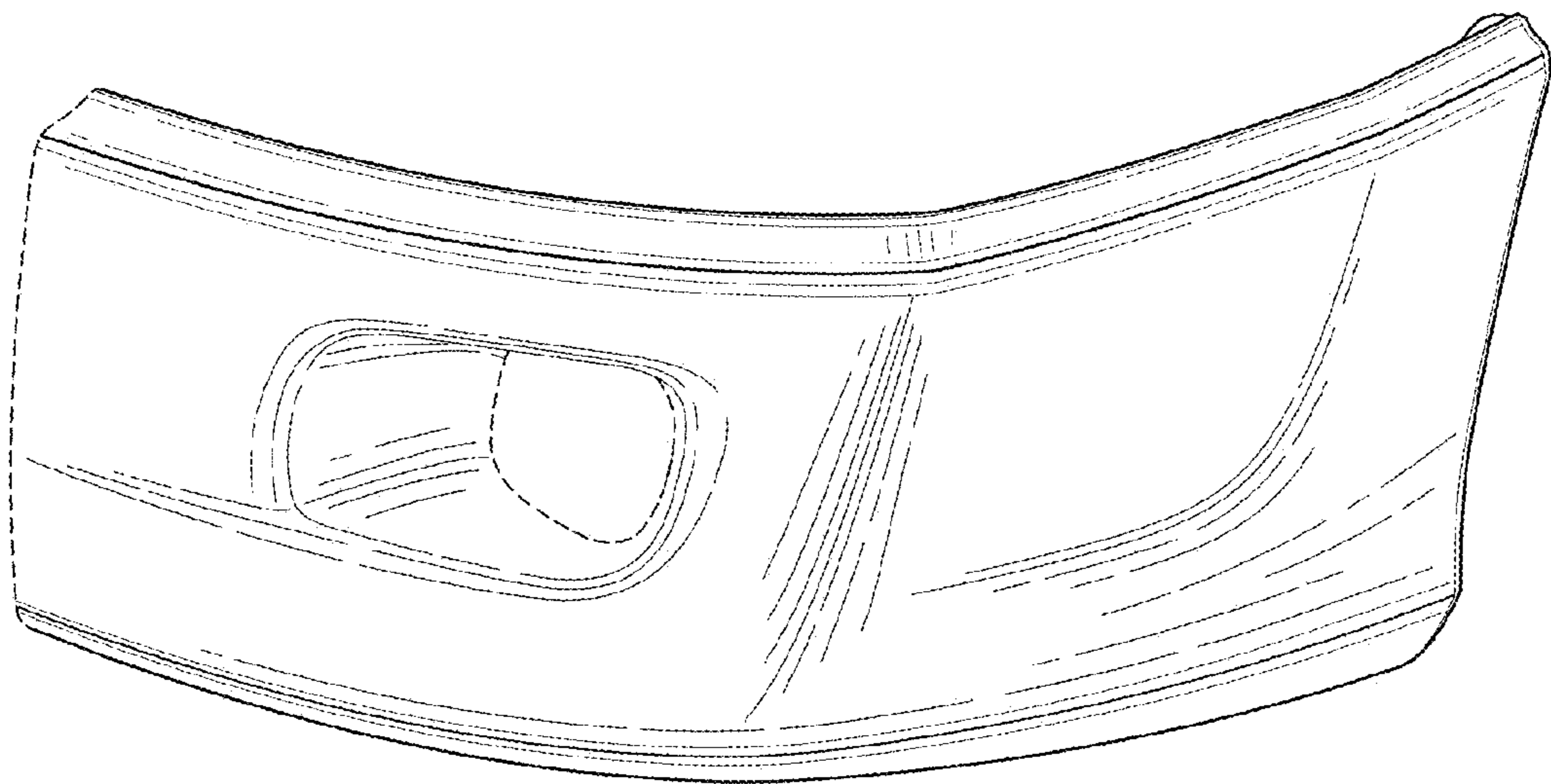

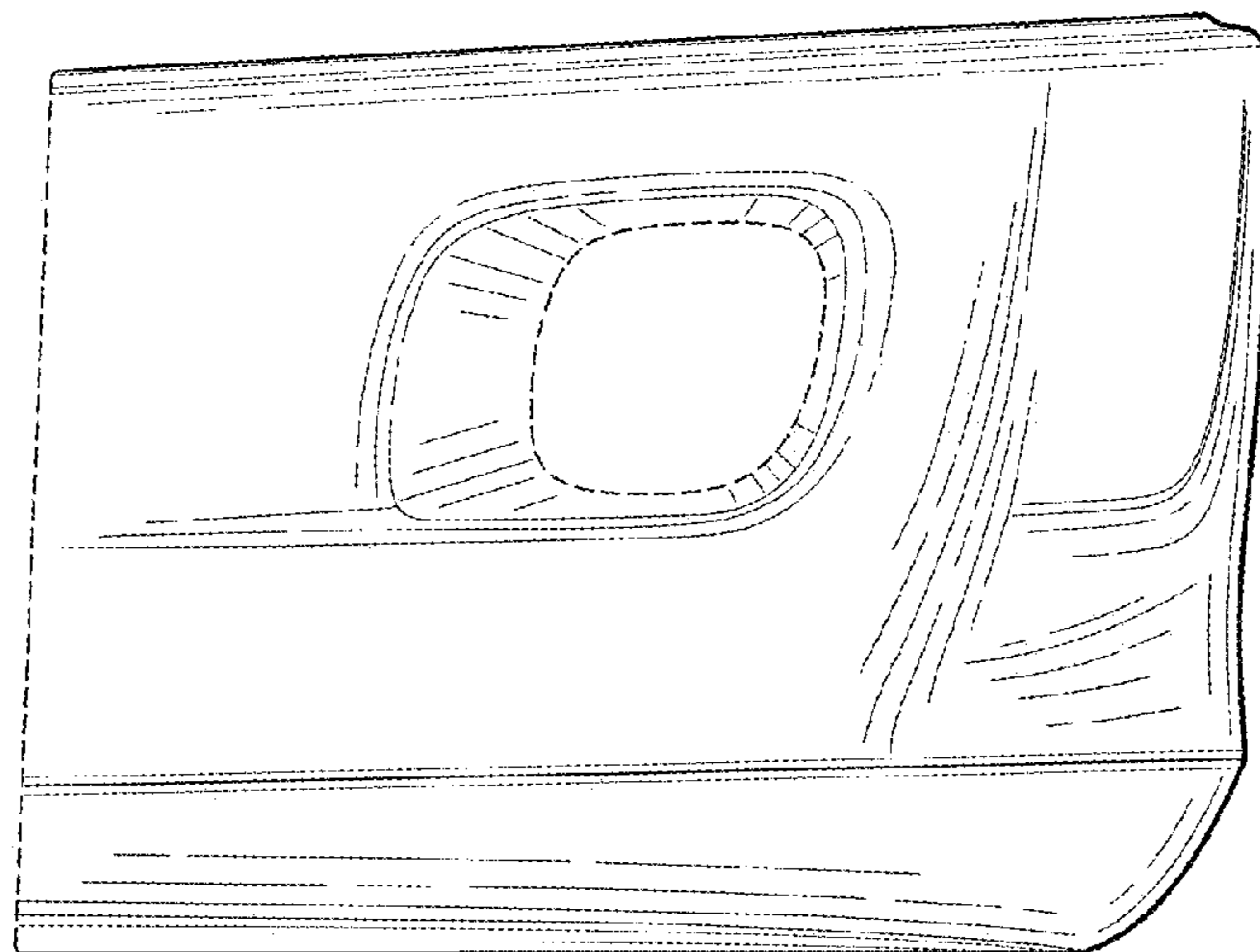

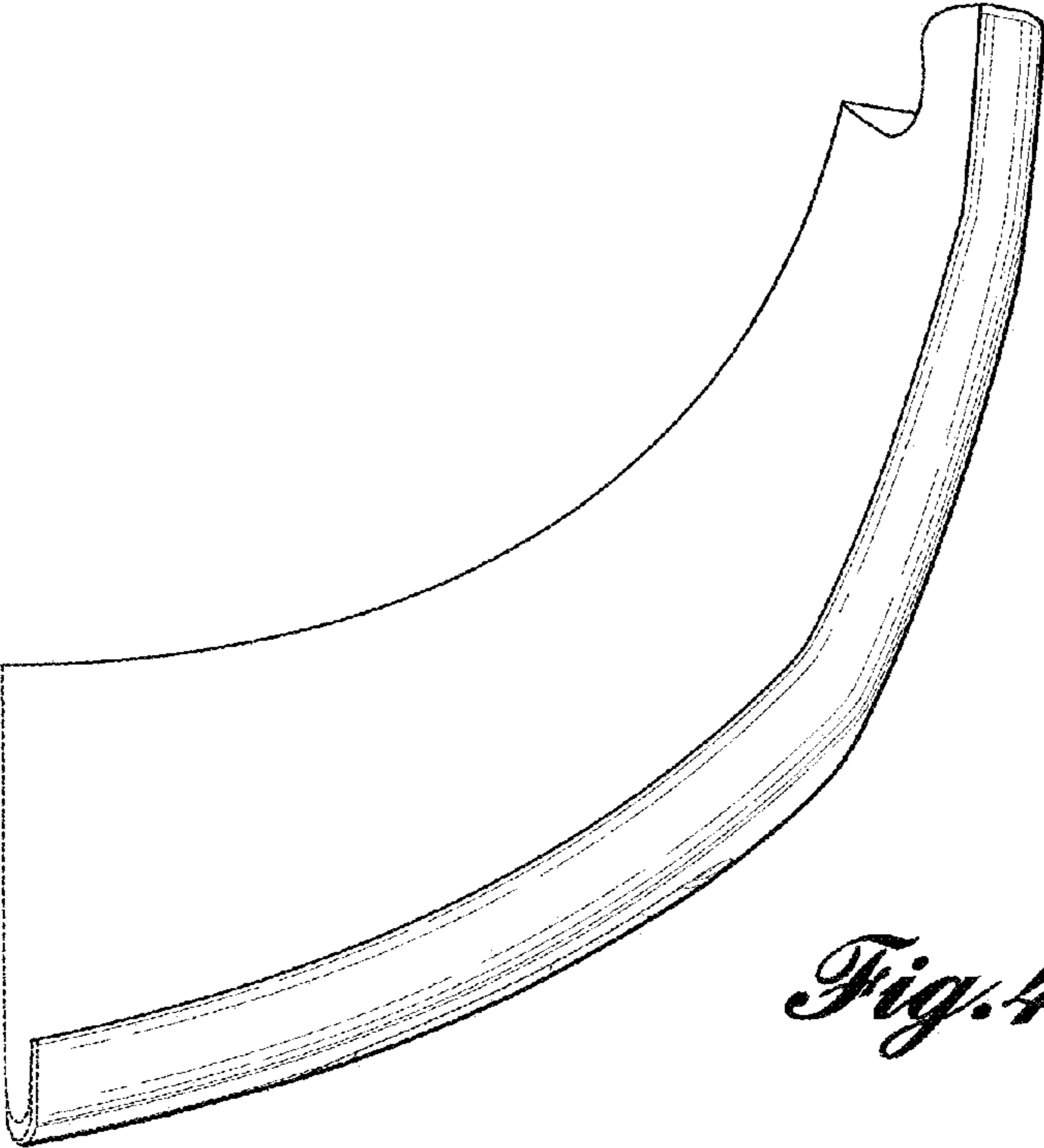

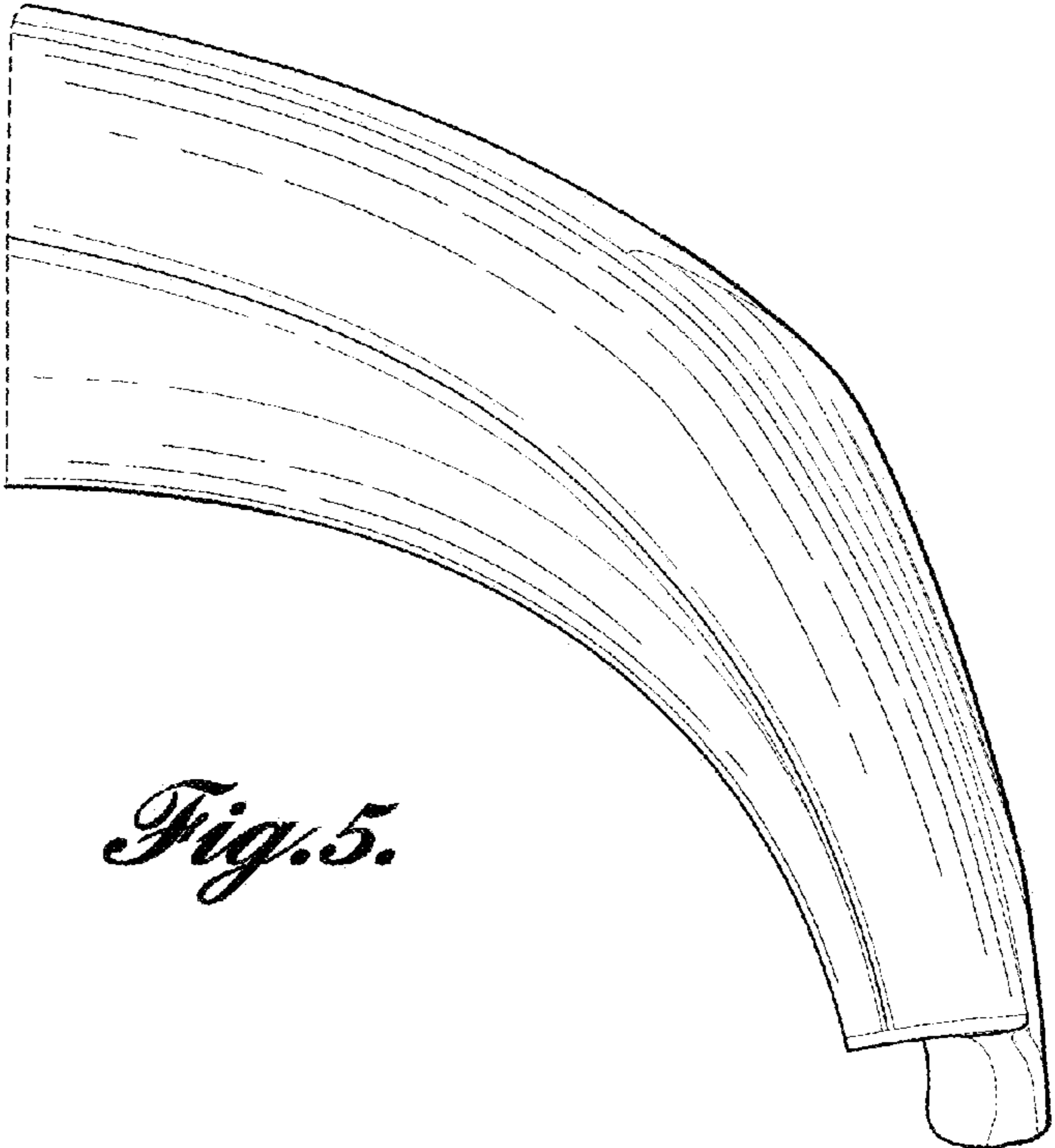
