mented.

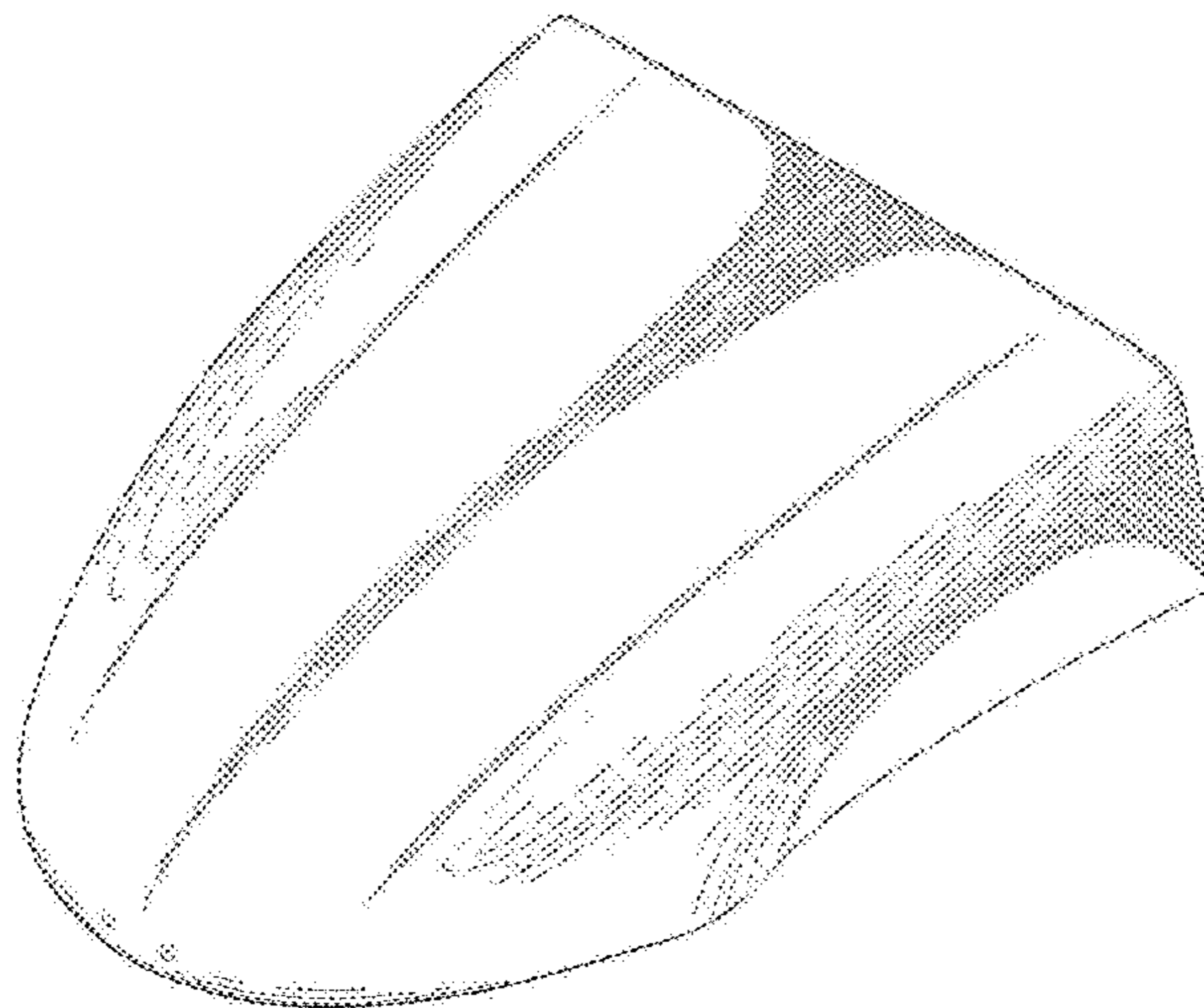

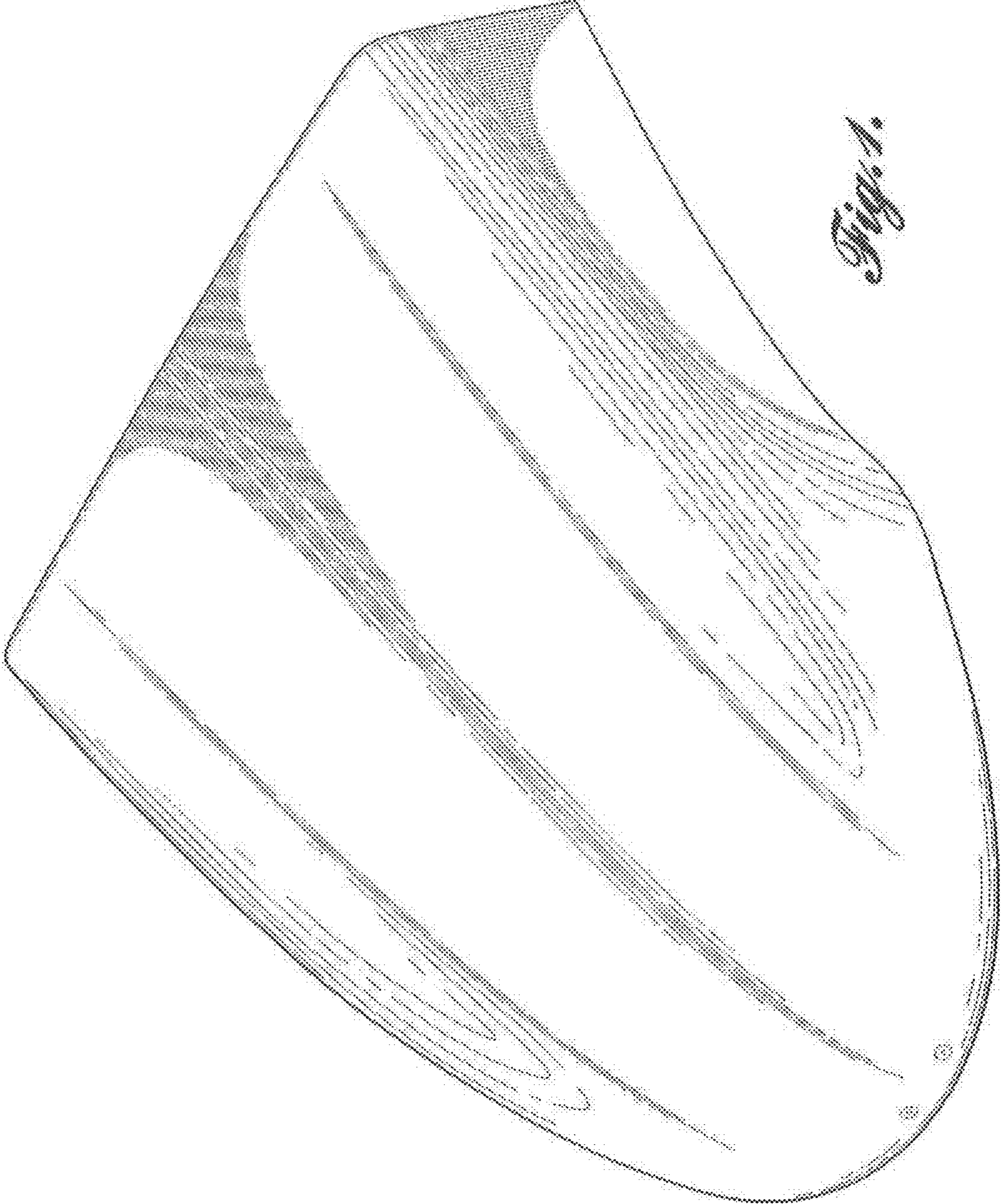

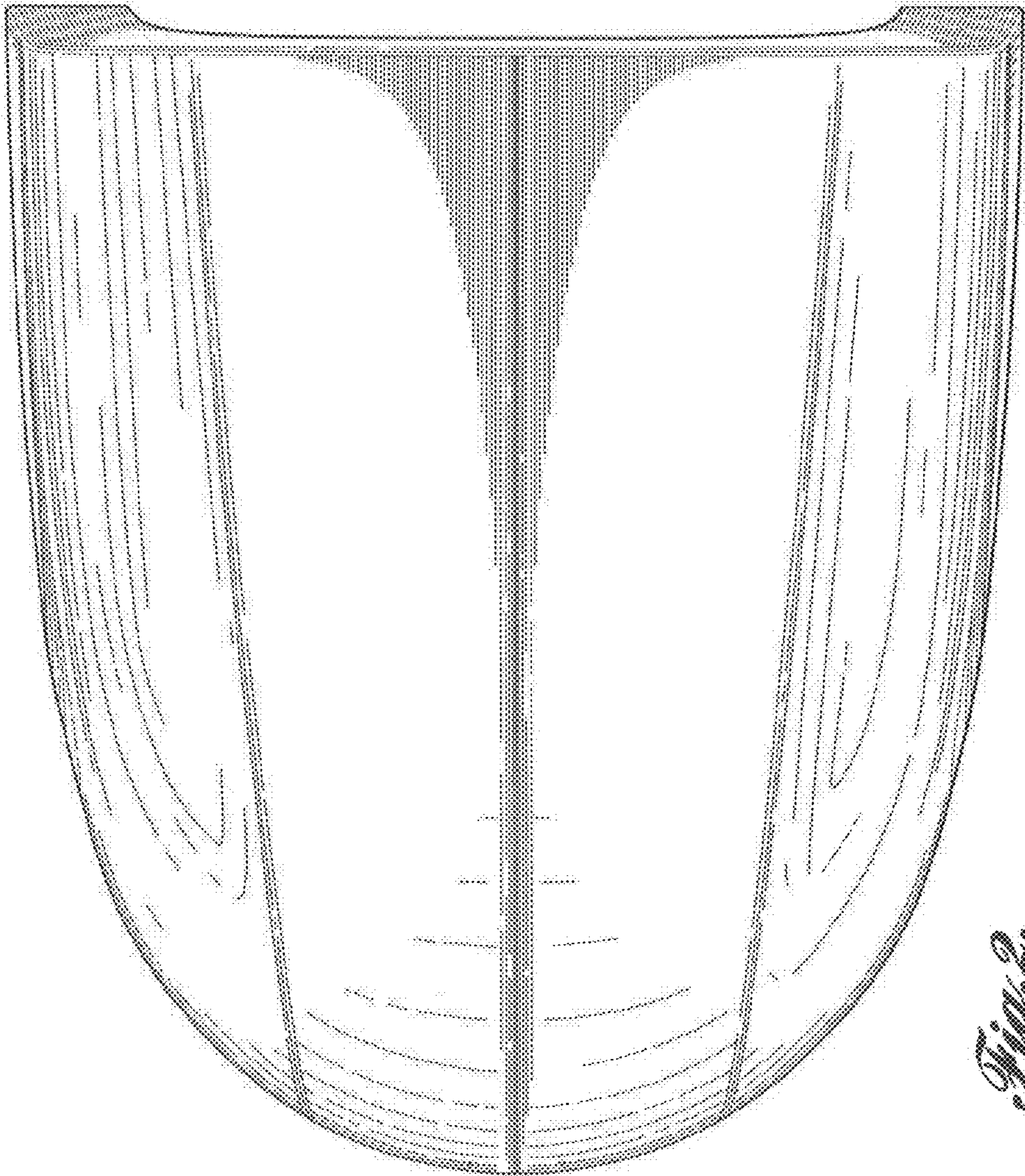

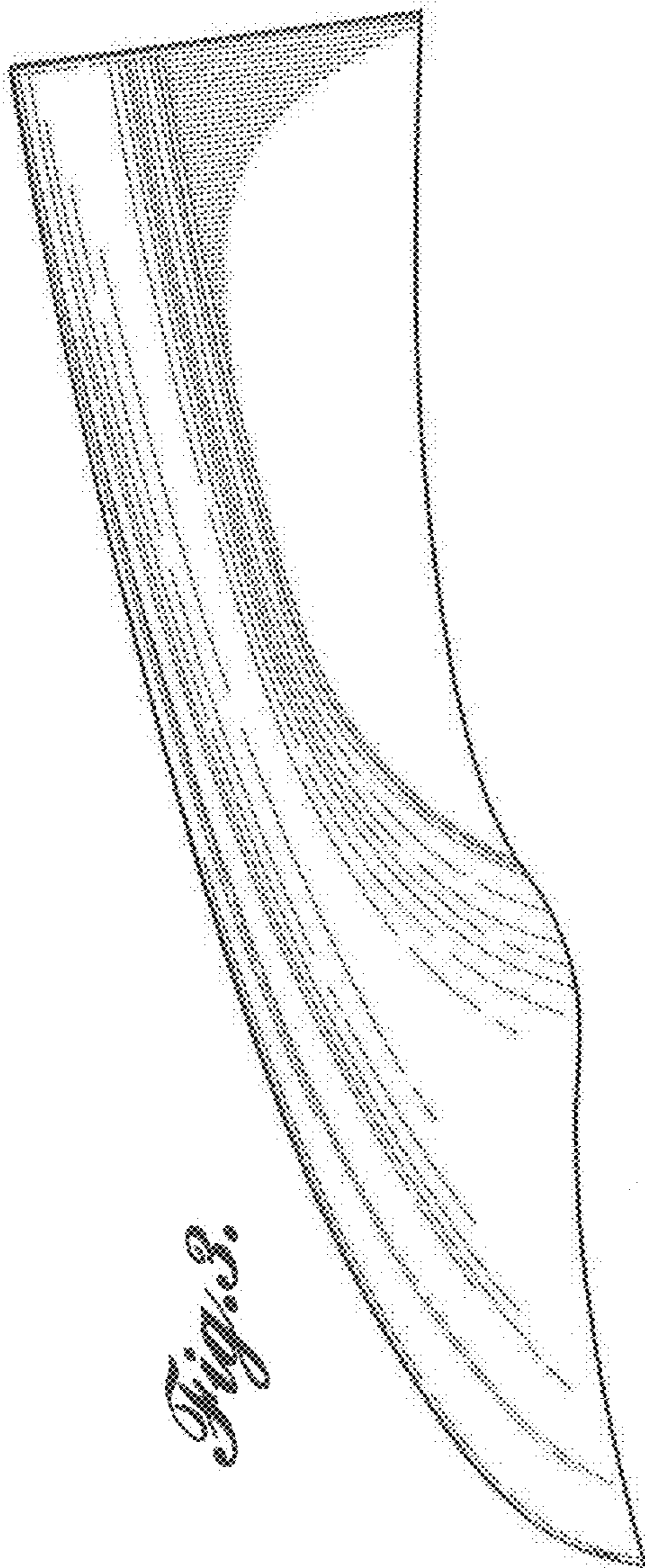

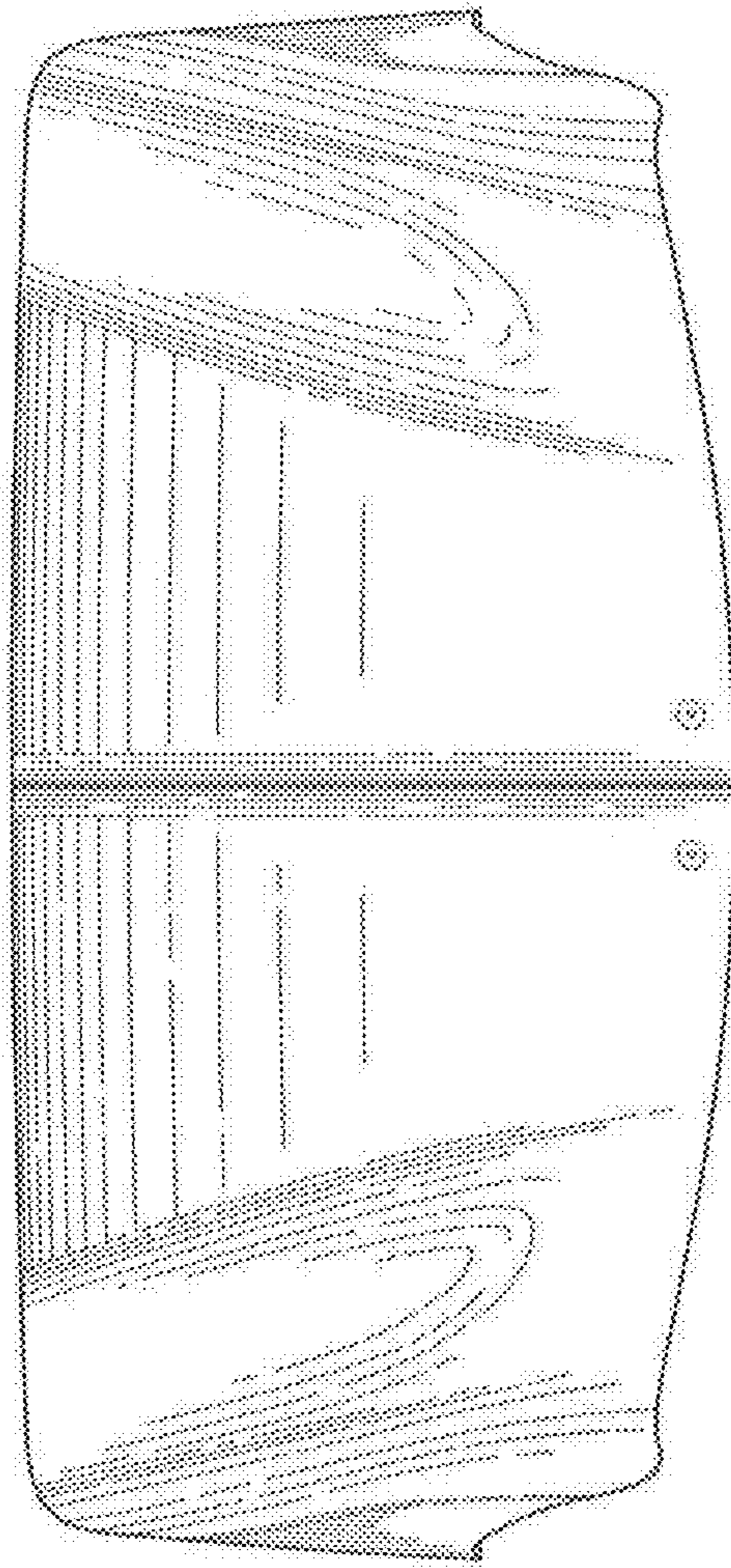
