The ornamental design for a three dimensional shark fin vehicle ornament, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the three dimensional vehicle ornament of the present invention;  
FIG. 2 is a view of the left side of the three dimensional vehicle ornament of the present invention;  
FIG. 3 is a view of the right side of the three dimensional vehicle ornament of the present invention;  
FIG. 4 is a front view of the three dimensional vehicle ornament of the present invention;  
FIG. 5 is a rear view of the three dimensional vehicle ornament of the present invention;  
FIG. 6 is a top view of the three dimensional vehicle ornament of the present invention; and,  
FIG. 7 is a bottom view of the three dimensional vehicle ornament of the present invention.

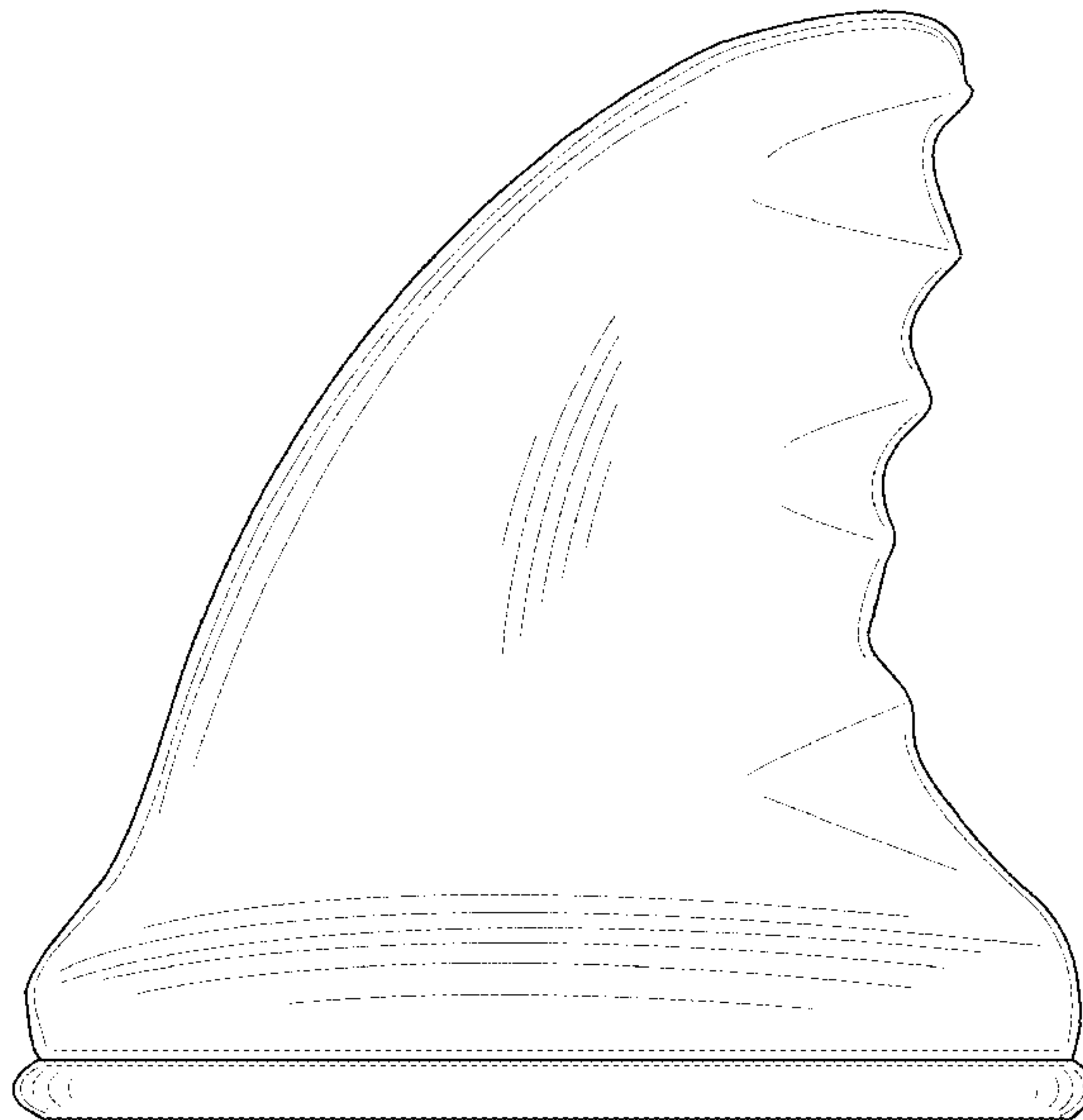
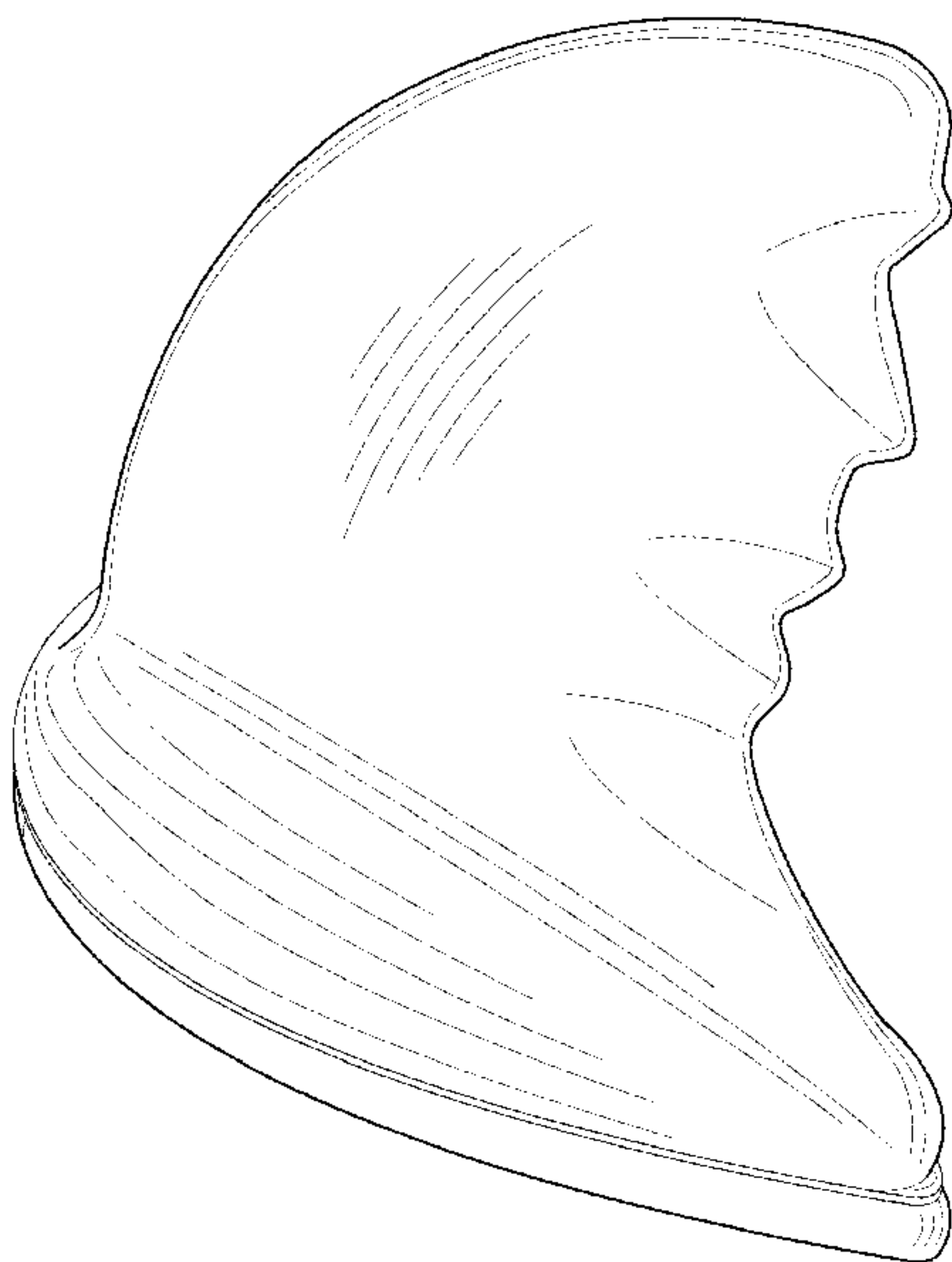

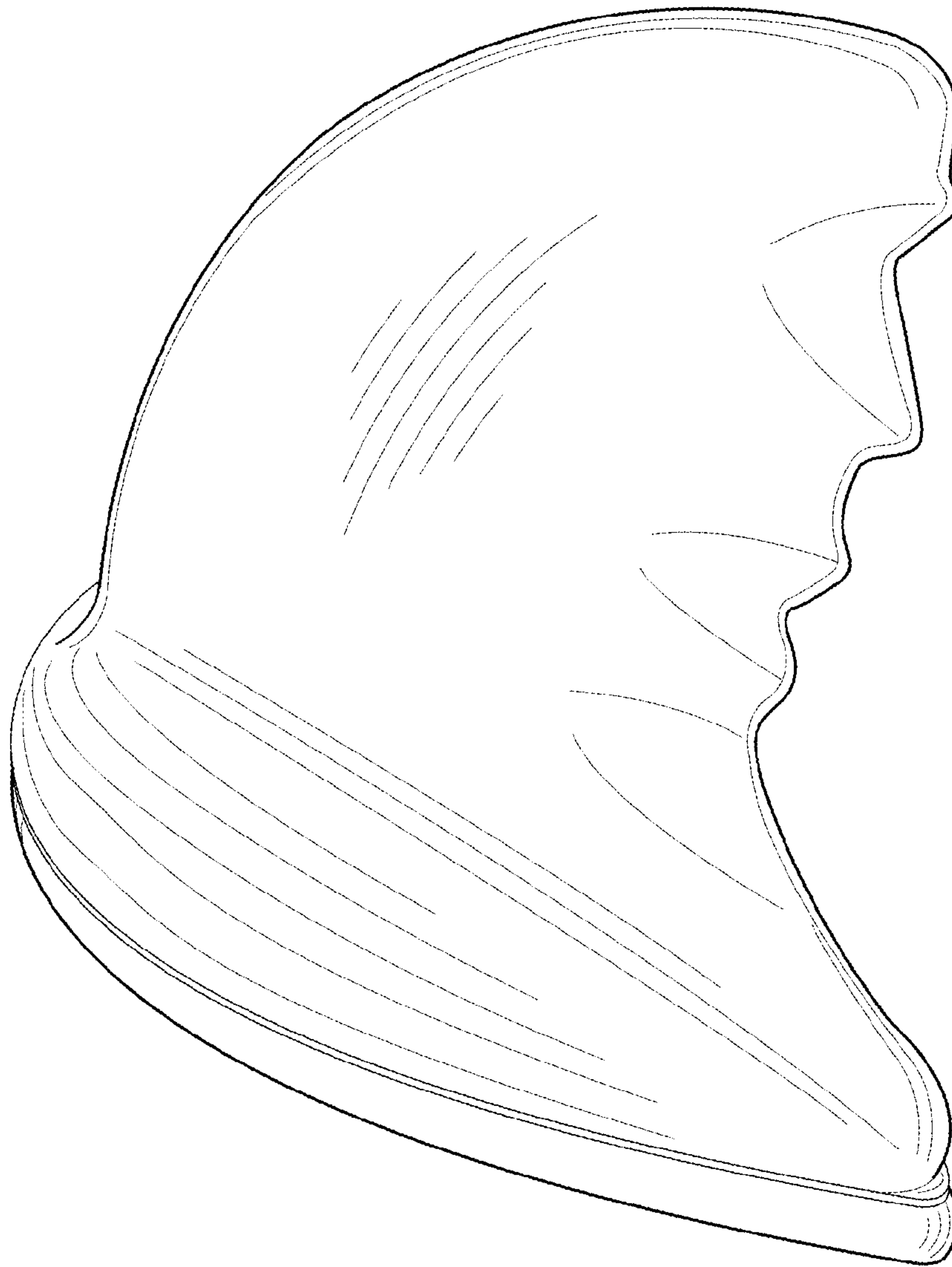

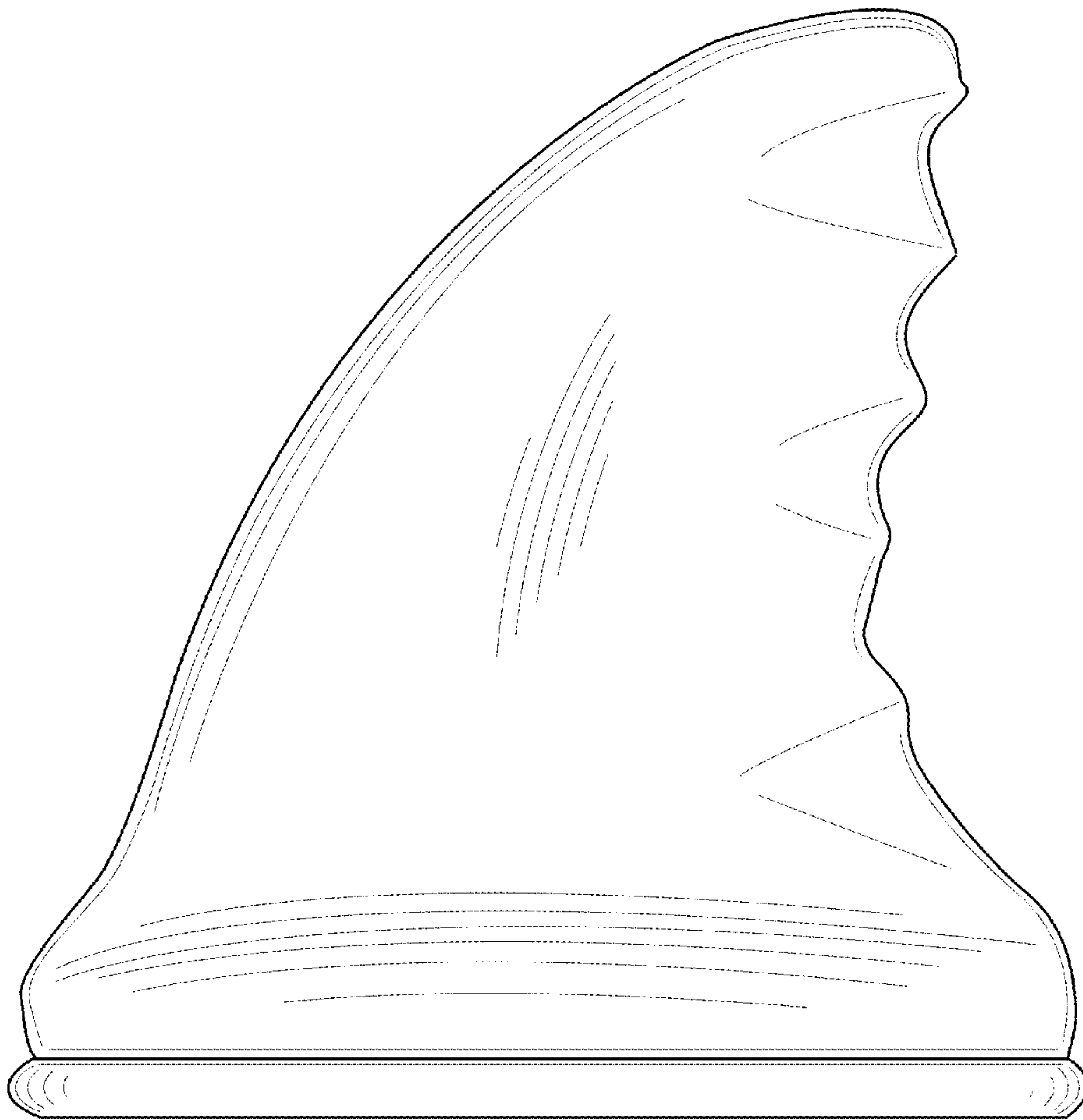

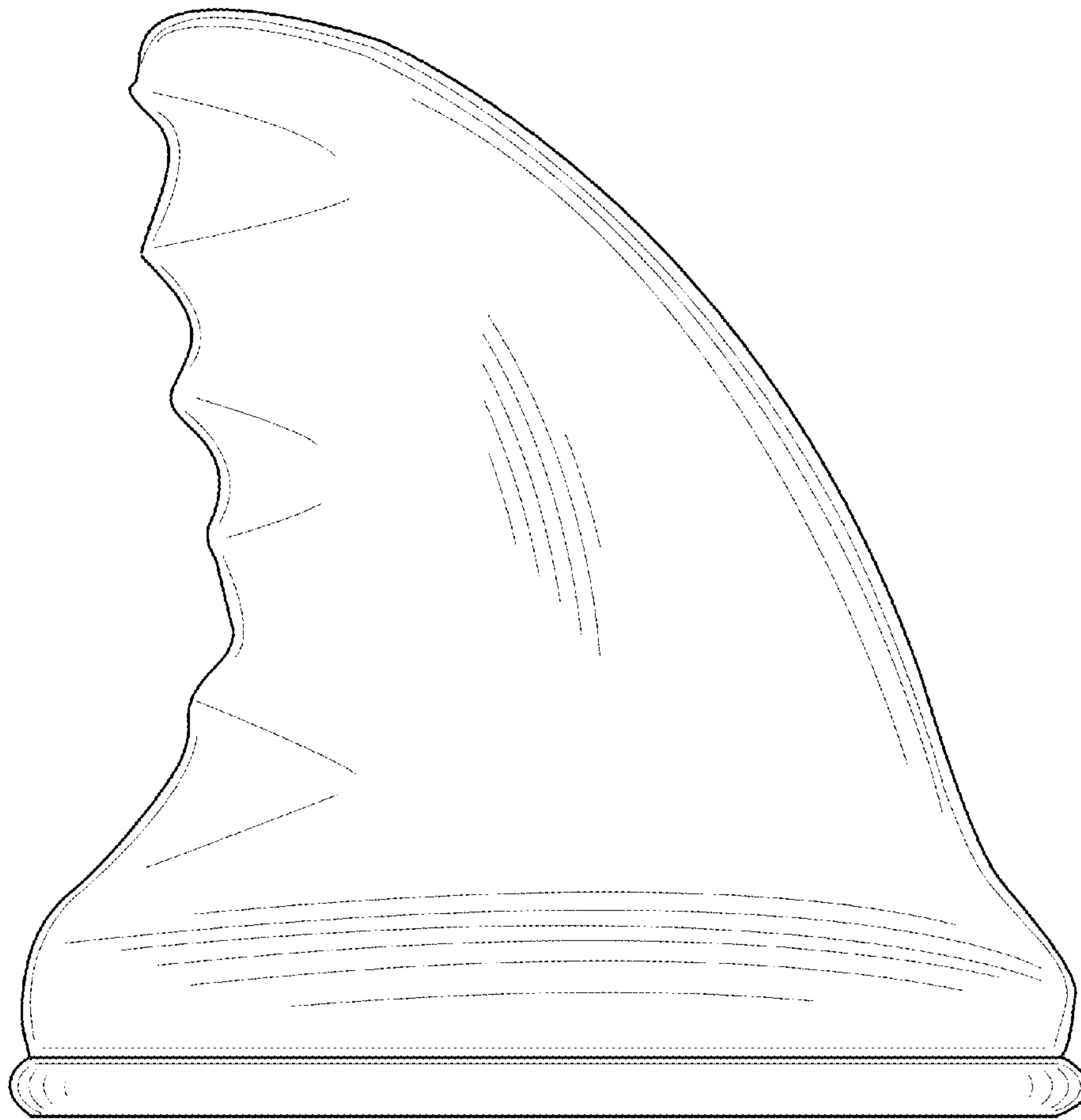

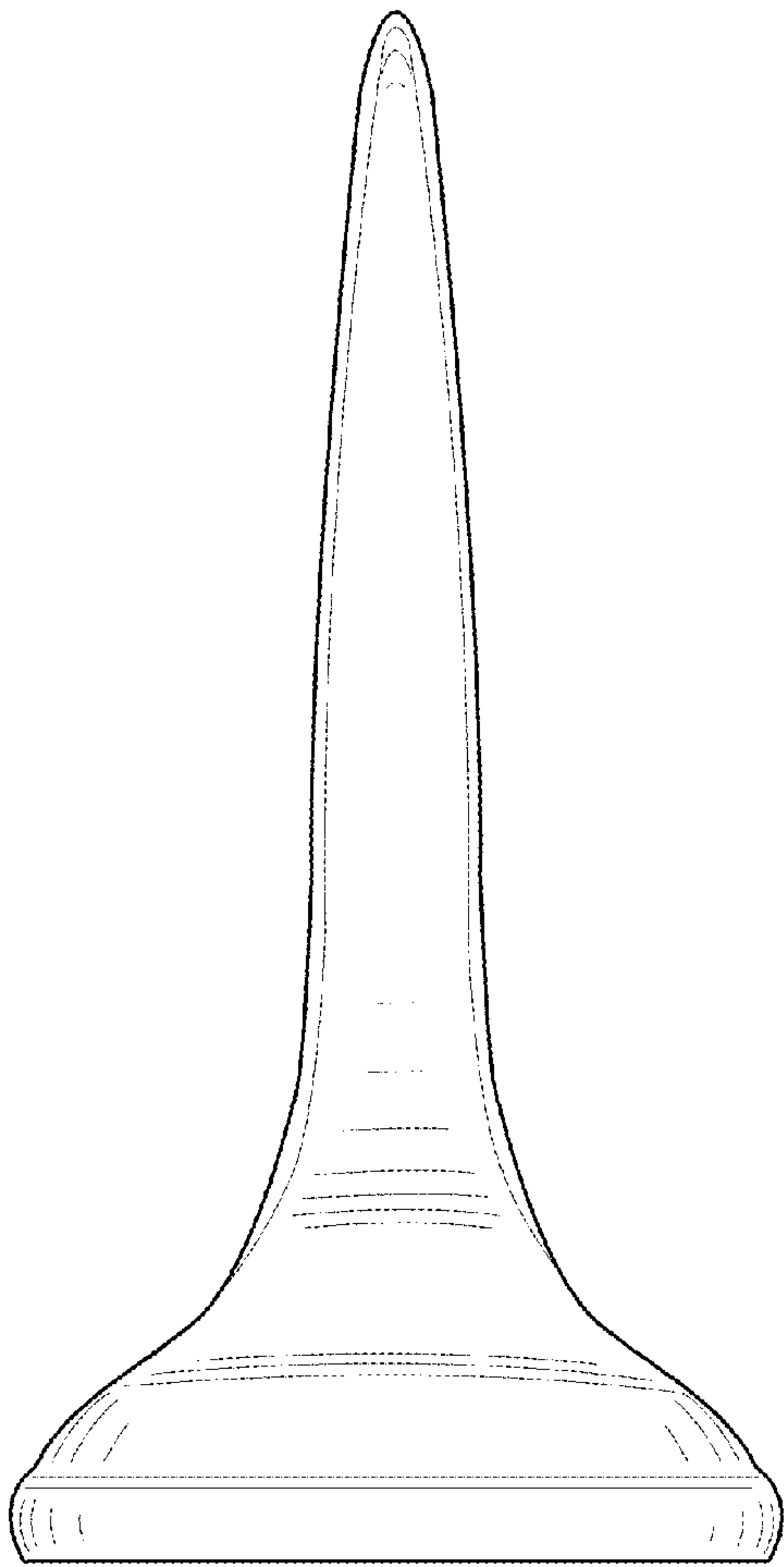

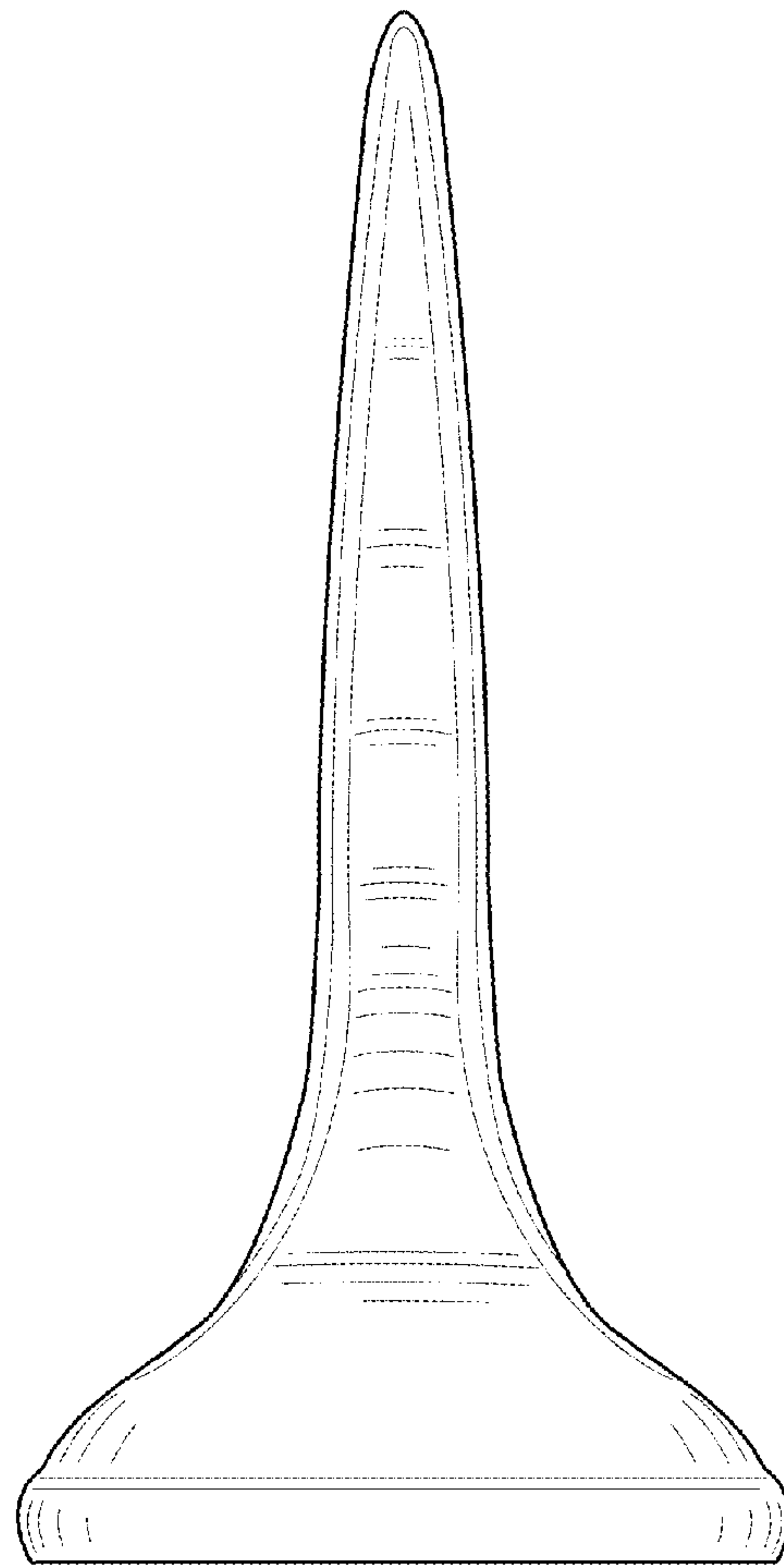

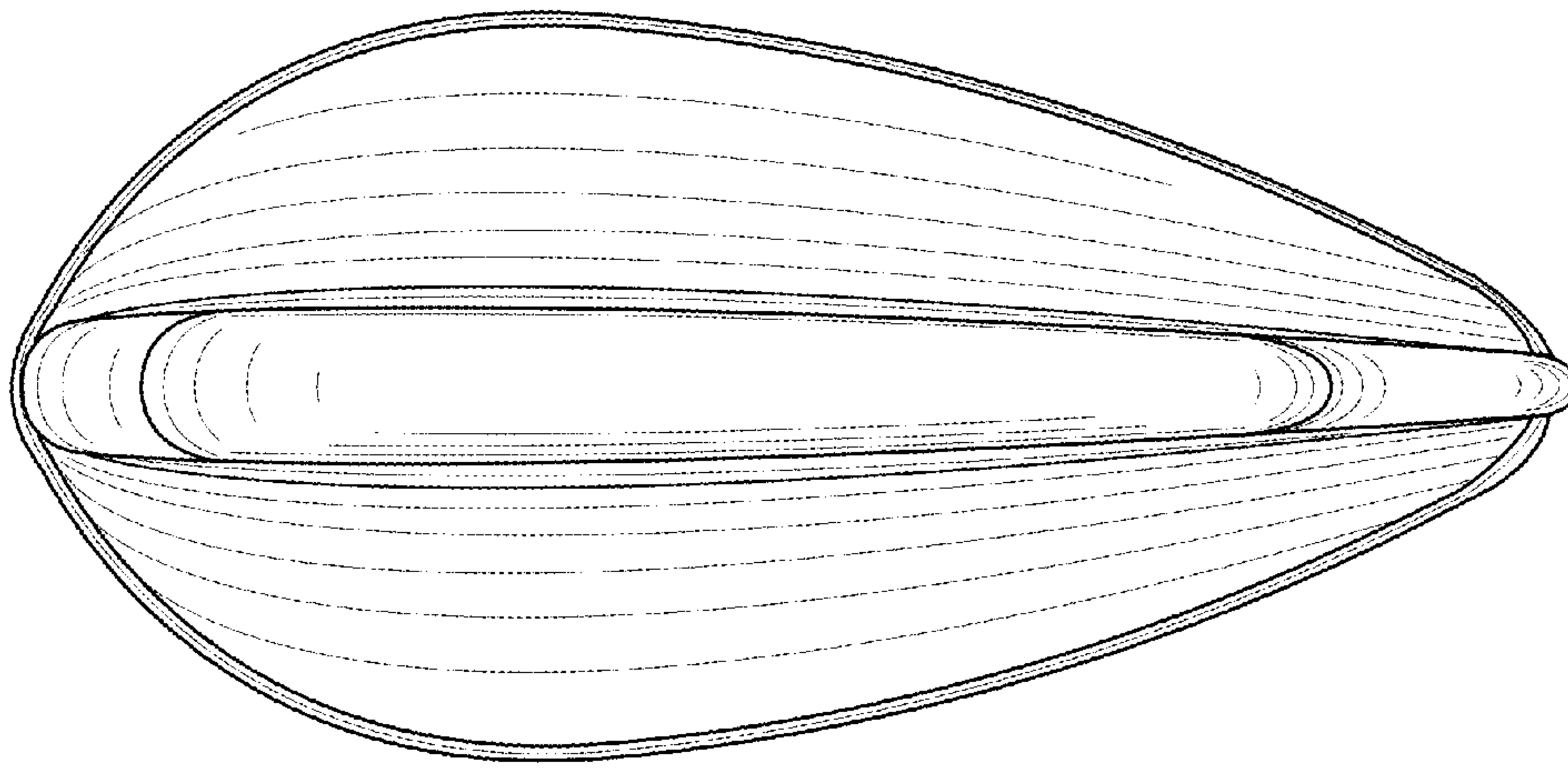
