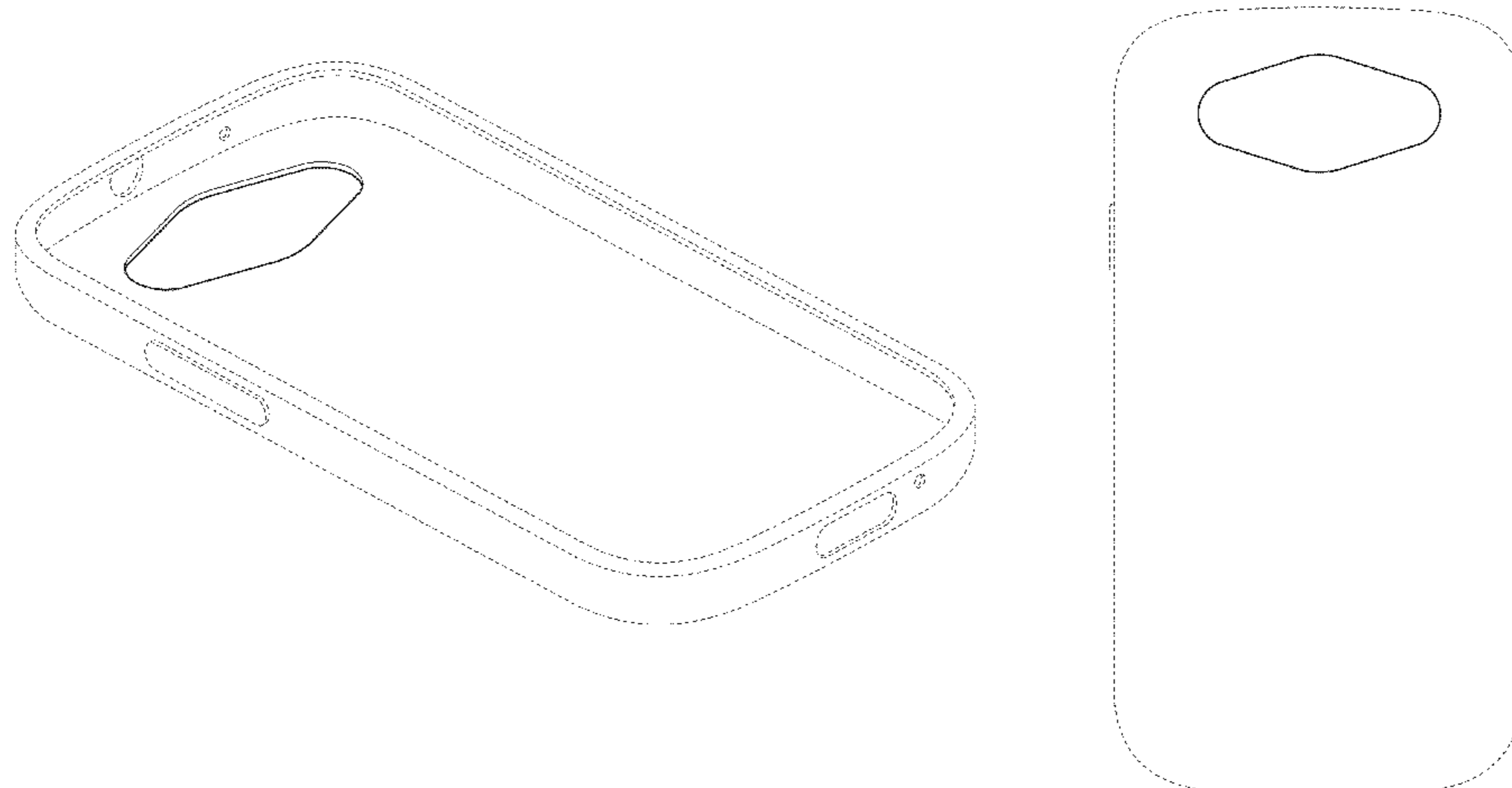
The ornamental design for a protective case for an electronic device, substantially as shown and described.

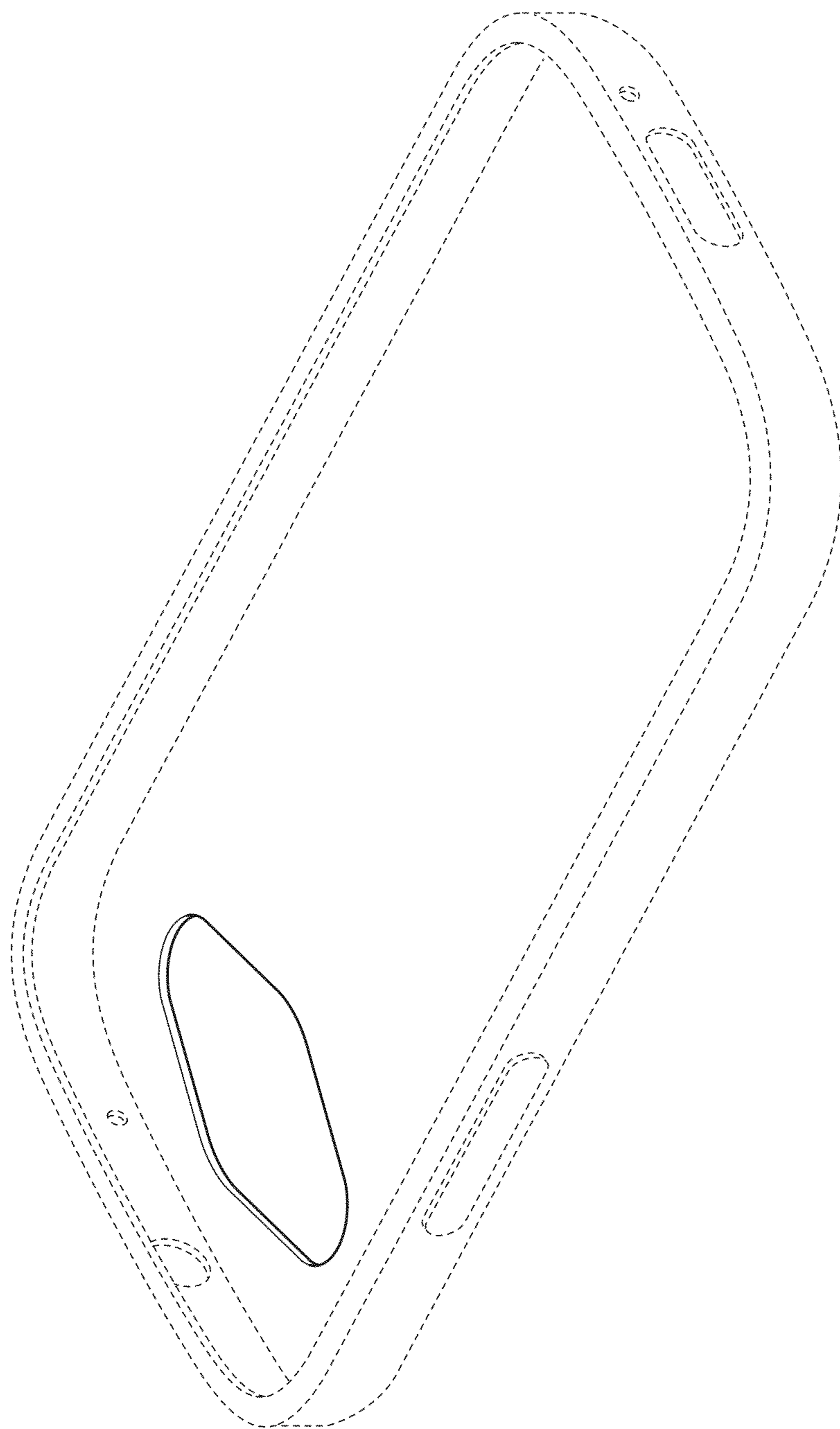
**DESCRIPTION**

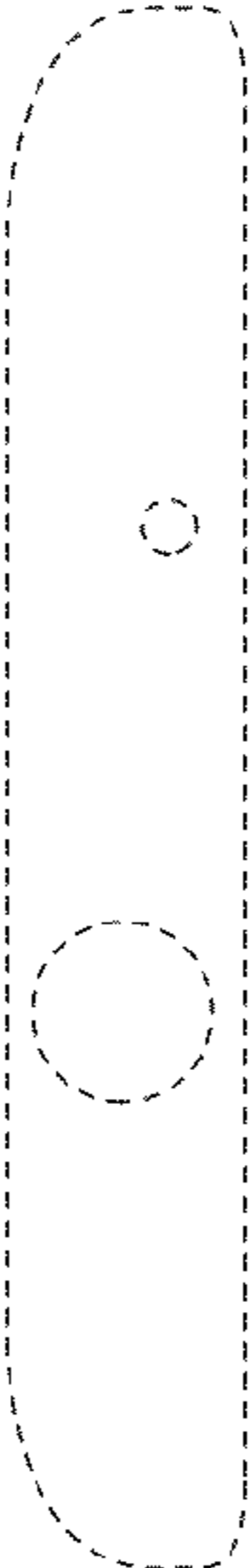

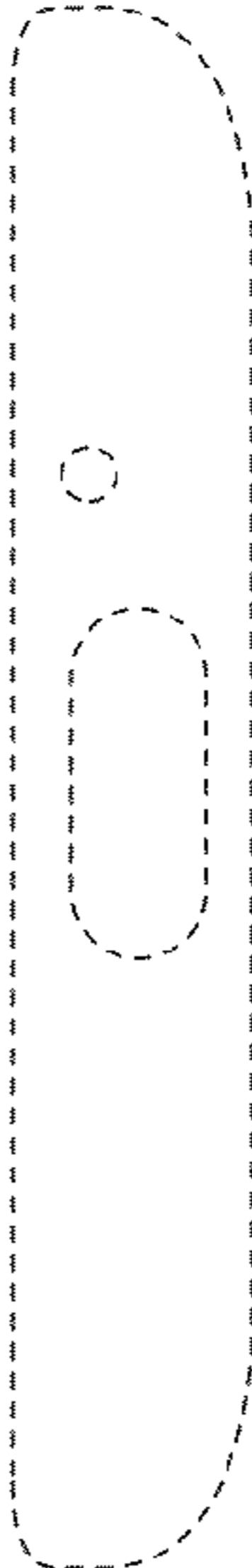

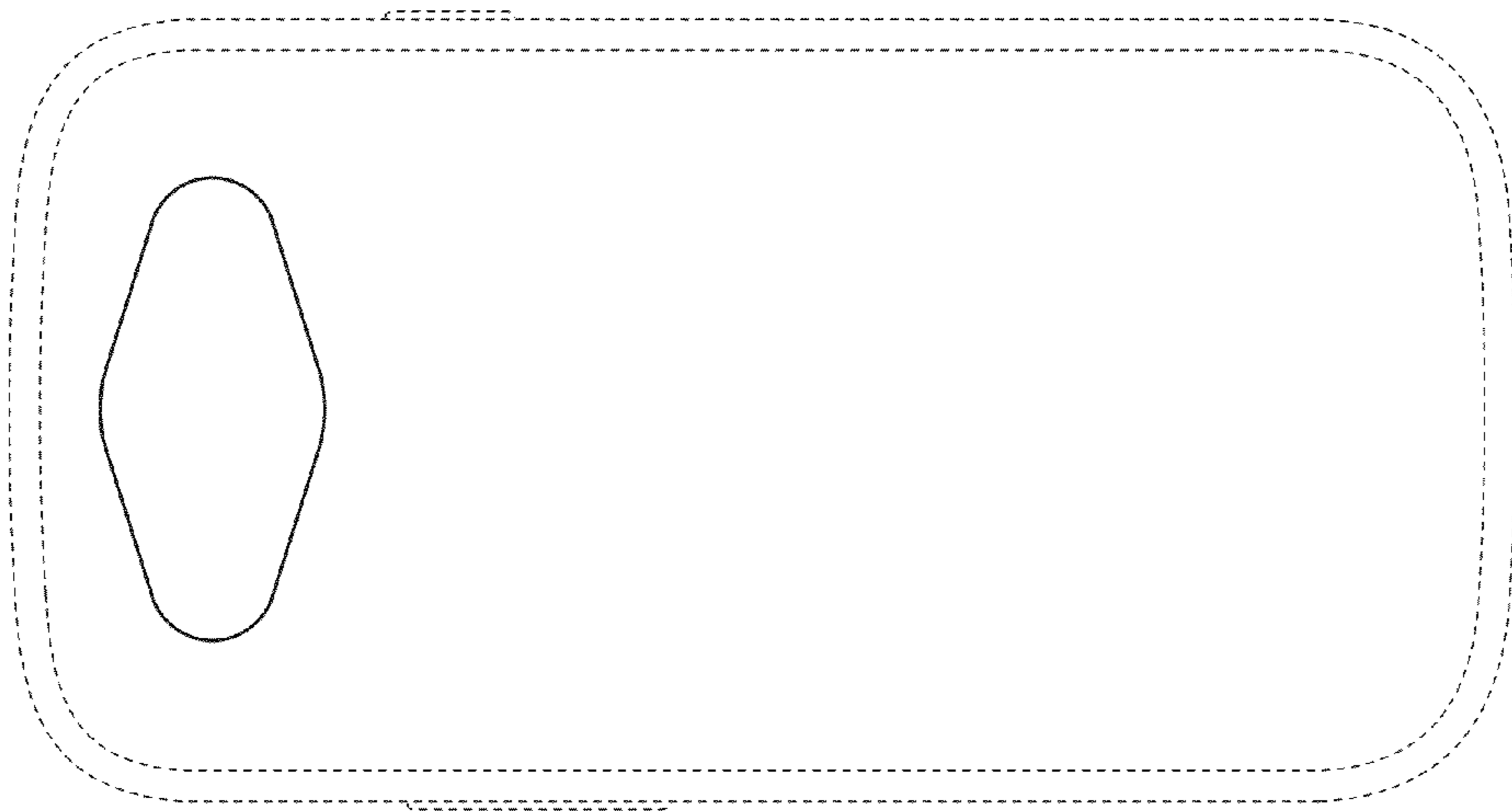
