The ornamental design for a horizontal octagonal eyeglass lens with vertical hexagonal aperture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front environmental view of a horizontal octagonal eyeglass lens with vertical hexagonal aperture showing my new design;

FIG. 2 is a front perspective view of the horizontal octagonal eyeglass lens with vertical hexagonal aperture;

FIG. 3 is a front view thereof;

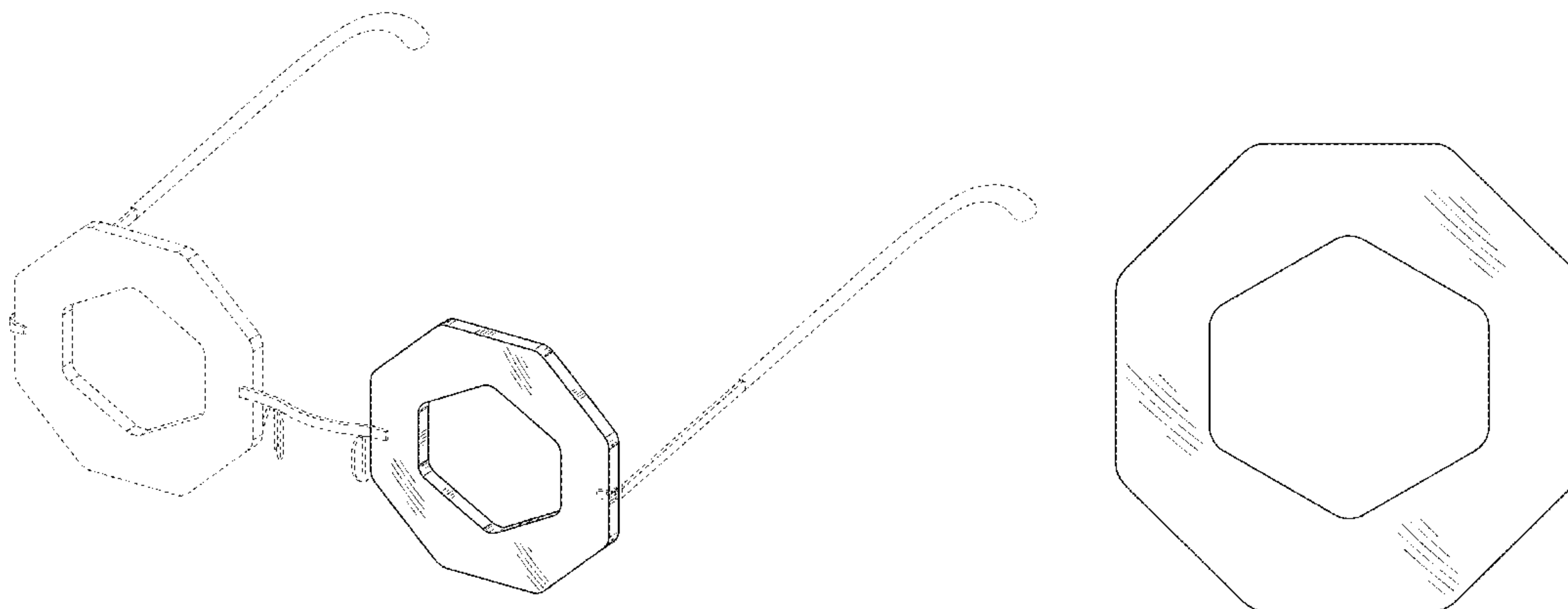
FIG. 4 is a rear view thereof;

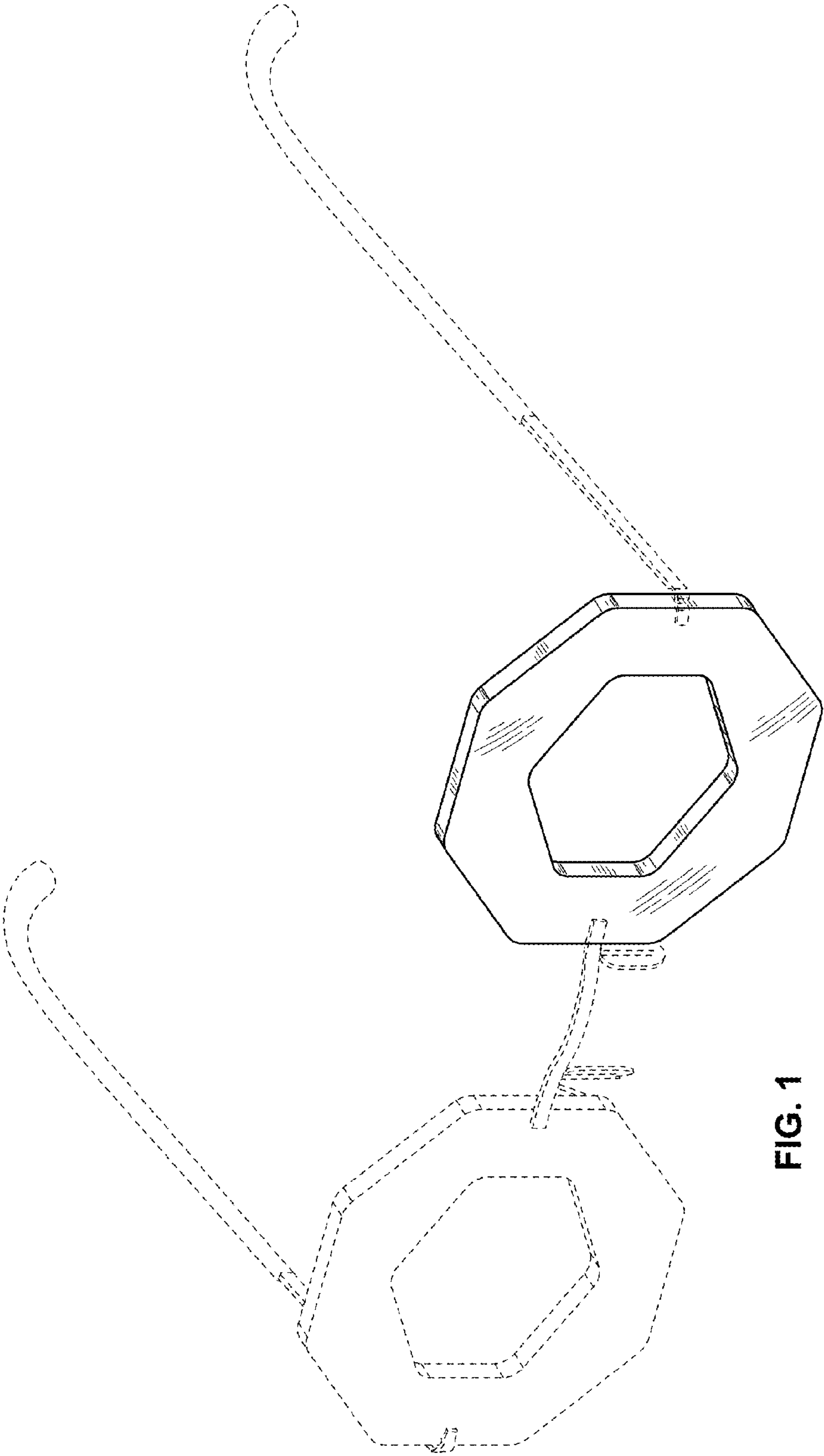

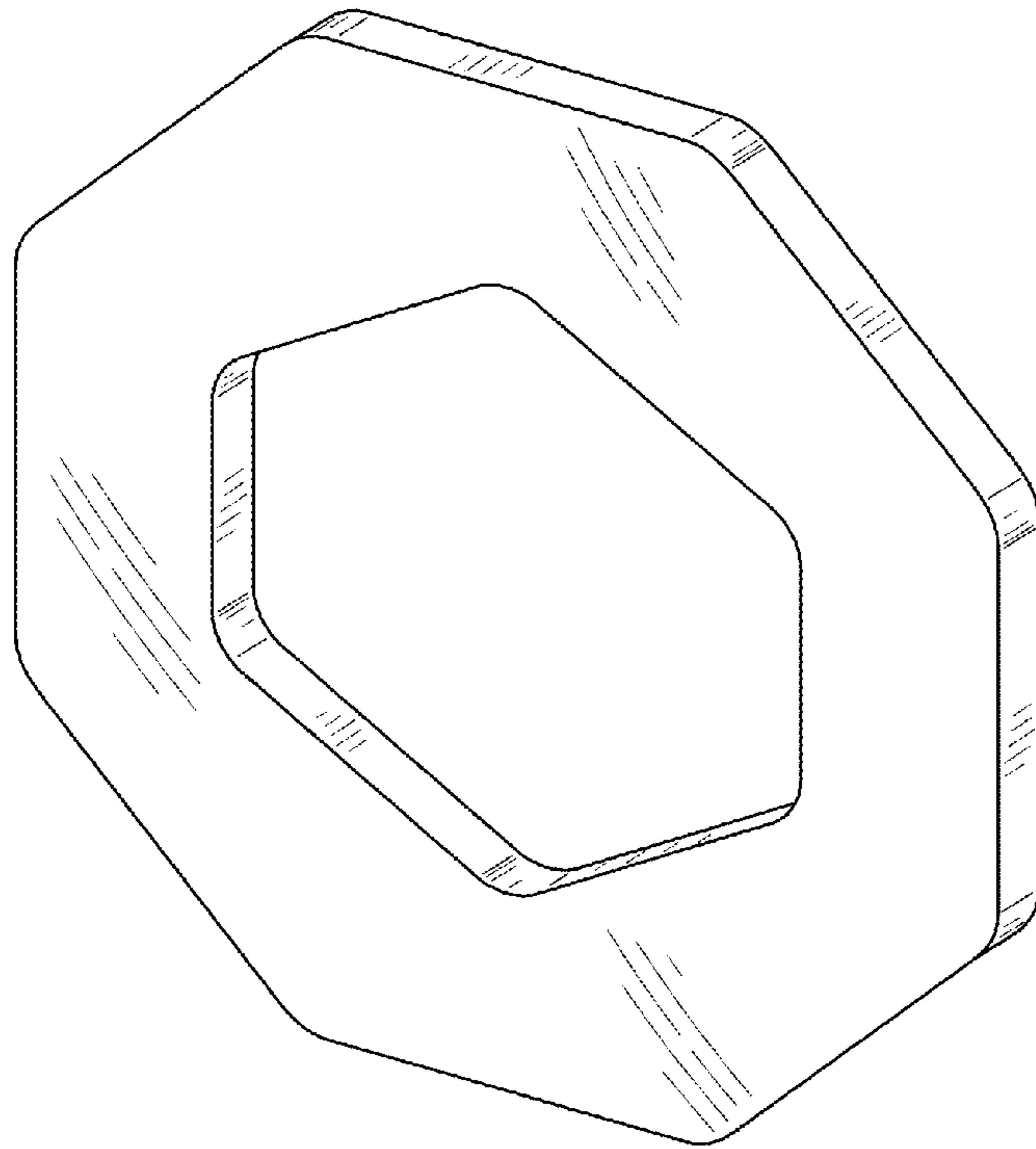

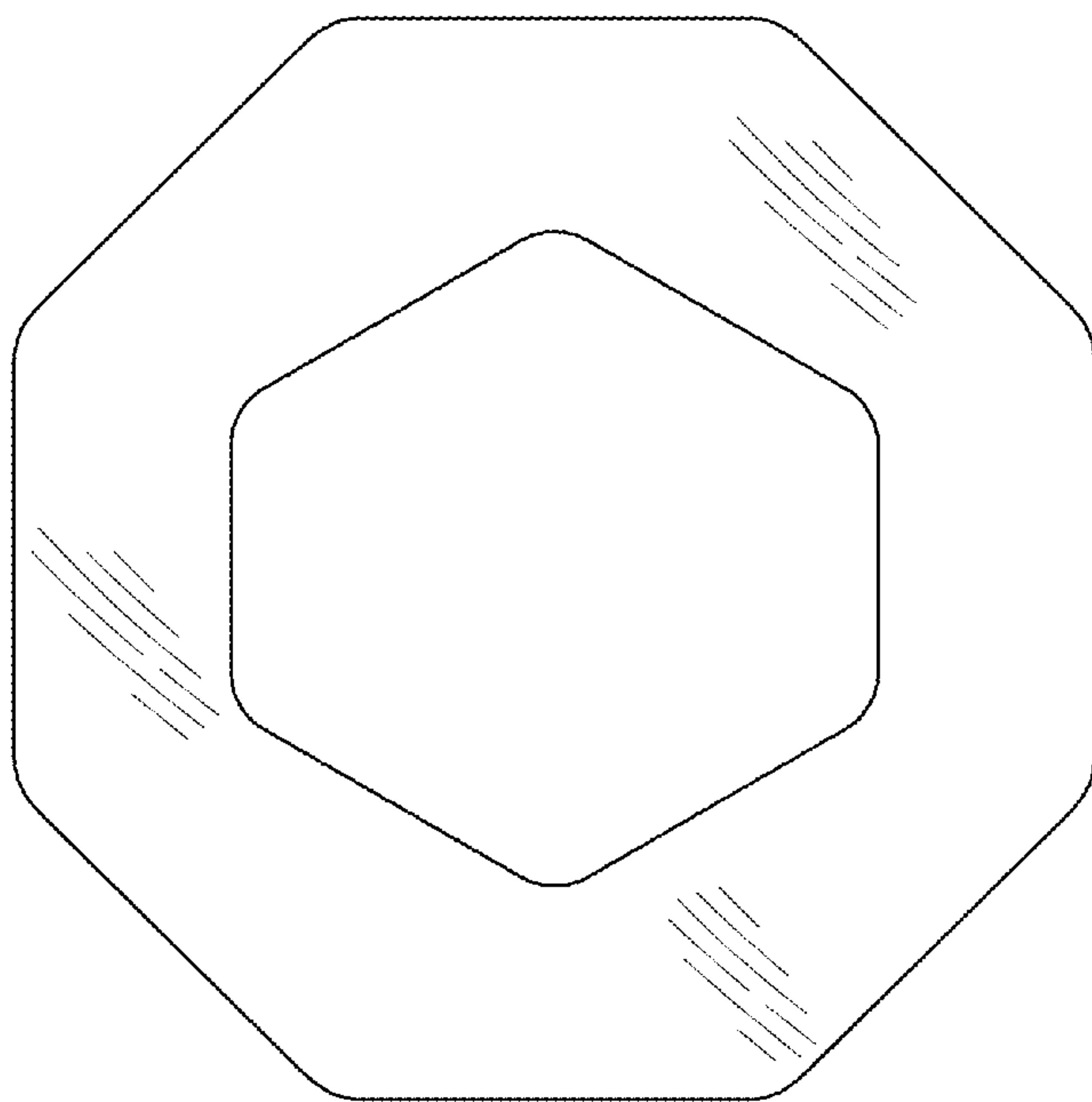

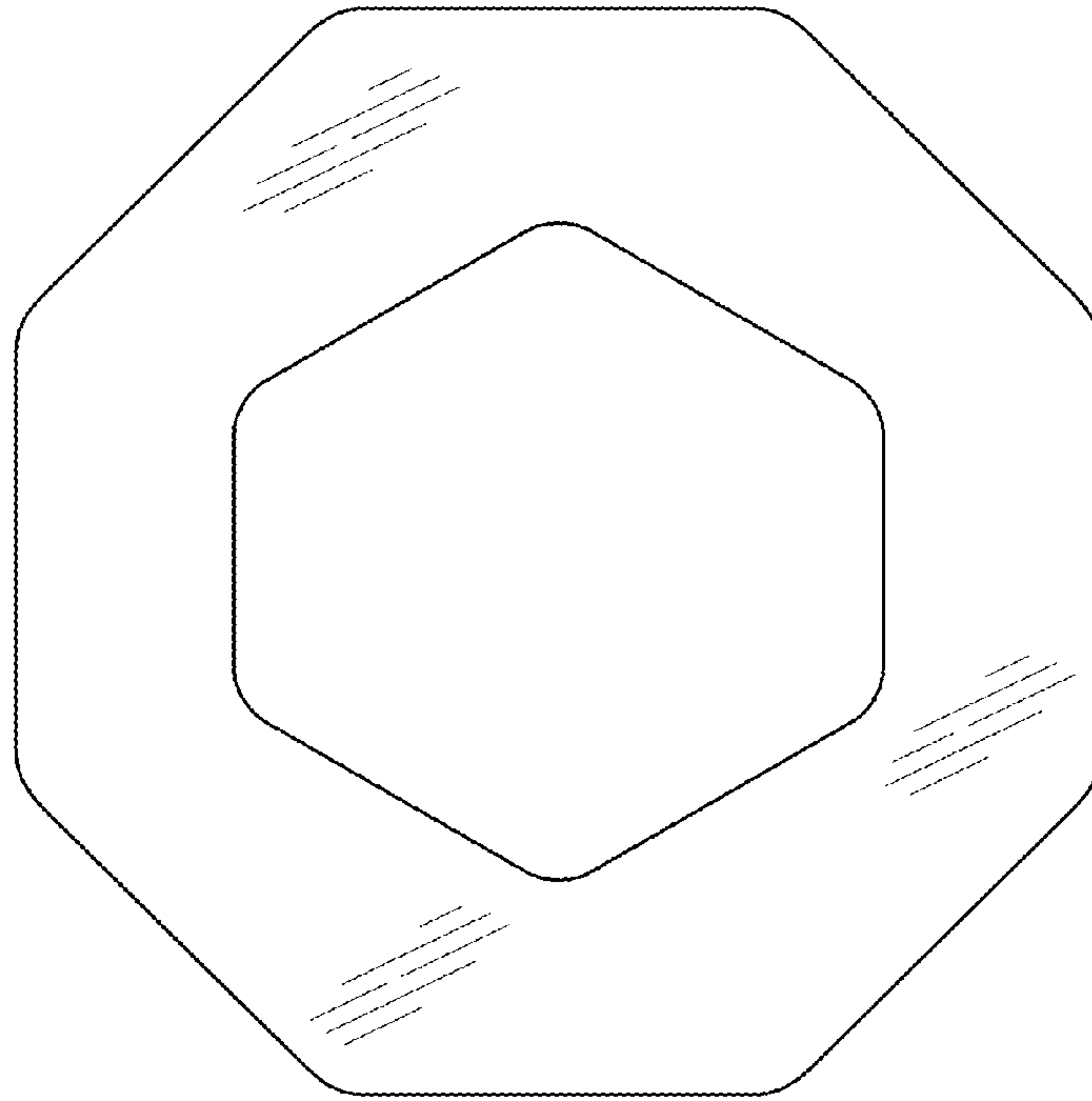

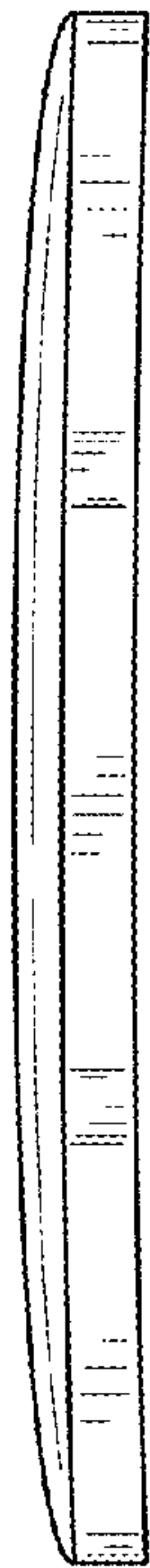

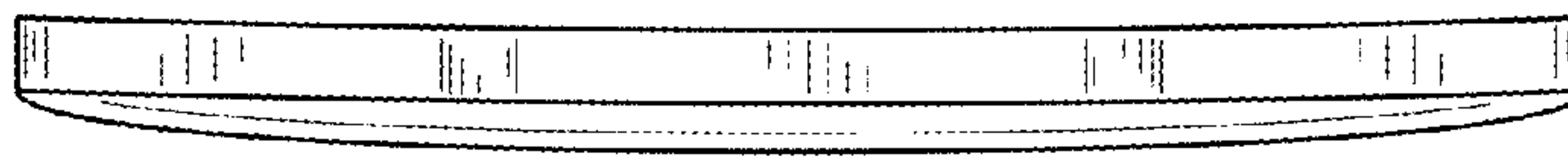
