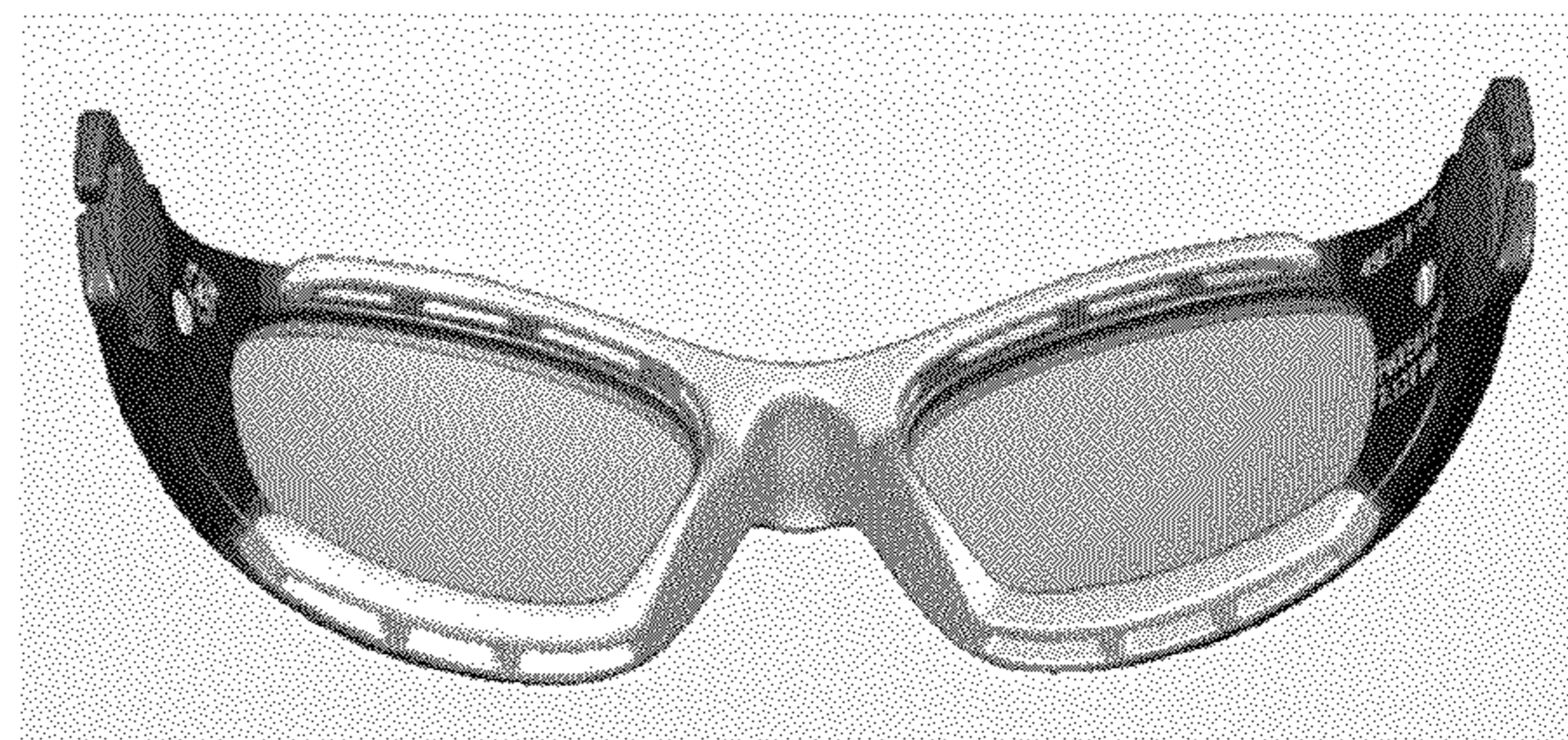
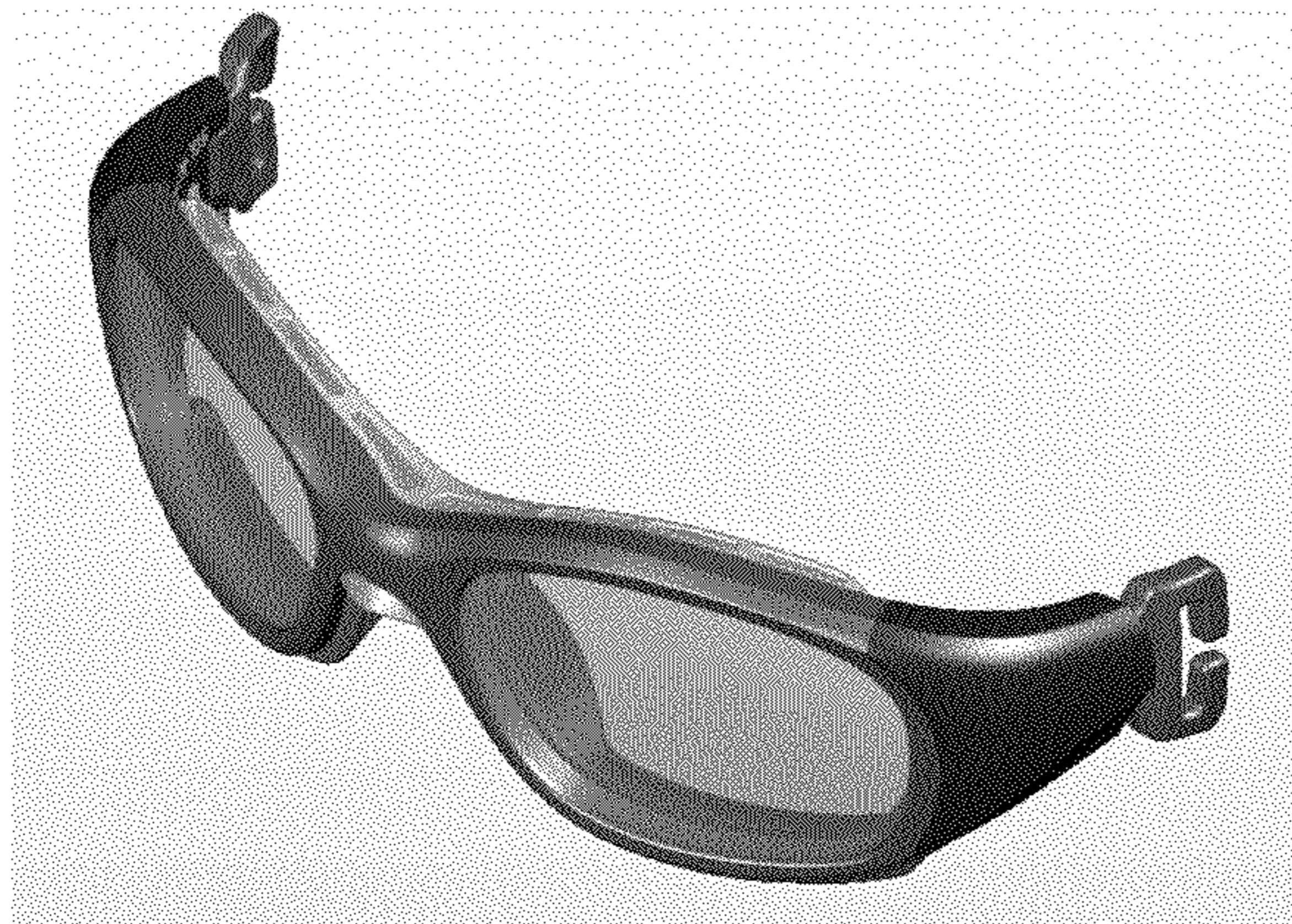
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top view of the slam goggle;  
FIG. 2 is a left side view thereof, the right side view being a mirror image thereof;

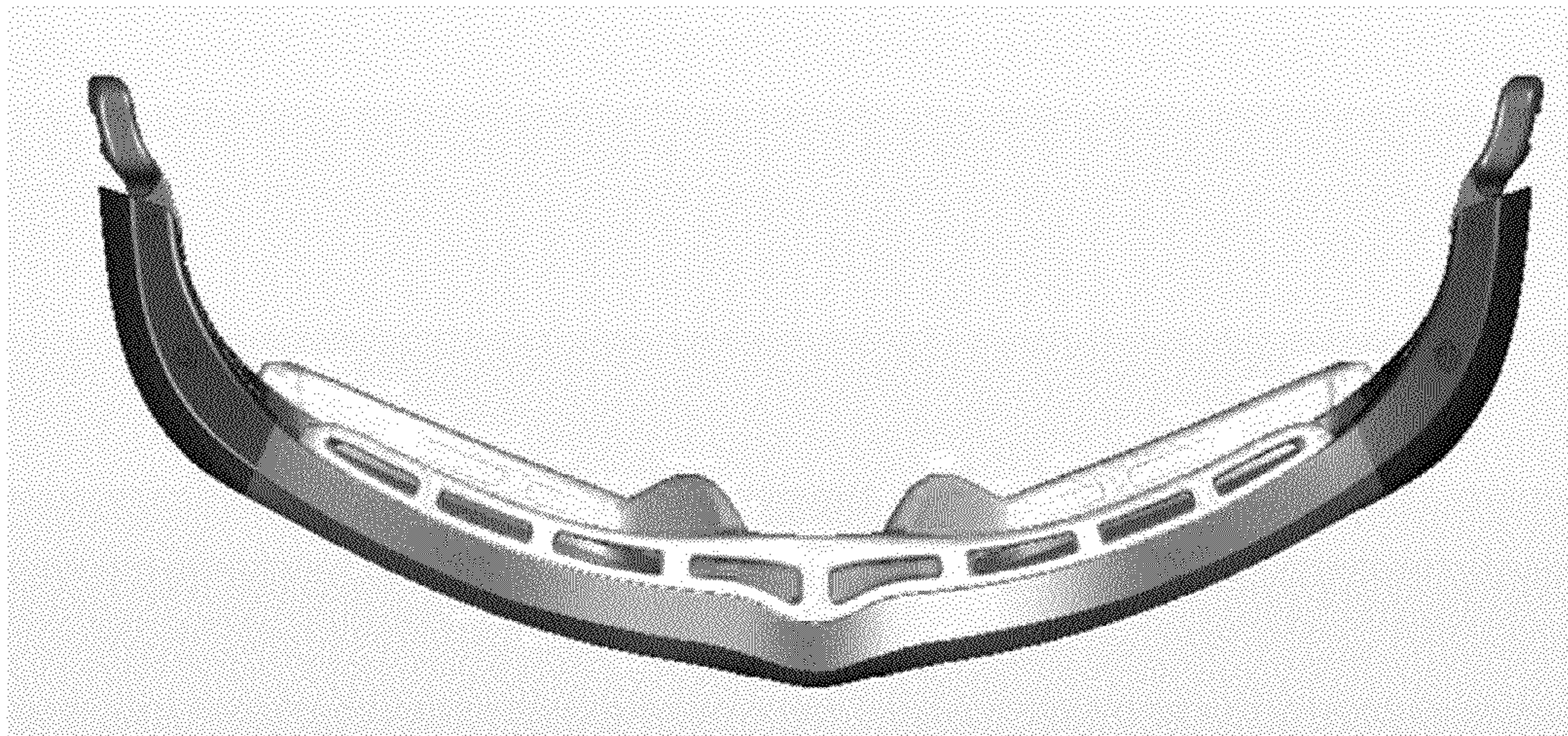

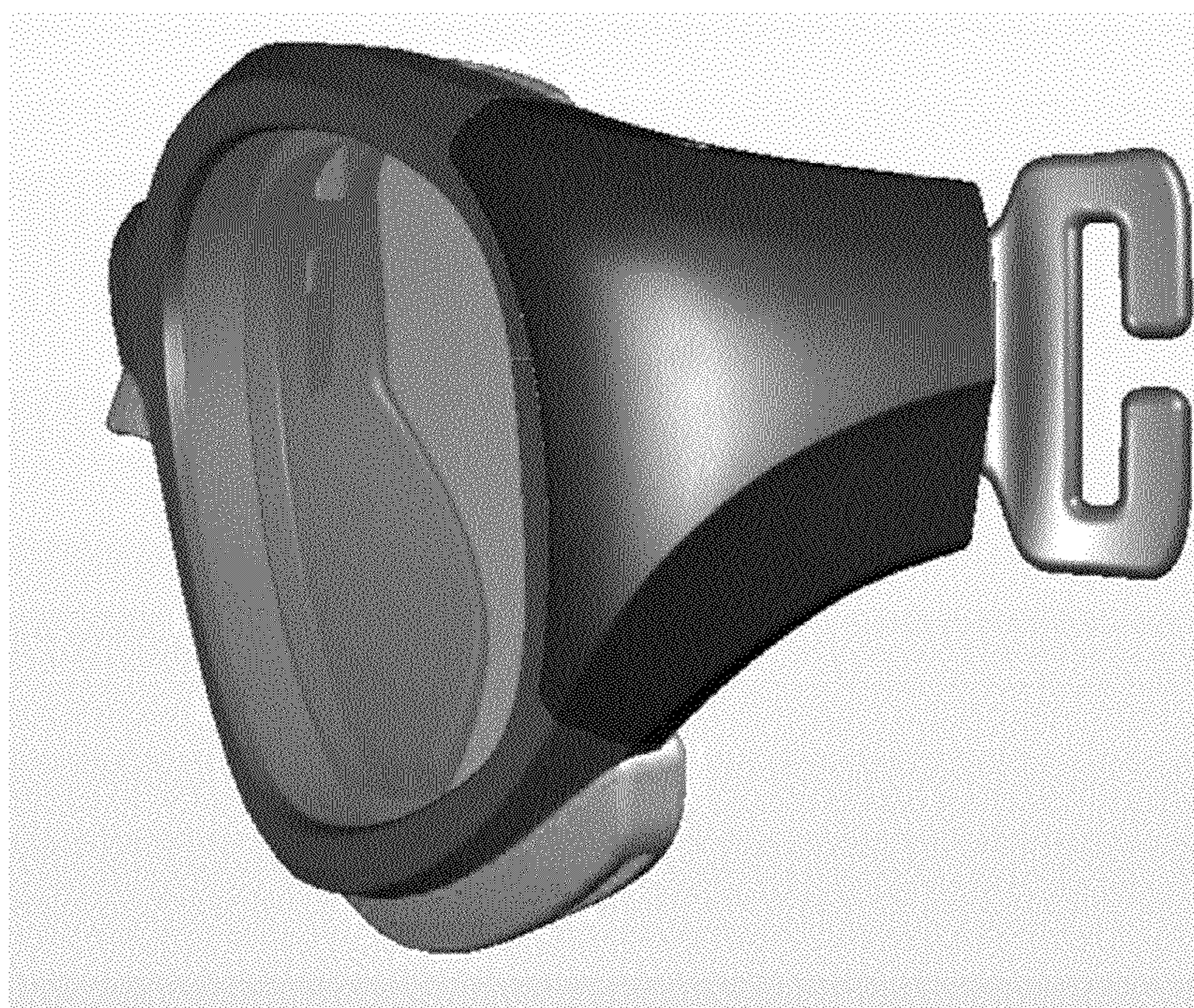

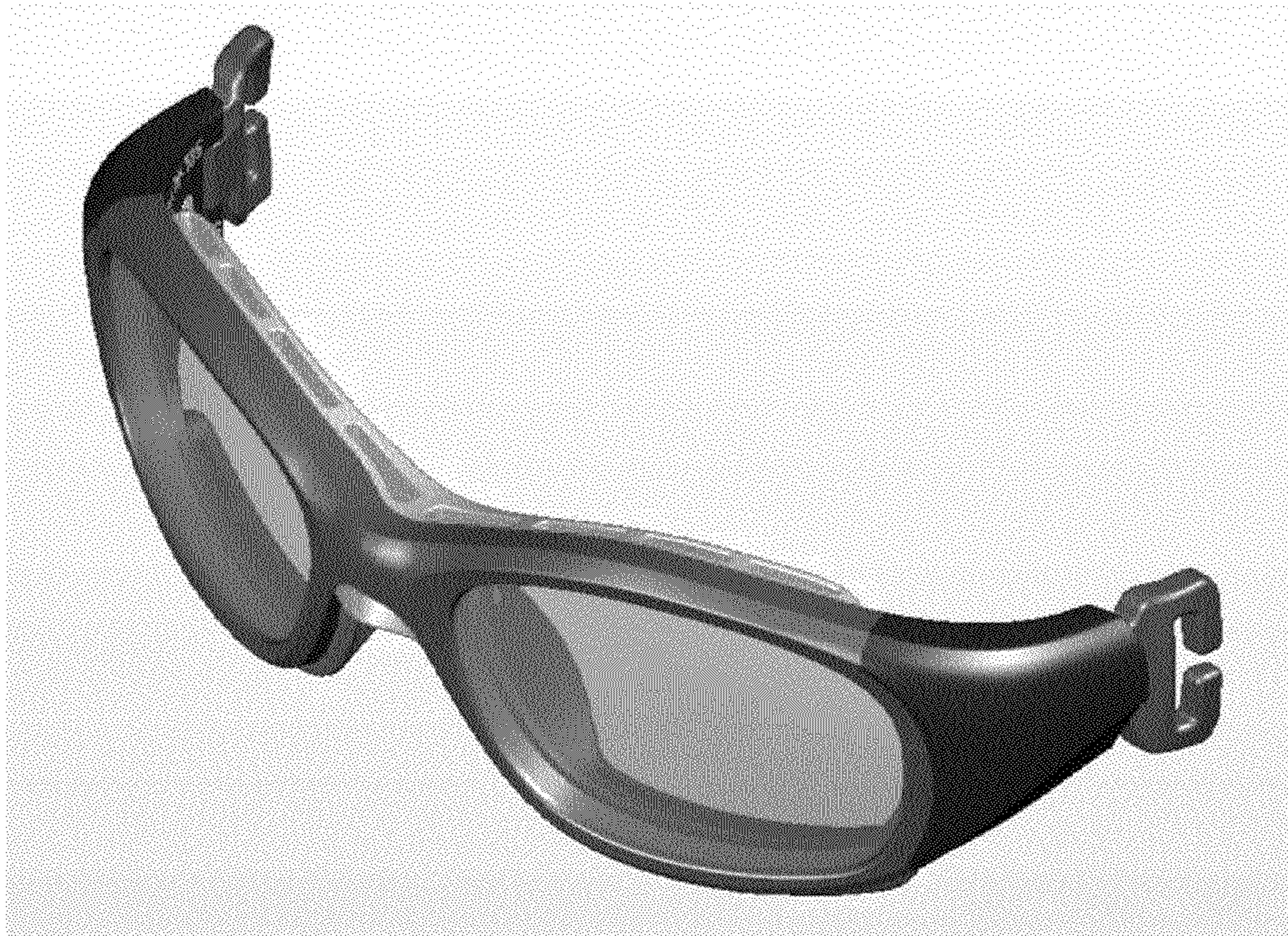

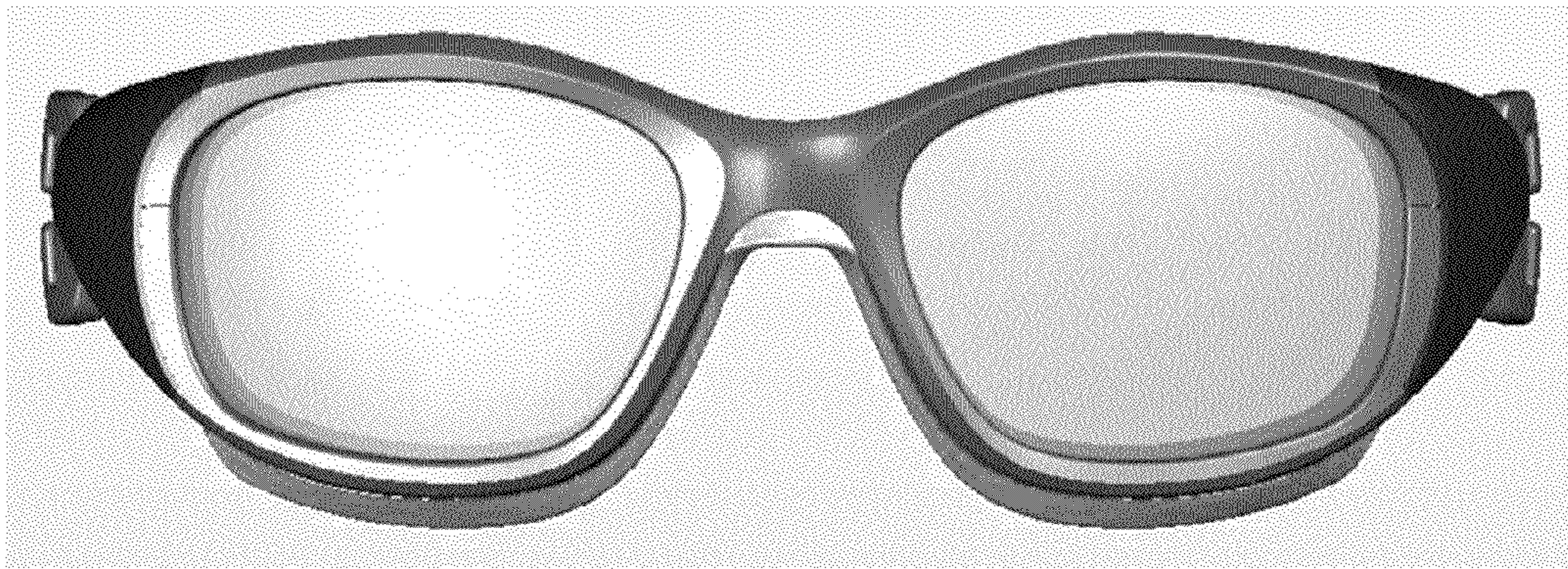

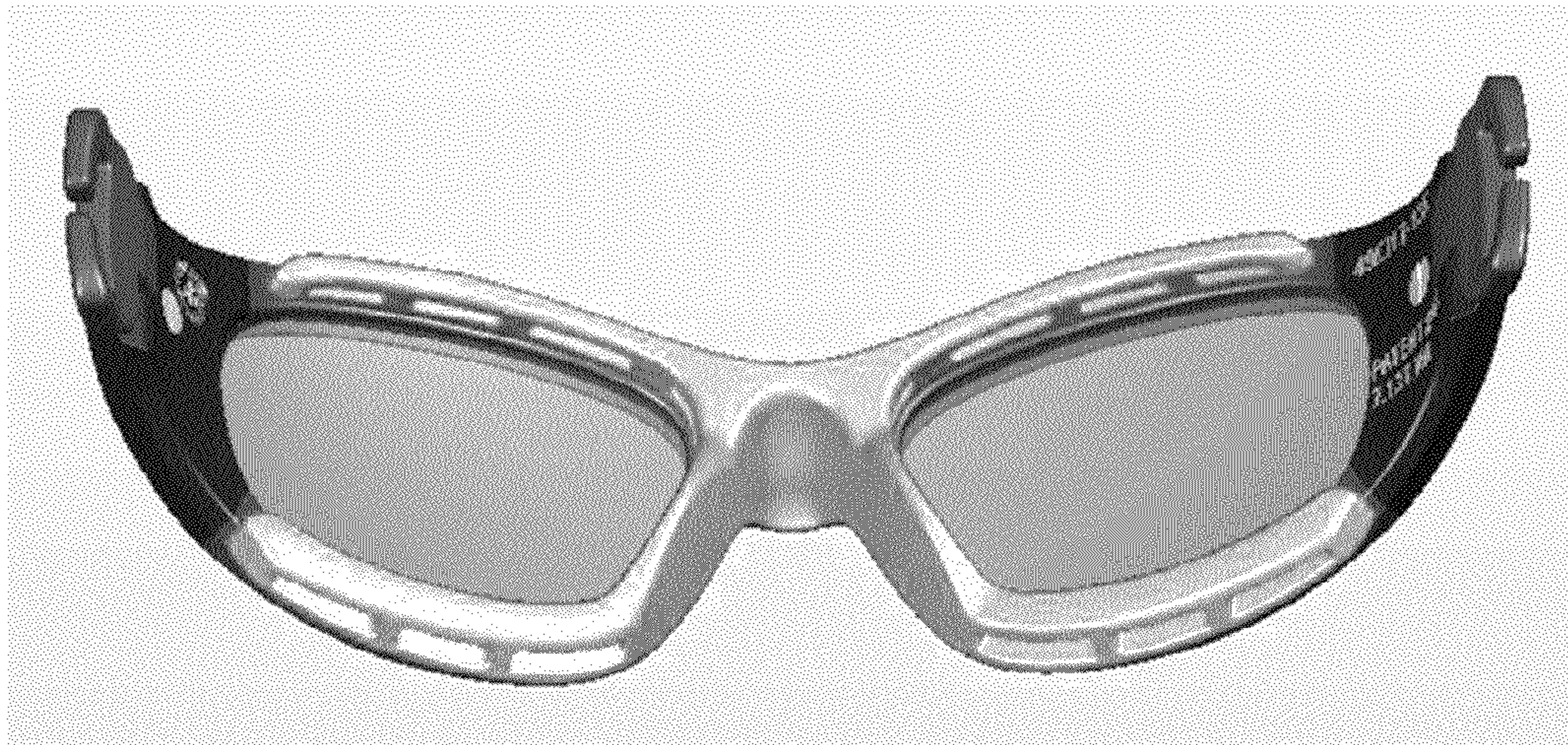

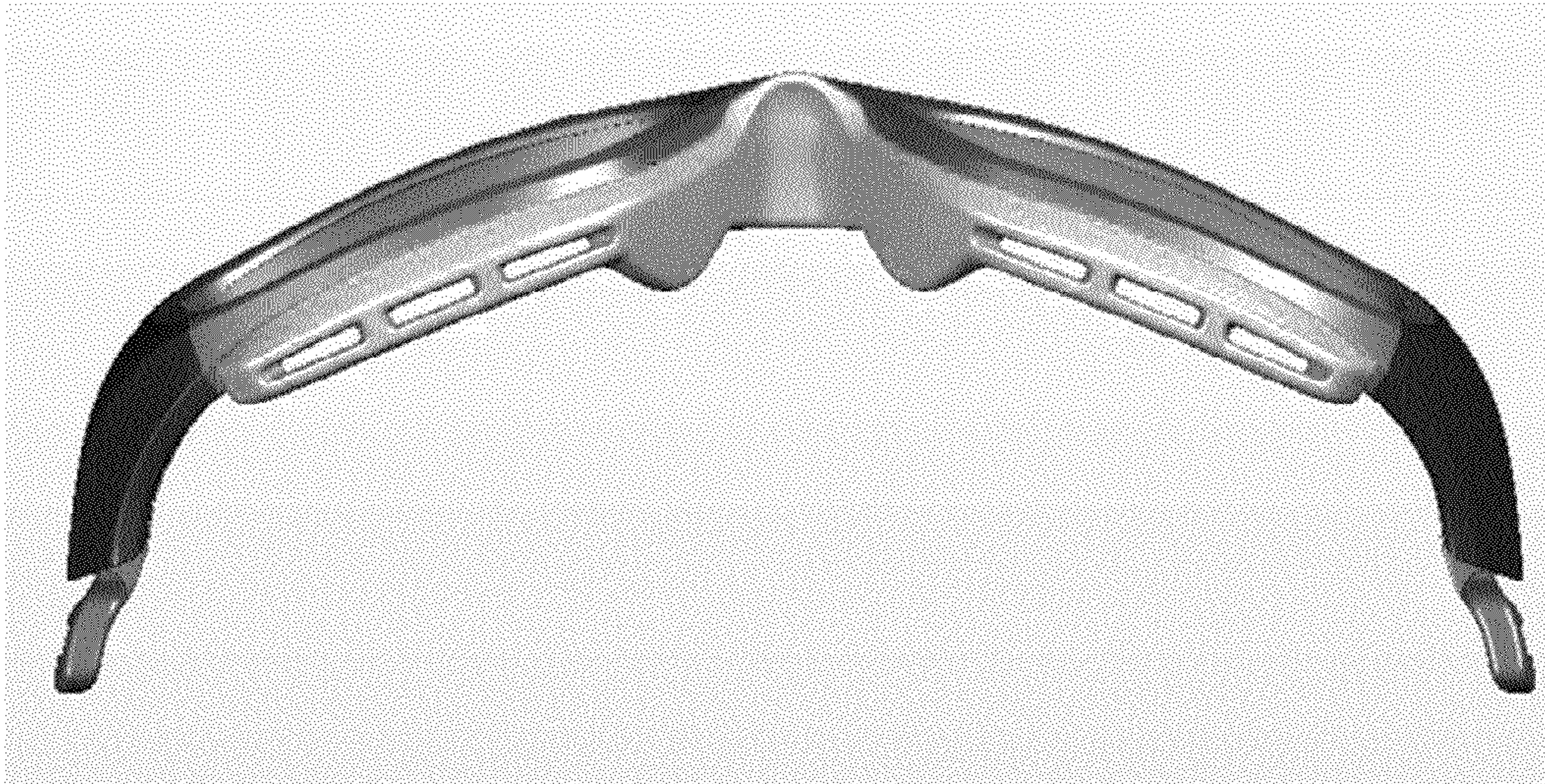
