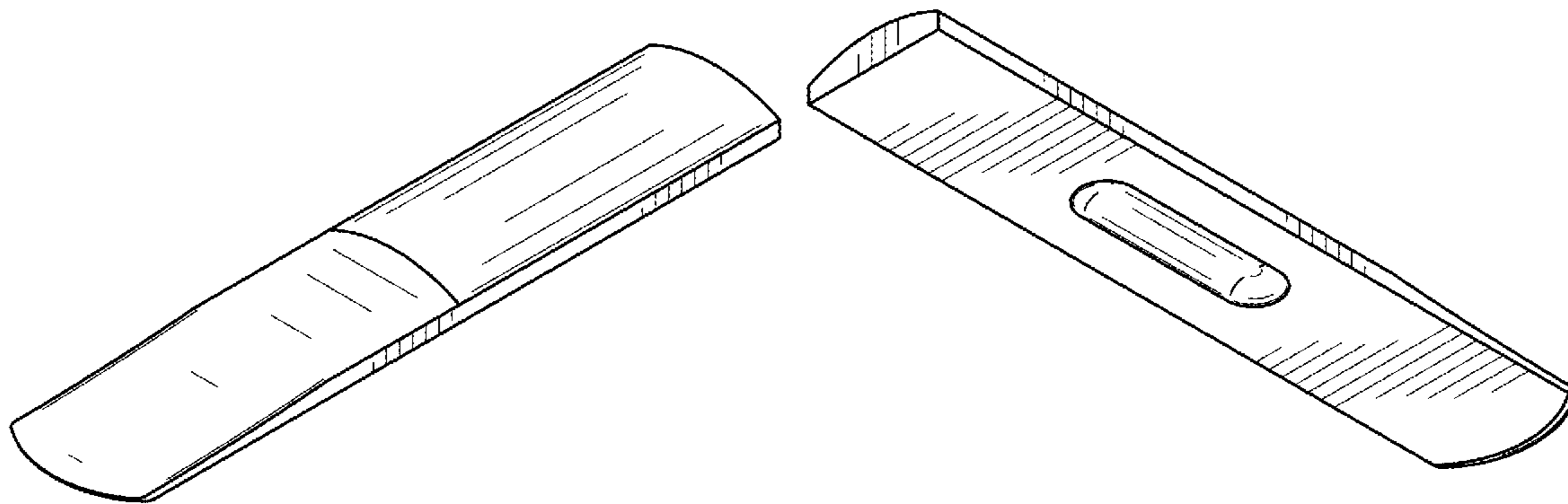
(57) **CLAIM**

The ornamental design for a reed for musical instruments, as shown.

DESCRIPTION

FIG. 1 is a top perspective view of a reed for musical instruments showing our new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side view thereof; the right side being a mirror image;
FIG. 6 is a front elevational view thereof; and,
FIG. 7 is a back elevational view thereof.

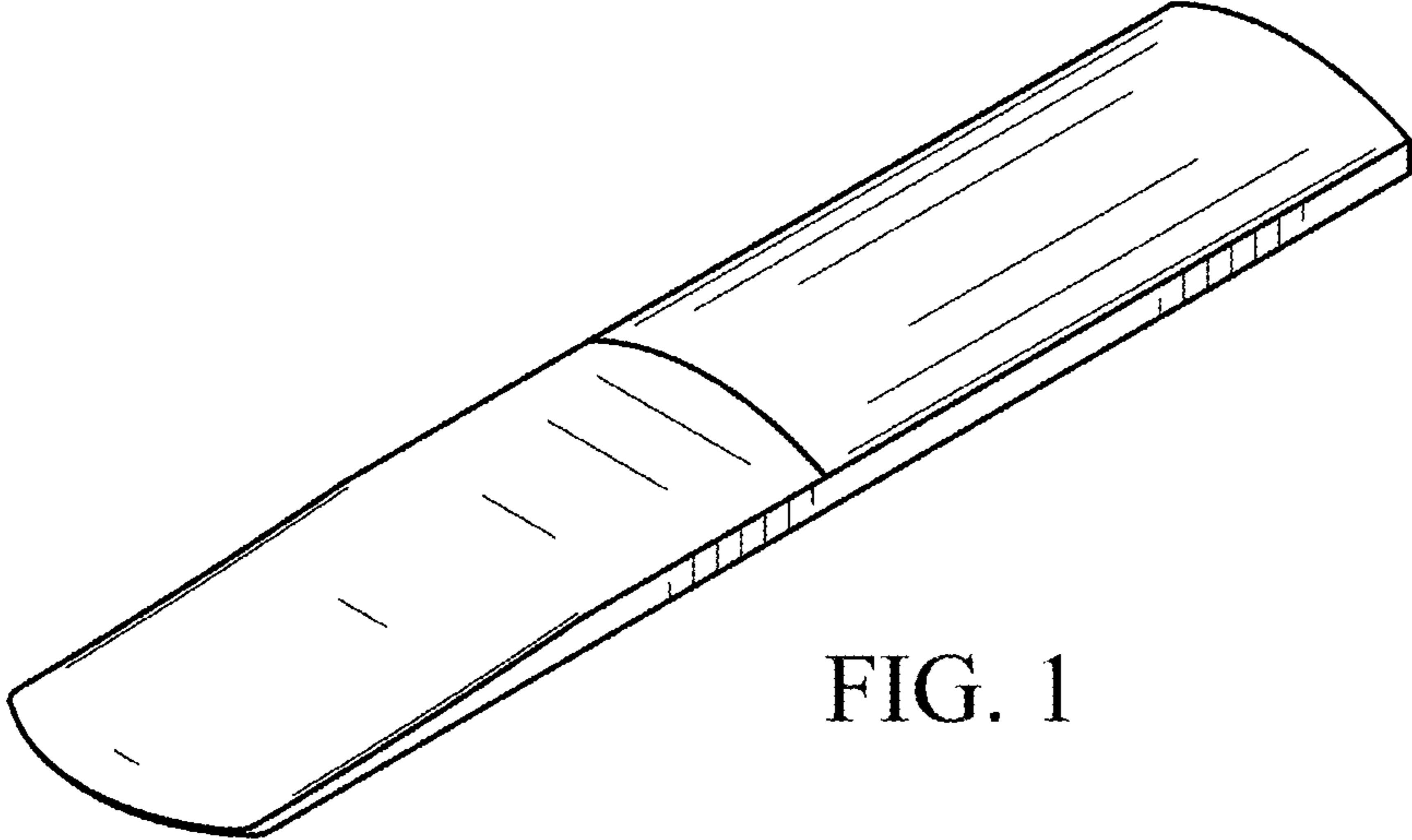

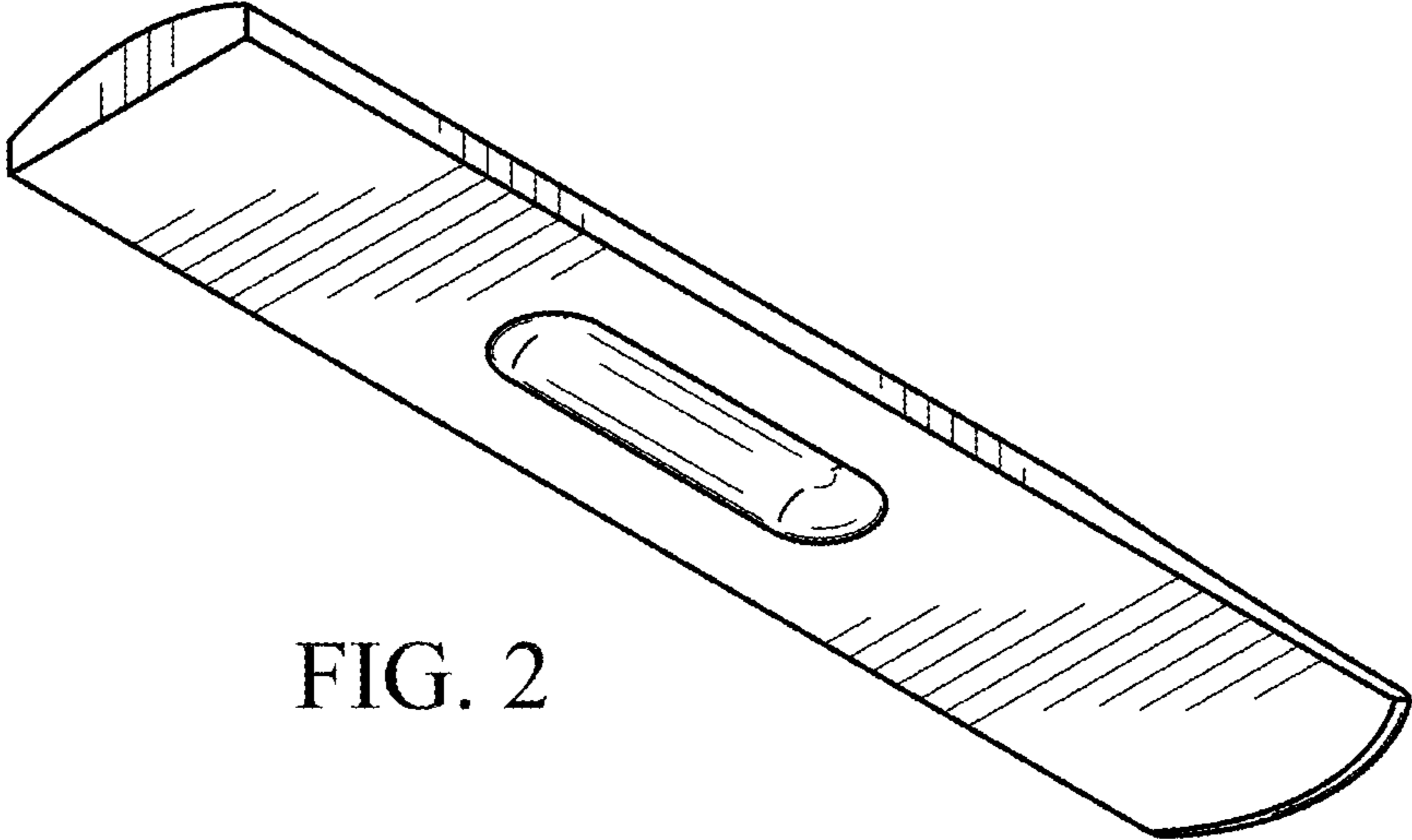

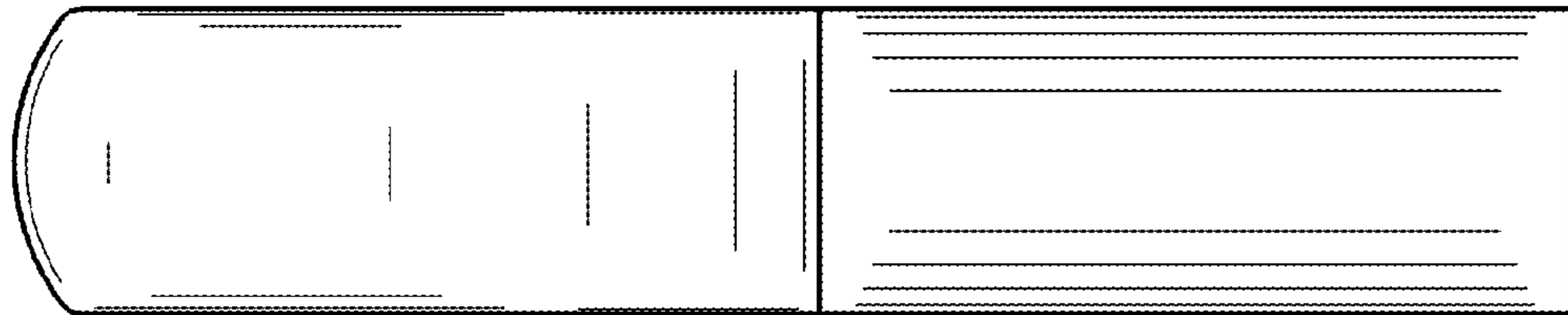

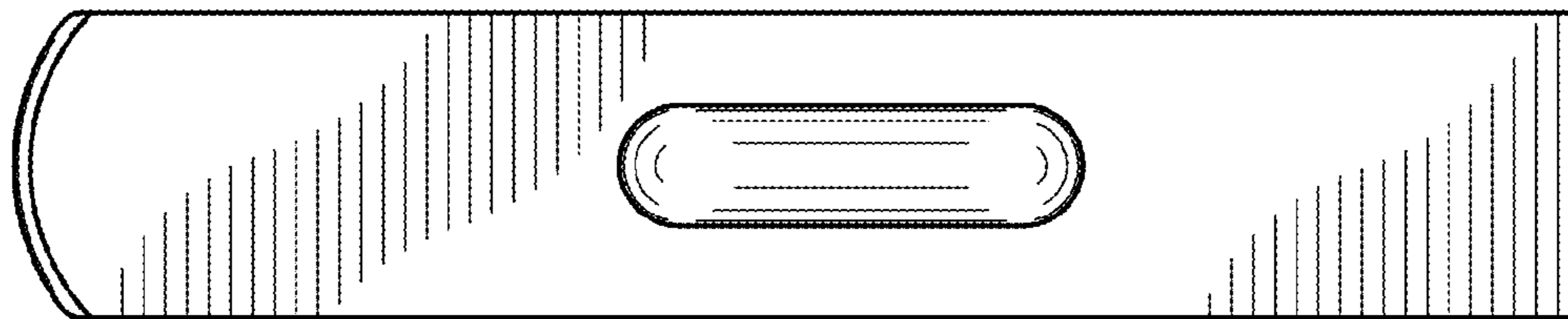

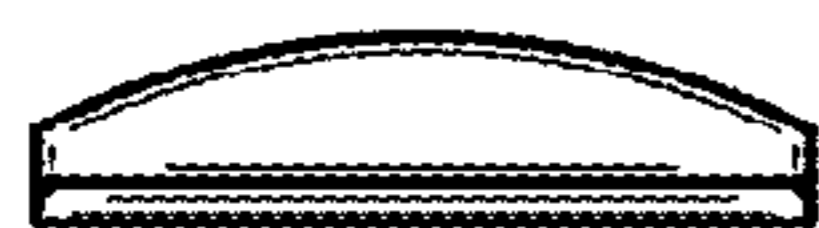
