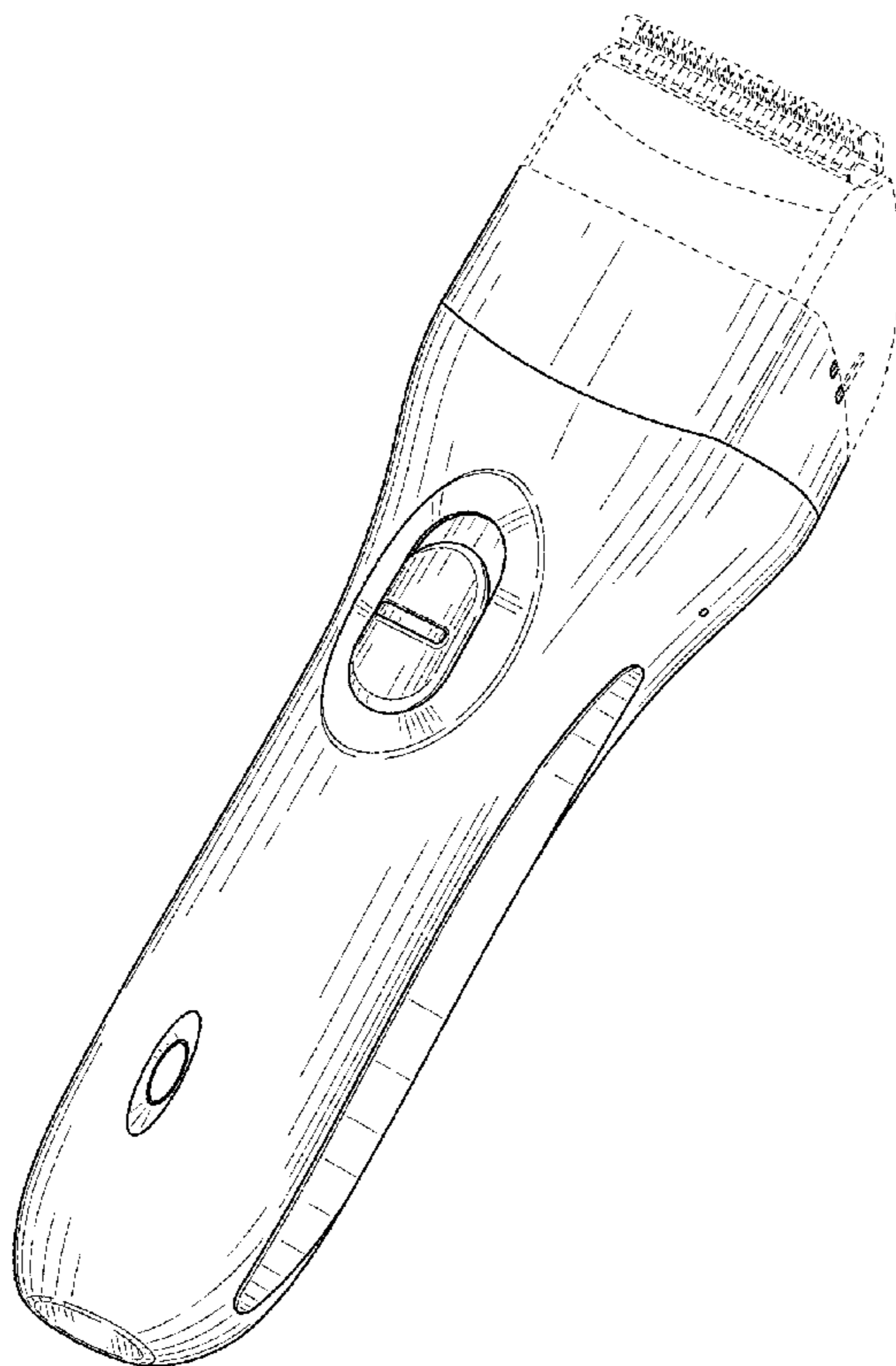
(57) **CLAIM**

The ornamental design for a clipper, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, bottom perspective view of a clipper showing our new design;
 FIG. 2 is a front perspective view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a right side elevation view thereof;
 FIG. 5 is a left side elevation view thereof; and,
 FIG. 6 is a bottom plan view thereof.
 The dashed broken lines are for purposes of illustrating portions of the clipper and form no part of the claimed design.

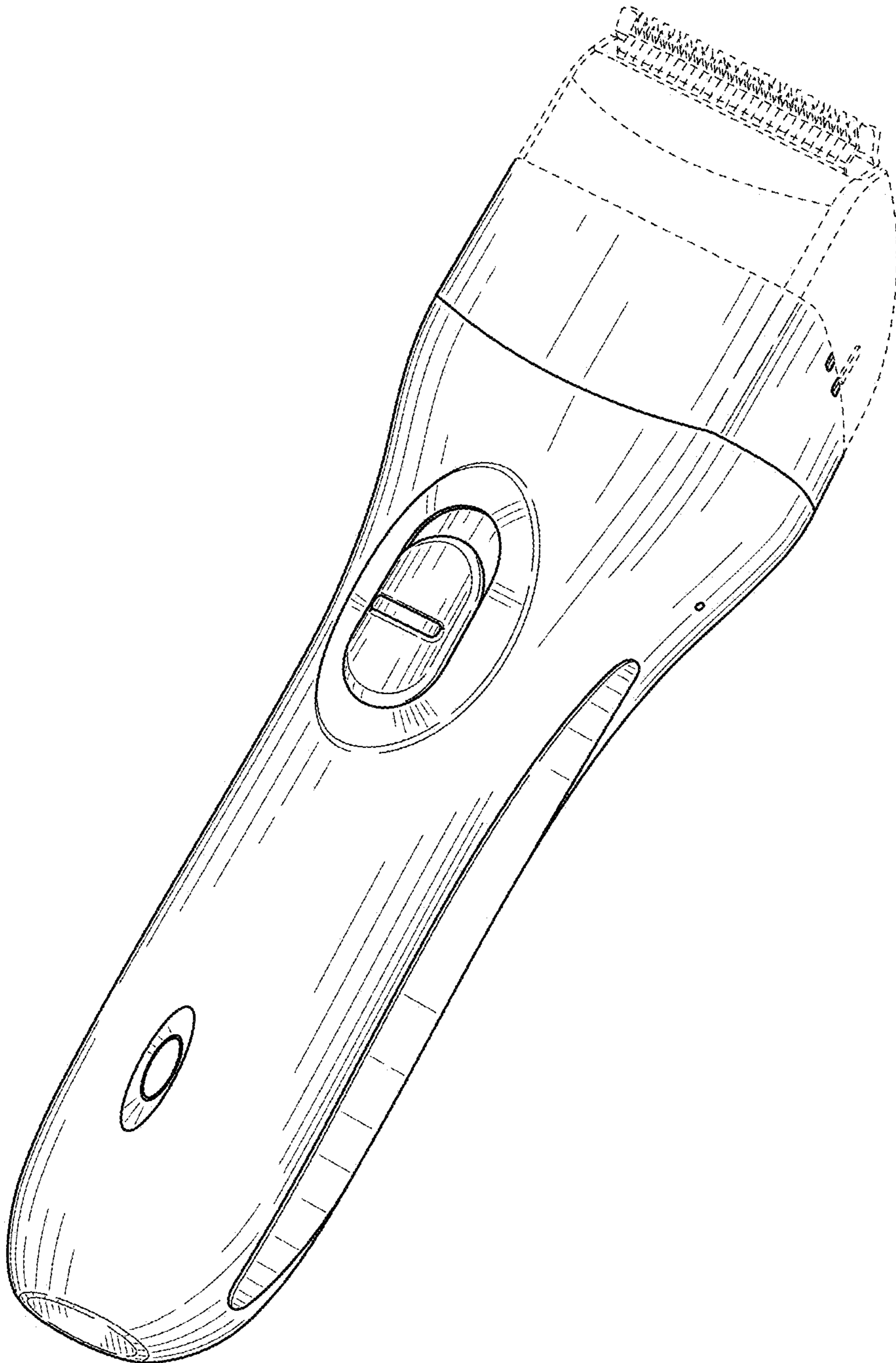

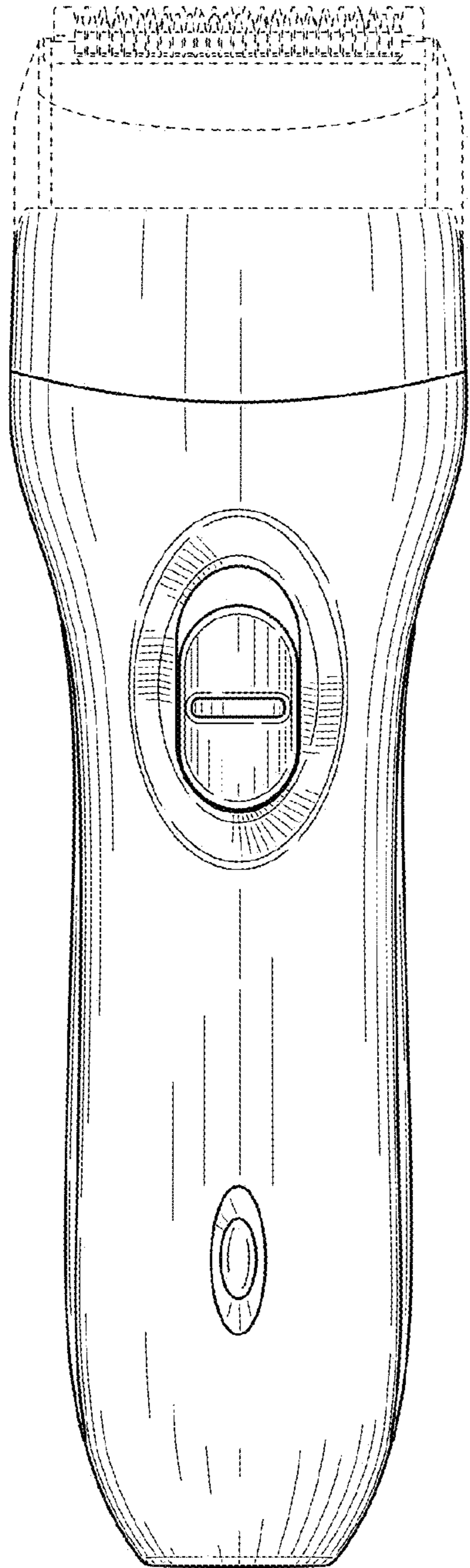

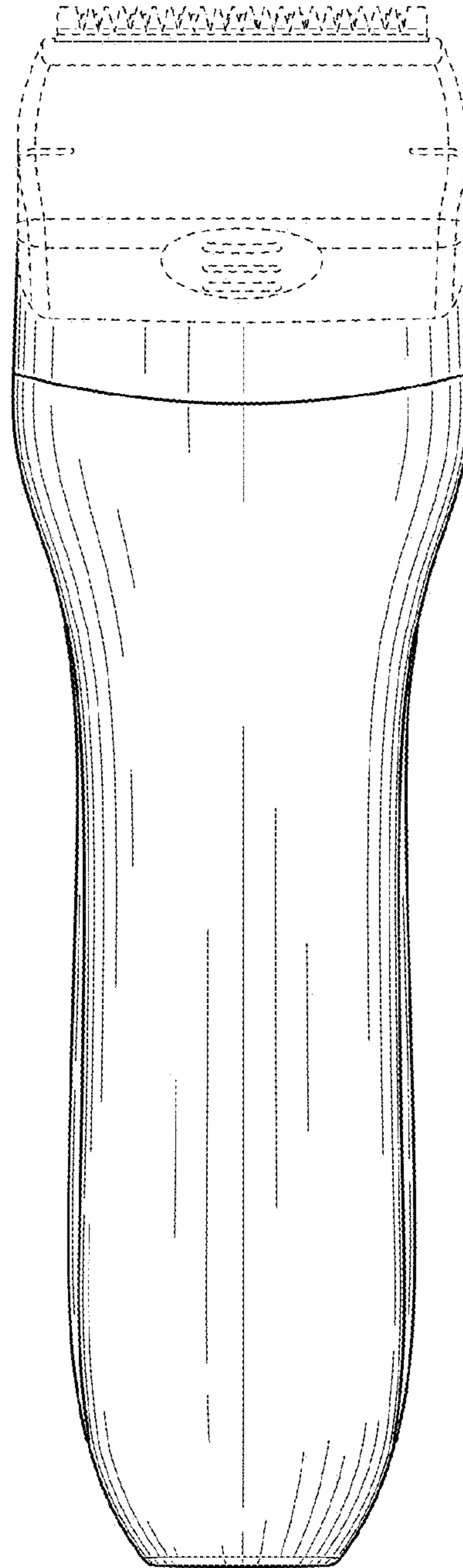

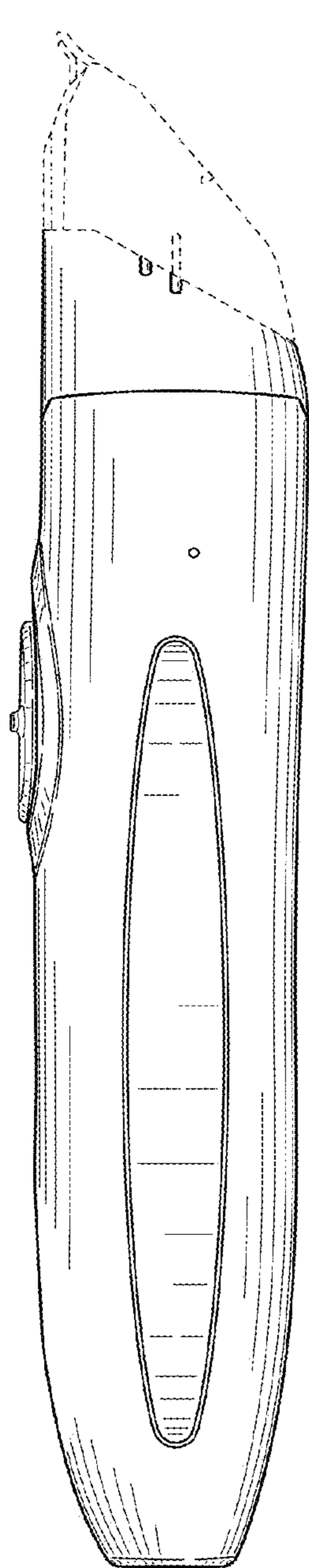

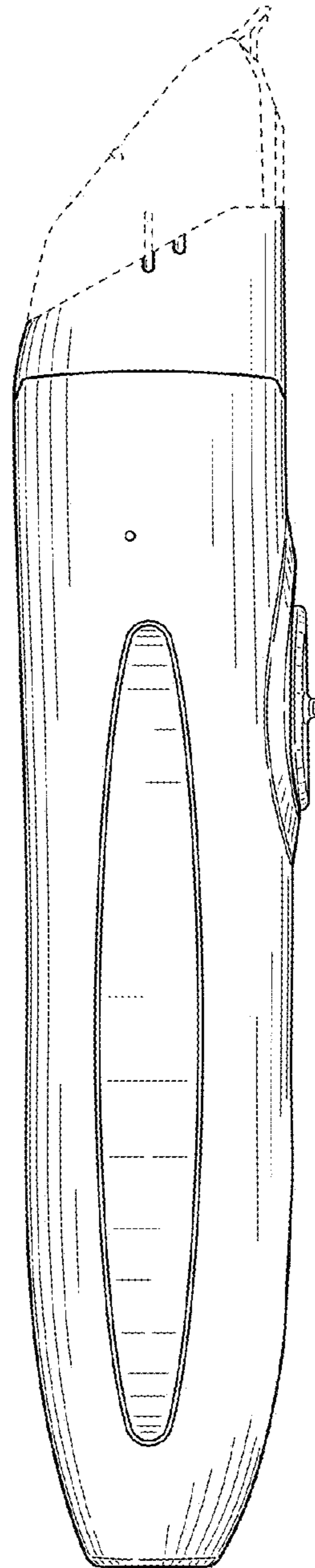

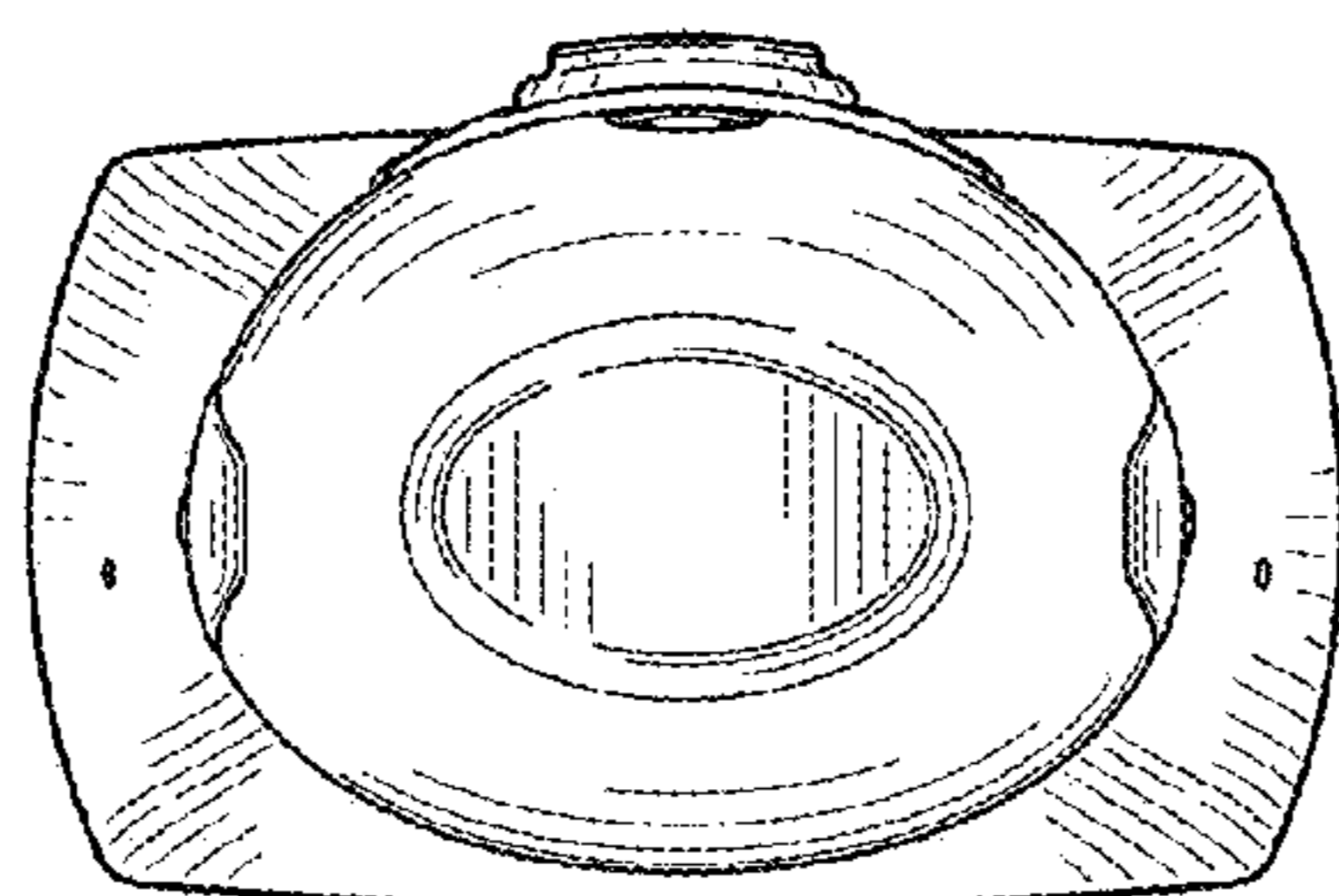
